I claim the ornamental design for an ice cube novelty, as shown and described.

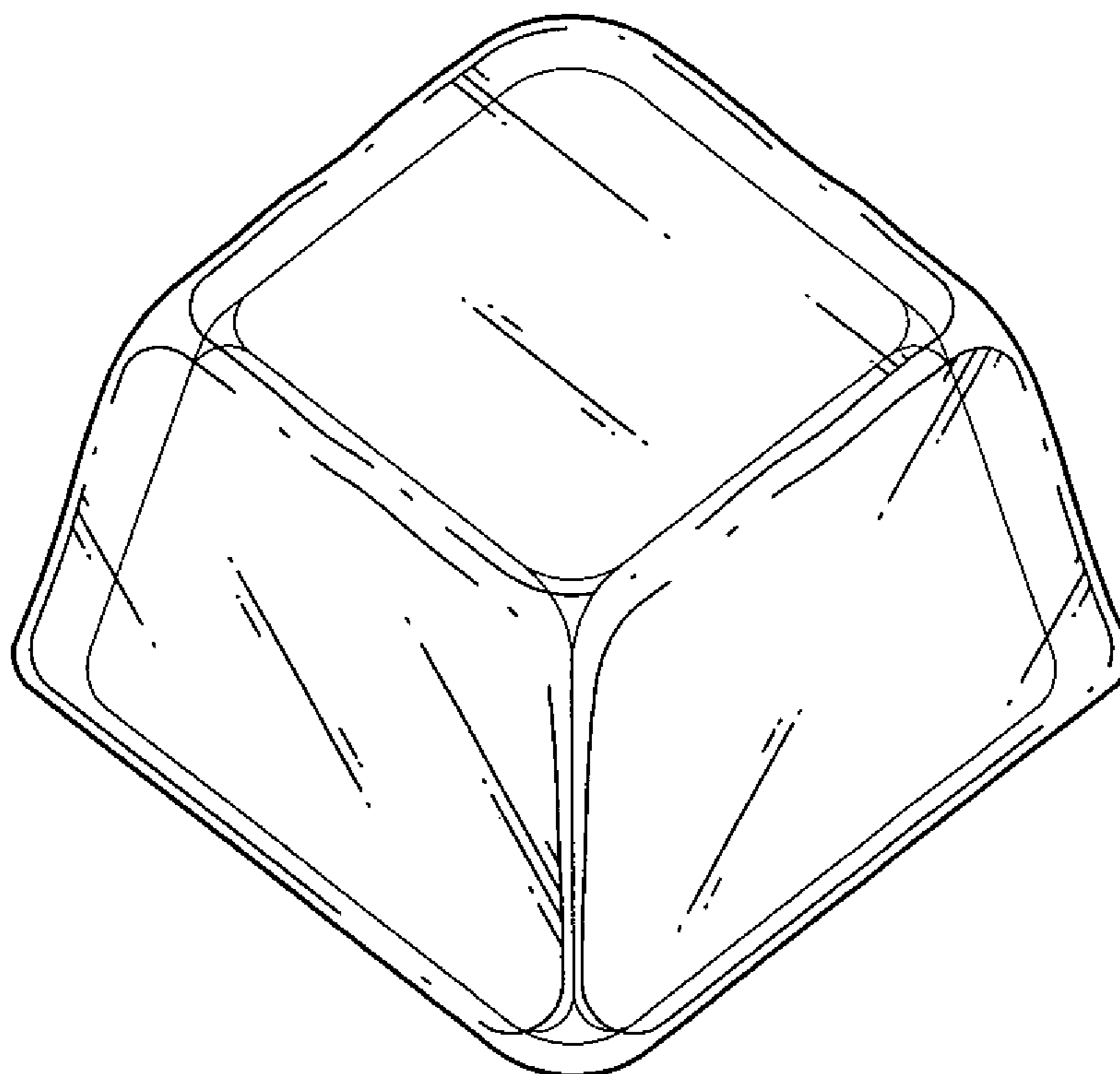
DESCRIPTION

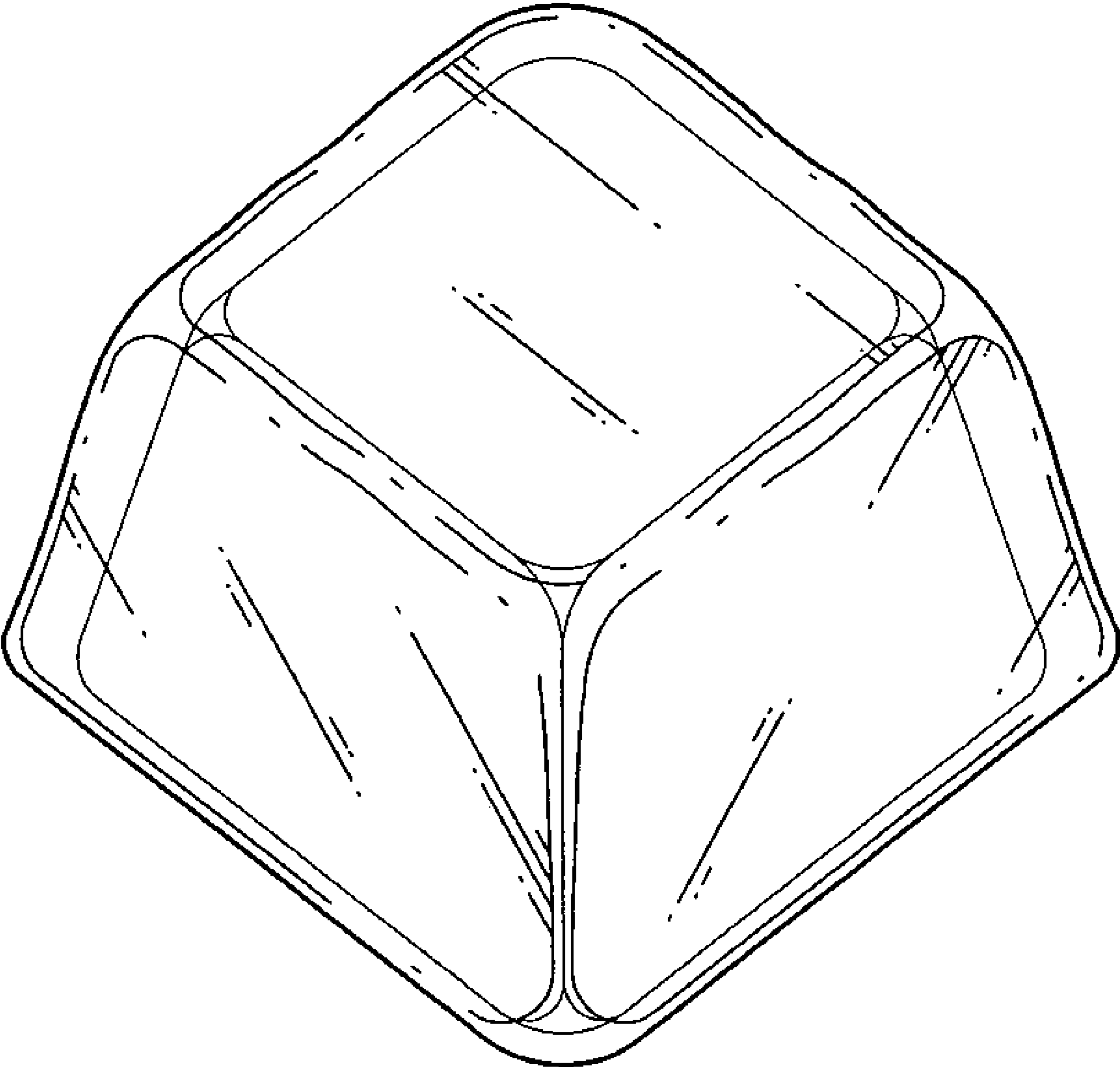

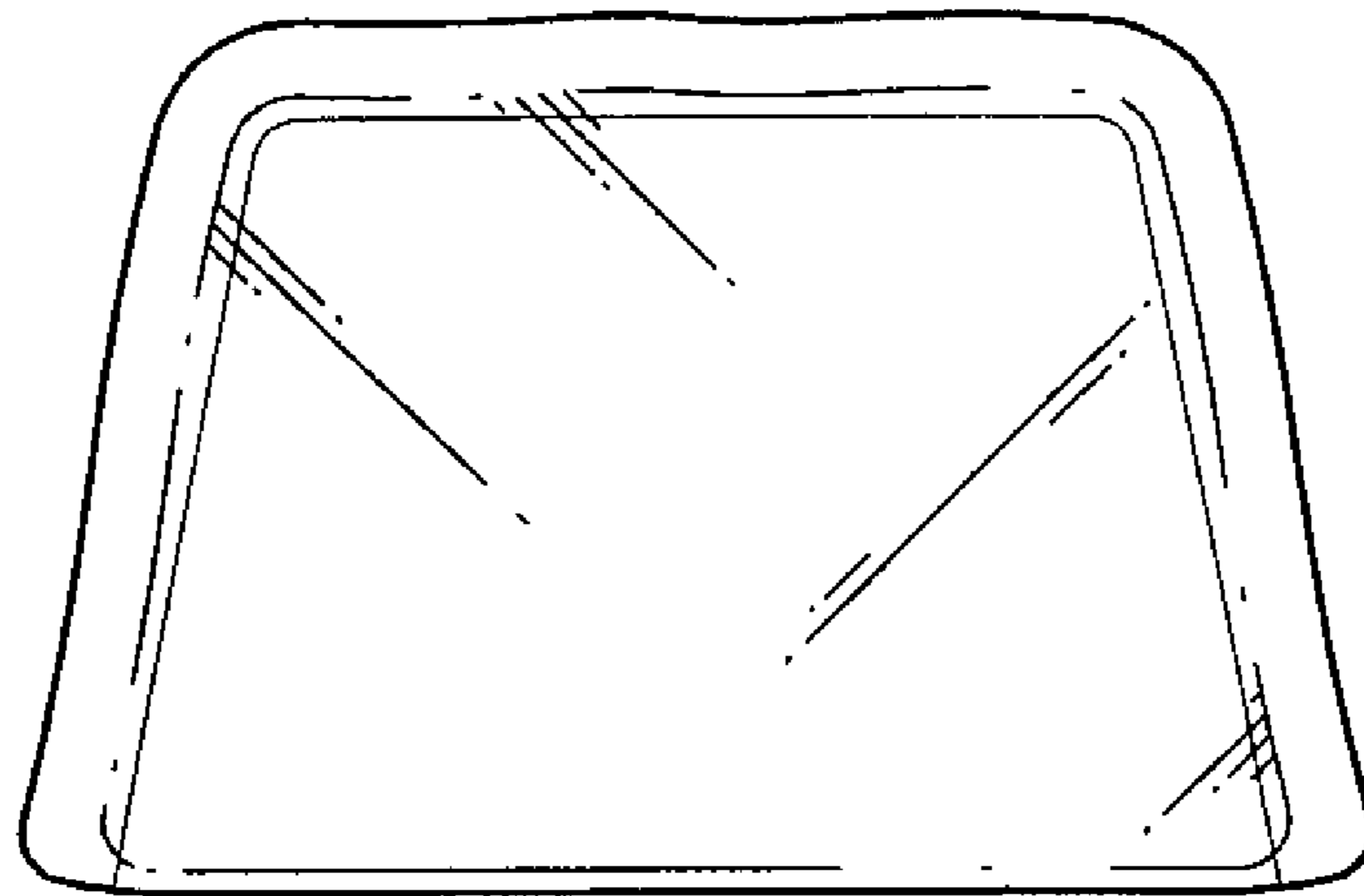

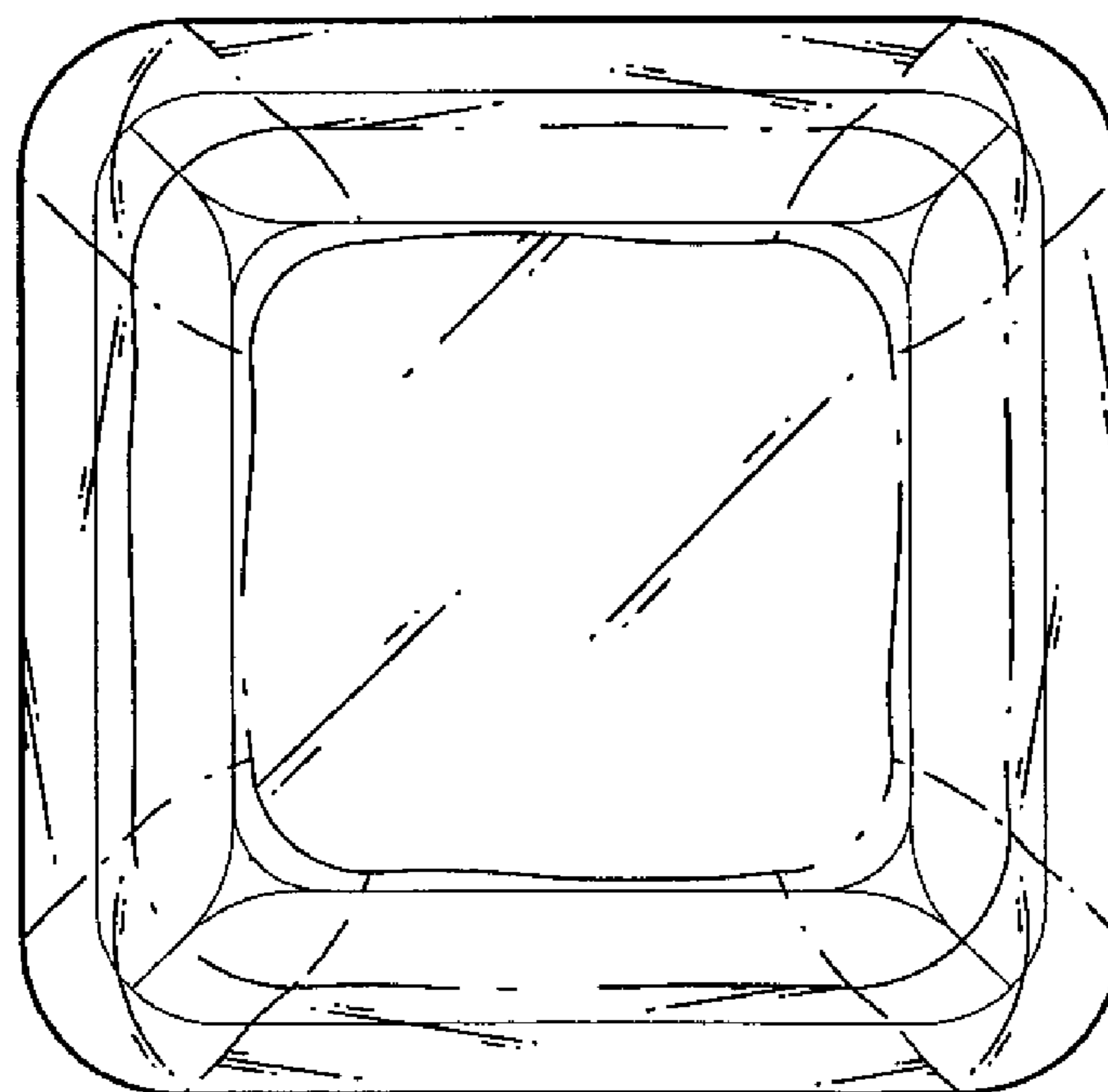
