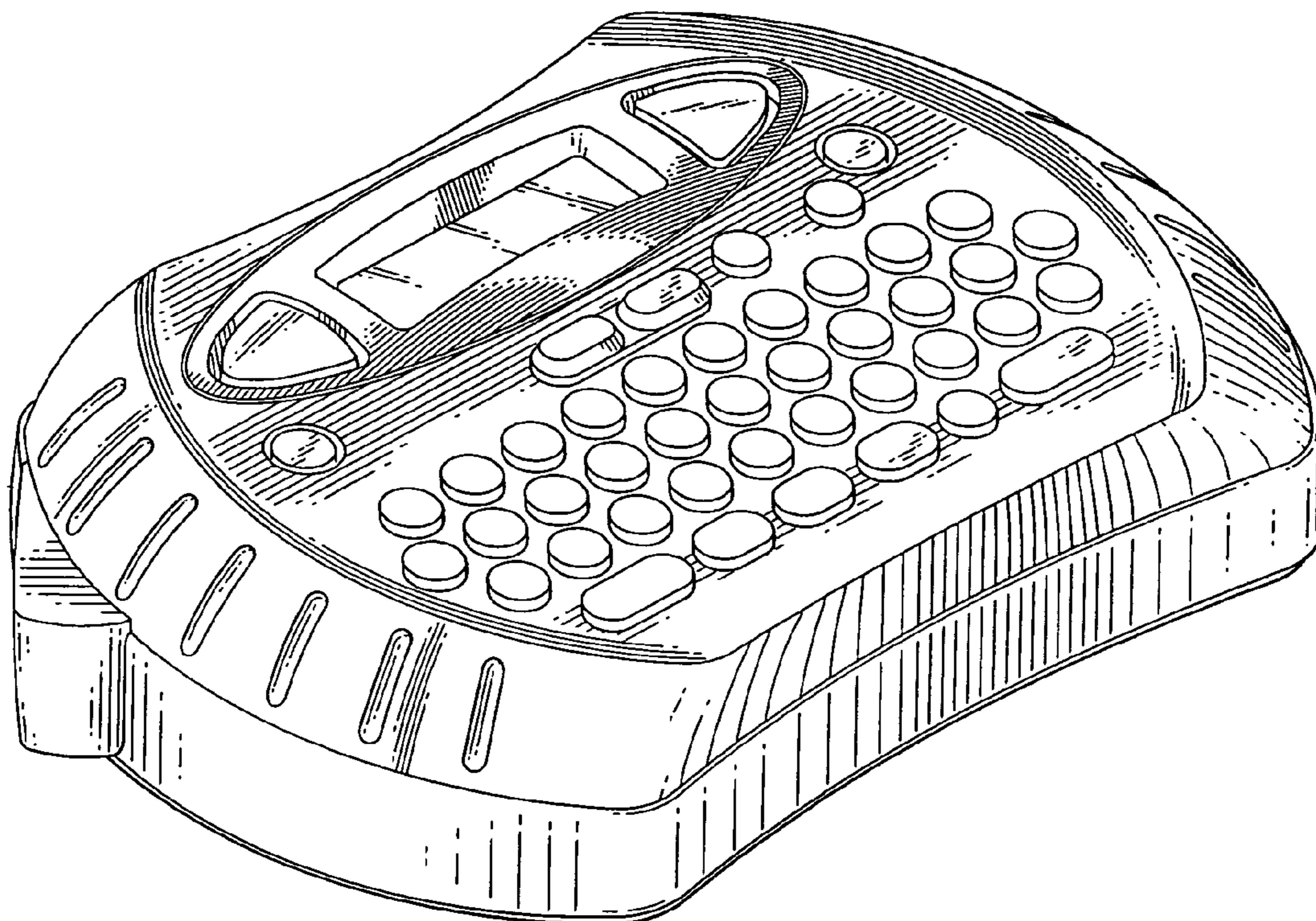
The ornamental design for tape printing machine, as shown and described.

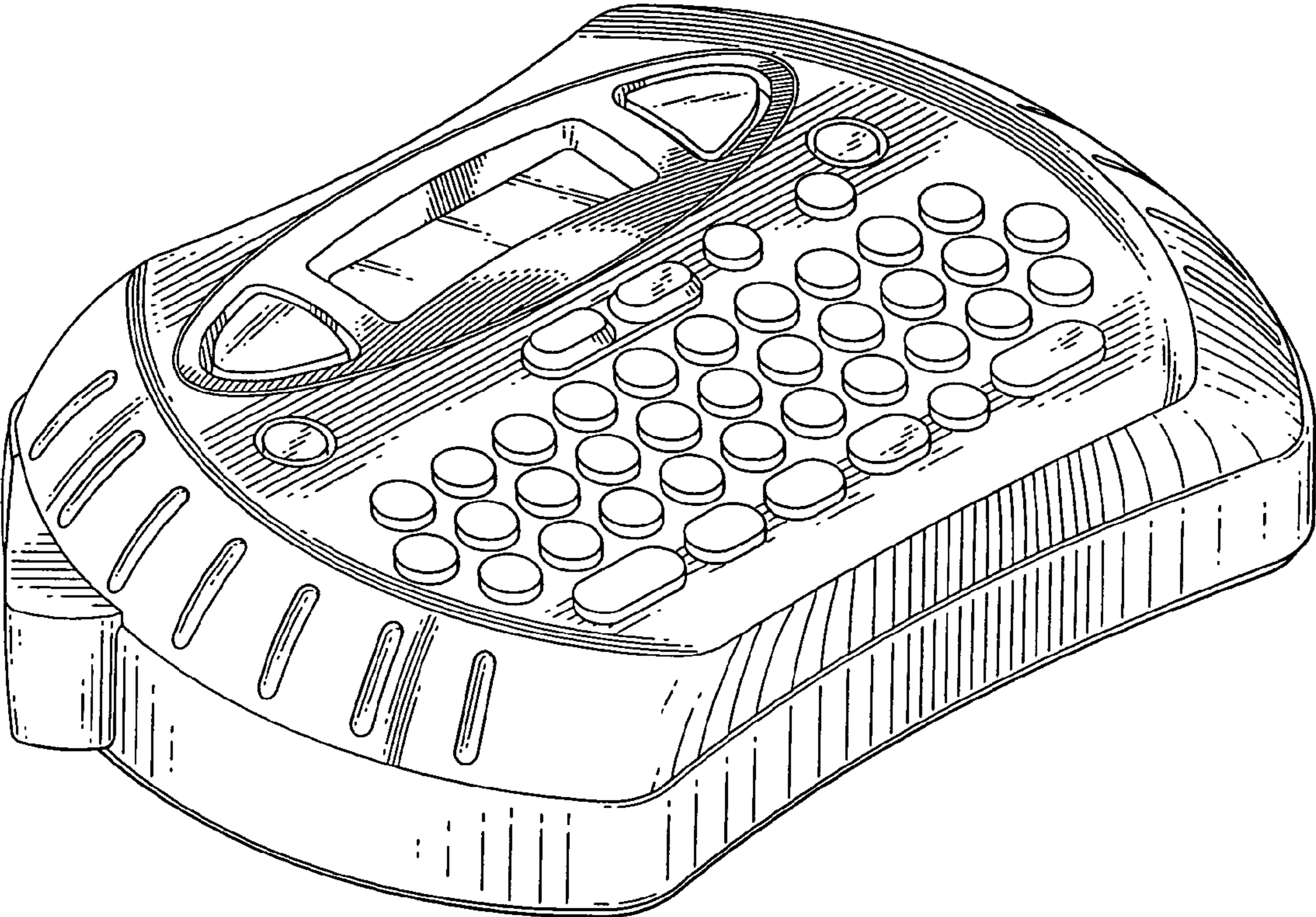

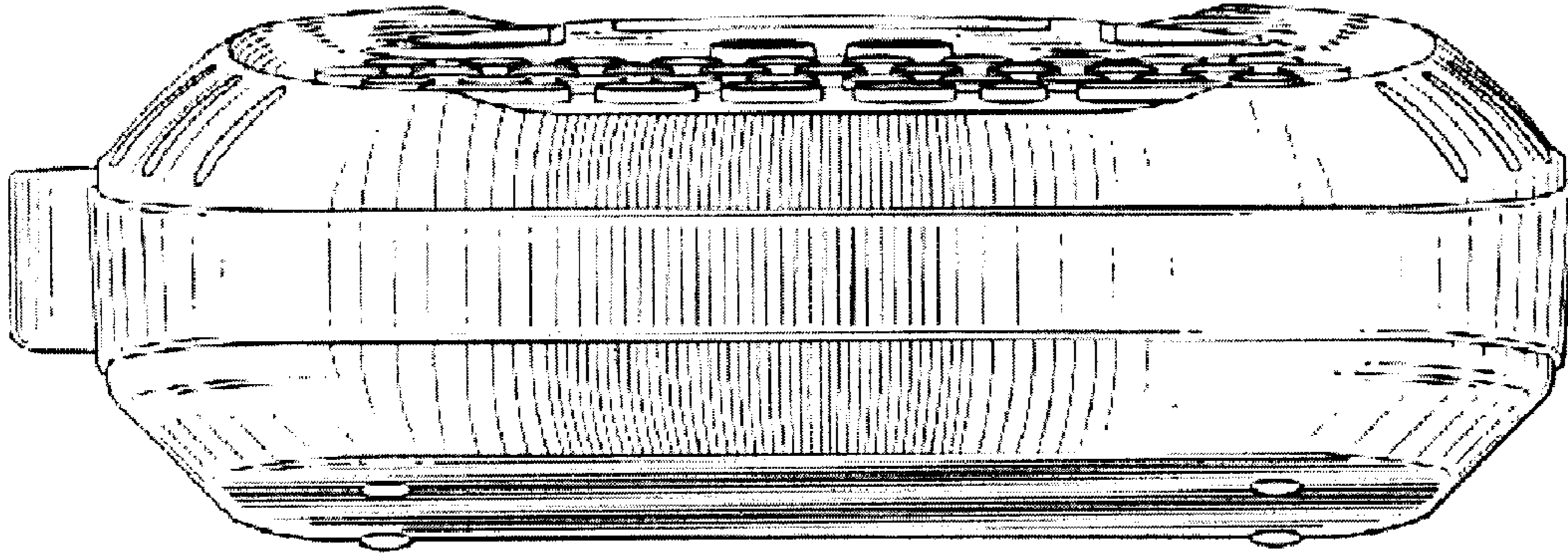

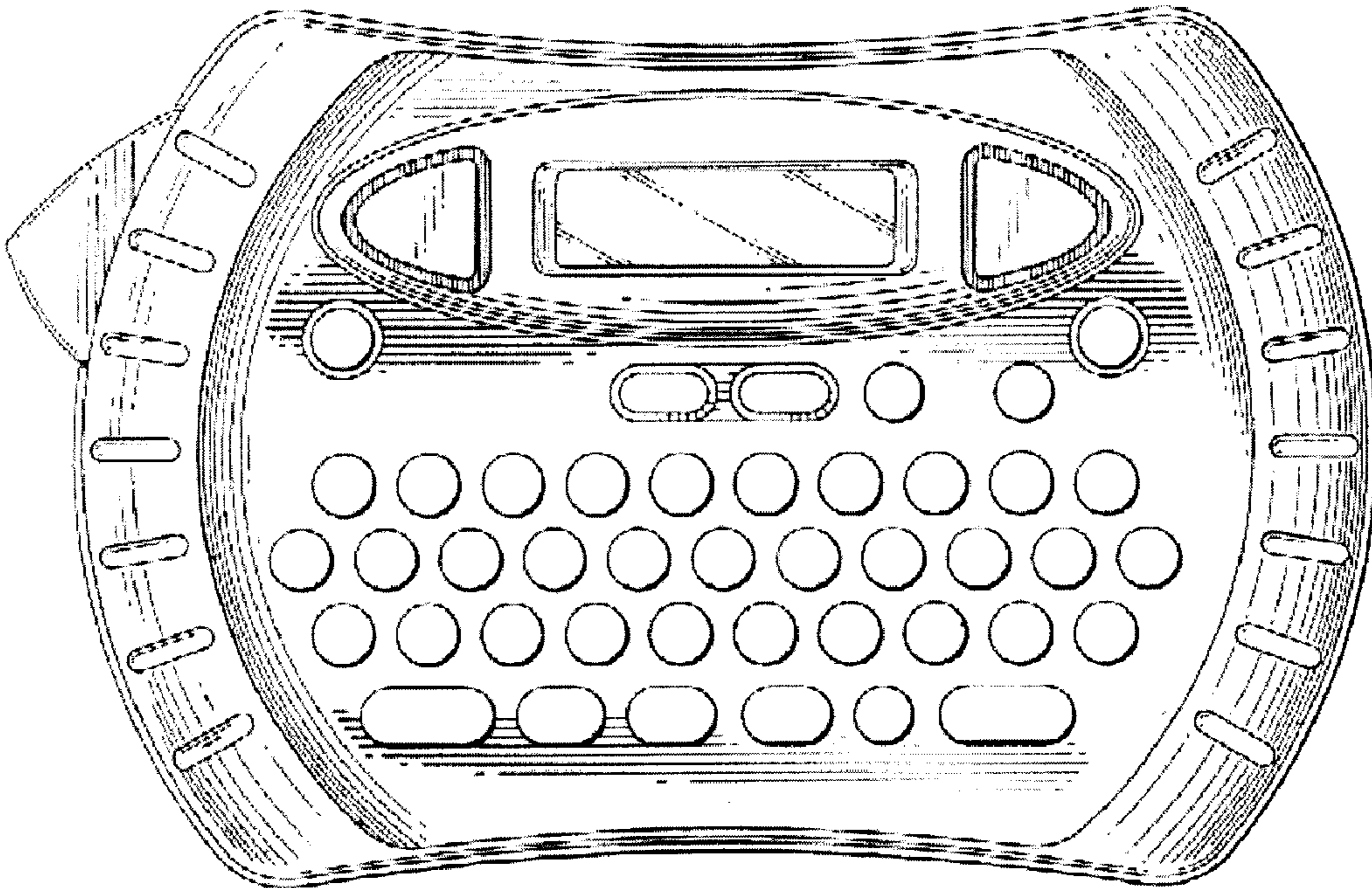

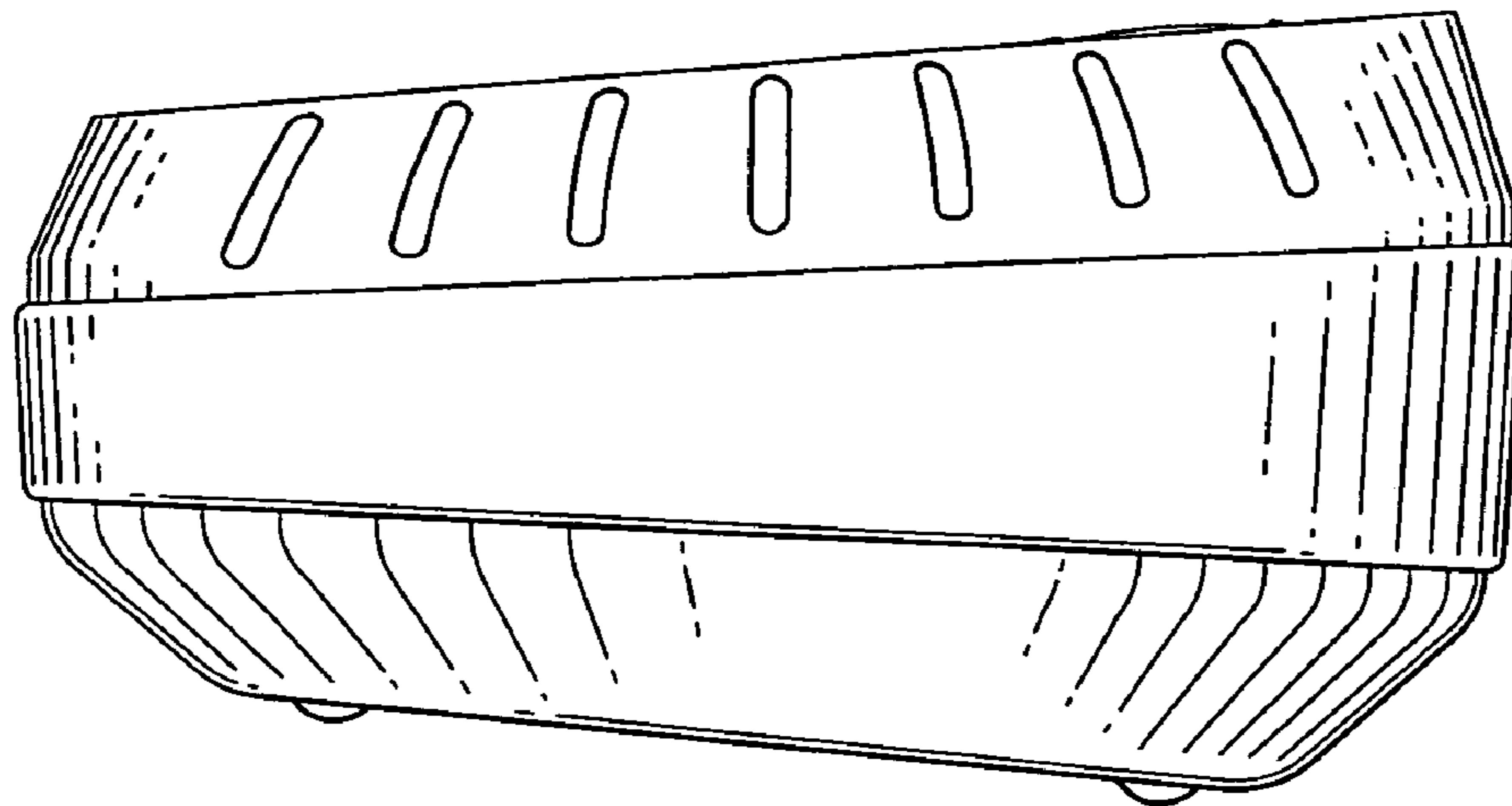

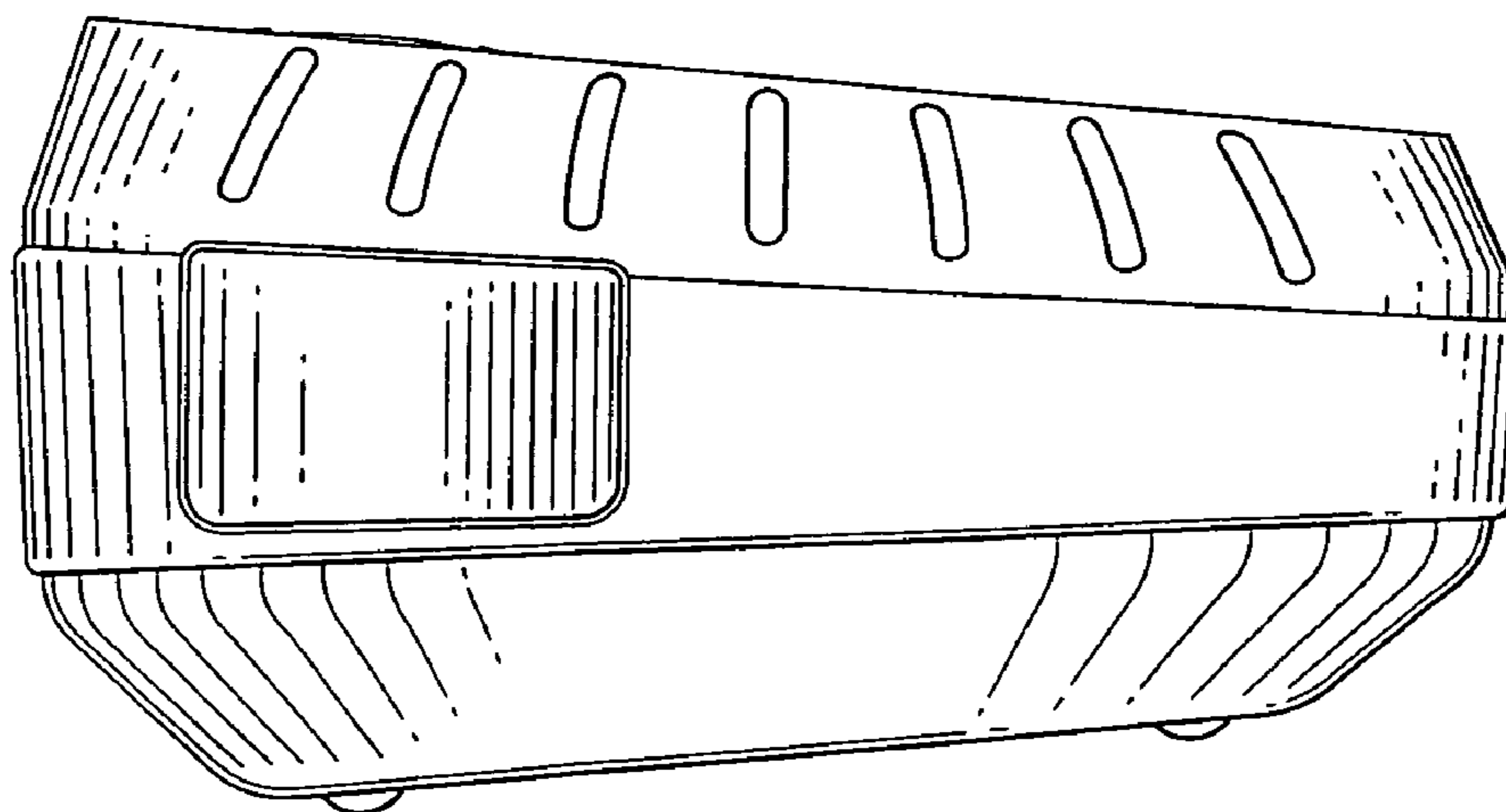

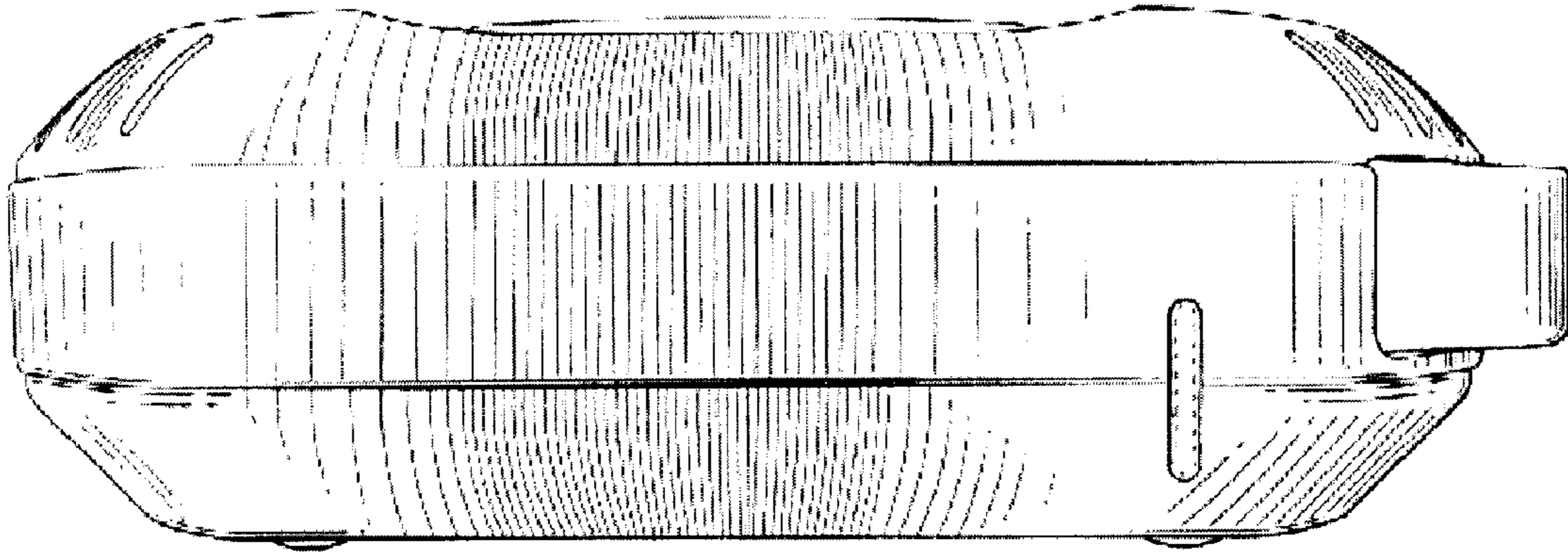

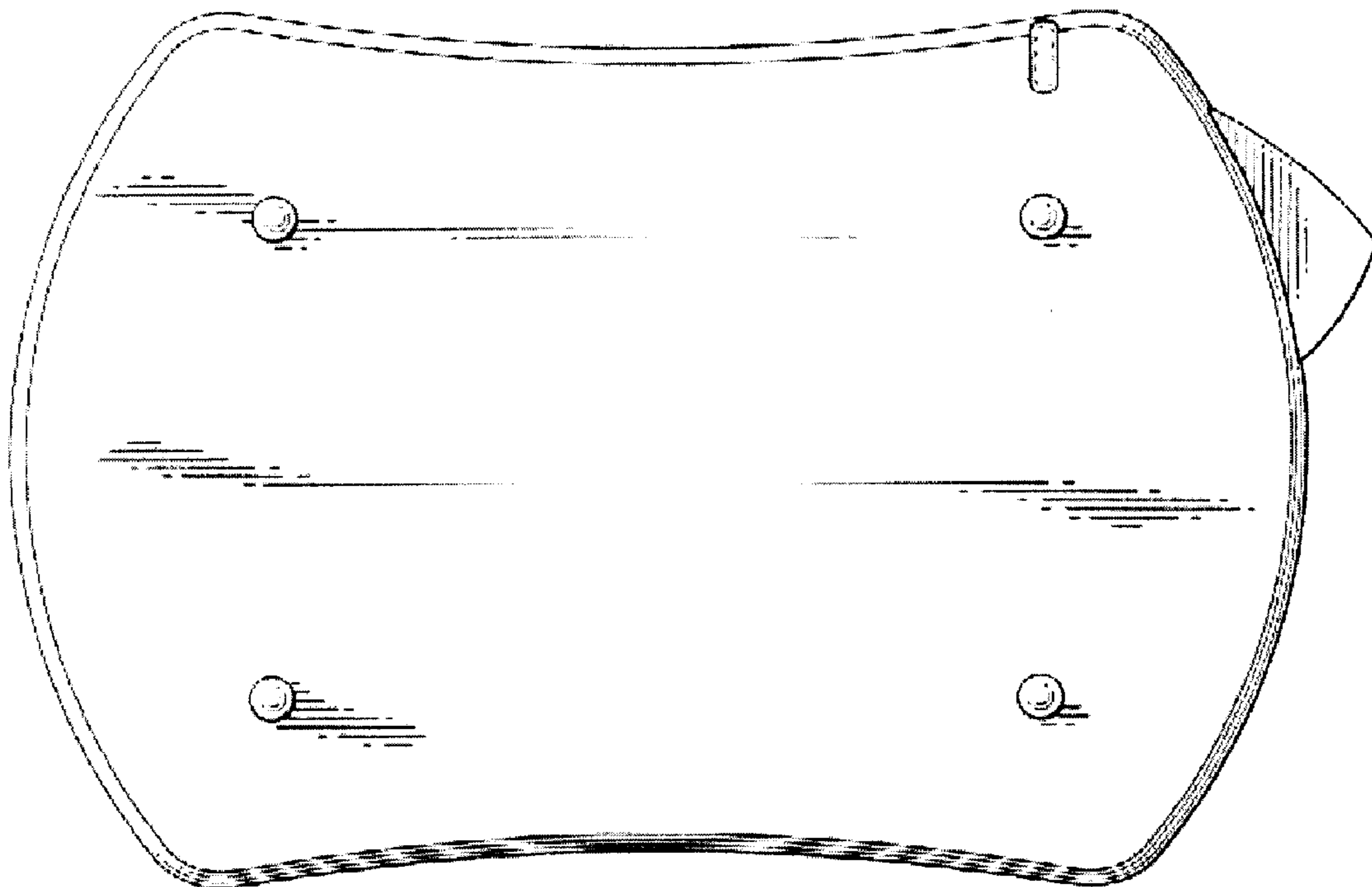
