The ornamental design for a pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right perspective view of a pen showing my new design;

FIG. 11 is a front elevational view thereof;

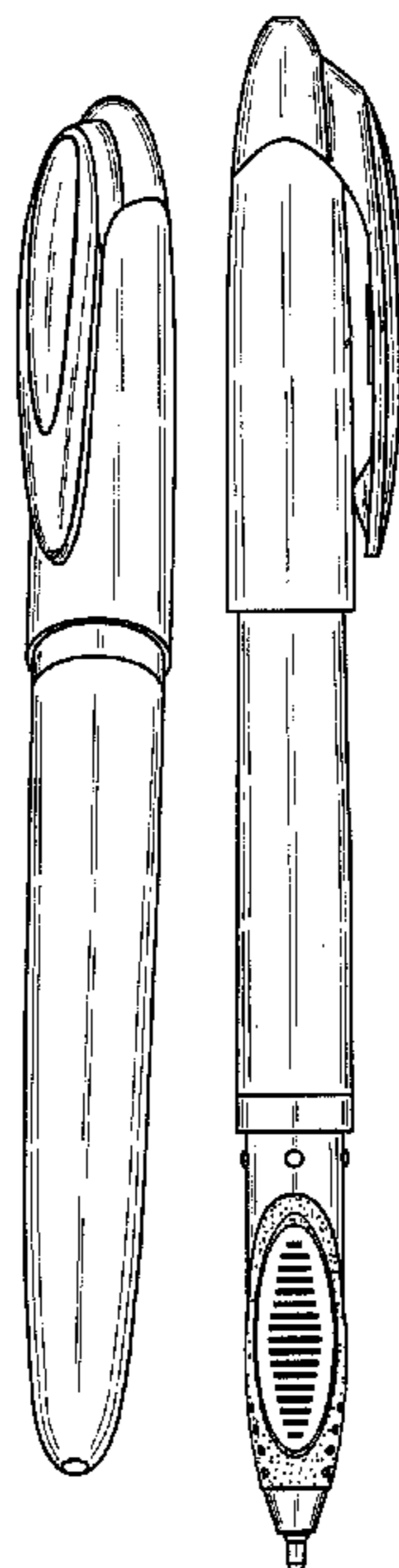
FIG. 12 is a right elevational view thereof;

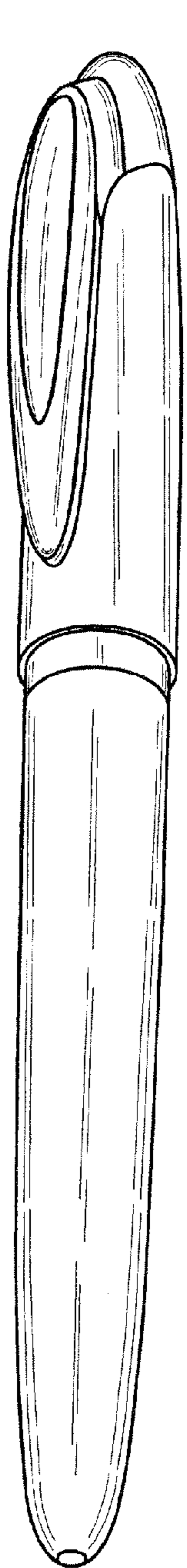
FIG. 13 is a top plan view thereof; and,

FIG. 14 is a rear elevational view thereof.

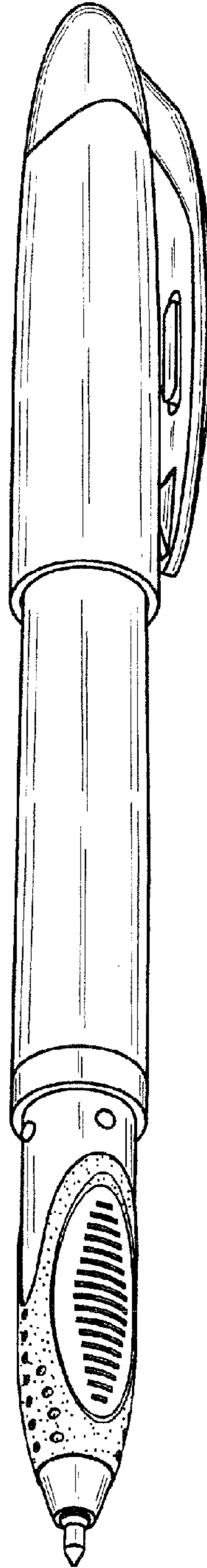
The stippling on the grip represents a surface texture.

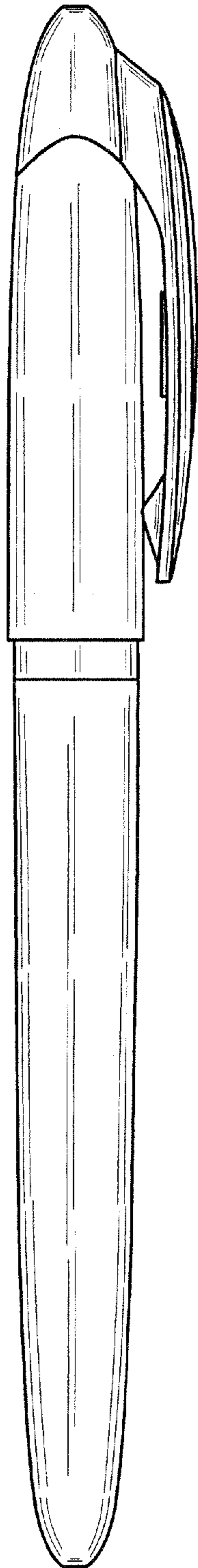




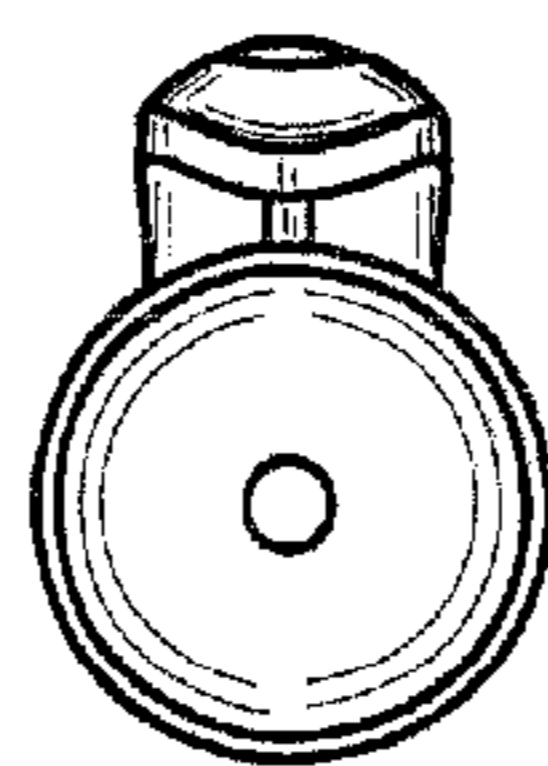

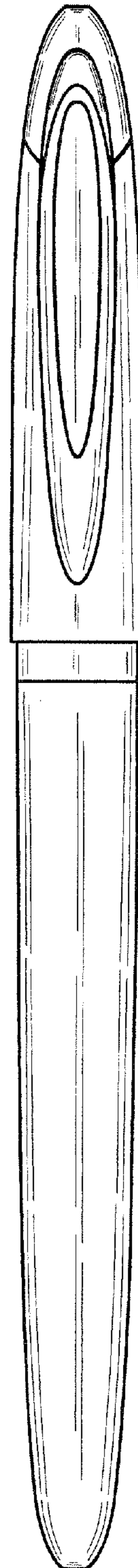

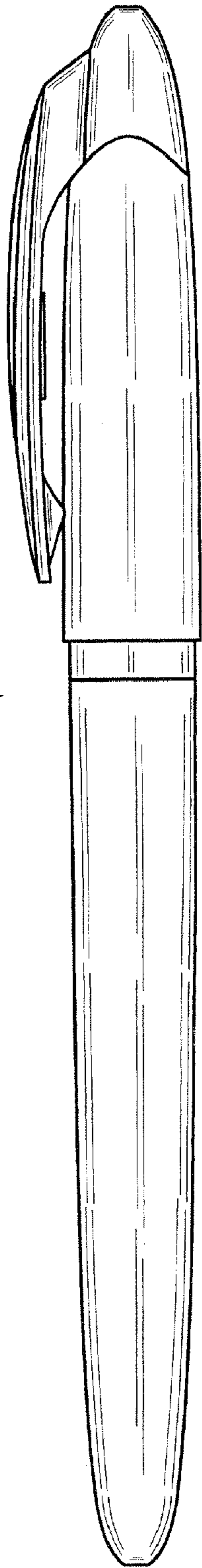

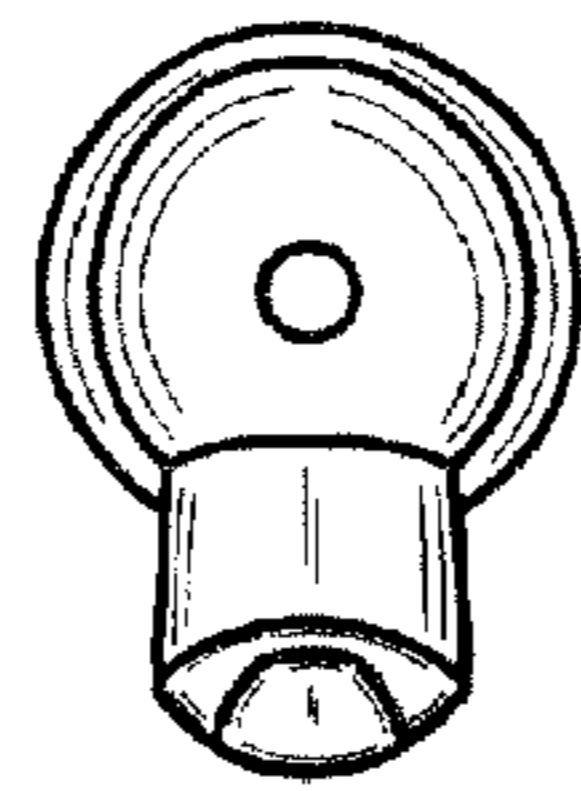

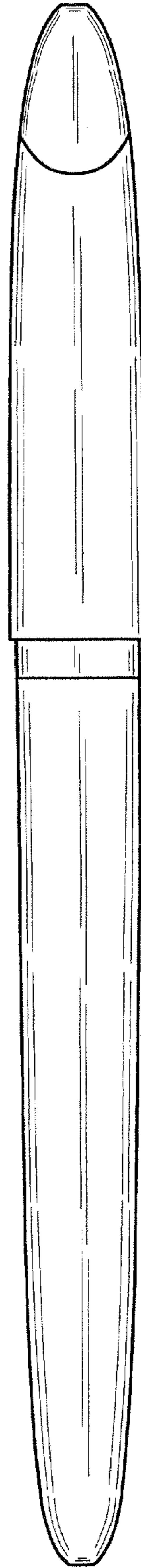

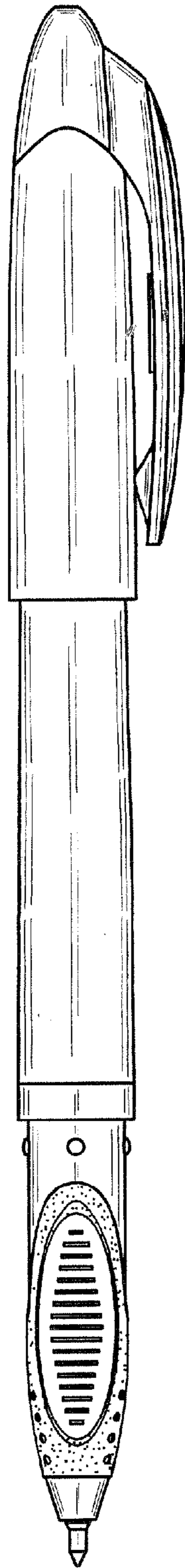

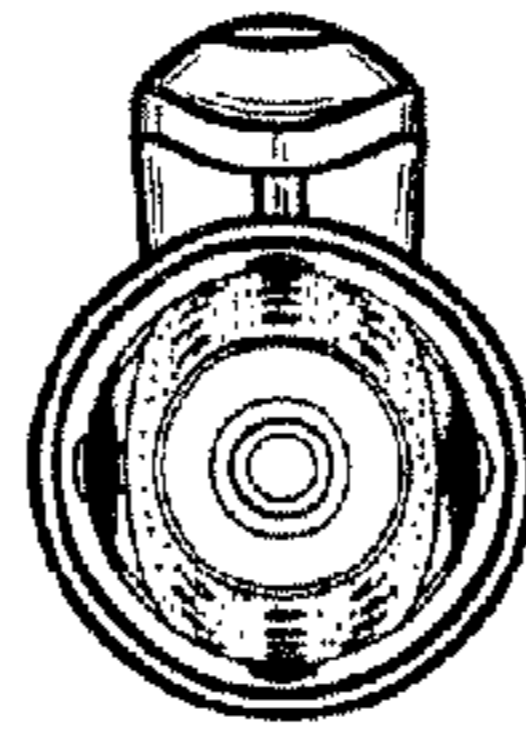

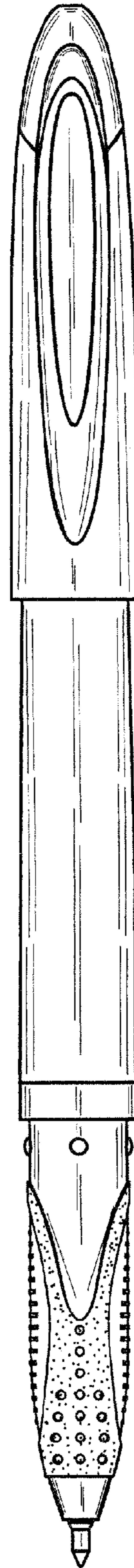

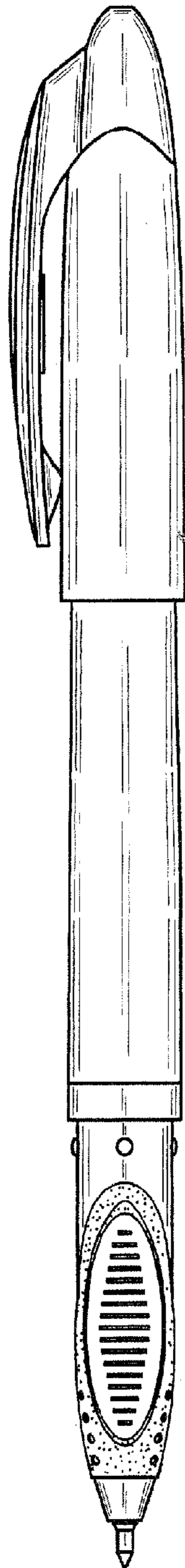

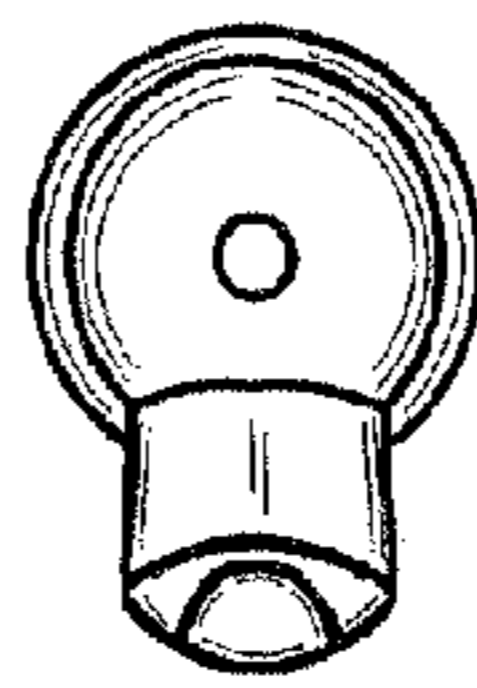

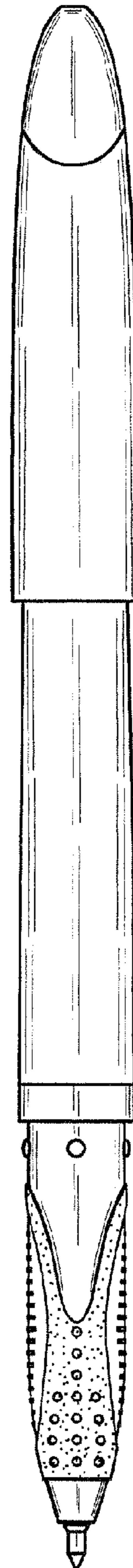
