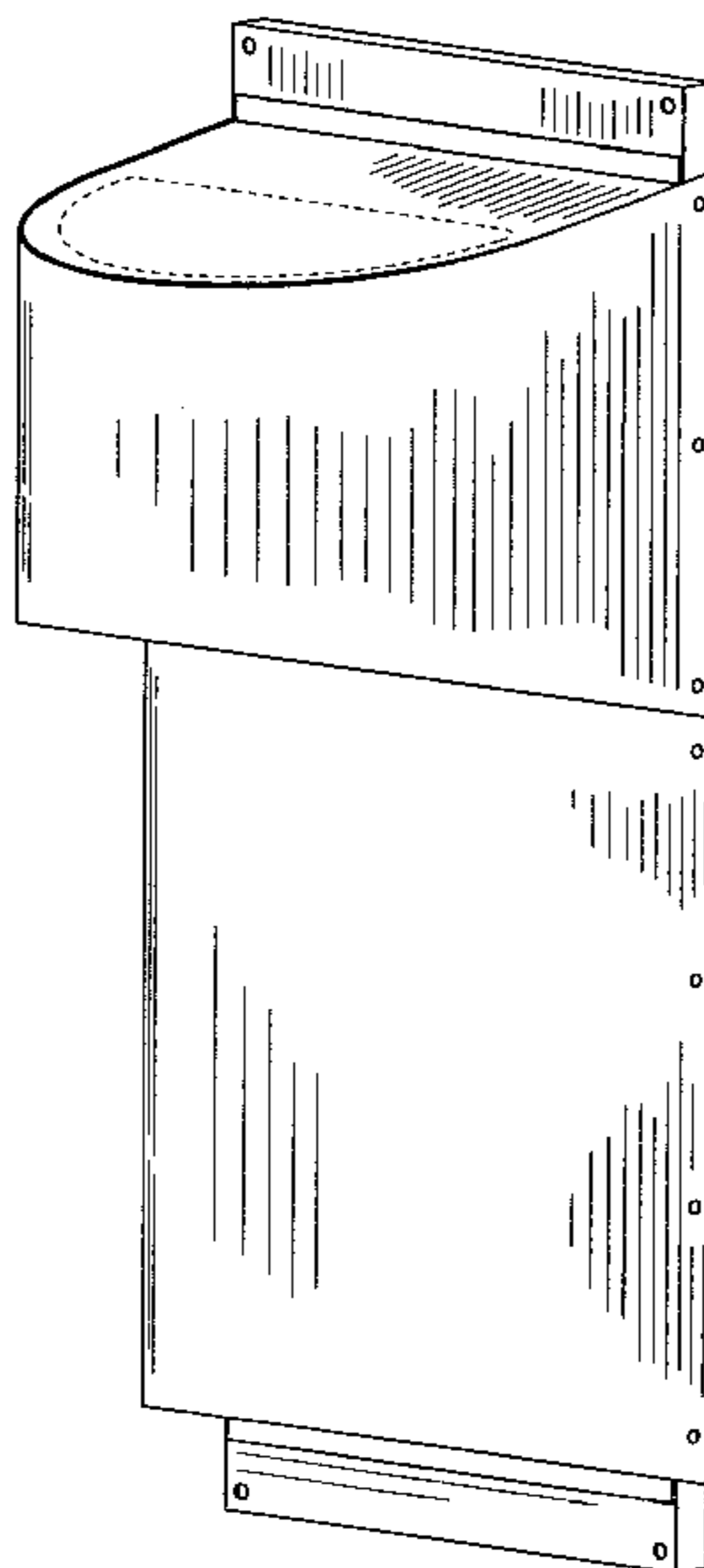
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the vent cap.
 FIG. 2 is a front view of the vent cap.
 FIG. 3 is a rear view of the vent cap.
 FIG. 4 is a side view of the vent cap.
 FIG. 5 is a top view of the vent cap; and,
 FIG. 6 is a bottom view of the vent cap.

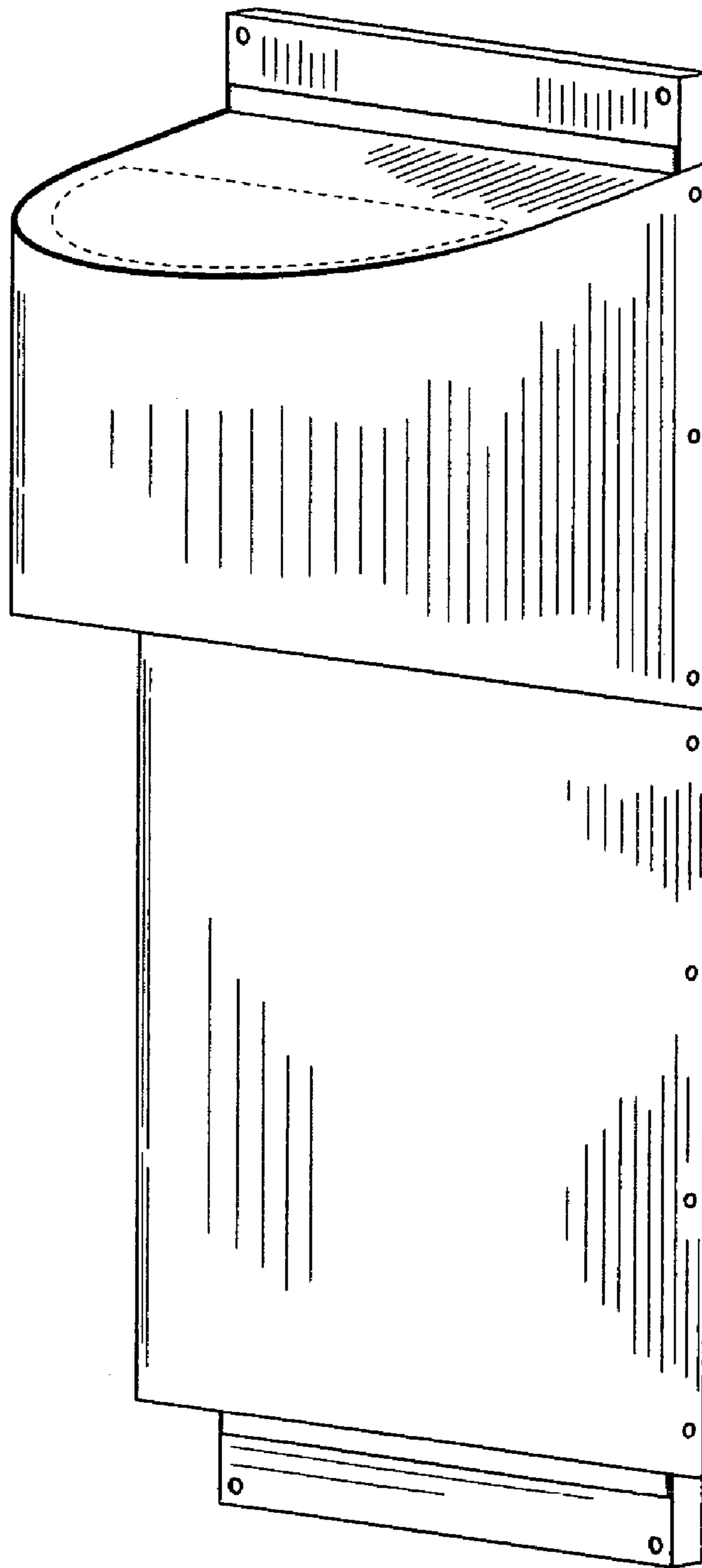

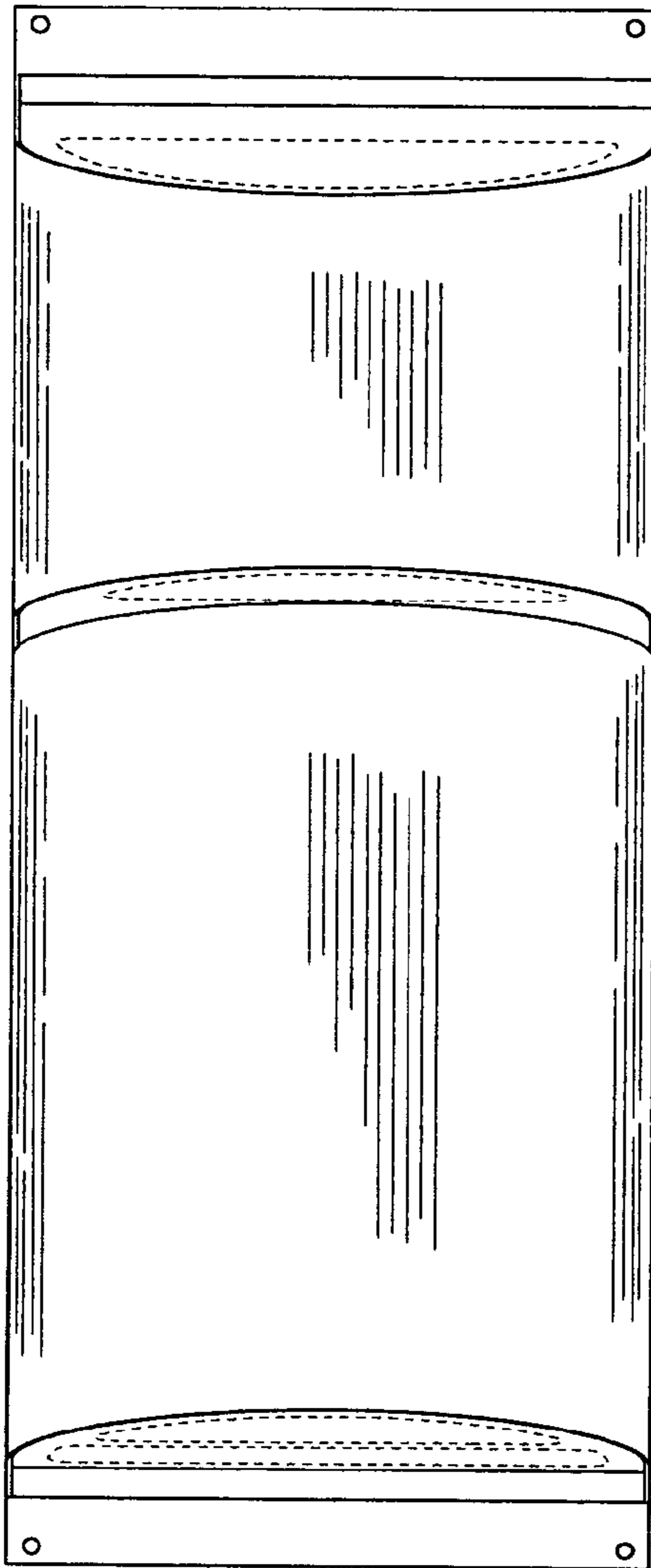

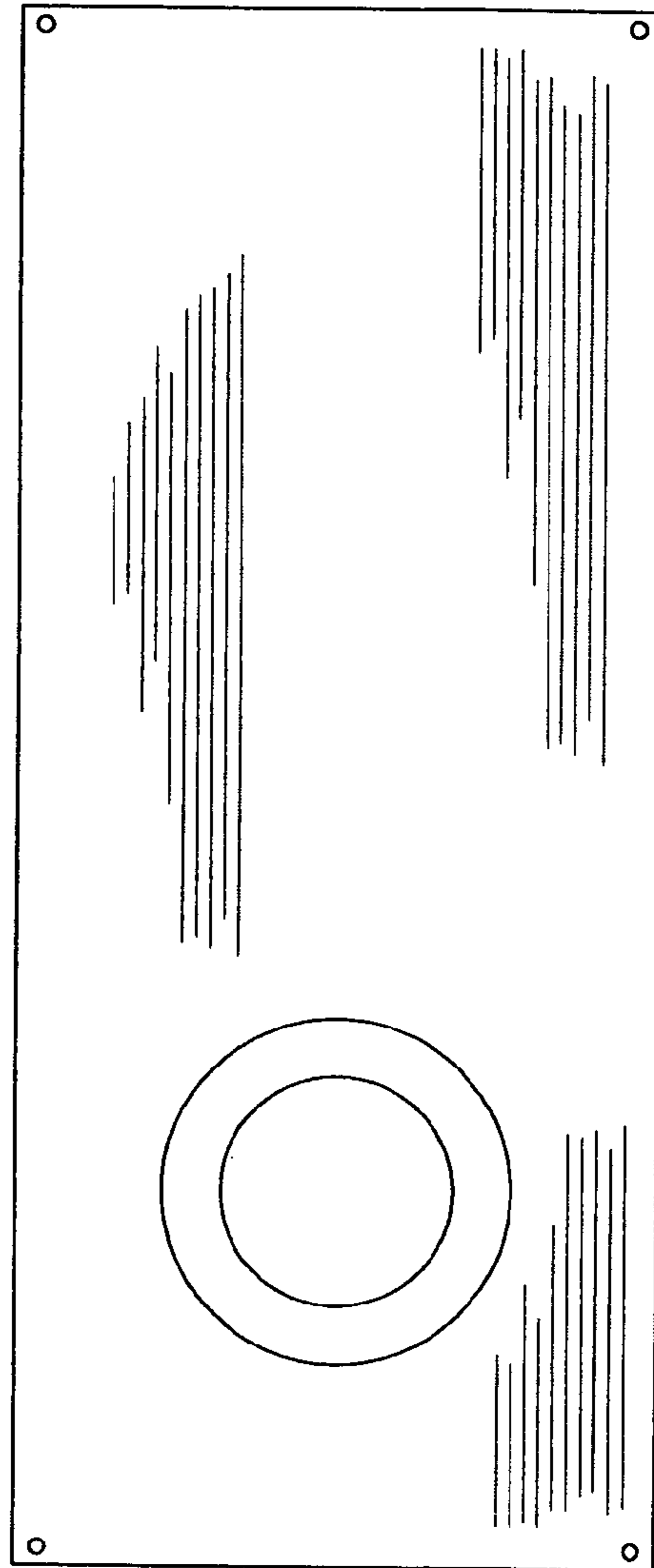

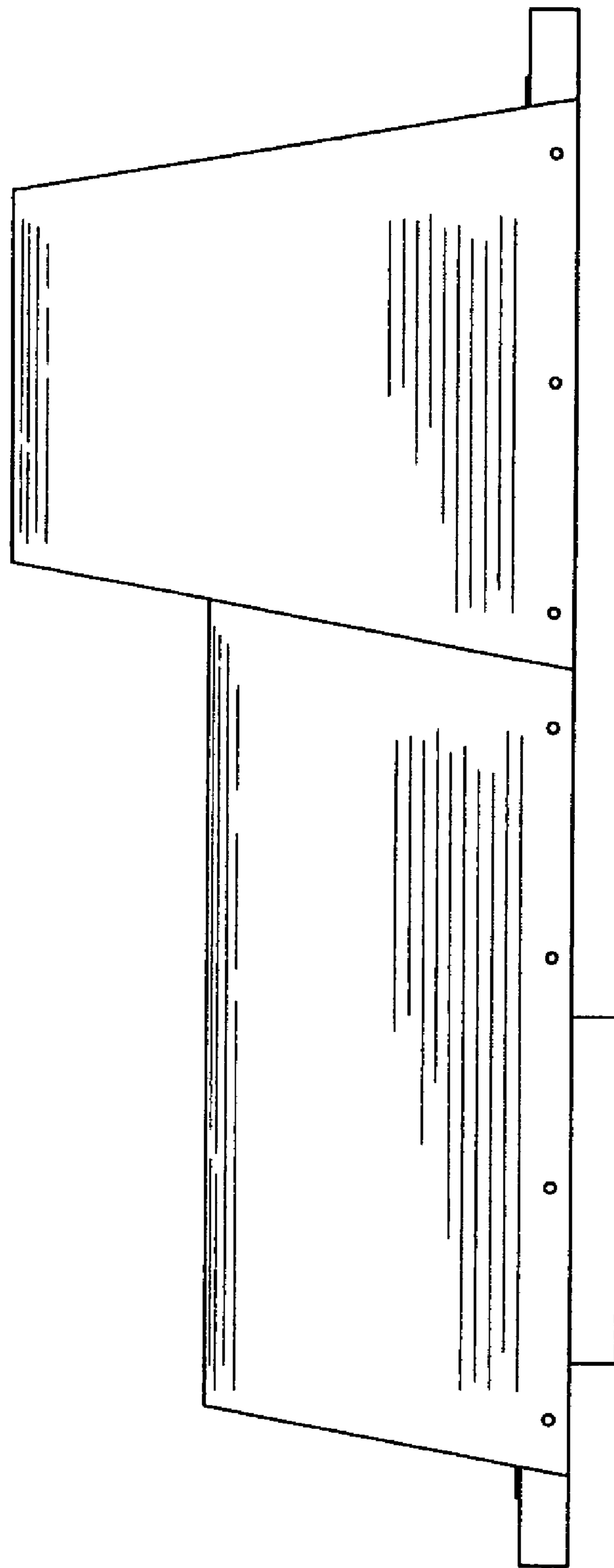

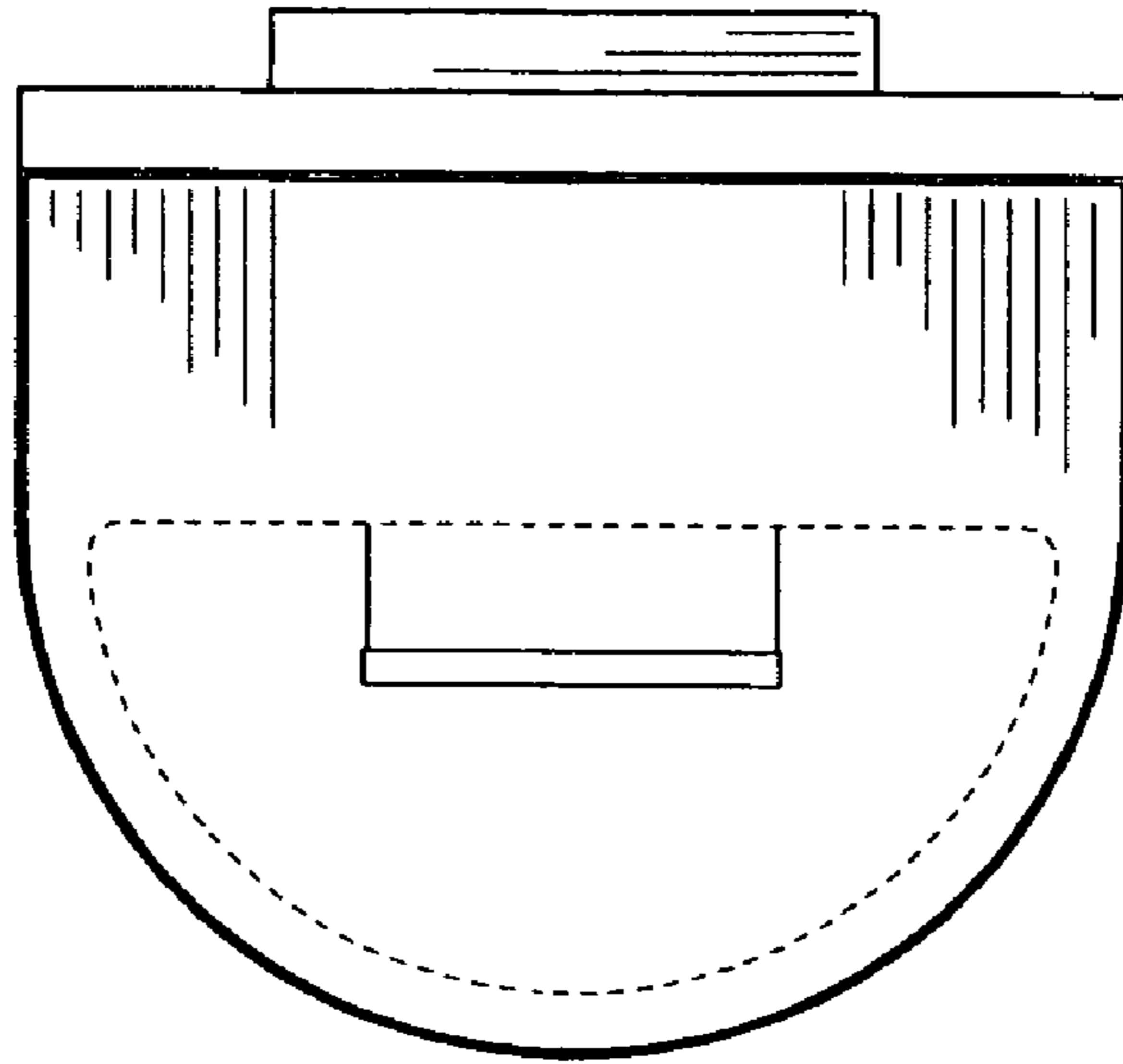

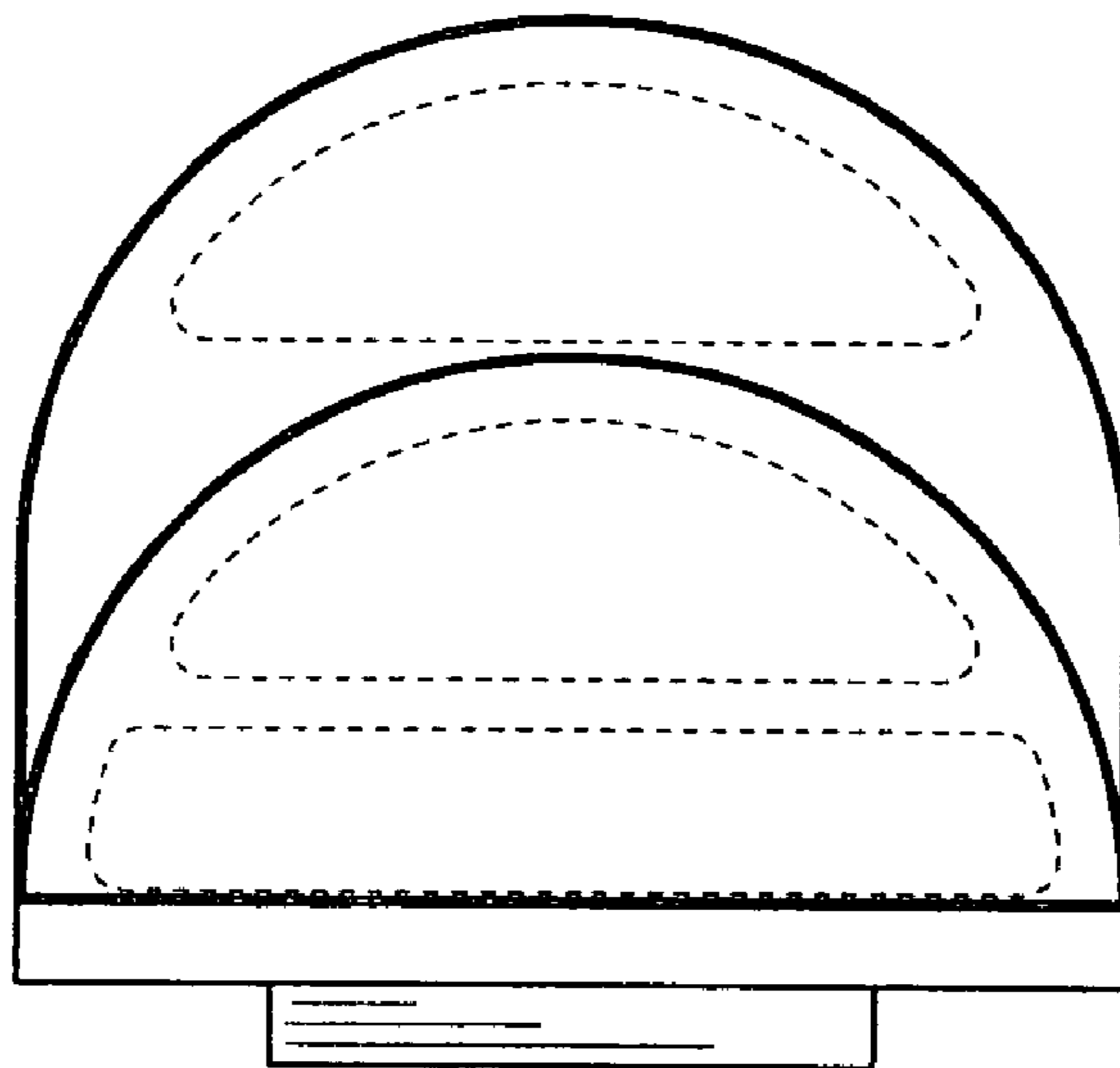
