DESCRIPTION

FIG. 1 is a front perspective view of a reusable cuff barrier with fingers and thumb enclosed, showing my new design.

FIG. 2 is a rear perspective view thereof with fingers and thumb exposed.

FIG. 3 is a front elevation view thereof.

FIG. 4 is a rear elevation view thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof.

FIG. 7 is a left side elevation view thereof; and,

FIG. 8 is a right side elevation view thereof.

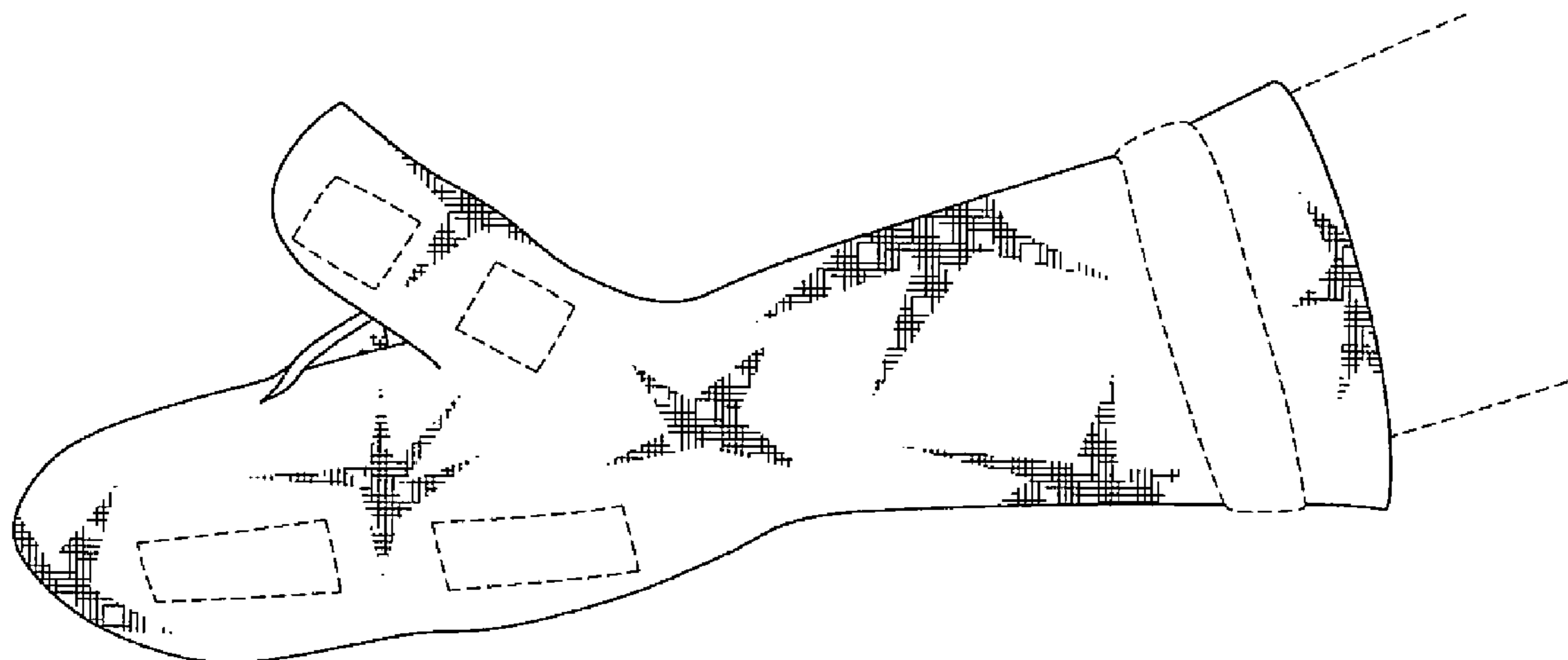

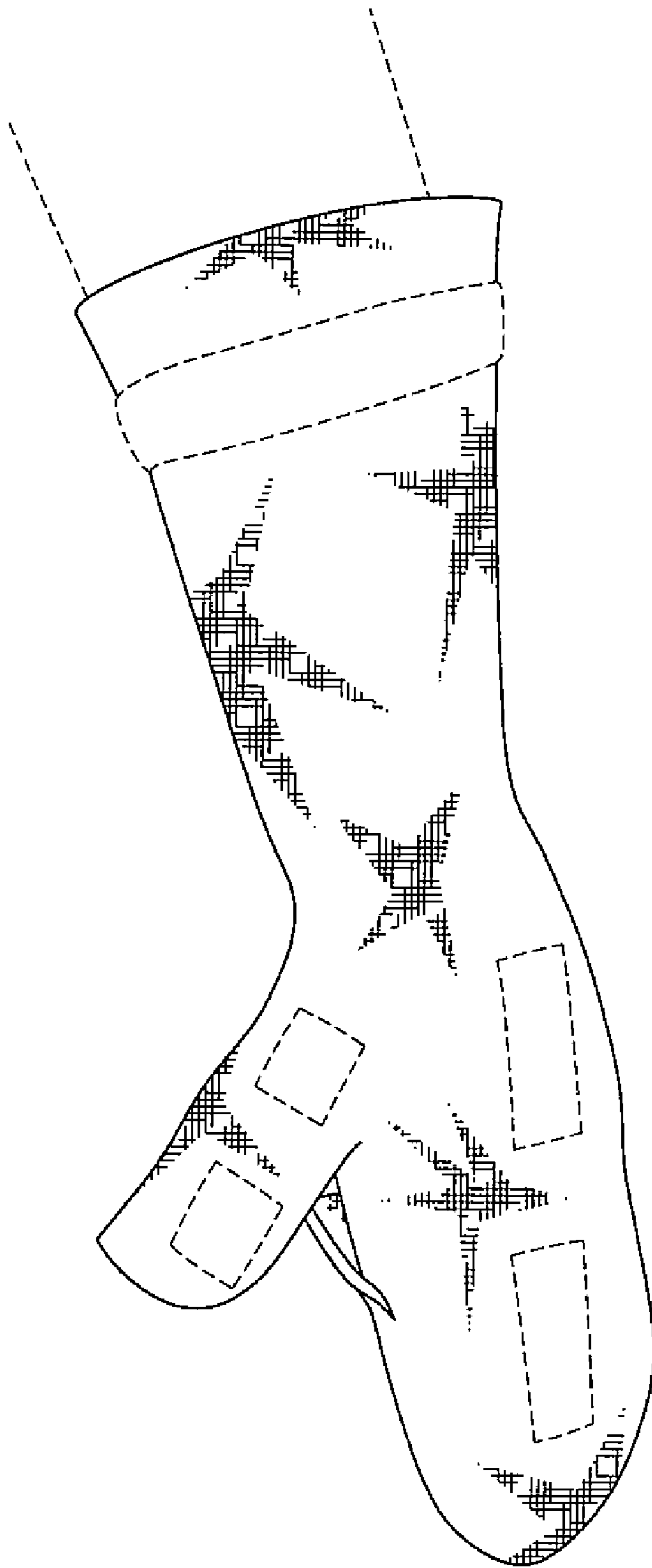

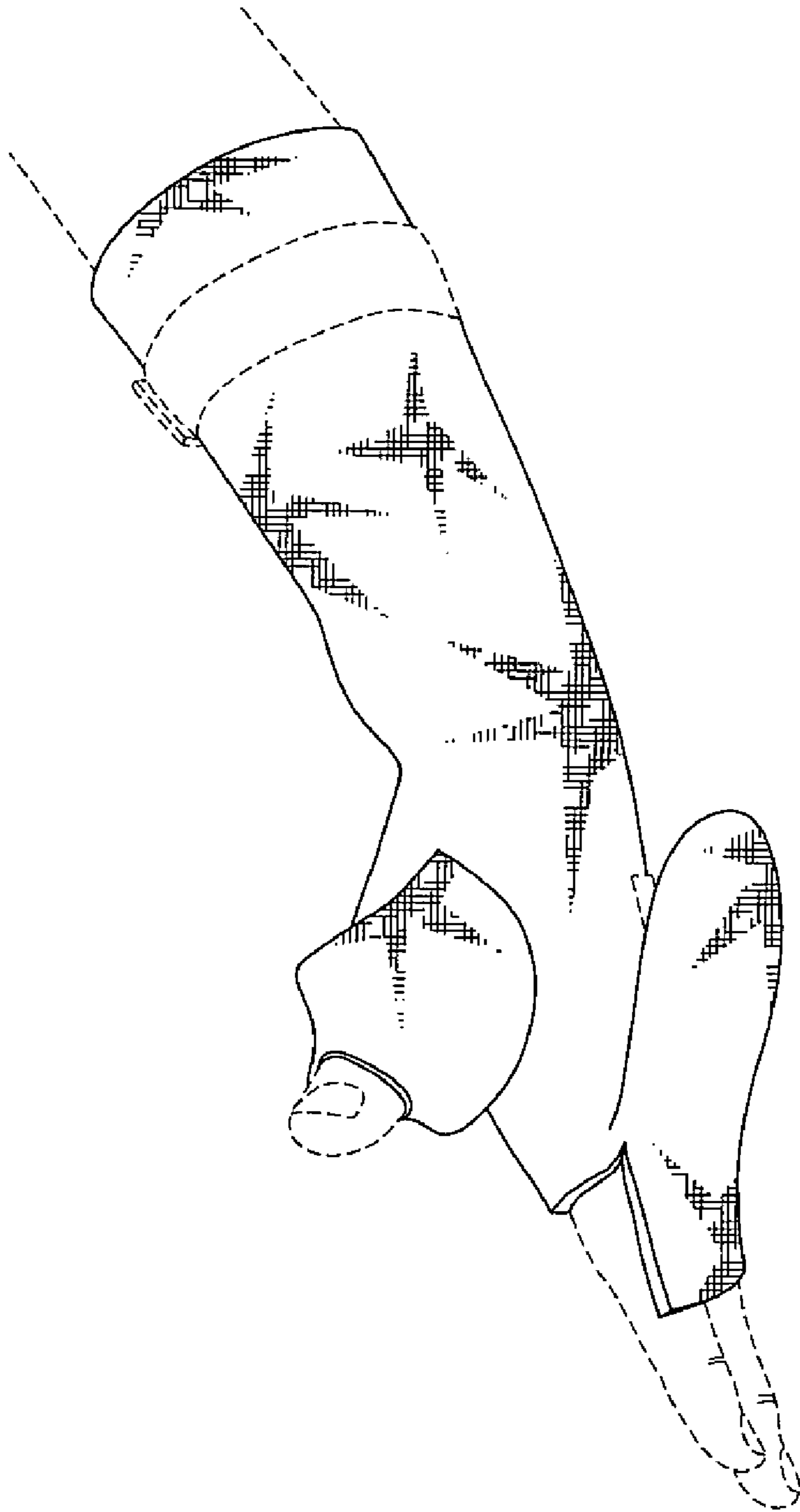

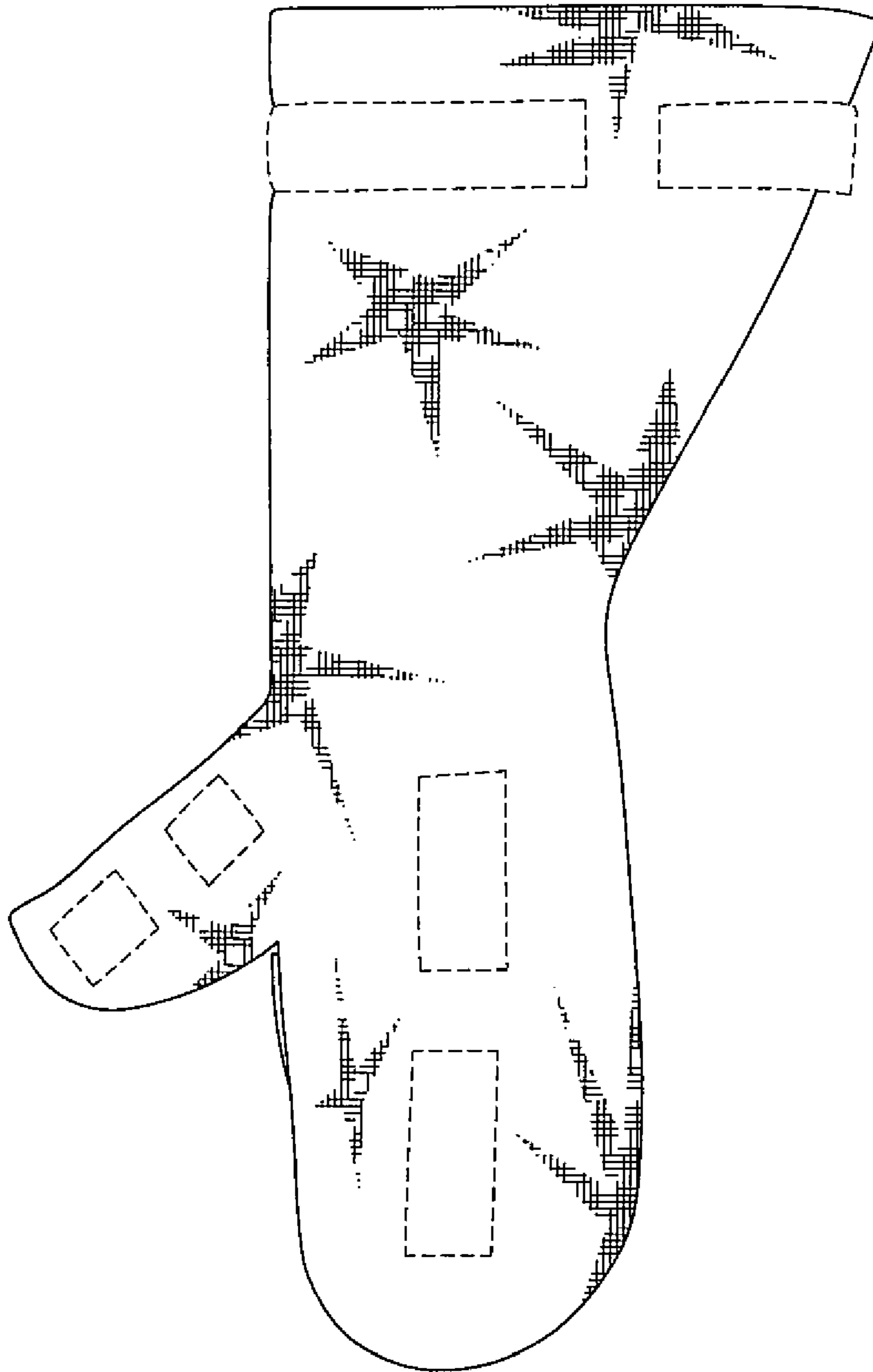

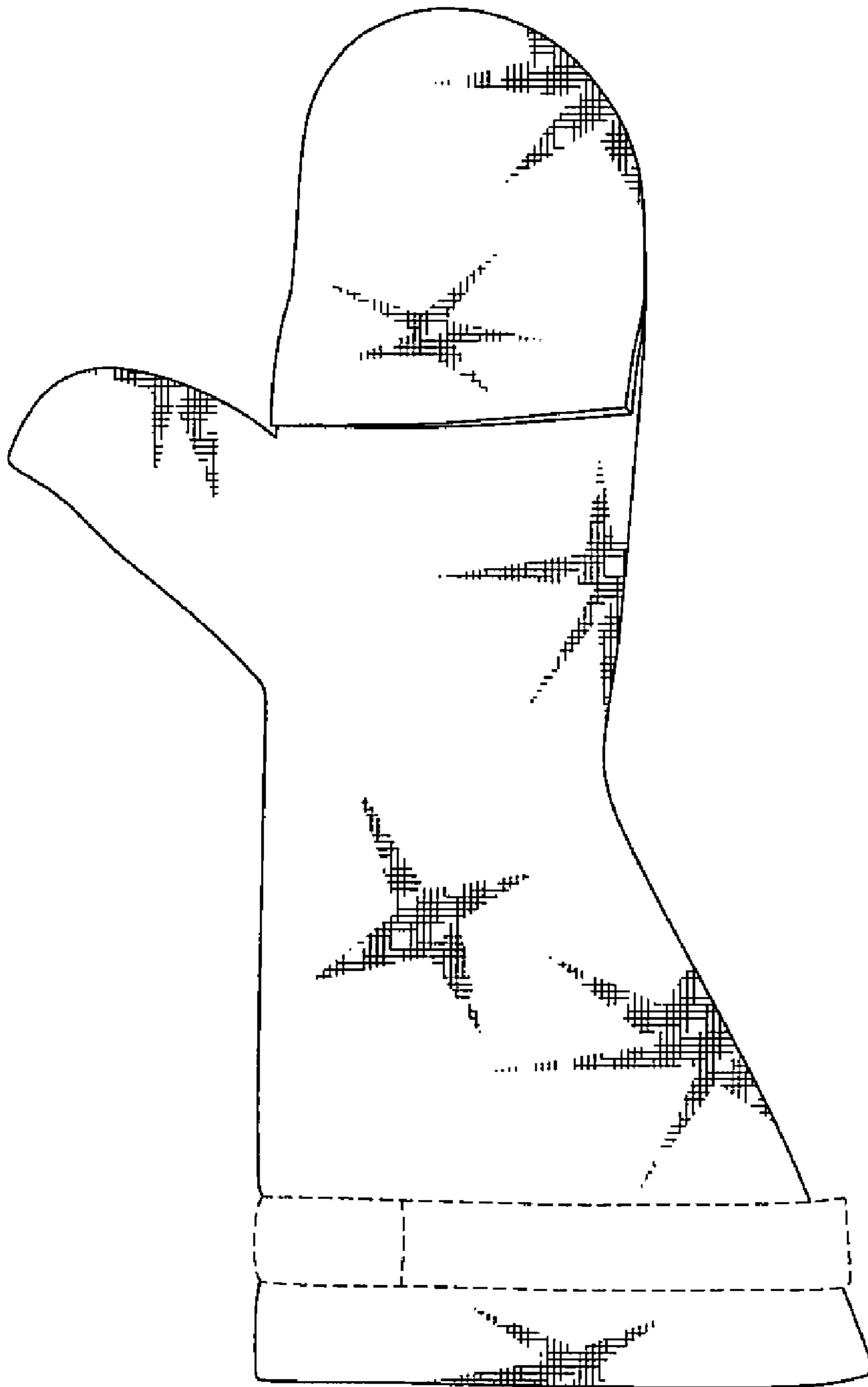

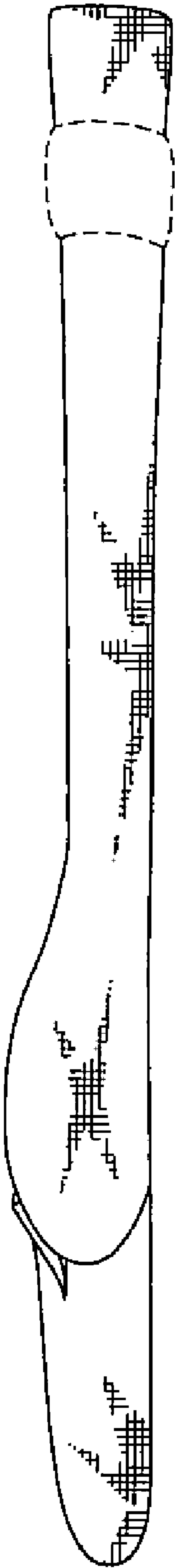

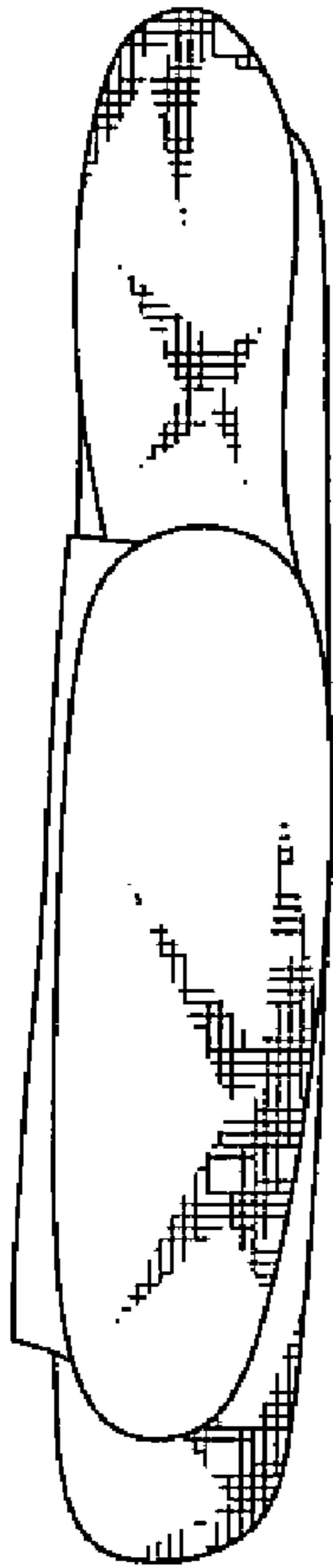

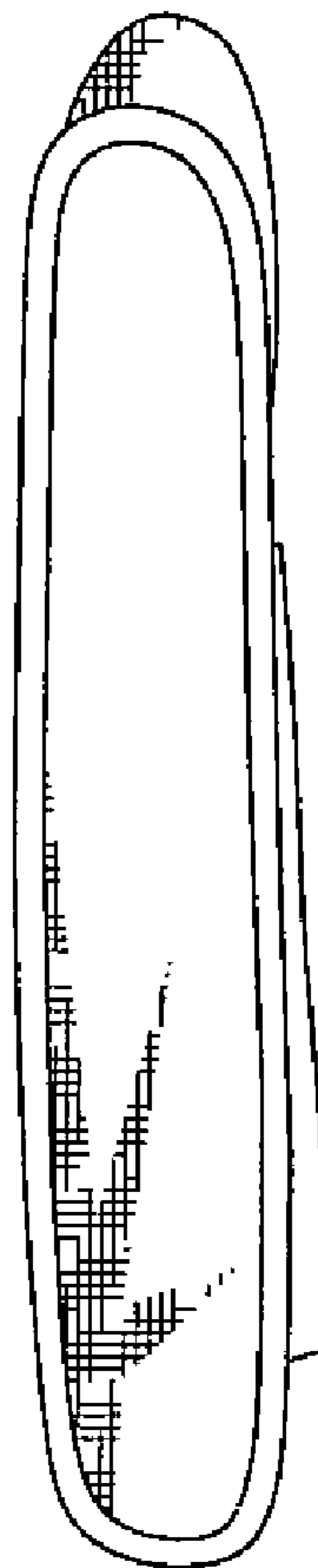
