(57) **CLAIM**

The ornamental design for a folding mirror, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a folding mirror showing my new design;

FIG. 2 is a front view of the mirror of FIG. 1;

FIG. 3 is a rear view of the mirror of FIG. 1;

FIG. 4 is a right side view of the mirror of FIG. 1;

FIG. 5 is a left side view of the mirror of FIG. 1;

FIG. 6 is a top view of the mirror of FIG. 1;

FIG. 7 is a bottom view of the mirror of FIG. 1;

FIG. 8 is a perspective view of the mirror of FIG. 1 showing the mirror in an open configuration; and,

FIG. 9 is a front view of the mirror of FIG. 8.

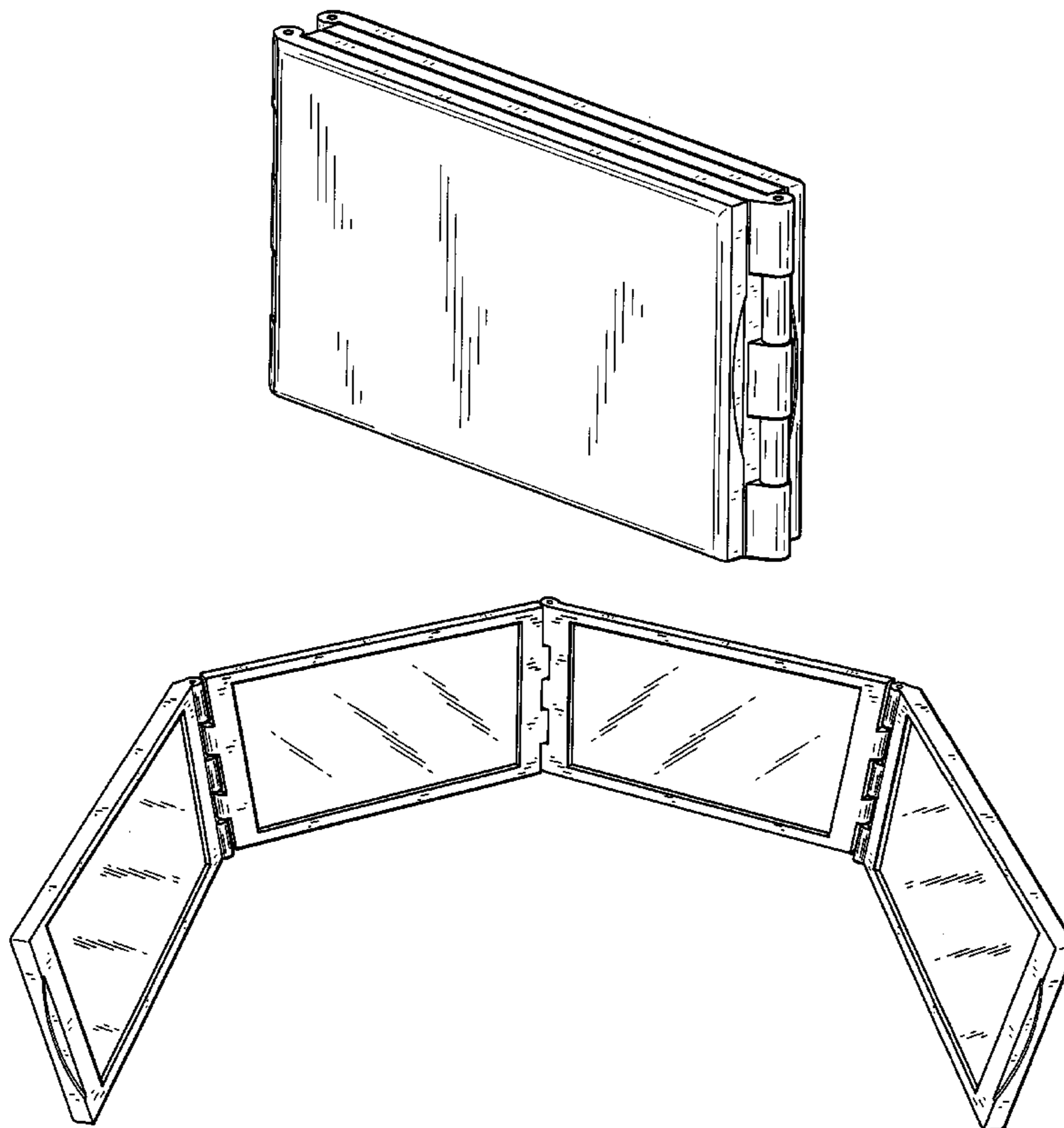

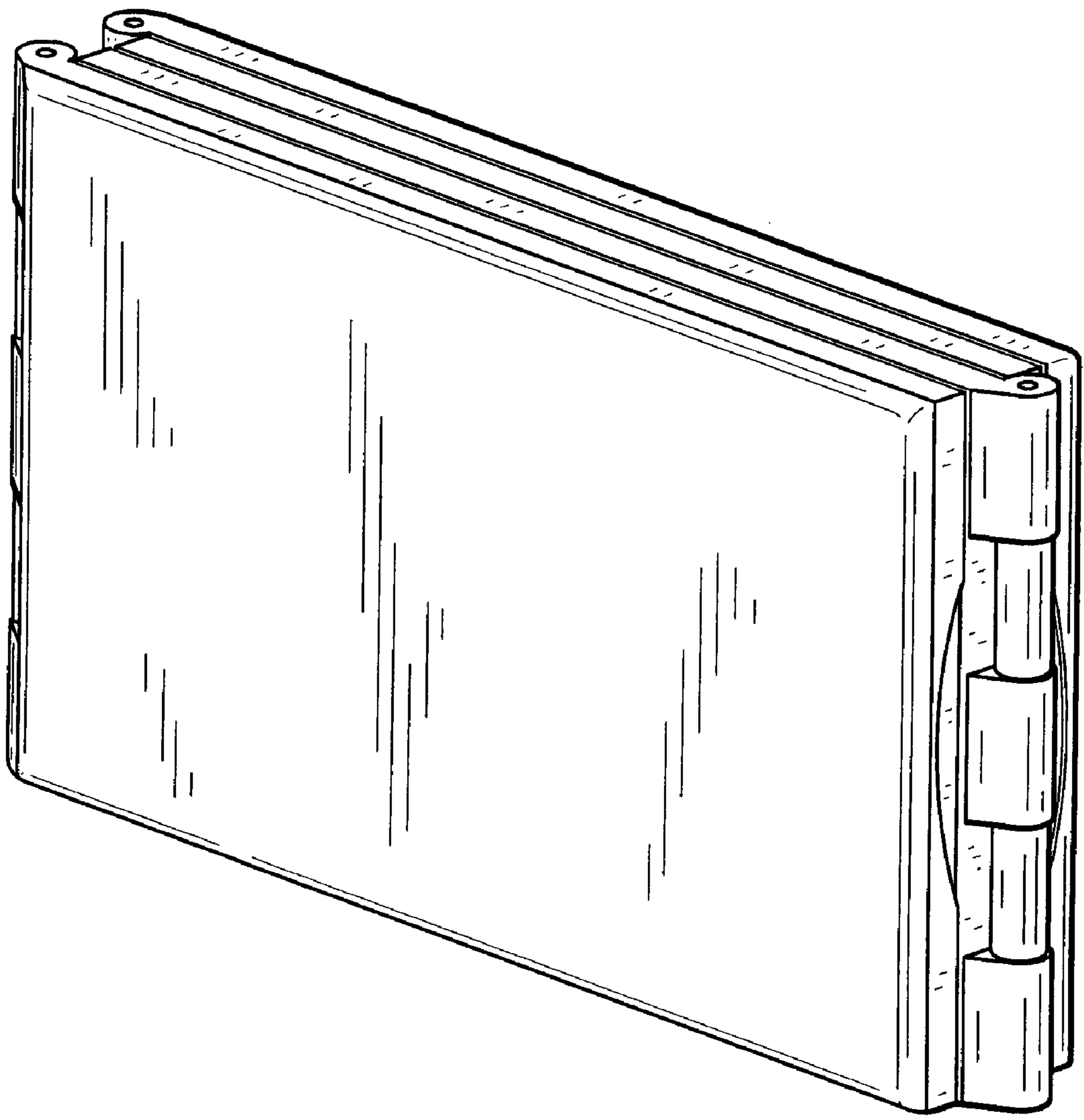

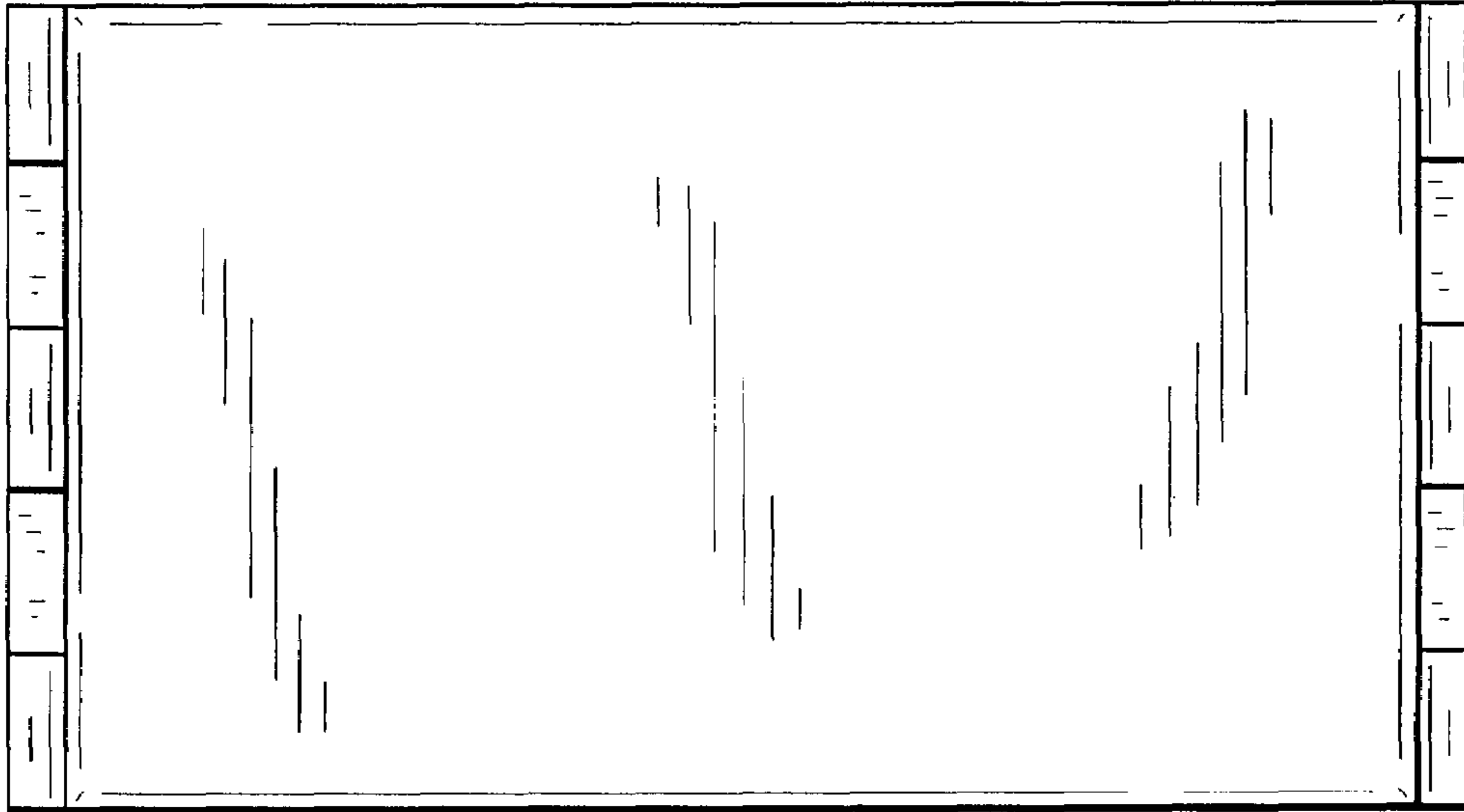

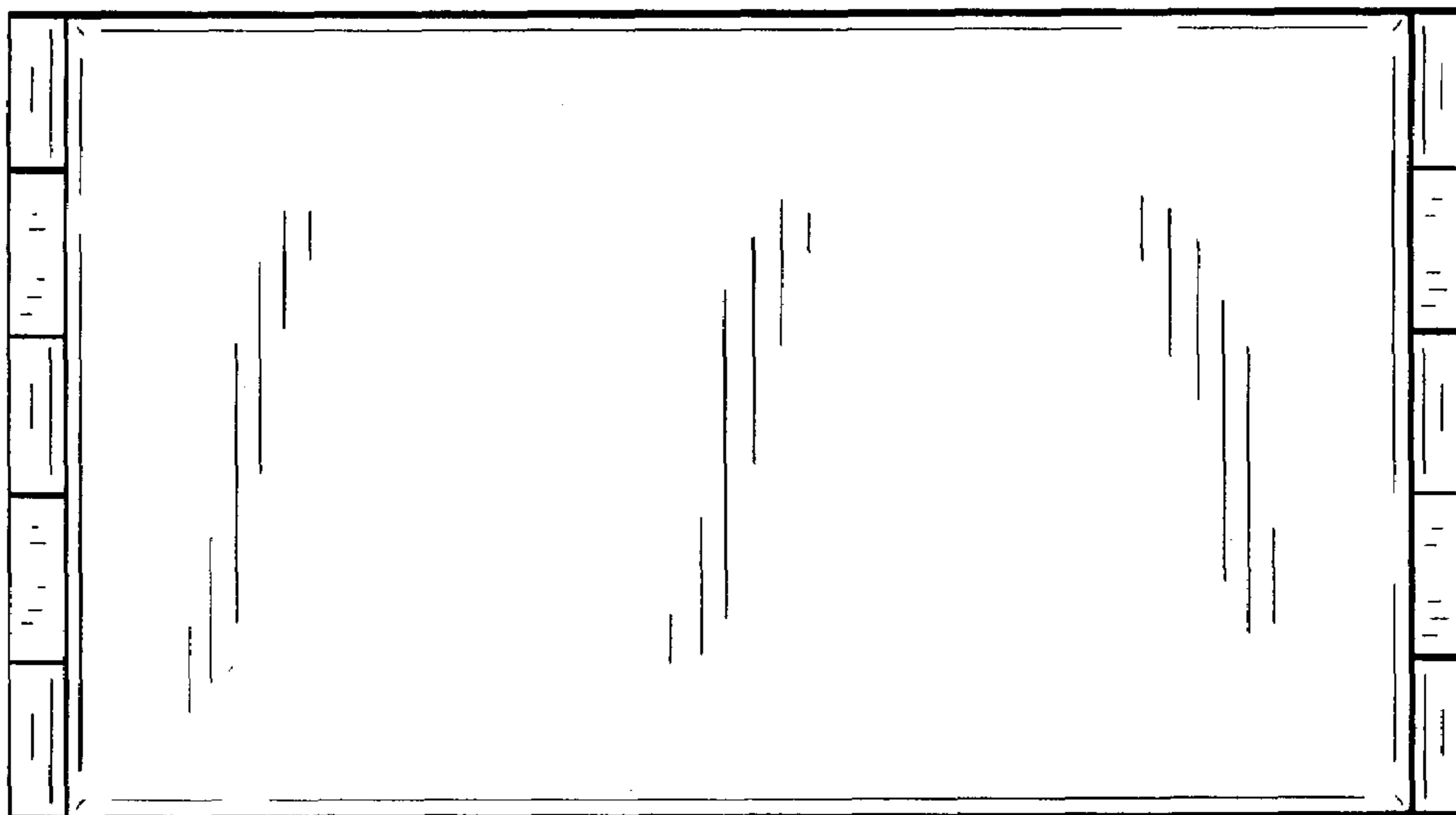

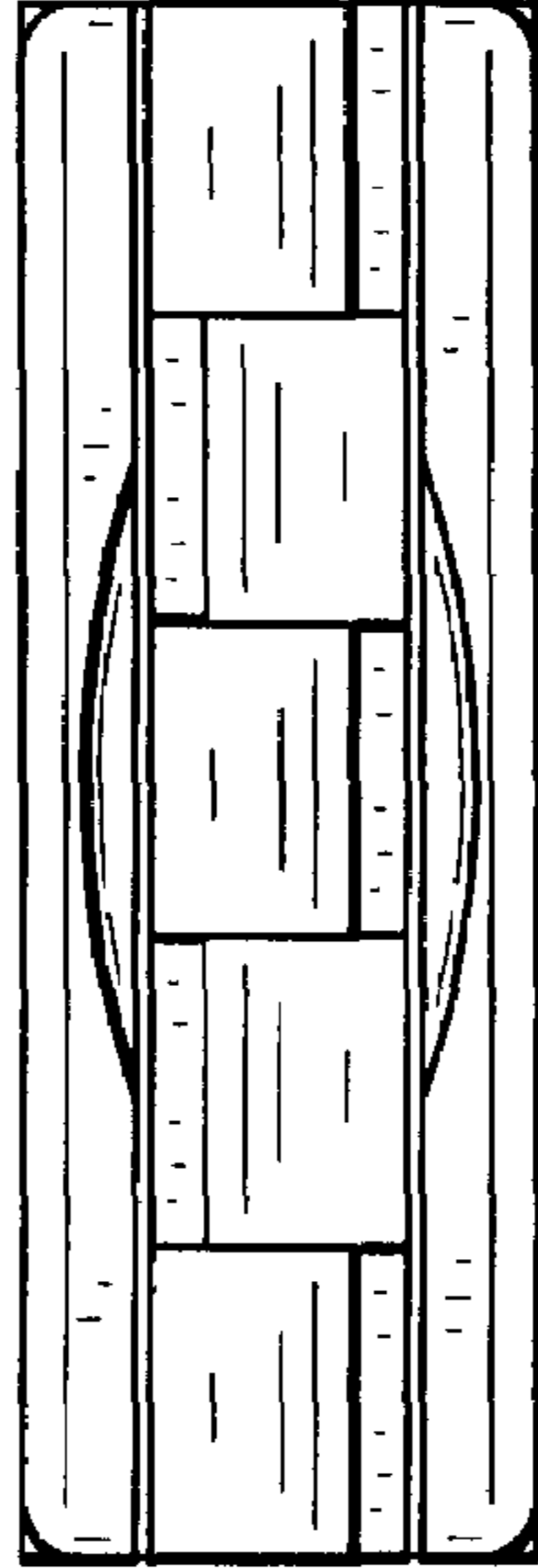

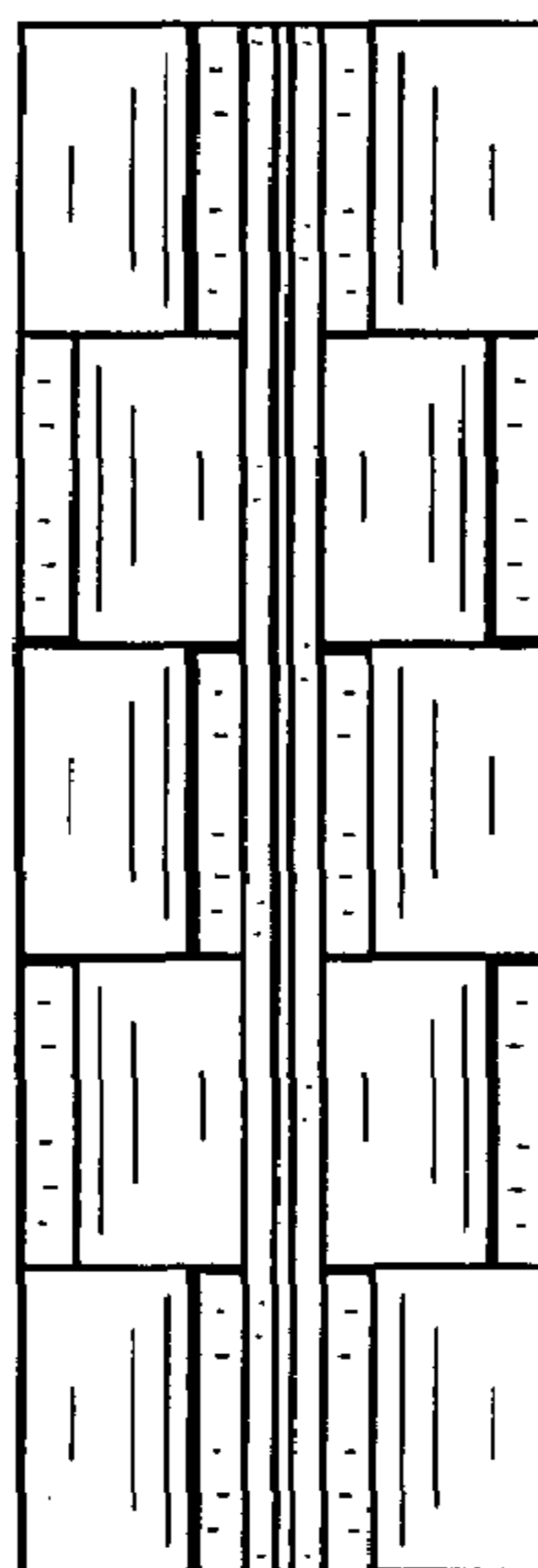

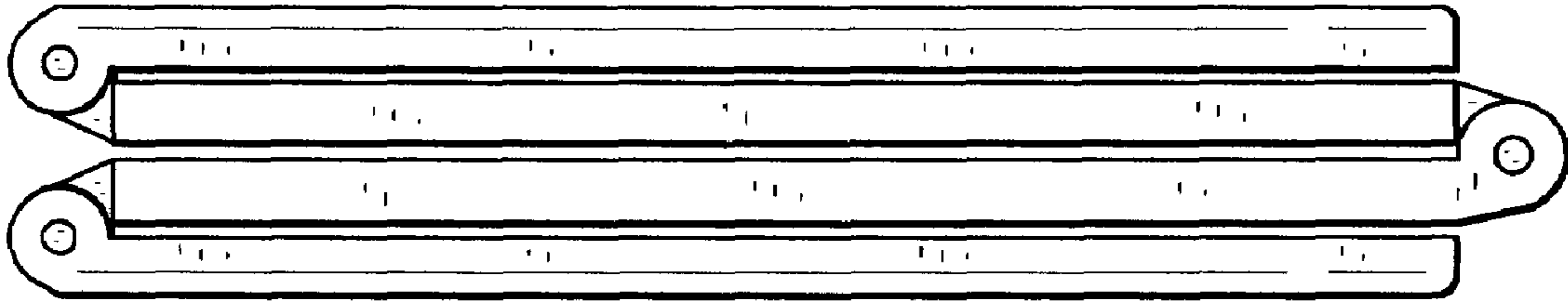

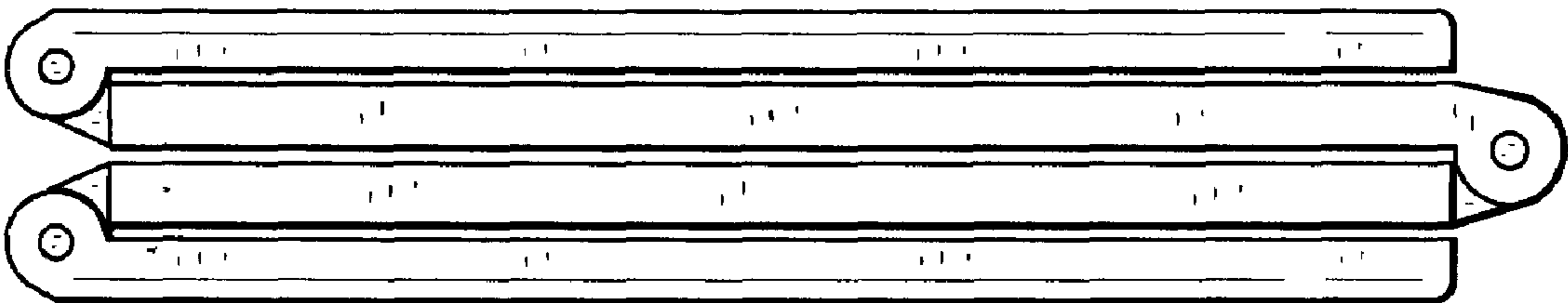

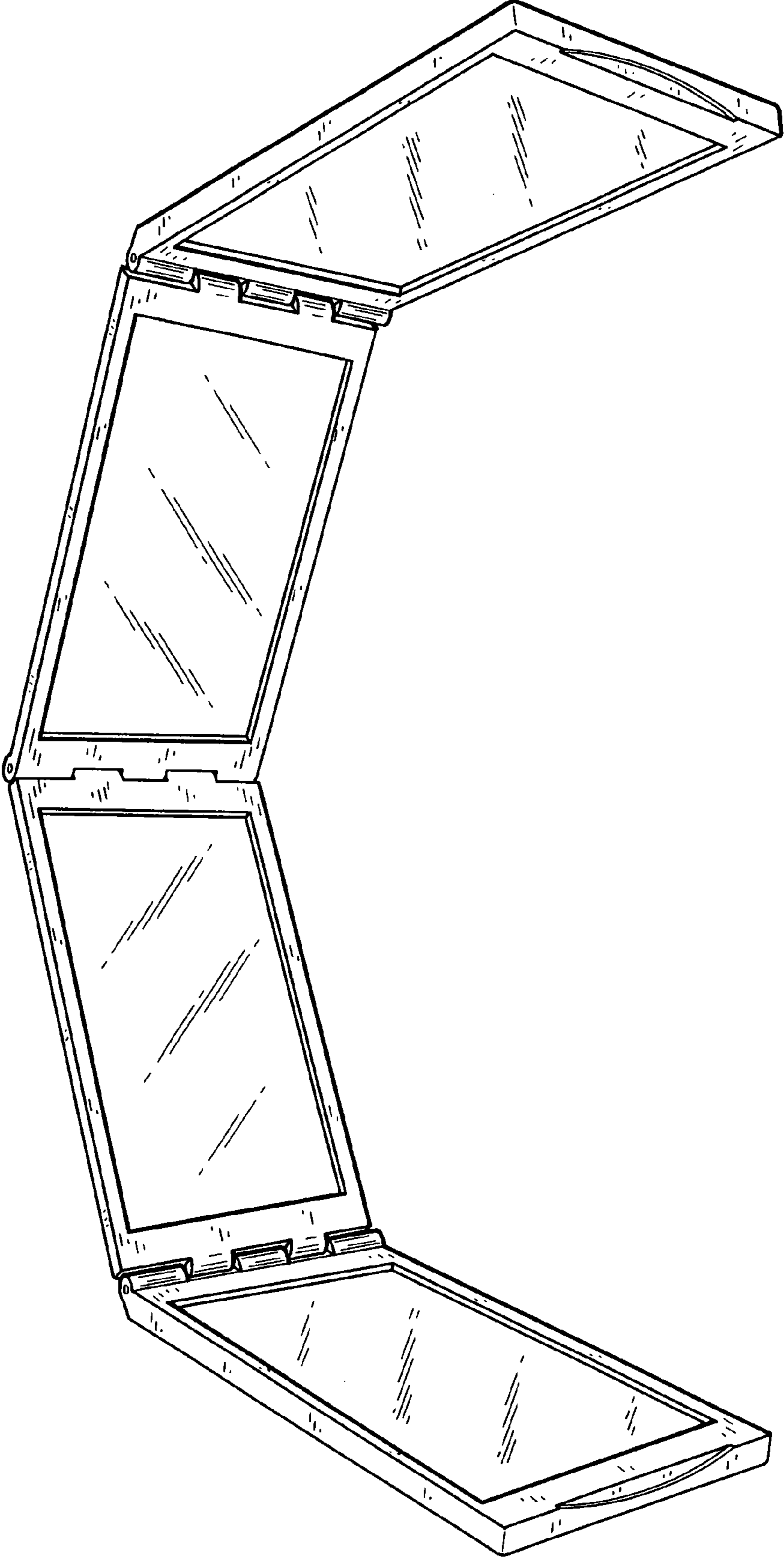
