DESCRIPTION

FIG. 1 is a front perspective view of the sofa showing my
new design;

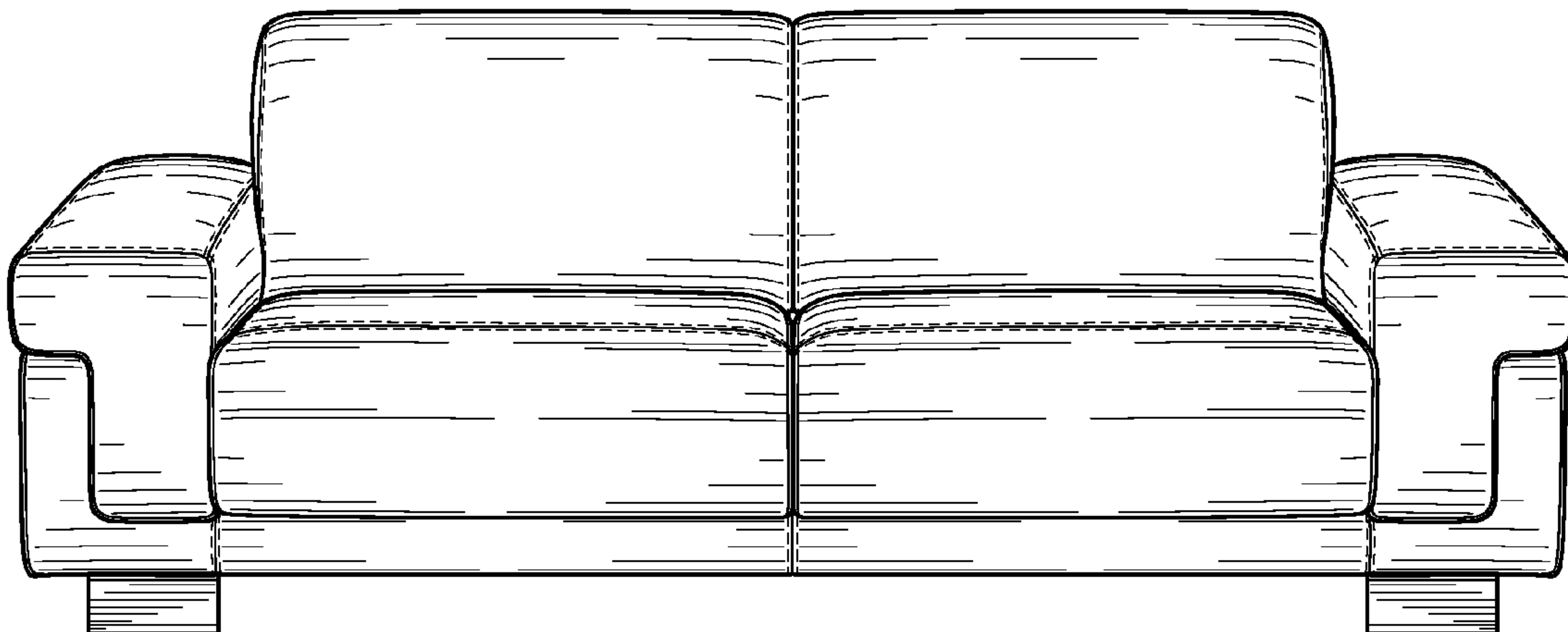
FIG. 2 is a top perspective view thereof;

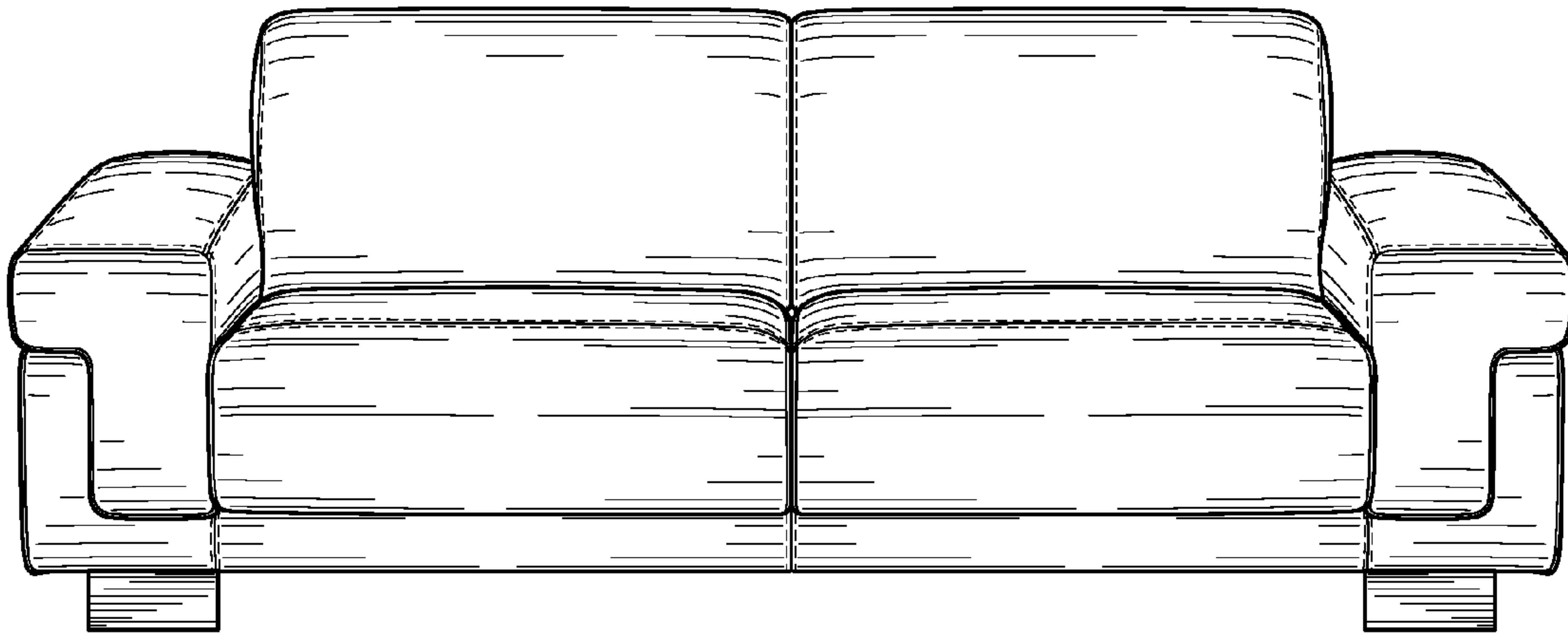

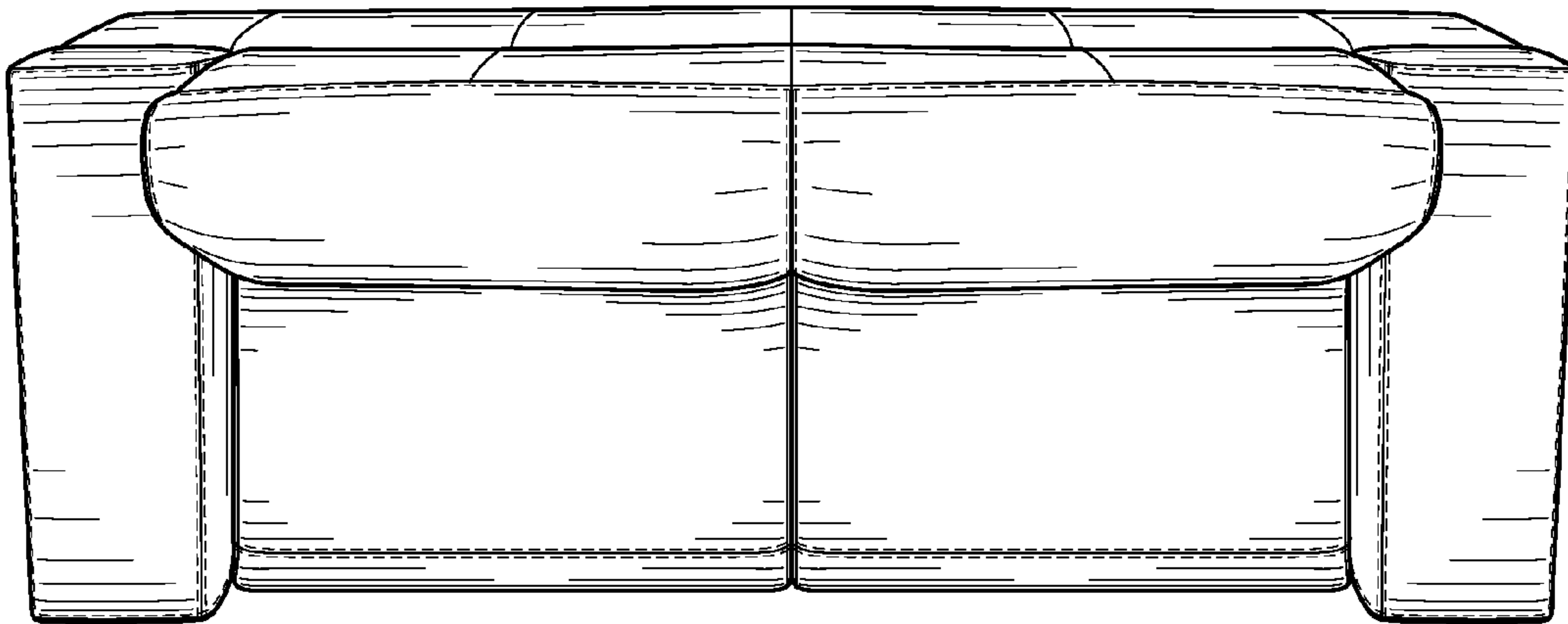

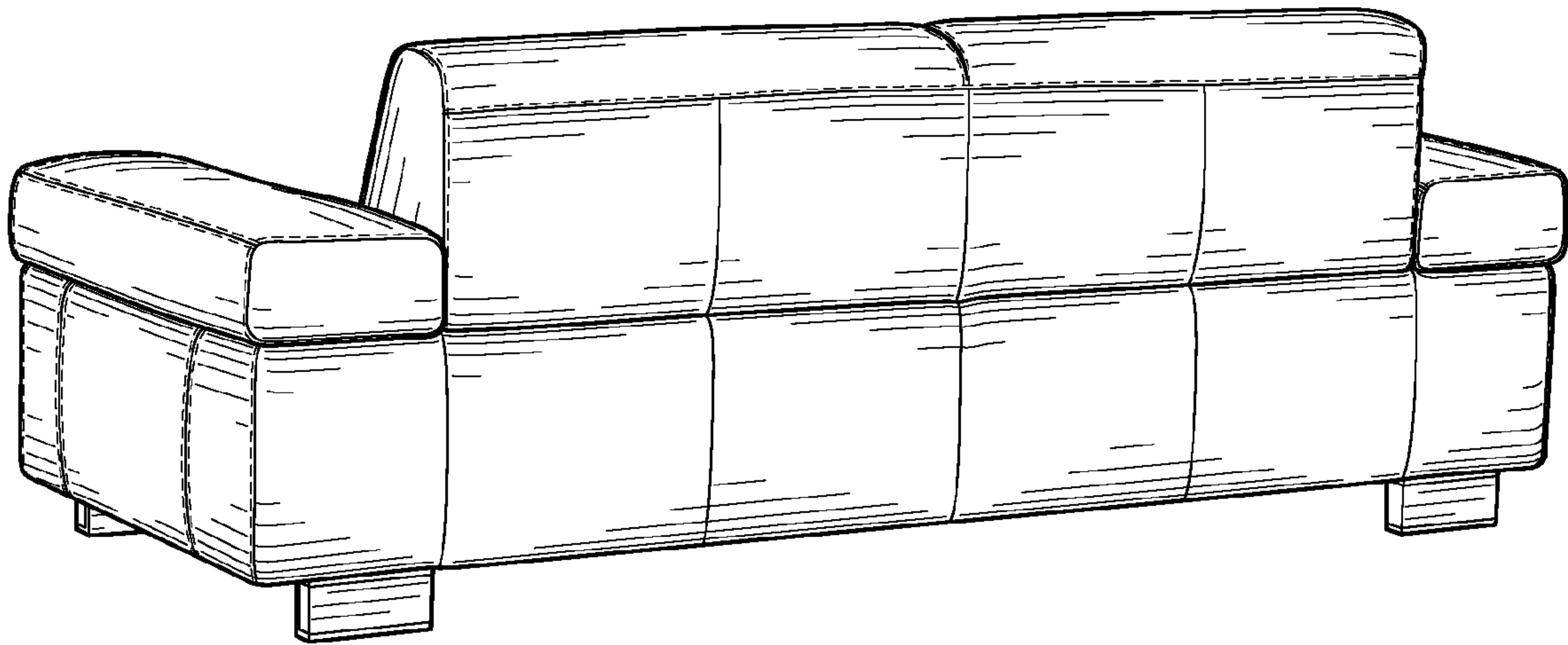

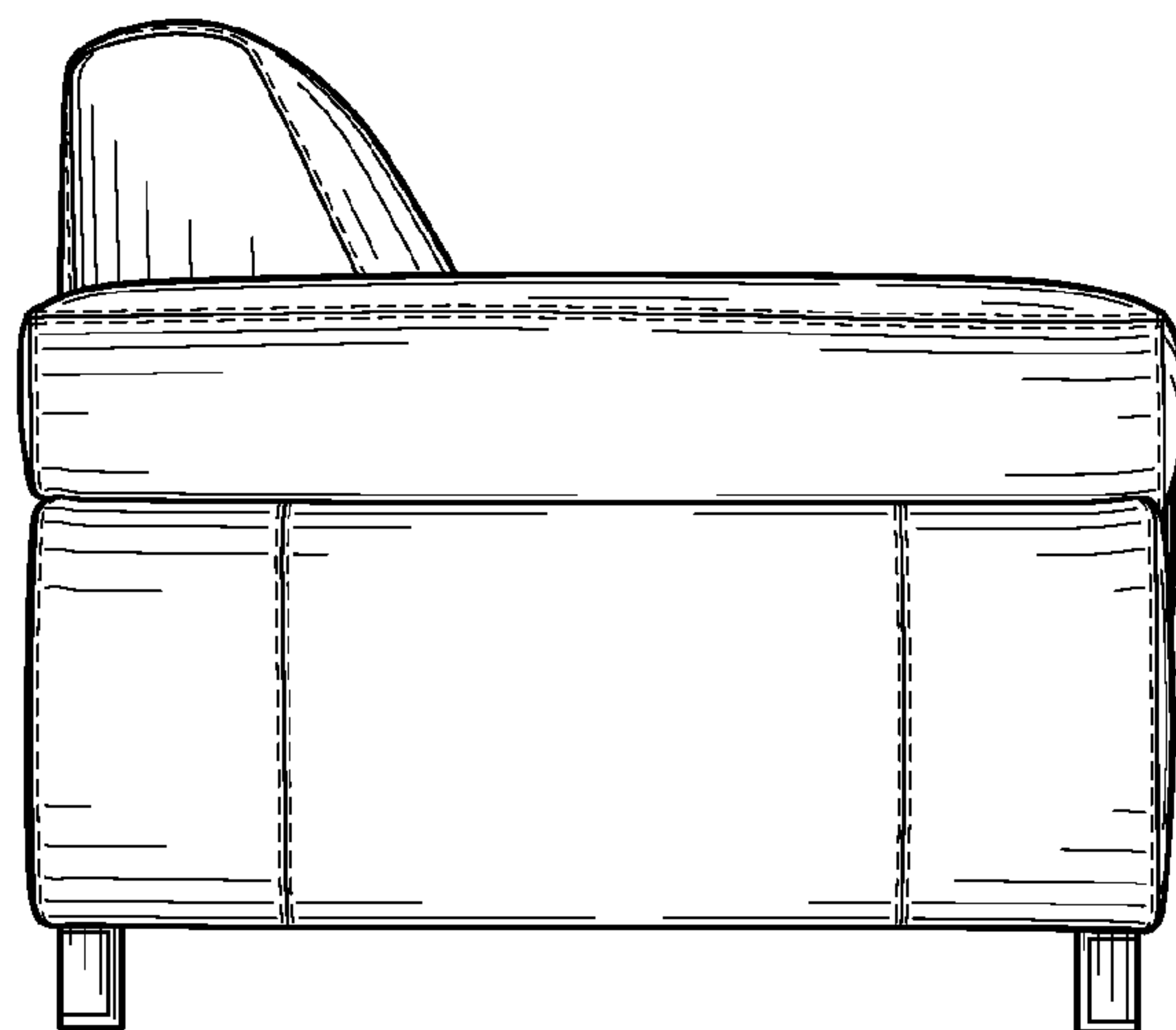
