(57) **CLAIM**

I claim the ornamental design for a sofa, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the sofa showing my new design;

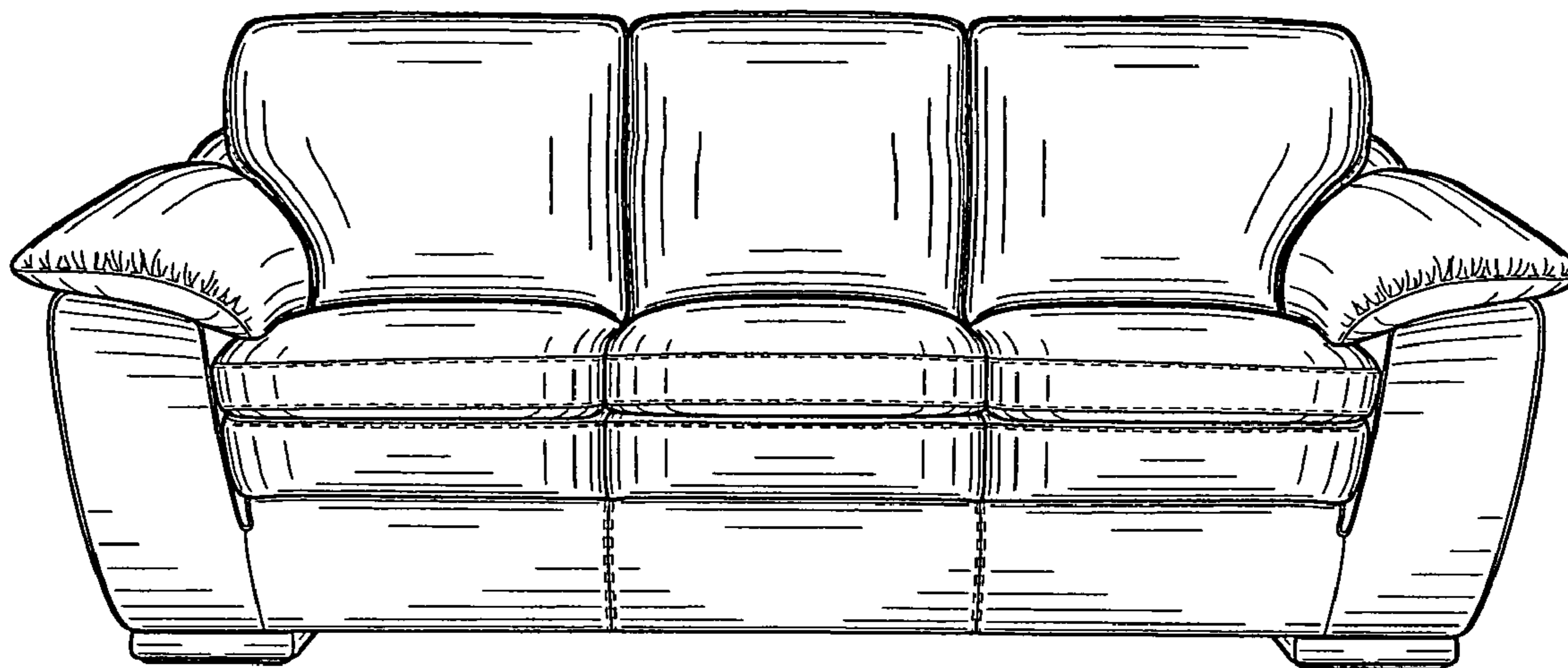
FIG. 2 is top plan view thereof;

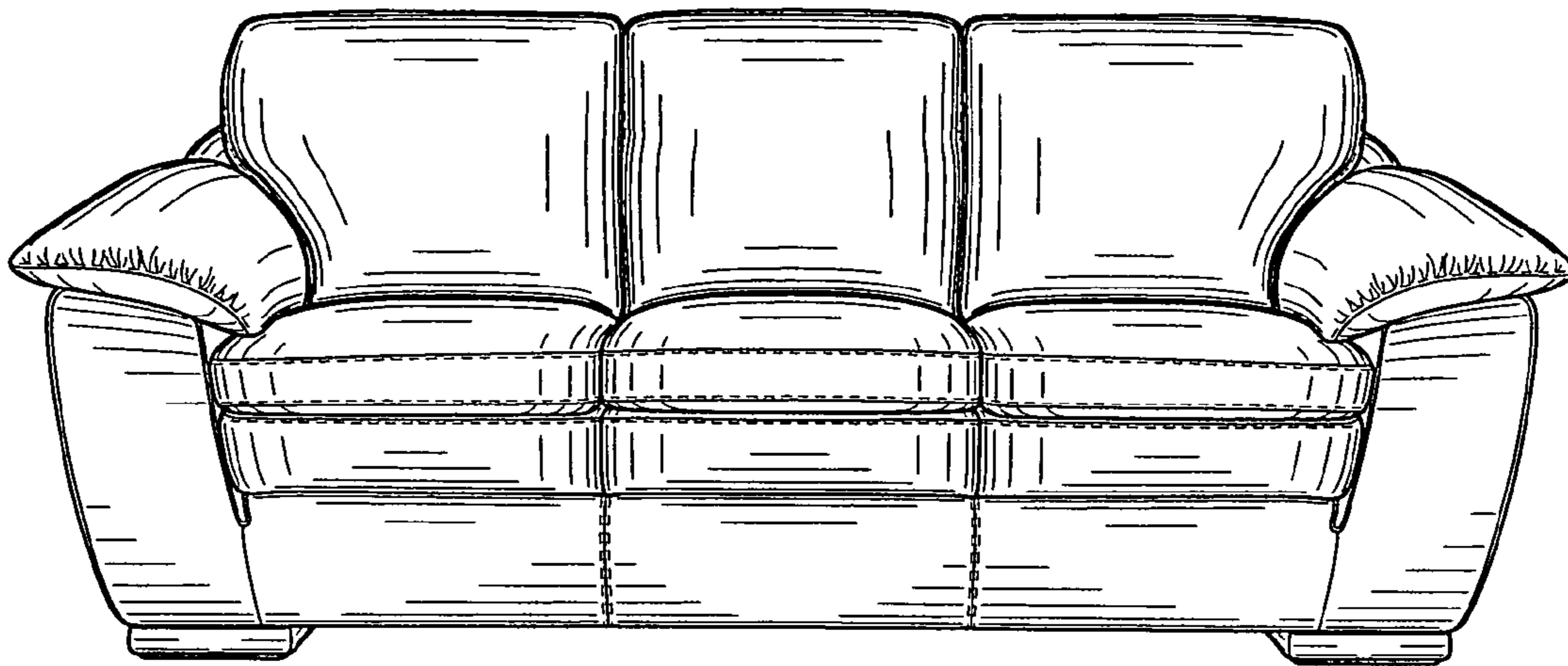

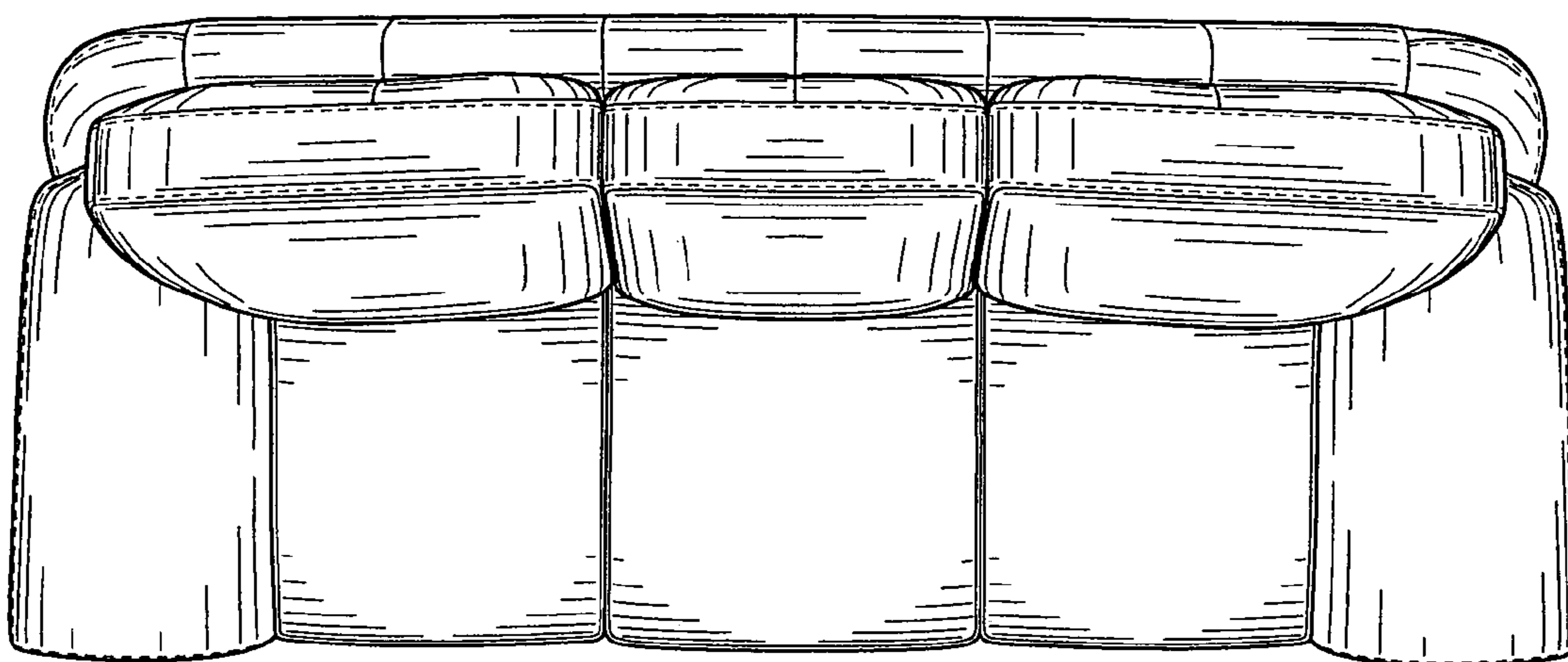

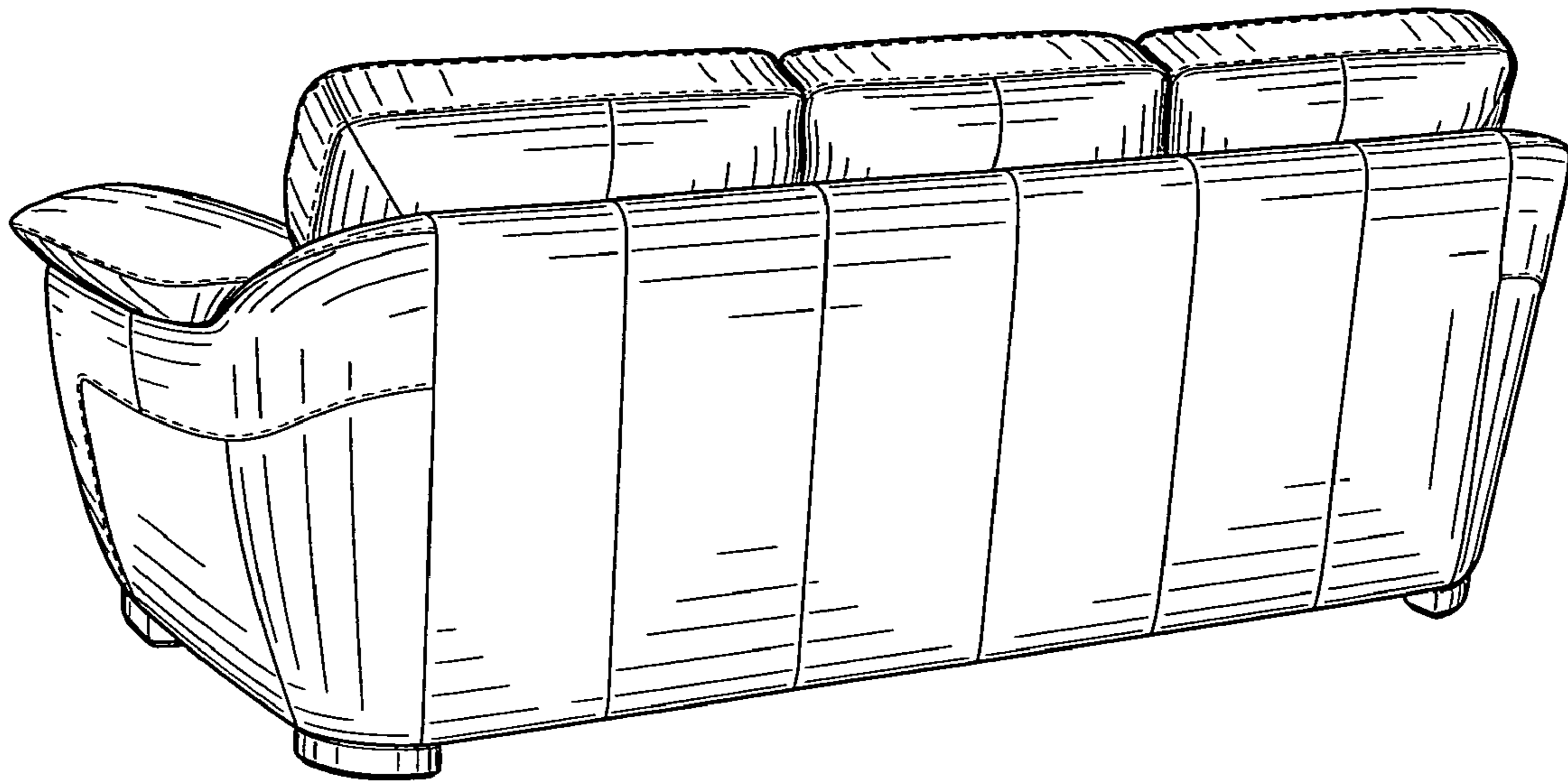

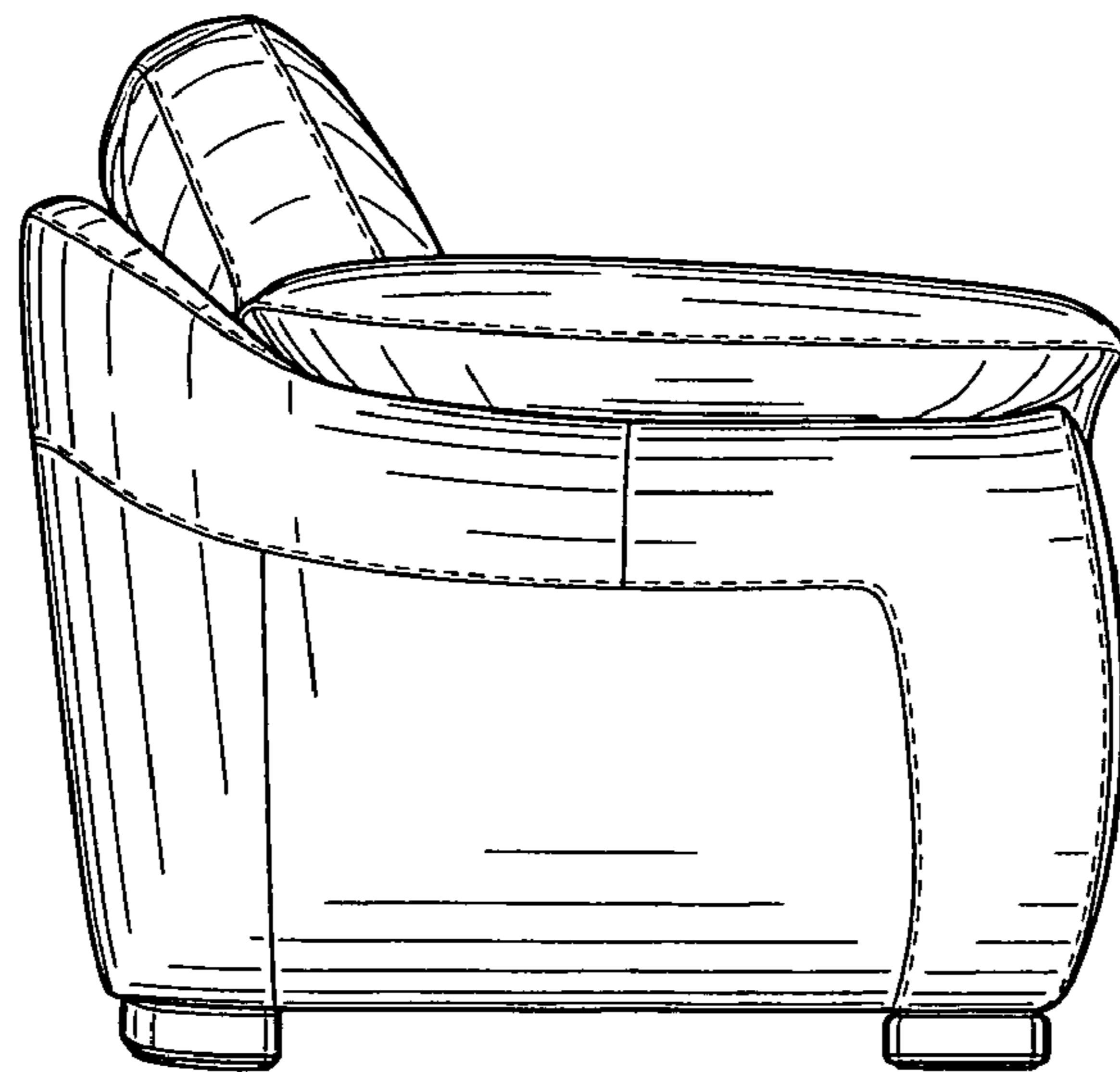
