(57) **CLAIM**

We claim the ornamental design for a reconfigurable storage system, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the reconfigurable storage system of the new design shown in a vertical position with the rear perspective view being similar to the front, the only difference being the absence of the handle on each basket;

FIG. 2 is a right perspective view of the reconfigurable storage system of the new design shown in a vertical position with the left side perspective view being identical thereto;

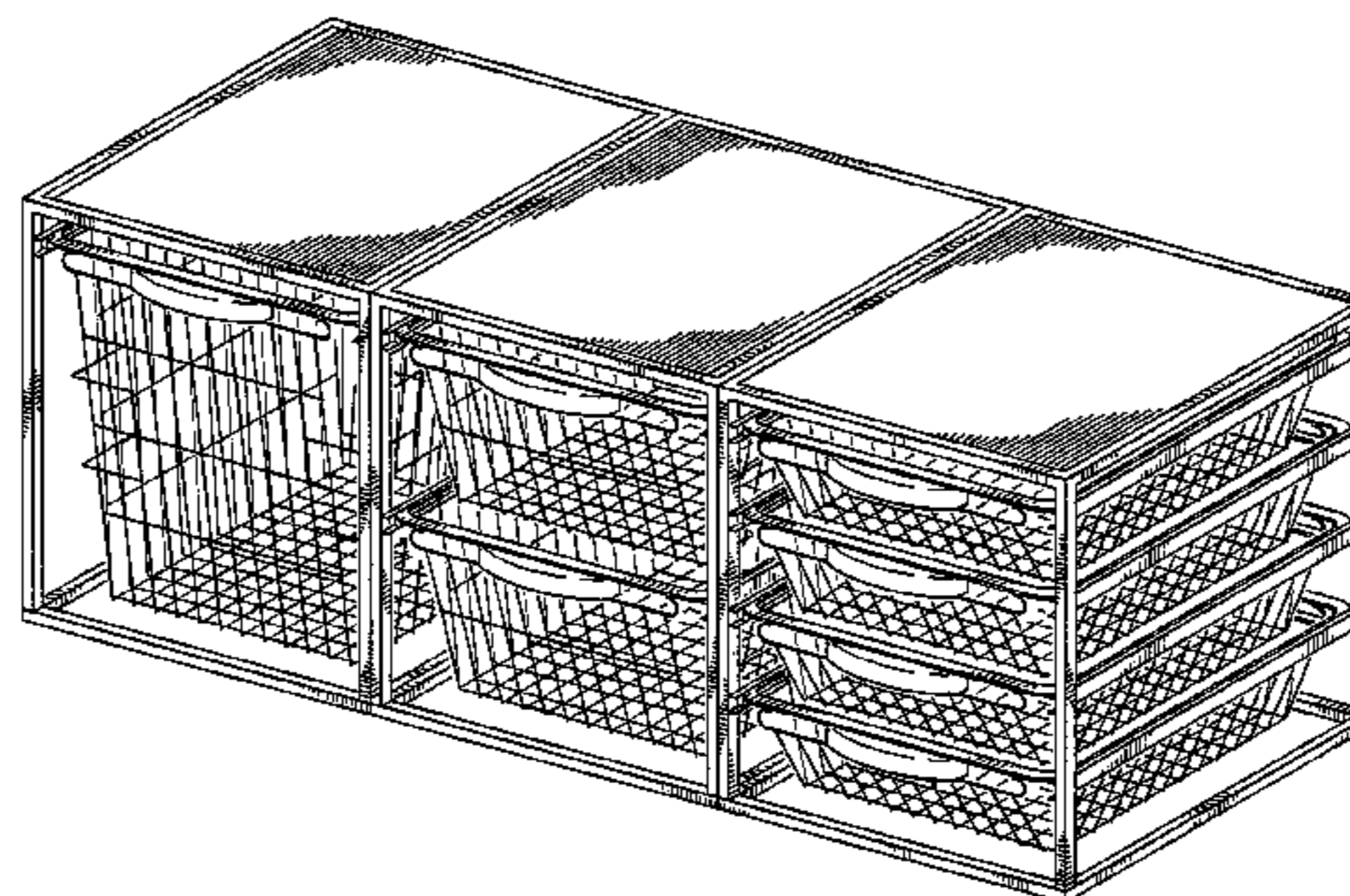
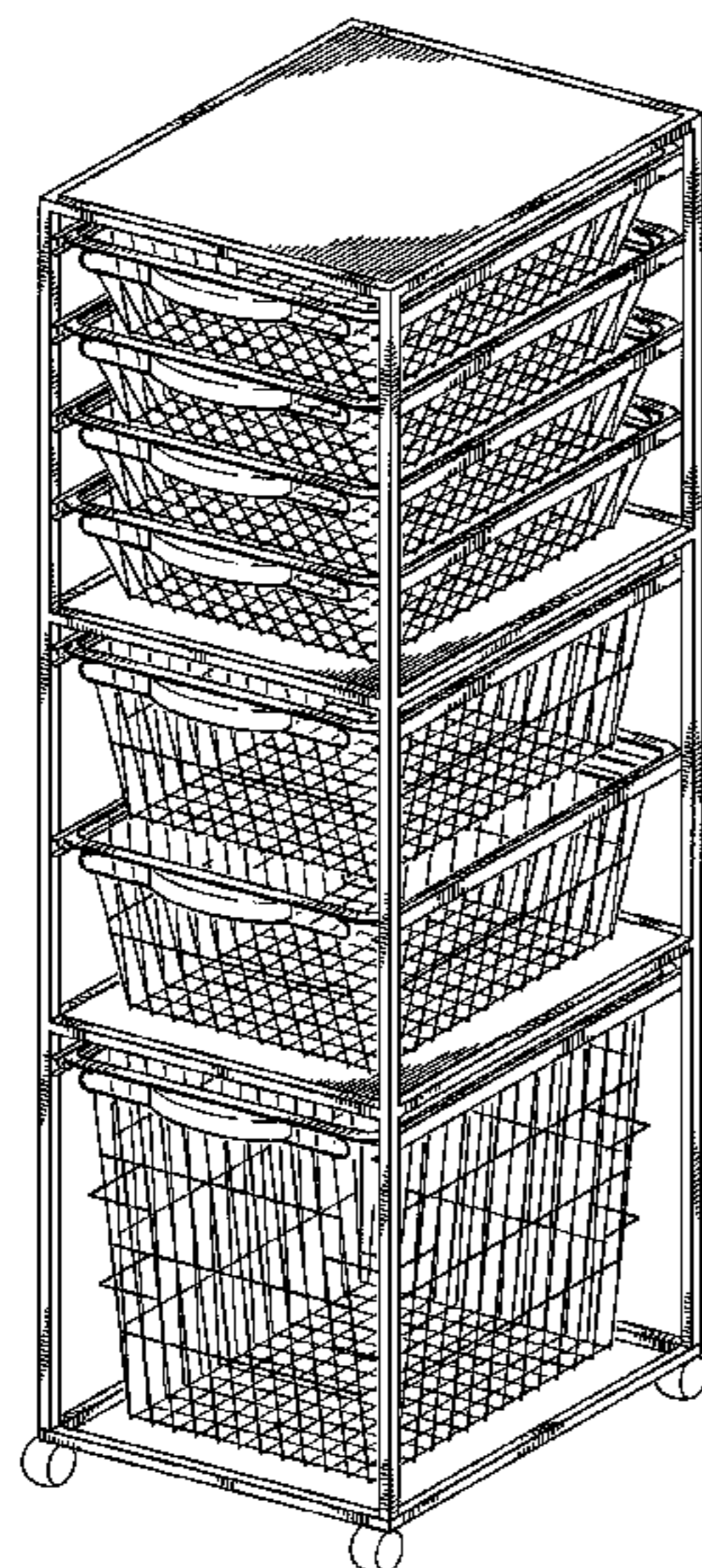
FIG. 3 is a top plan view of the reconfigurable storage system for the new design shown in a vertical position;

FIG. 4 is a bottom plan view of the reconfigurable storage system for the new design shown in a vertical position;

FIG. 5 is another front perspective view of the reconfigurable storage system for the new design shown in a vertical position showing the front side somewhat angled away; and,

FIG. 6 is a front perspective view of the reconfigurable storage system for the new design shown reconfigured for horizontal use with wheels removed.

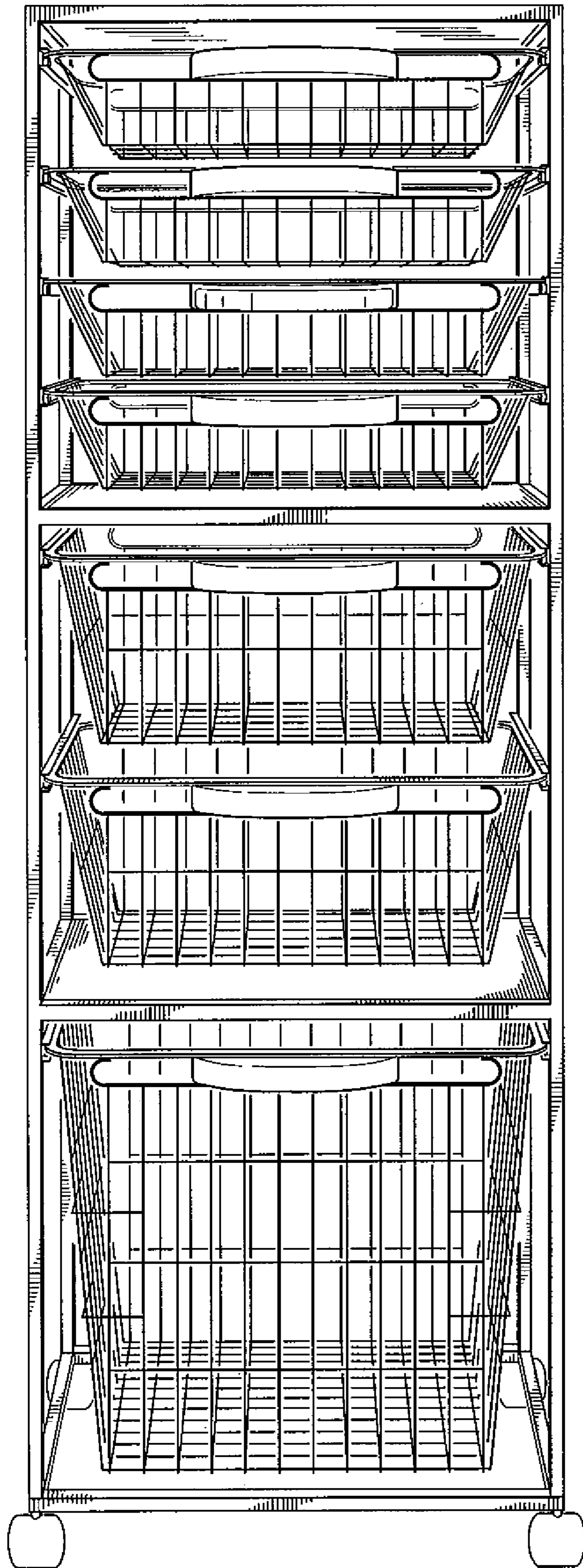

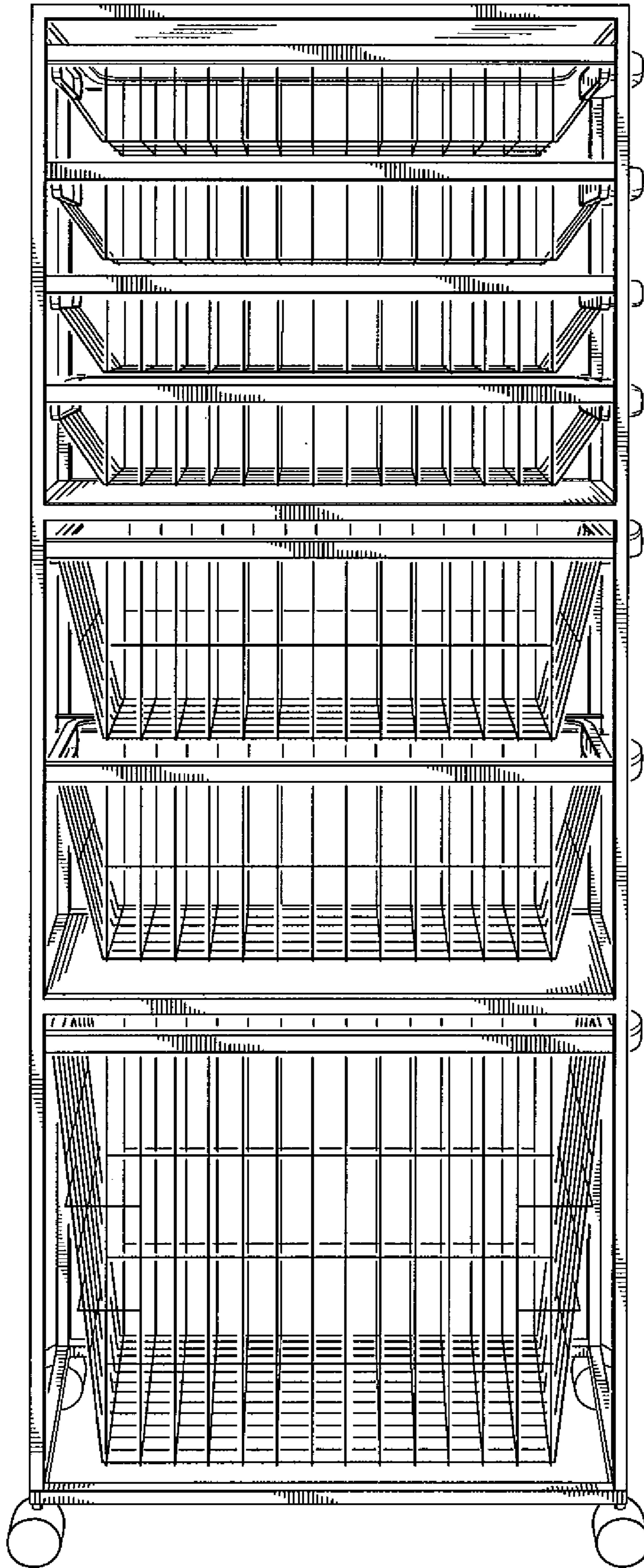

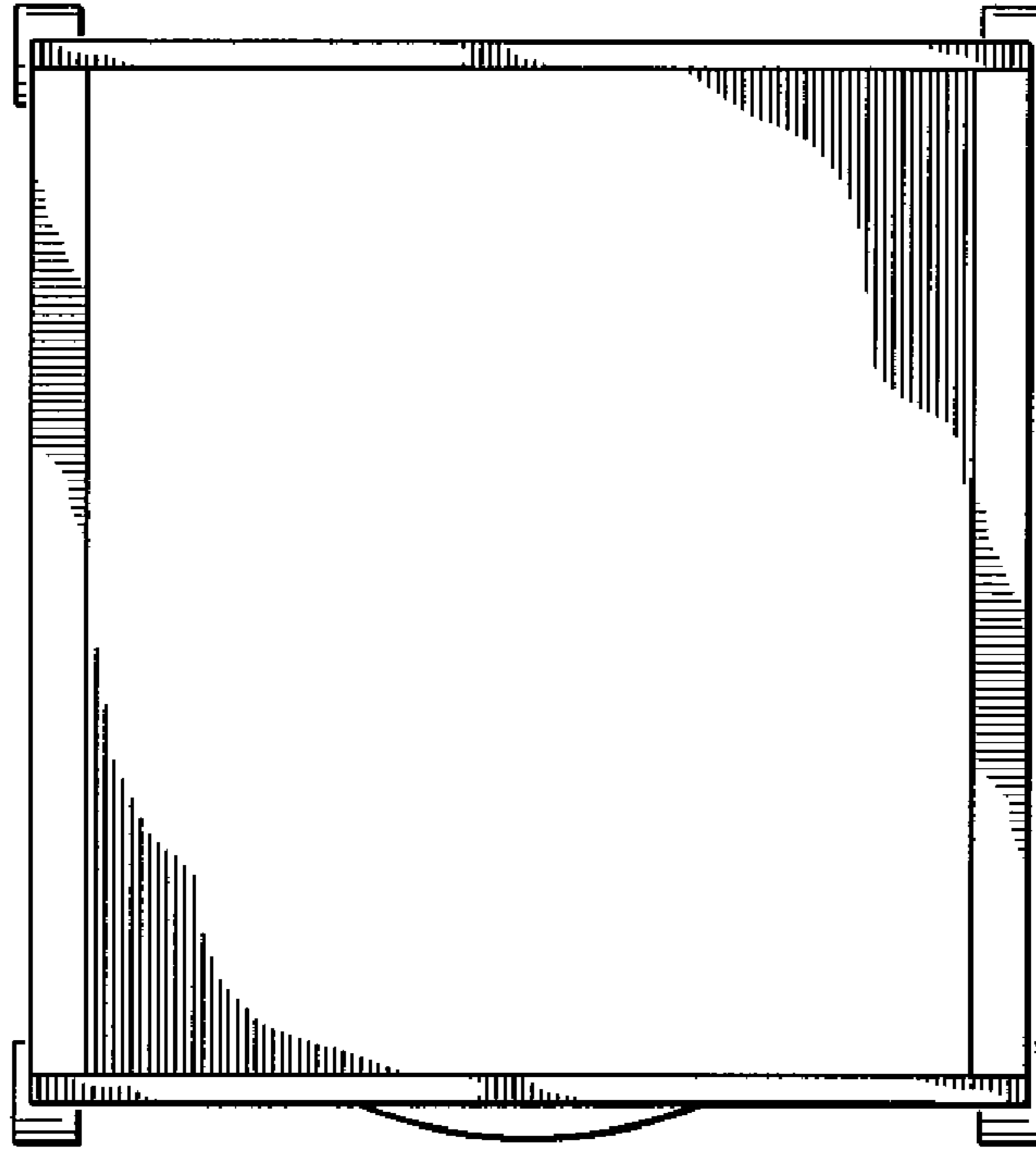

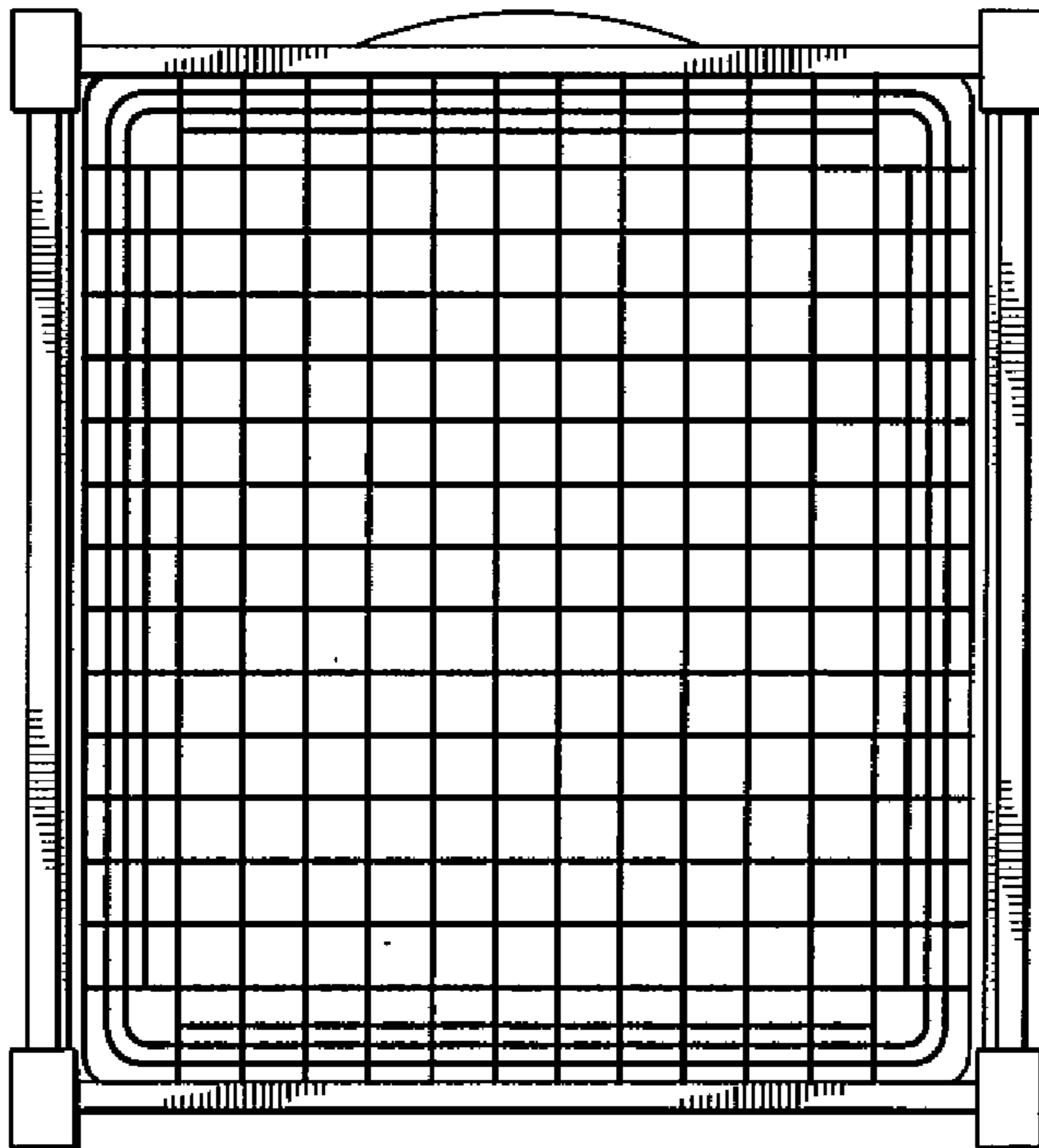

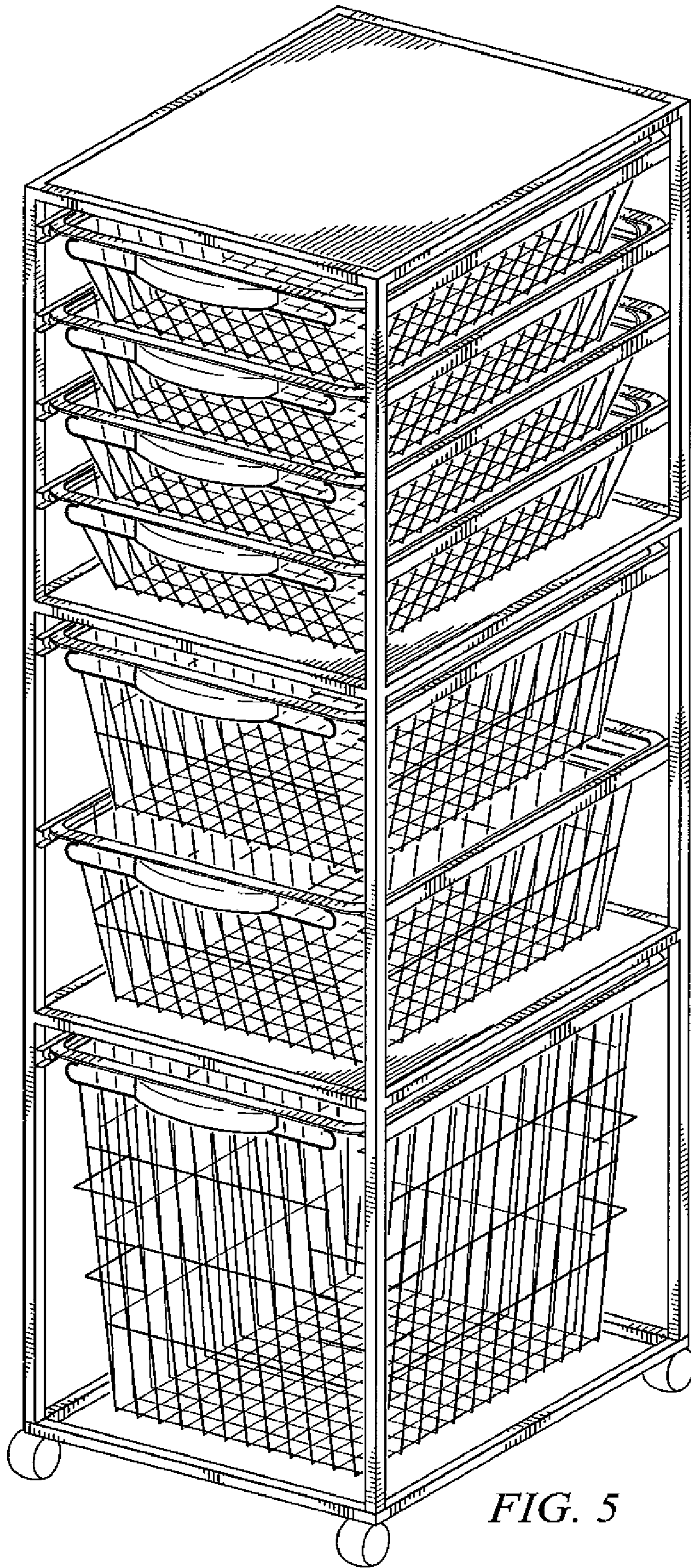

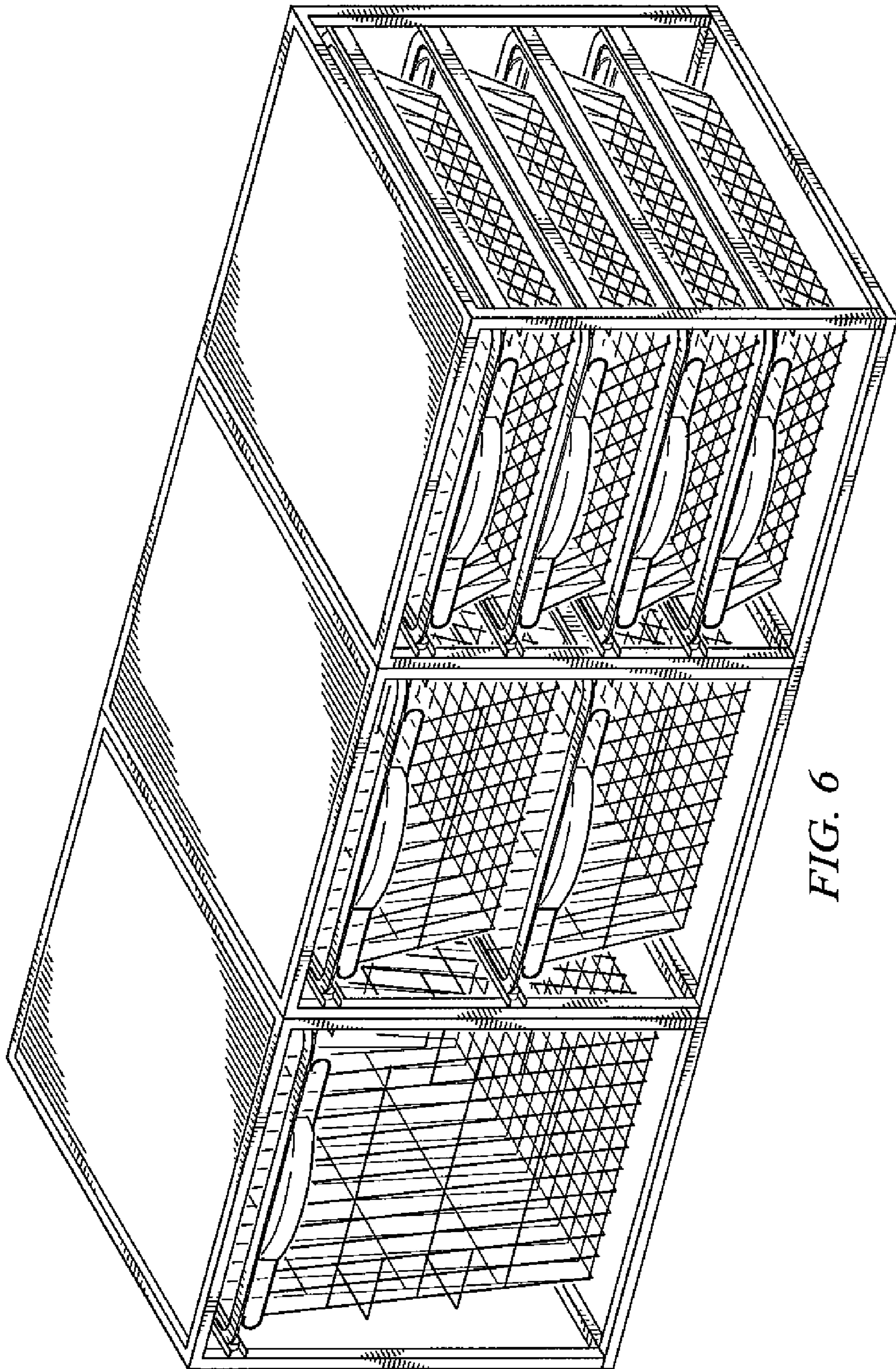
