(57) **CLAIM**

The ornamental design for a product display unit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a product display unit showing my new design, with a locking device, label, and key as well as unclaimed portions of the article being shown for illustrative purposes only and forming no part of the claimed design

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof

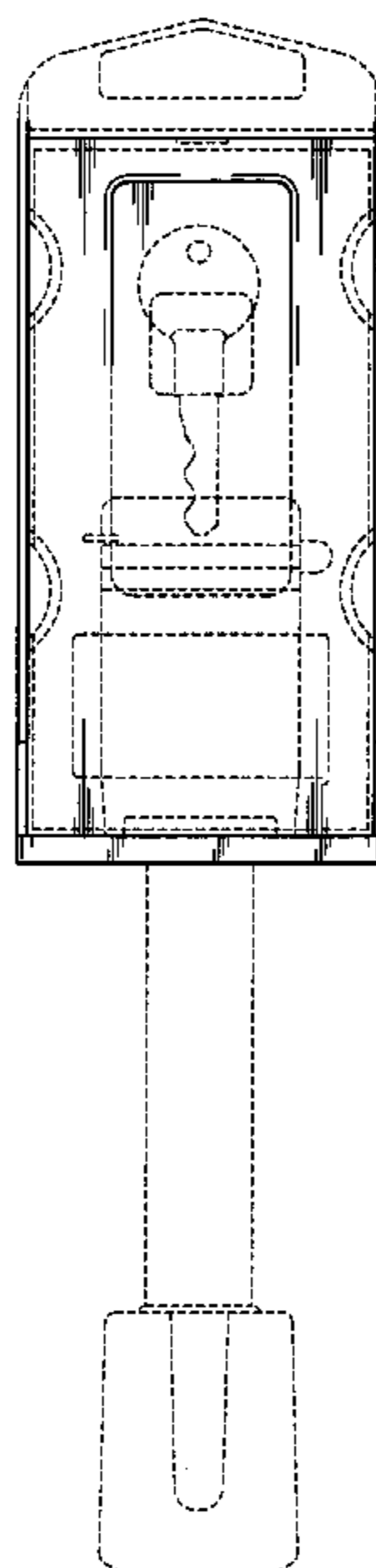
FIG. 5 is a right side elevational view thereof, the left side being a mirror image of that shown; and,

FIG. 6 is a top, front, and left side perspective view thereof.

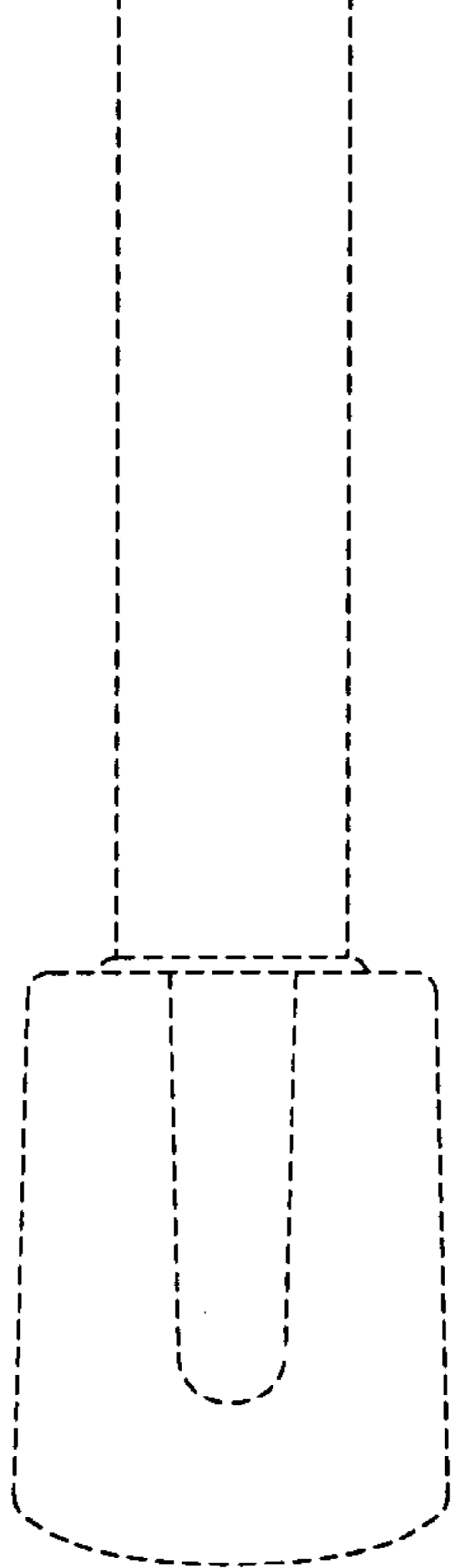
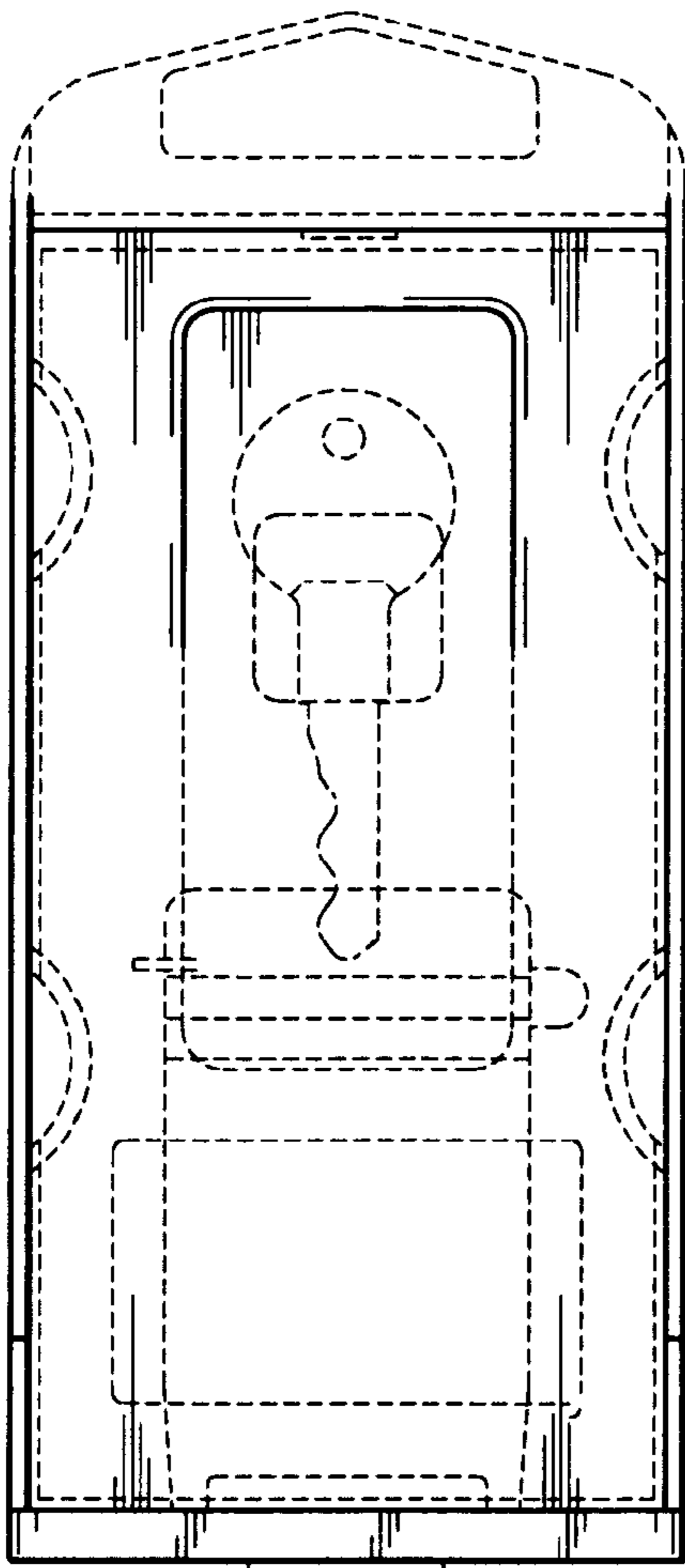
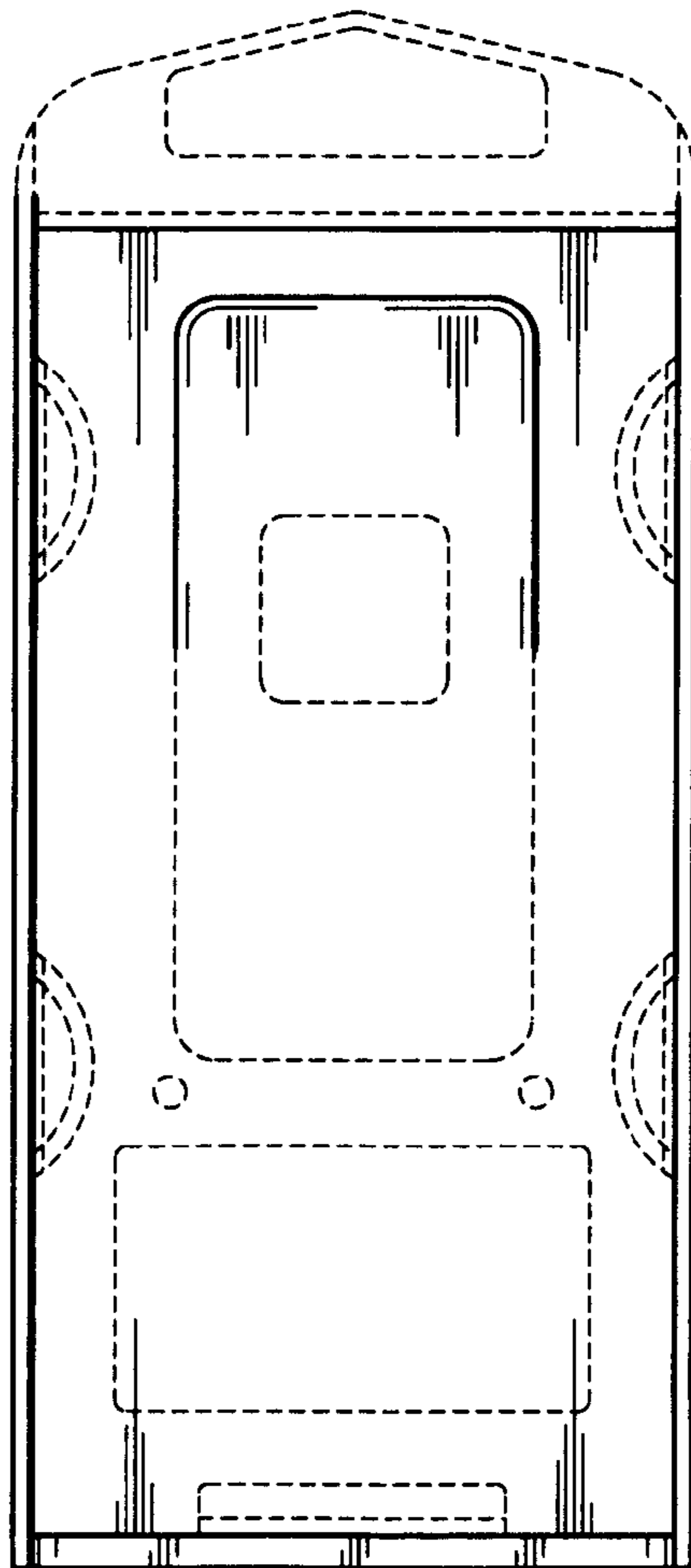

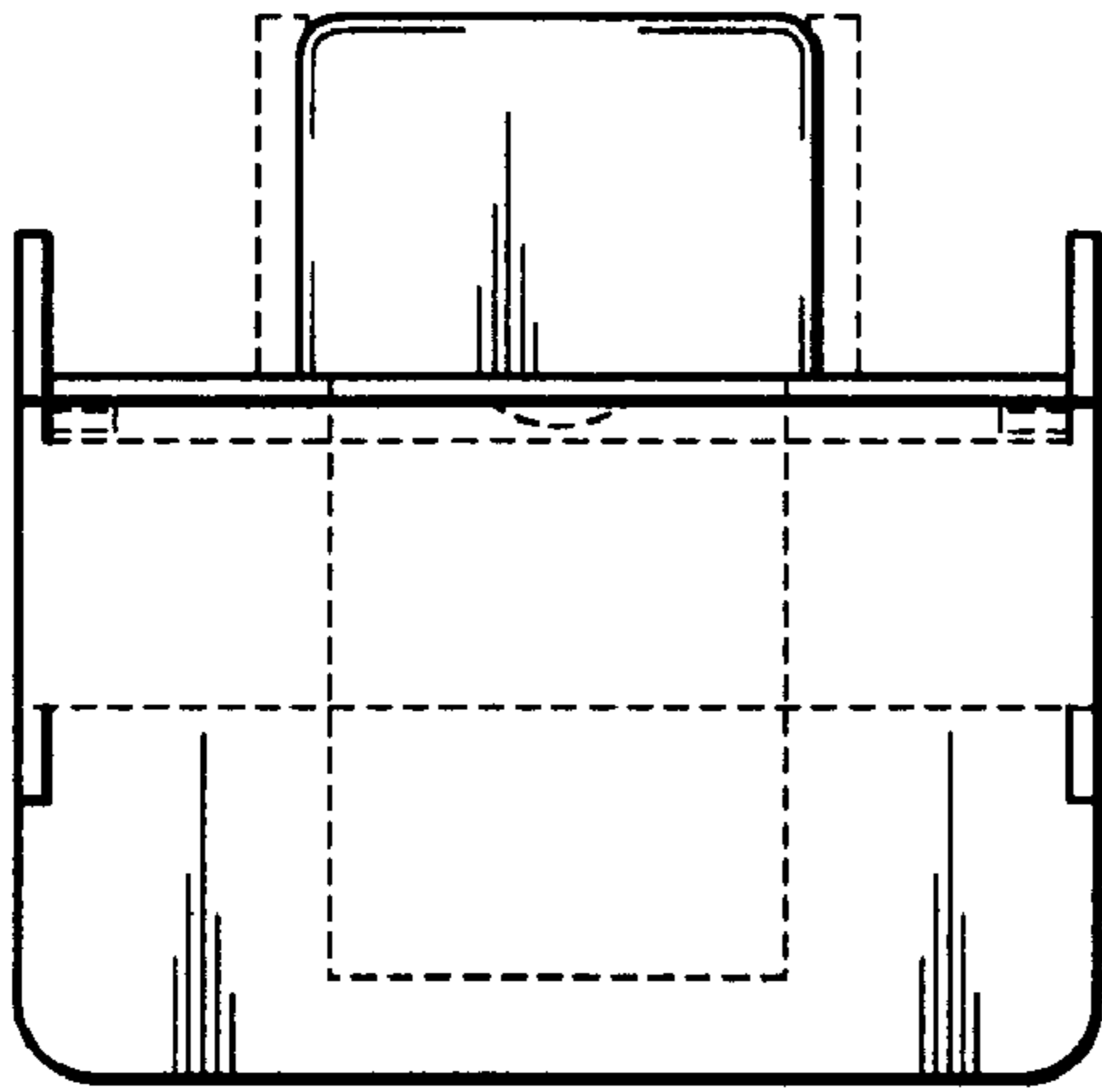

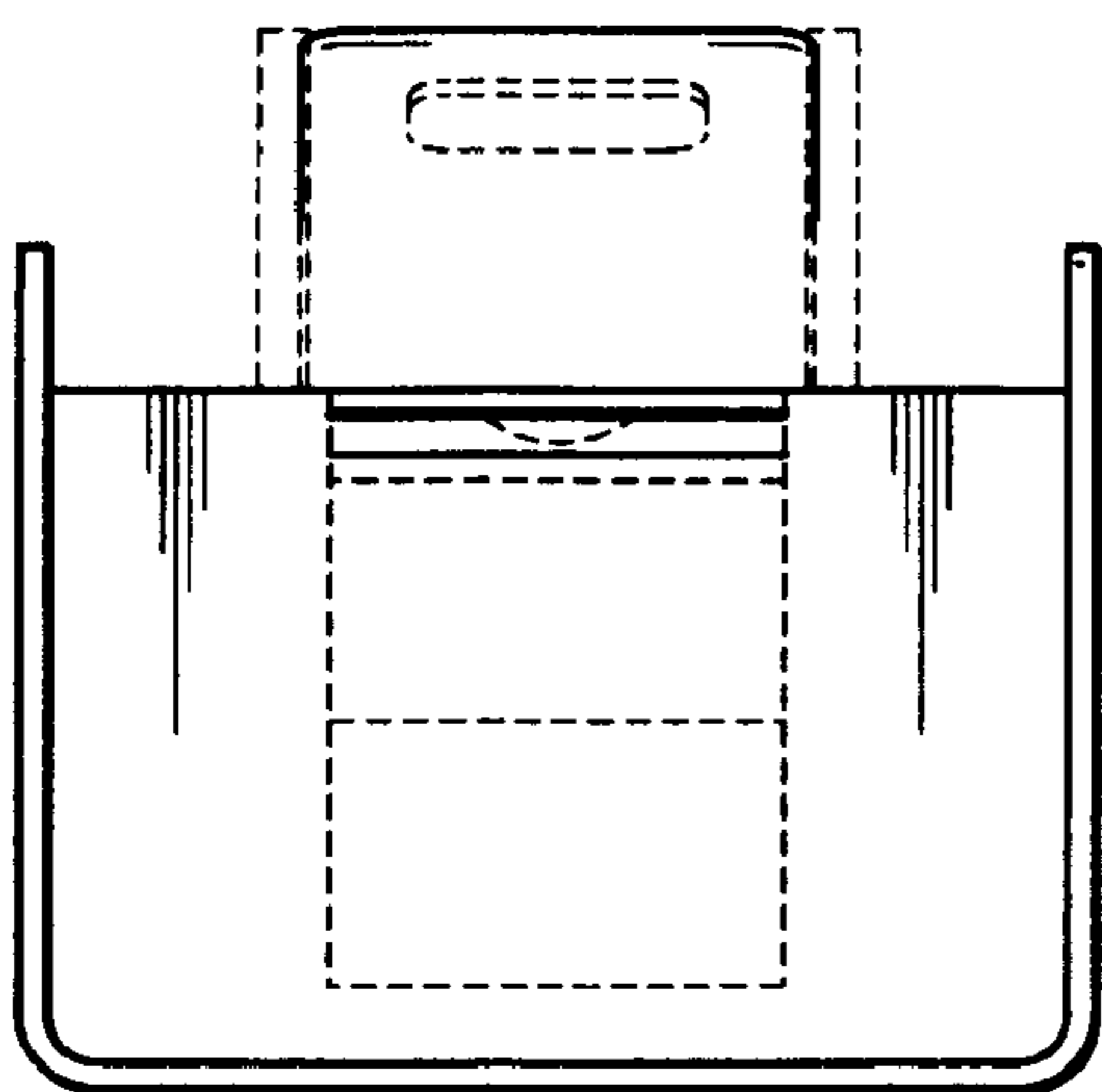

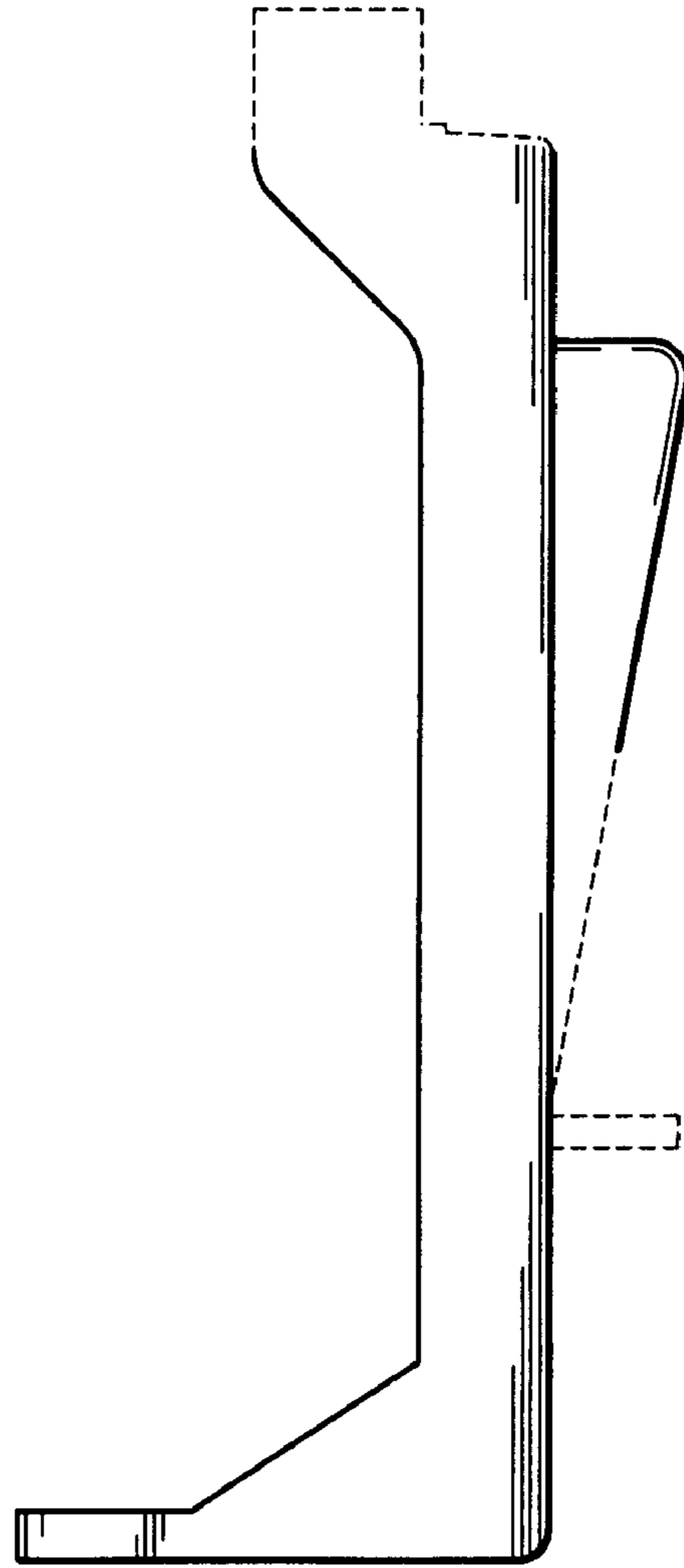

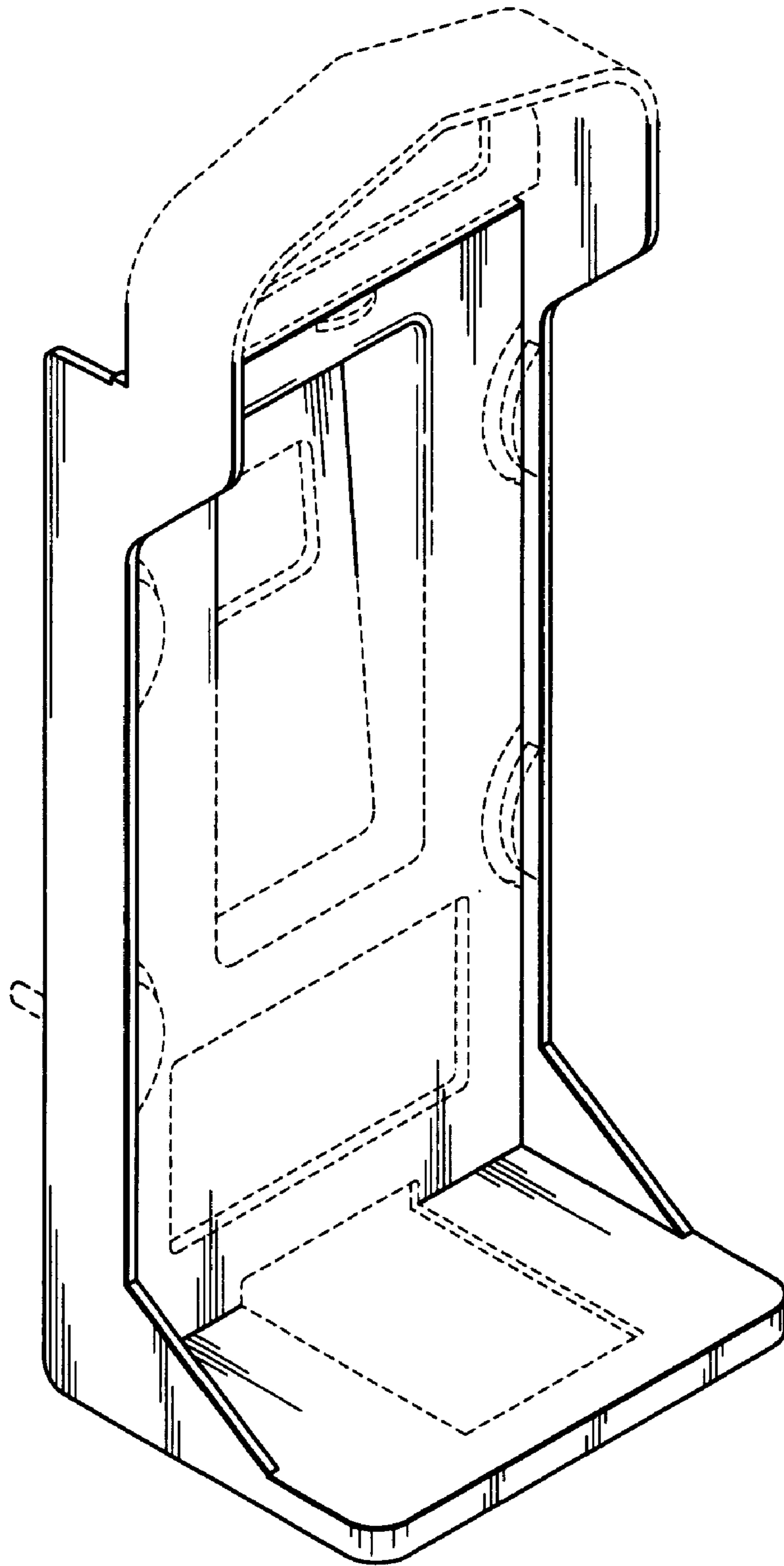
