FIG. 2 is a left hand end view thereof.

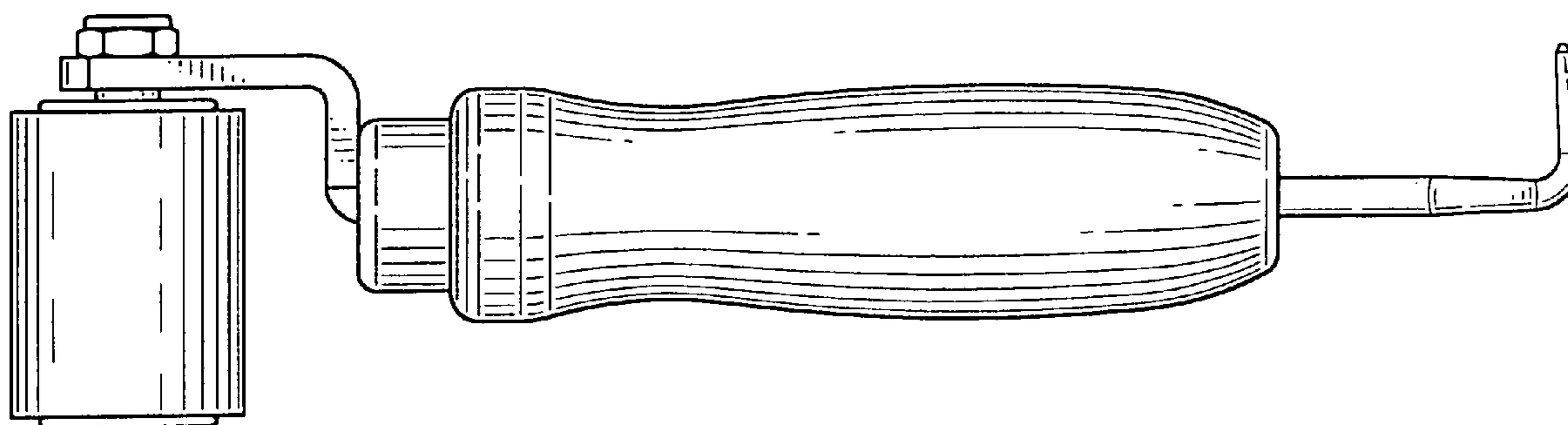
FIG. 3 is a right hand end view thereof.

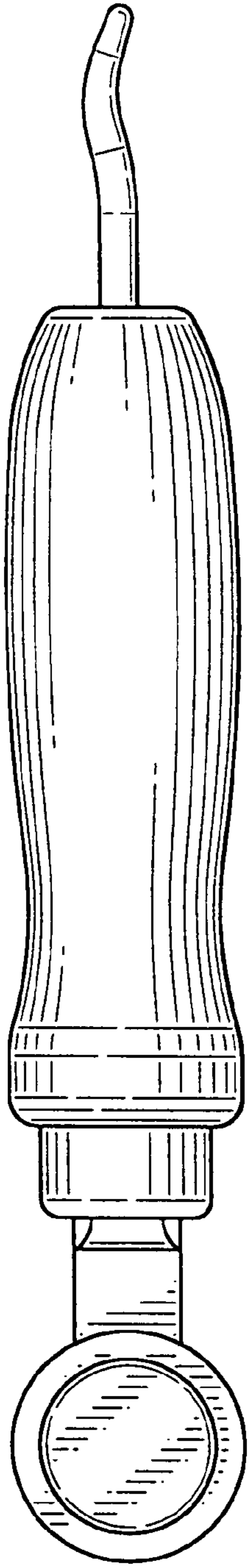

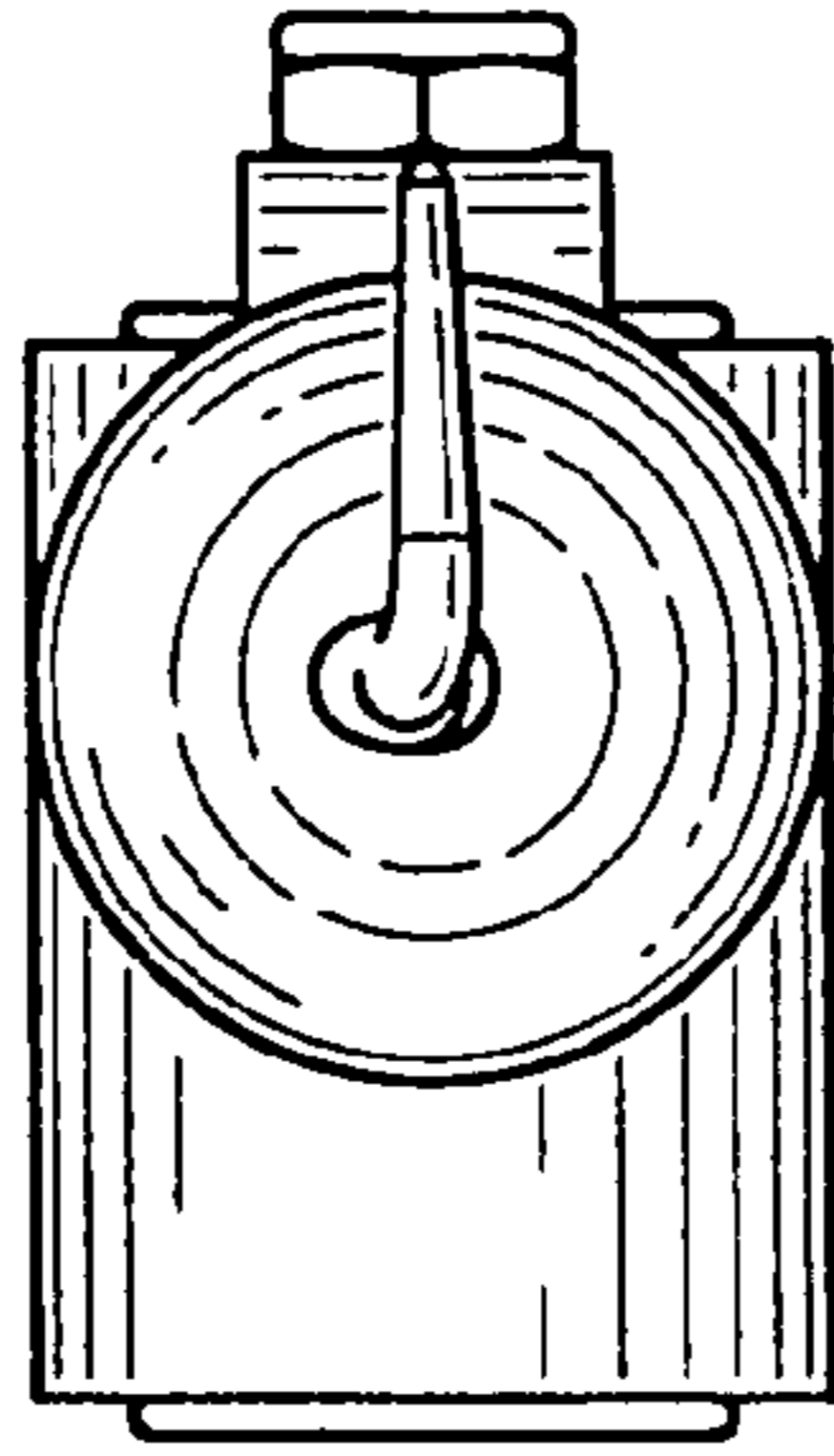

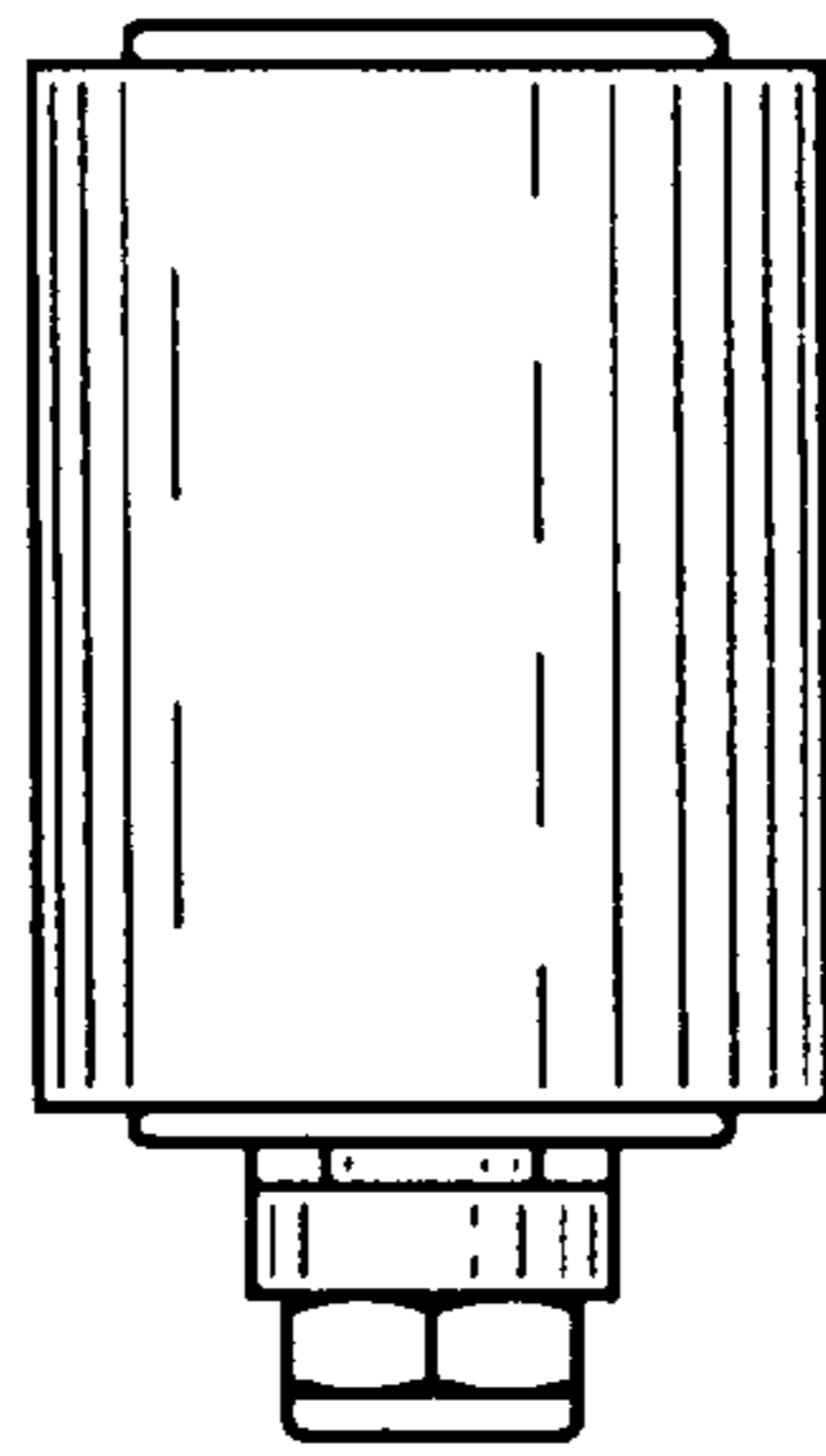

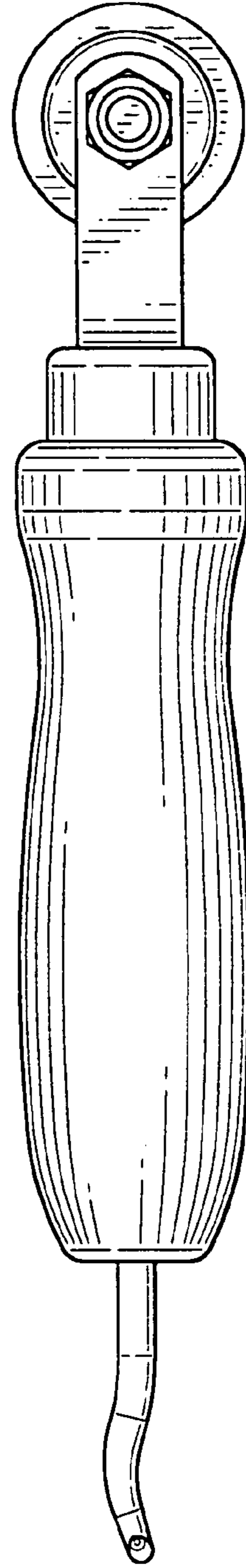
