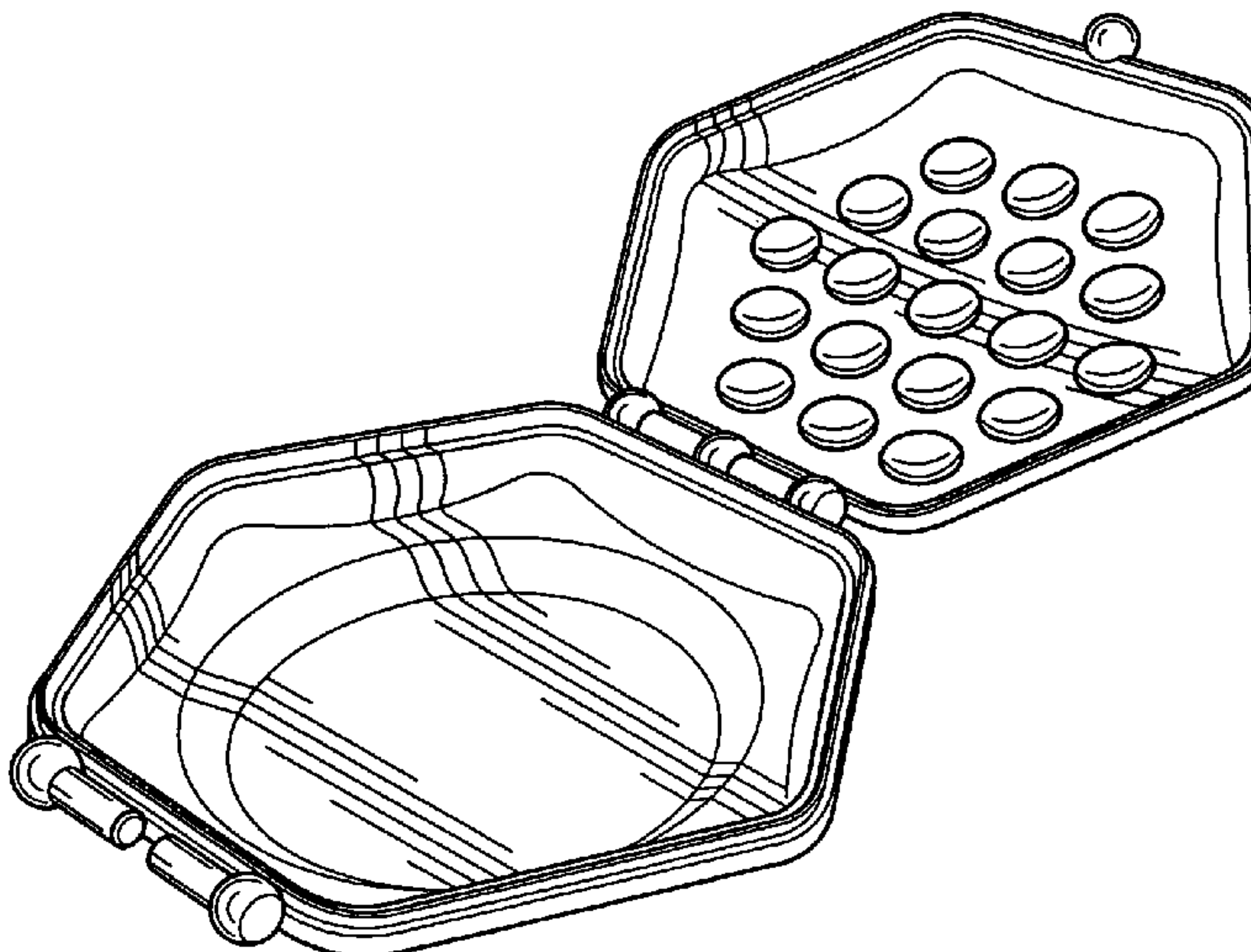
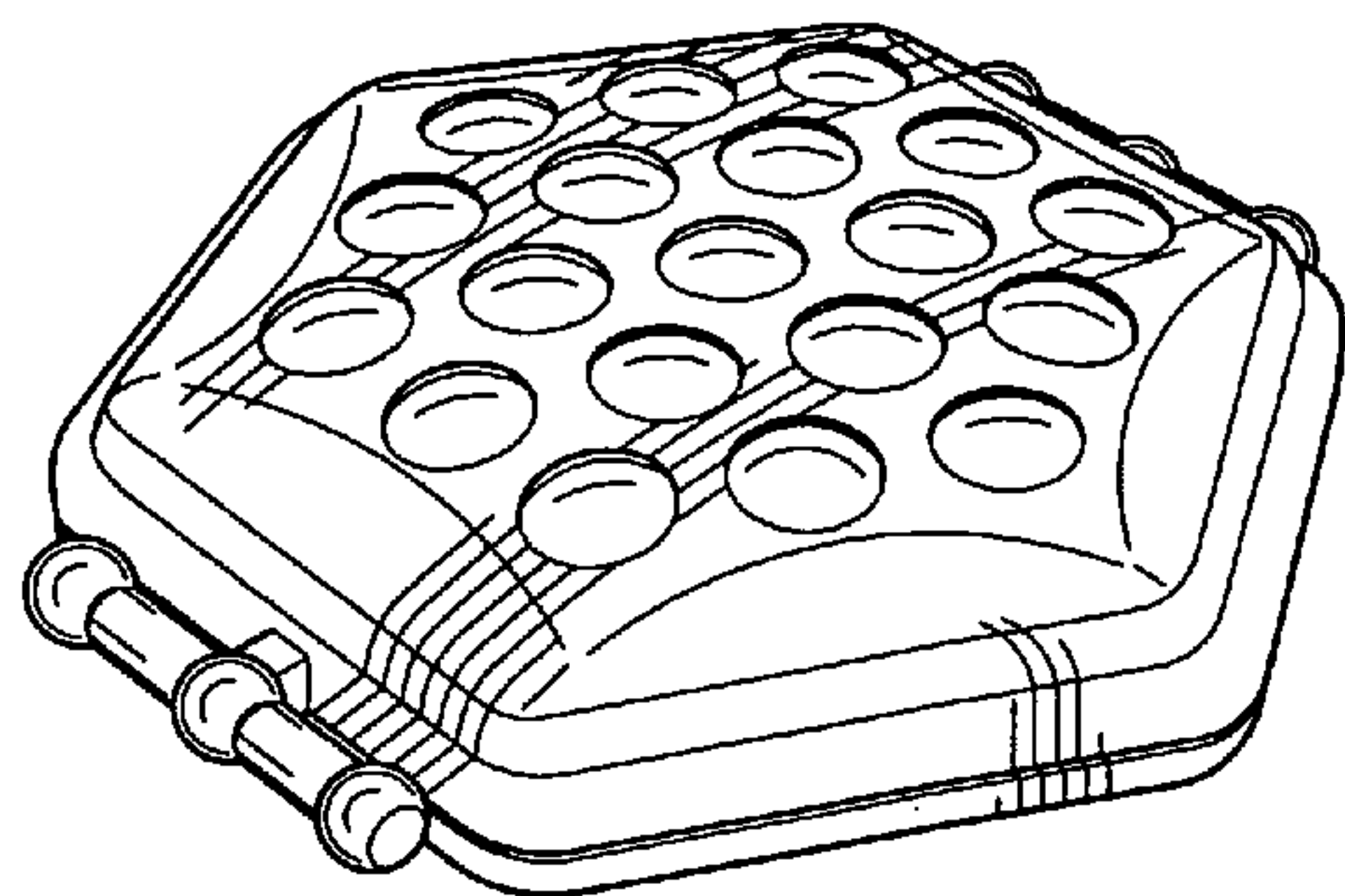
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a container, showing my new design, in a closed condition;  
FIG. 2 is a perspective view thereof, in an open condition;  
FIG. 3 is a top view of the container shown in FIG. 1;  
FIG. 4 is a front view thereof;  
FIG. 5 is a side view thereof, the opposite side being a mirror image thereof; and,  
FIG. 6 is a bottom view thereof.

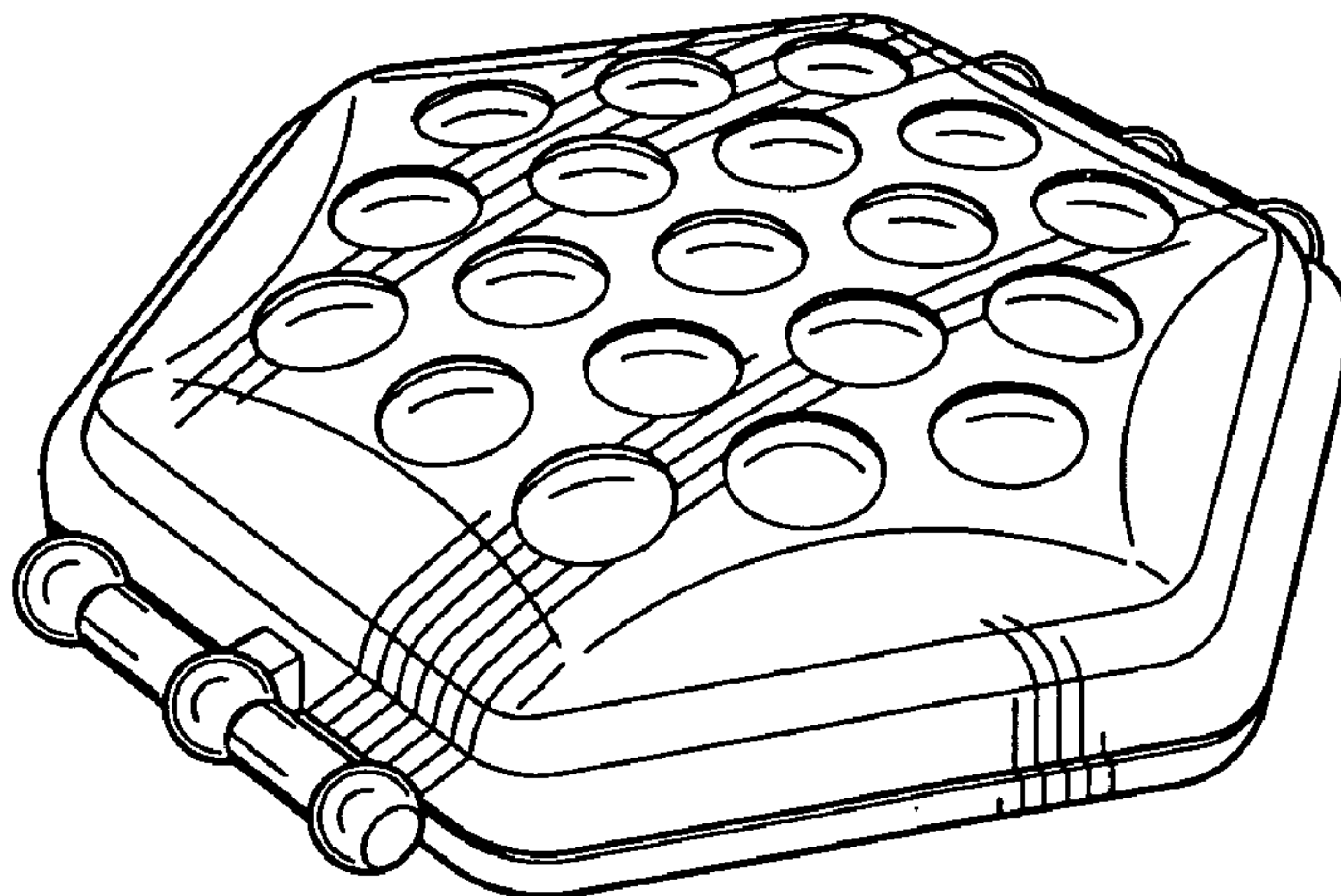

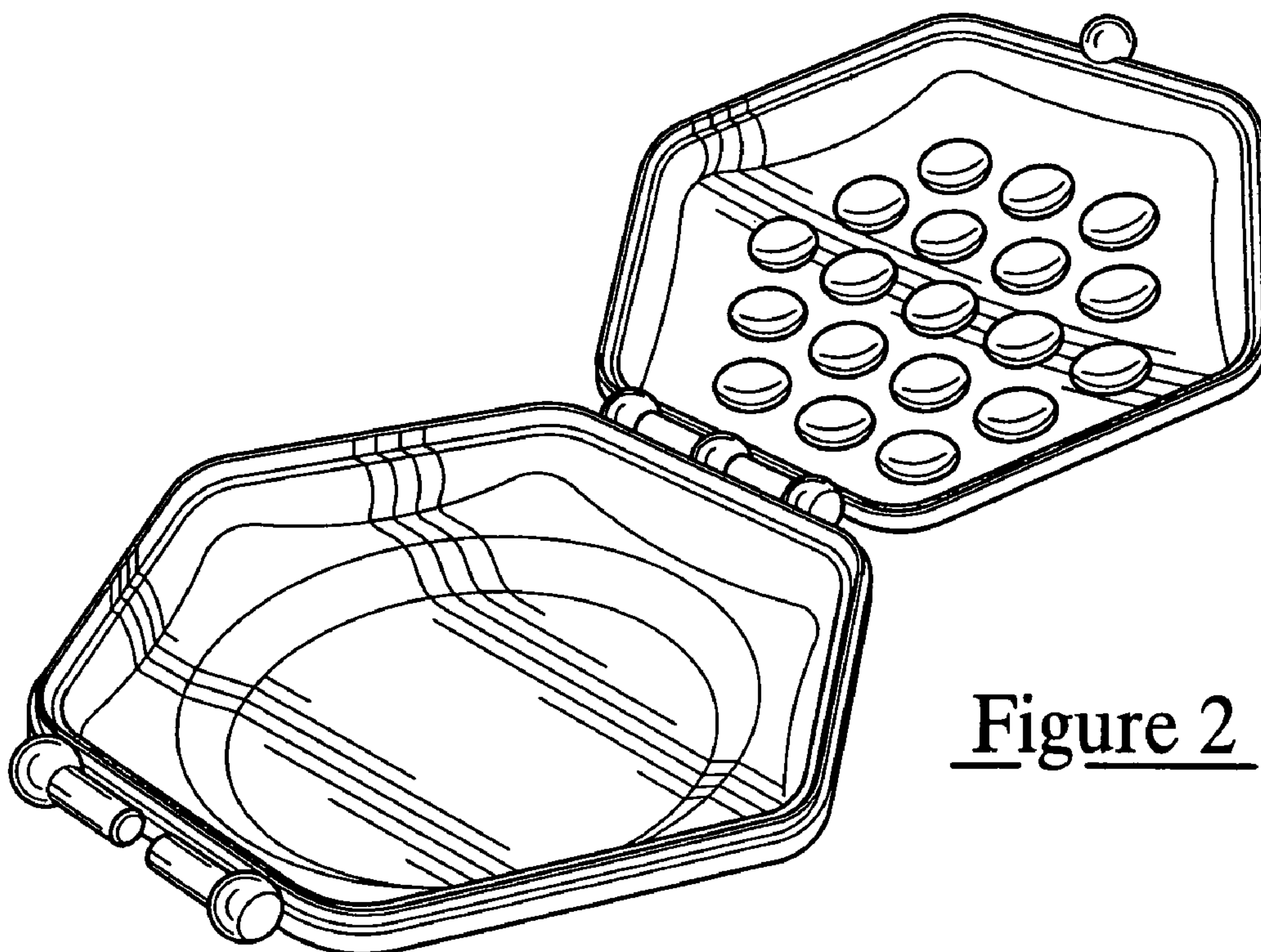

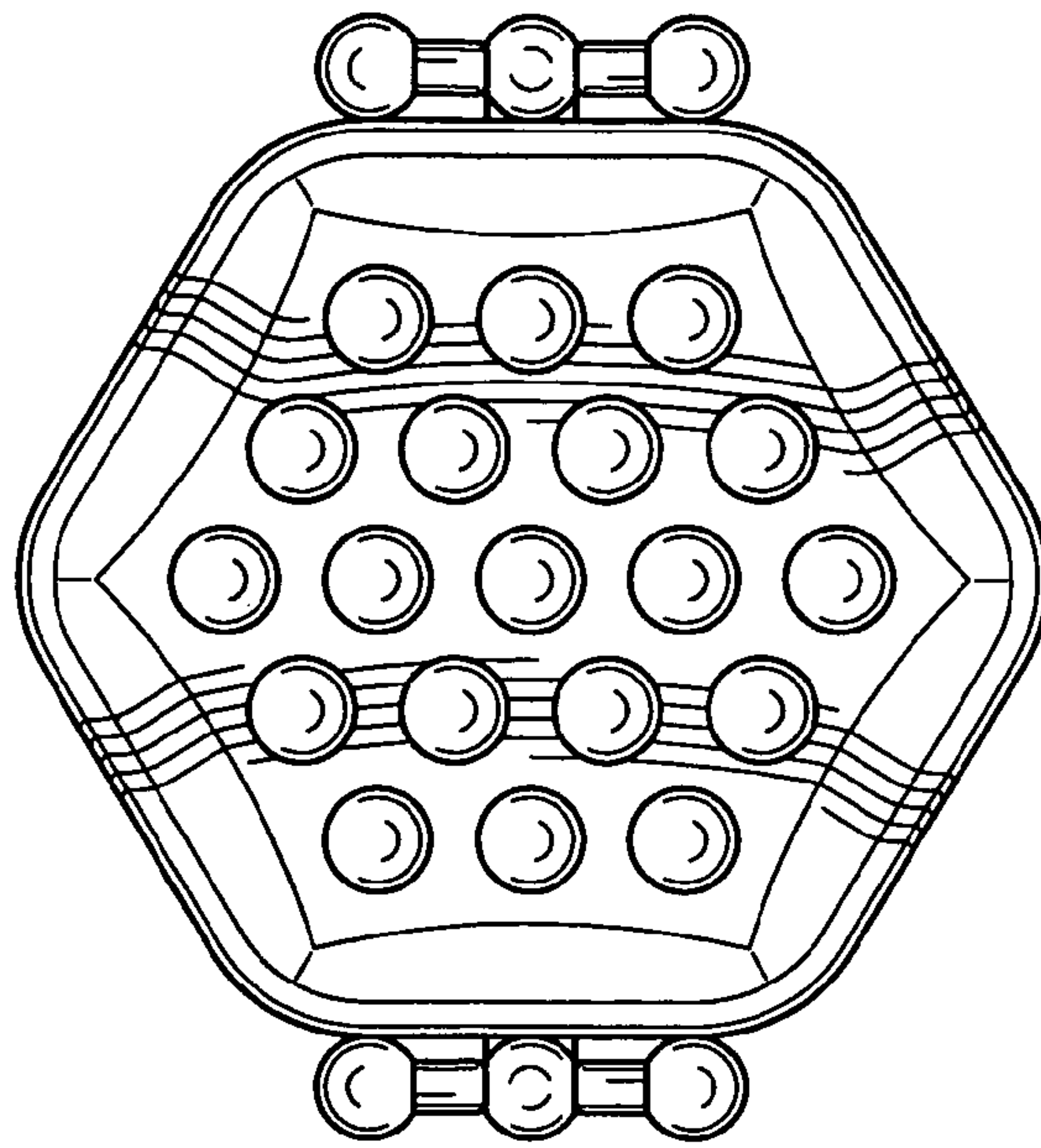

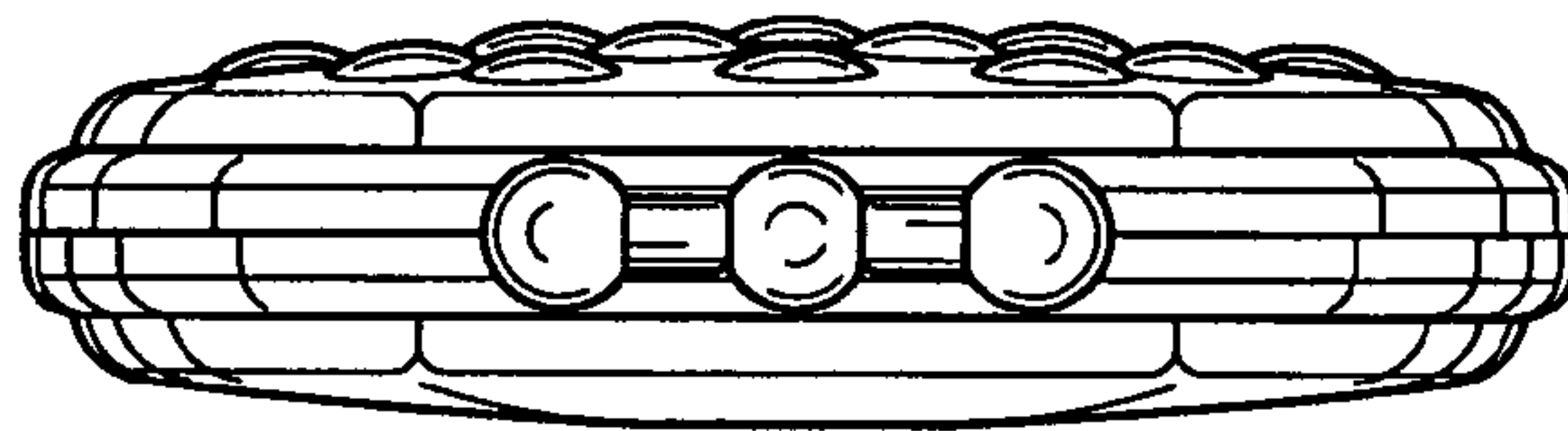

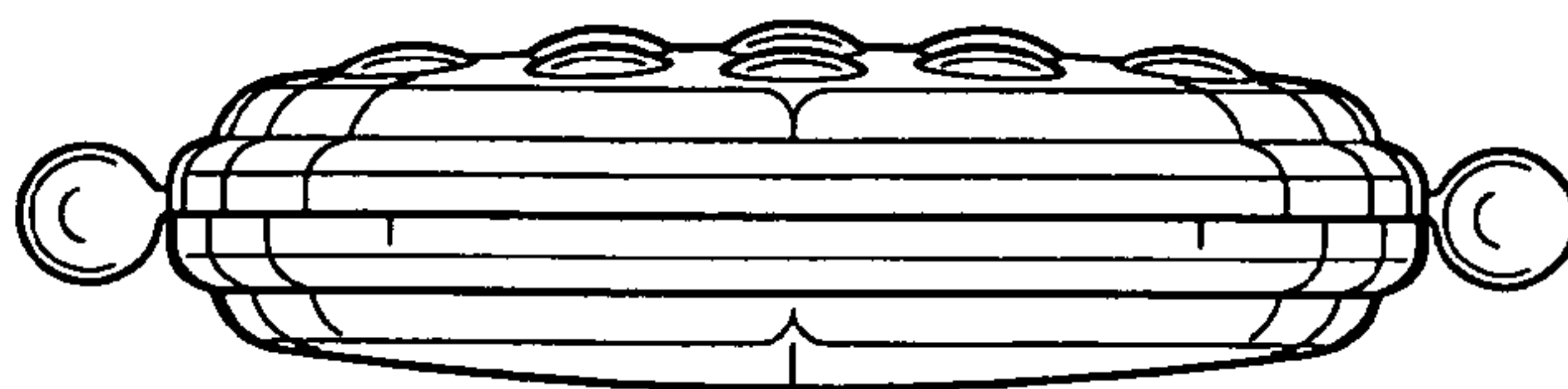

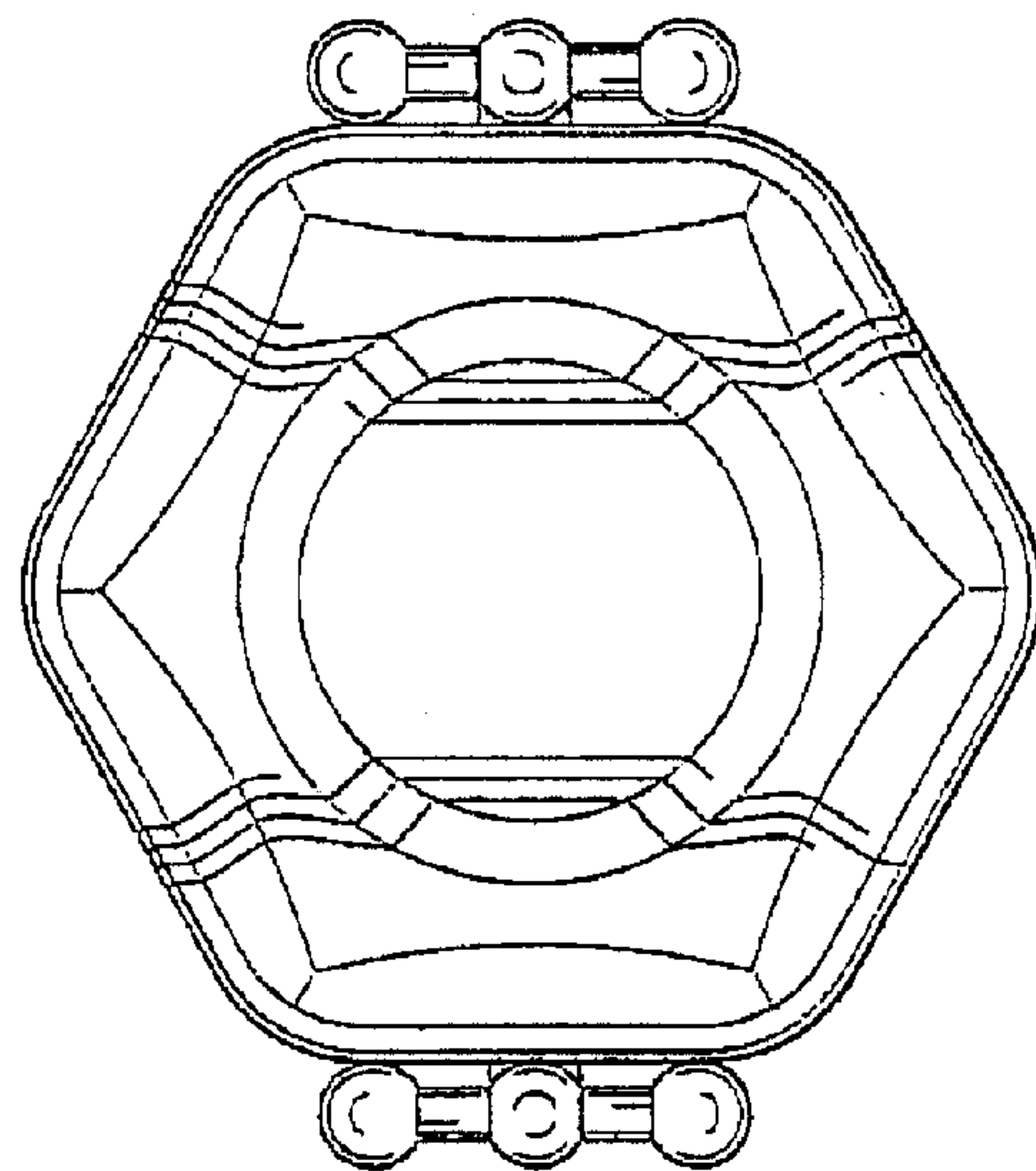
