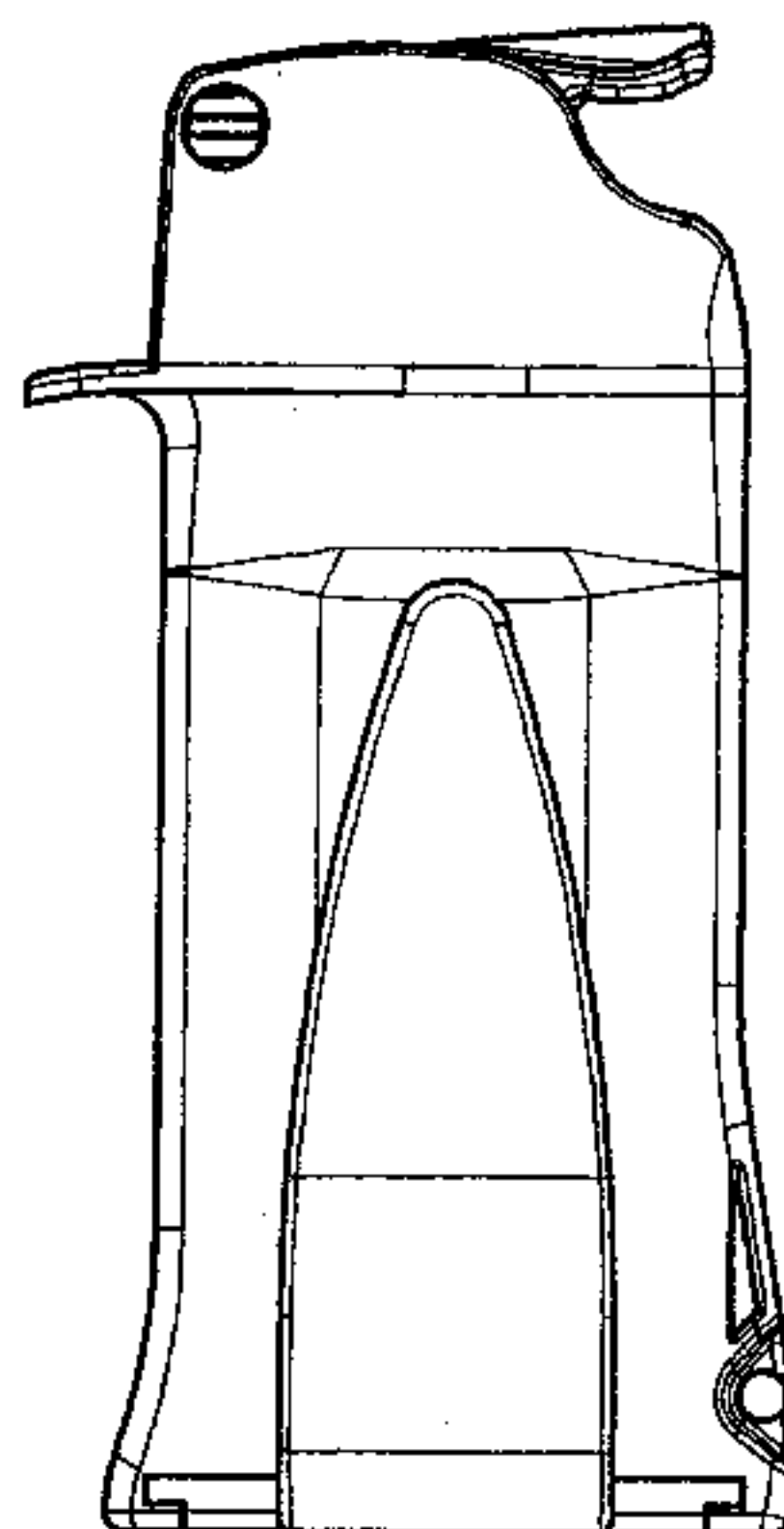
(57) **CLAIM**

The ornamental designs for a container with a clip for aerosol cans, as shown and described.

DESCRIPTION

FIG. 1 is the left side view of a container with a clip for aerosol cans, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is an elevated perspective view thereof;
FIG. 6 is an elevated rear perspective view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a rear view thereof;
FIG. 9 is a left side view of a second embodiment of a container with a clip for aerosol cans;
FIG. 10 is a front view of FIG. 9;
FIG. 11 is a bottom view of FIG. 9;
FIG. 12 is a top view of FIG. 9;
FIG. 13 is an elevated perspective front view of FIG. 9;
FIG. 14 is an elevated rear perspective view of FIG. 9;
FIG. 15 is a right side view of FIG. 9; and,

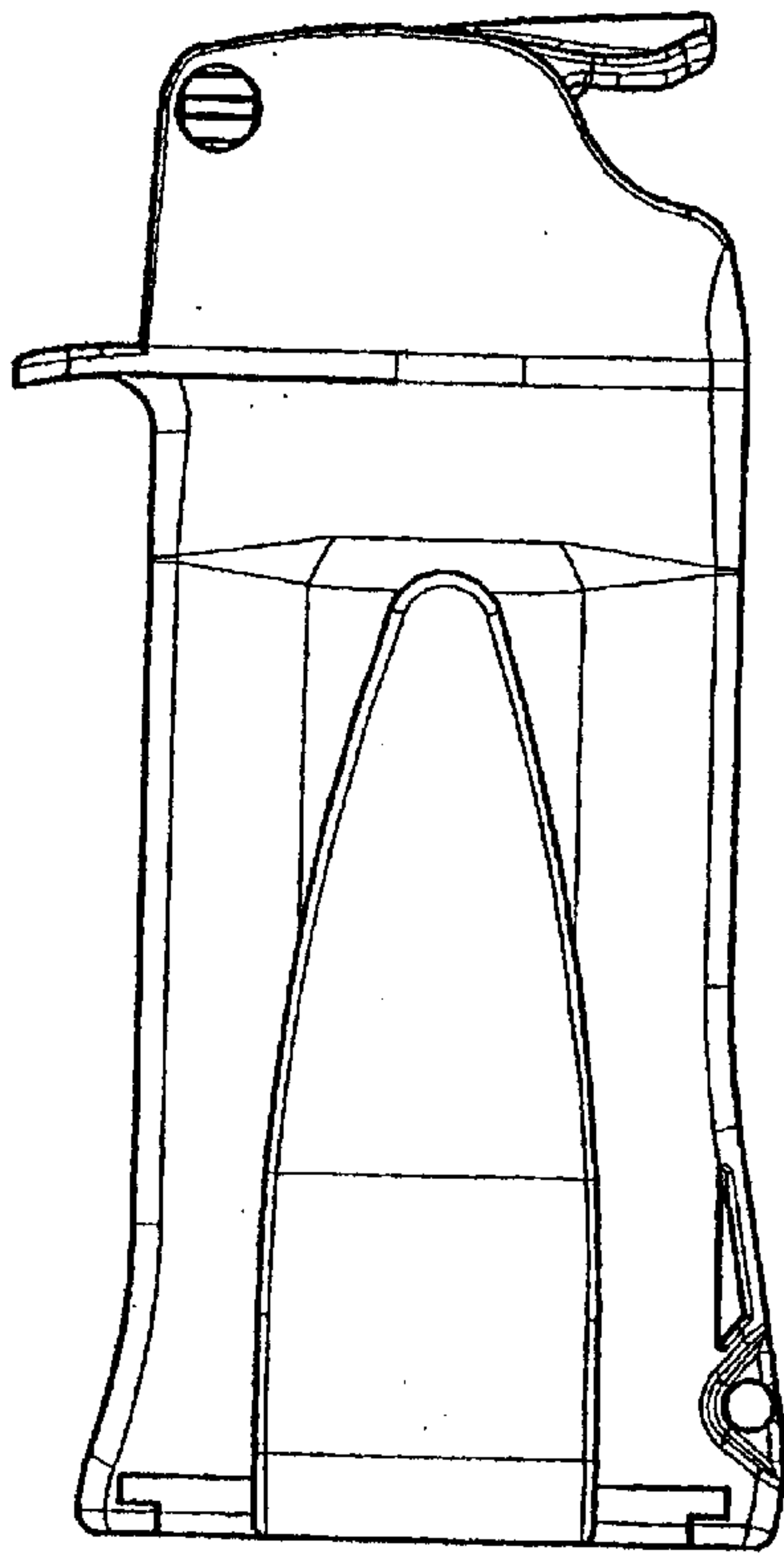

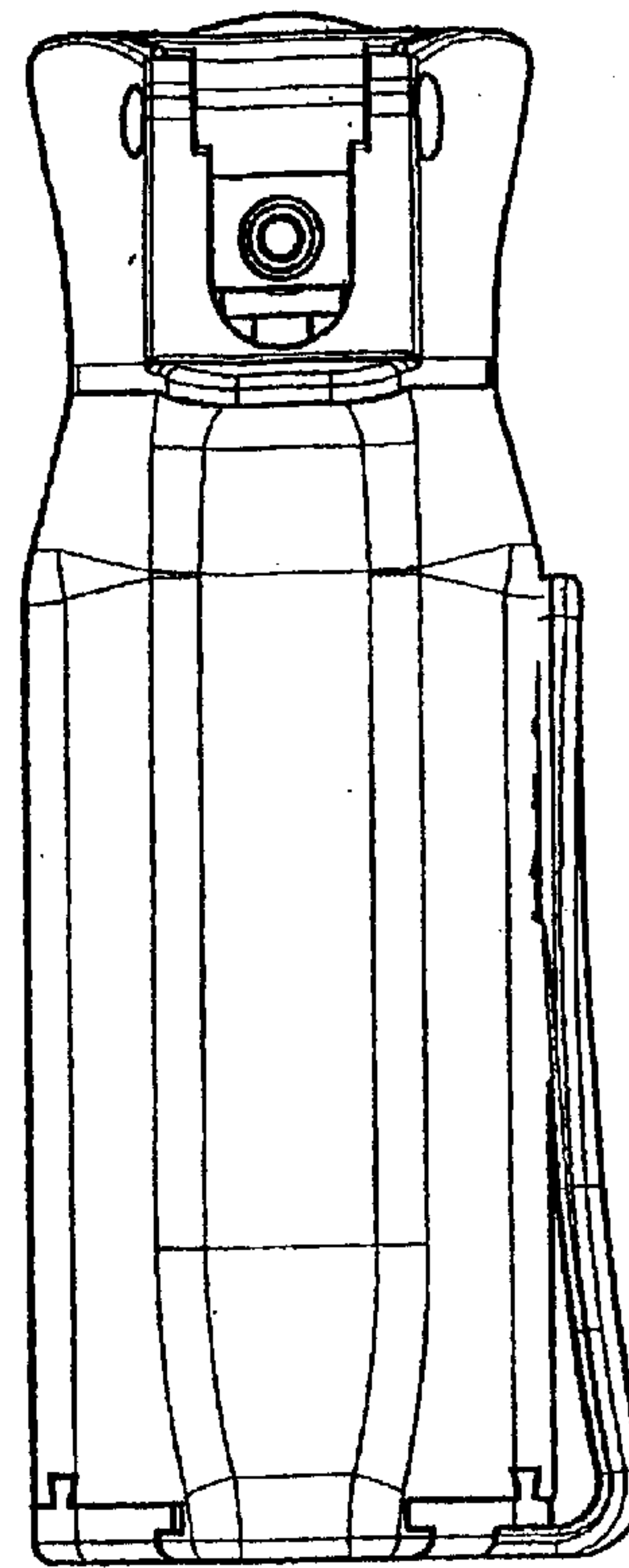

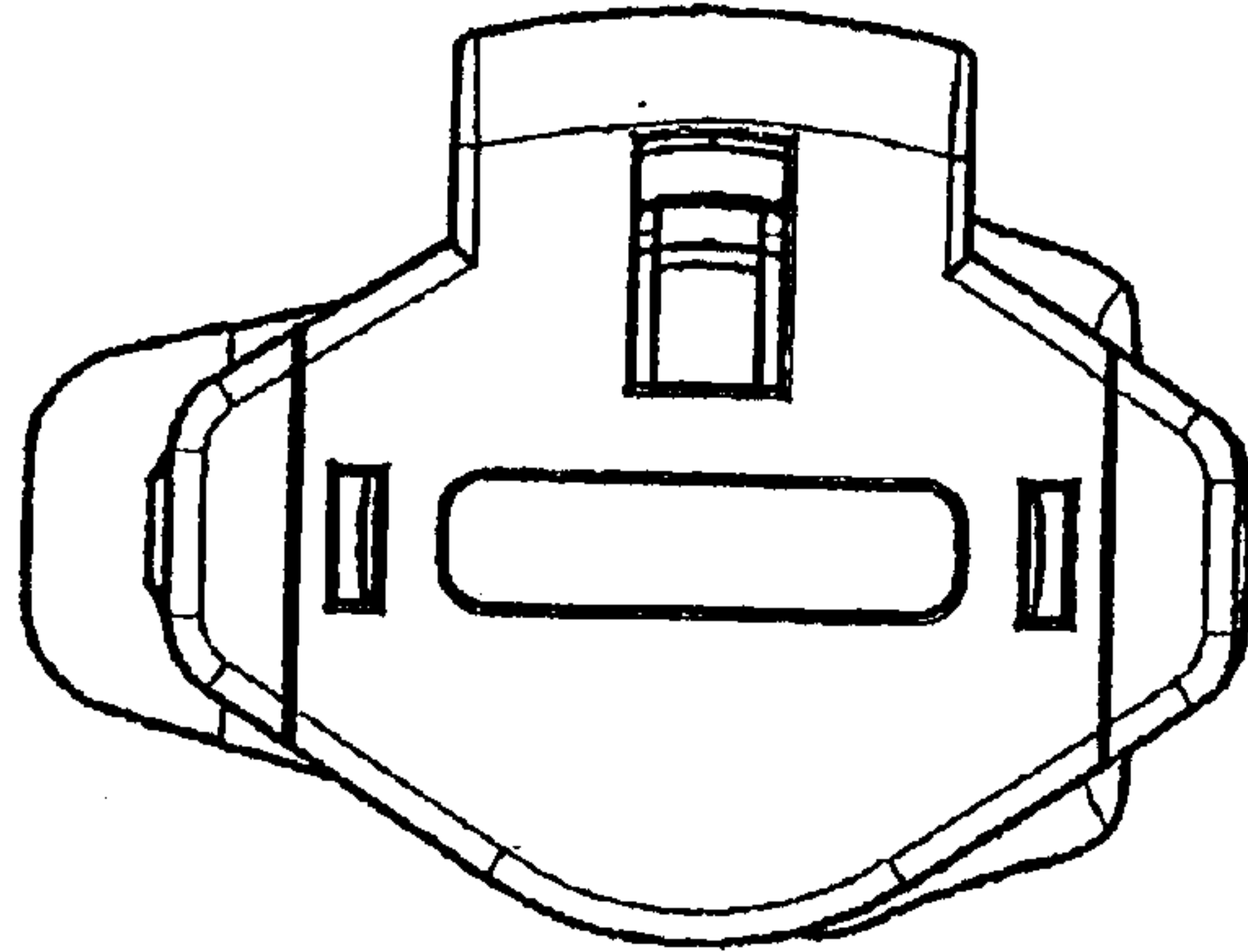

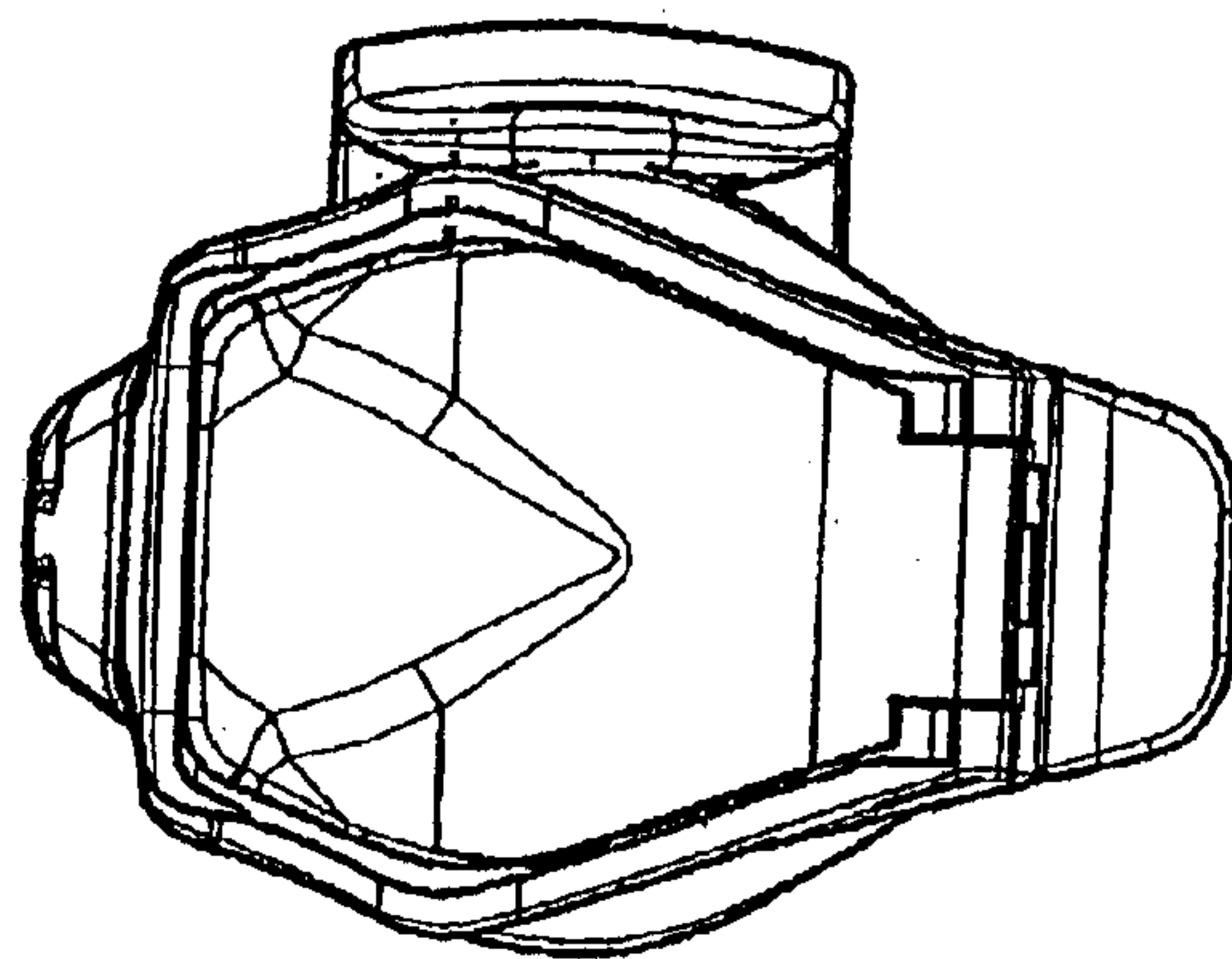

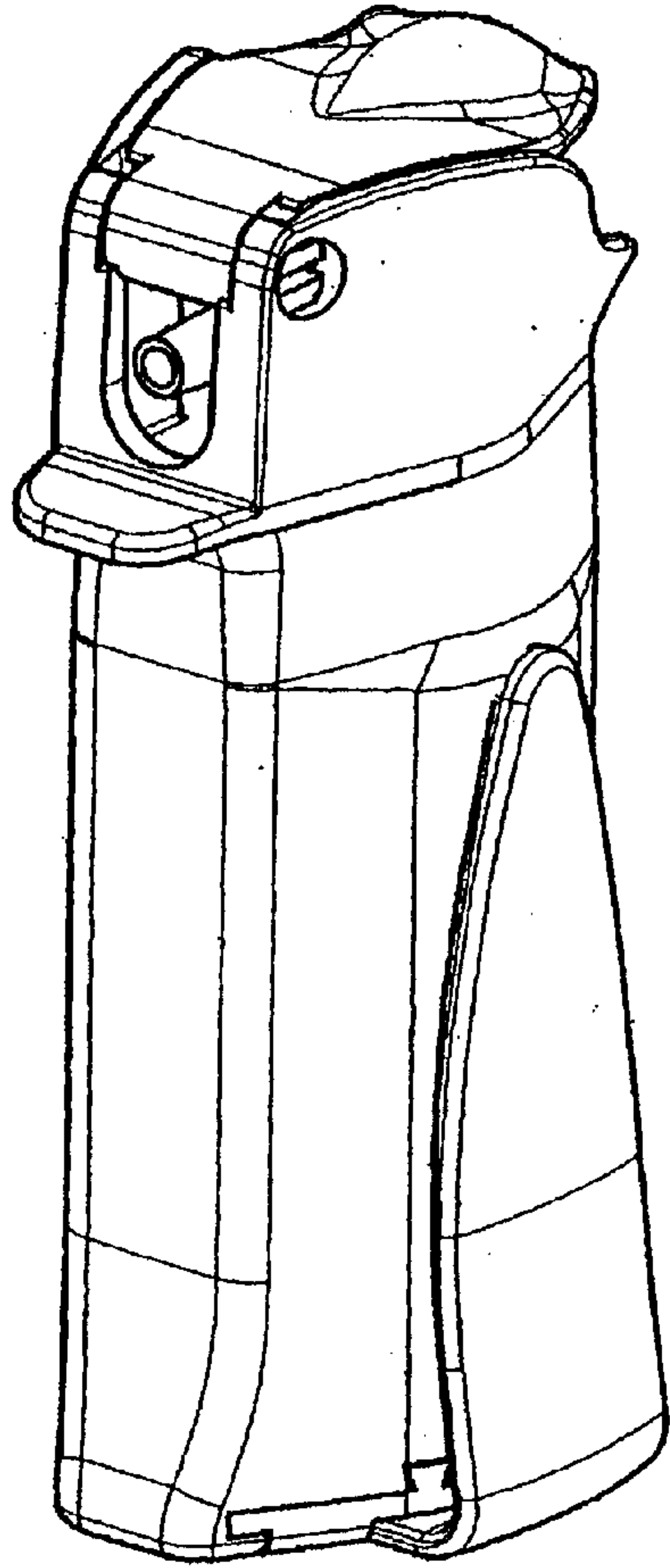

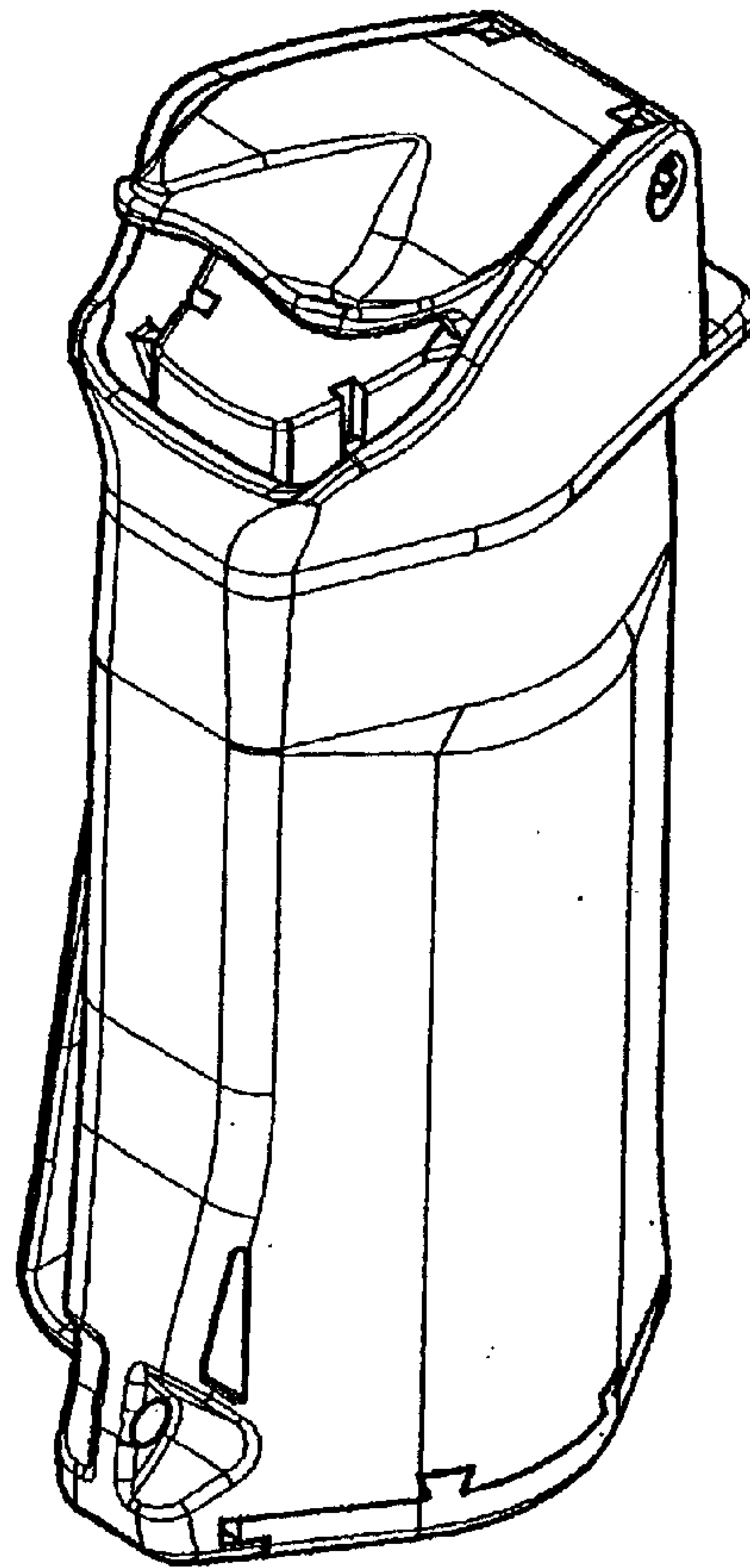

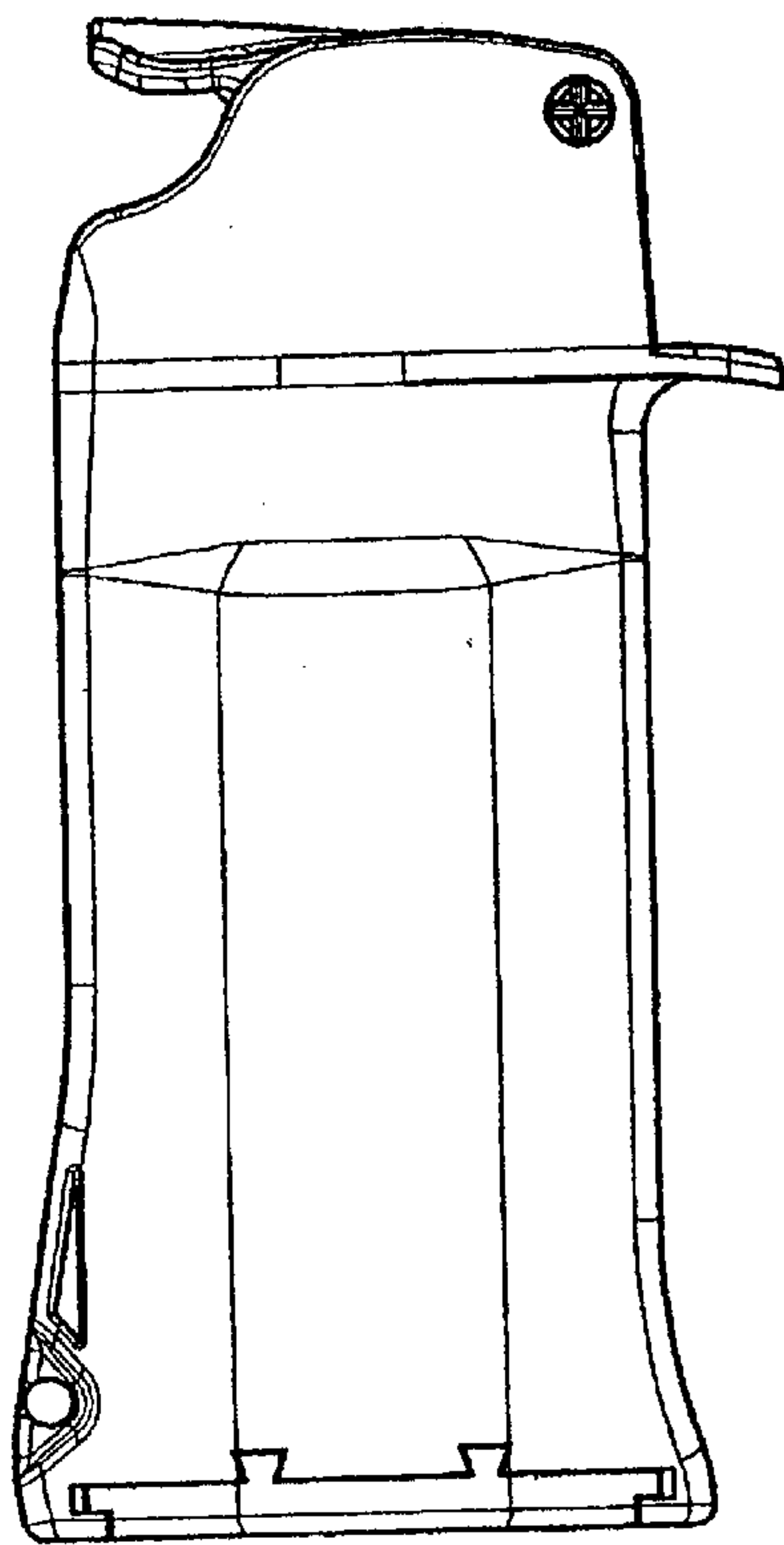

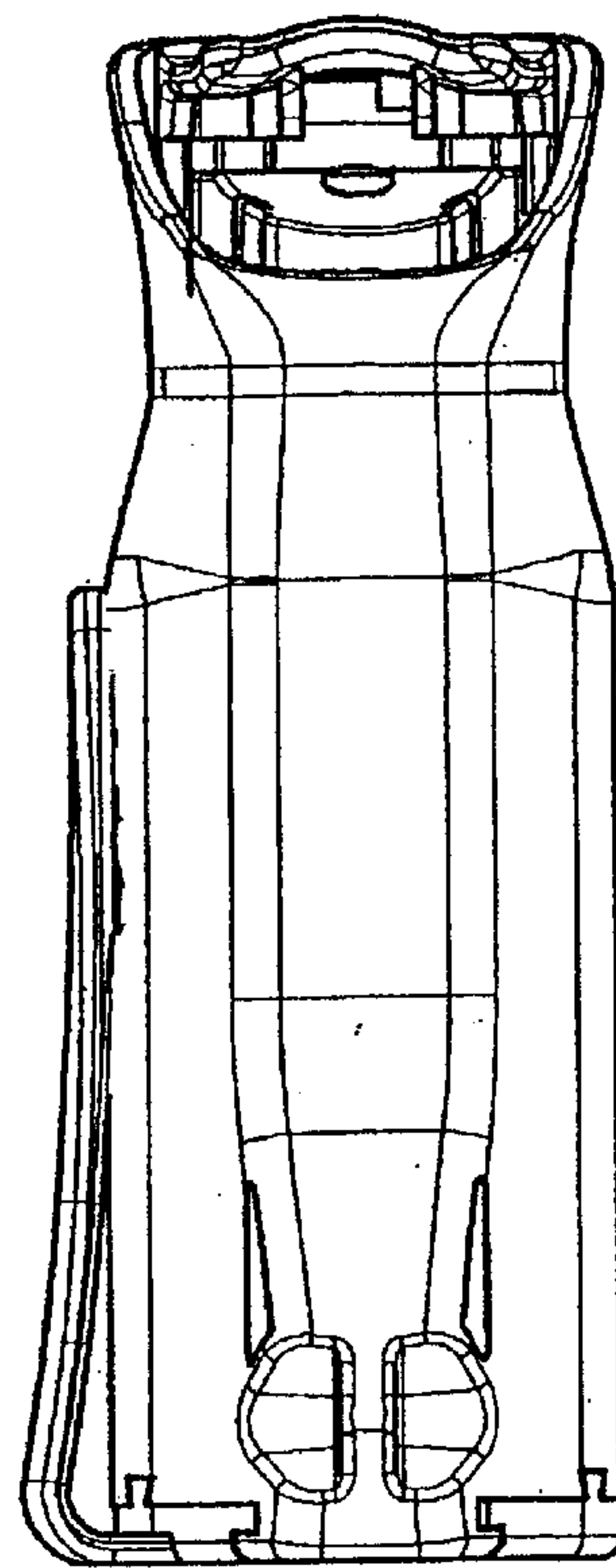

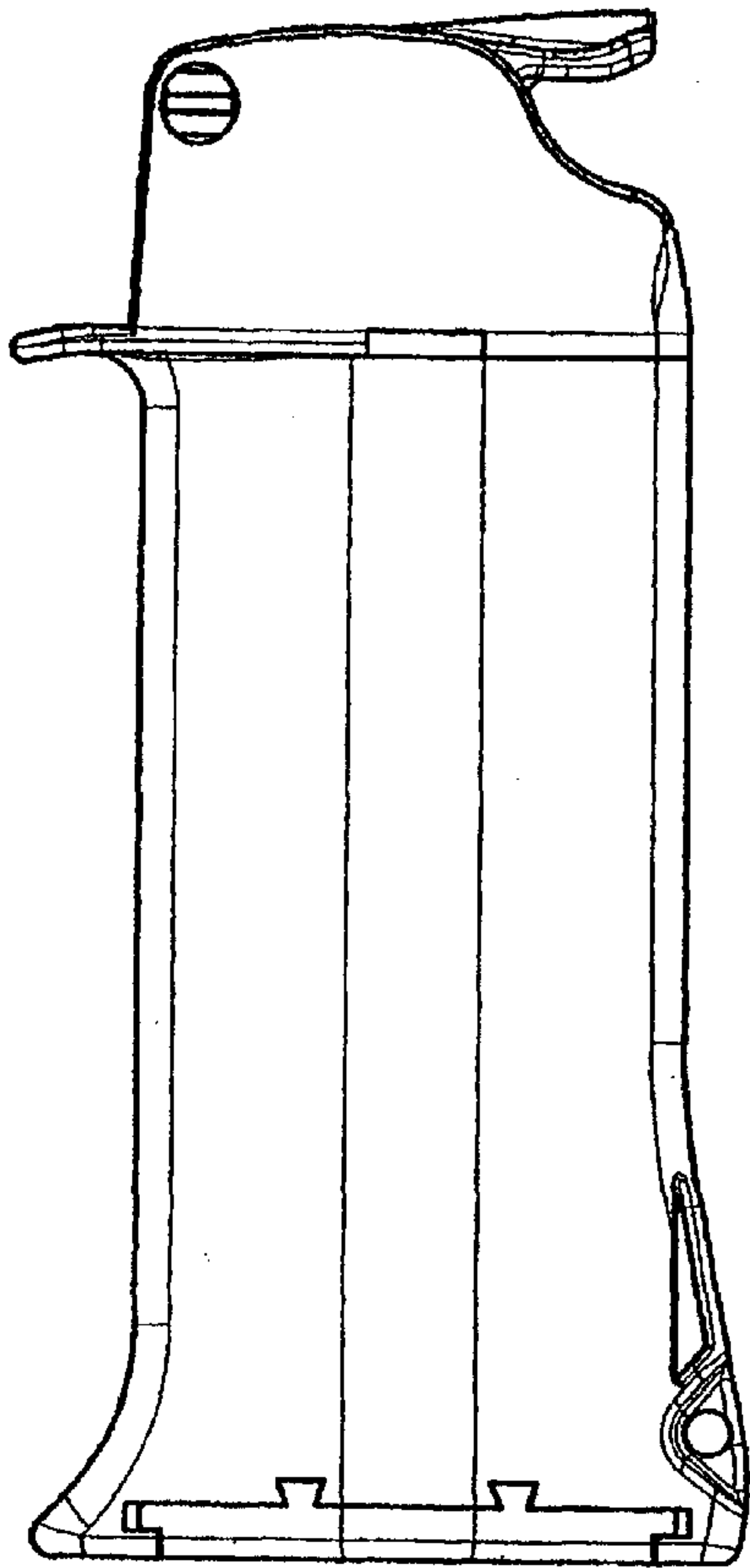

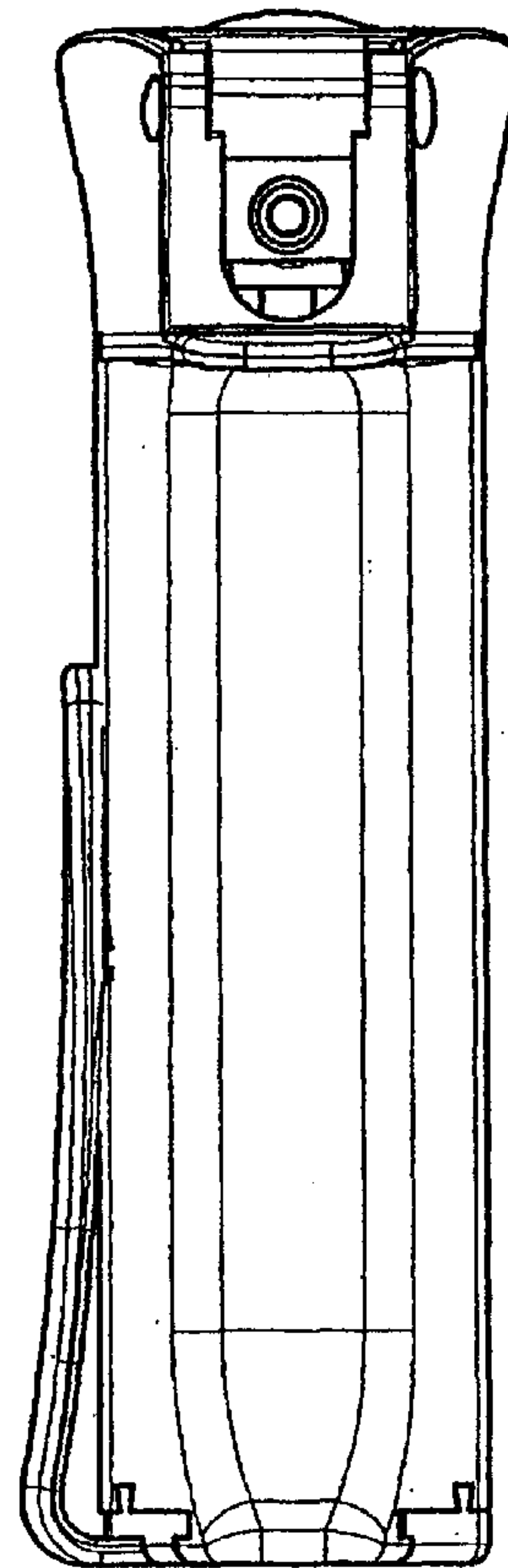

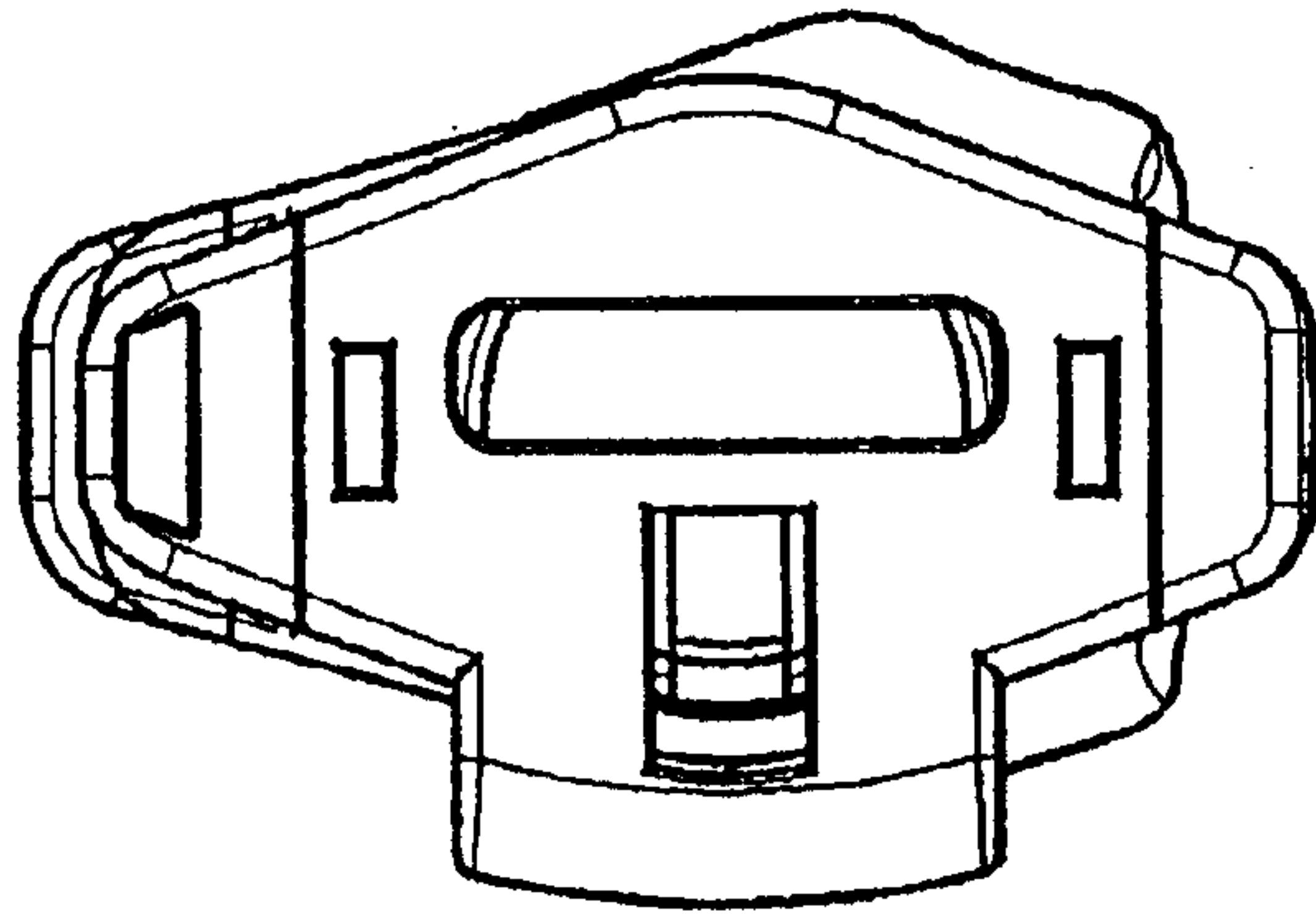

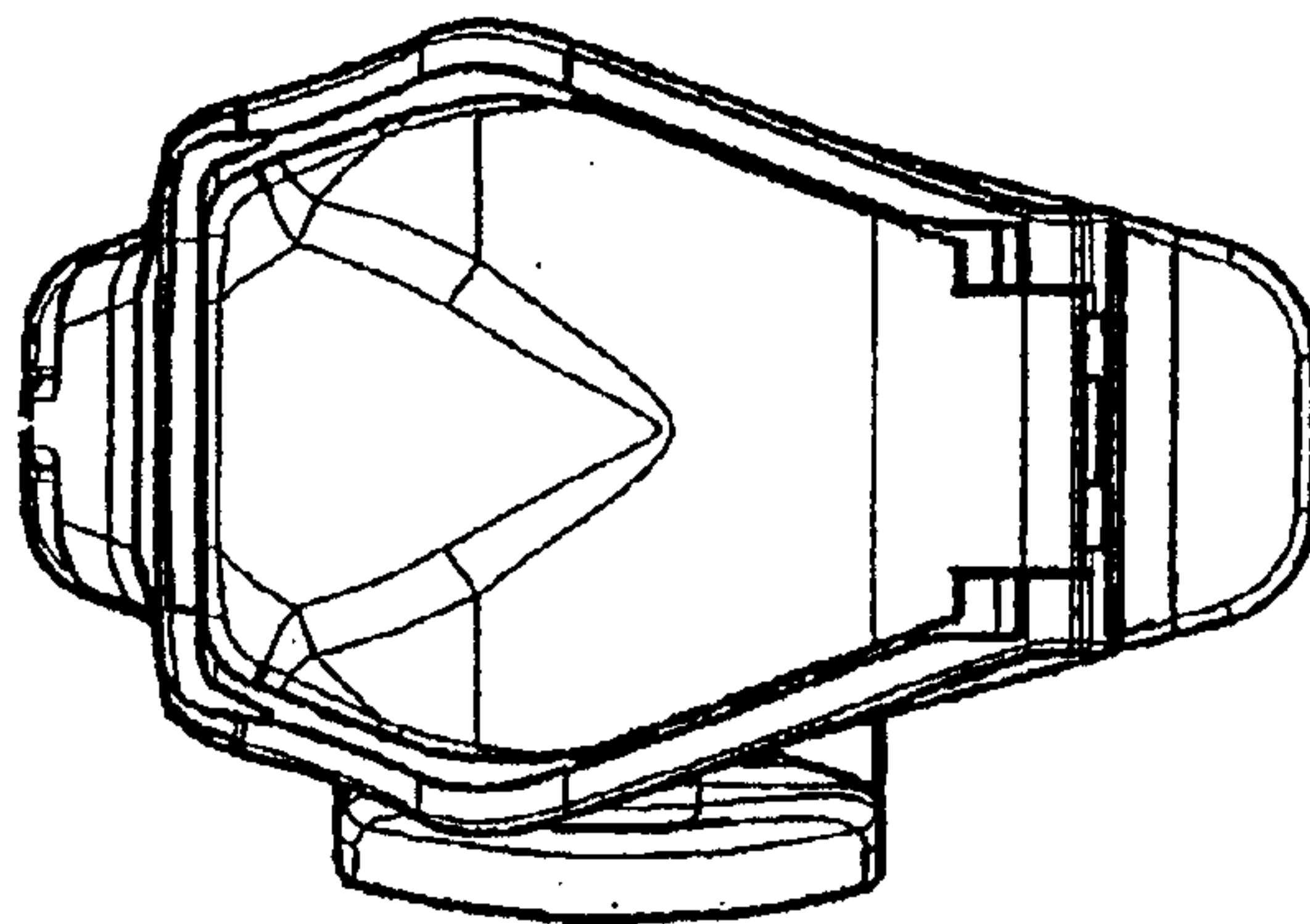

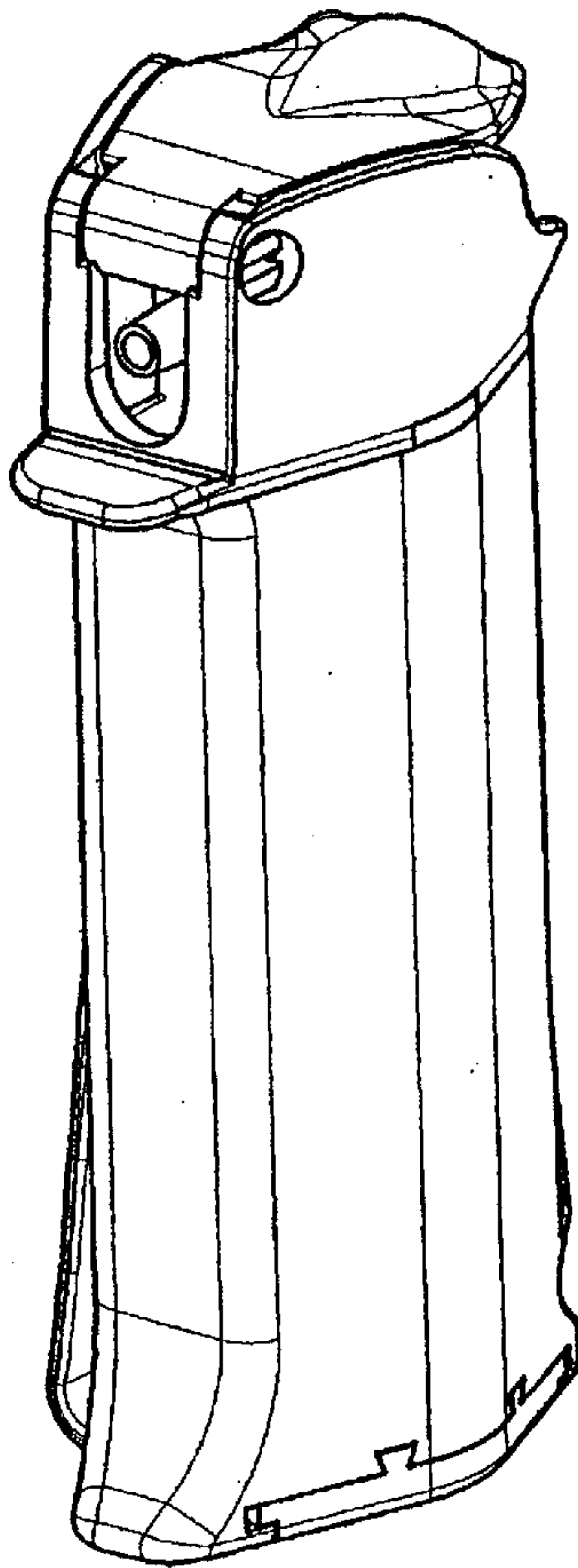

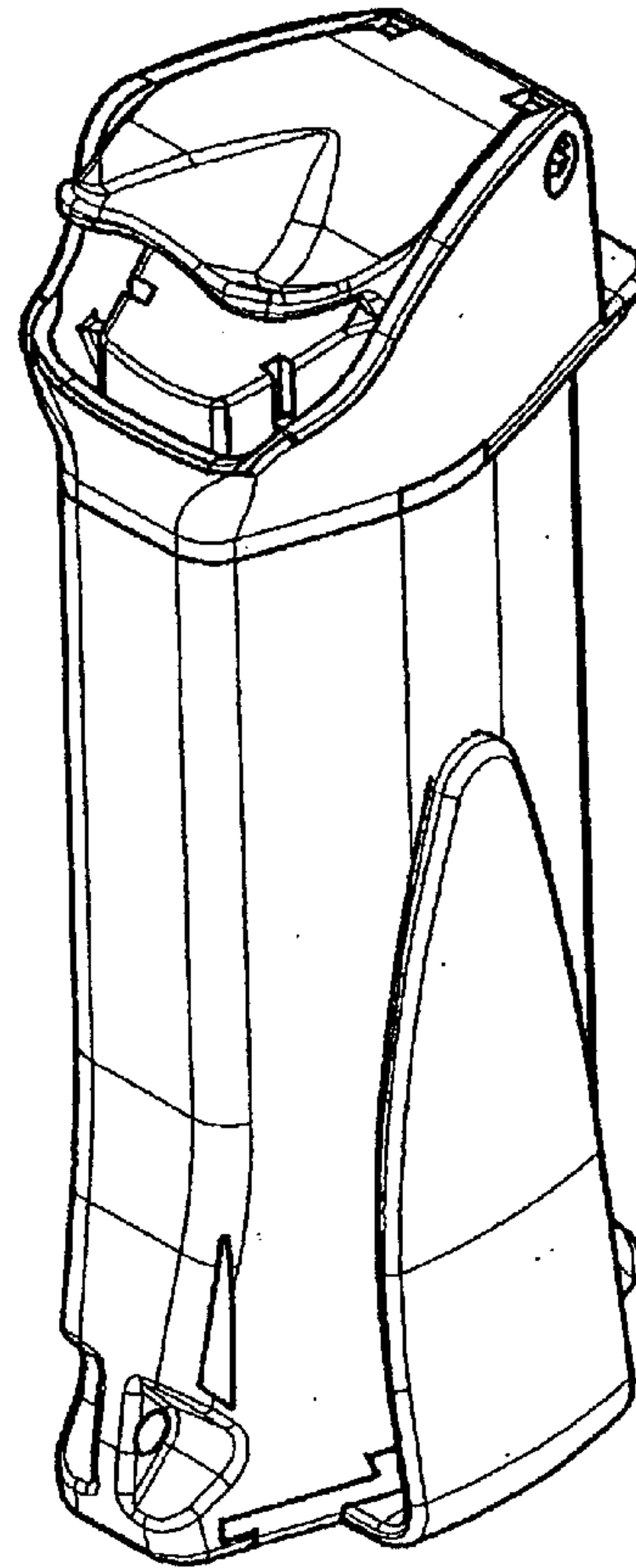

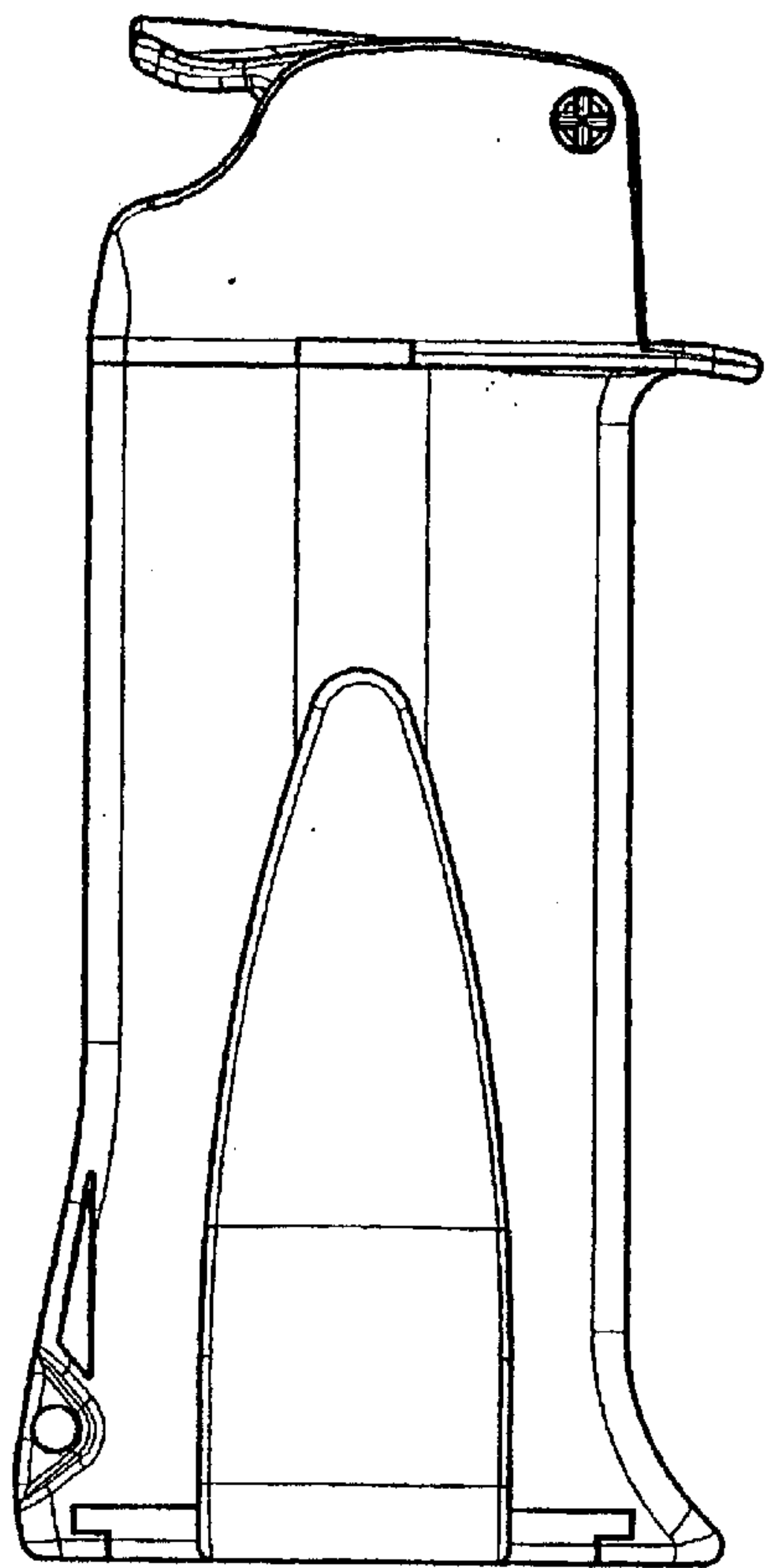

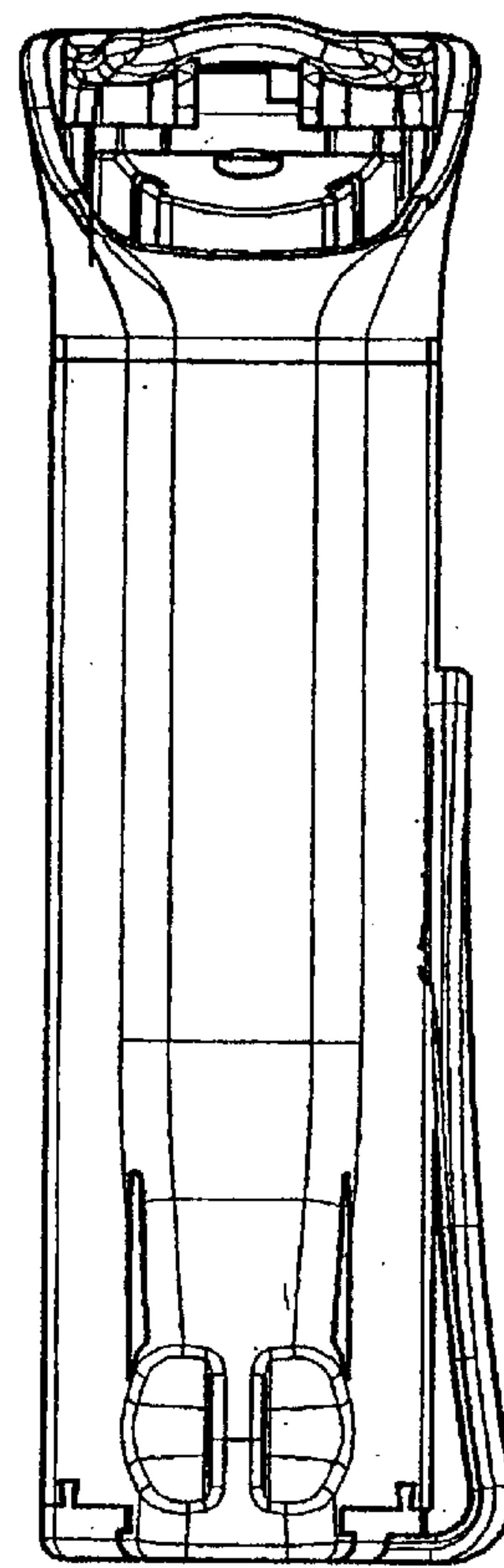
