DESCRIPTION

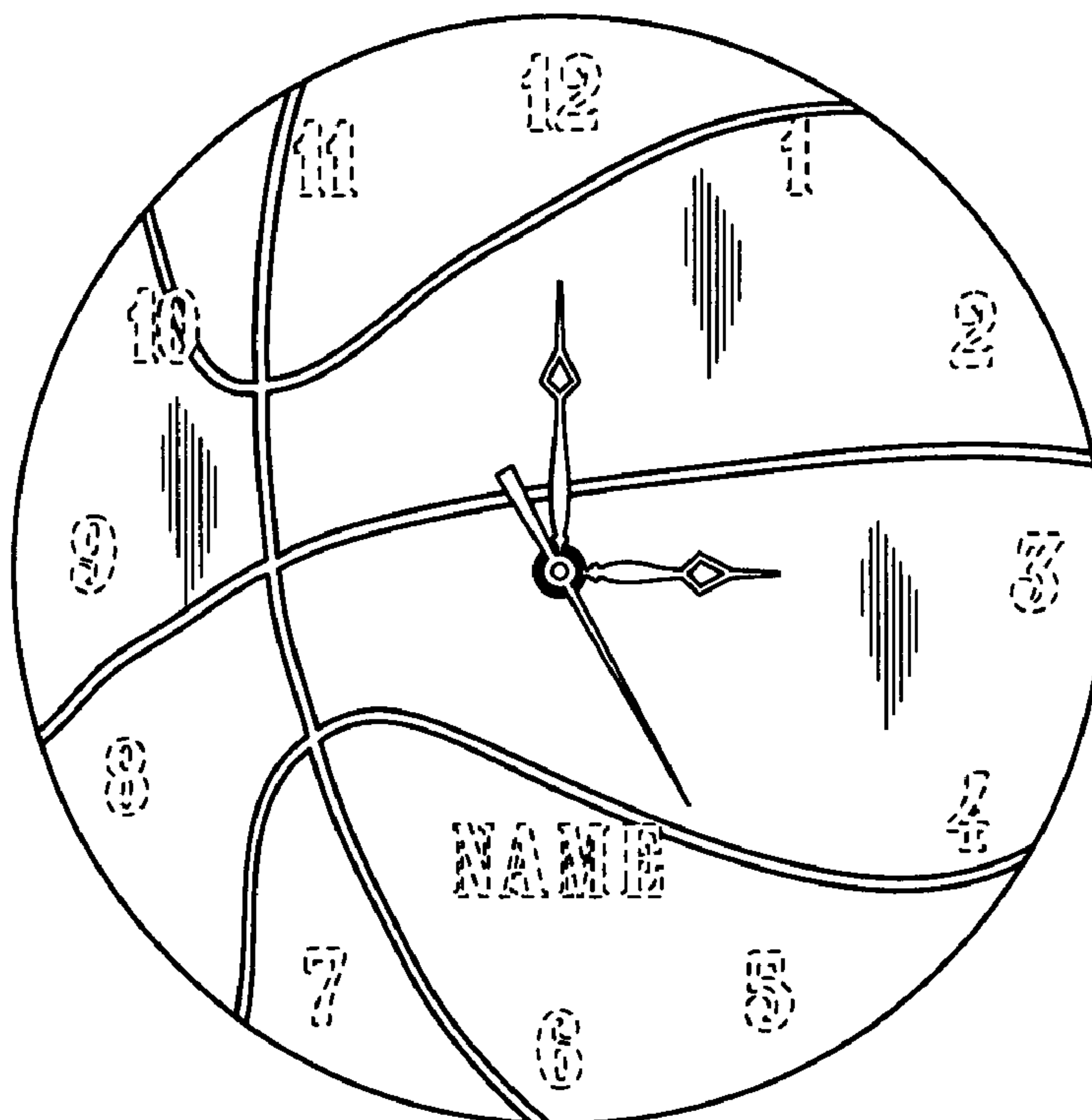
FIG. 1 shows a front elevational view of my design for a basketball clock;

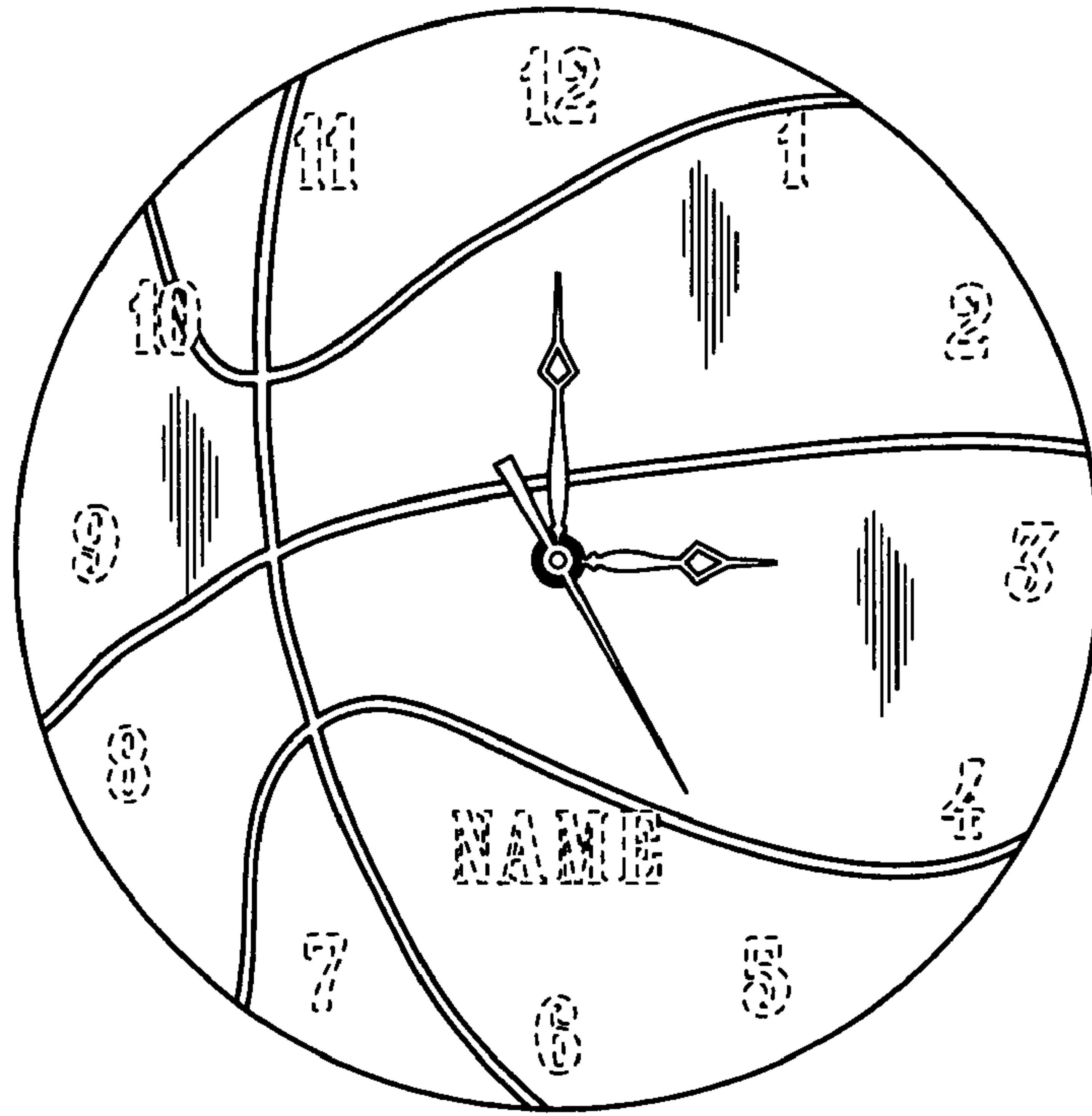

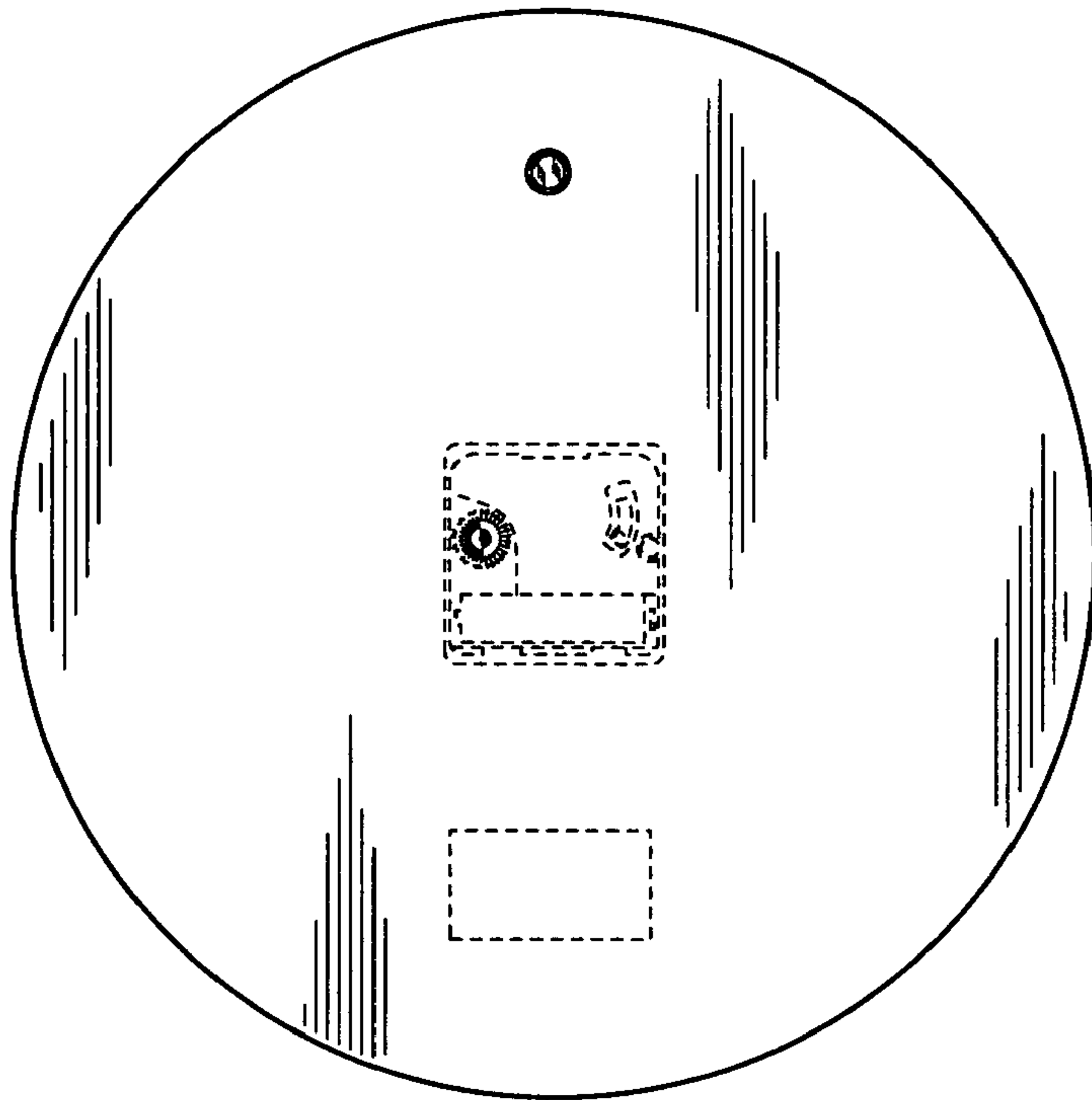

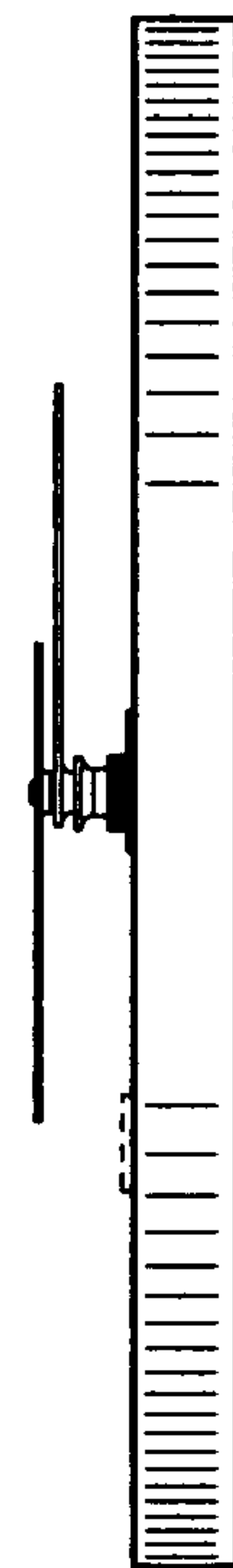
