The ornamental design for an electronic reminder clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electronic reminder clip showing our new design having a display part and an attachment part together.

FIG. 2 is a top plan view thereof.

FIG. 3 is a front elevational view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a right side view thereof.

FIG. 6 is a bottom view thereof.

FIG. 7 is a rear view thereof; and,

FIG. 8 is an exploded view thereof showing a display part and an attachment part separated.

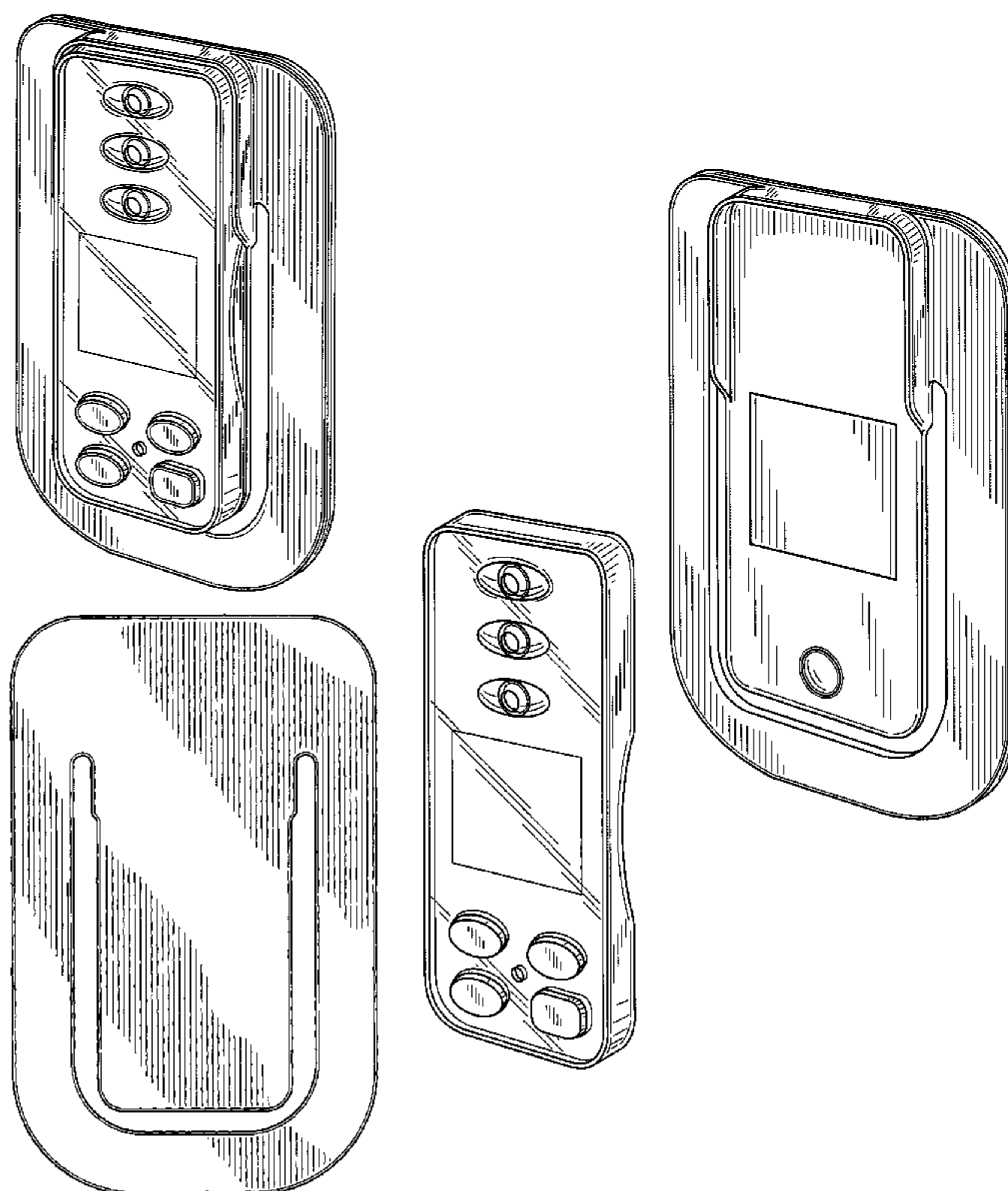

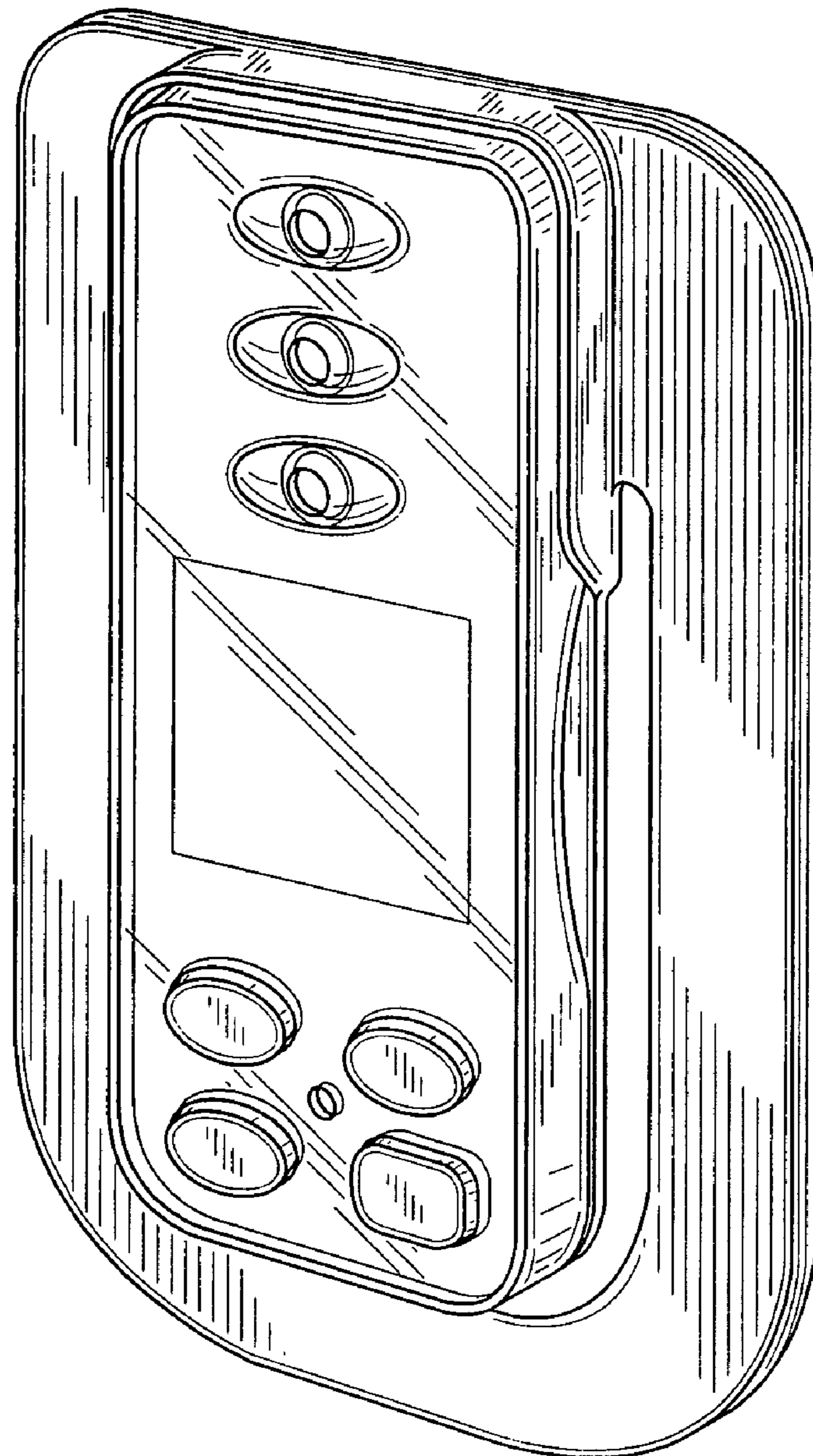

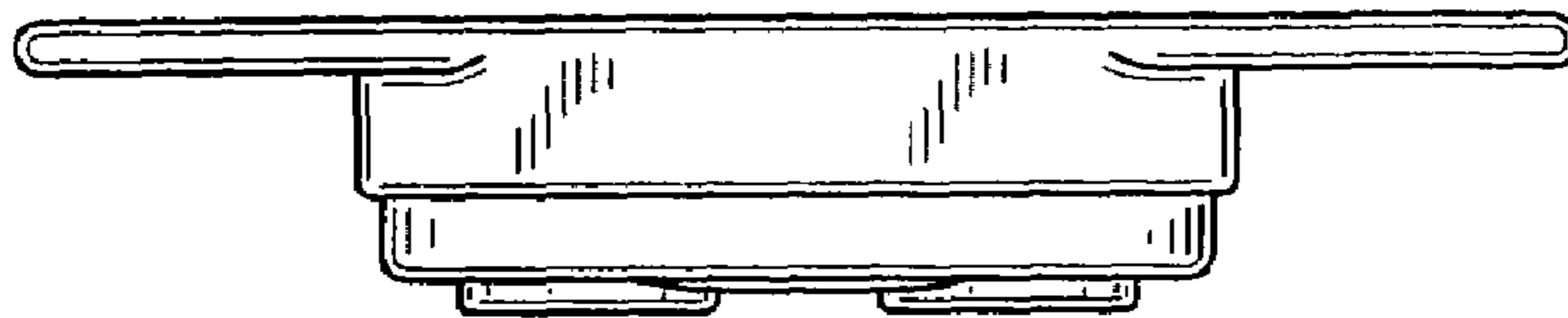

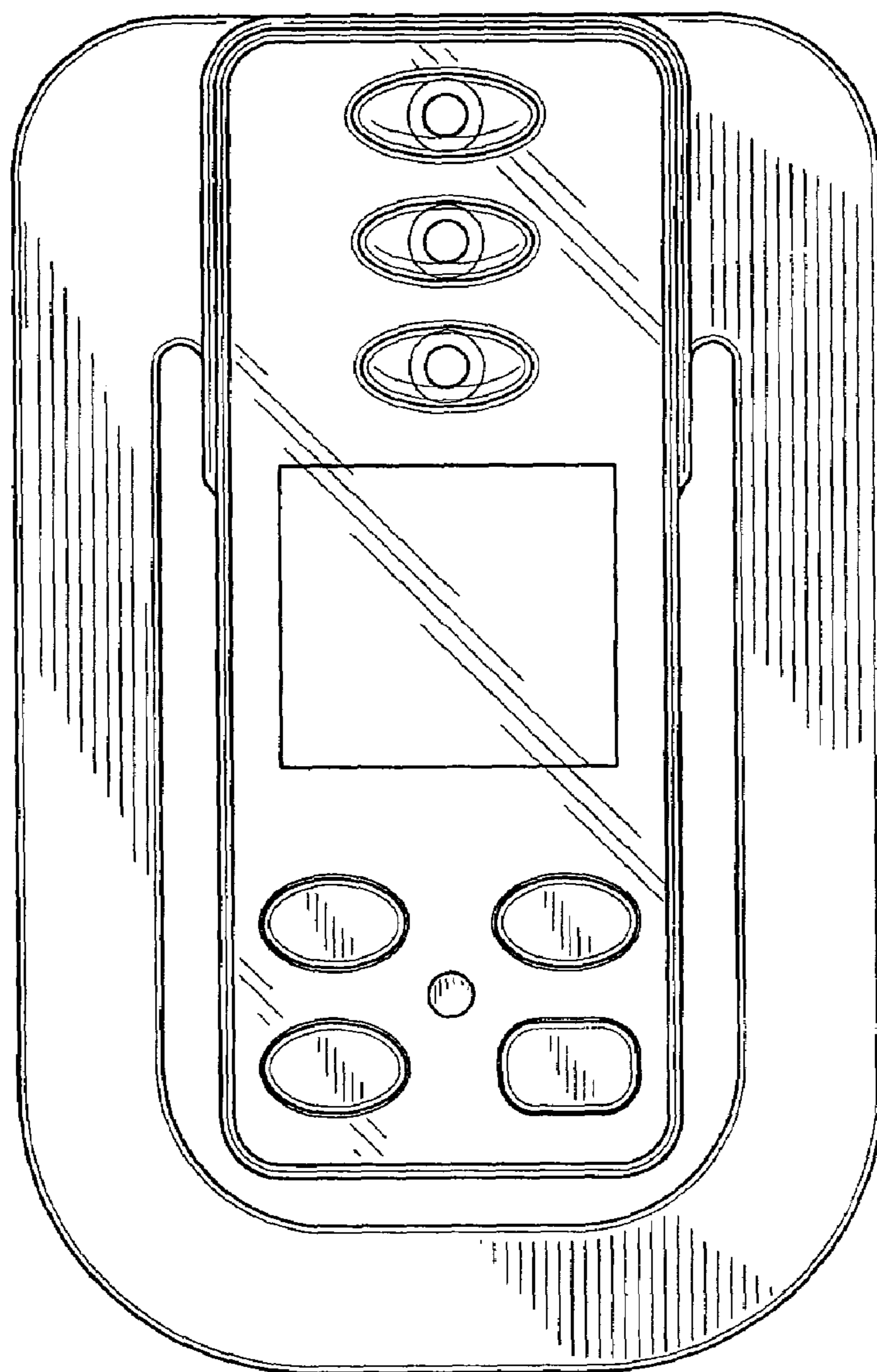

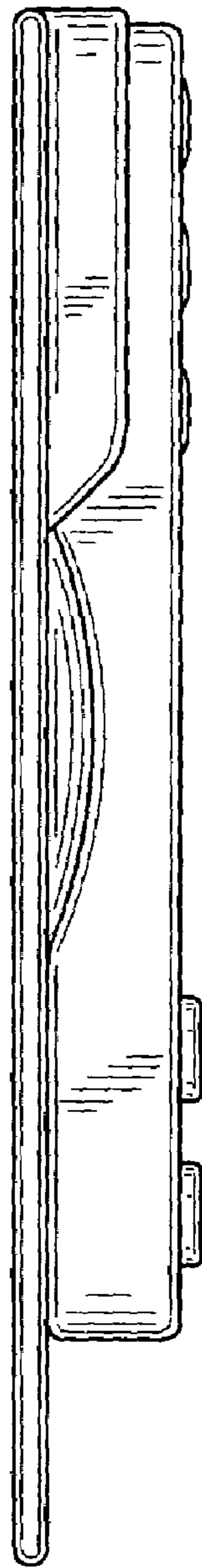

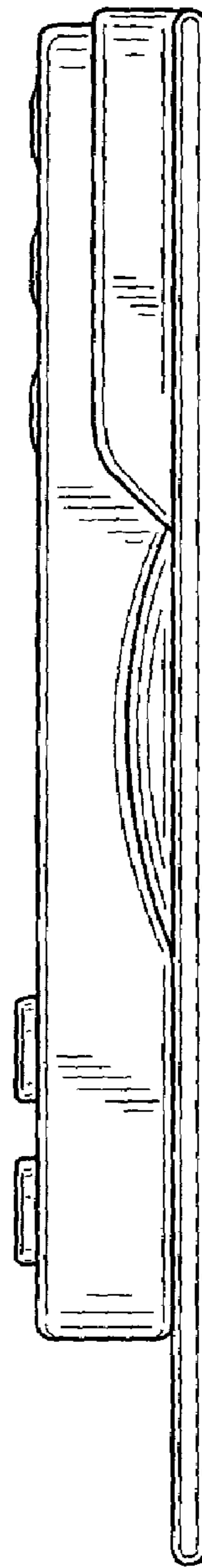

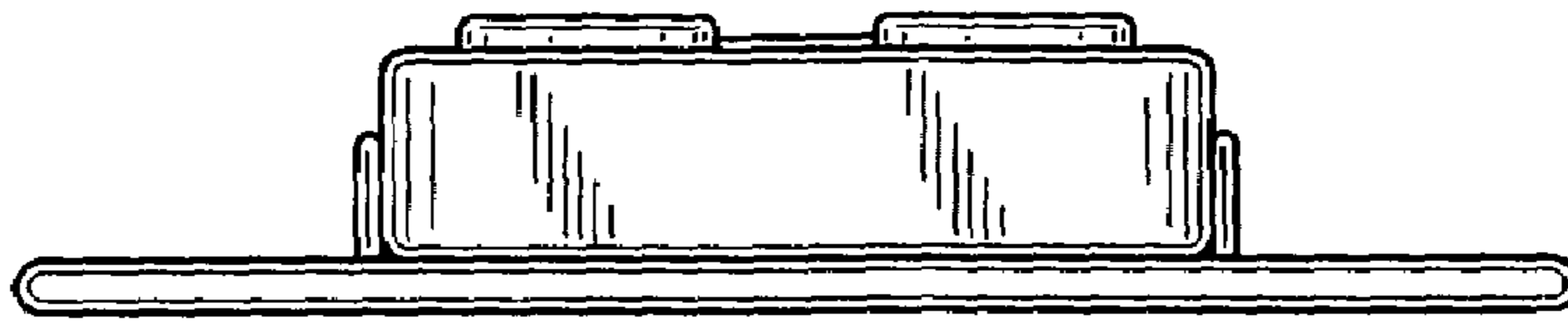

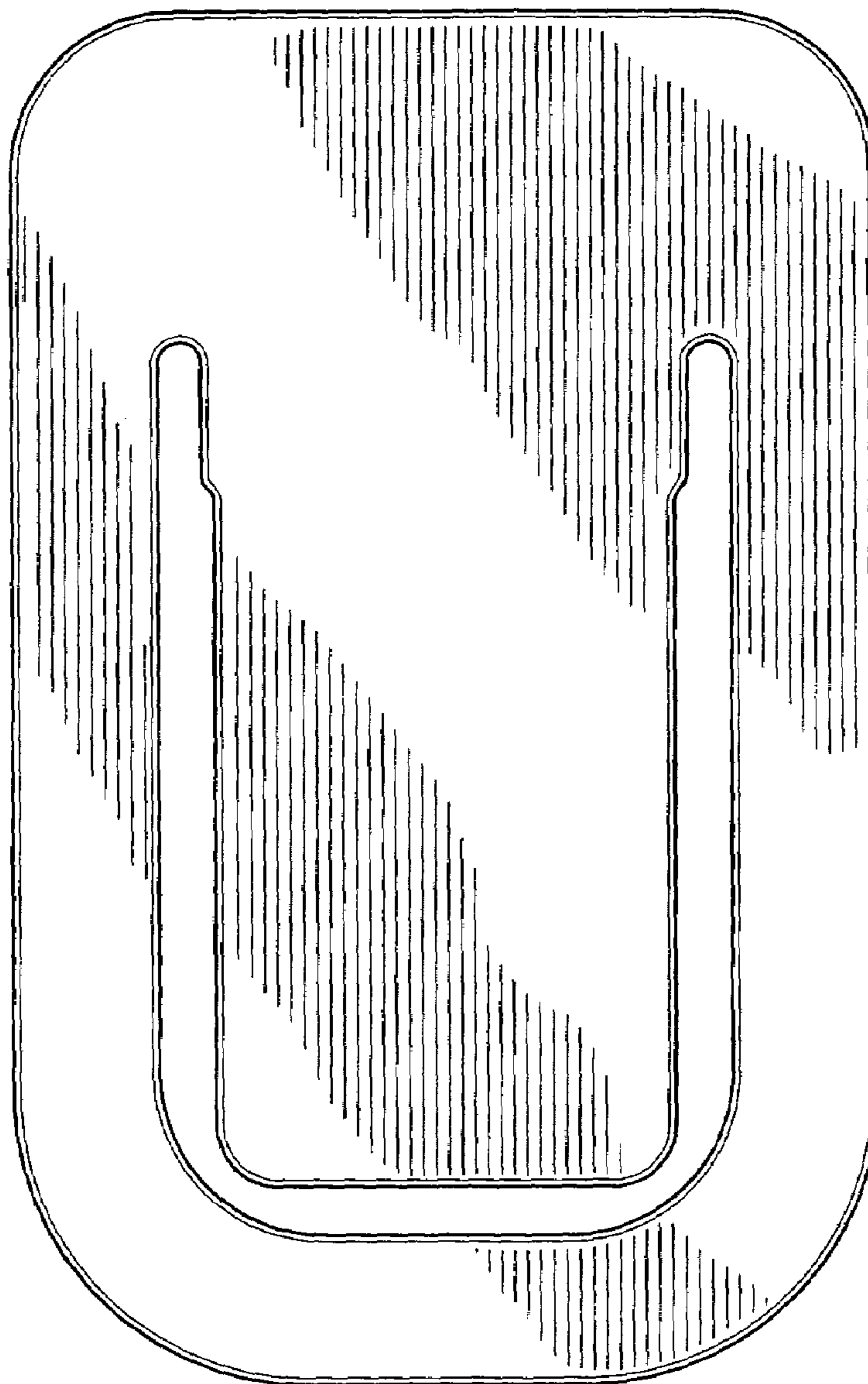
