(57) **CLAIM**

I claim the ornamental design for a jewelry article, as shown and described.

**DESCRIPTION**

FIG. 18 is a front elevation view thereof;

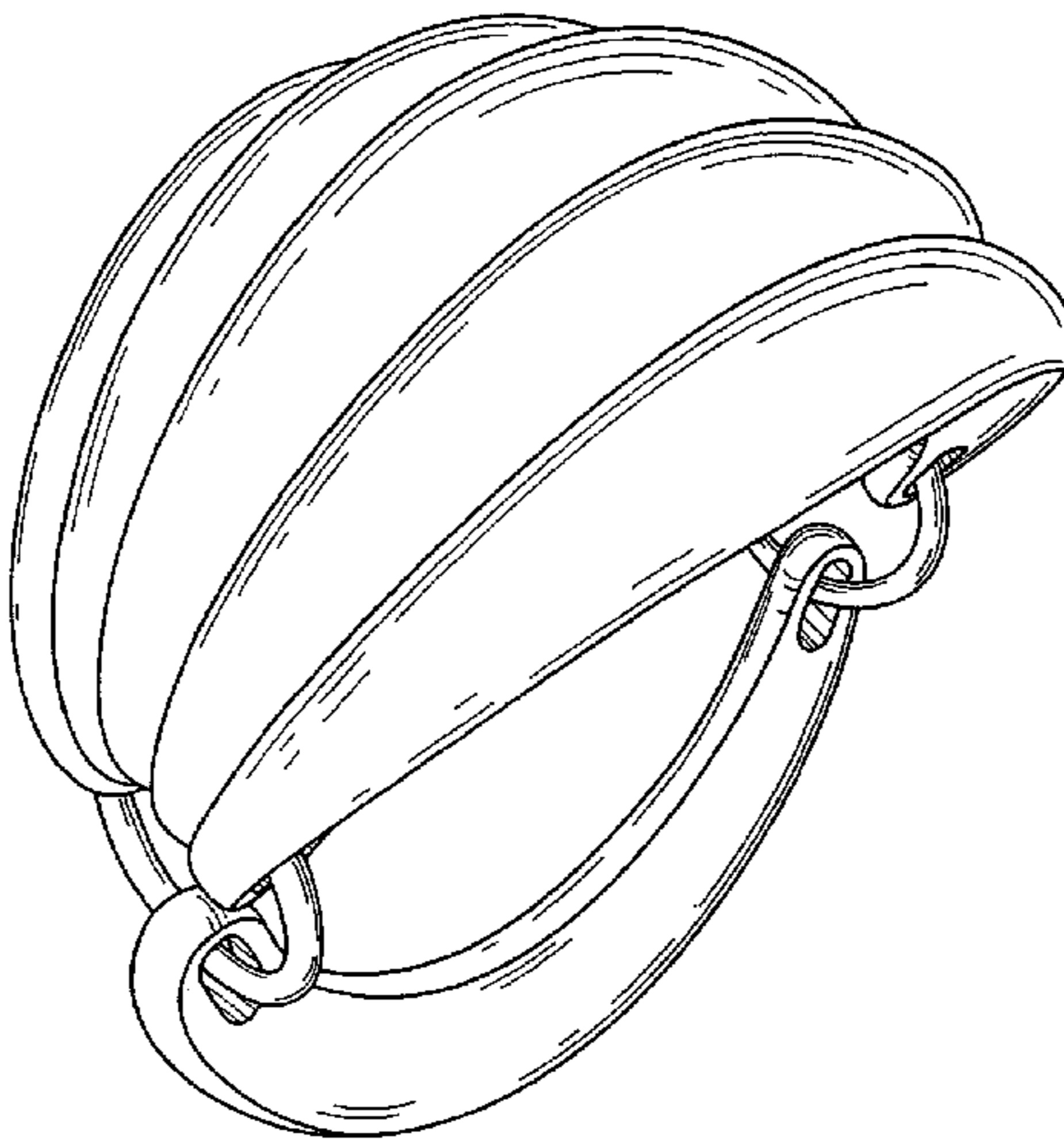
FIG. 19 is a bottom plan thereof;

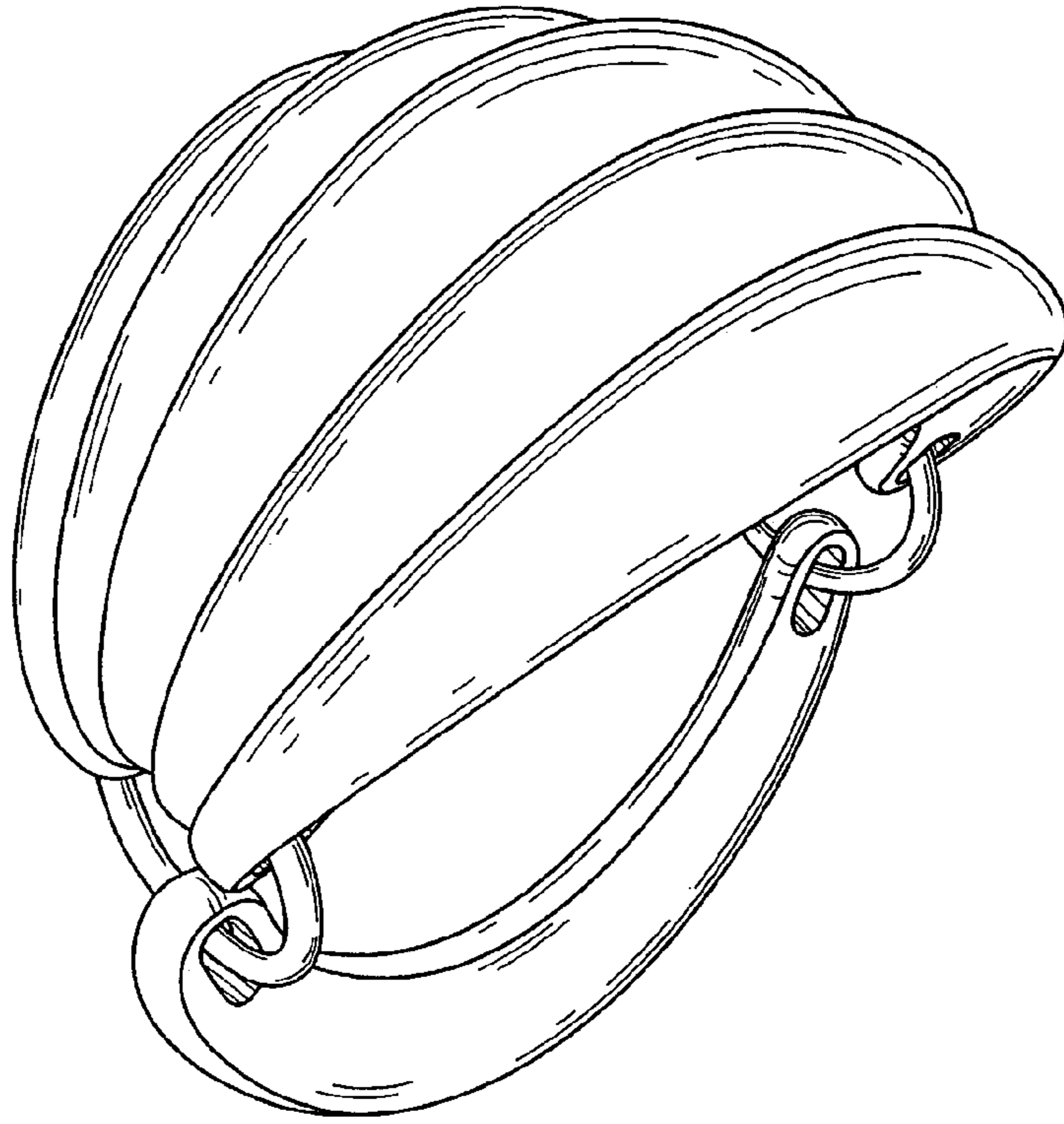
FIG. 20 is a top plan view thereof;

FIG. 21 is a perspective partially open view thereof; and,

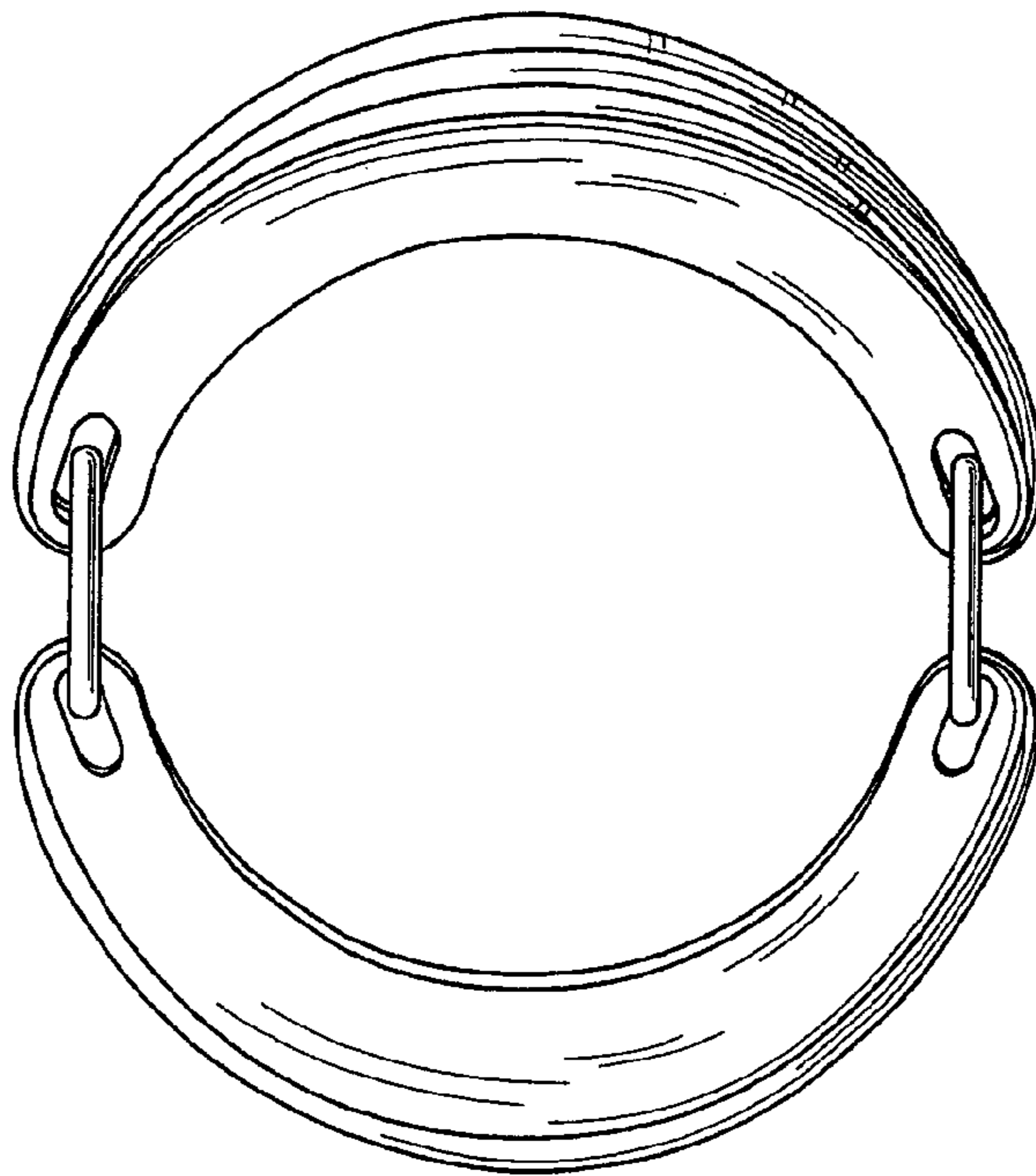
FIG. 22 is a perspective fully open view thereof.

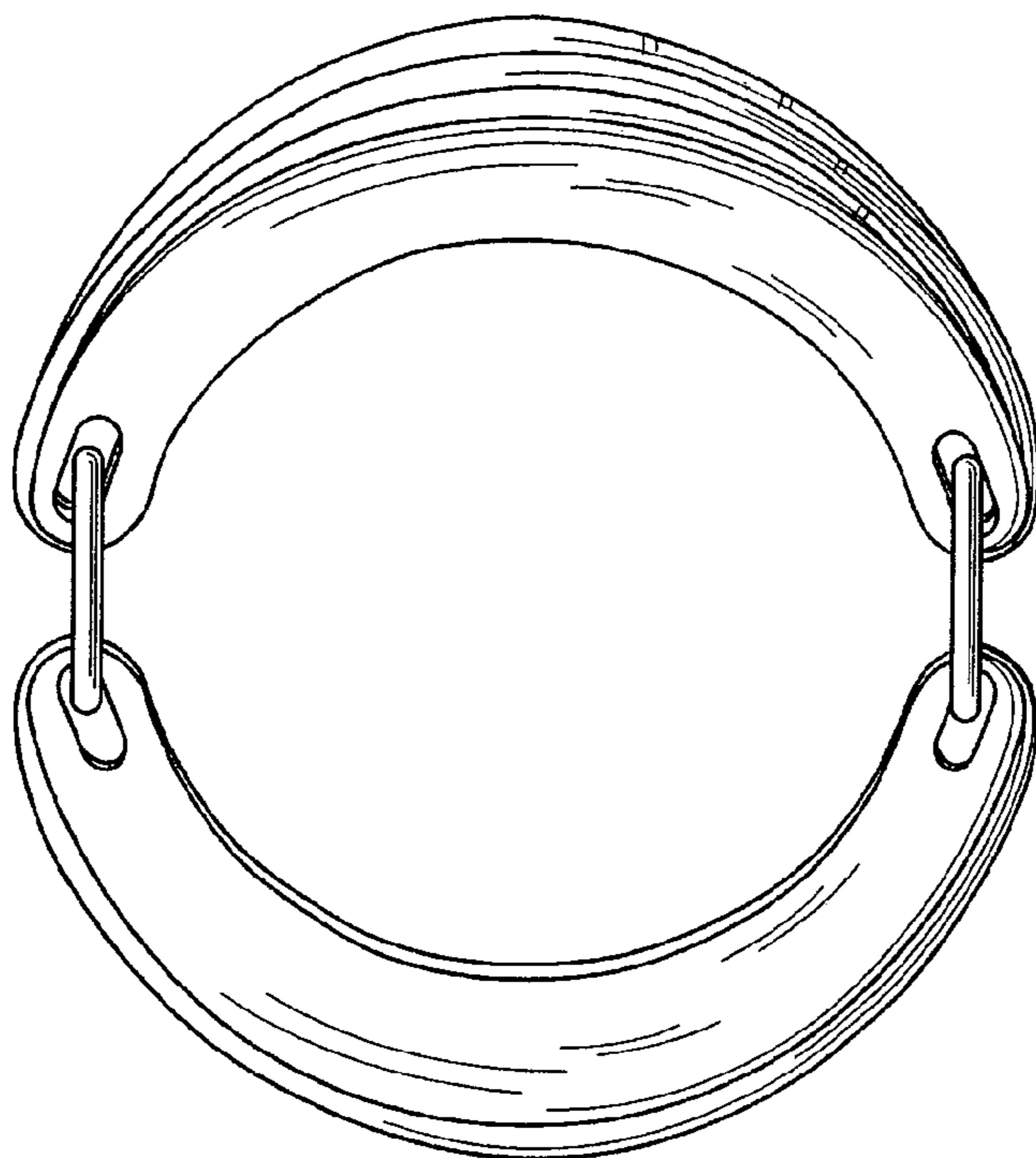




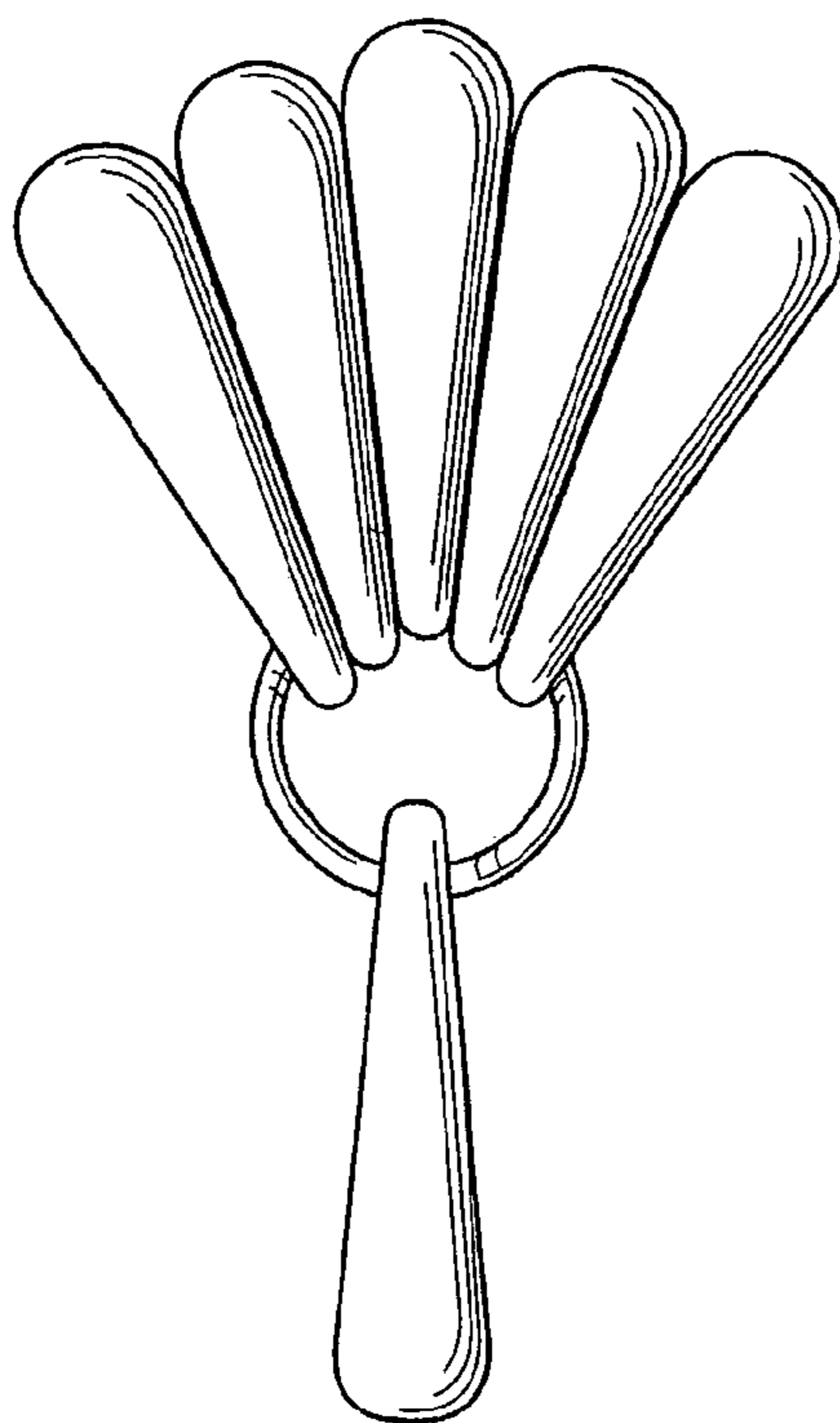

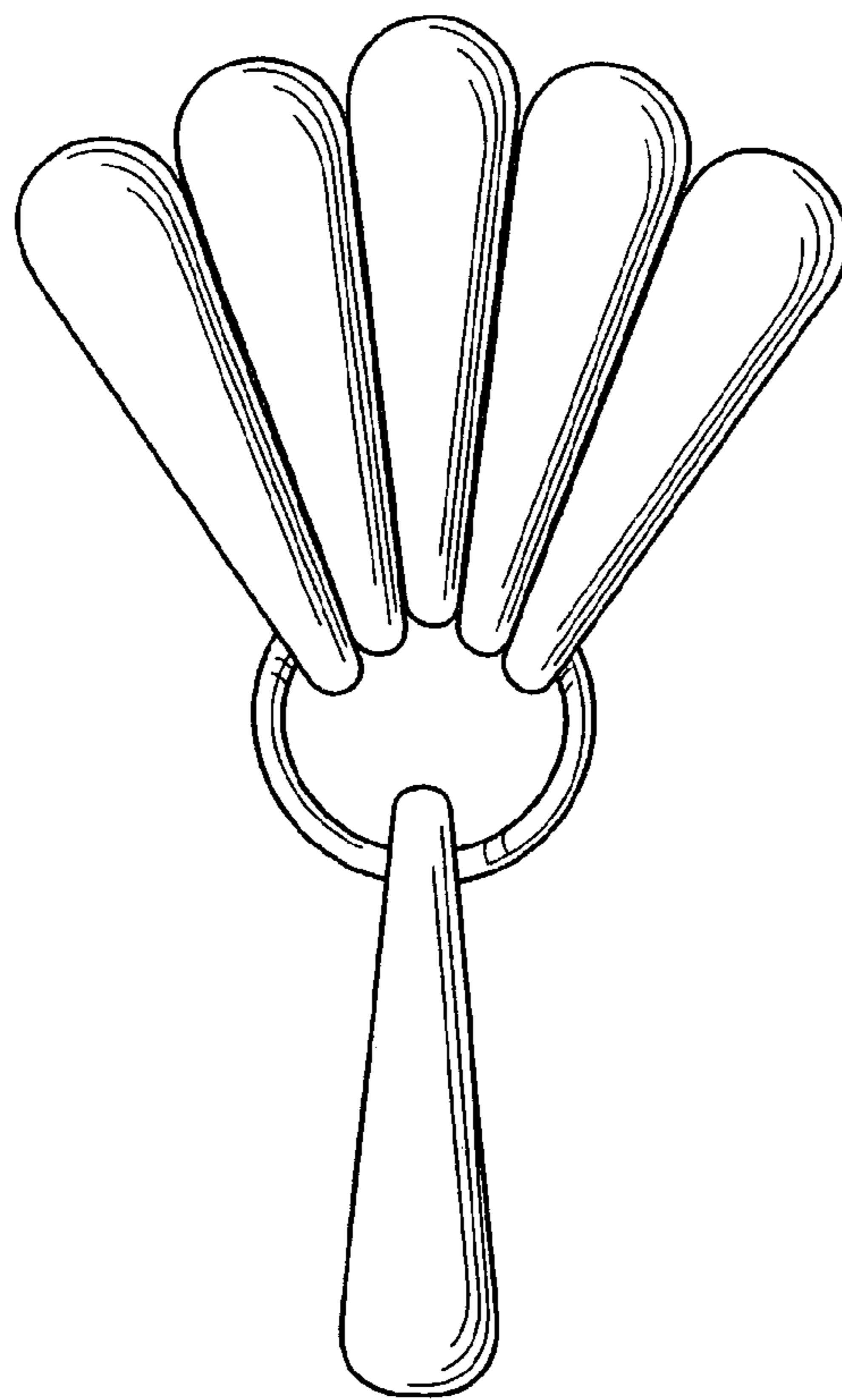

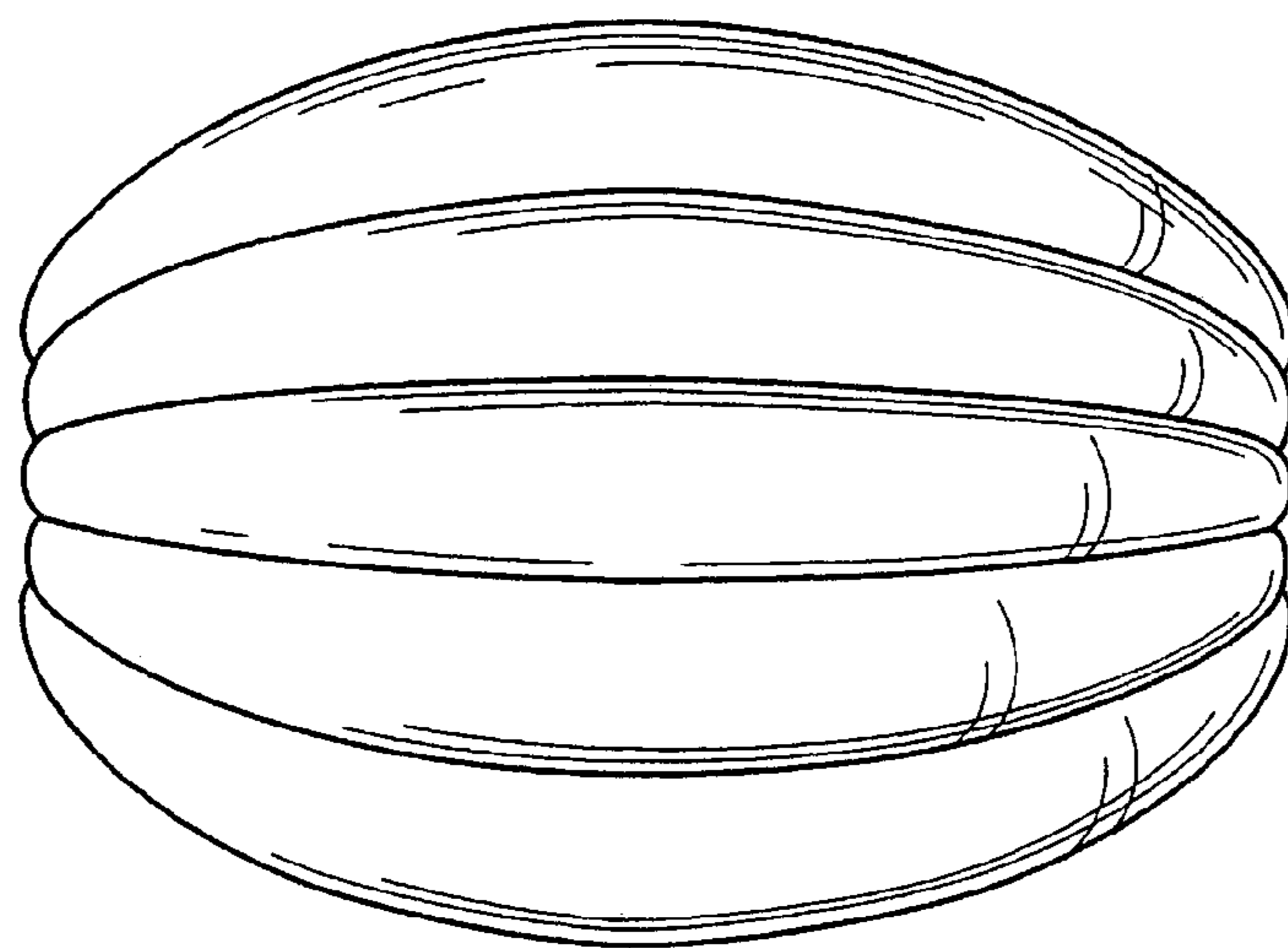

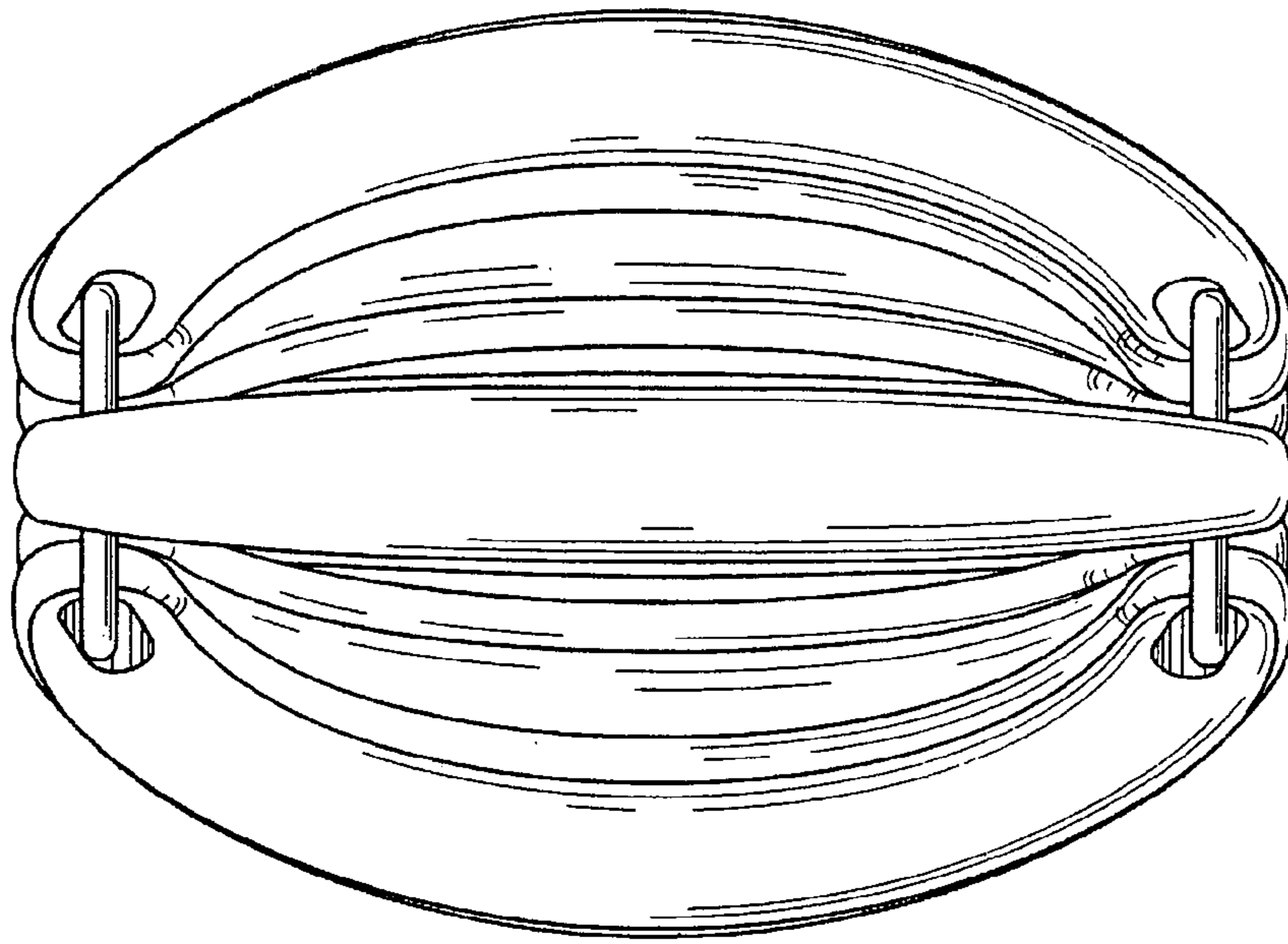

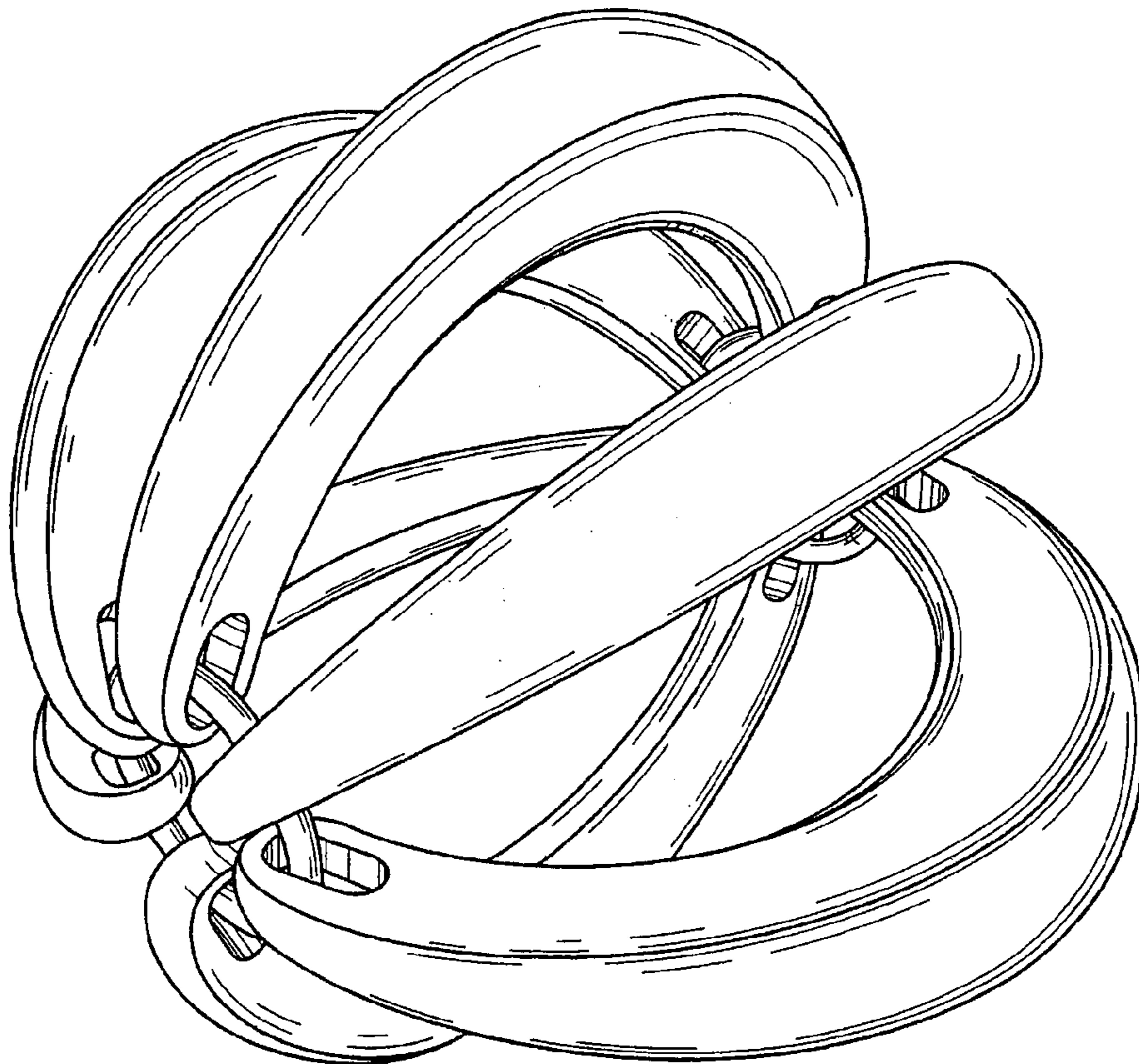

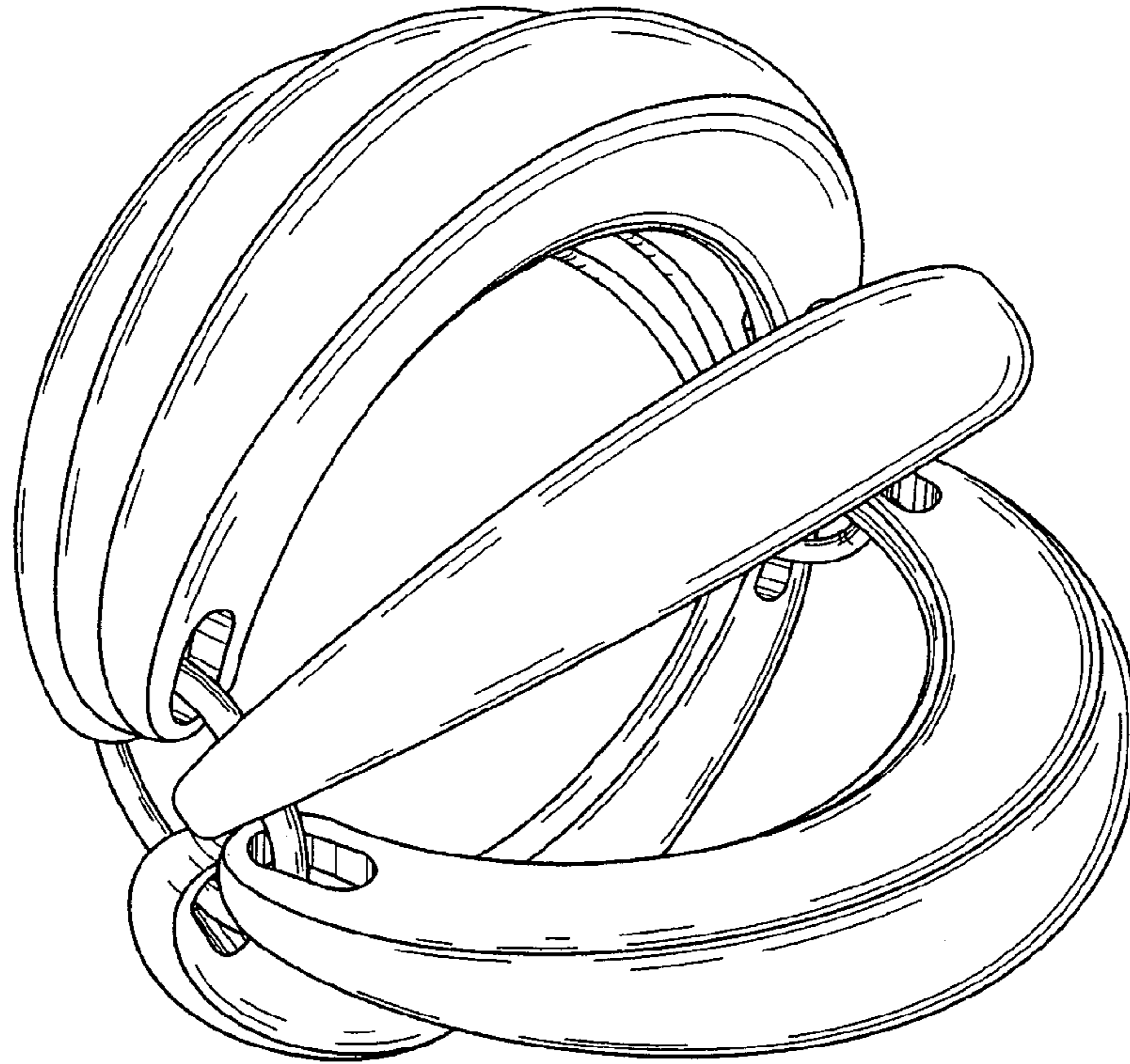

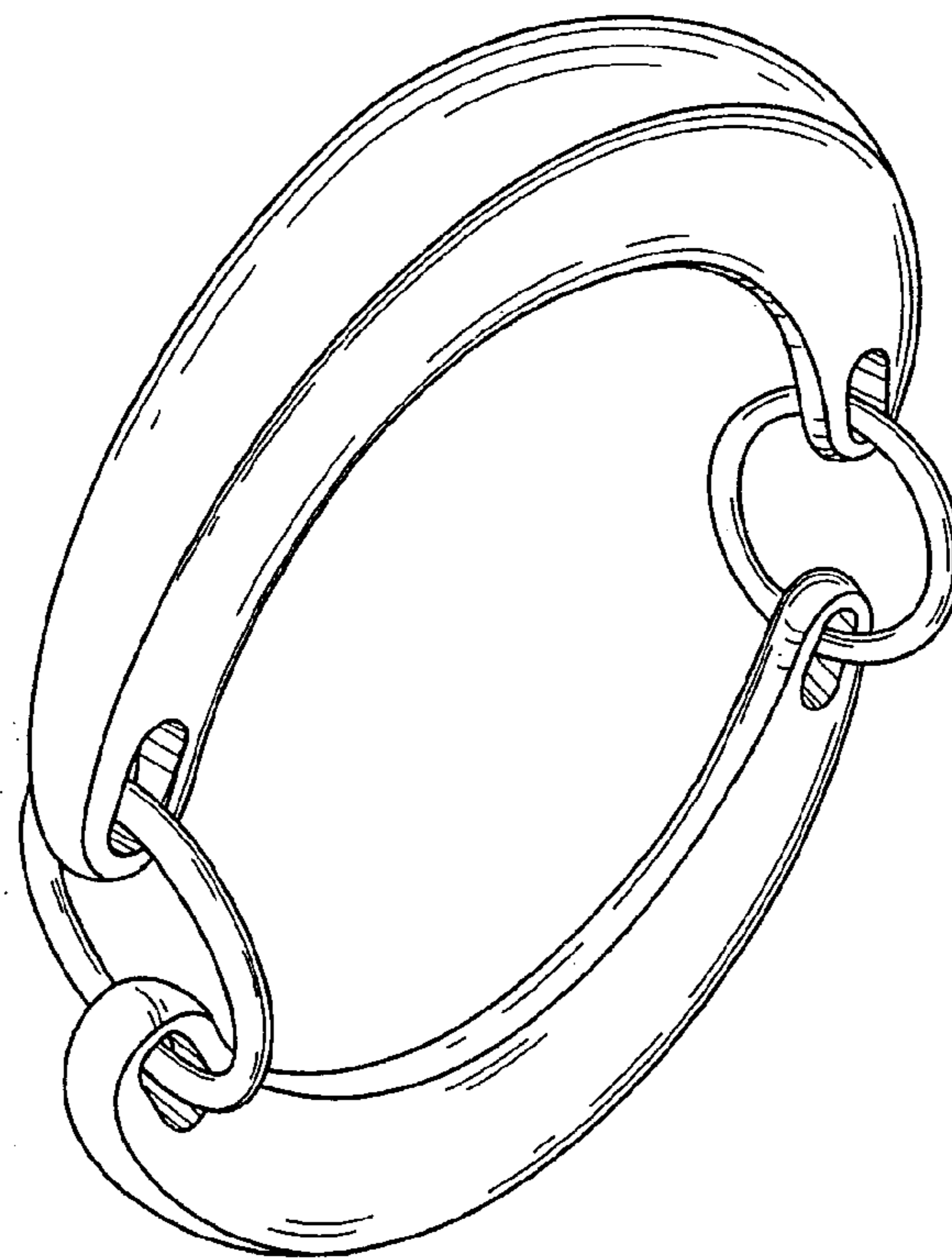

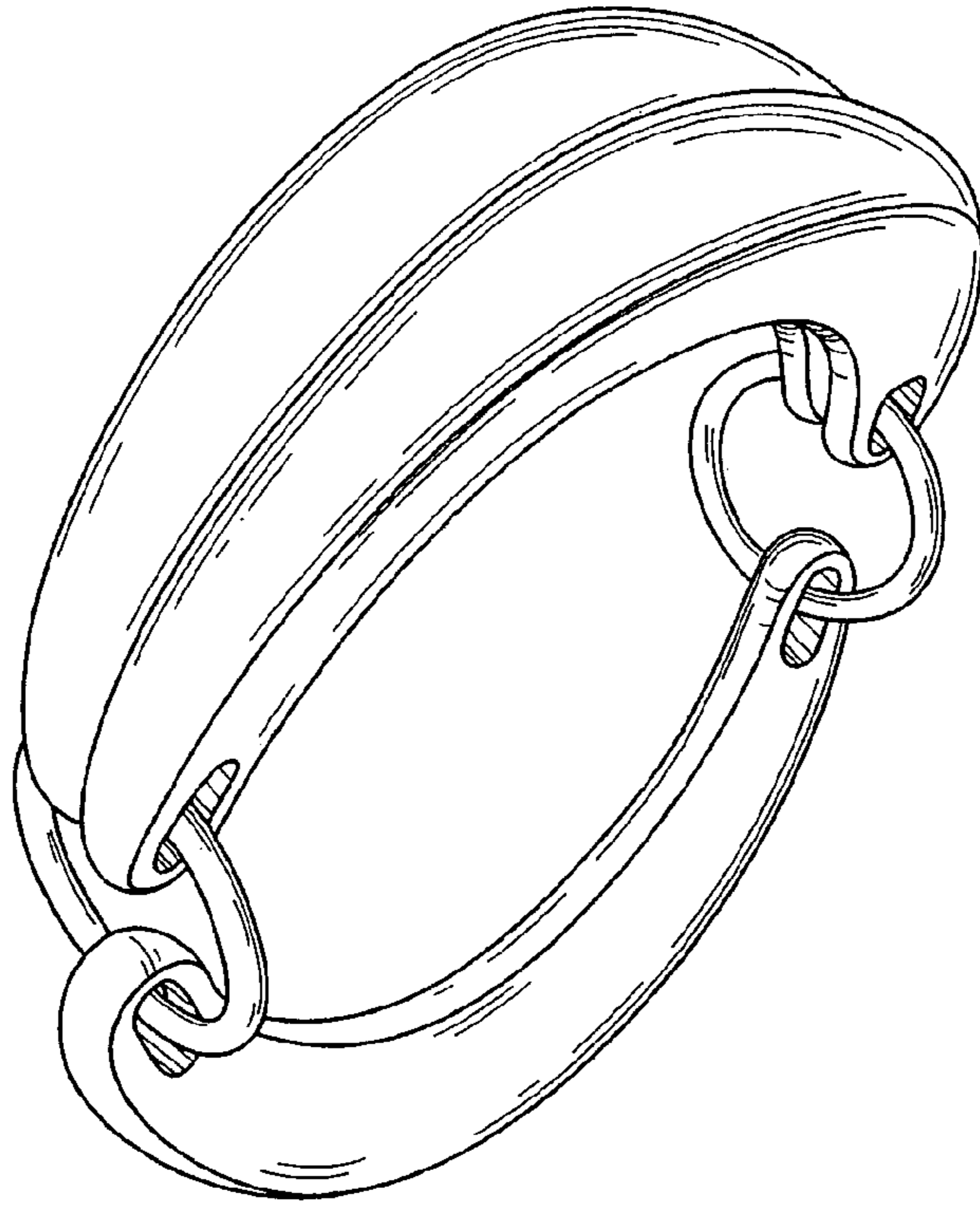

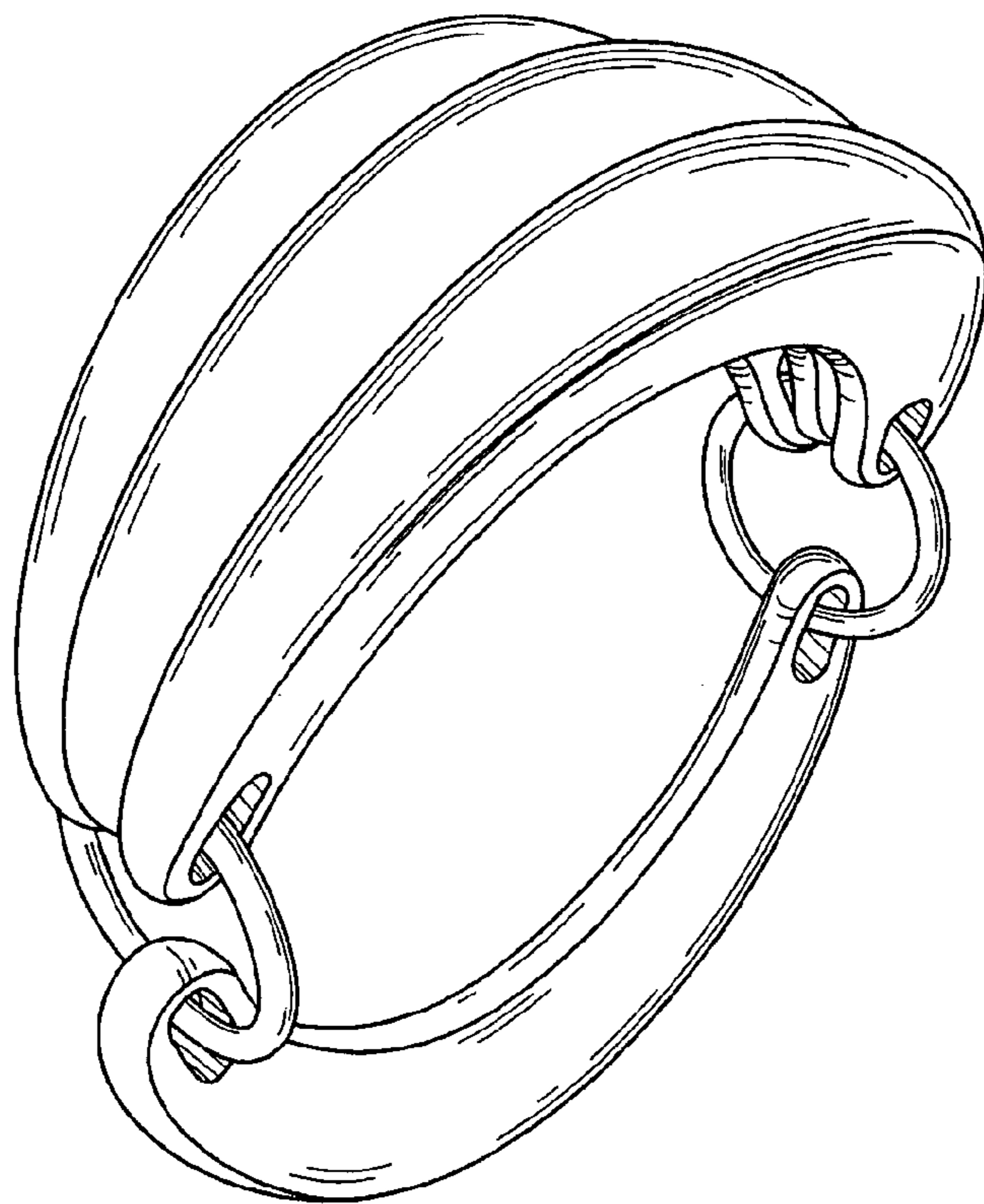

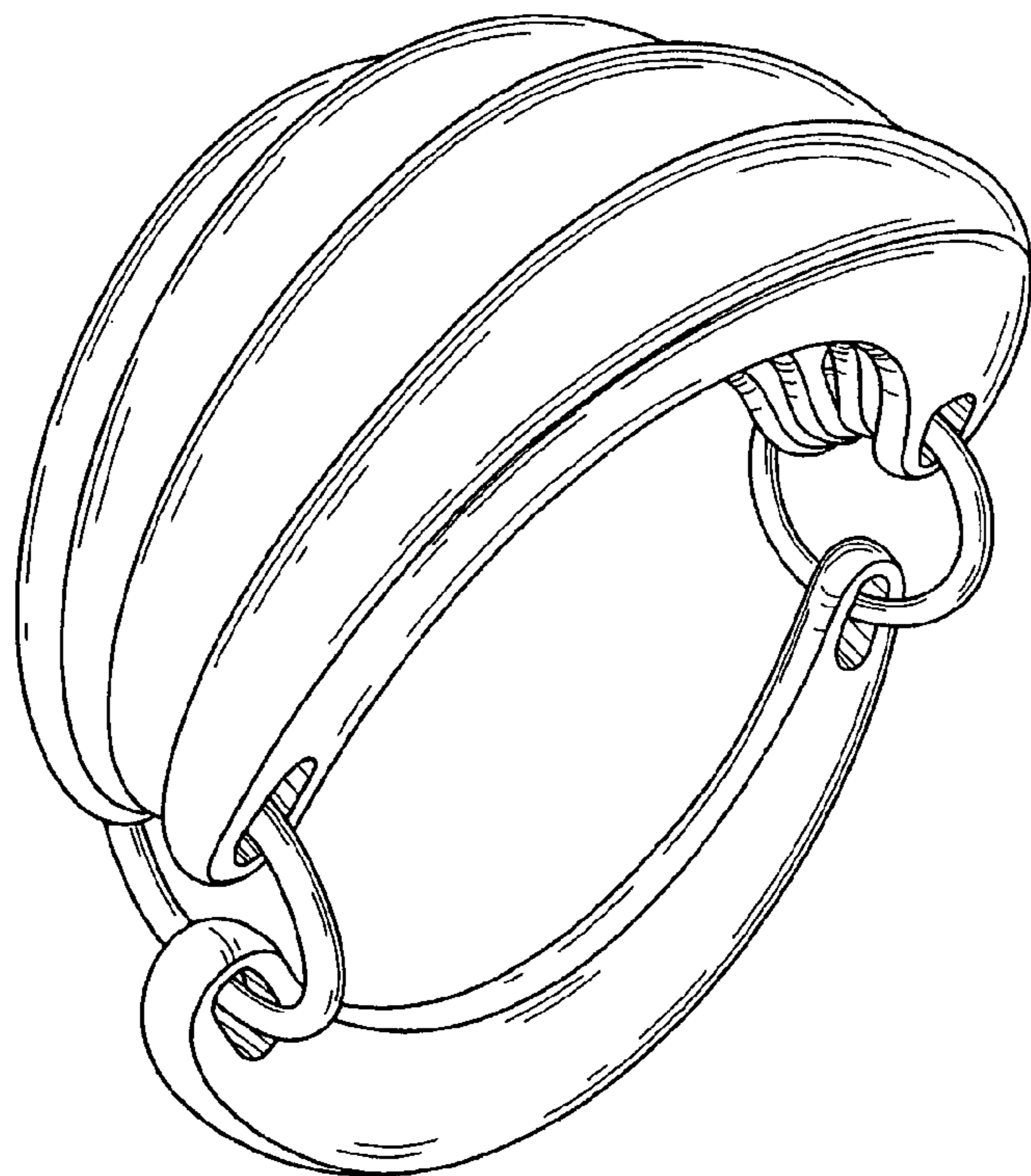

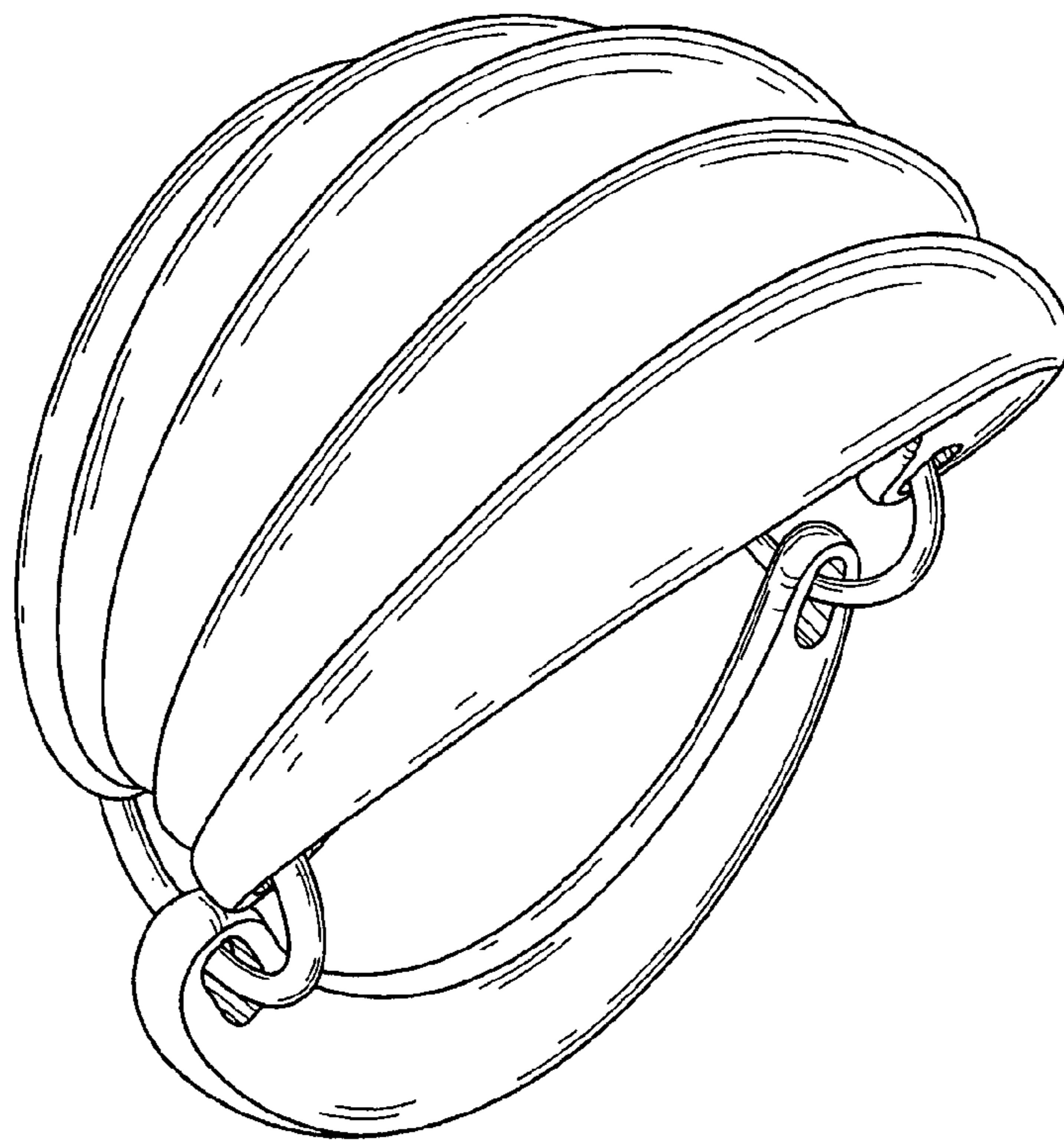

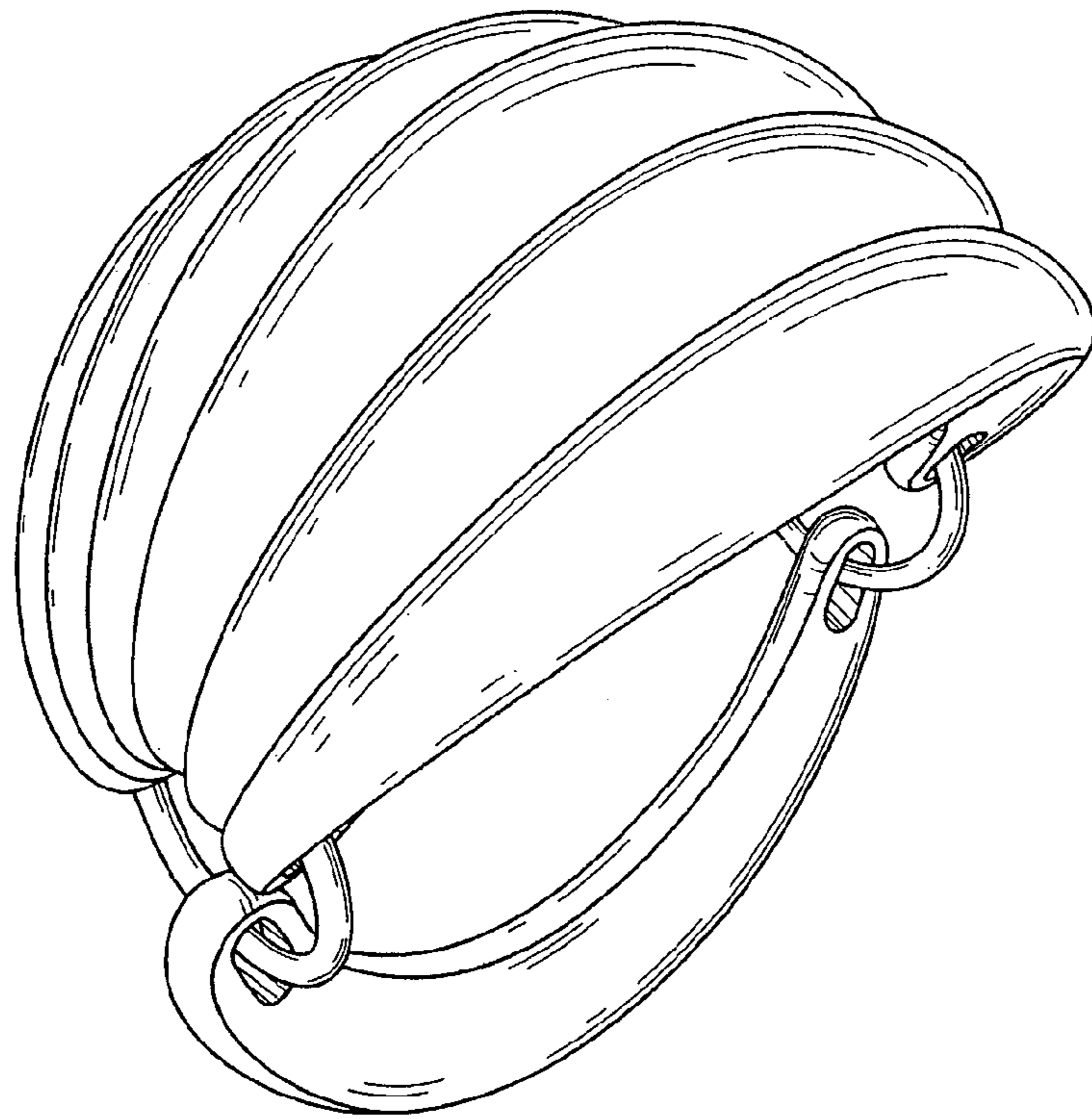

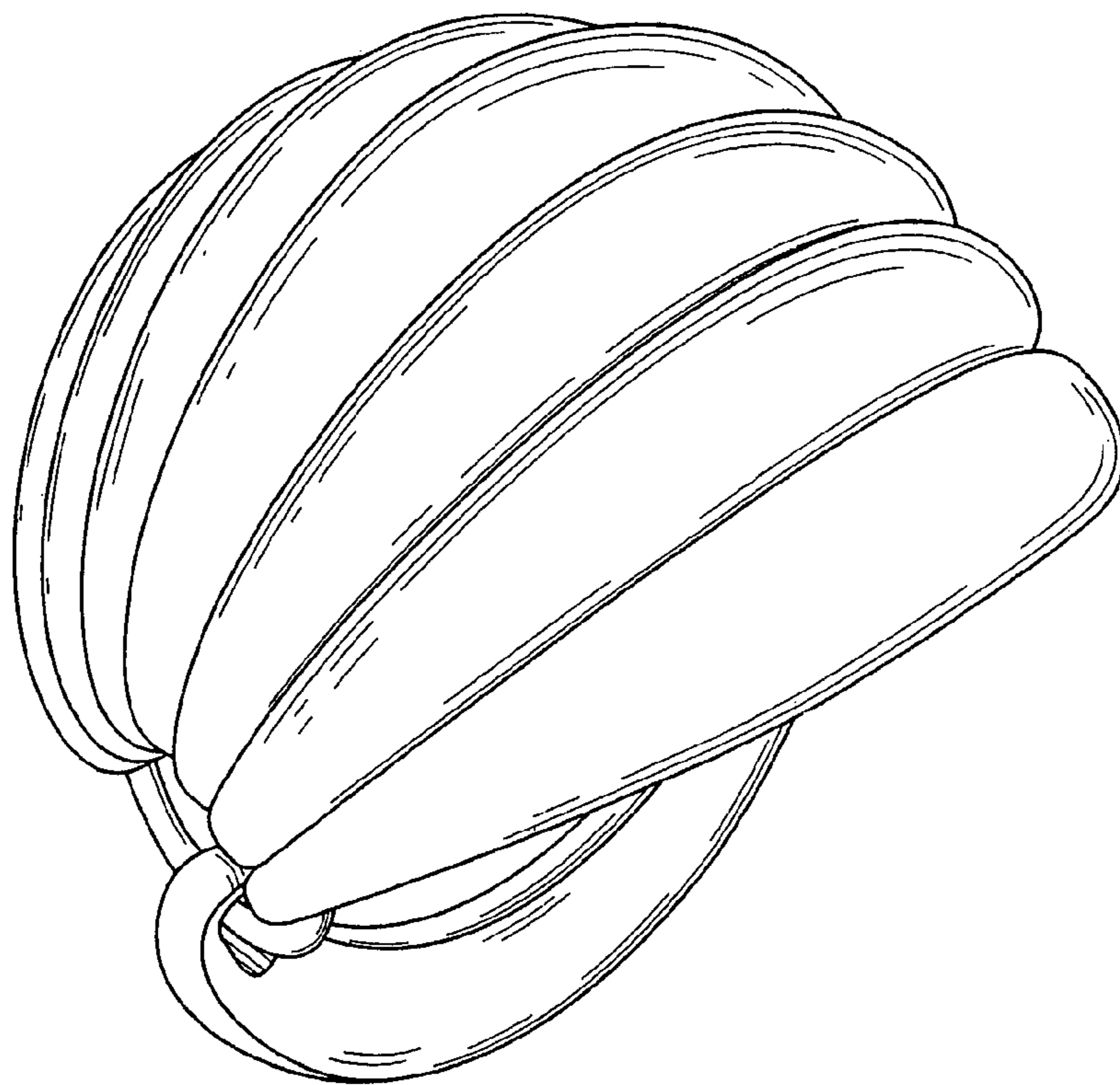

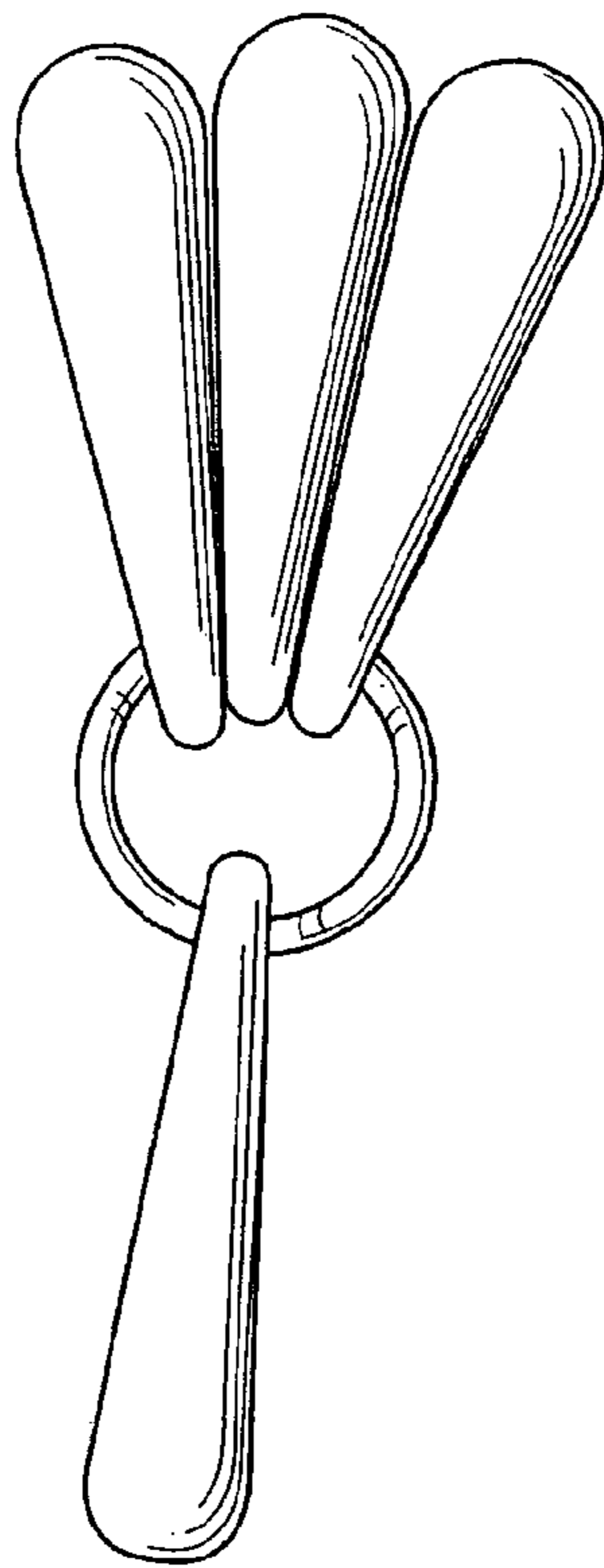




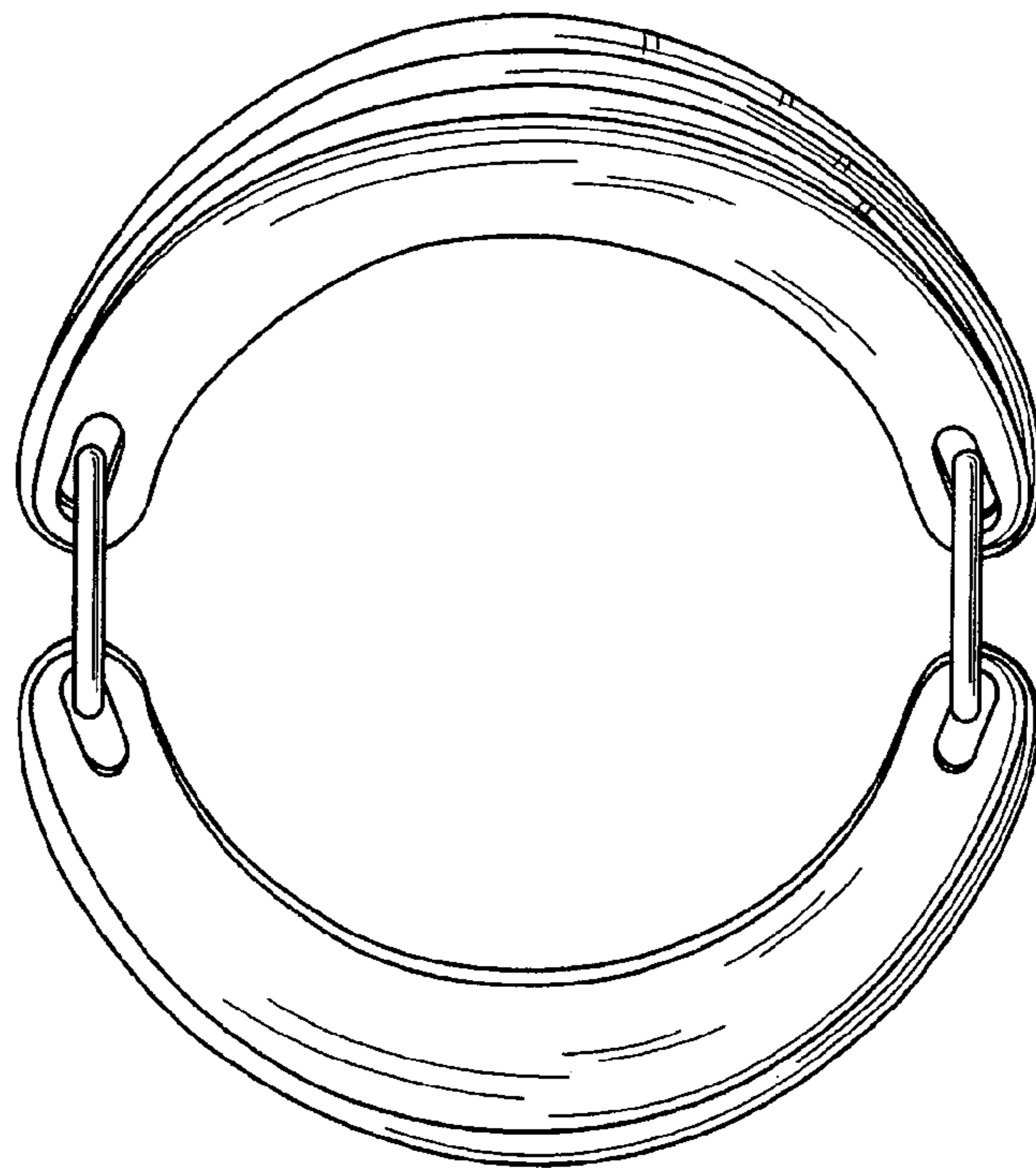

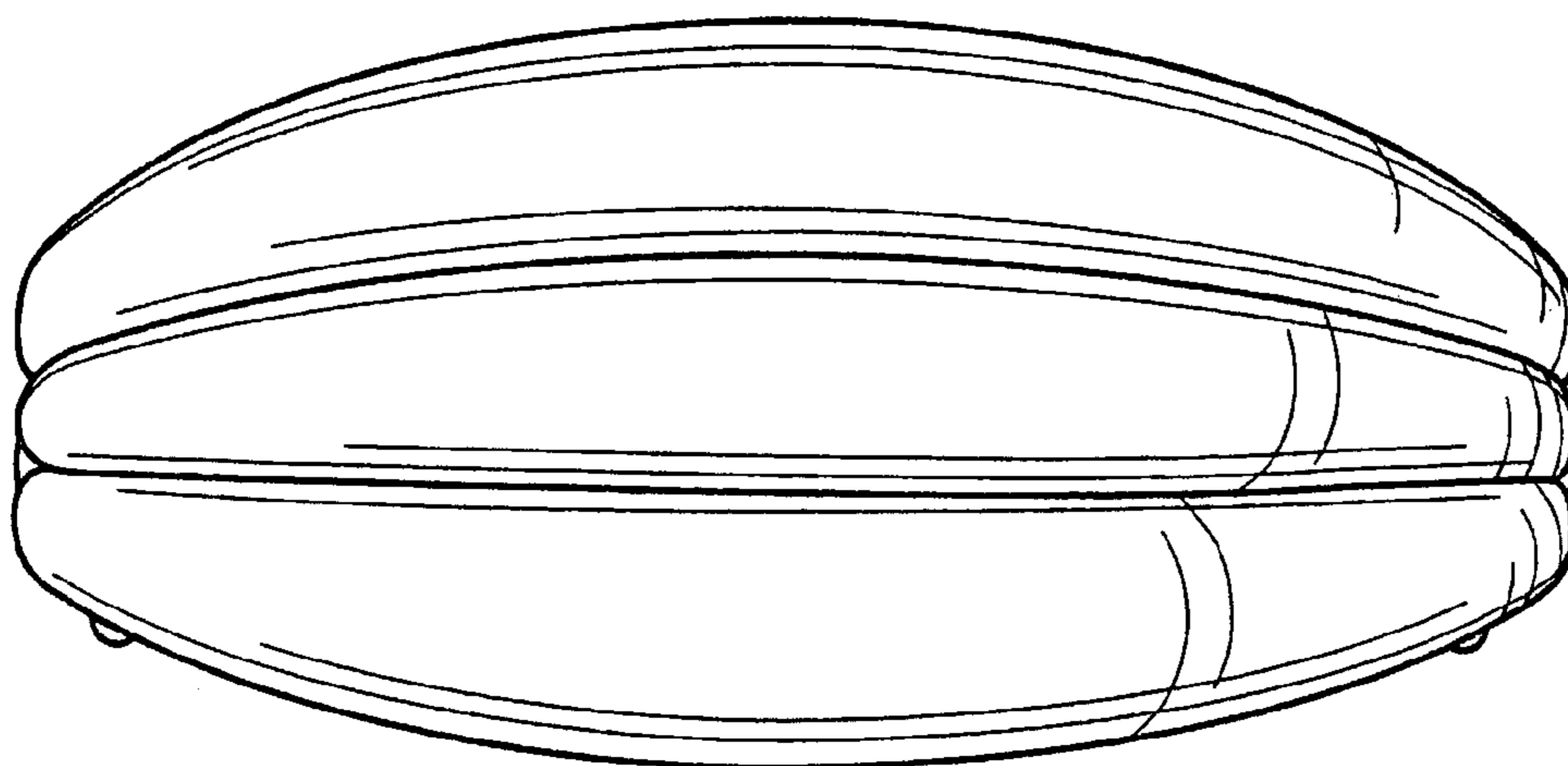

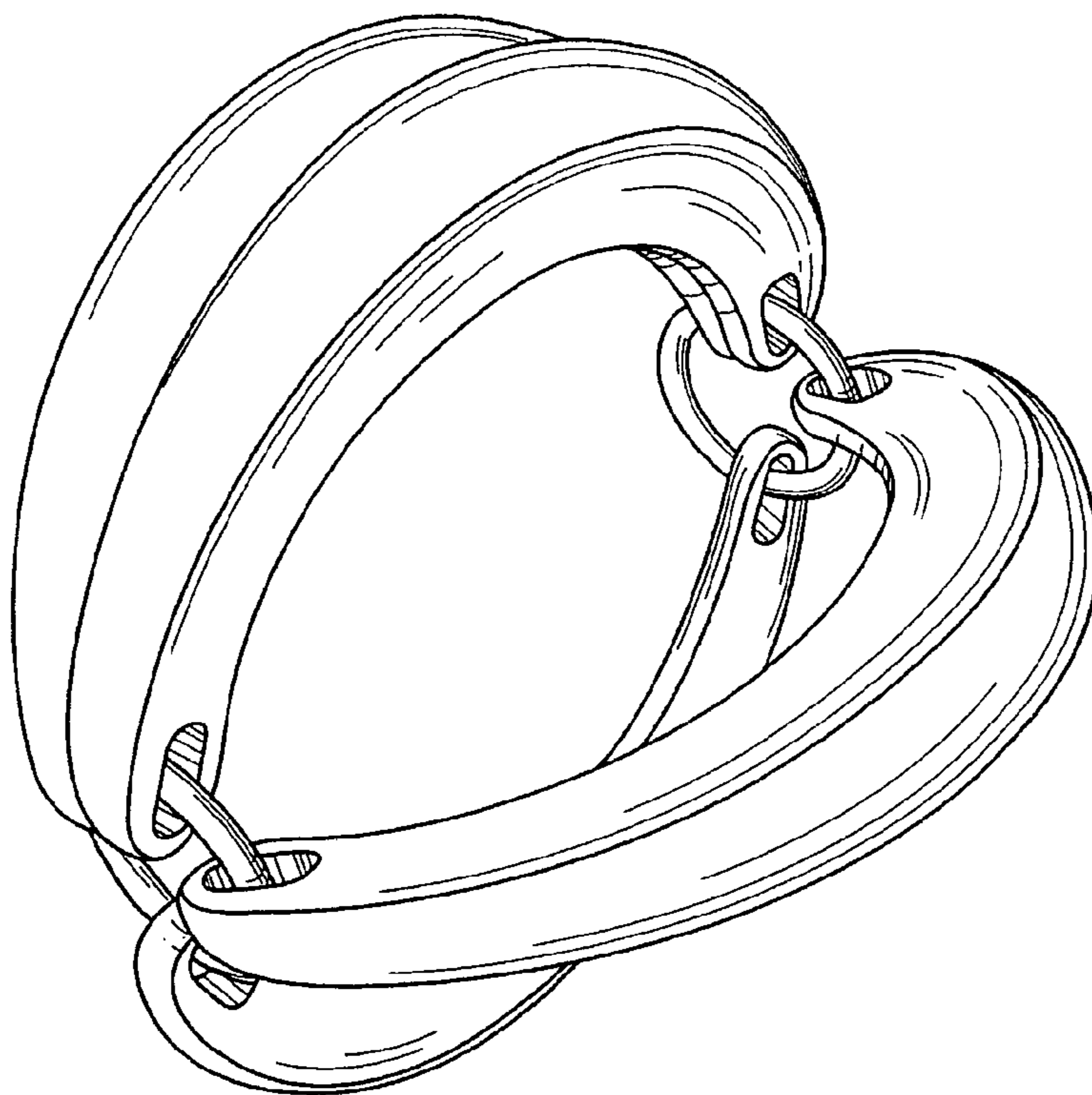

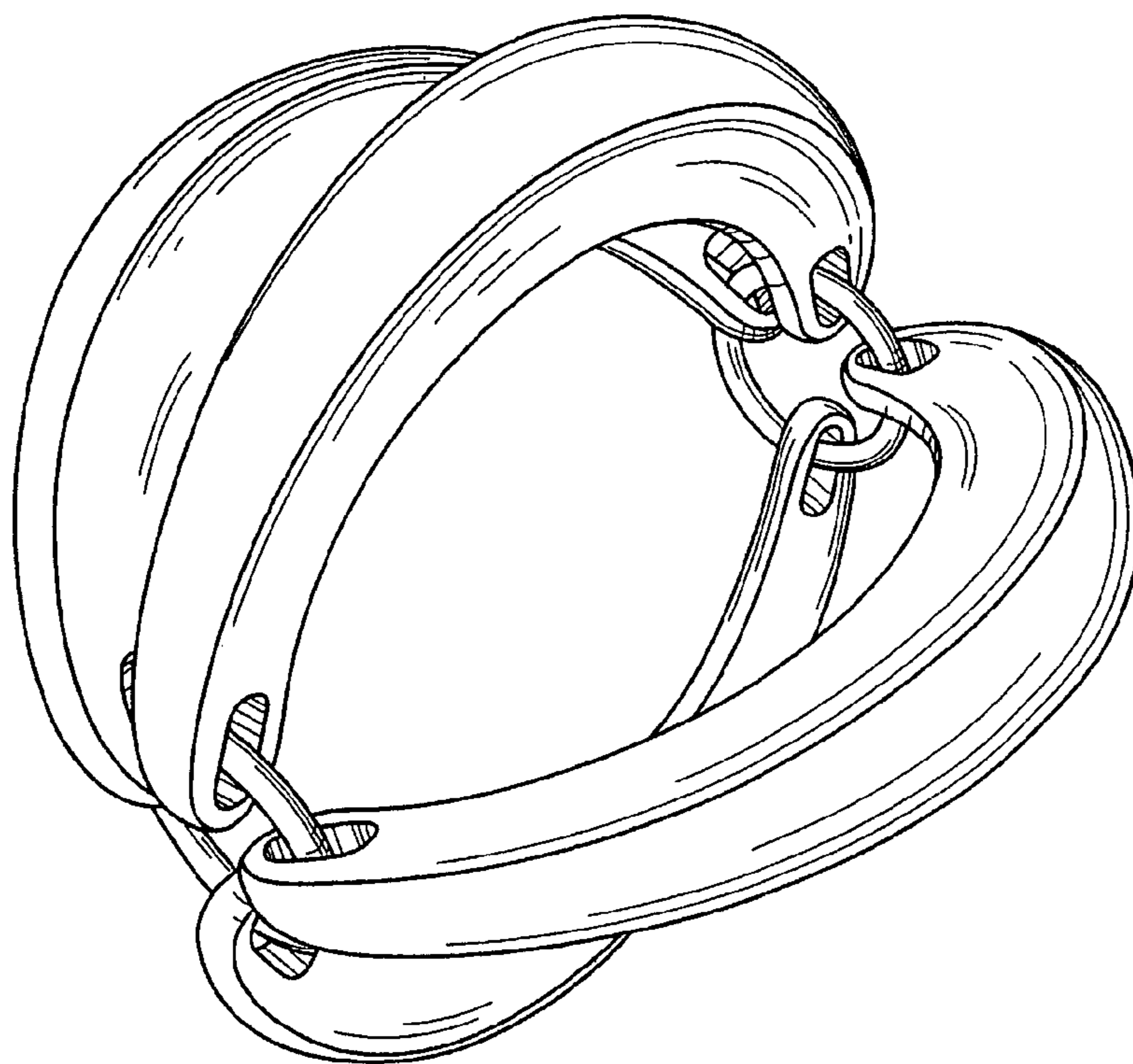
***FIG. 19***
