FIG. 4 is a top view of the vehicular mirror;

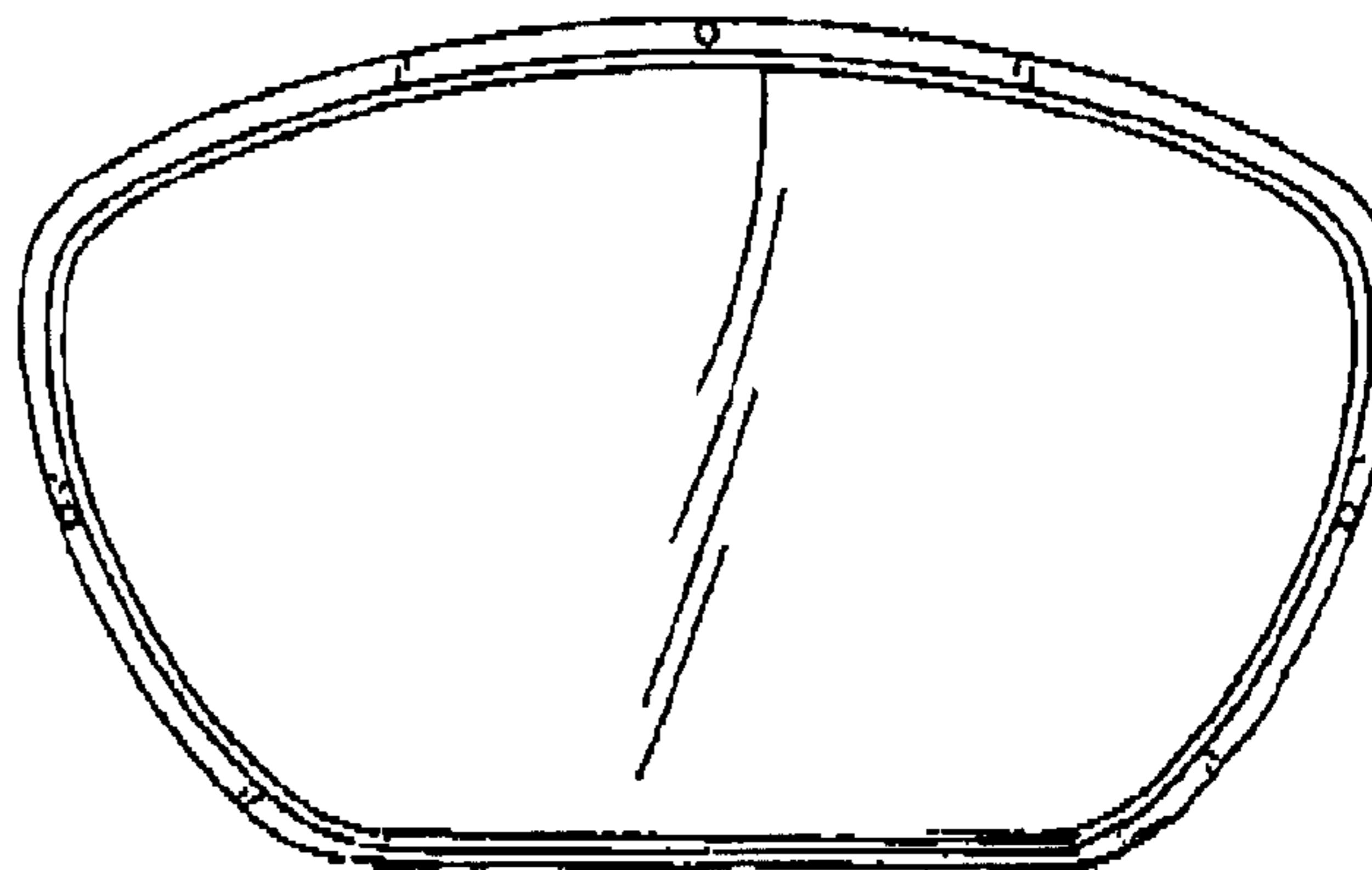
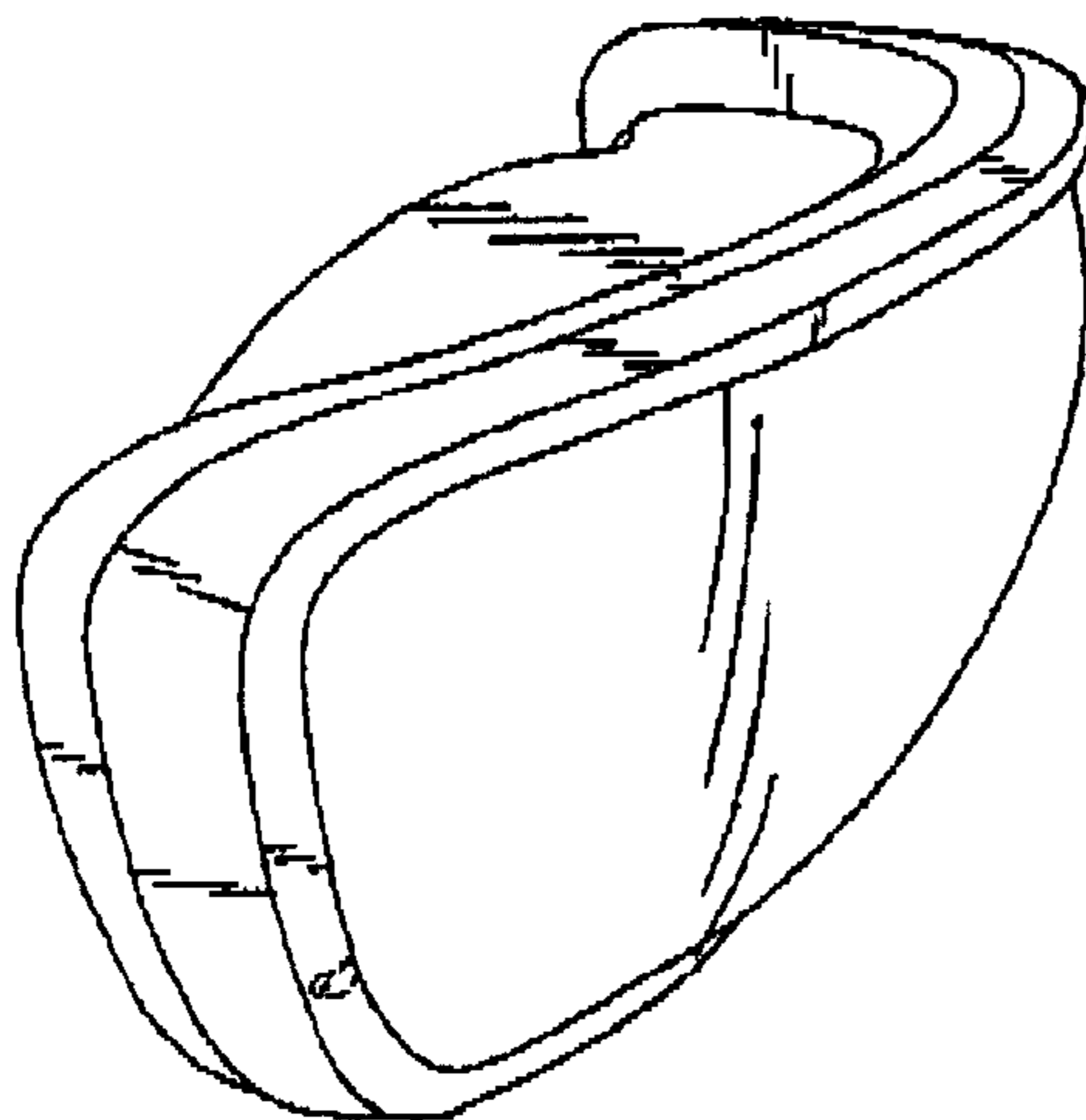
FIG. 5 is a bottom view of the vehicular mirror;

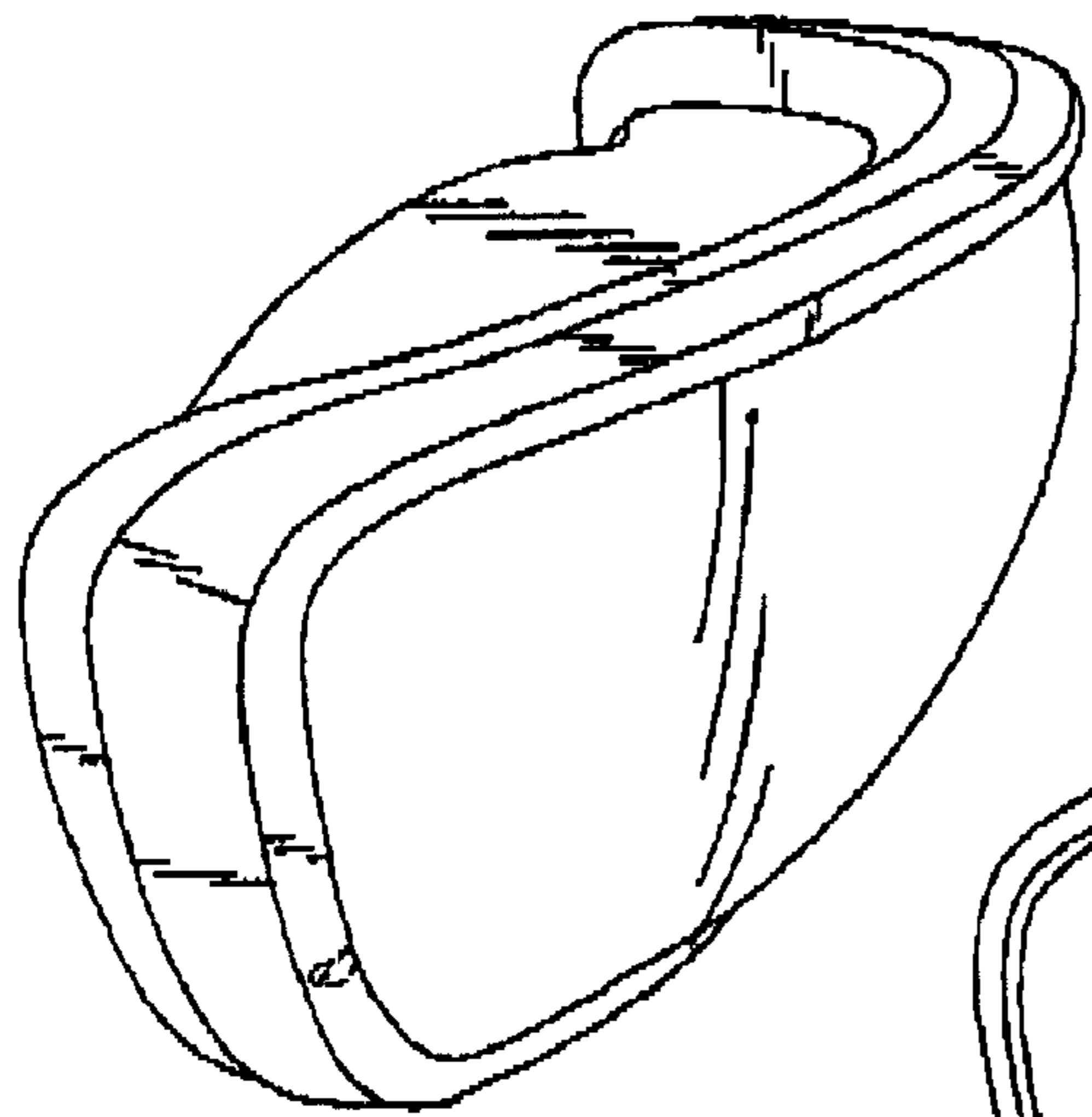

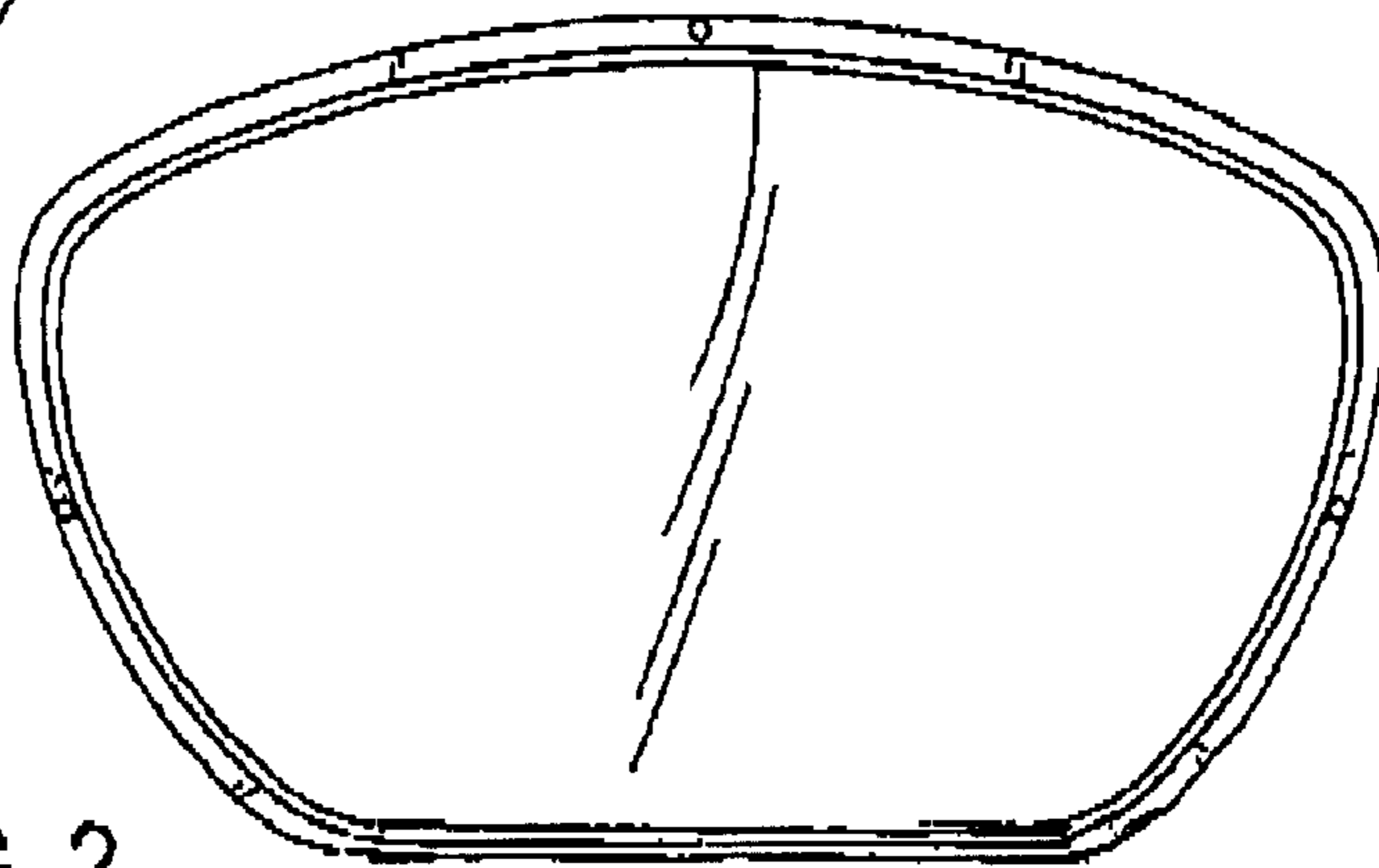

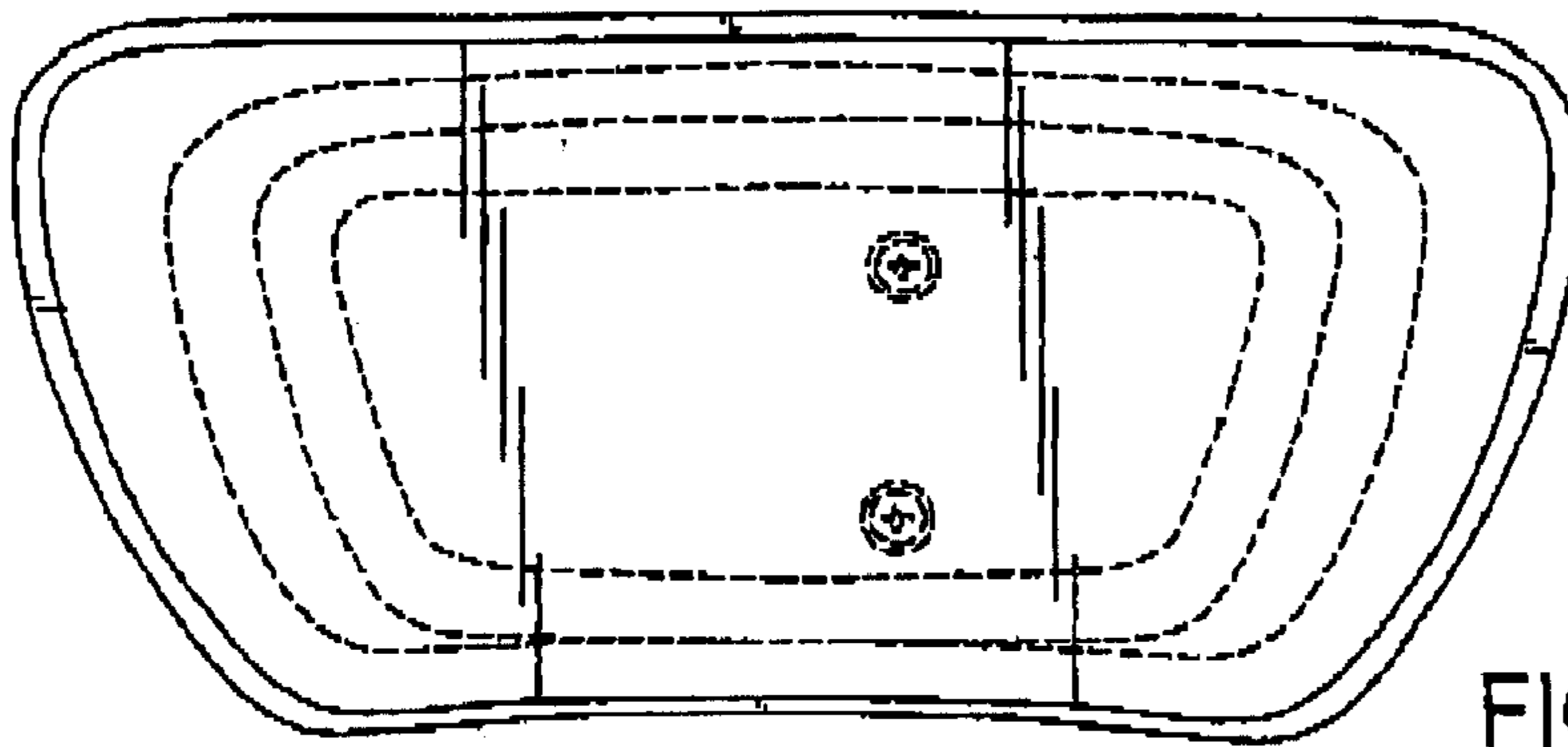

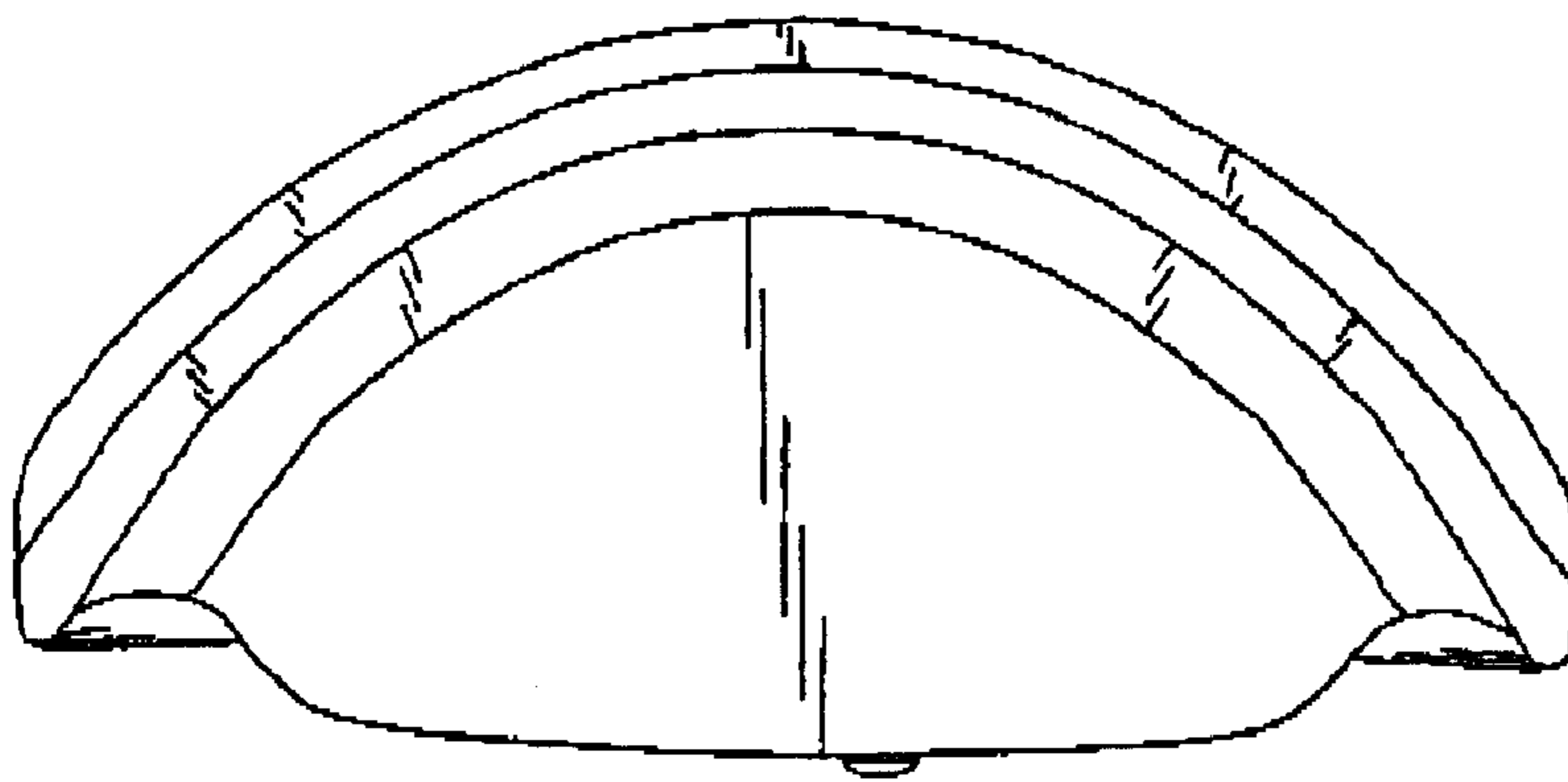

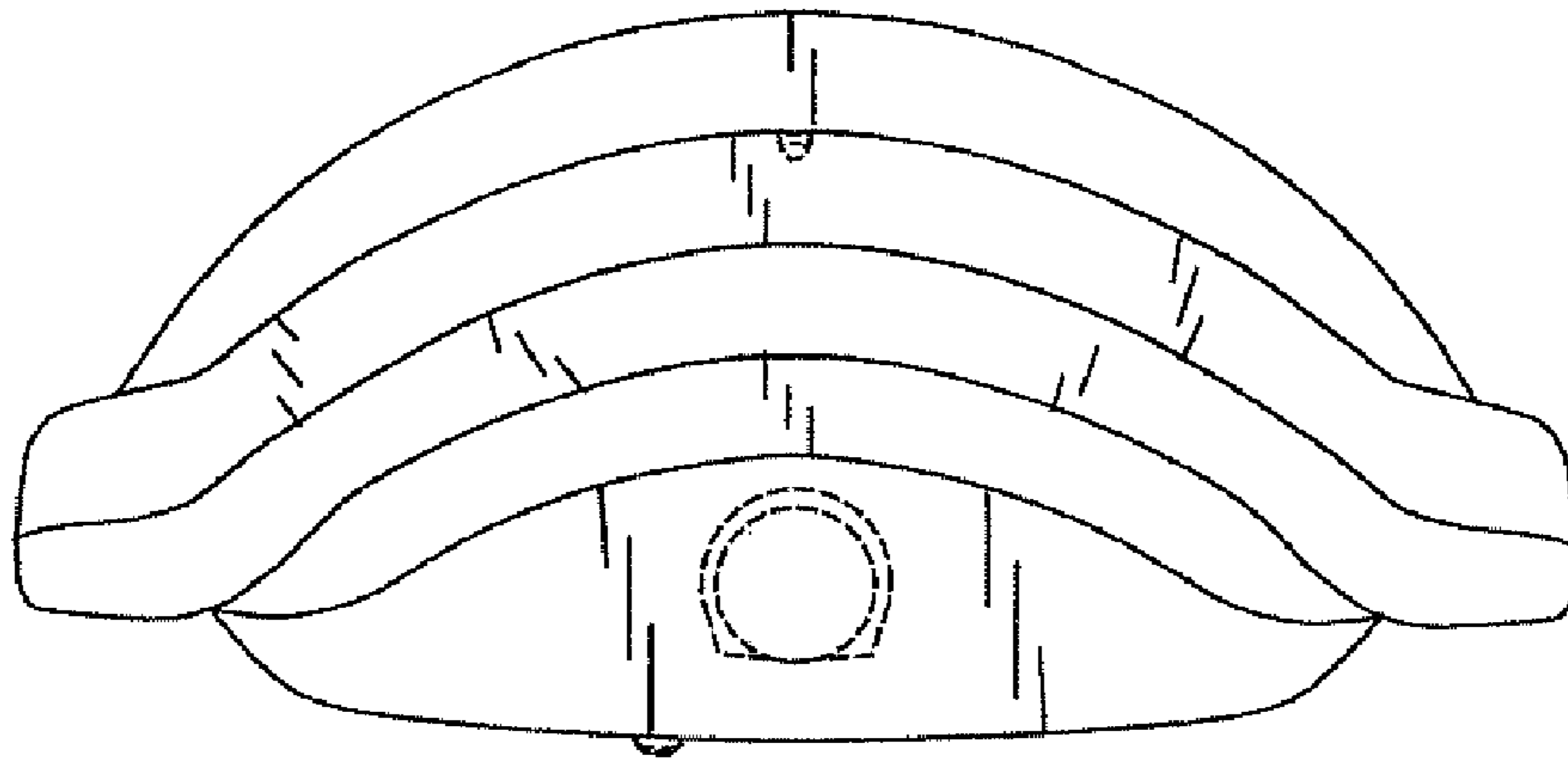

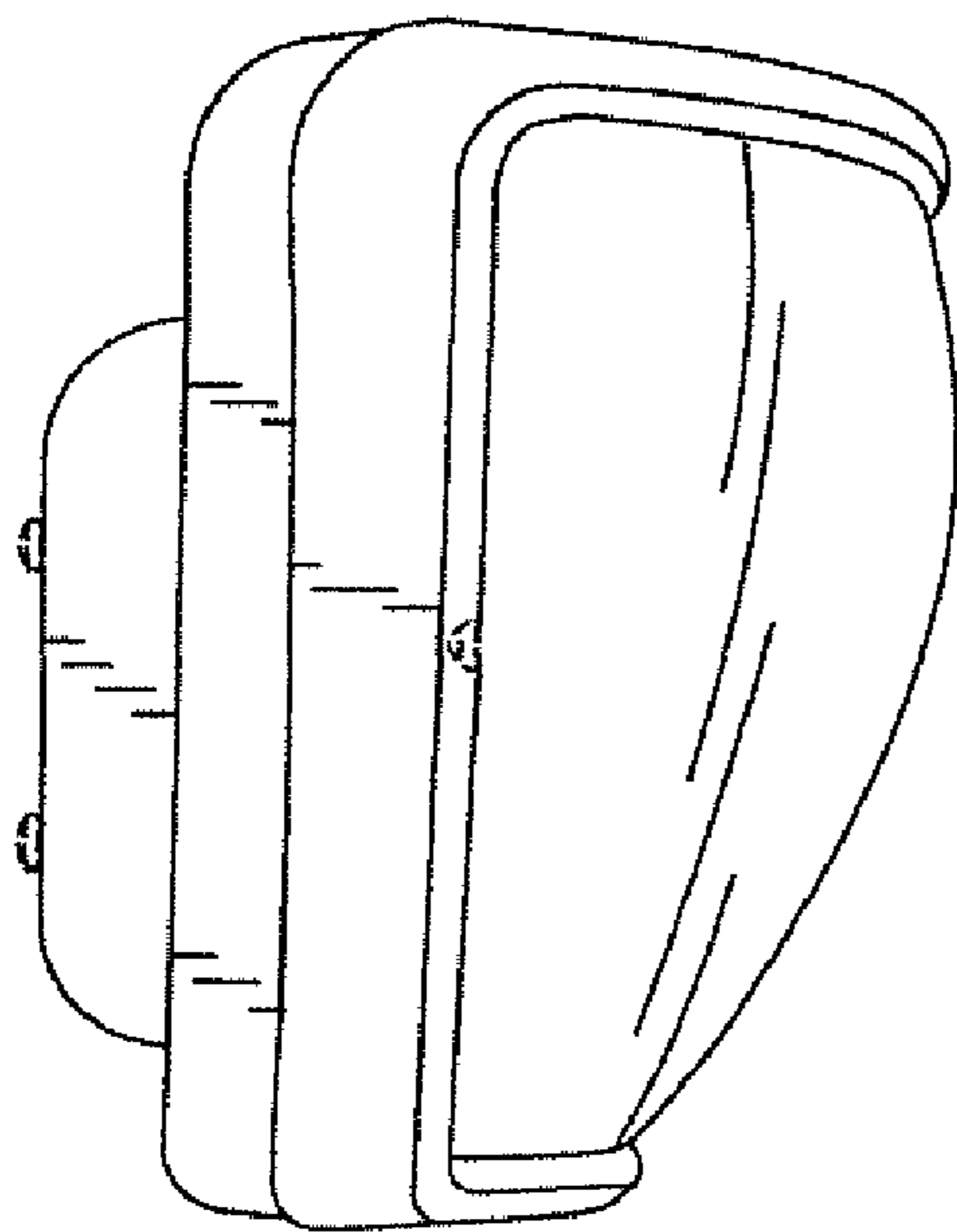

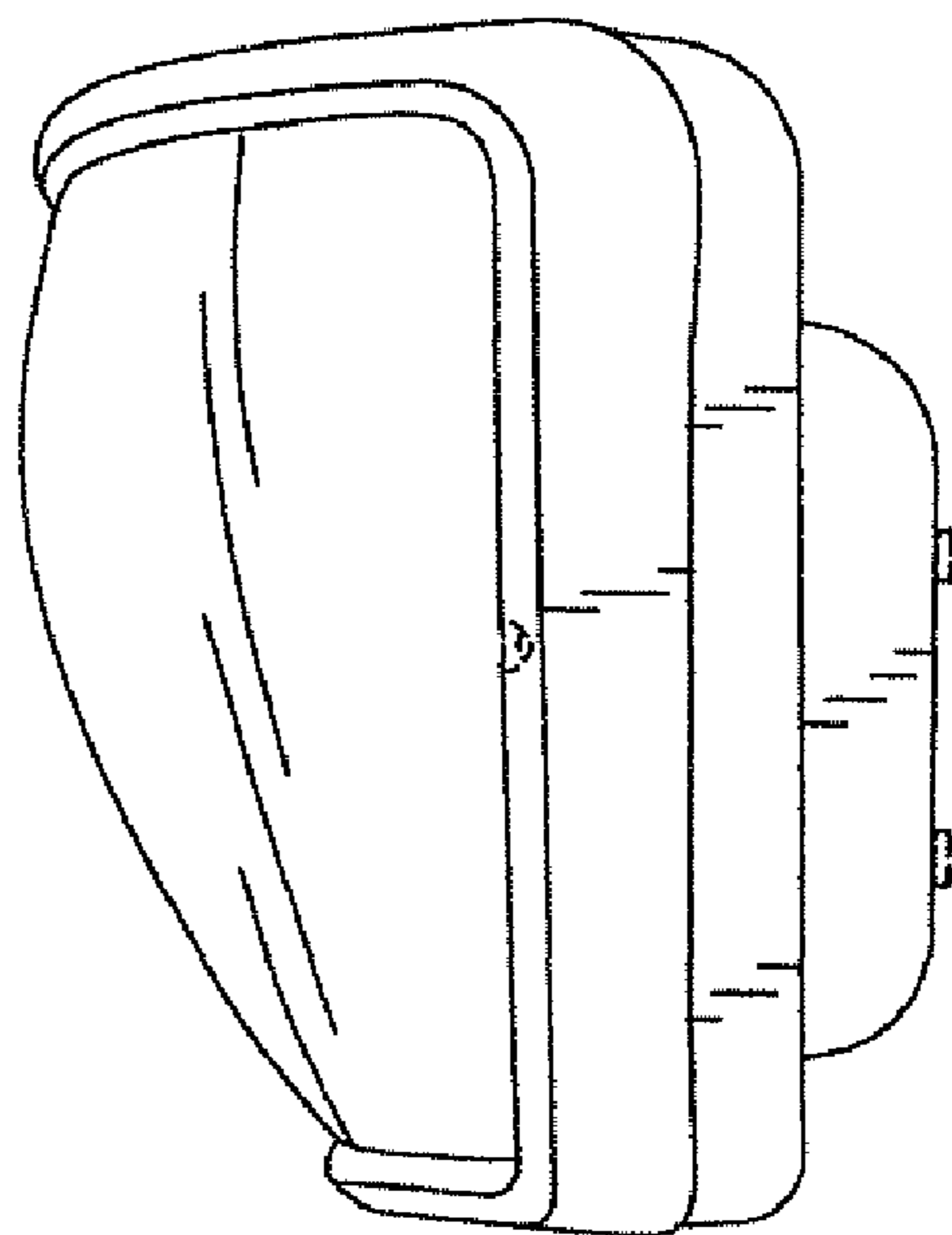
