FIG. 1 is a perspective view of an information and paging system kiosk;

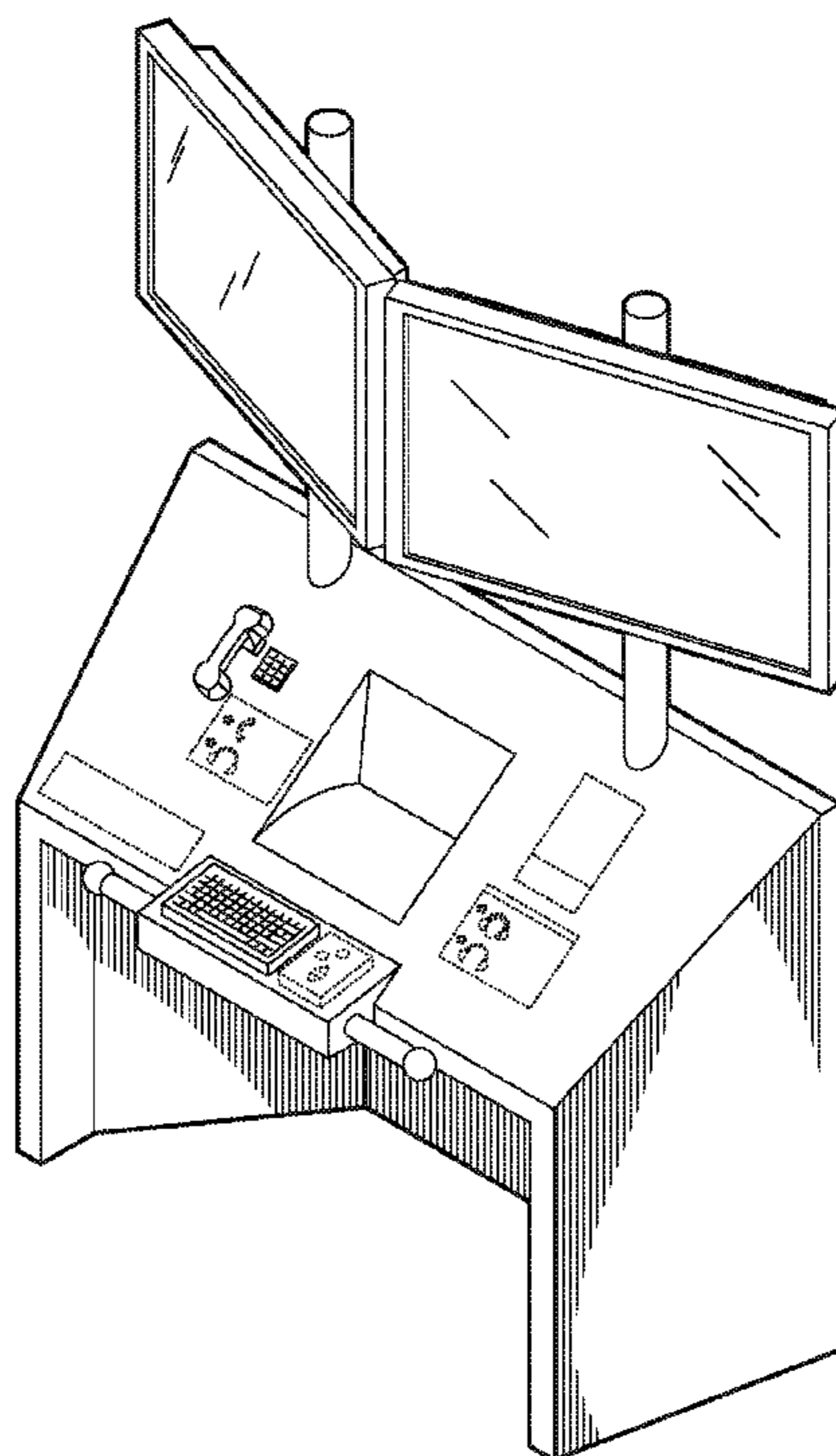
FIG. 2 is another perspective view of the information and paging system kiosk of FIG. 1;

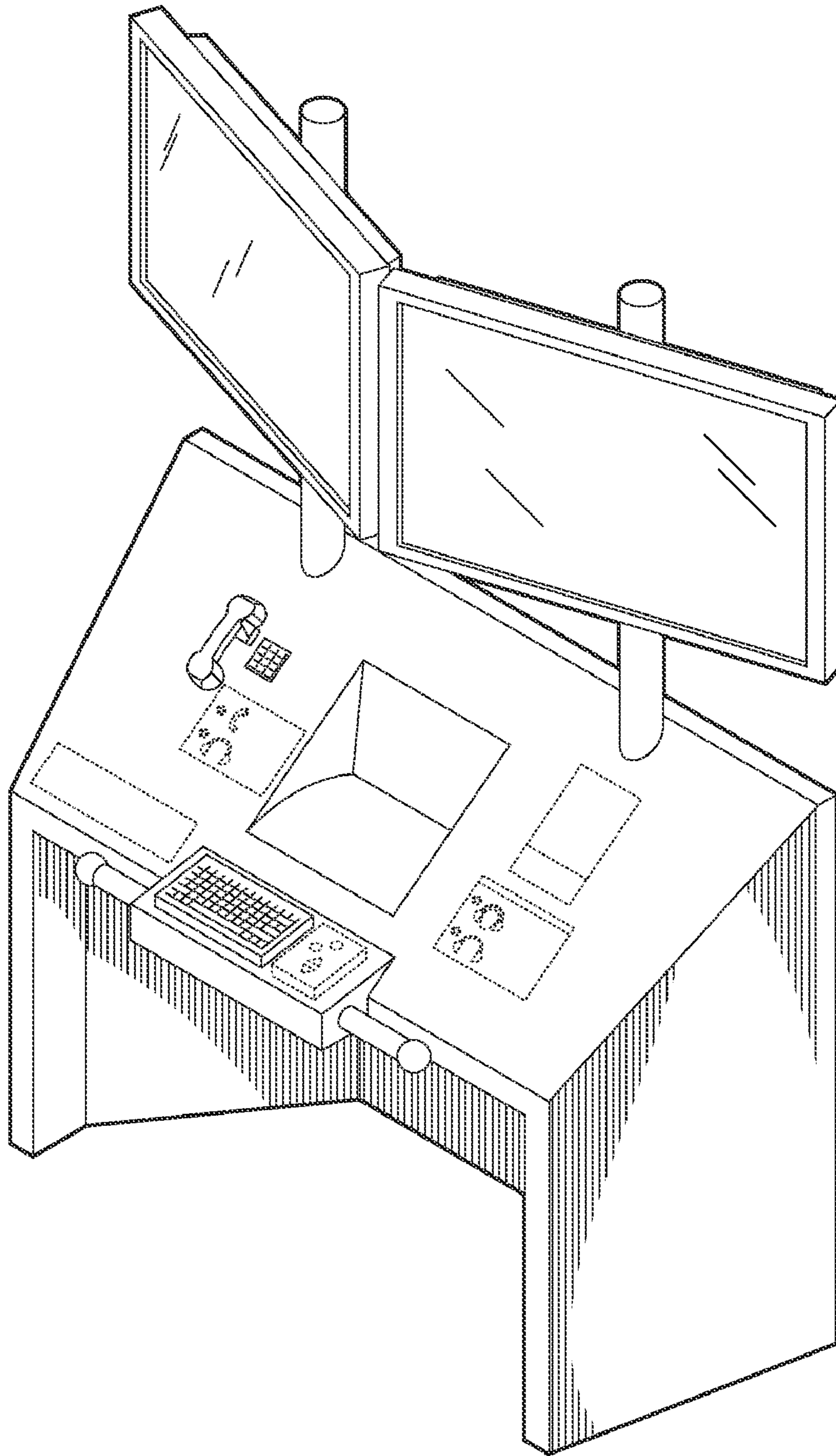

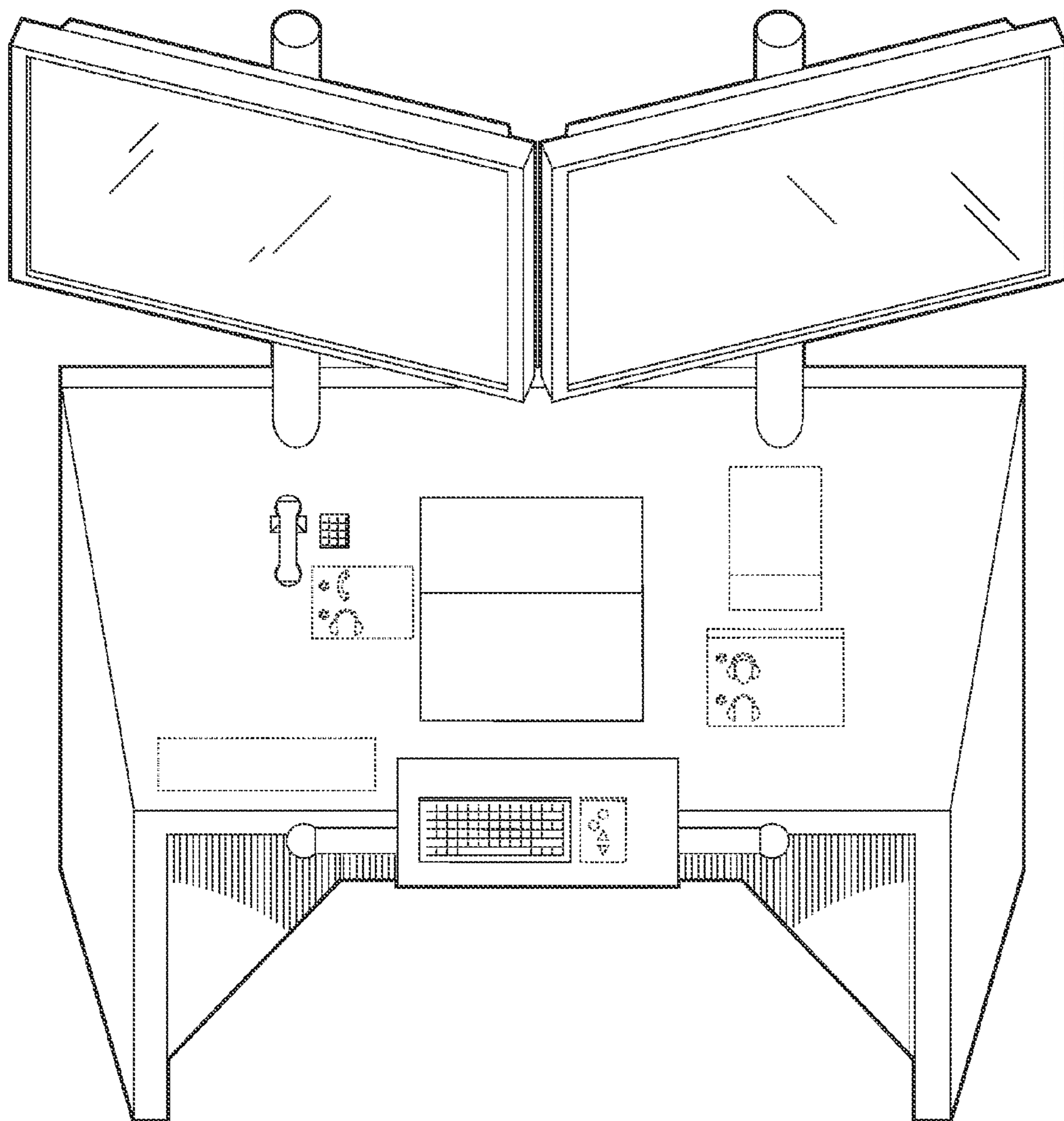

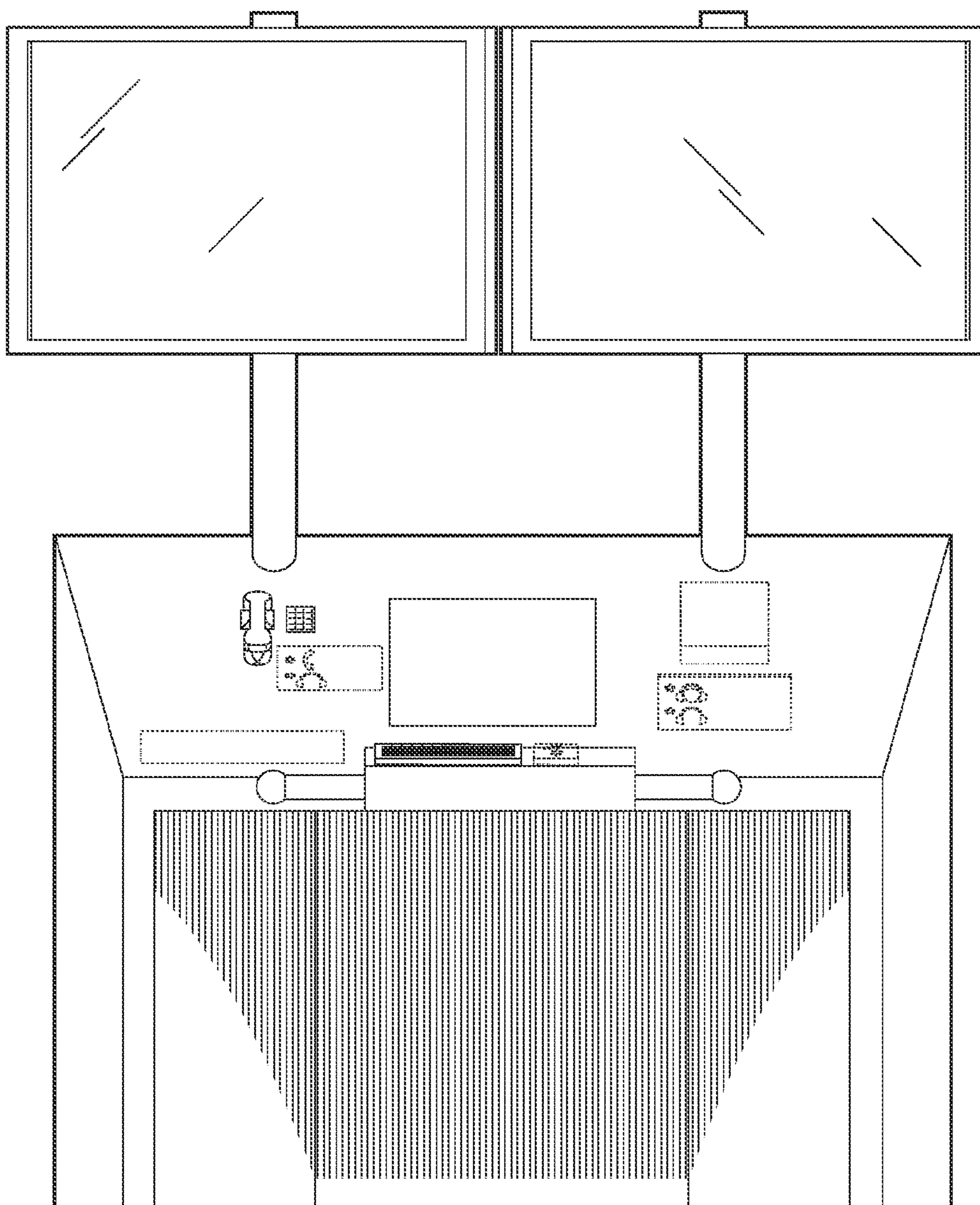

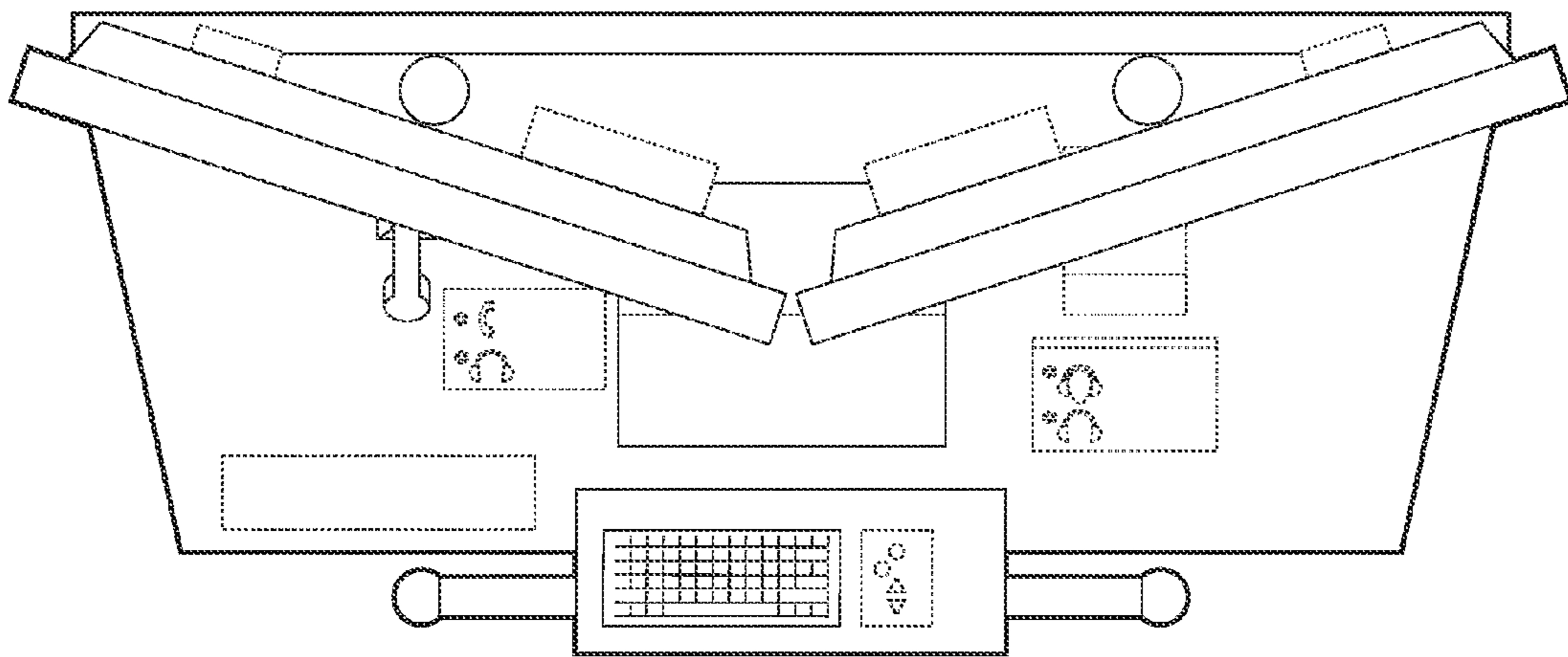

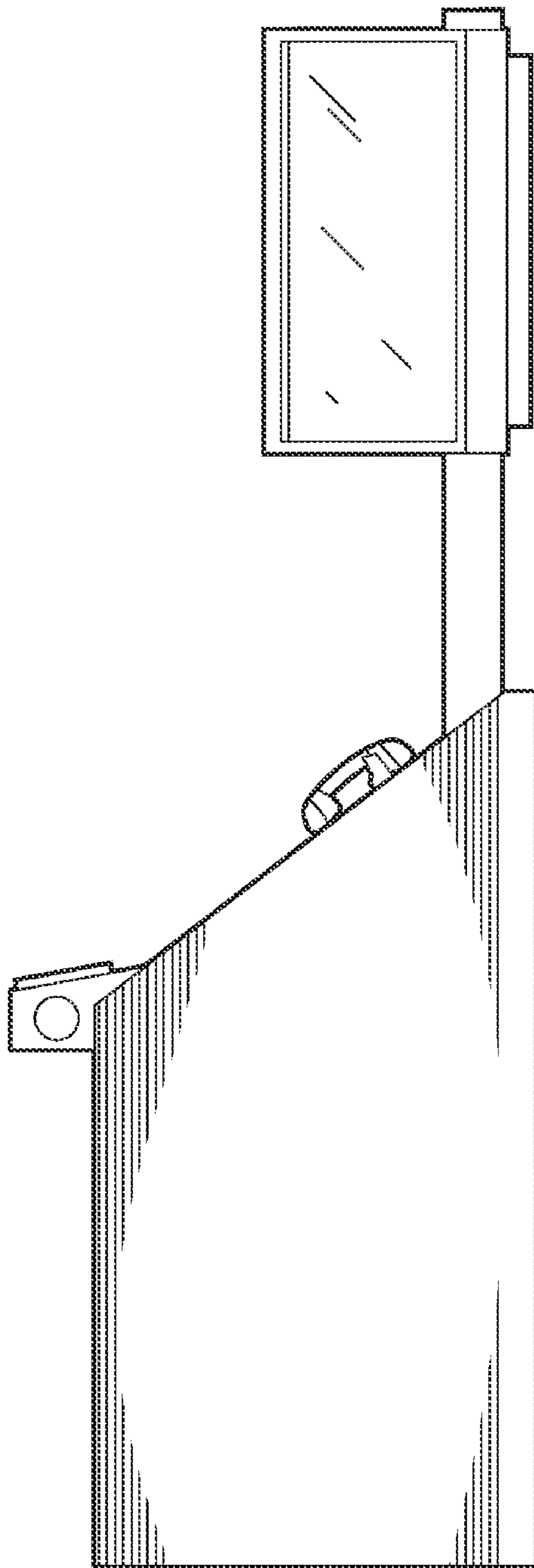
