FIG. 3 is a right view of FIG. 1;

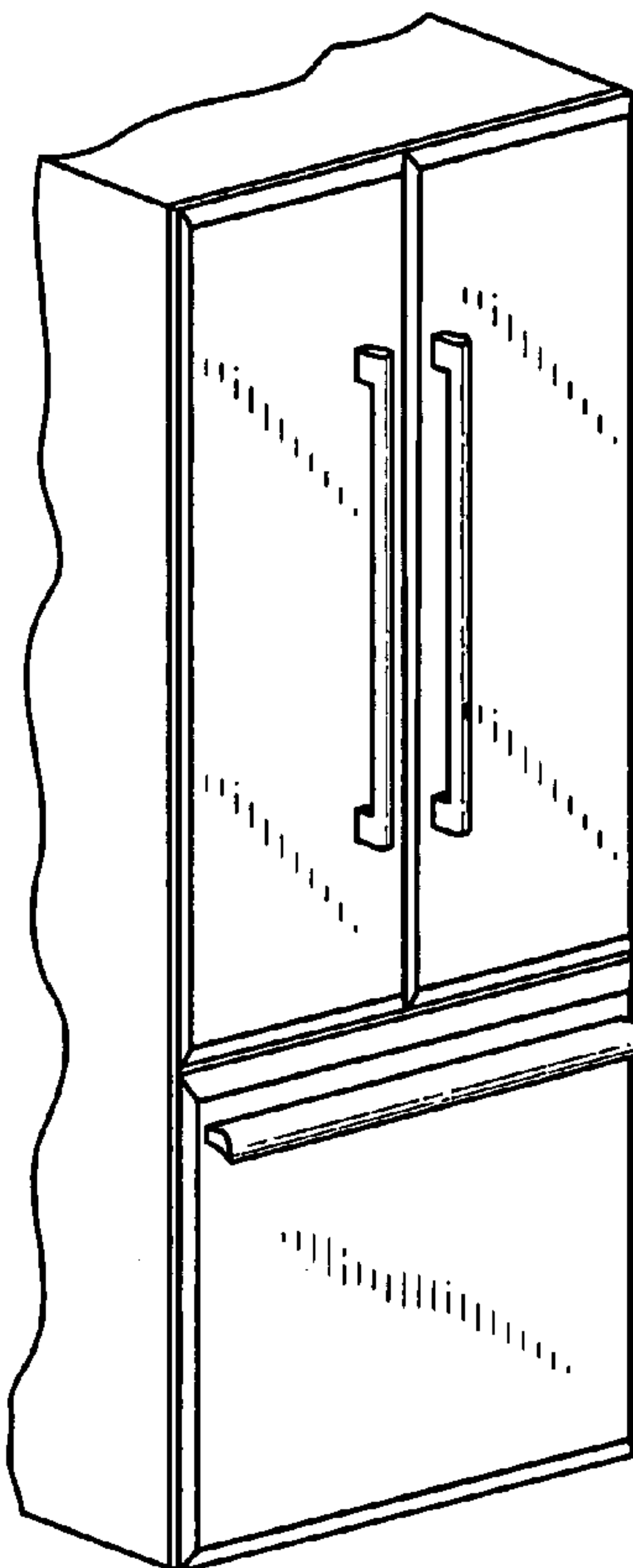
FIG. 4 is a left view of FIG. 1;

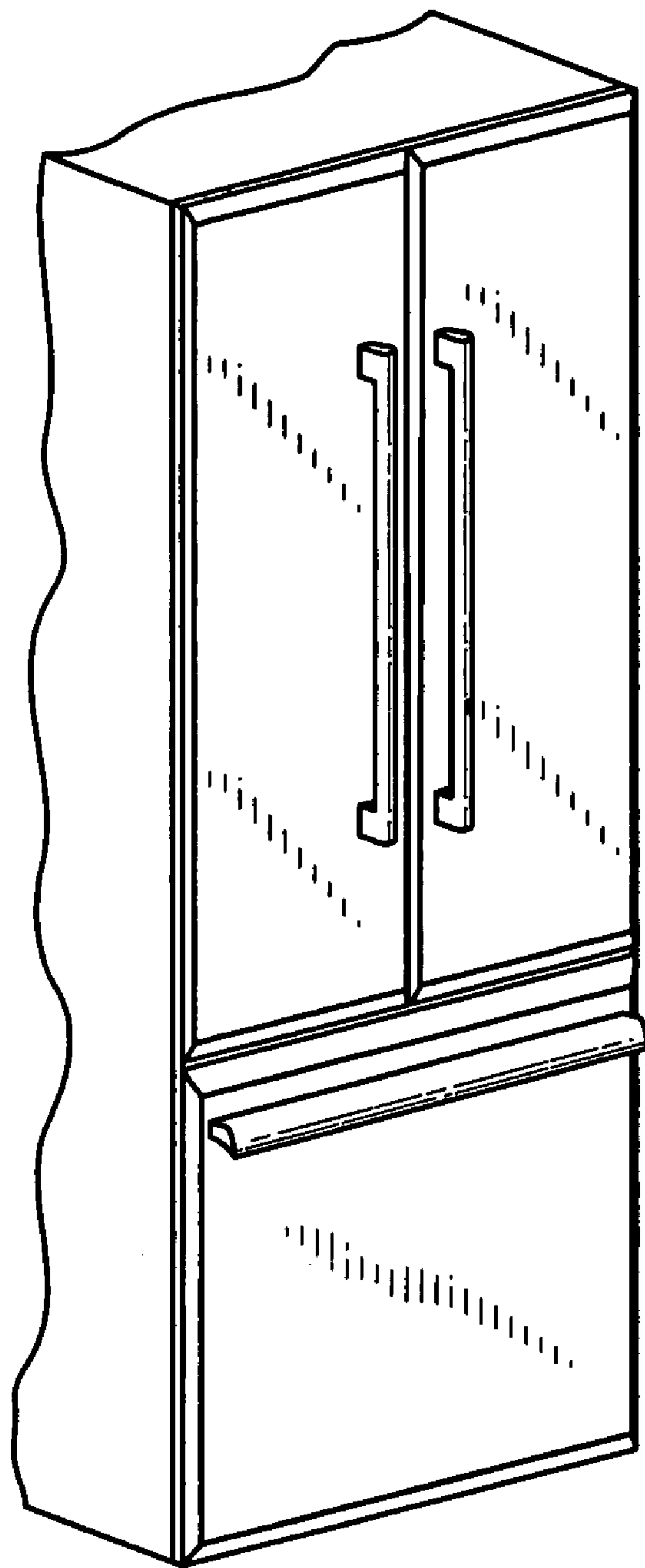

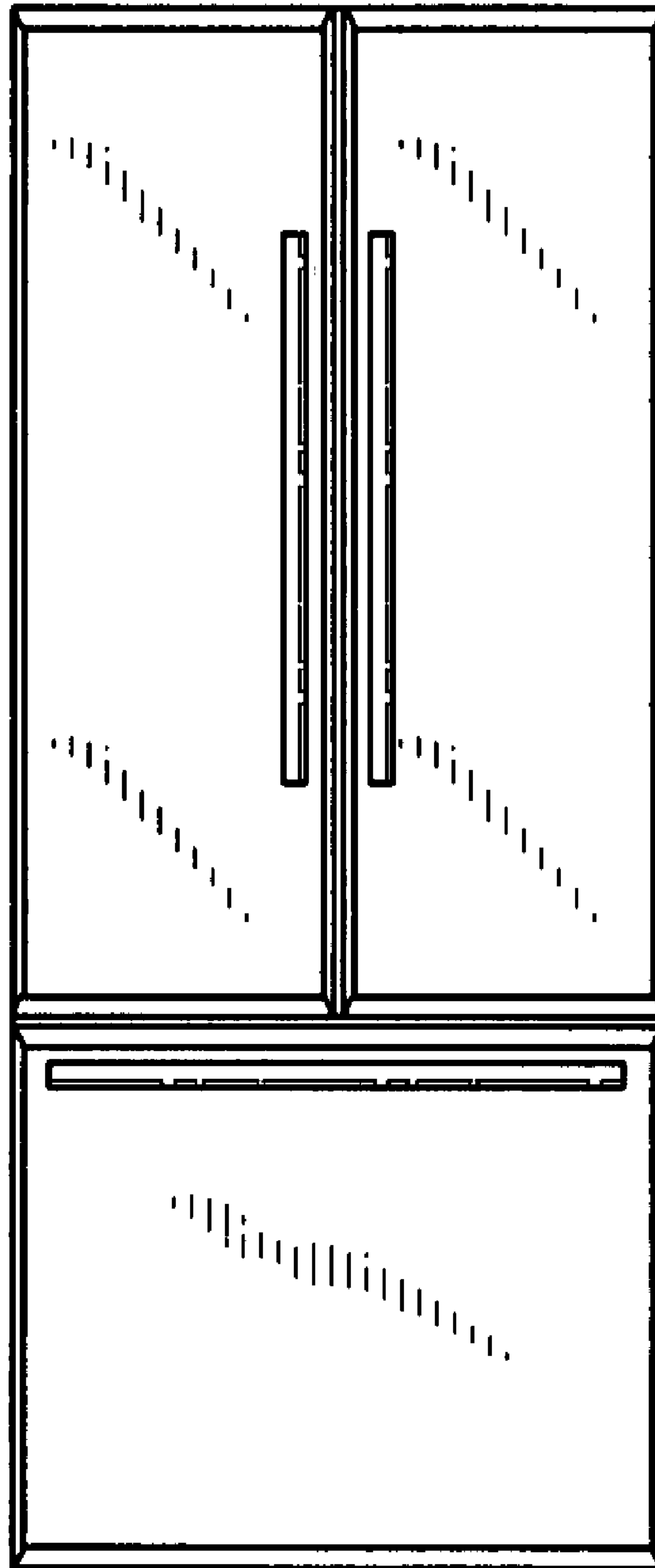

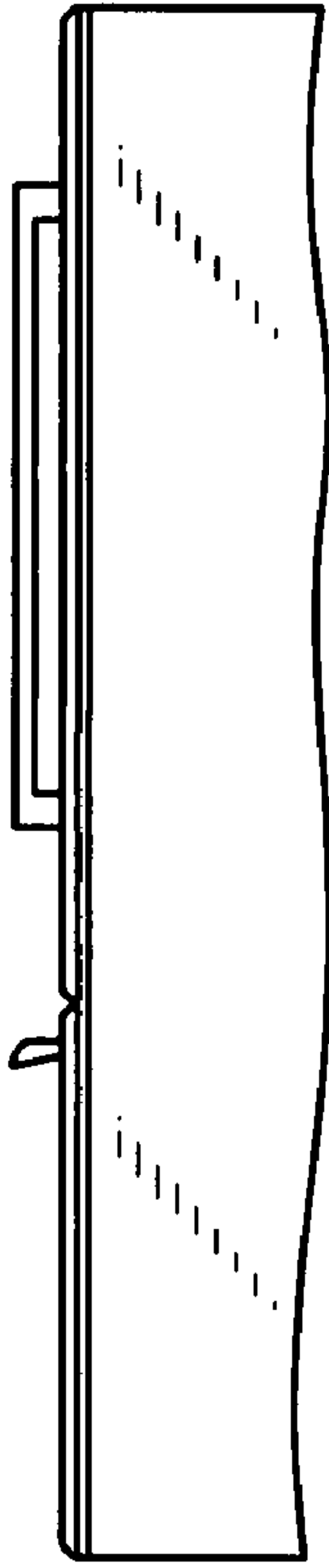

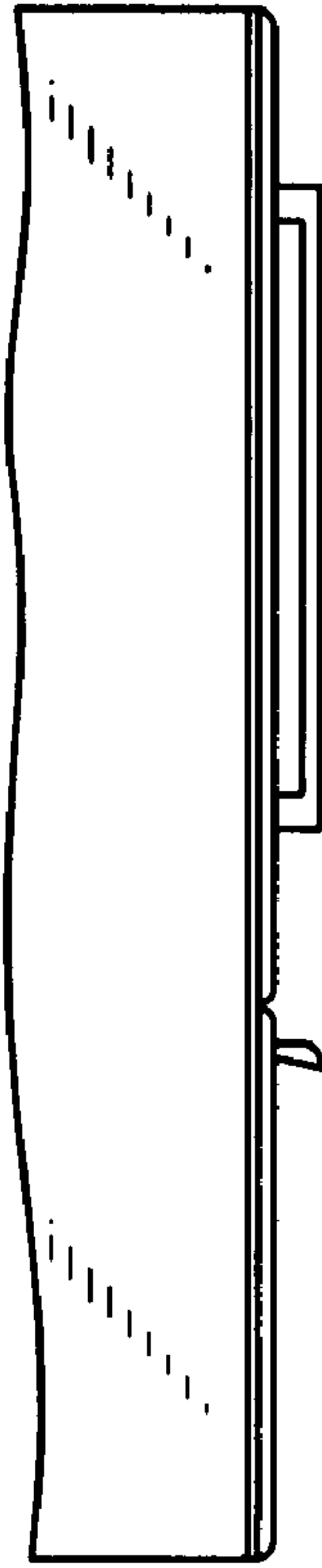

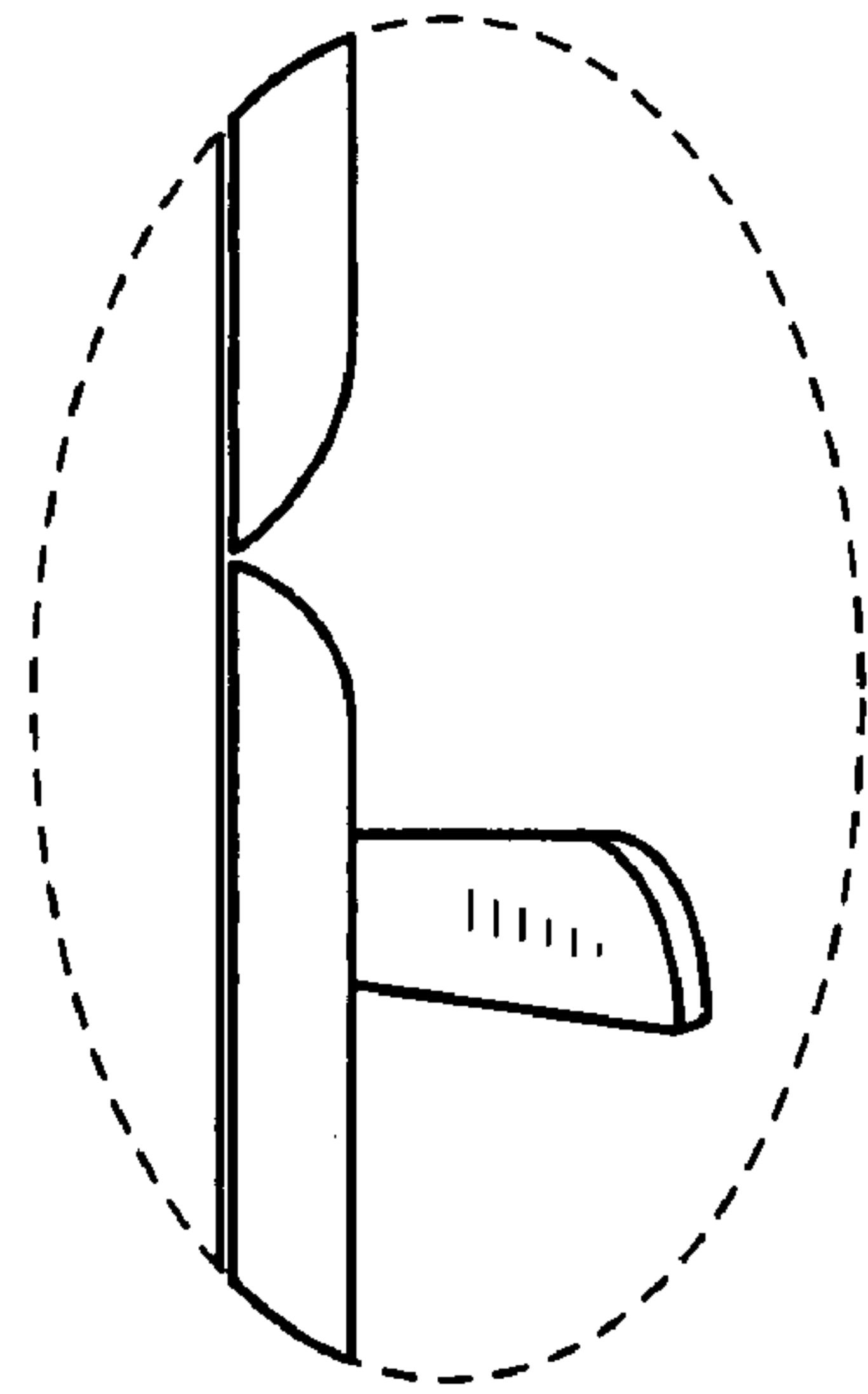

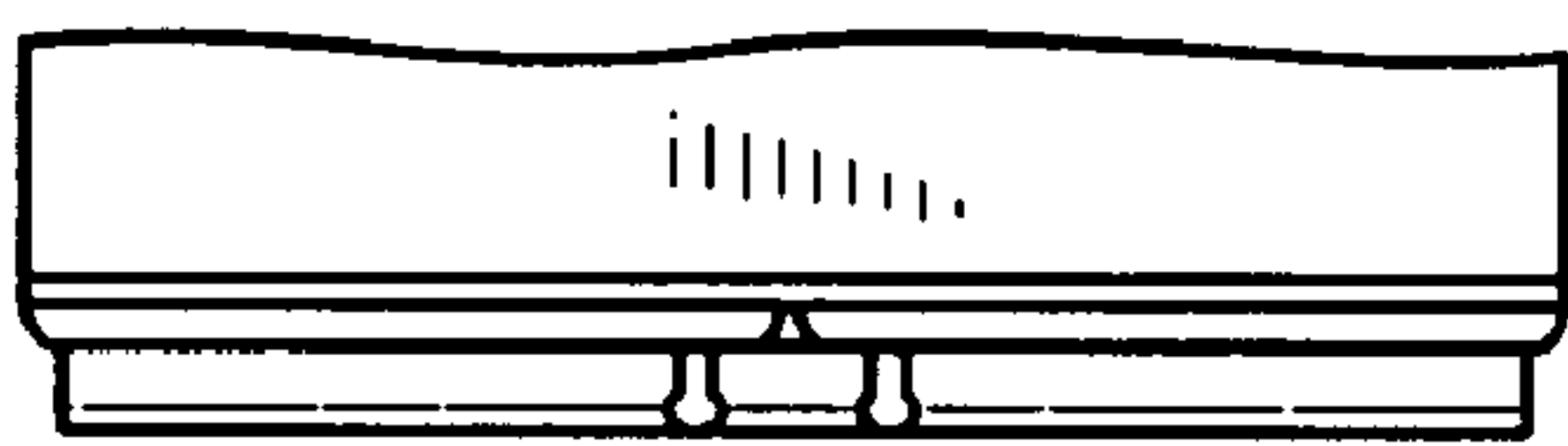

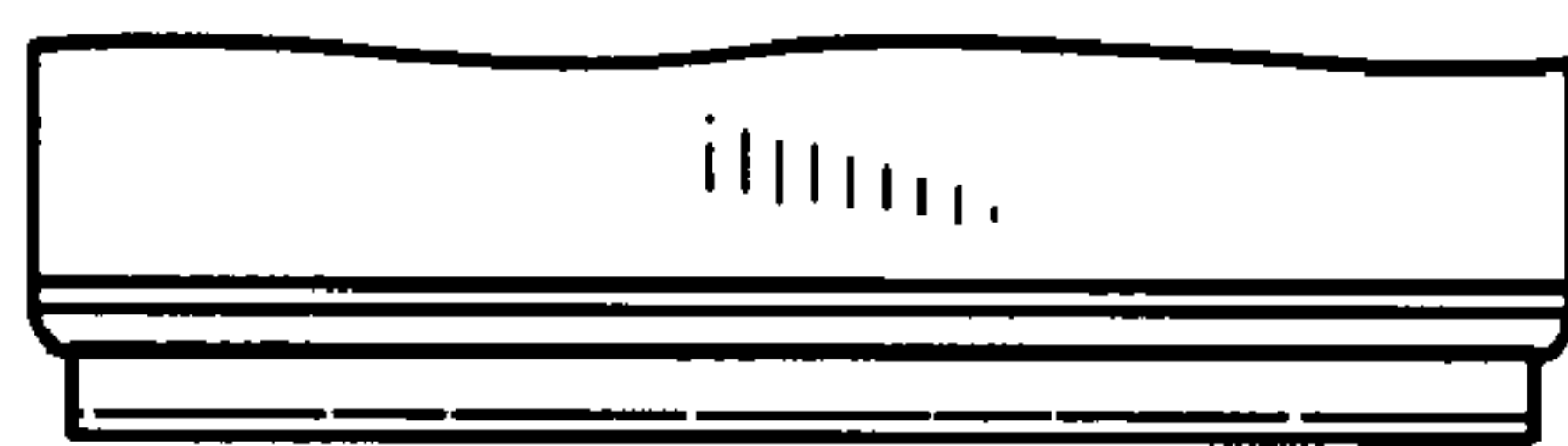
