DESCRIPTION

FIG. 1 is a perspective view of the stencil of the invention;

FIG. 2 is a top plan view of the stencil;

FIG. 3 is a view in elevation of the stencil from the front side;

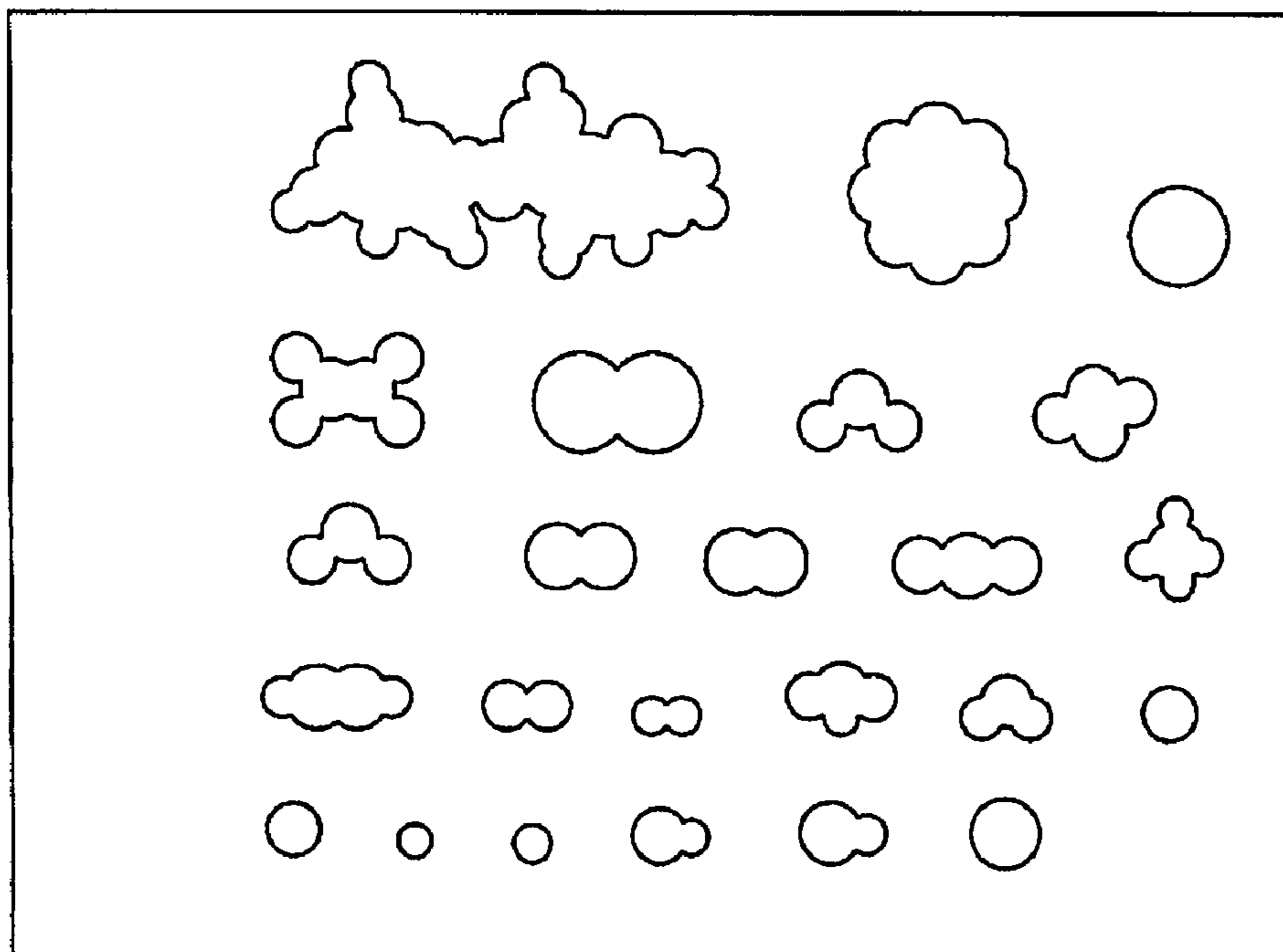
FIG. 4 is a view in elevation of the stencil from the right side;

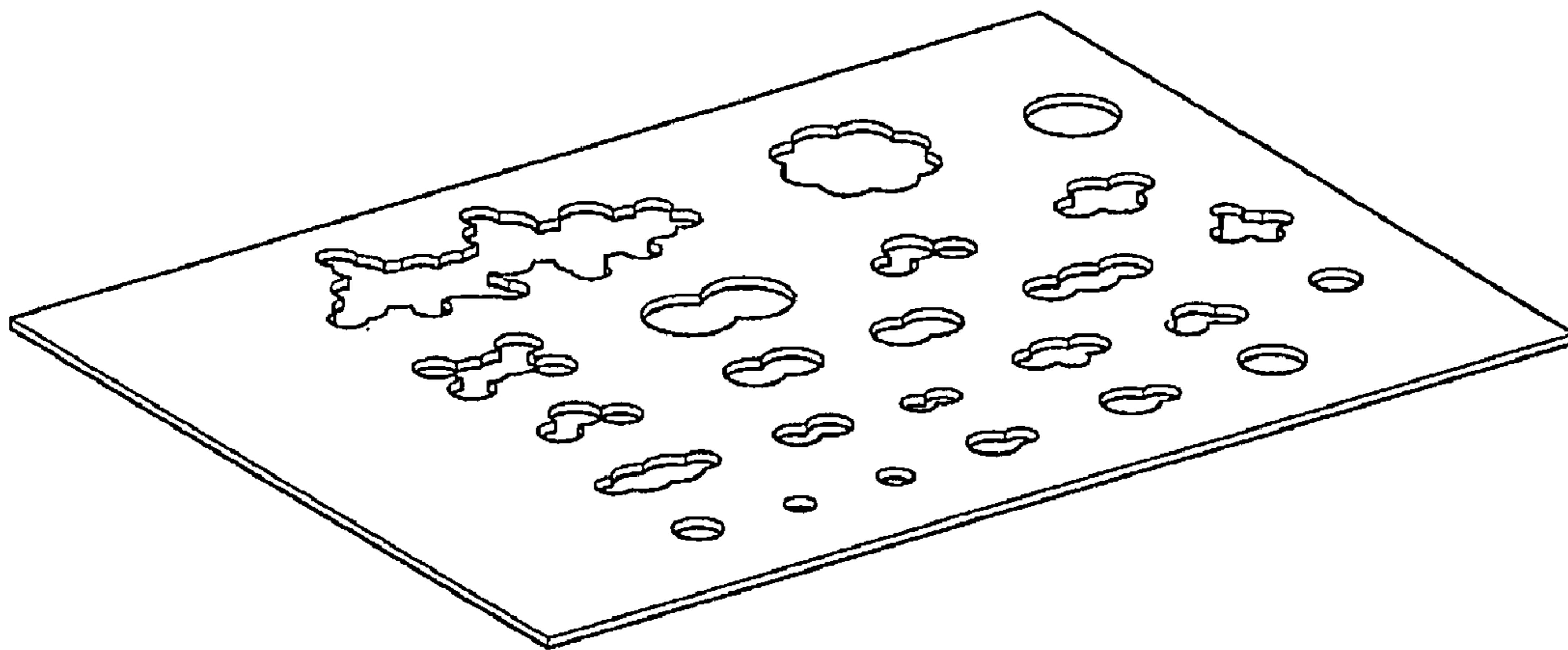

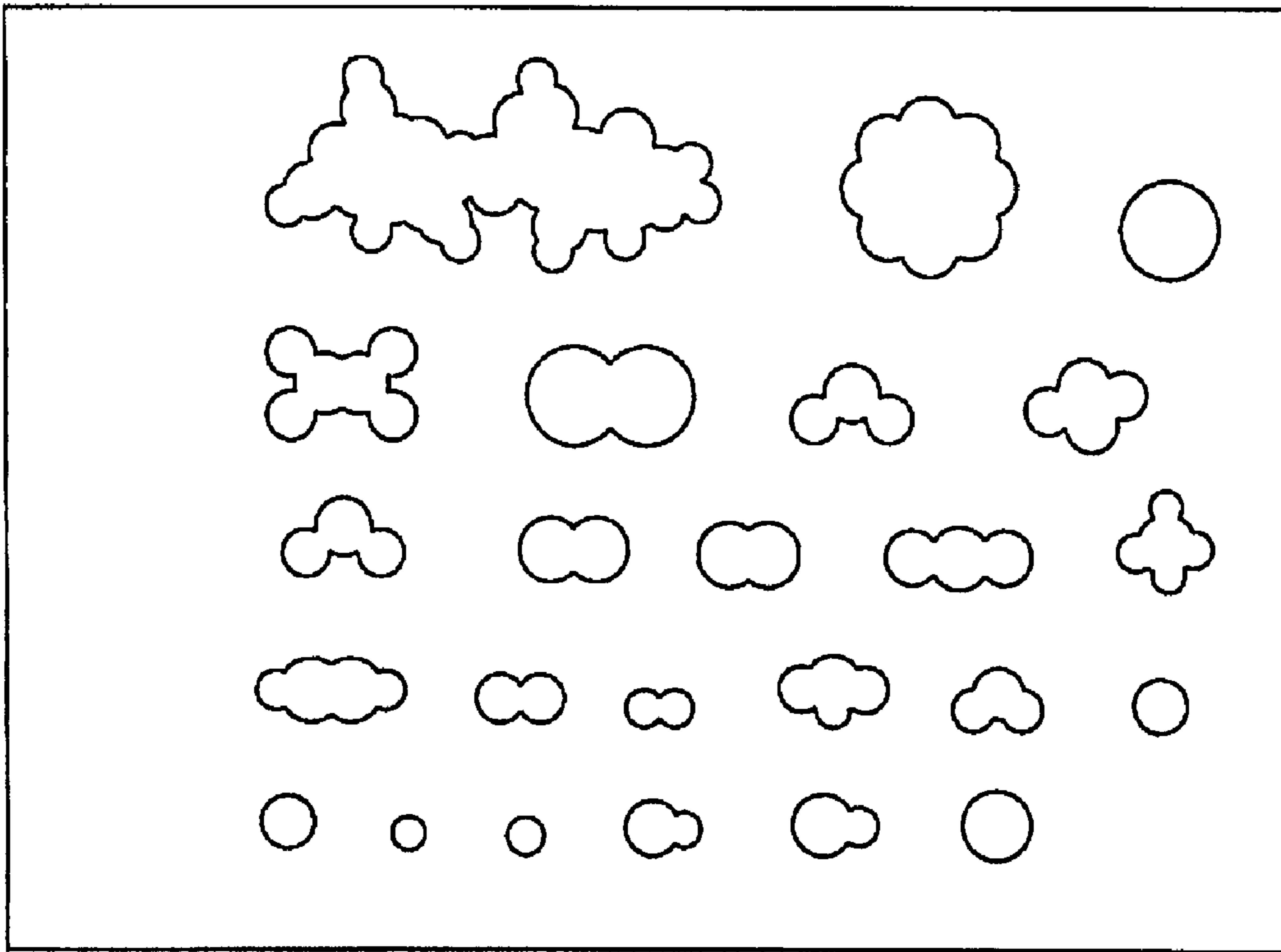

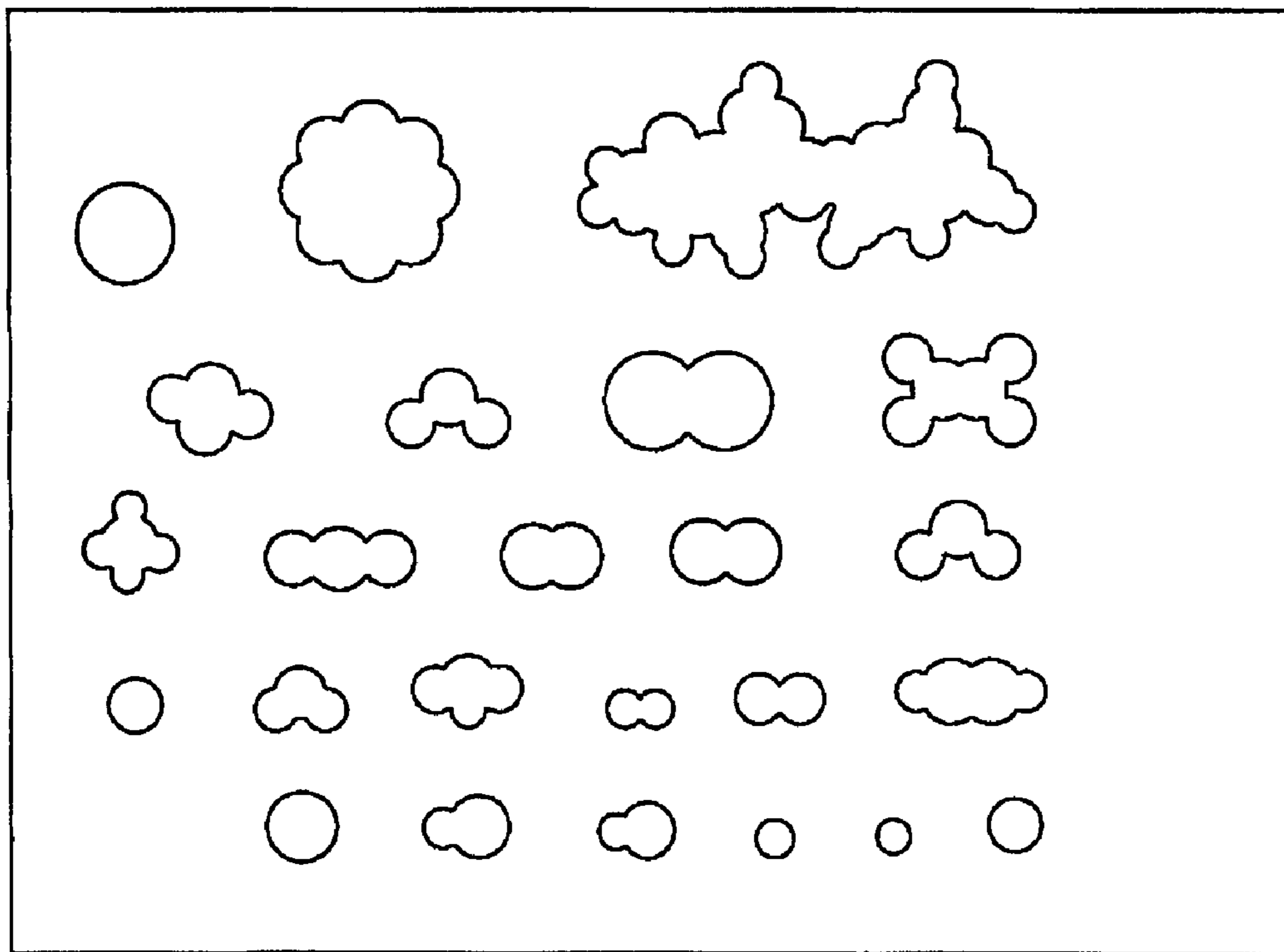
