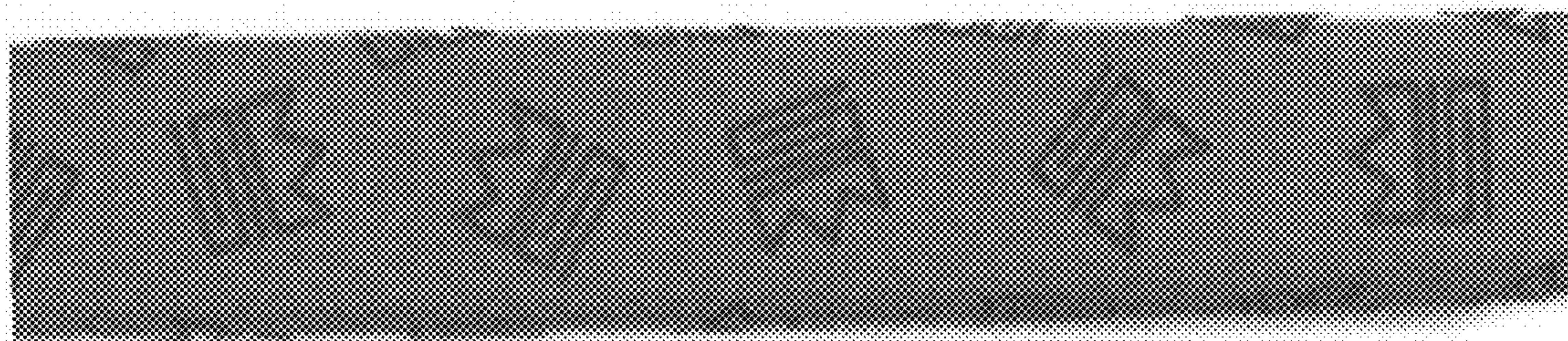
FIG. 1 is a front side view of our new design for a portion of a grip;

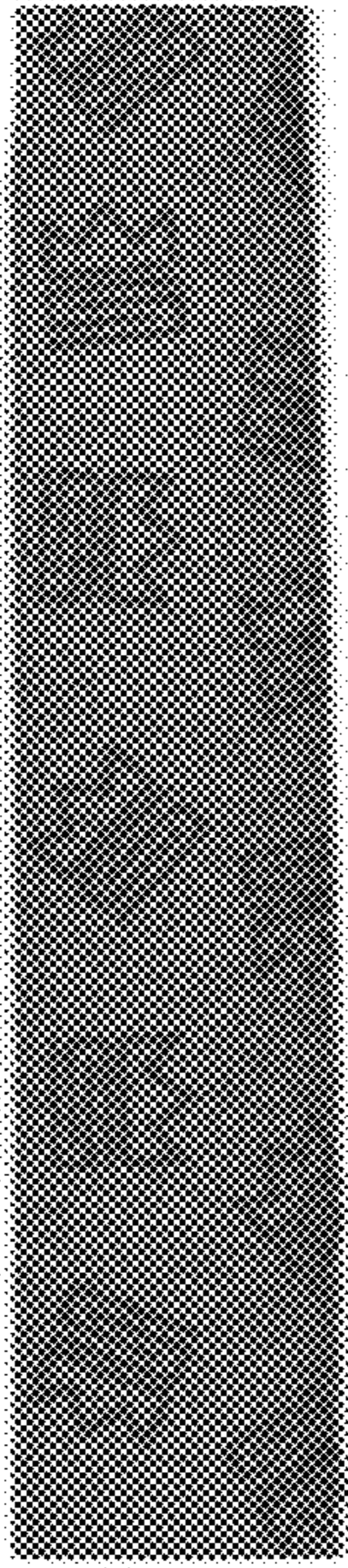

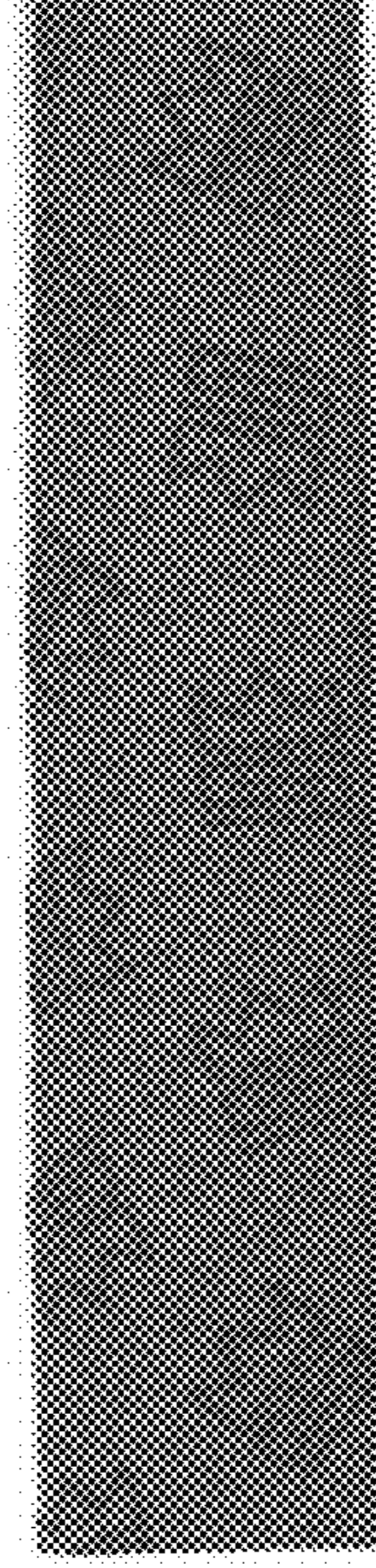

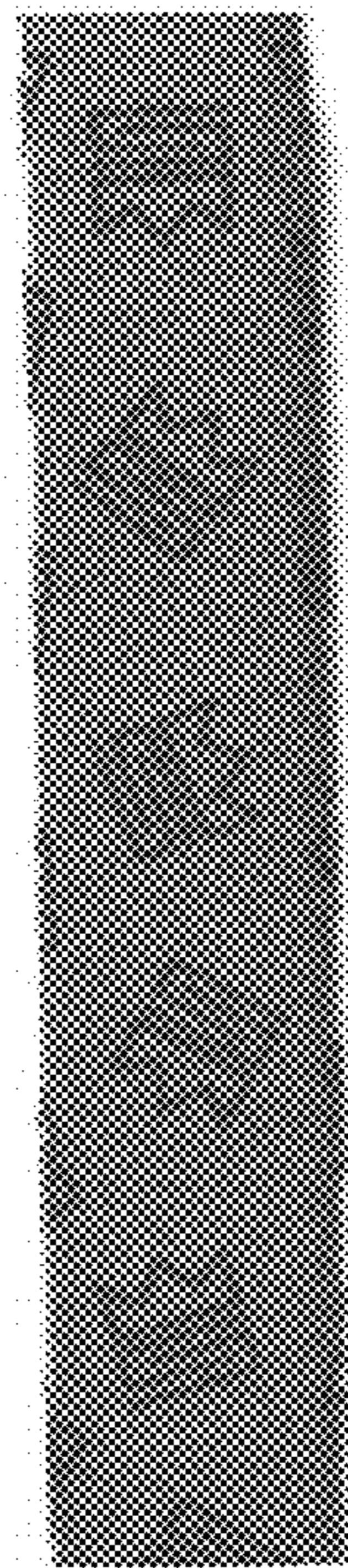

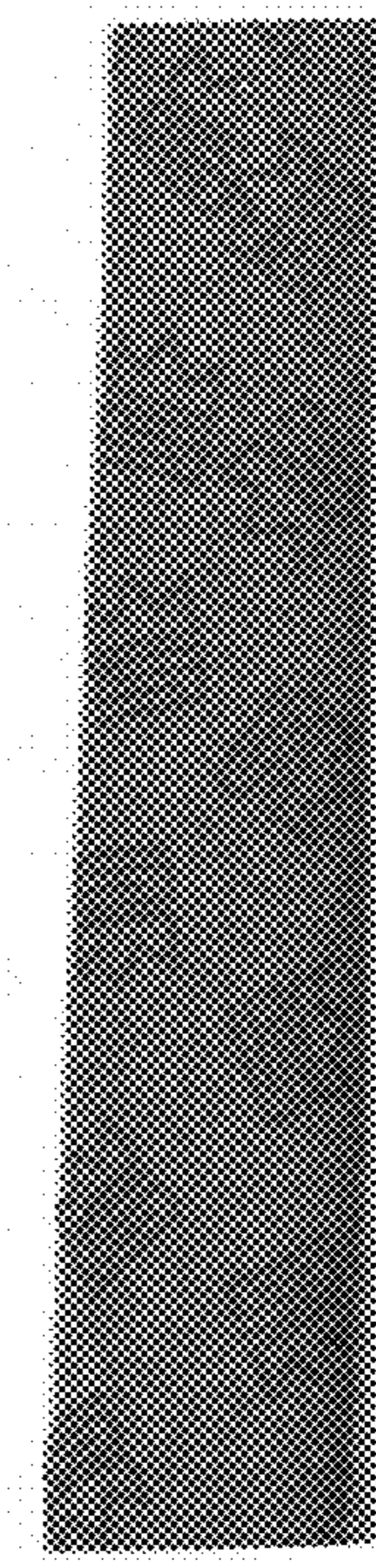
