(57) **CLAIM**

We claim the ornamental design for a dehumidifier, as shown.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a dehumidifier showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

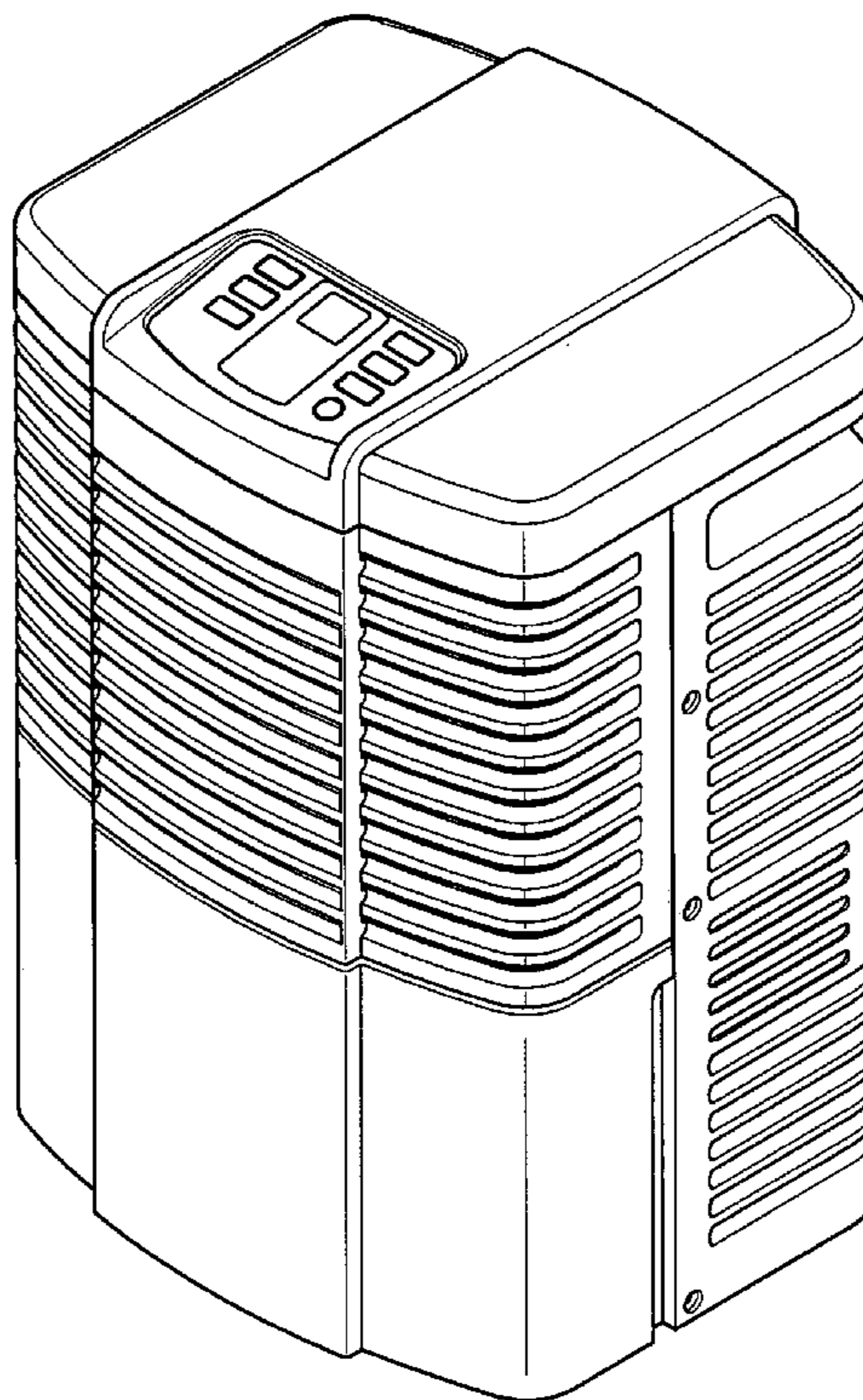

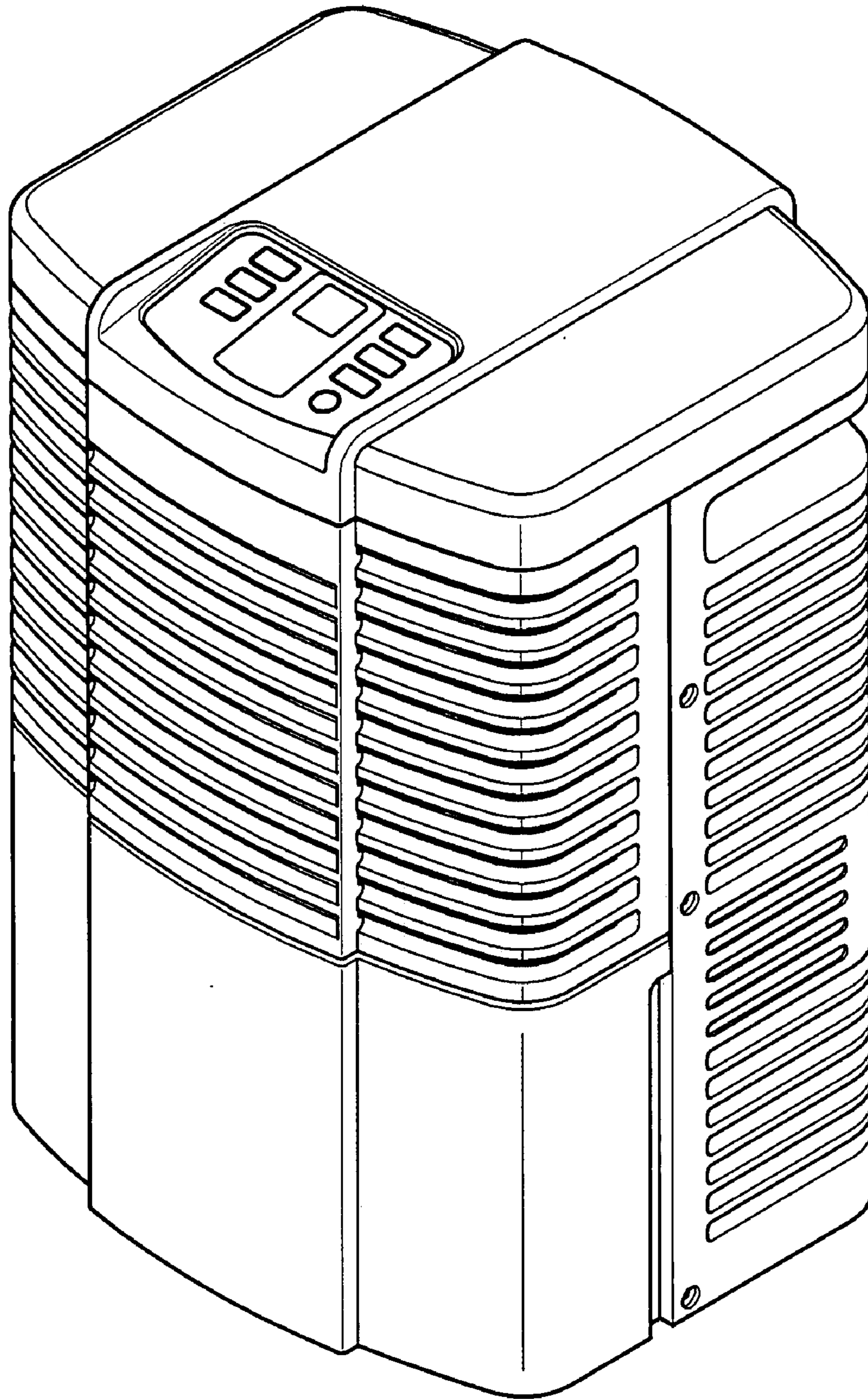

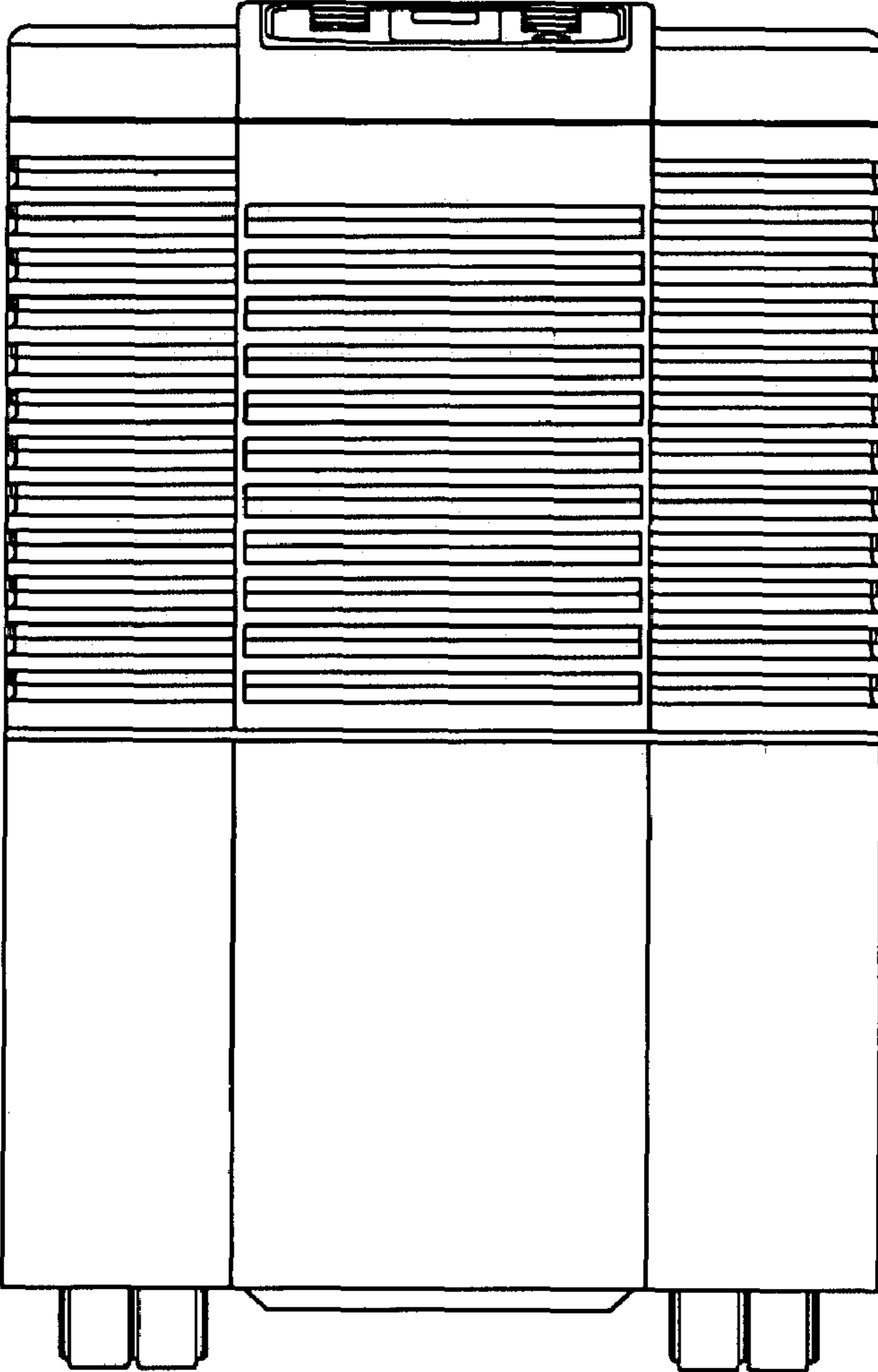

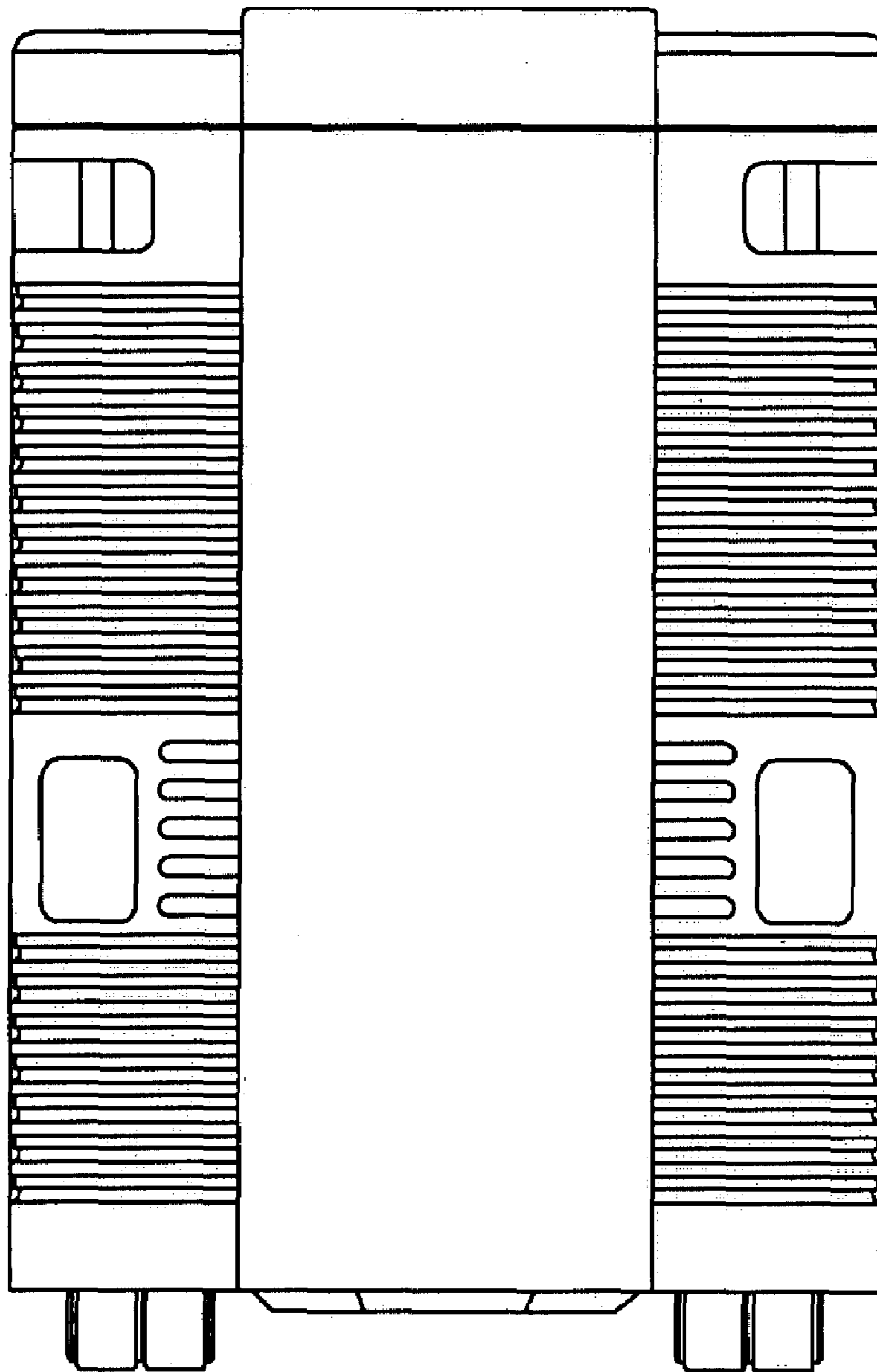

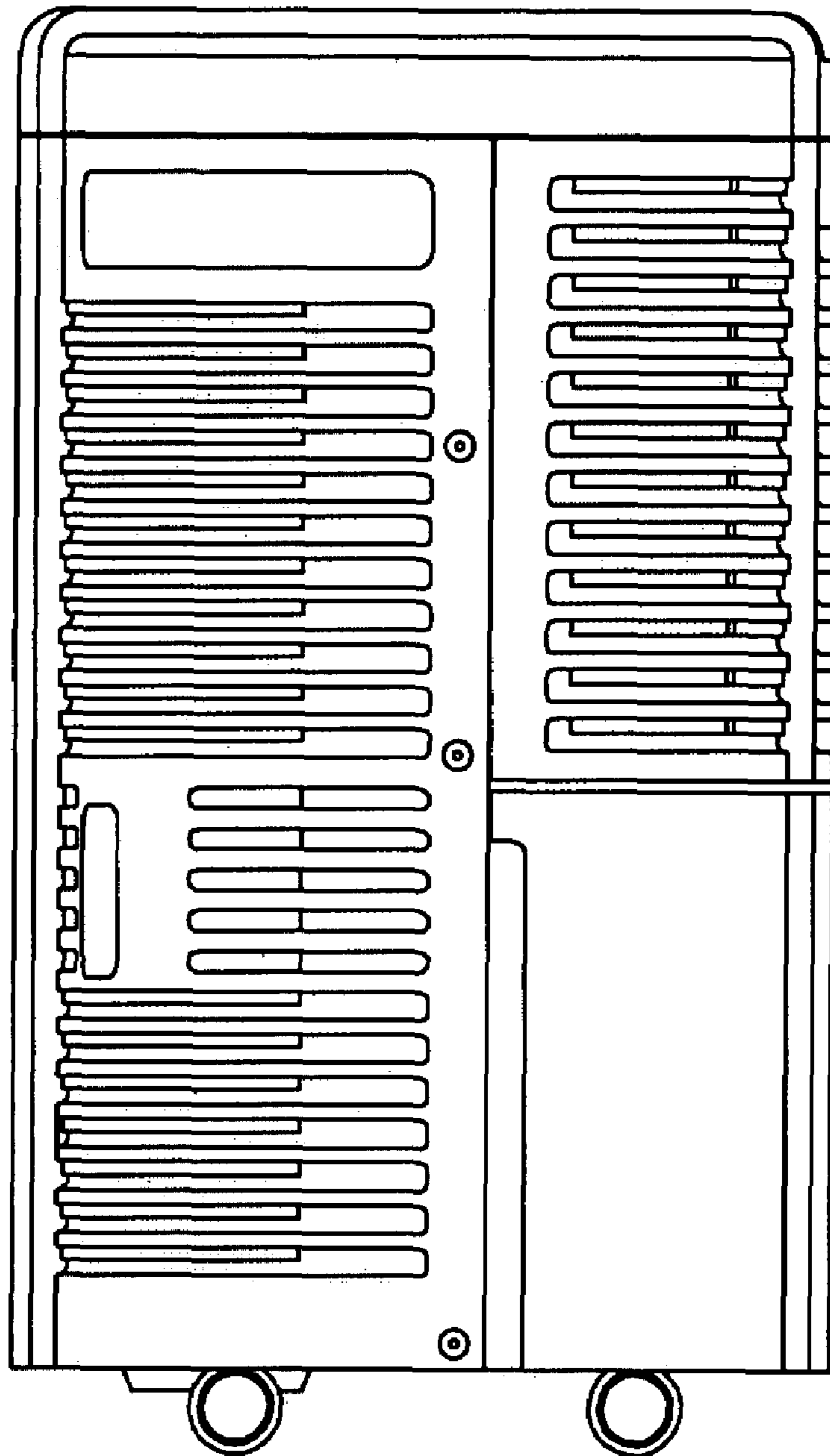

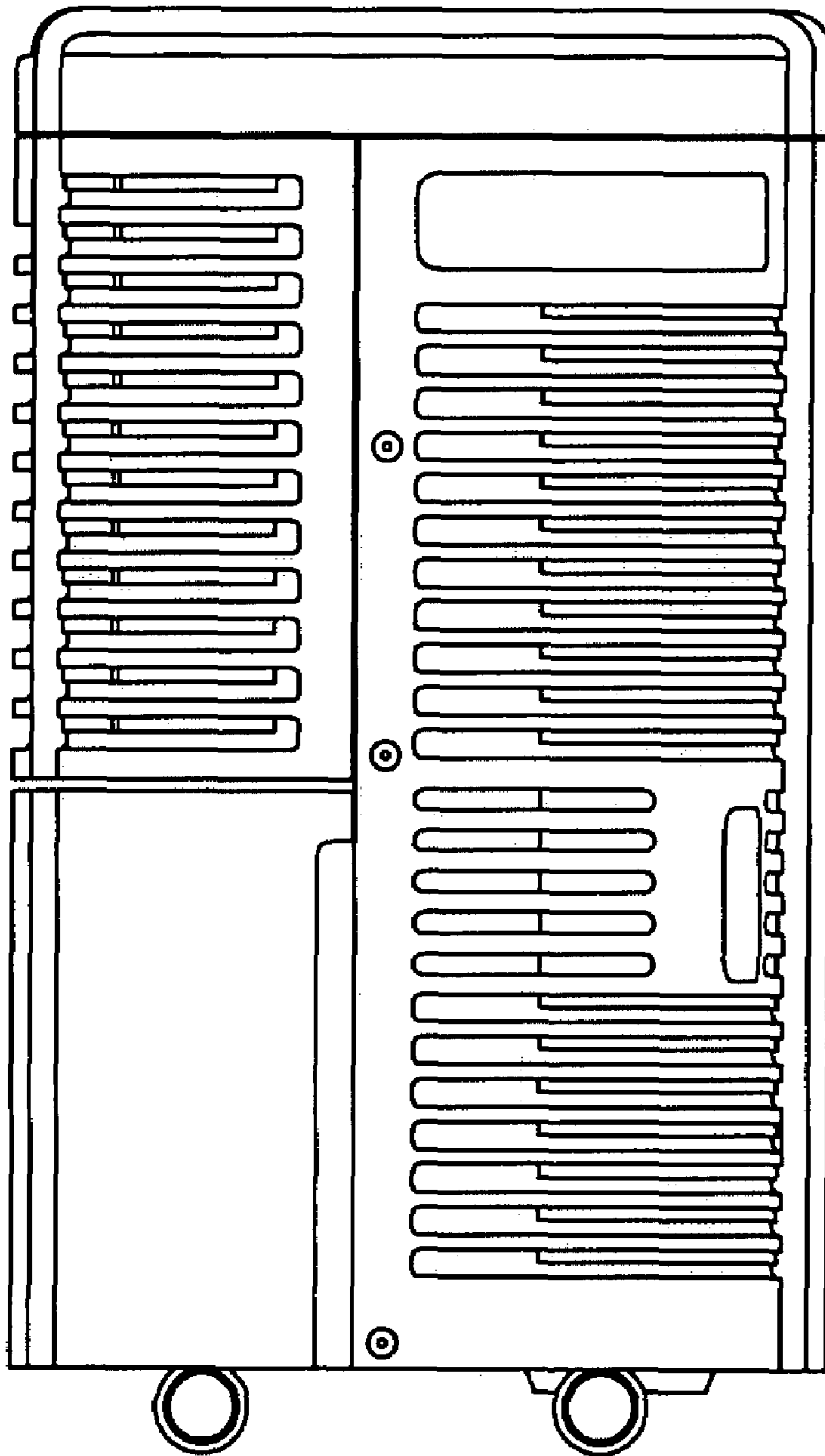

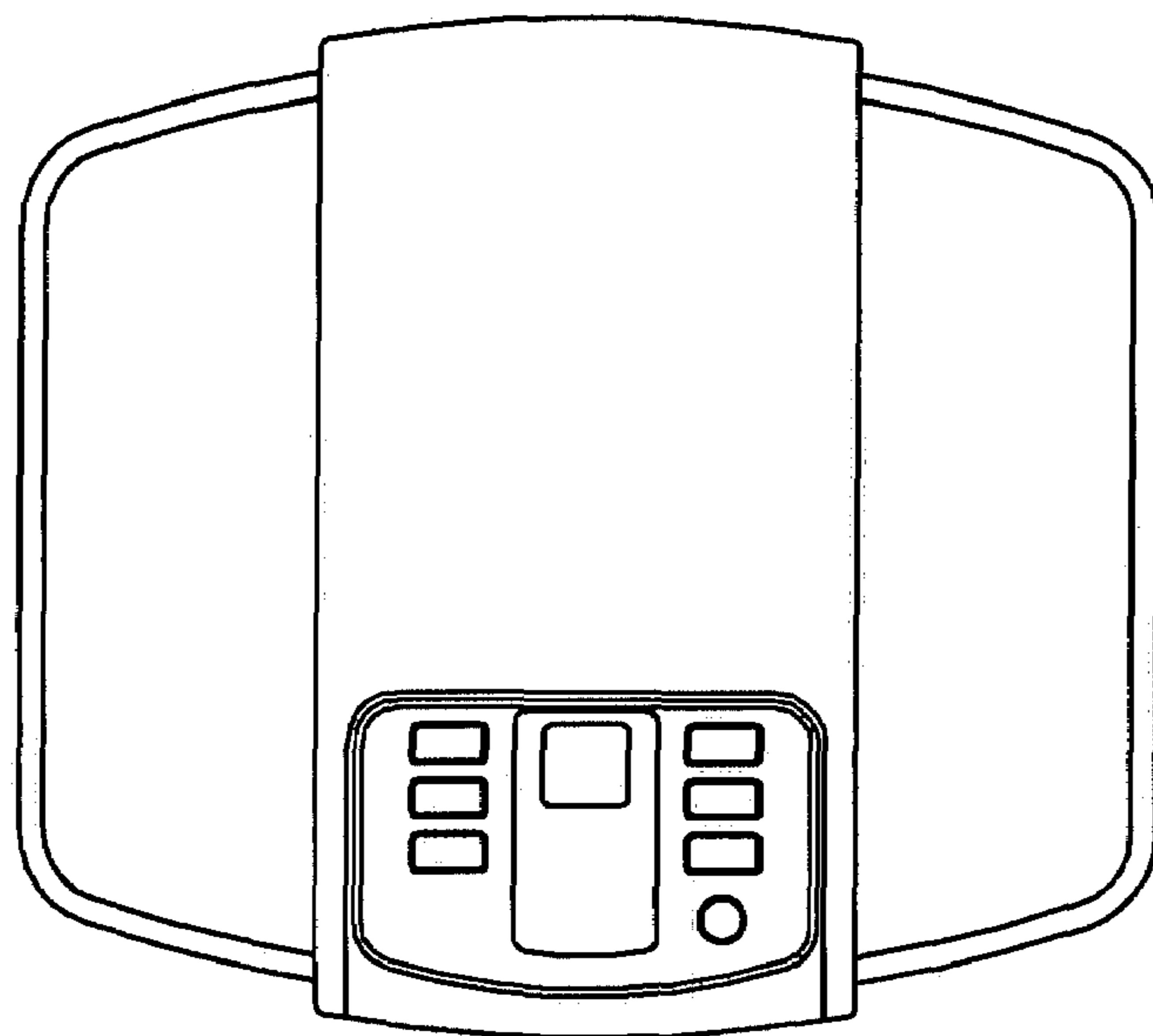
