FIG. 1 is a top isometric view of a preferred embodiment of  
the colored pad shown in pink.

FIG. 2 is a bottom isometric view of the preferred embodi-  
ment of the colored pad from FIG. 1.

FIG. 3 is left side view of the preferred embodiment of the  
colored pad from FIG. 1, and the right side view is essen-  
tially the same in appearance.

FIG. 4 is top side view of the preferred embodiment of the  
colored pad from FIG. 1, and the bottom side view is  
essentially the same in appearance.

FIG. 5 is a top isometric view of a preferred embodiment of  
the colored pad shown in blue.

FIG. 6 is a bottom isometric view of the preferred embodi-  
ment of the colored pad from FIG. 5.

FIG. 7 is left side view of the preferred embodiment of the  
colored pad from FIG. 5, and the right side view is essen-  
tially the same in appearance.

FIG. 8 is top side view of the preferred embodiment of the  
colored pad from FIG. 5, and the bottom side view is  
essentially the same in appearance.

FIG. 9 is a top isometric view of a preferred embodiment of  
the colored pad shown in red.

FIG. 10 is a bottom isometric view of the preferred embodi-  
ment of the colored pad from FIG. 9.

FIG. 11 is left side view of the preferred embodiment of the  
colored pad from FIG. 9, and the right side view is essen-  
tially the same in appearance.

FIG. 12 is top side view of the preferred embodiment of the  
colored pad from FIG. 9, and the bottom side view is  
essentially the same in appearance.

FIG. 13 is a top isometric view of a preferred embodiment  
of the colored pad shown in gray.

FIG. 14 is a bottom isometric view of the preferred embodi-  
ment of the colored pad from FIG. 13.

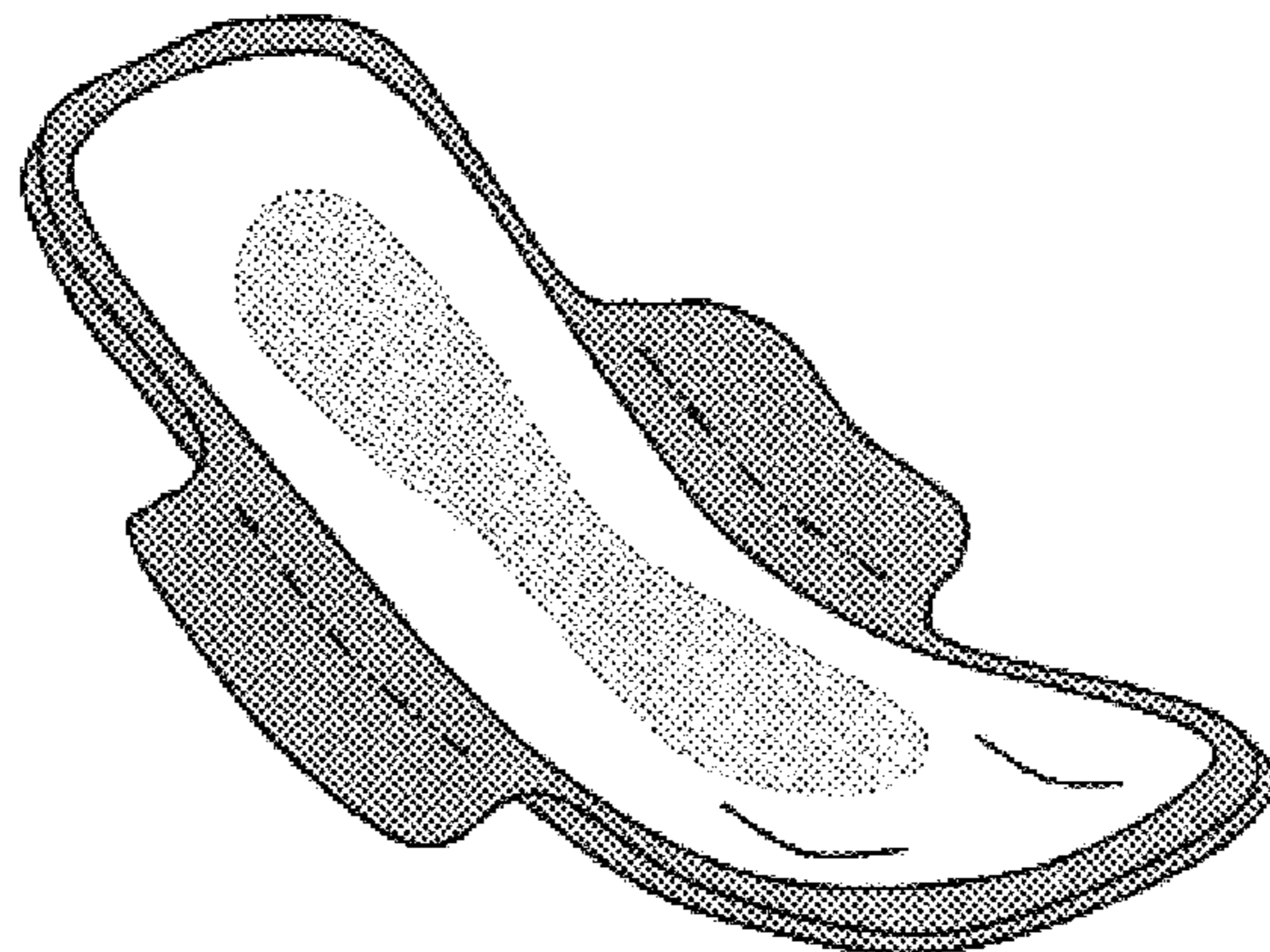


FIG. **15** is left side view of the preferred embodiment of the colored pad from FIG. **13**, and the right side view is essentially the same in appearance.

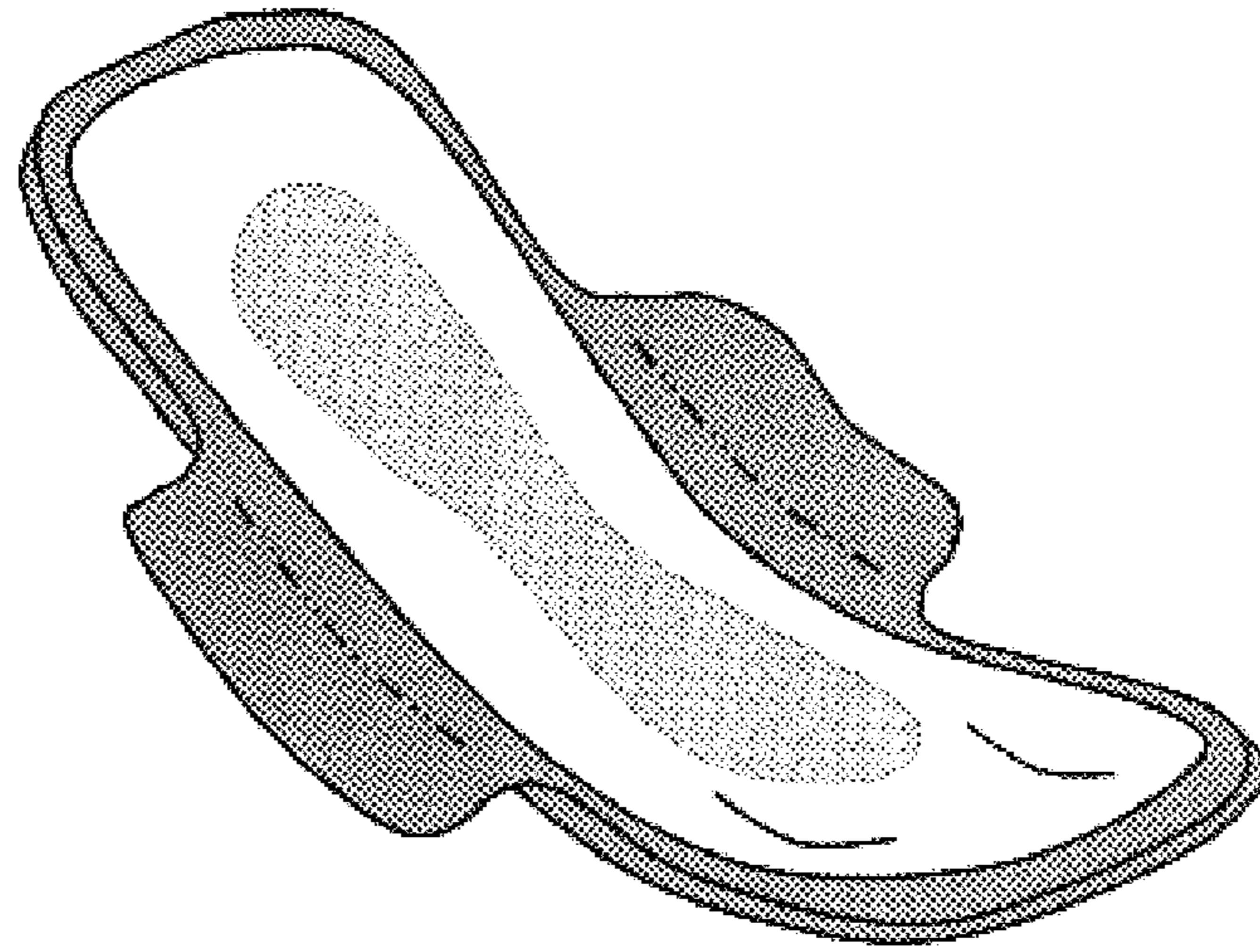

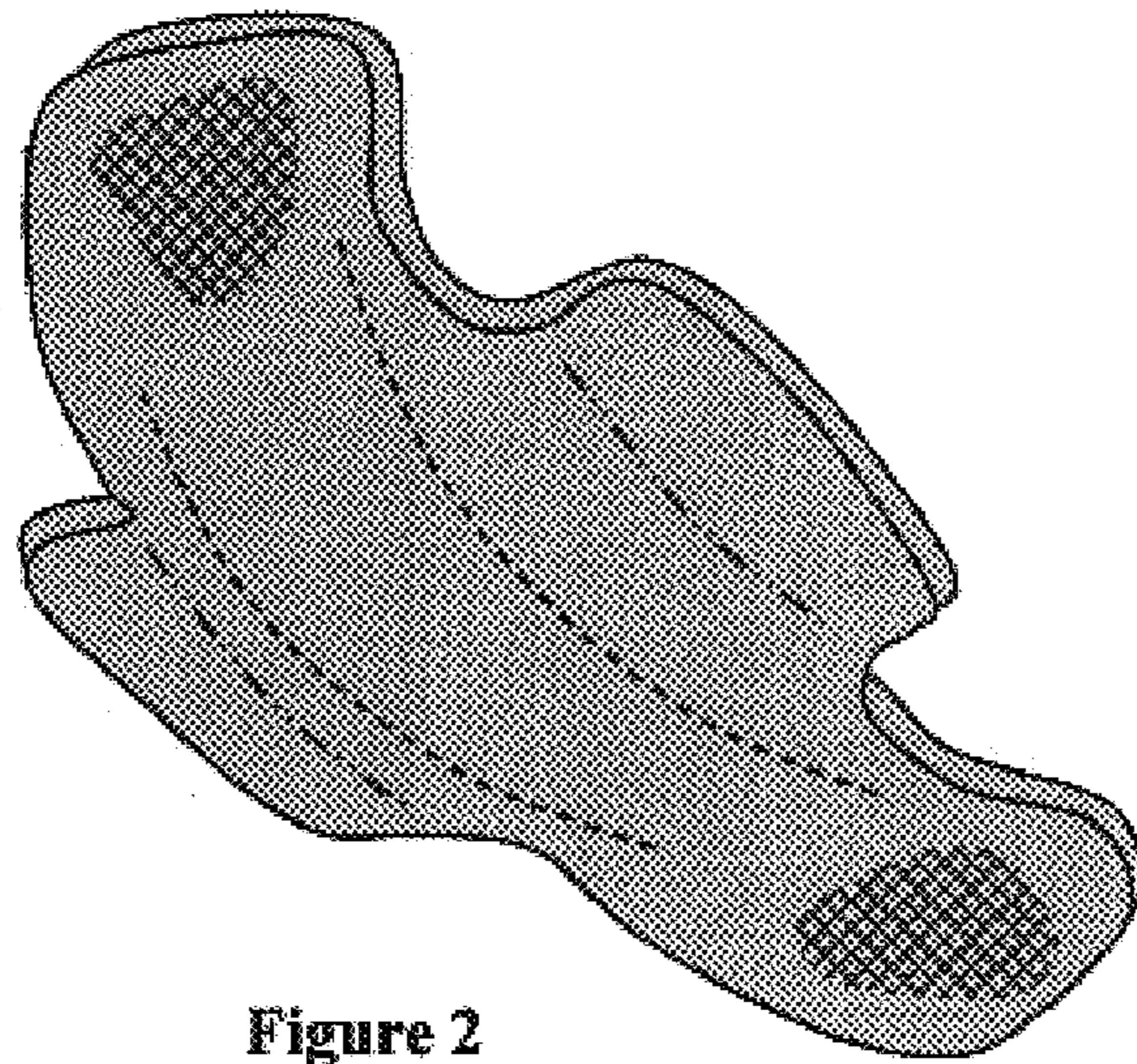

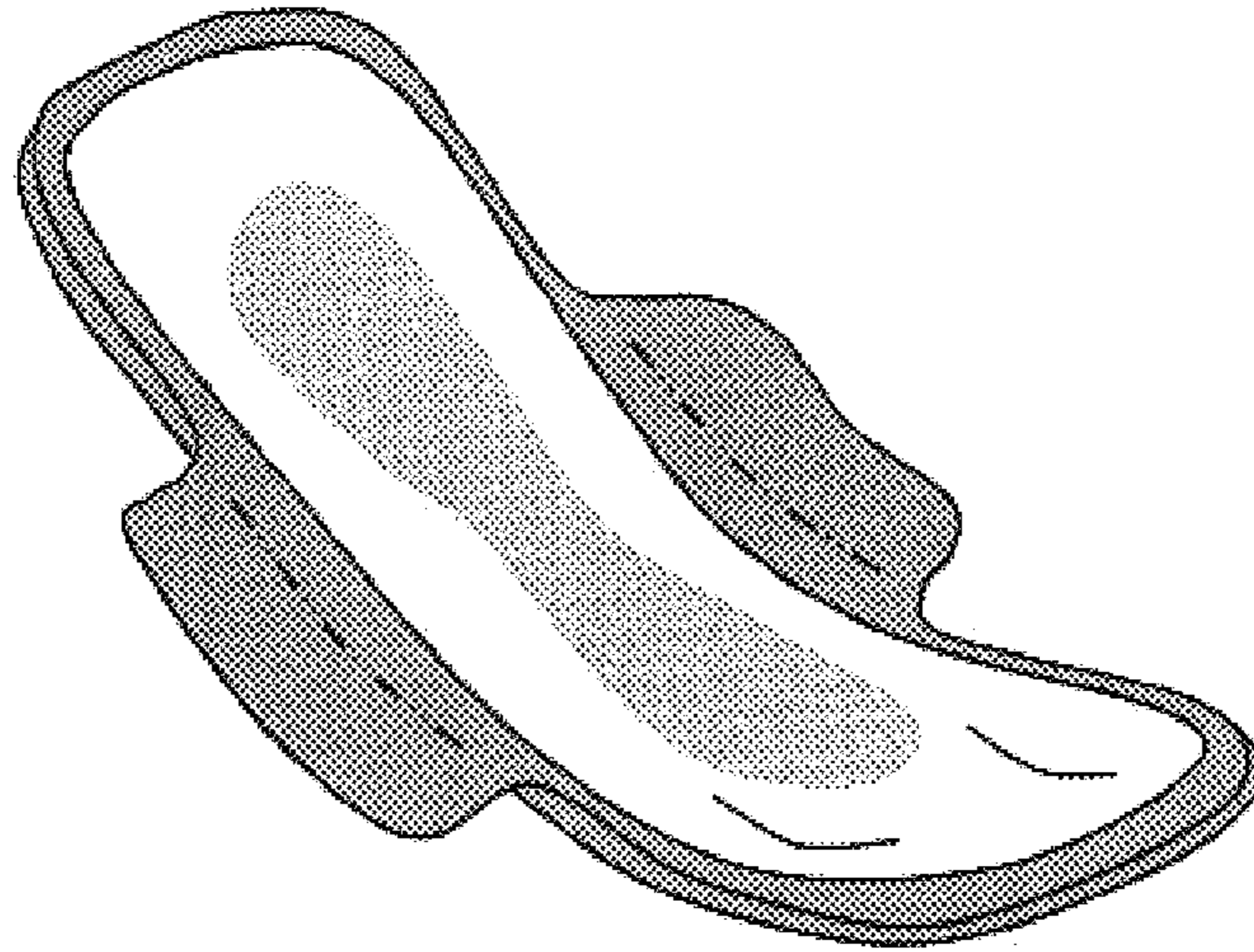

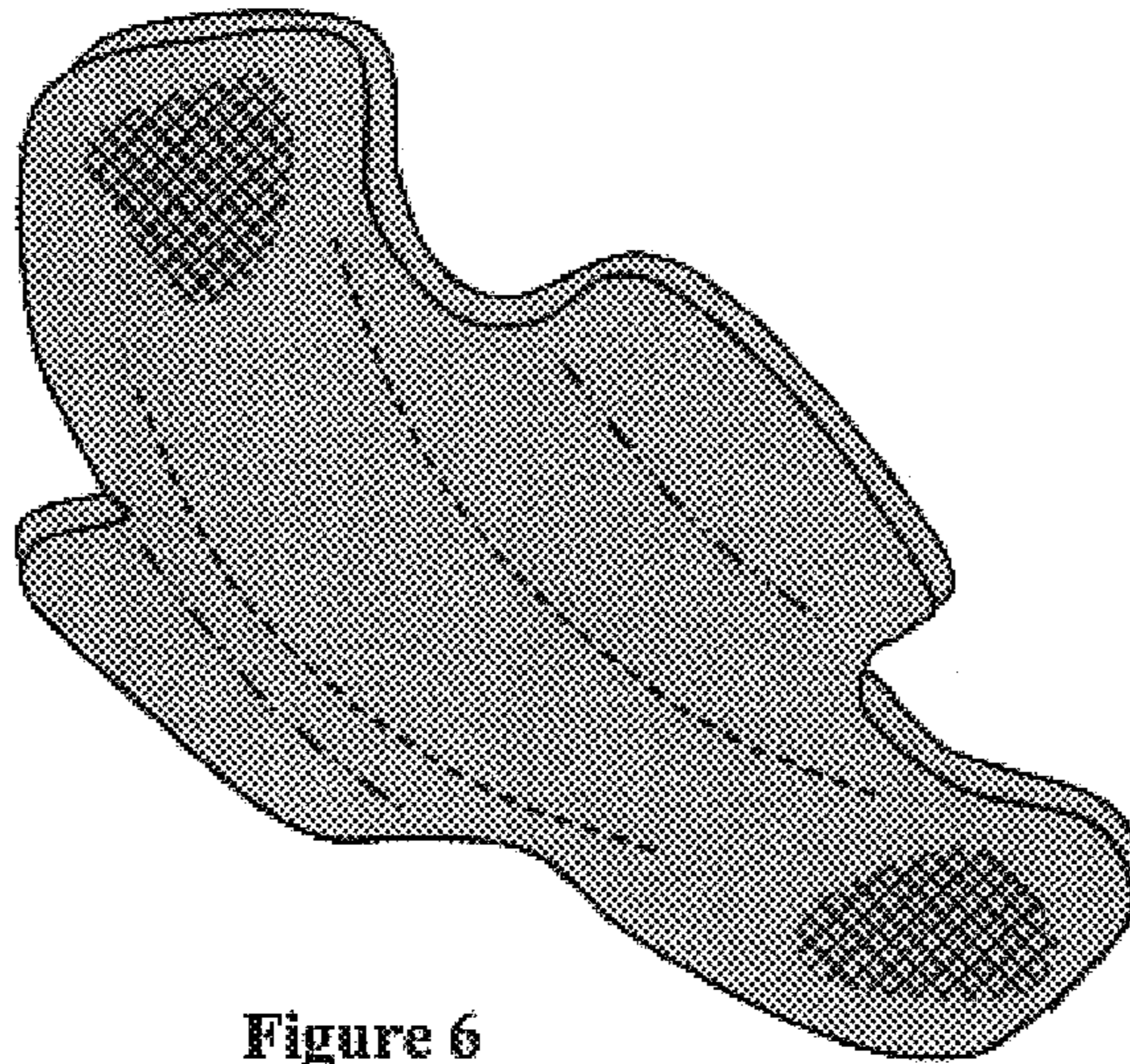

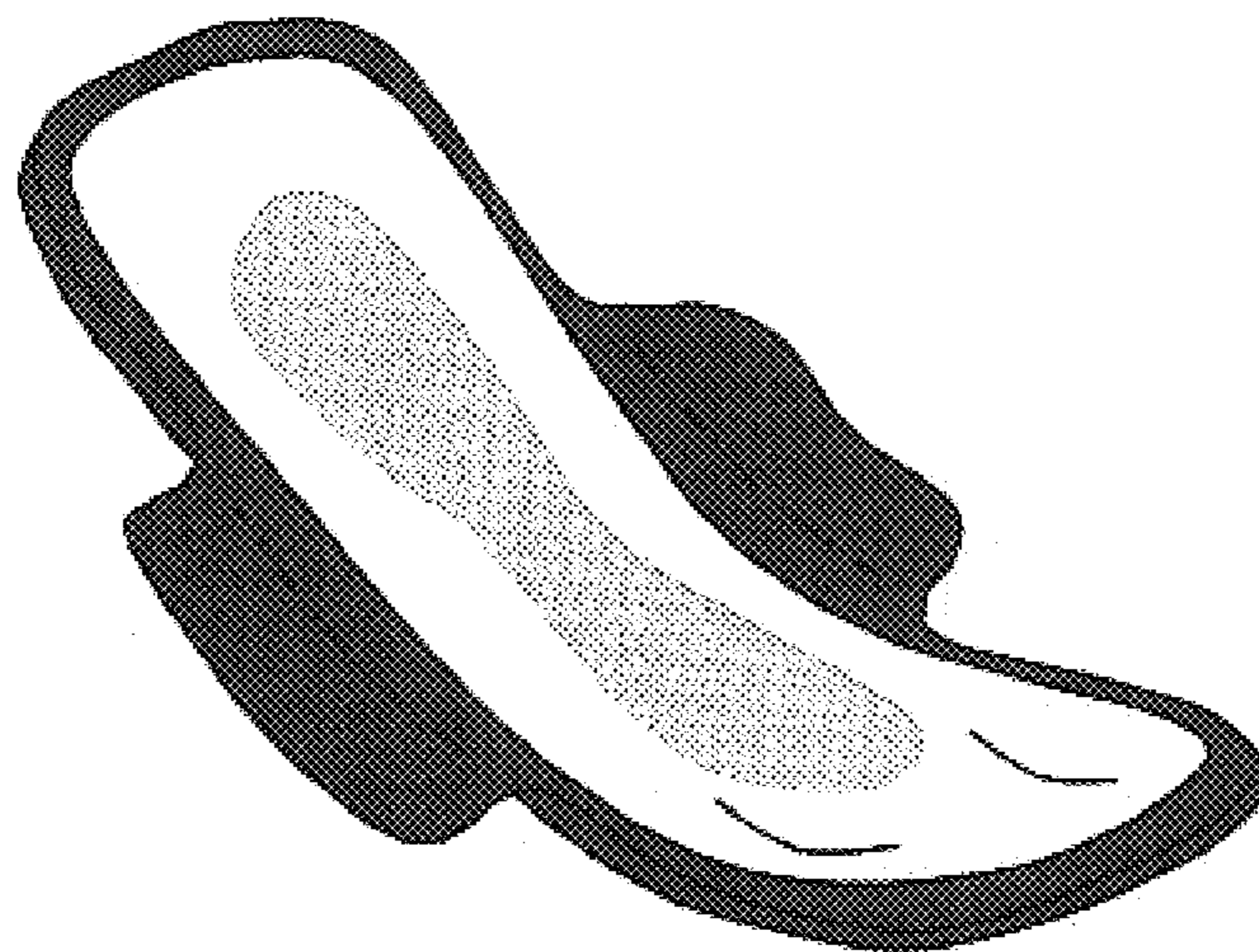

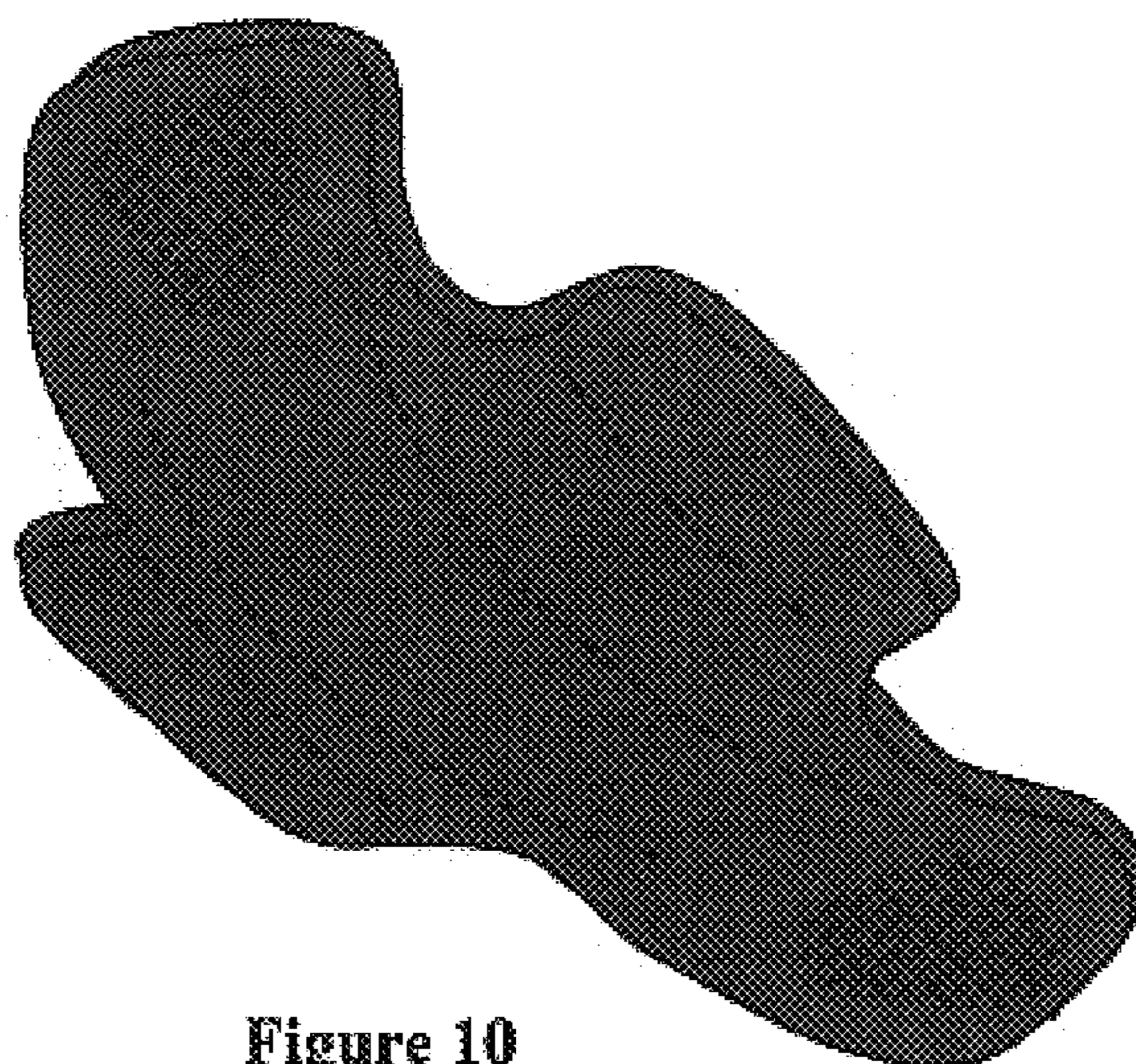

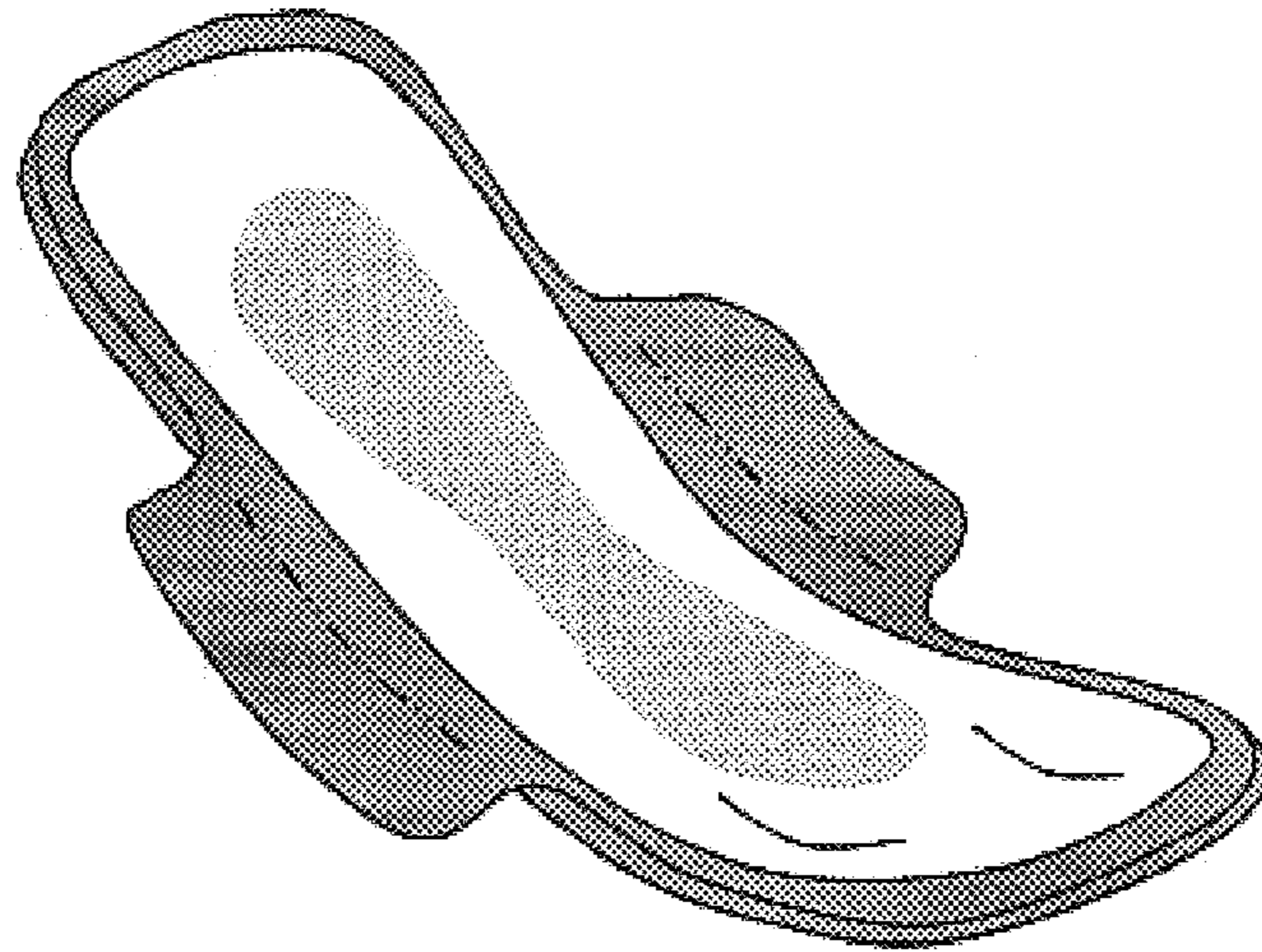

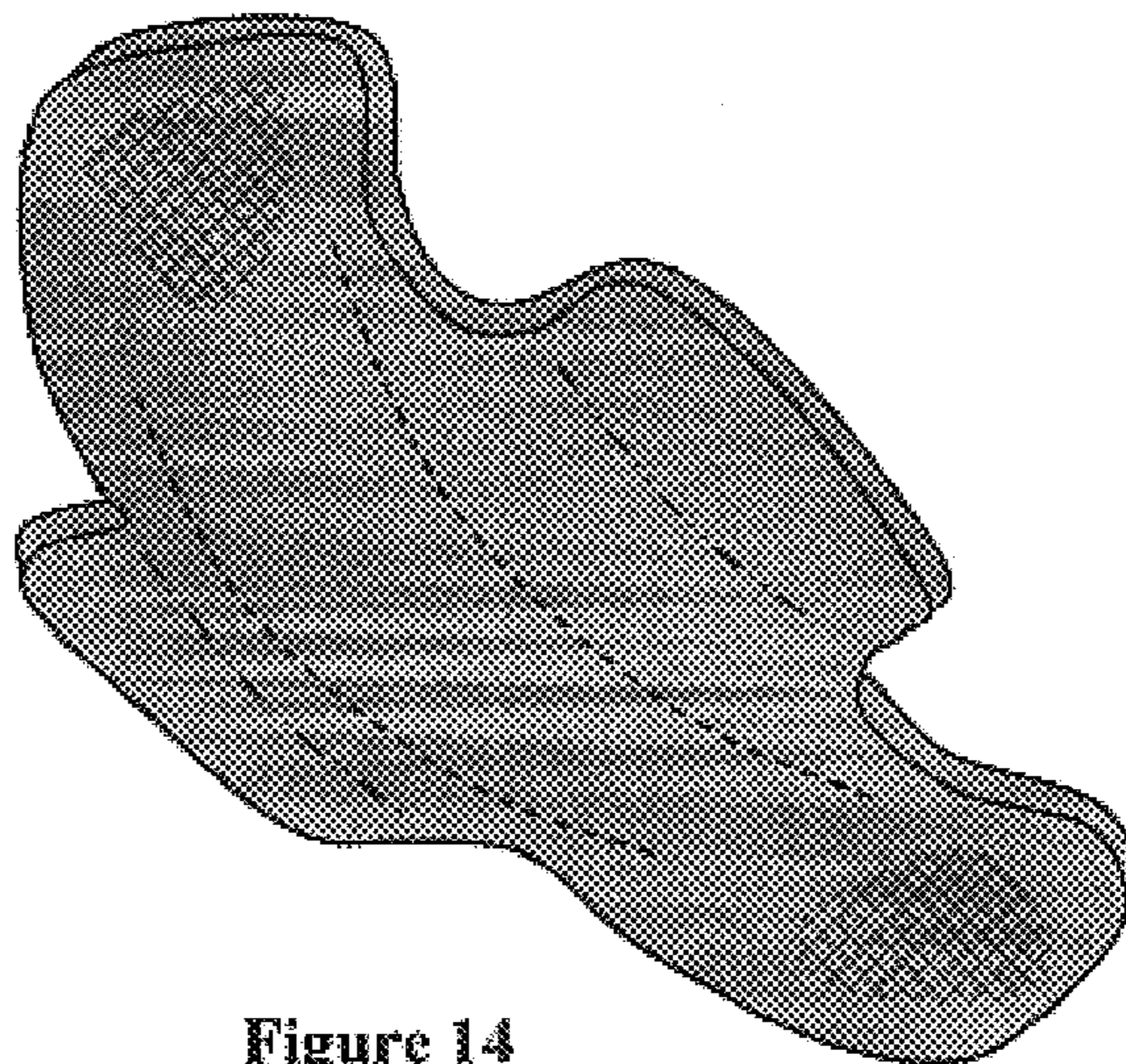

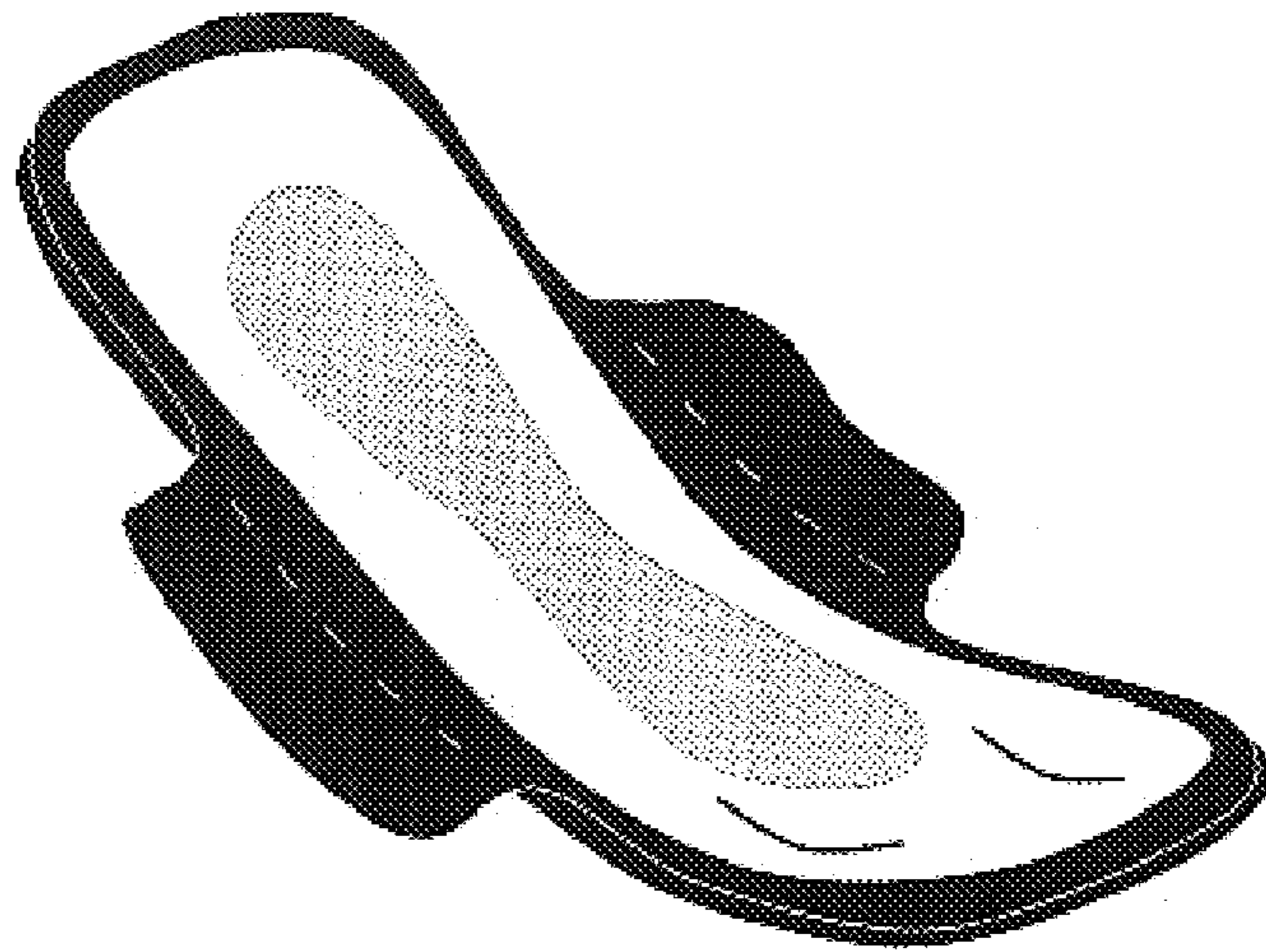

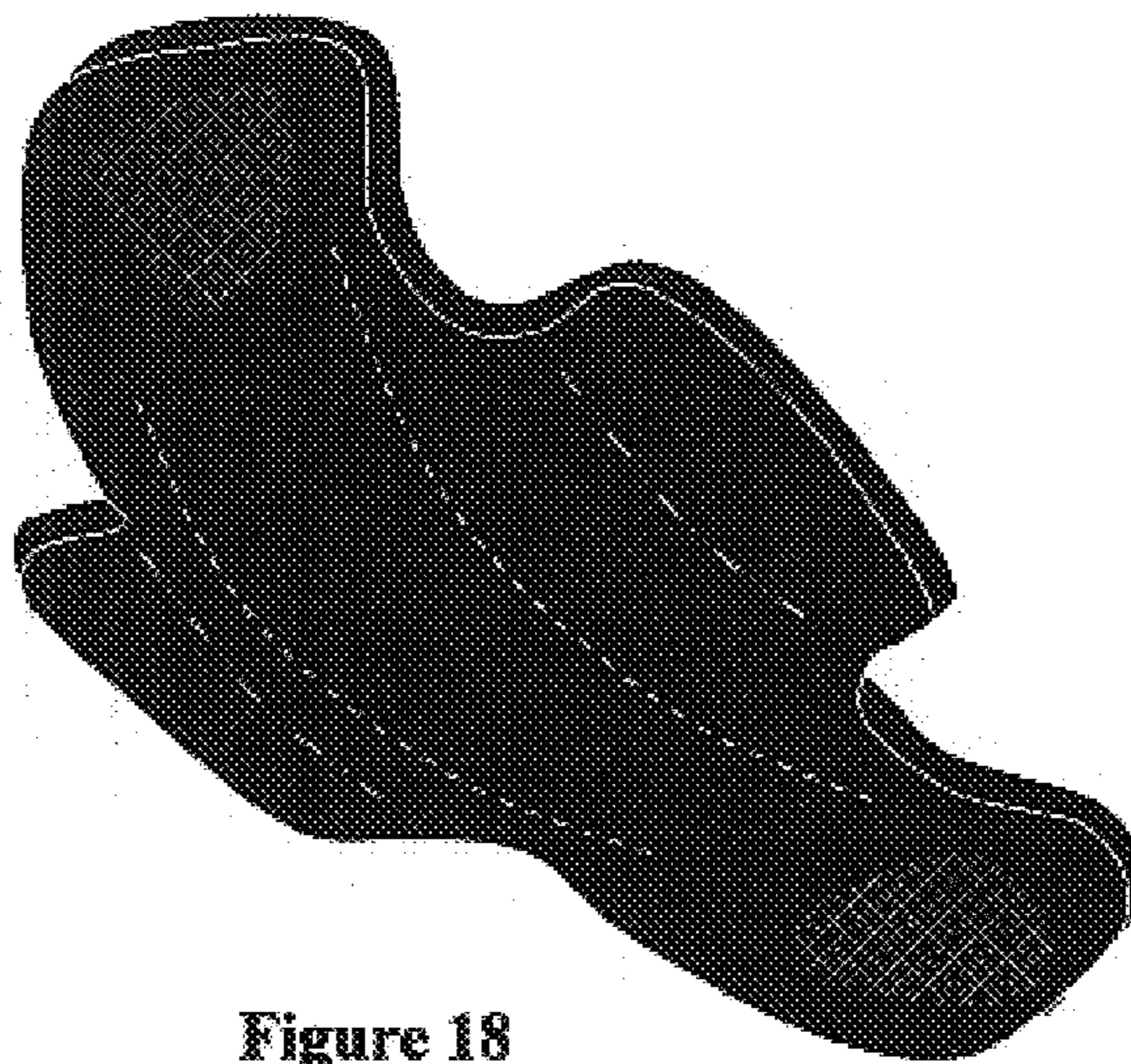
