(57) **CLAIM**

We claim the ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the light fixture showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

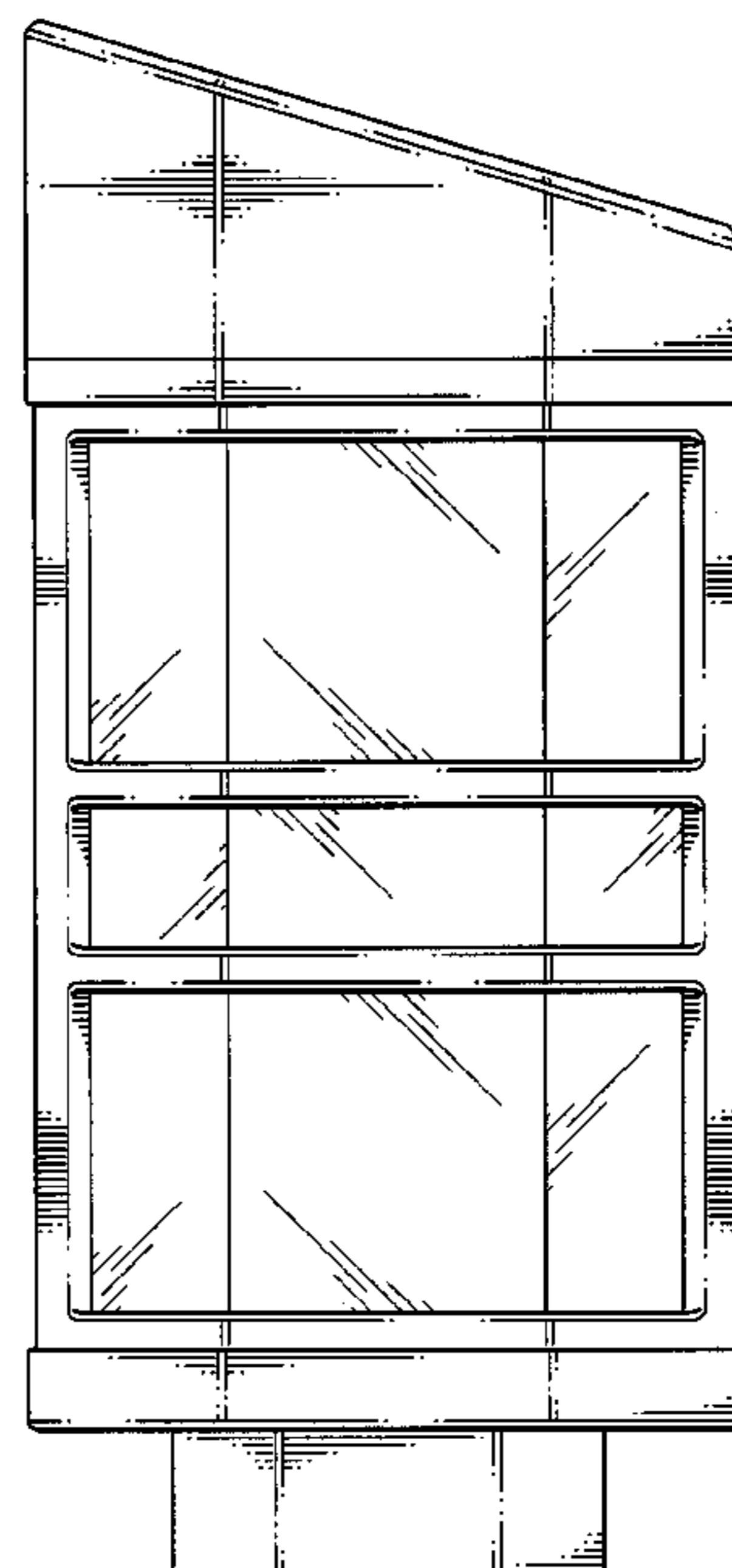
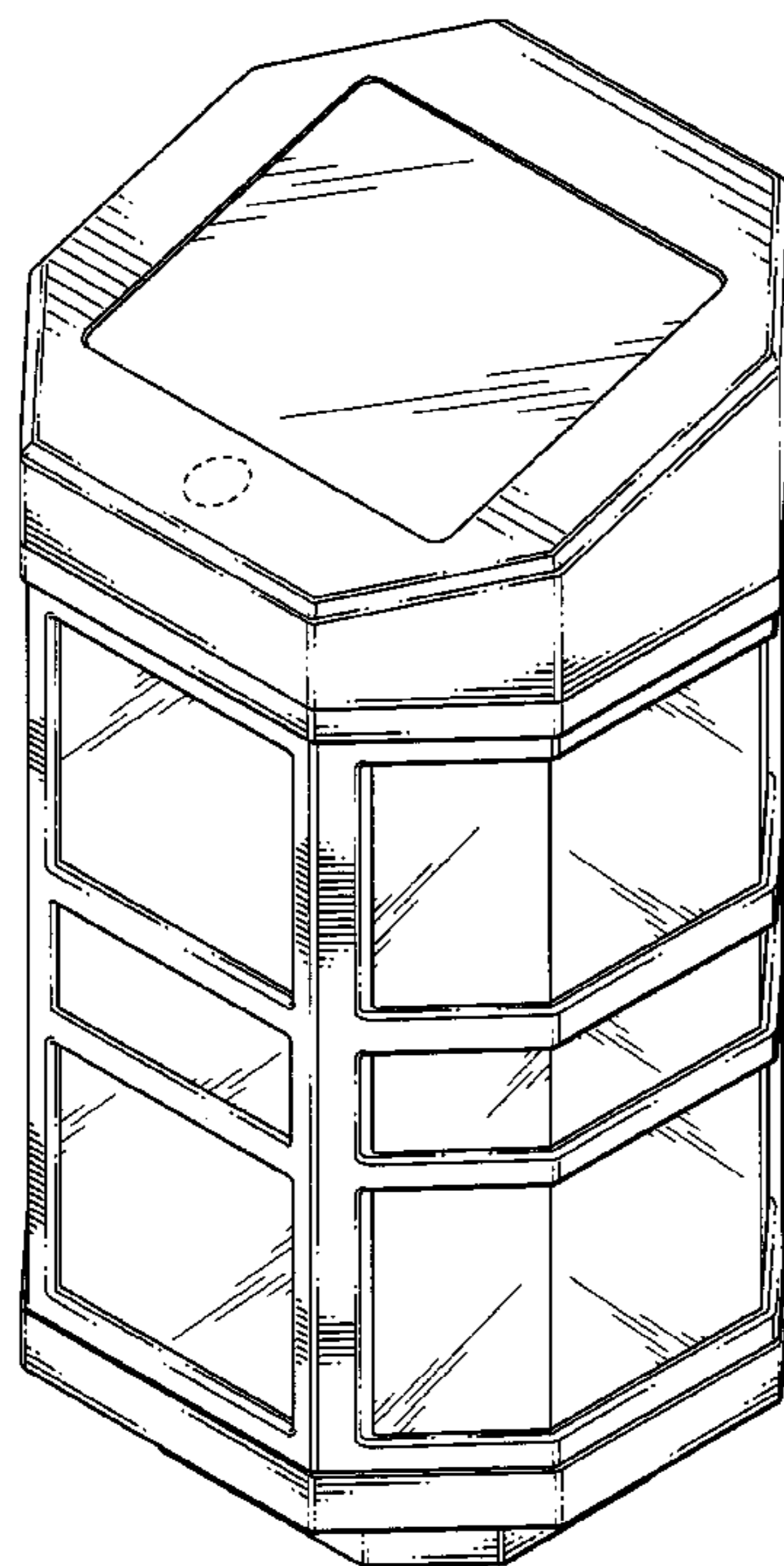
FIG. 4 is a rear elevational view thereof;

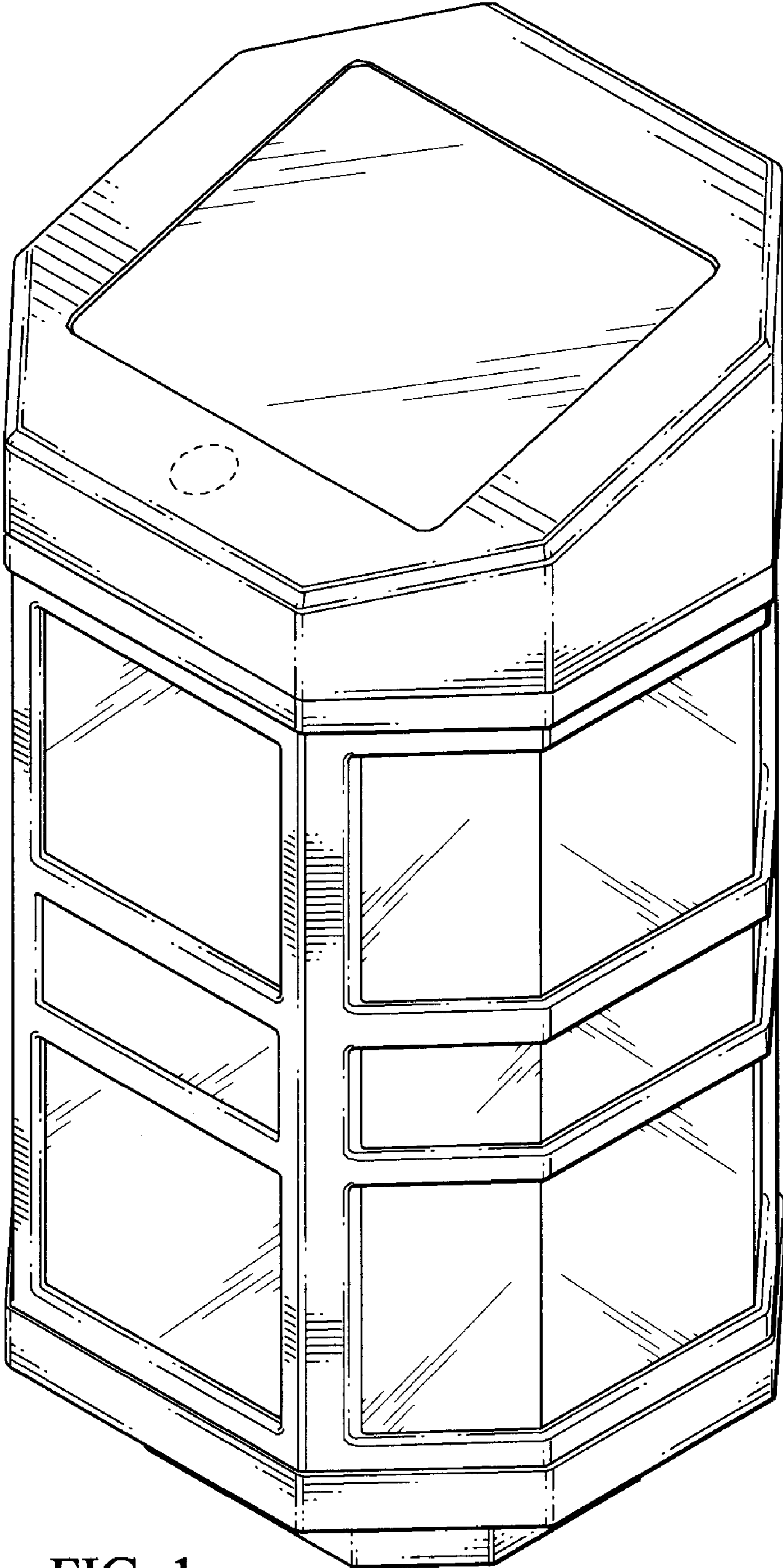

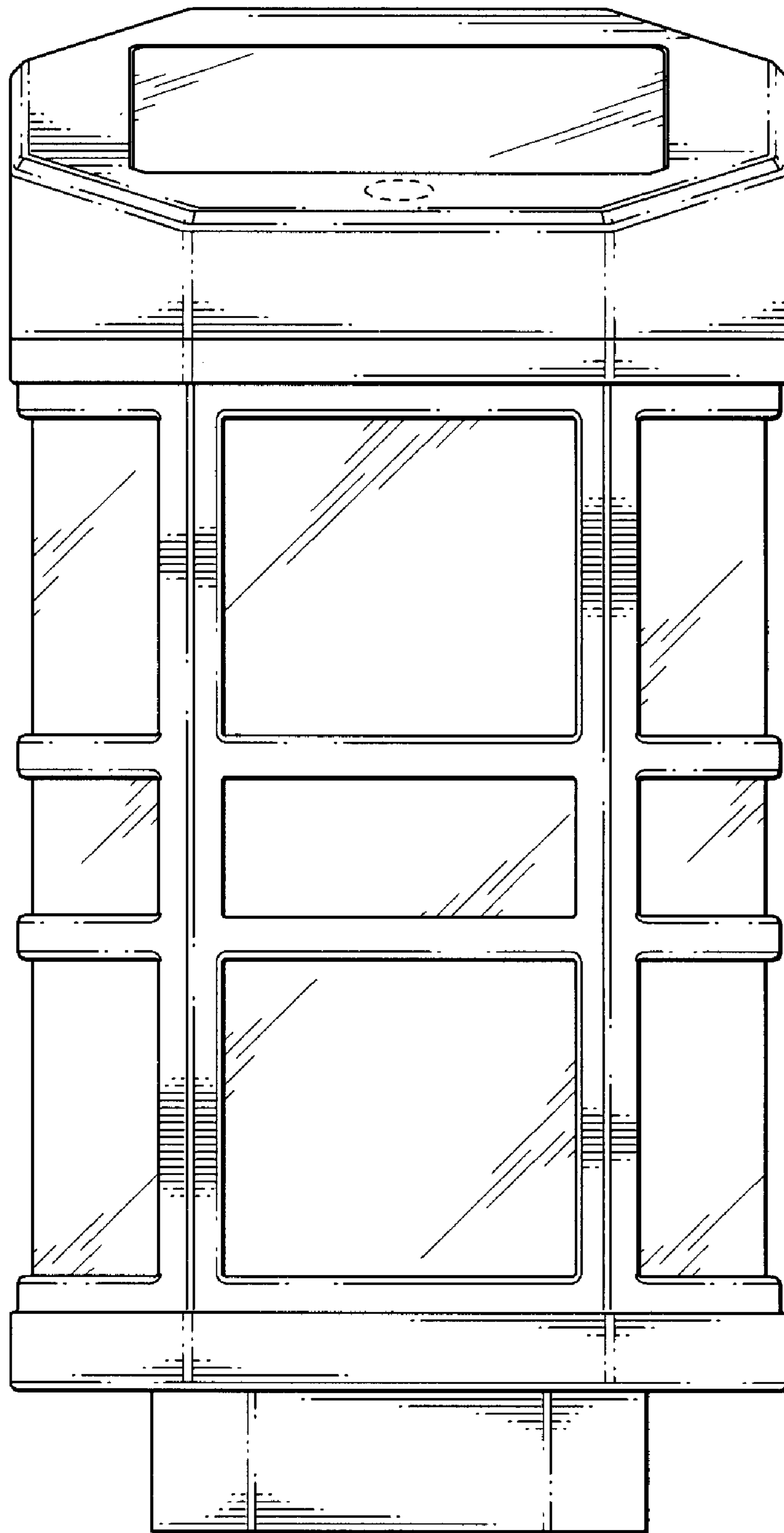

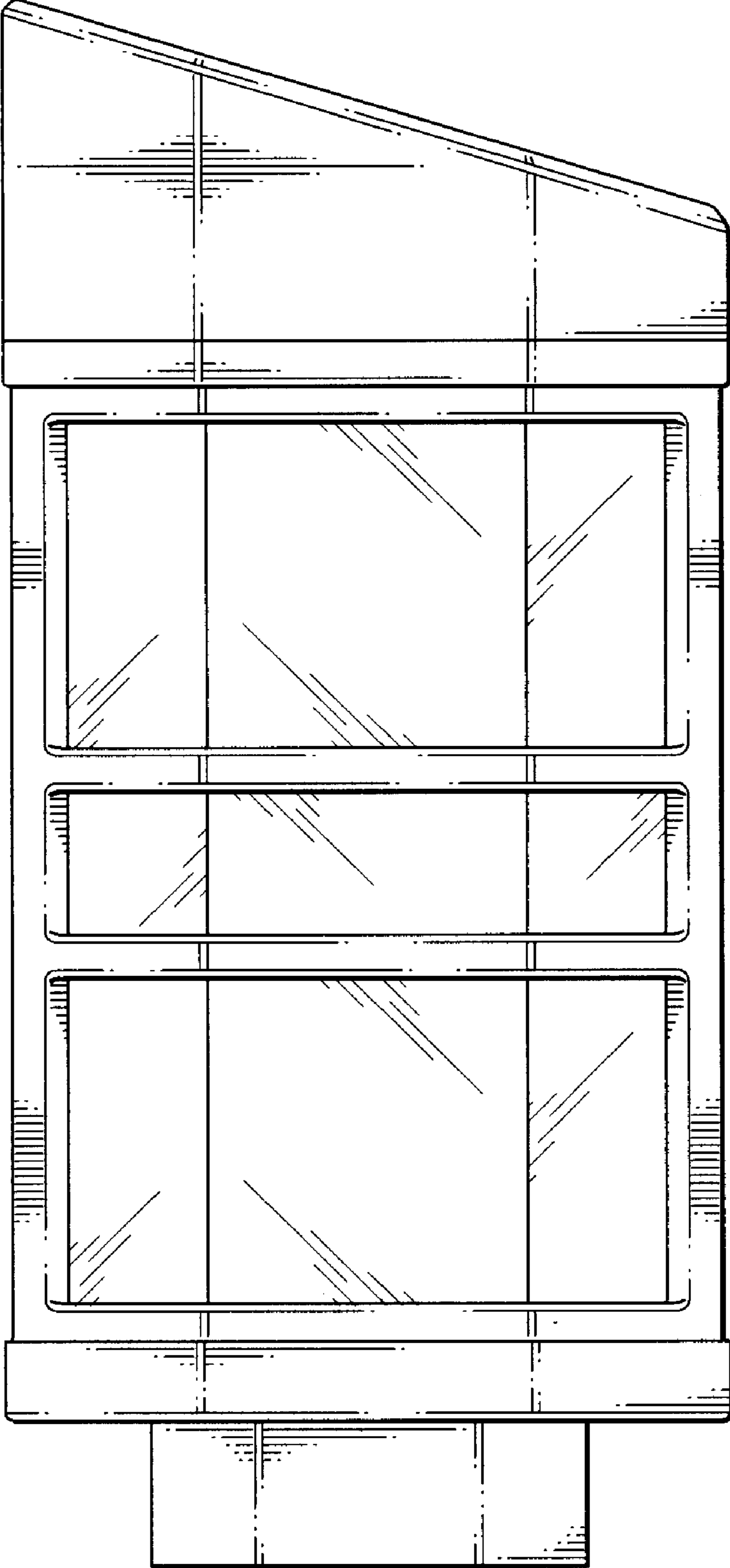

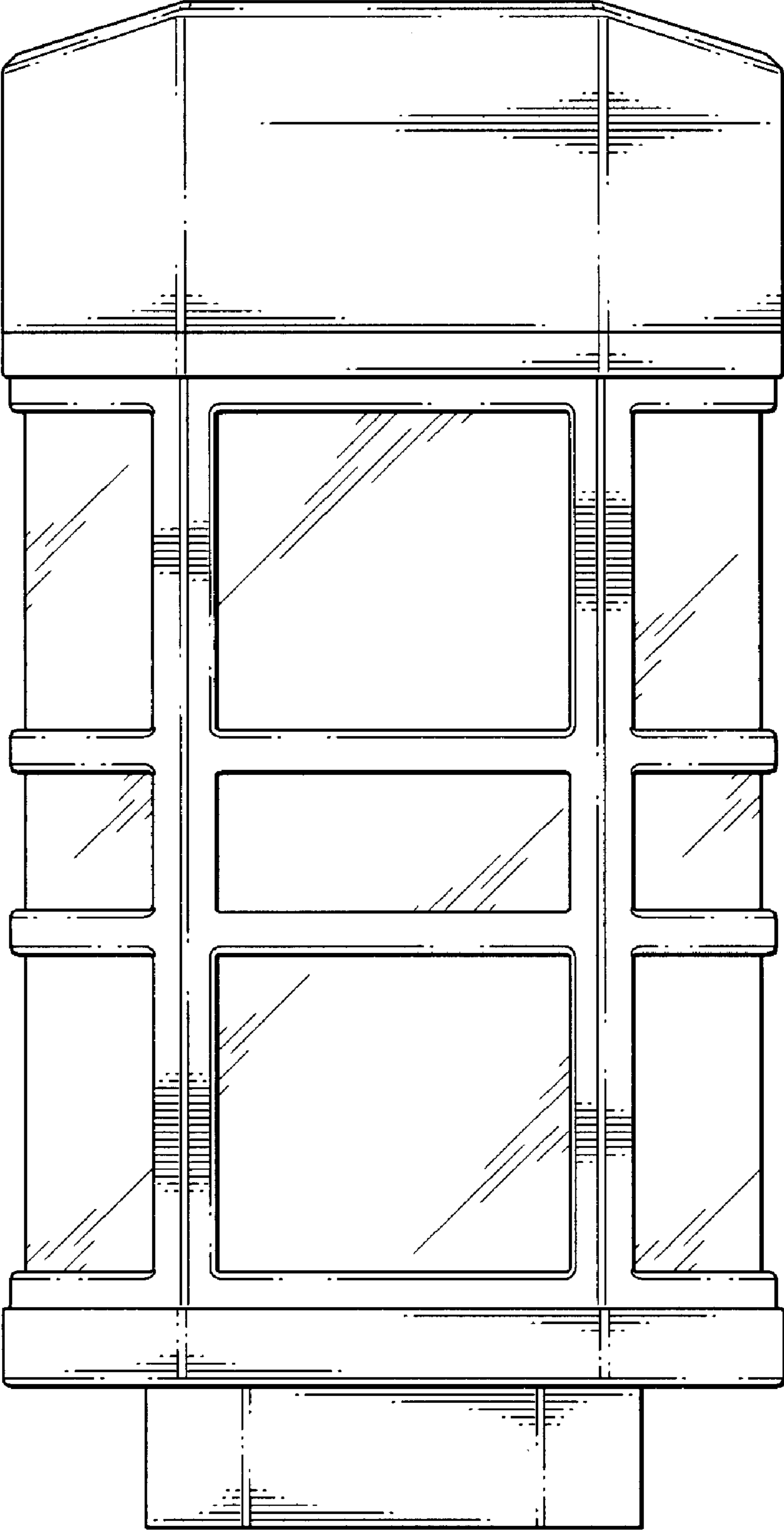

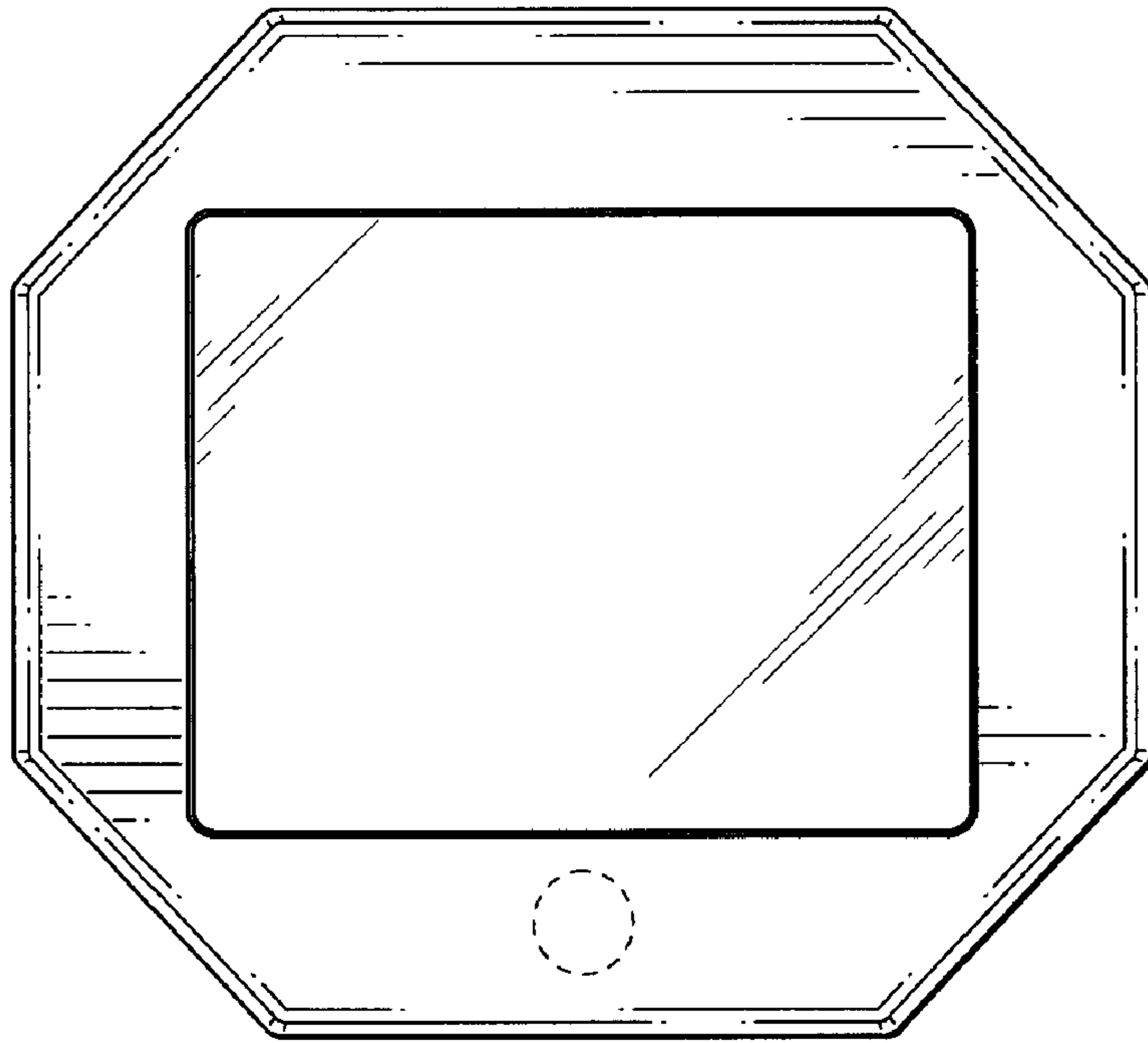

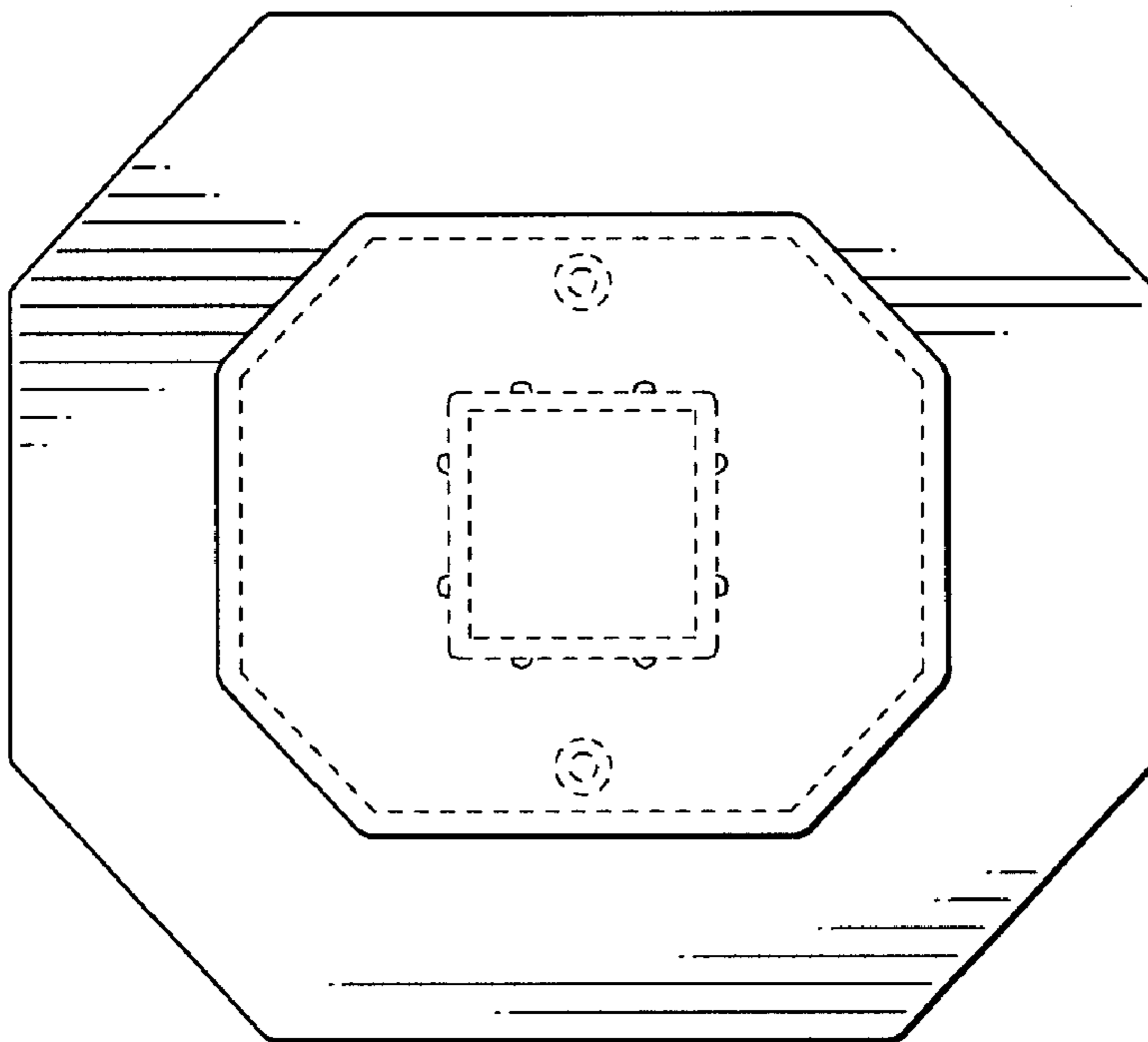
