(57) **CLAIM**

The ornamental design for a disposable non-woven cleaning wipe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a disposable non-woven cleaning wipe, embodying the new design;

FIG. 2 is a rear view thereof, the opposite front view is a mirror image thereto;

FIG. 3 is a left view thereof;

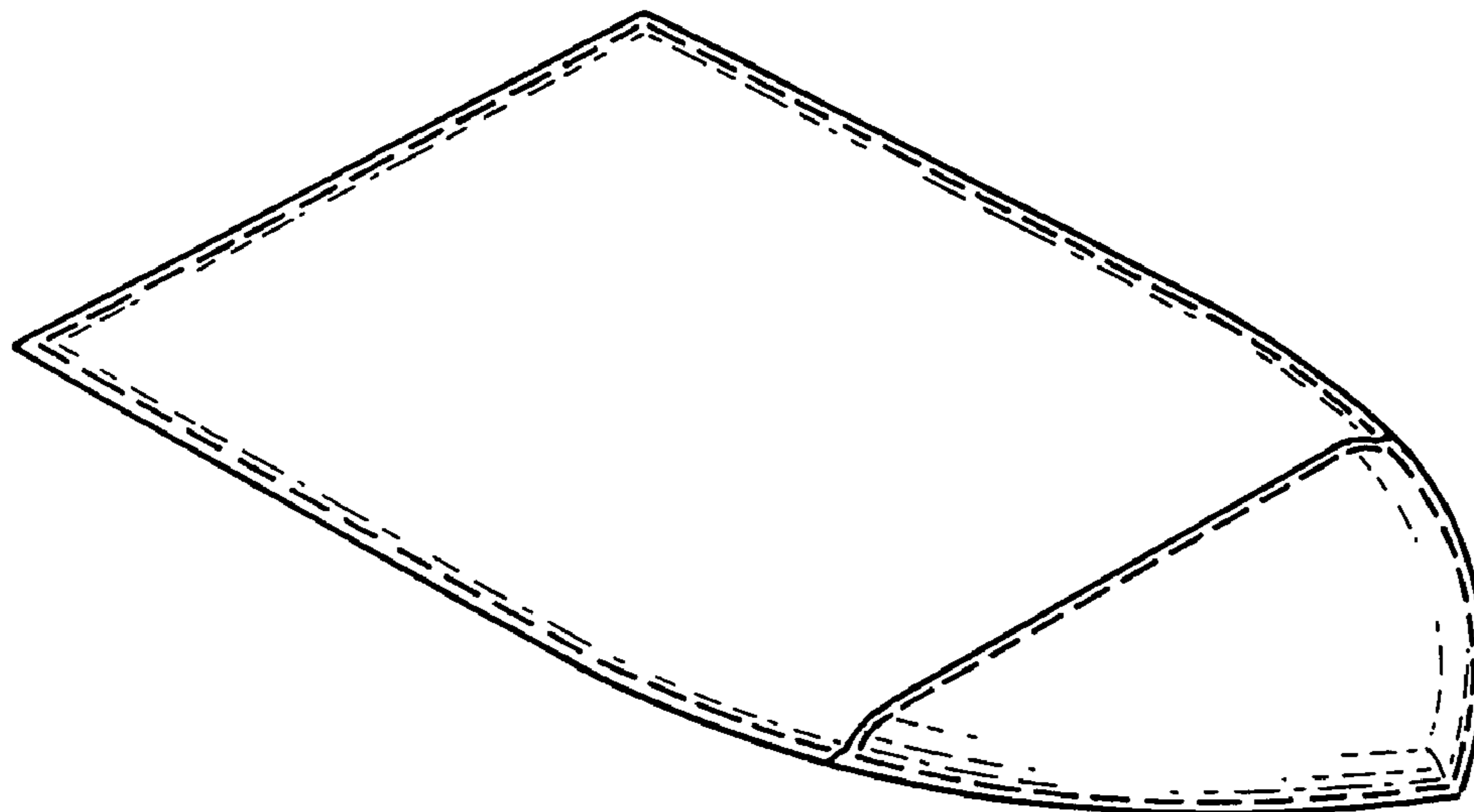
FIG. 4 is a right view thereof;

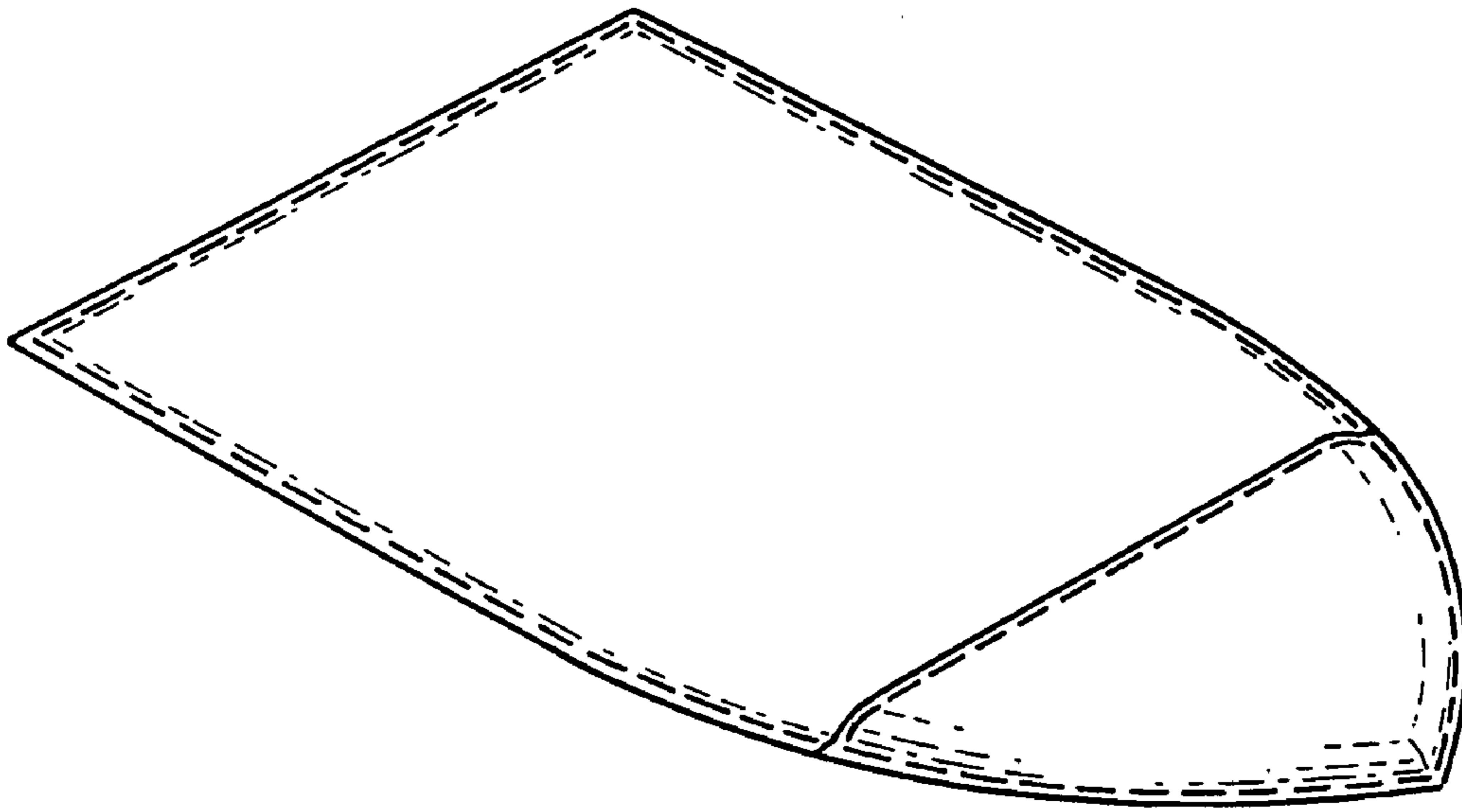

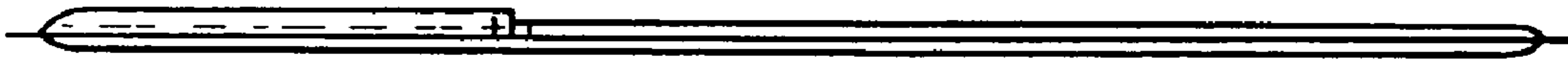

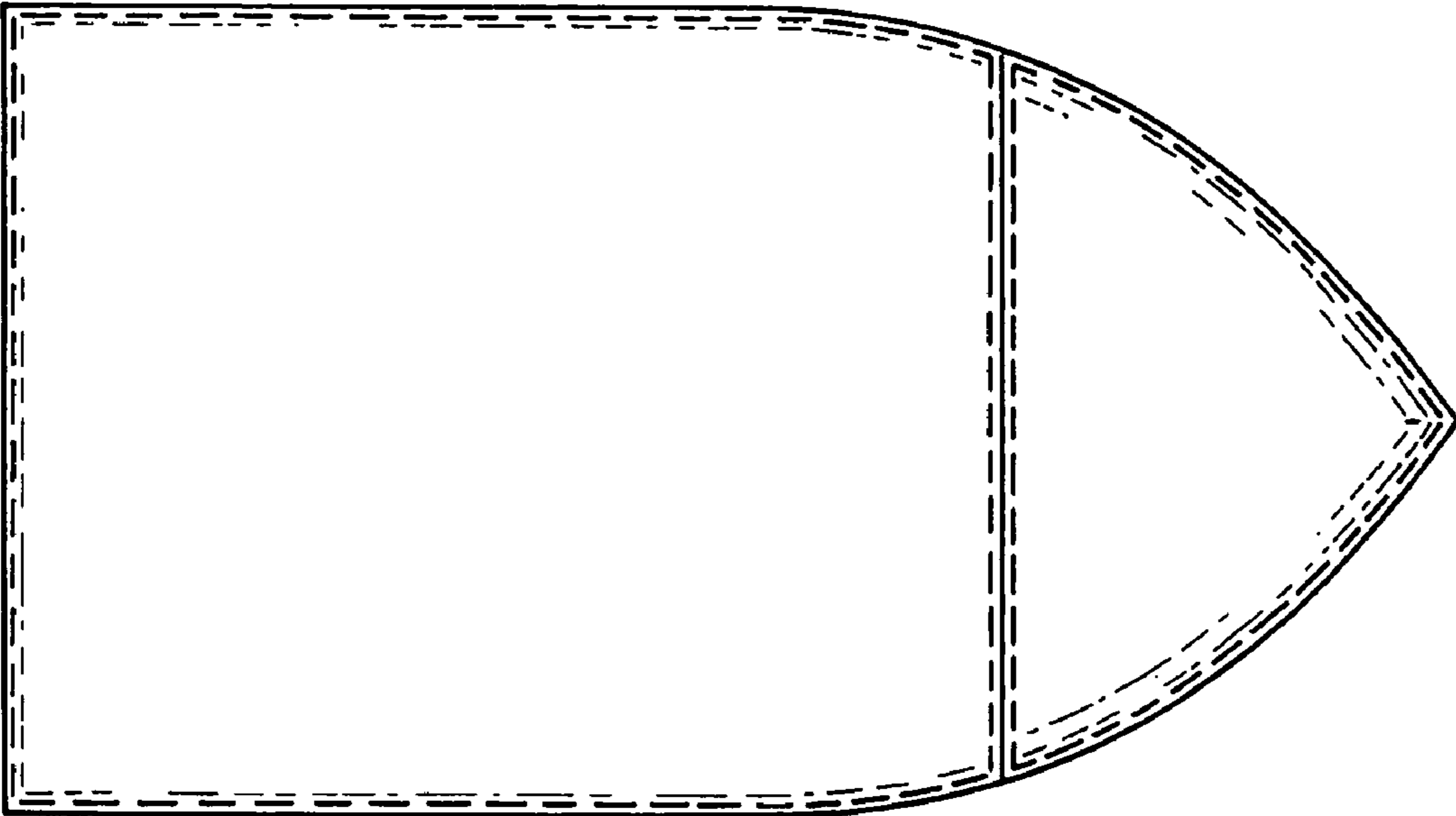

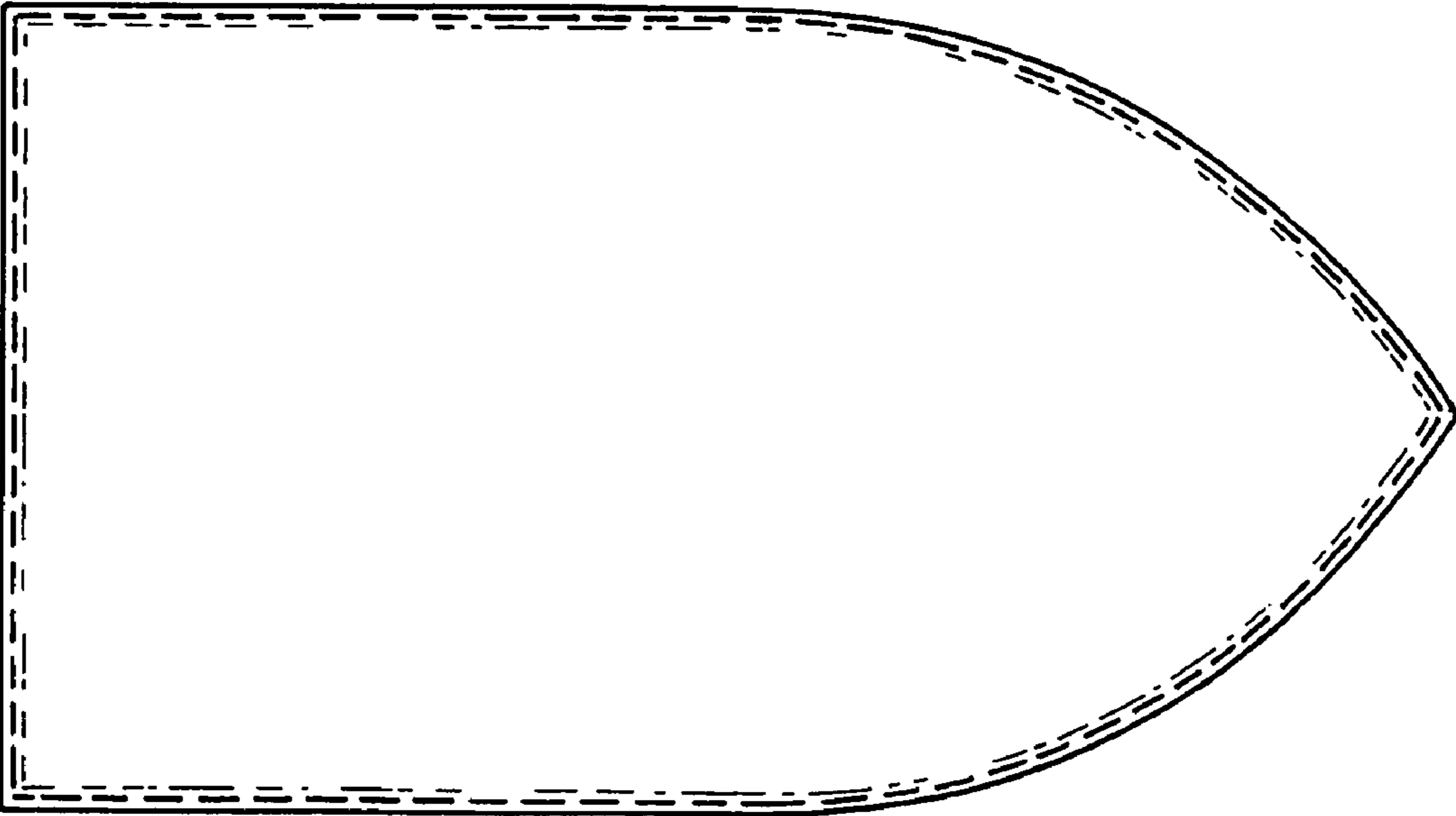
