(57) **CLAIM**

The ornamental design for a shoulder strap for use with a bag or medical device, as shown and described.

DESCRIPTION

FIG. 5 is a front view thereof;

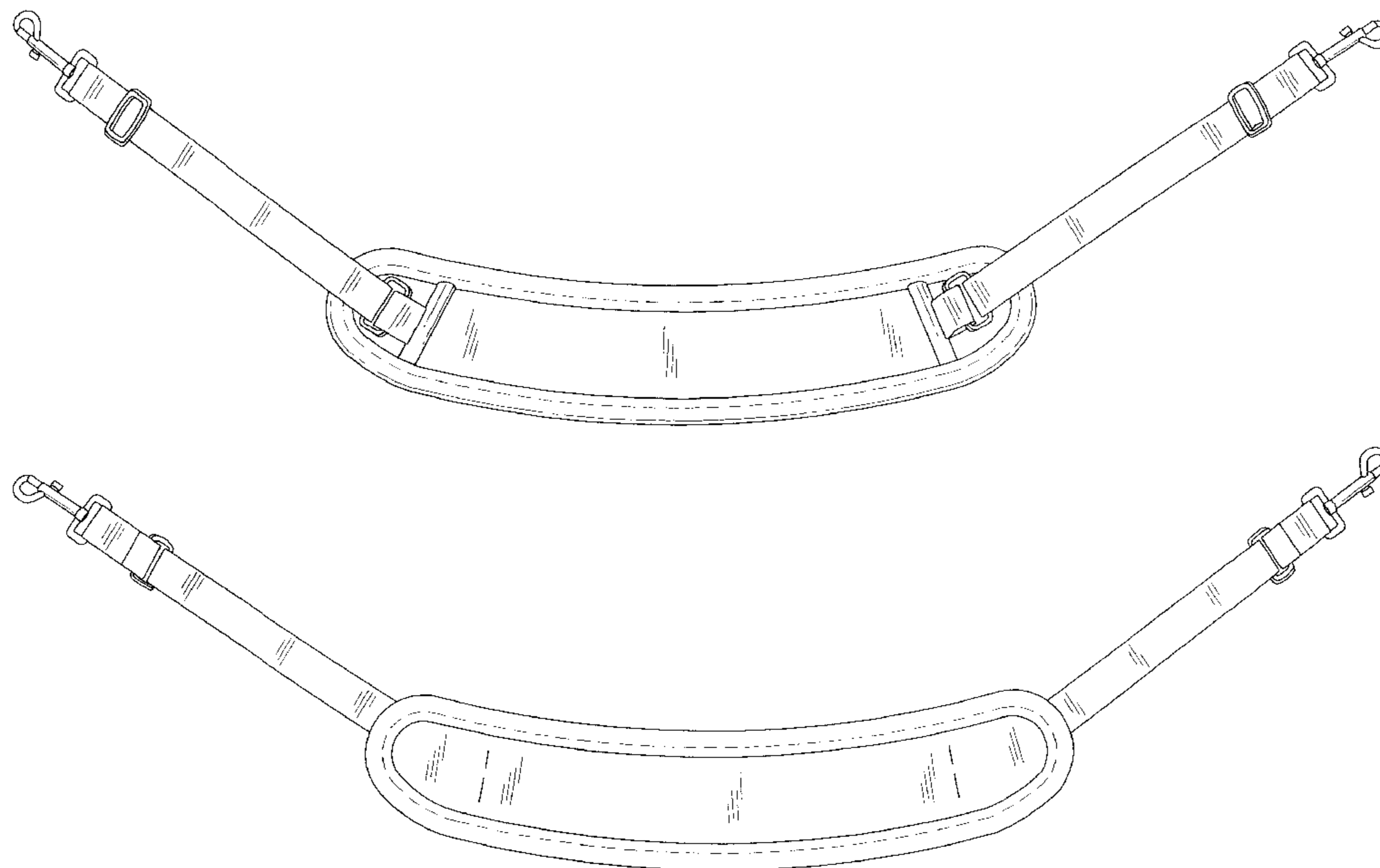
FIG. 6 is a rear view thereof;

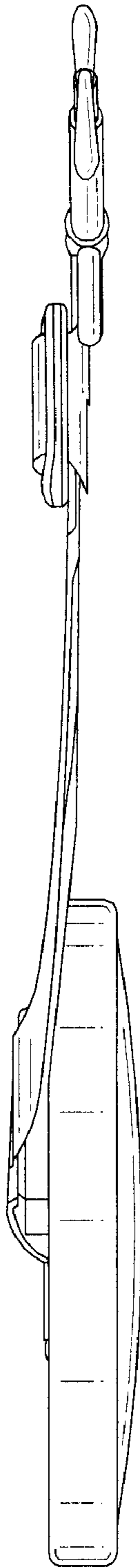

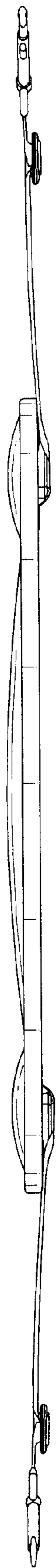

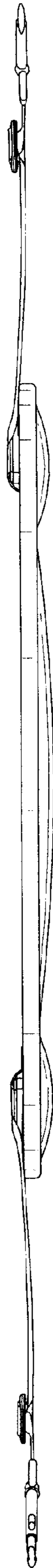

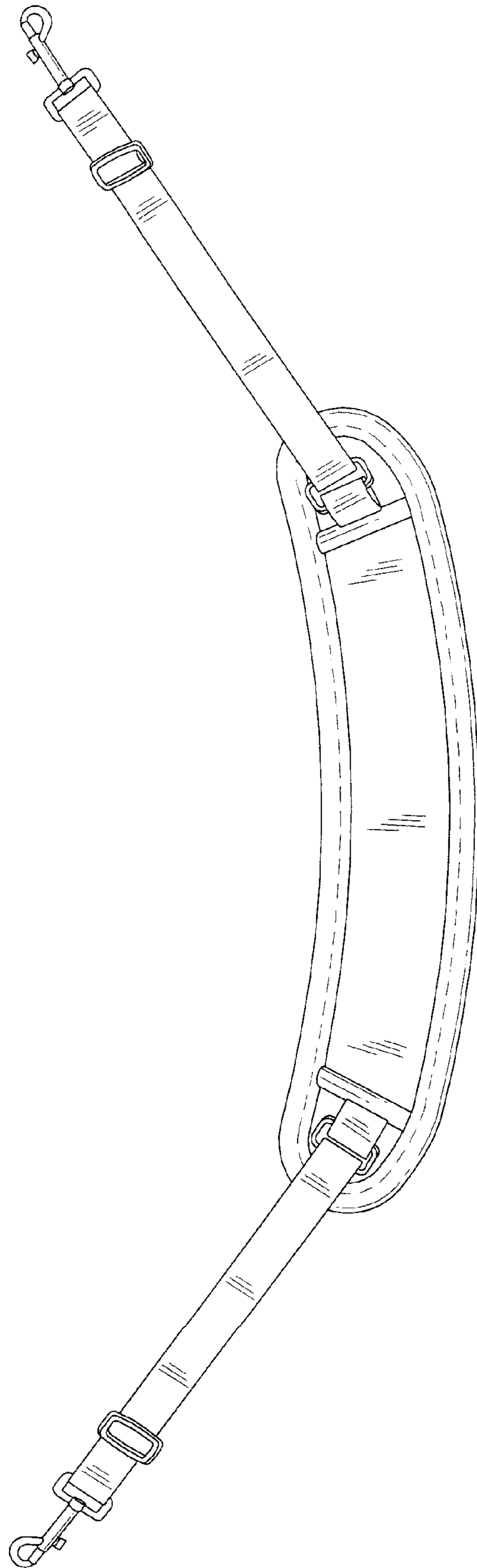

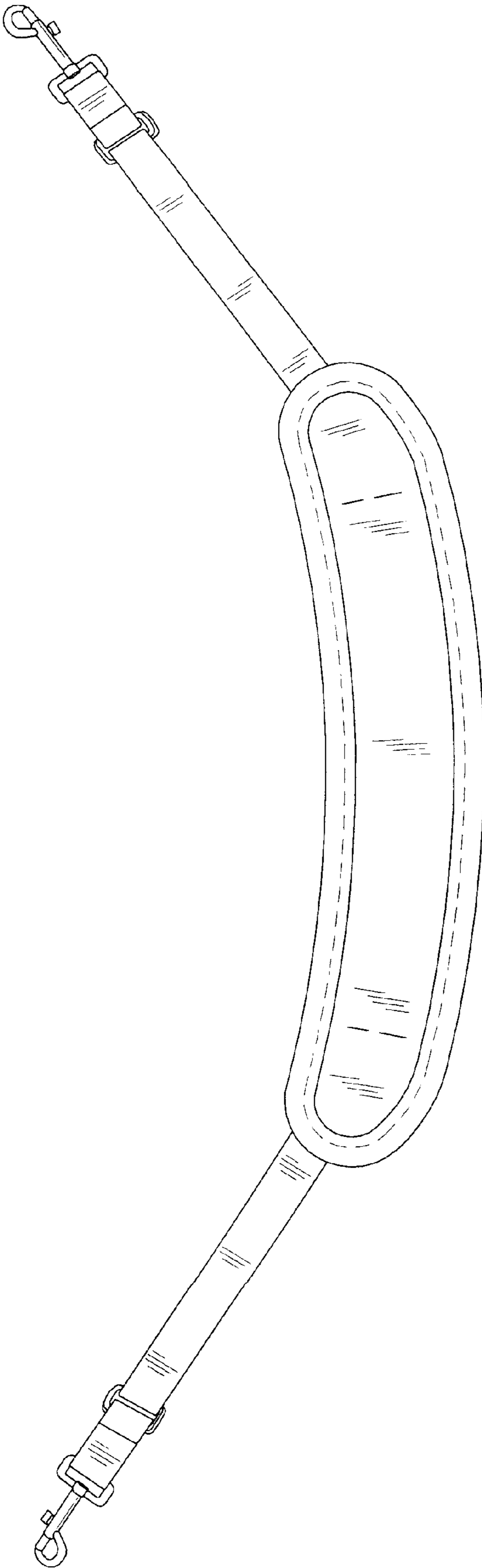

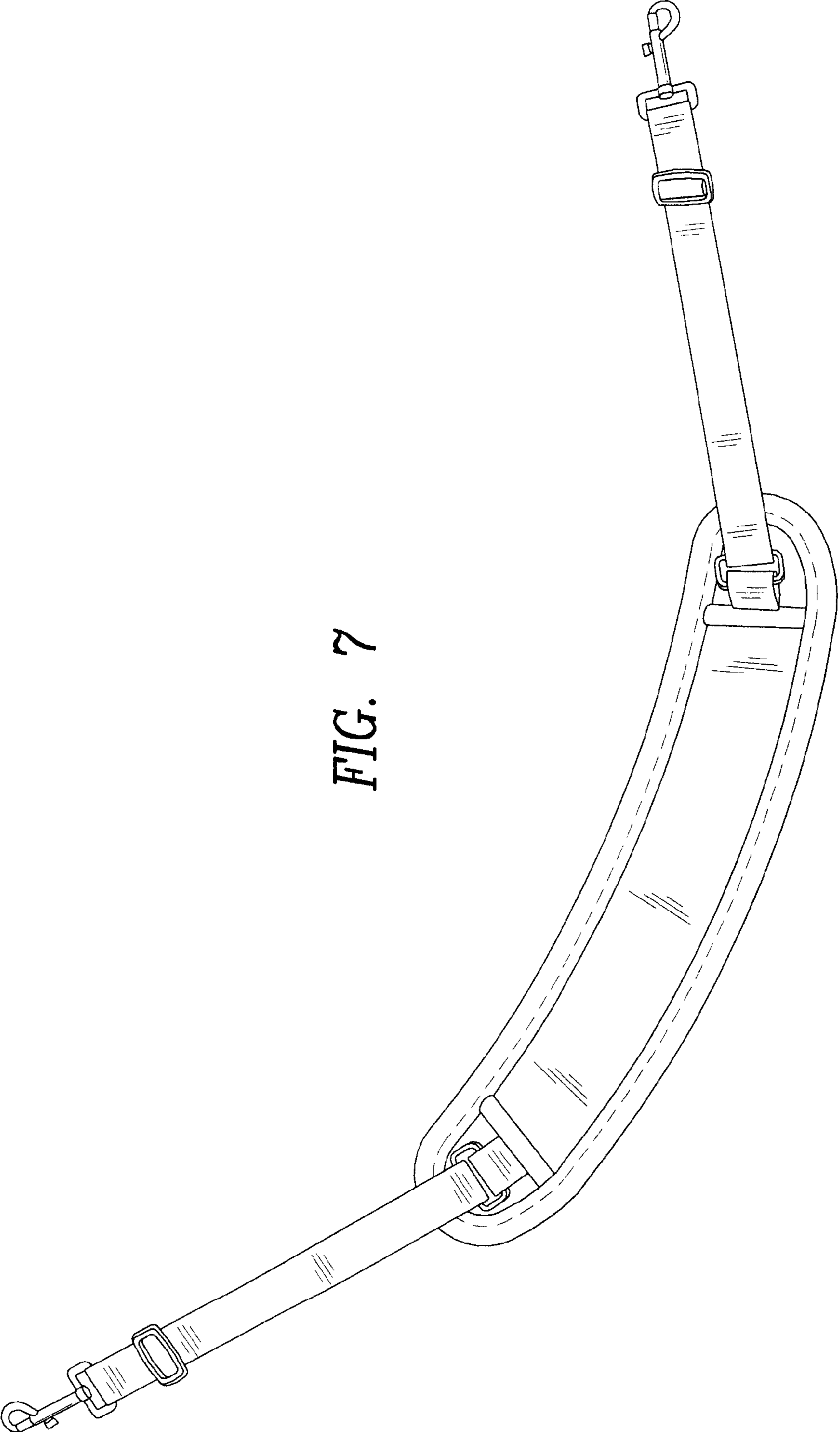

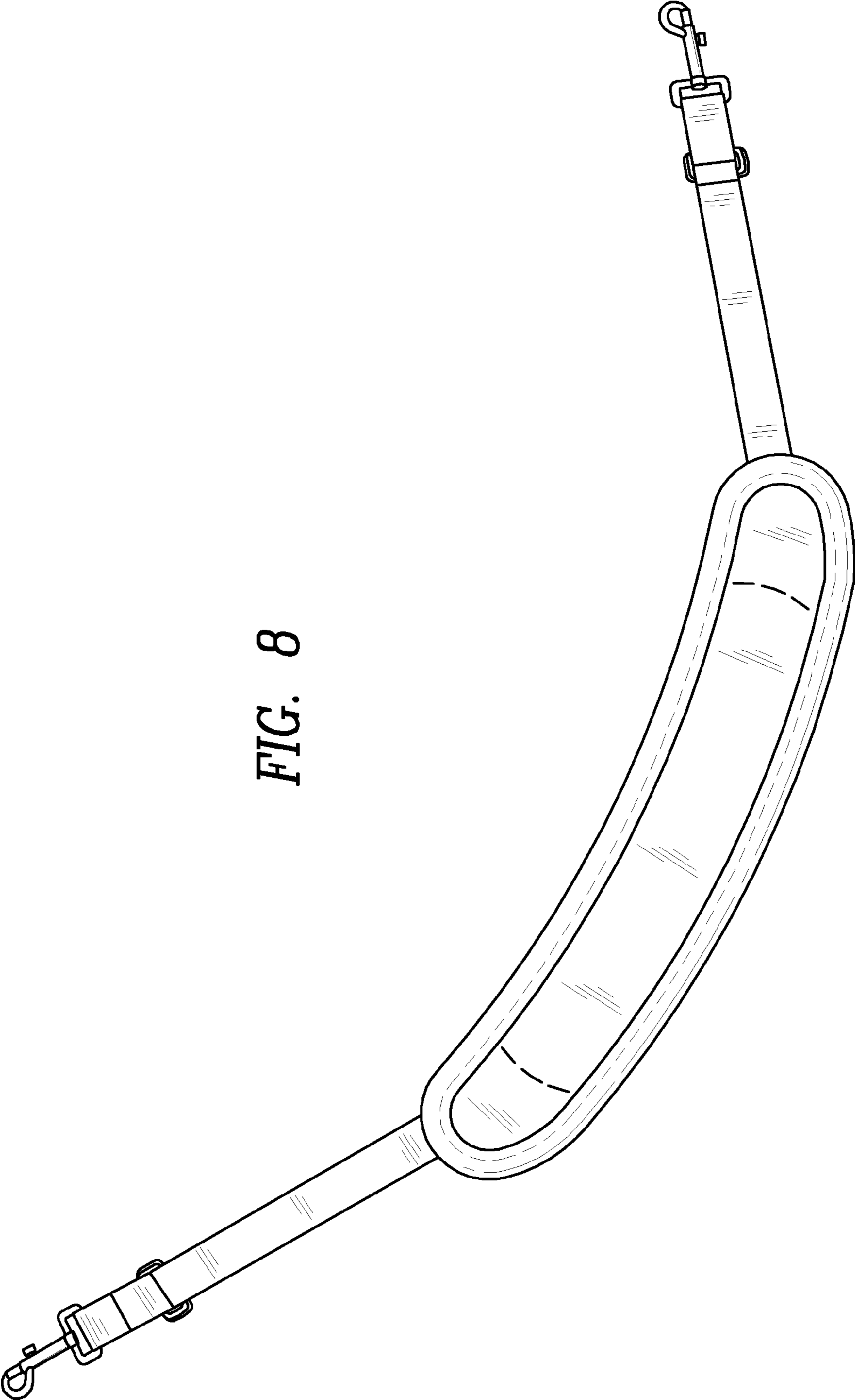
