DESCRIPTION

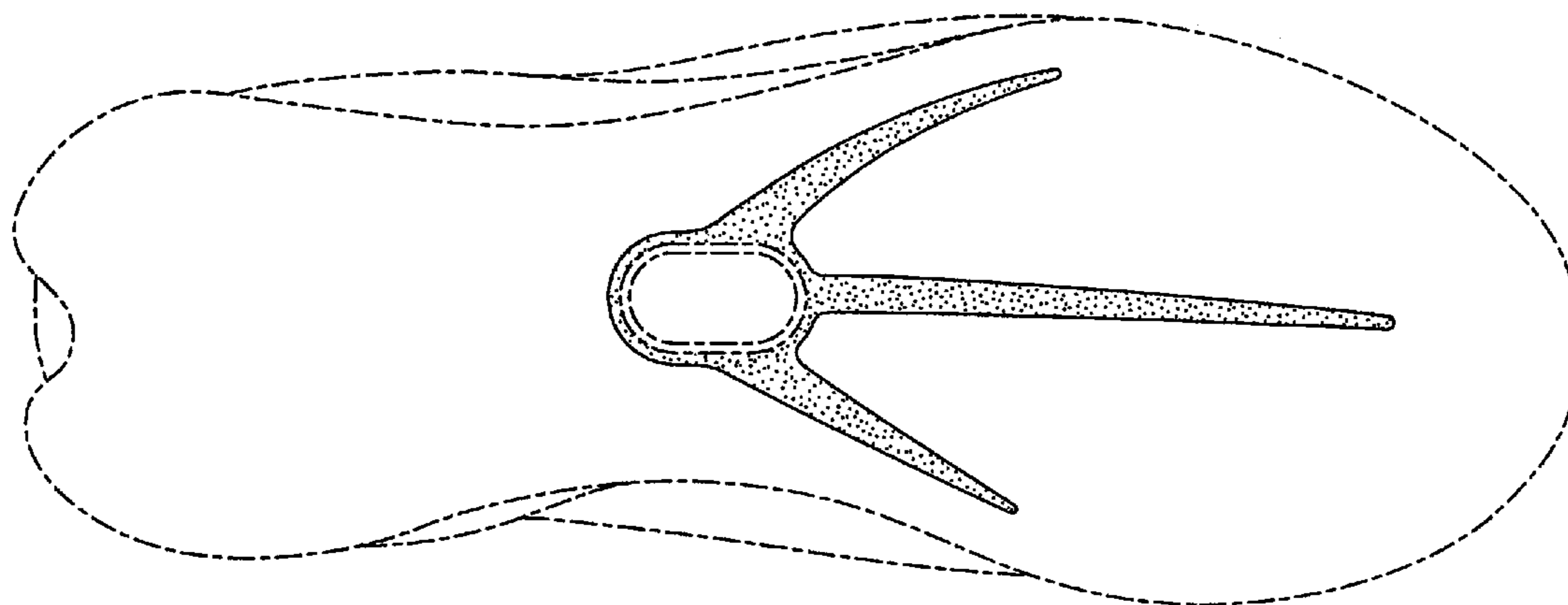
FIG. 1 is a first perspective view of a shoe outsole showing my new design;

FIG. 2 is a second perspective view thereof; and,

FIG. 3 is a bottom view thereof.

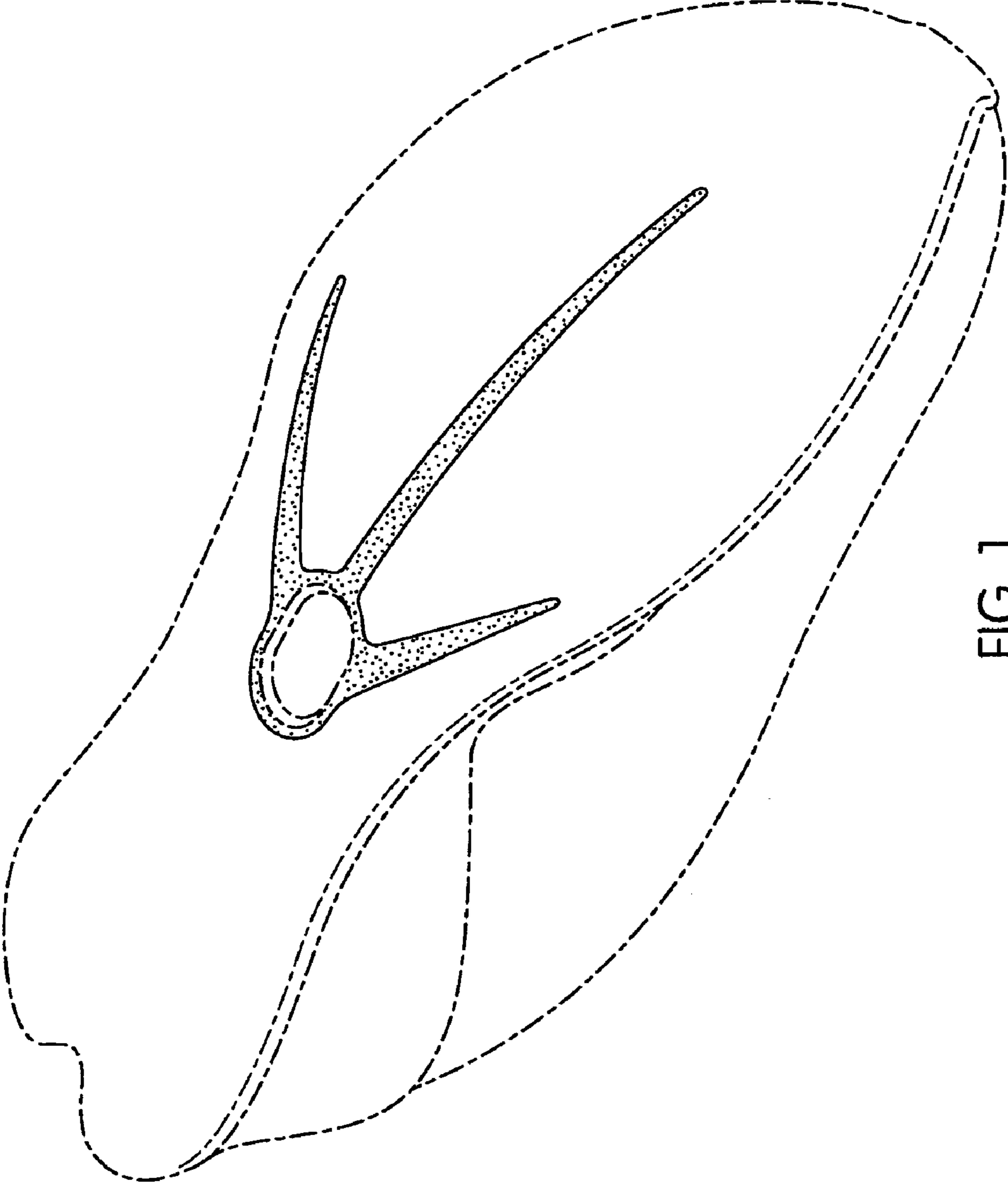

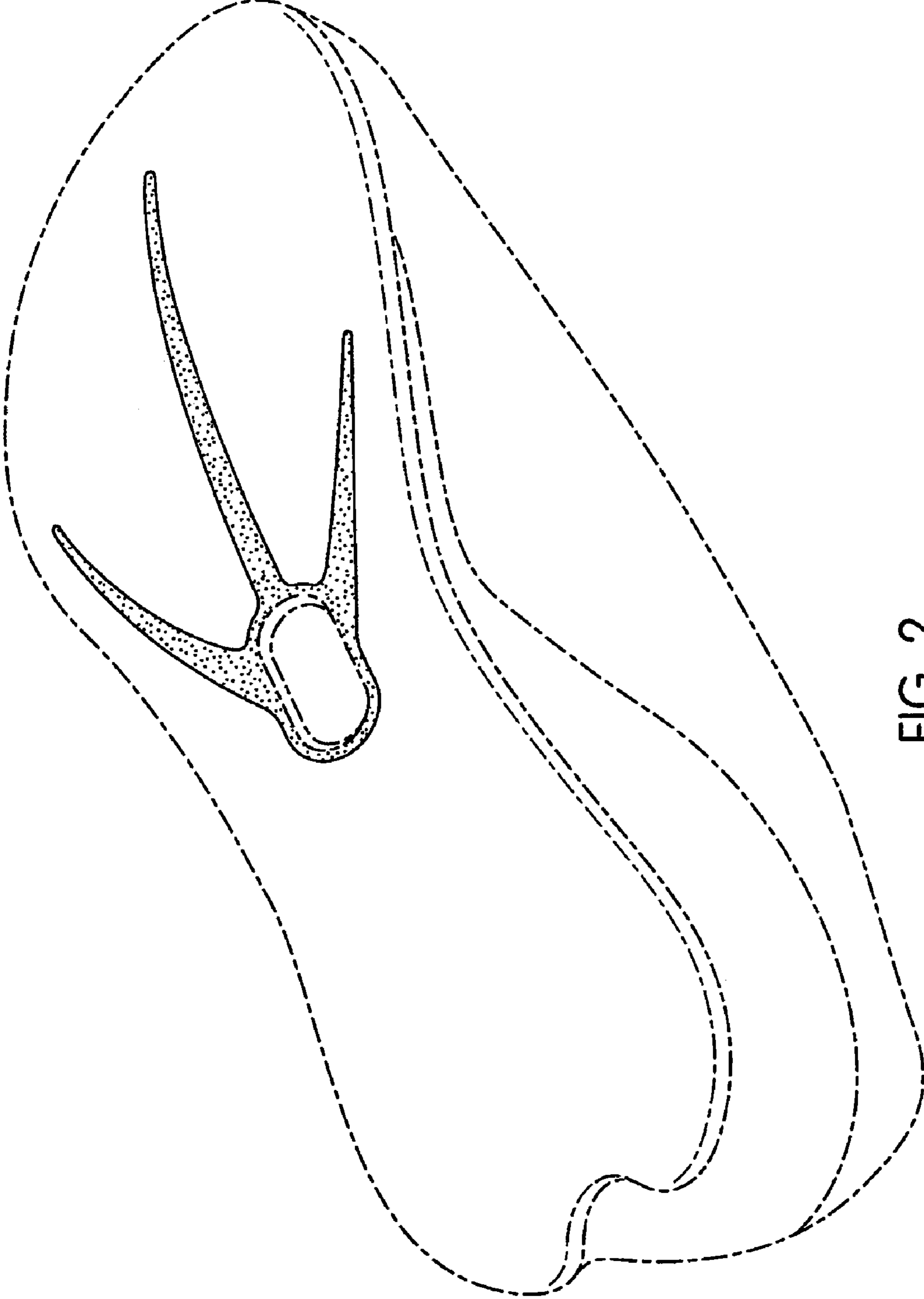

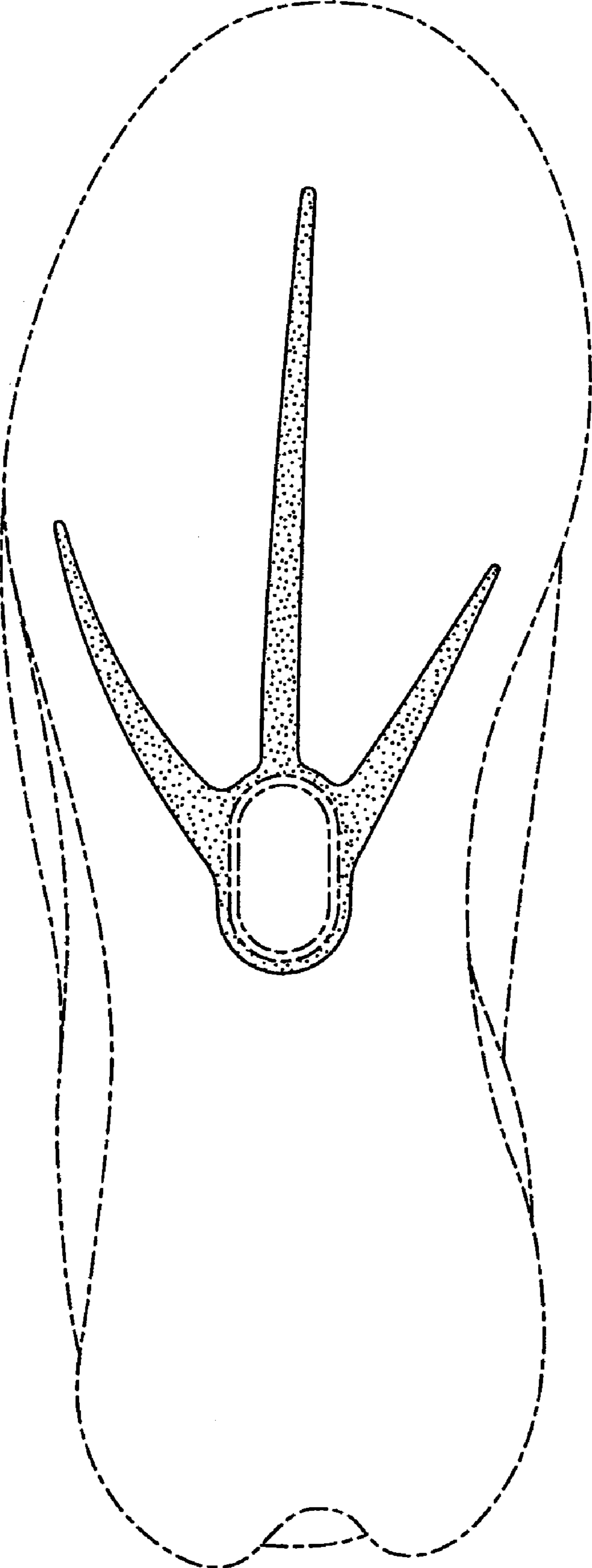
