(57) **CLAIM**

The ornamental design for a card case, as shown and claimed.

**DESCRIPTION**

FIG. 1 is a perspective view of a card case showing my new design;

FIG. 2 is a perspective view of an alternative card case of the present invention;

FIG. 3 is a perspective view of another alternative card case of the present invention;

FIG. 4 is a perspective view of the card case of FIG. 1 showing a ribbon for carrying the case;

FIG. 5 is a perspective view of the card case of FIG. 2 showing a ribbon for carrying the case;

FIG. 6 is a top view of the card case of FIG. 1

FIG. 7 is a bottom view of the card case of FIG. 1.

FIG. 8 is a side view of the card case of FIG. 1 as viewed from the right side of the card case. The view of the left side of the card case is a mirror image of FIG. 8;

FIG. 9 is a top end view of the card case of FIG. 1;

FIG. 10 is a bottom end view of the card case of FIG. 1;

FIG. 11 is a top view of the card case of FIG. 2;

FIG. 12 is a bottom view of the card case of FIG. 2.

FIG. 13 is a side view of the card case of FIG. 2 as viewed from the right side of the card case. The view of the left side of the card case is a mirror image of FIG. 13;

FIG. 14 is a top end view of the card case of FIG. 2;

FIG. 15 is a bottom end view of the card case of FIG. 2;

FIG. 16 is a top view of the card case of FIG. 3;

FIG. 17 is a bottom view of the card case of FIG. 3.

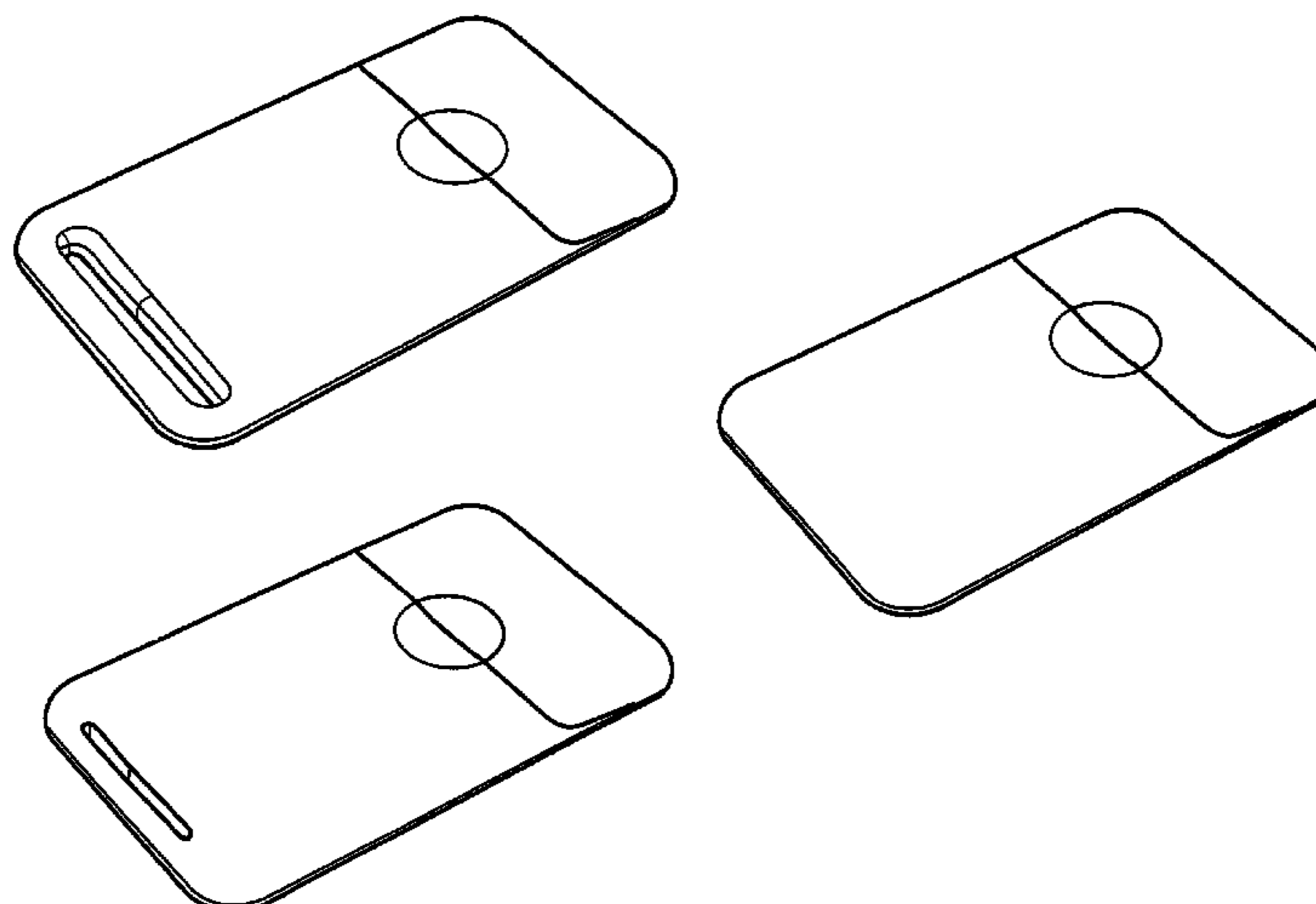

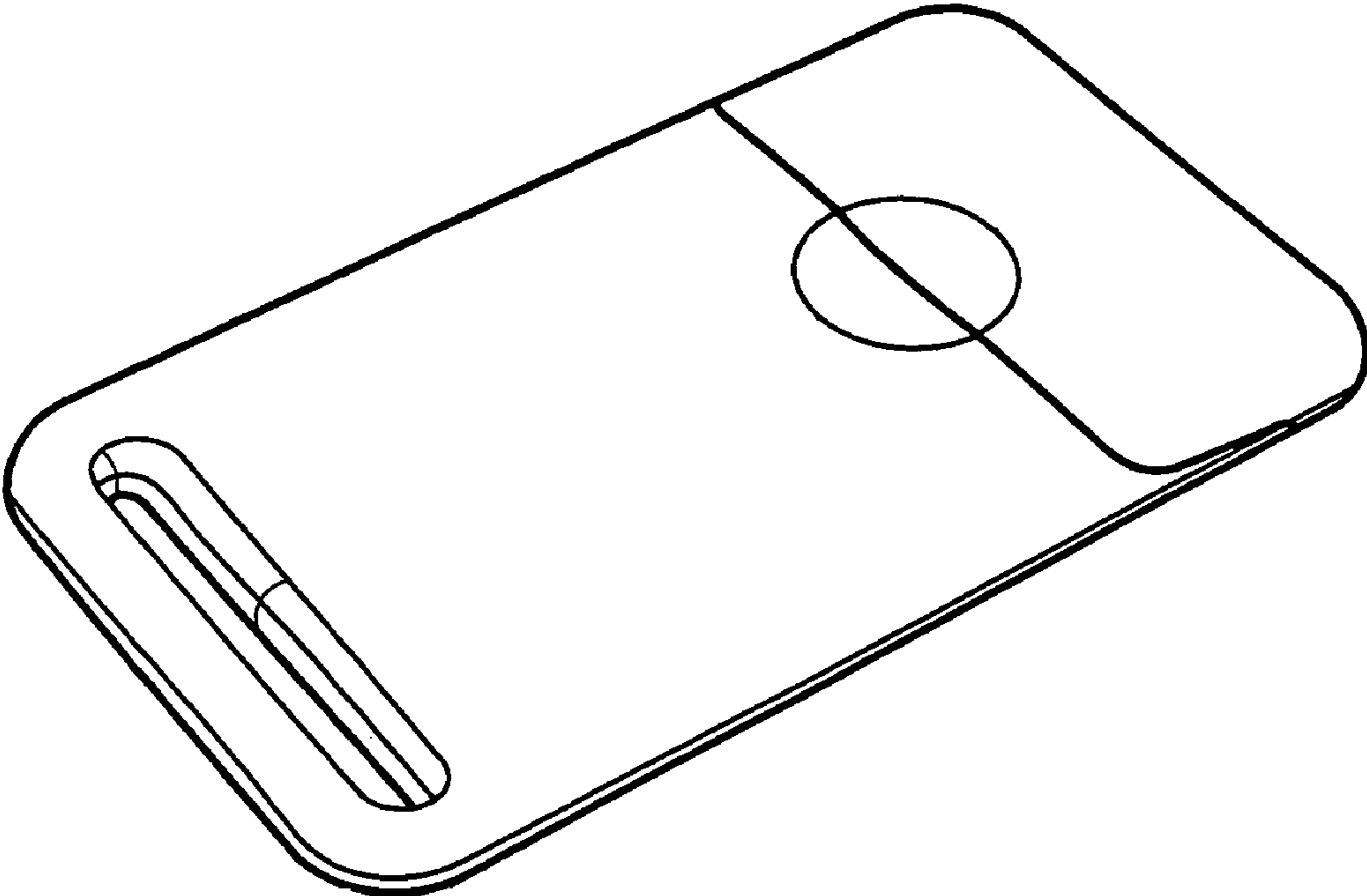

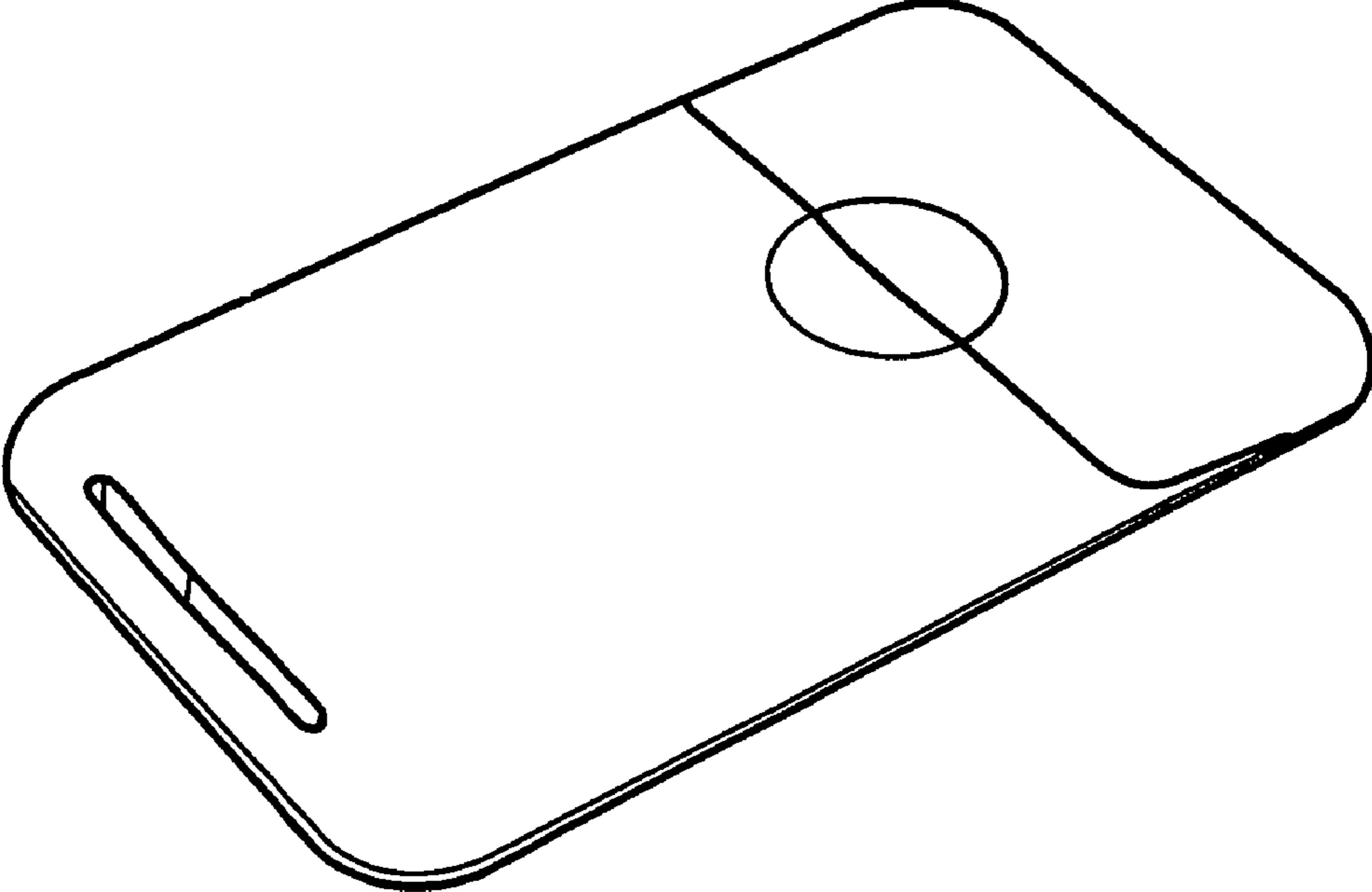

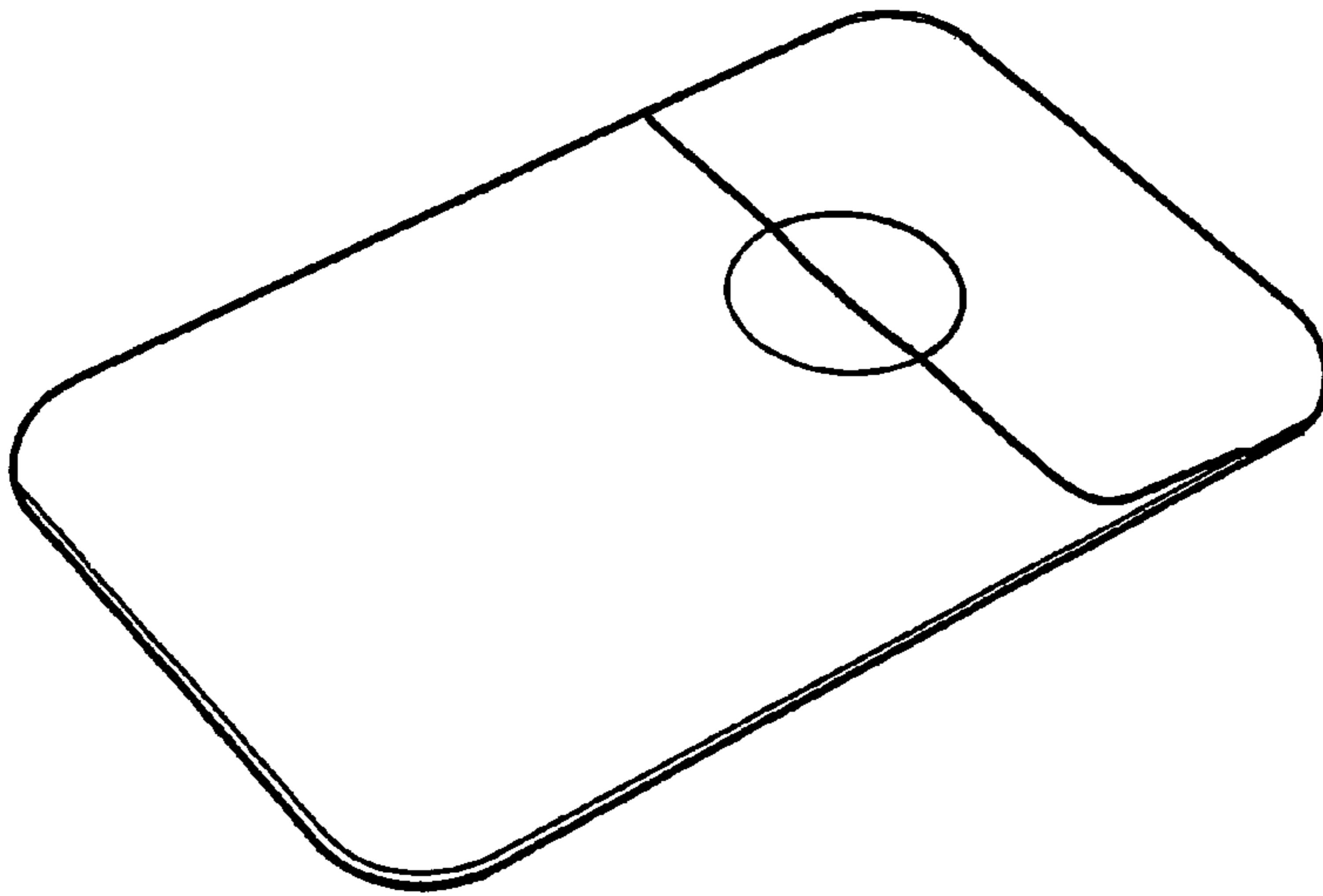

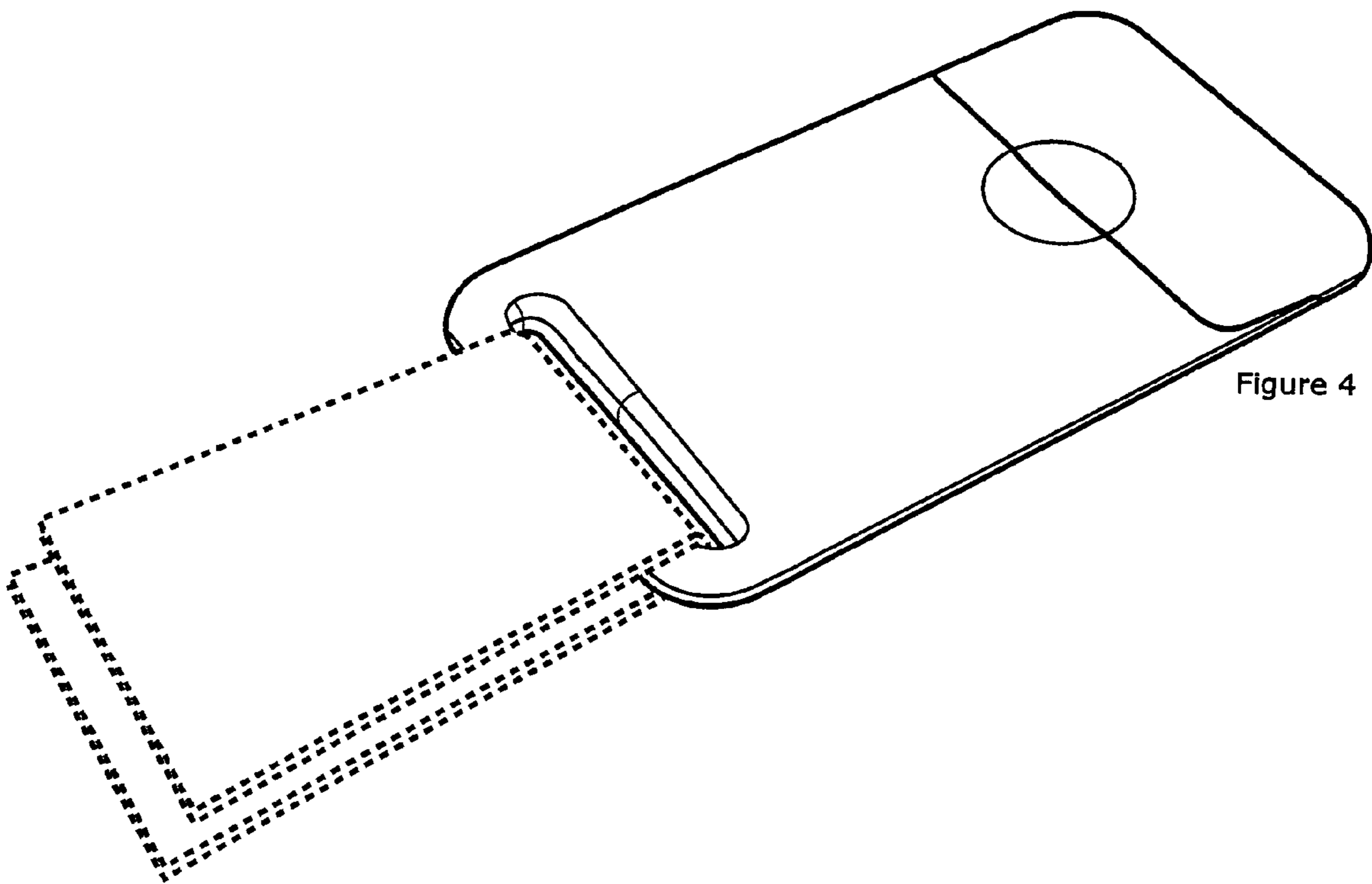

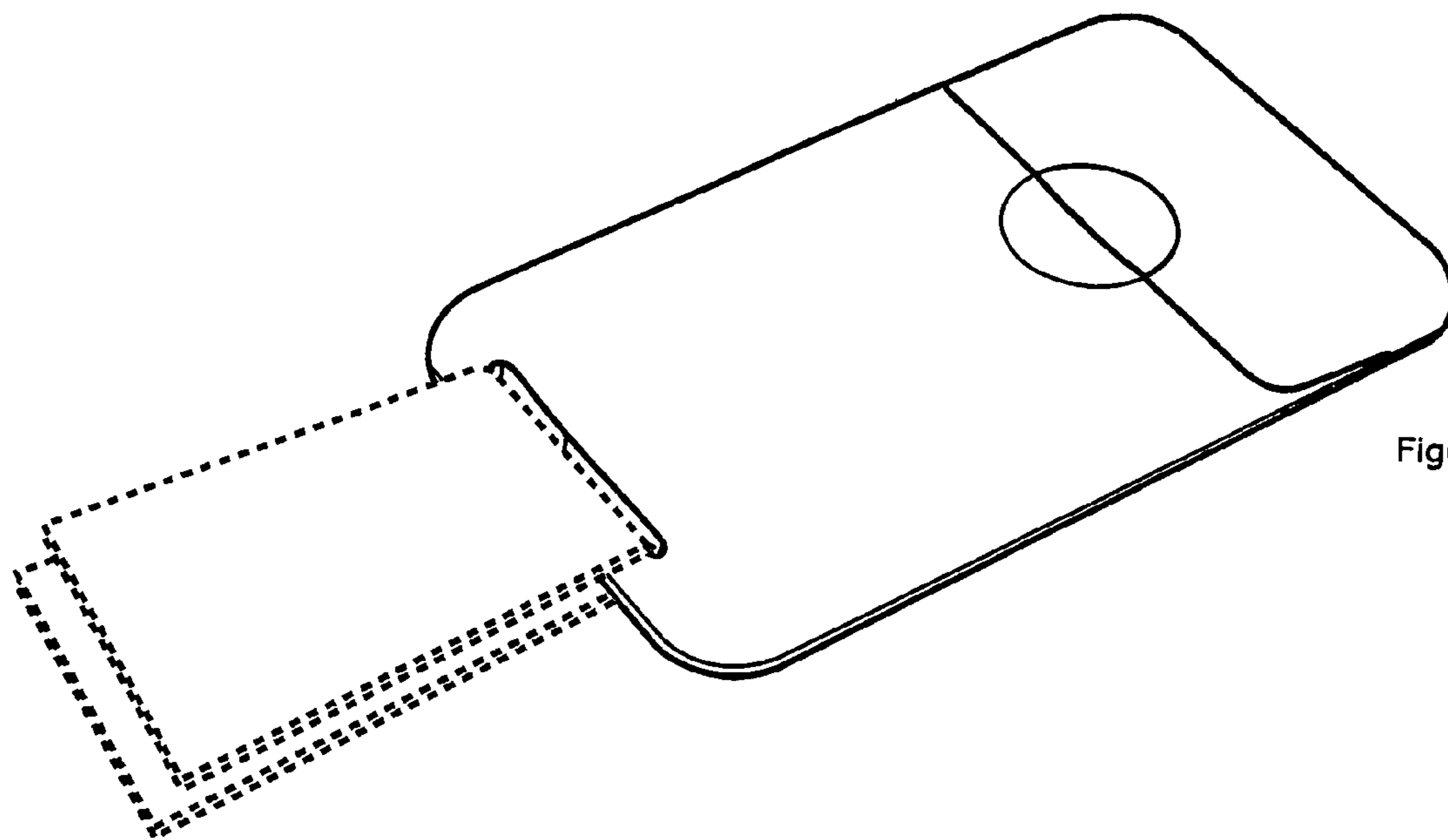

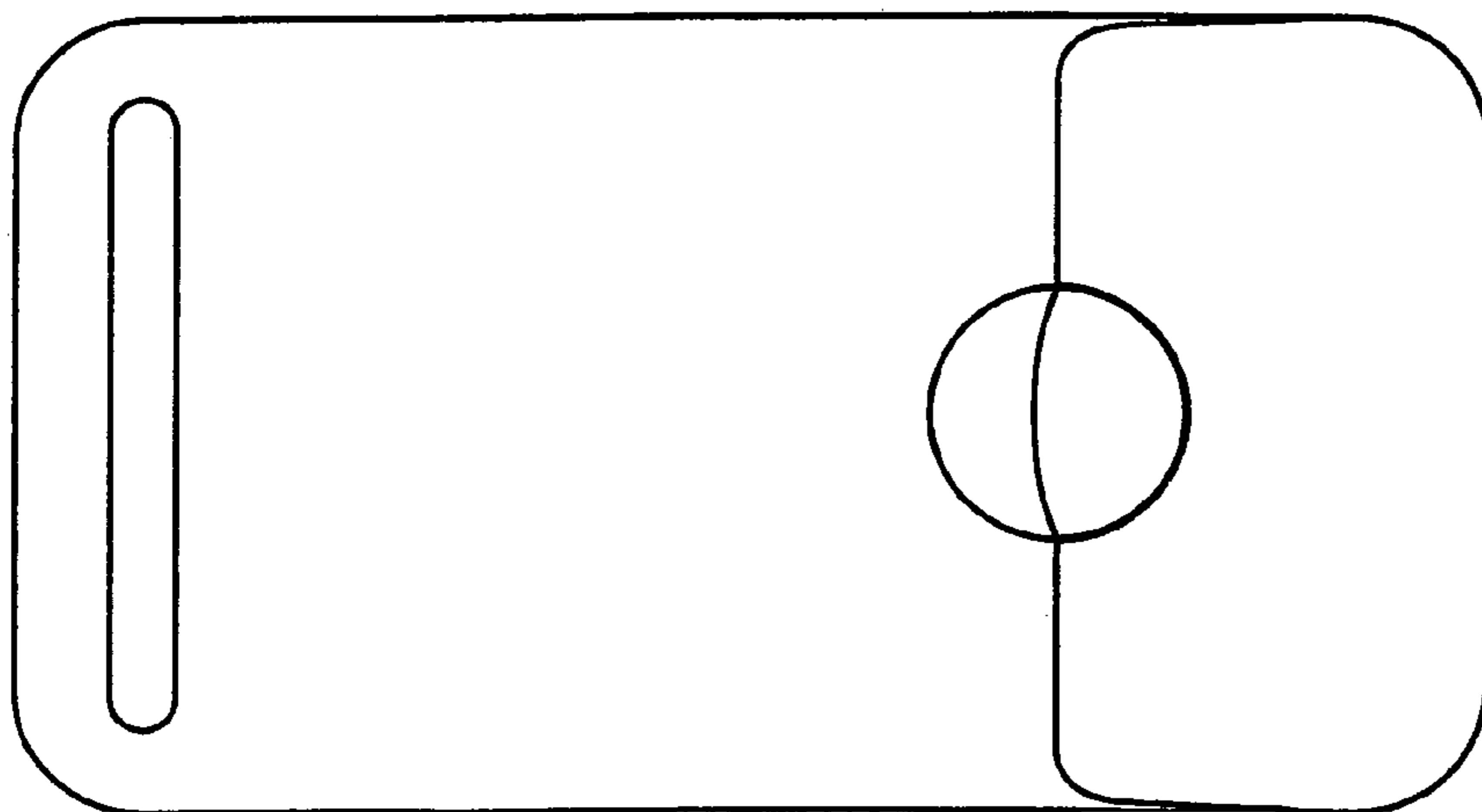

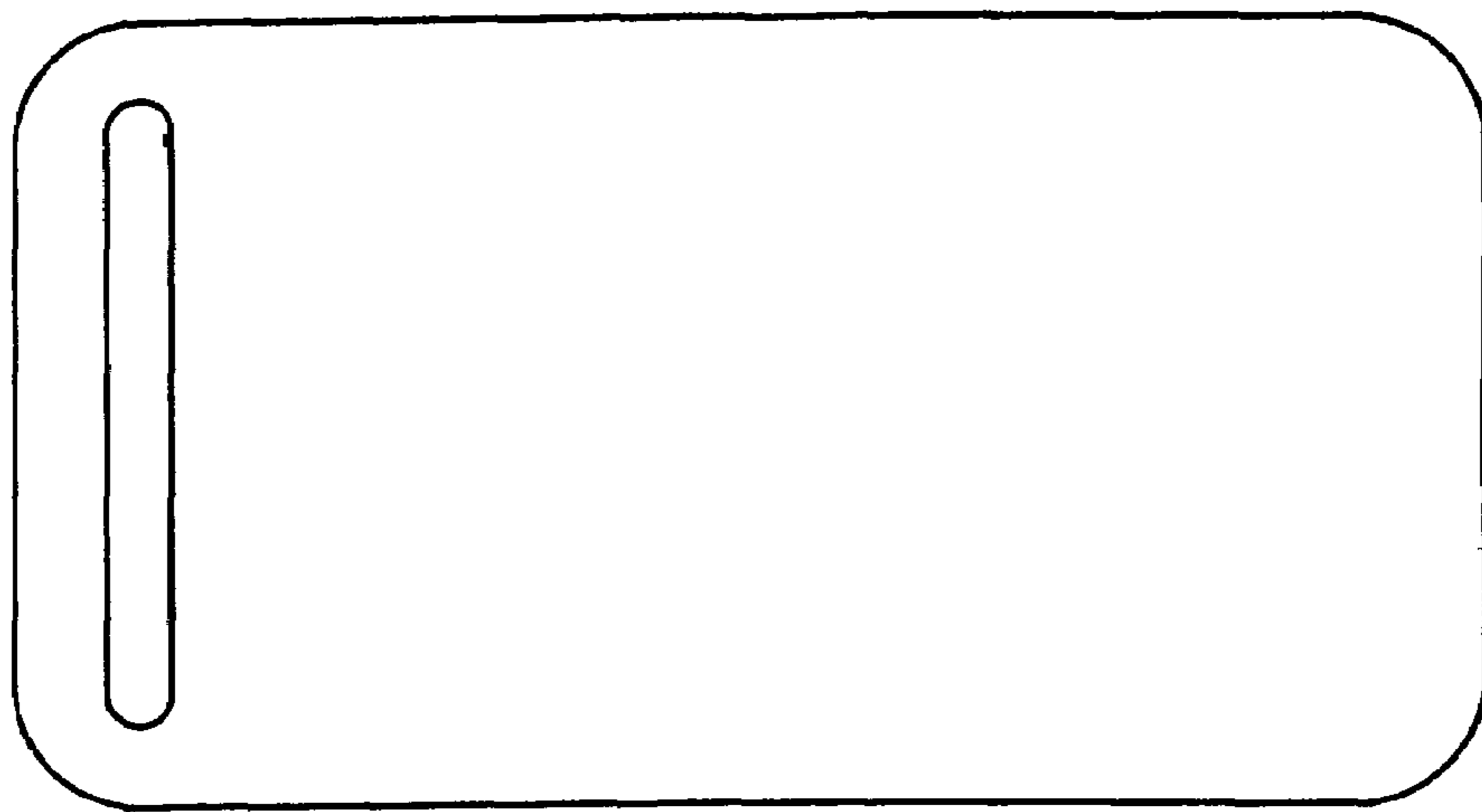

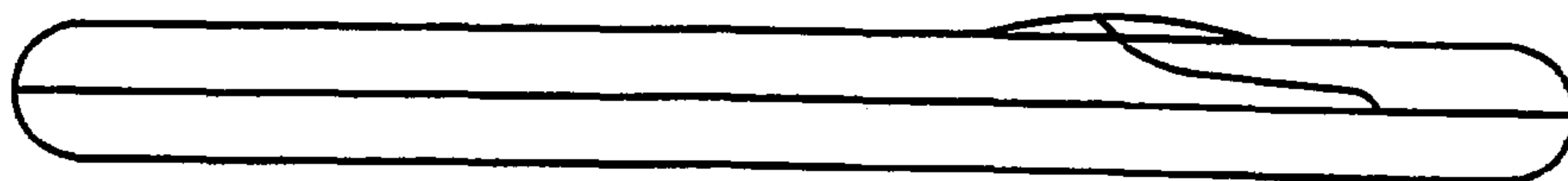

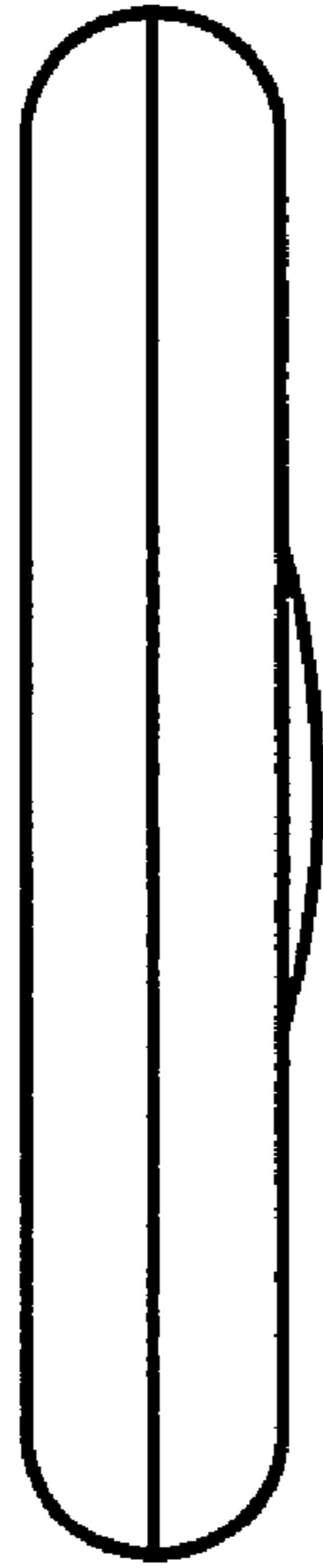

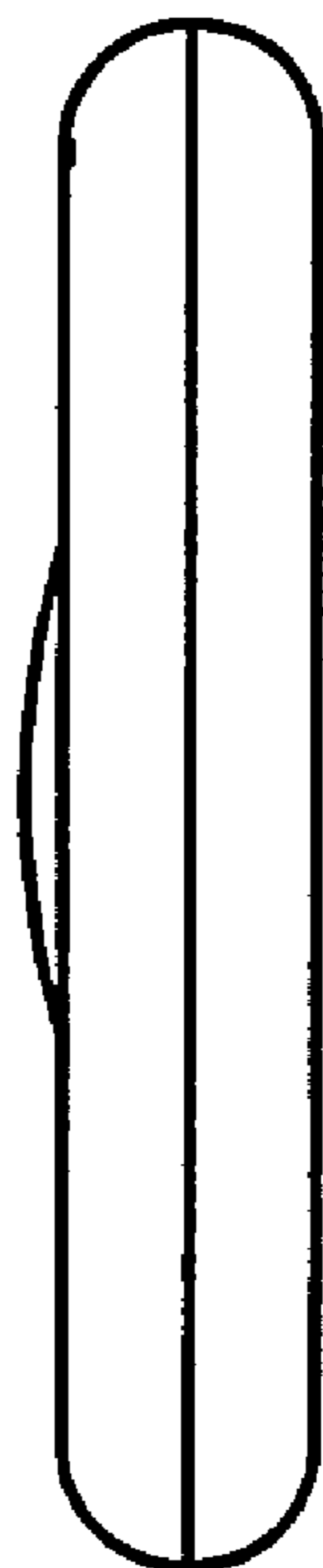

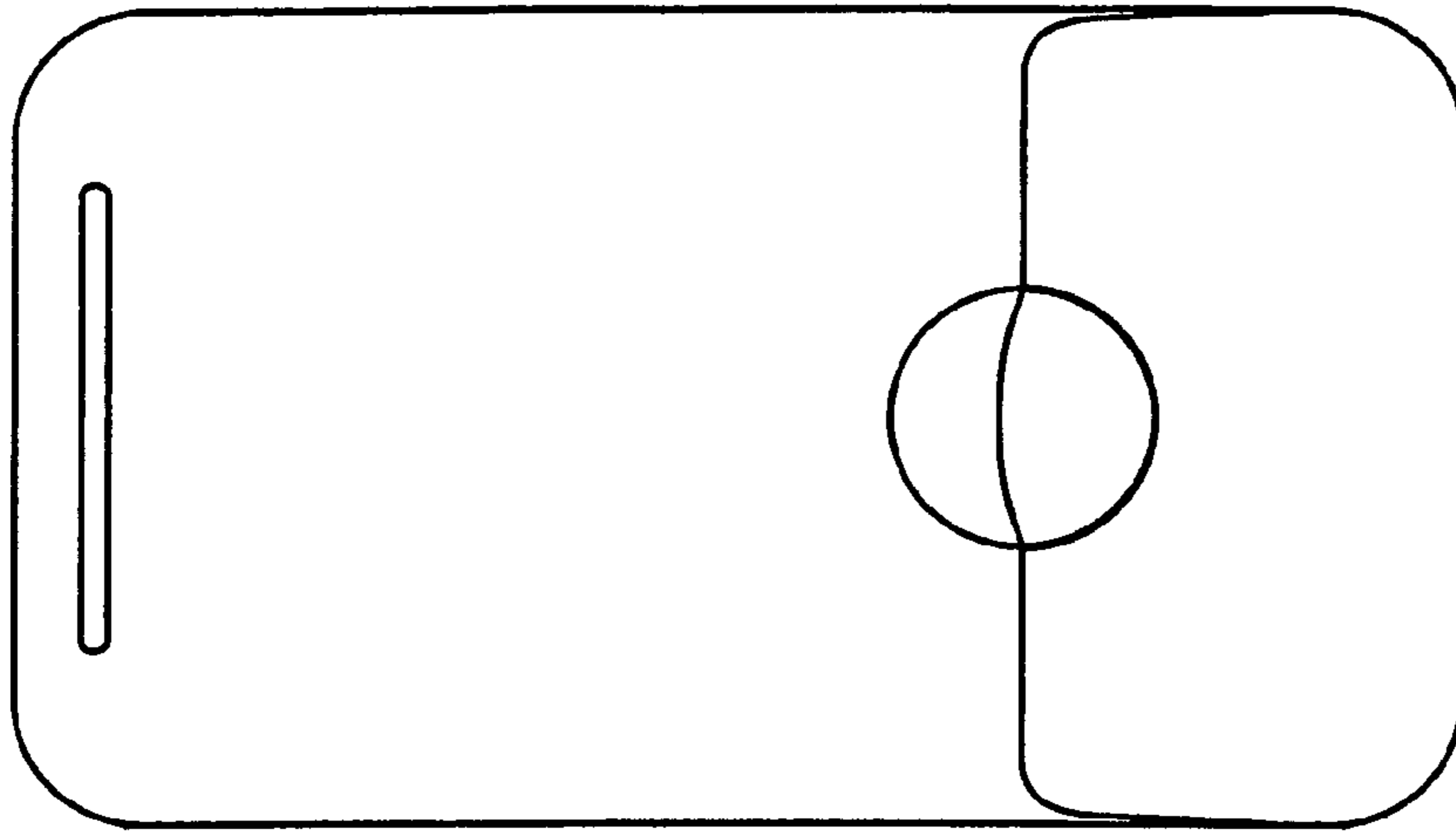

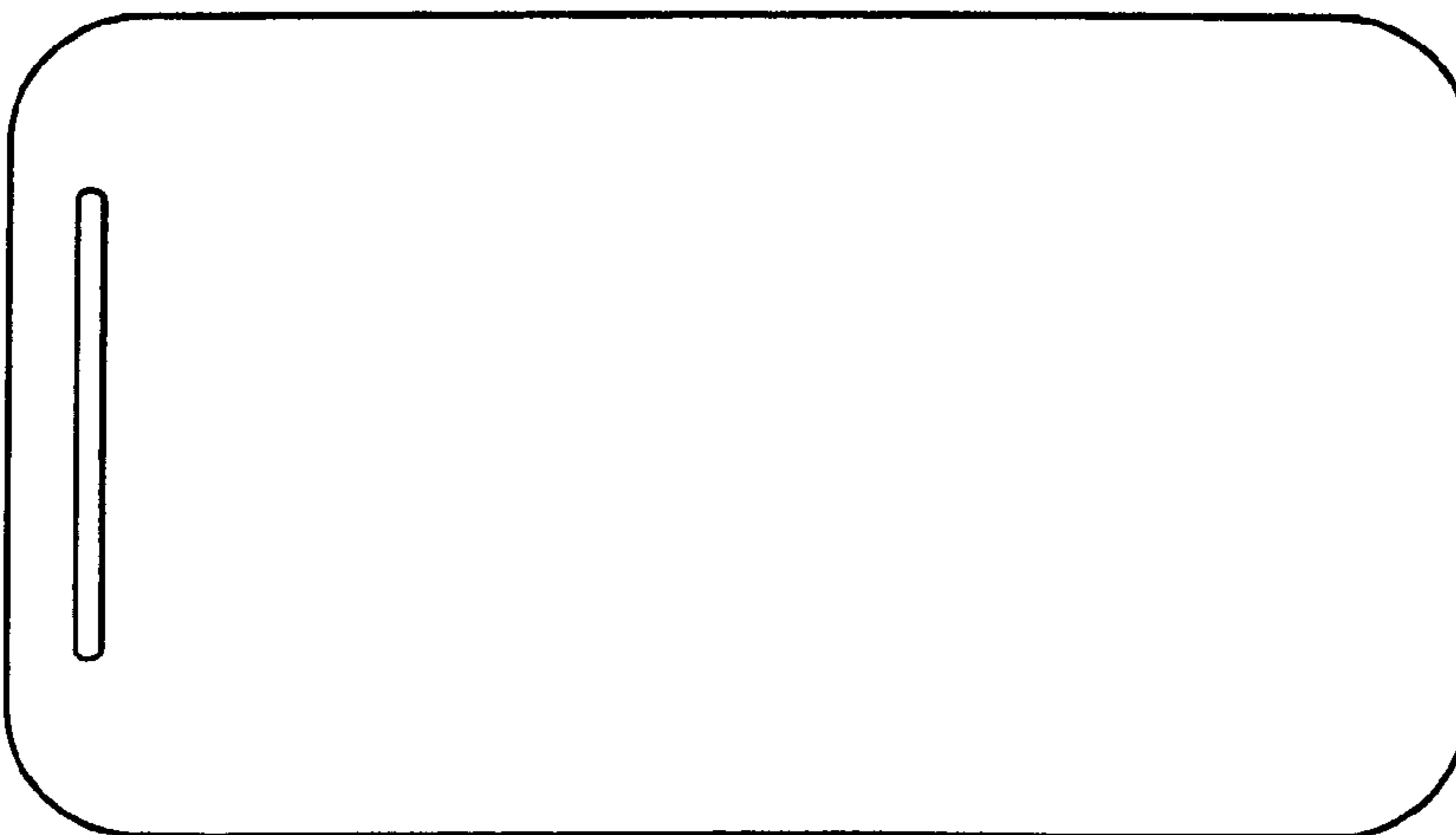

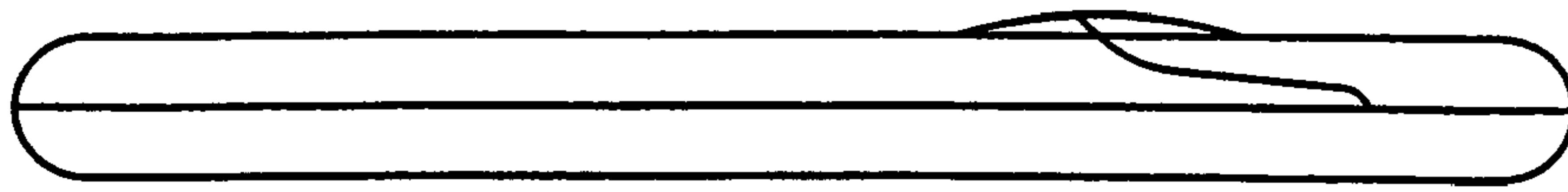

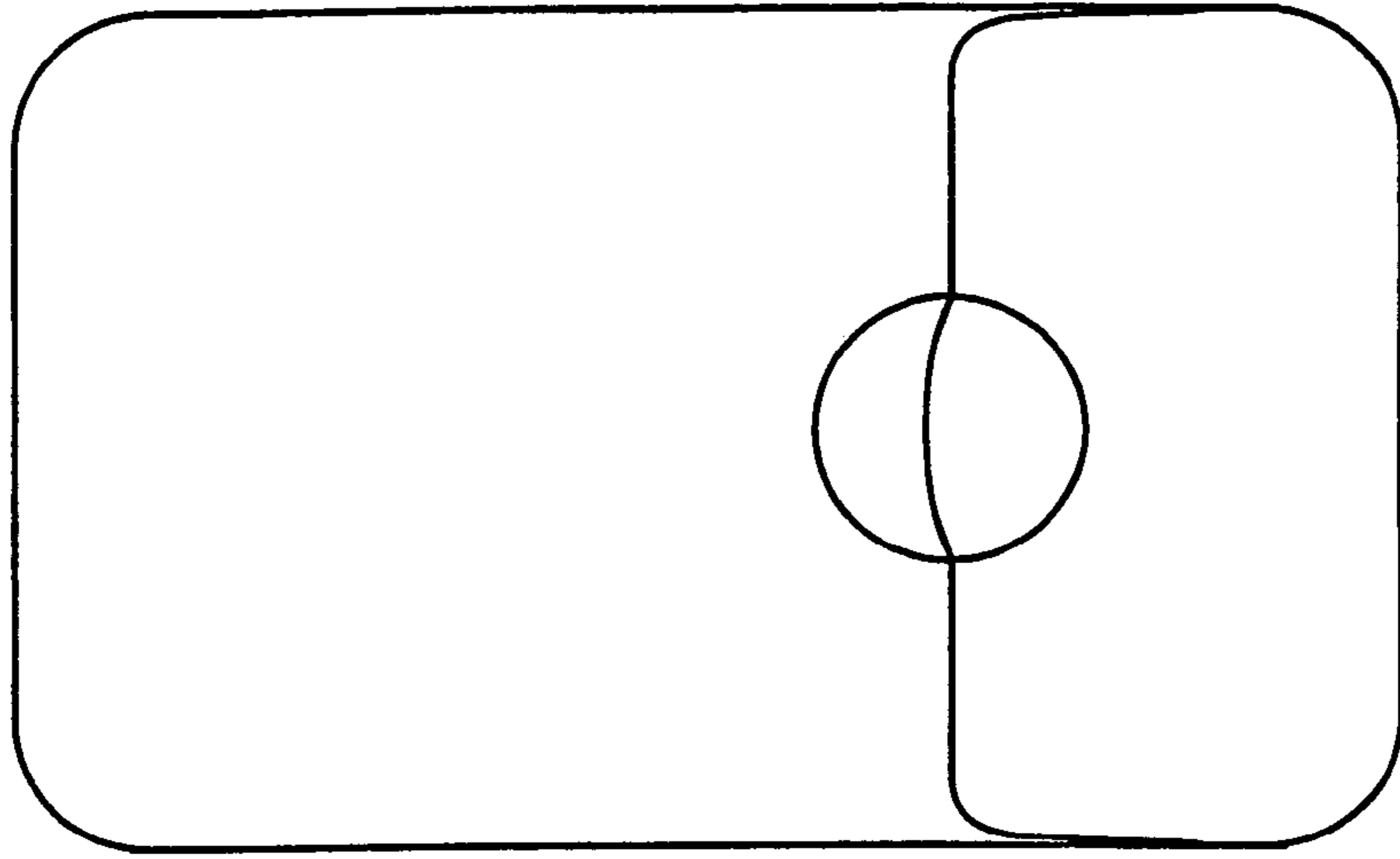

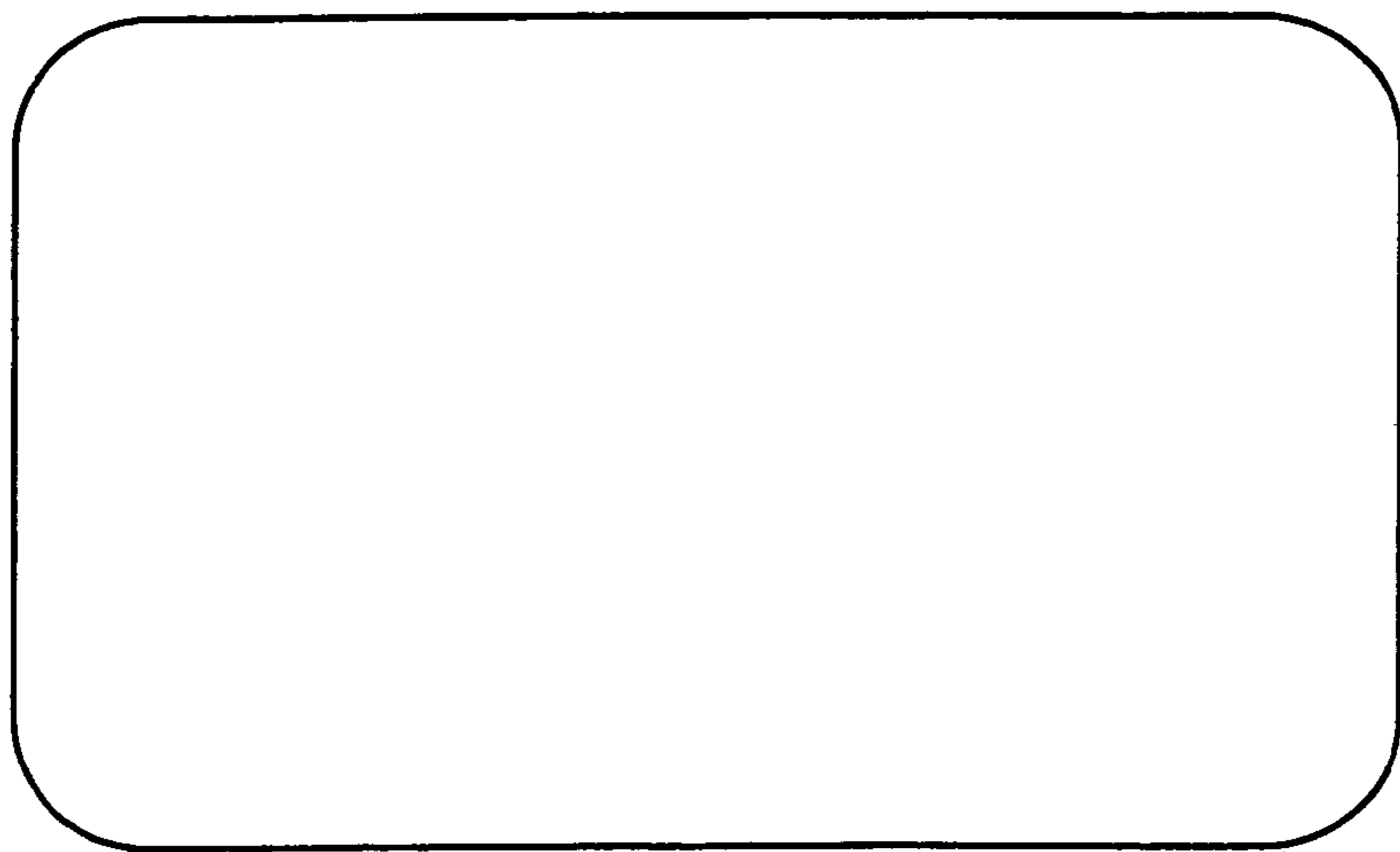

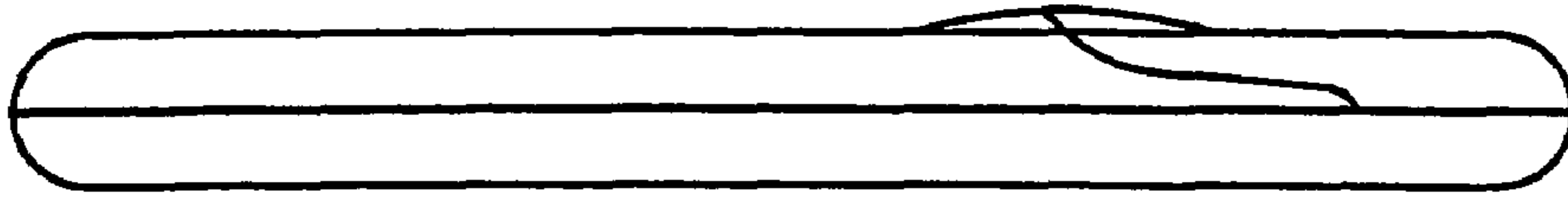

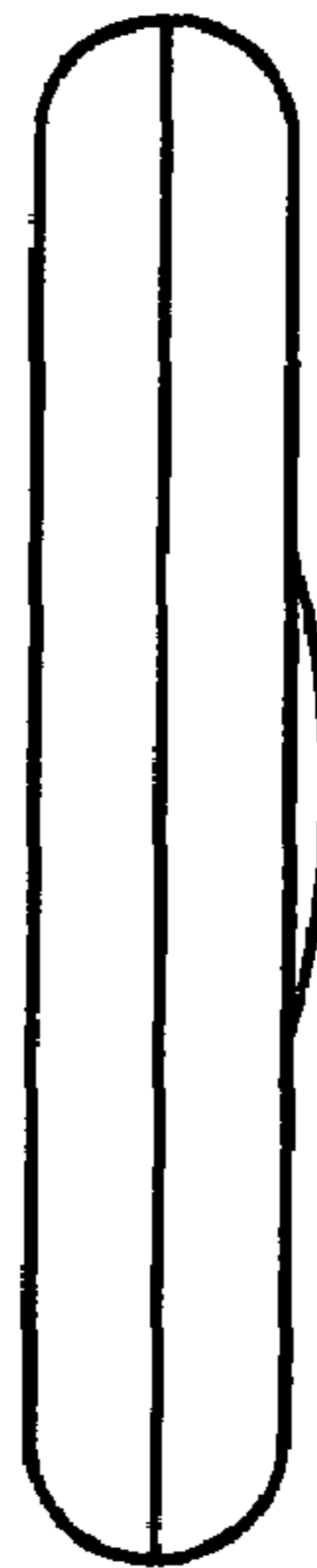

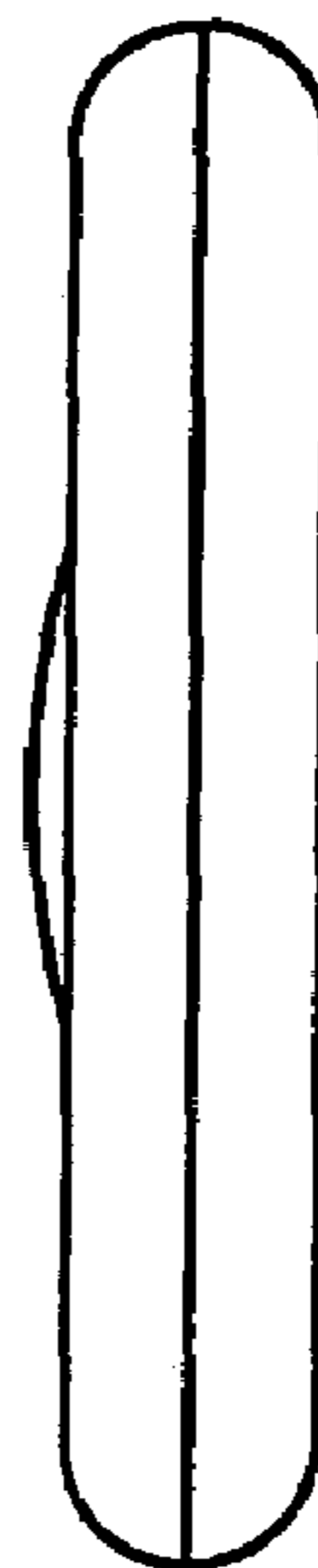
