(57) **CLAIM**

The ornamental design for stay for furniture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of stay for furniture embodying my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a sectional view along 7—7 plane thereof;

FIG. 8 is an enlarged view of 8—8 portion thereof;

FIG. 9 is an enlarged view of 9—9 portion thereof;

FIG. 10 is an enlarged view of 10—10 portion thereof;

FIG. 11 is a sectional view along 11—11 plane thereof;

FIG. 12 is an enlarged left side view thereof;

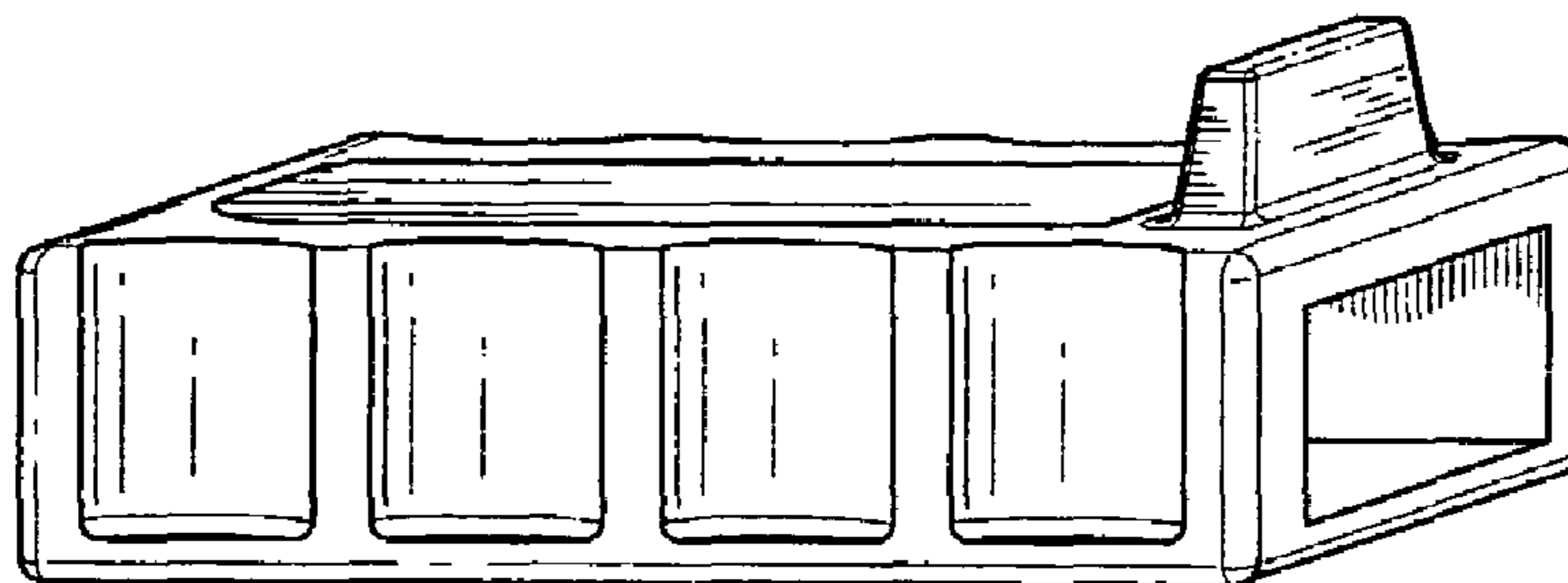
FIG. 13 is an enlarged right side view thereof;

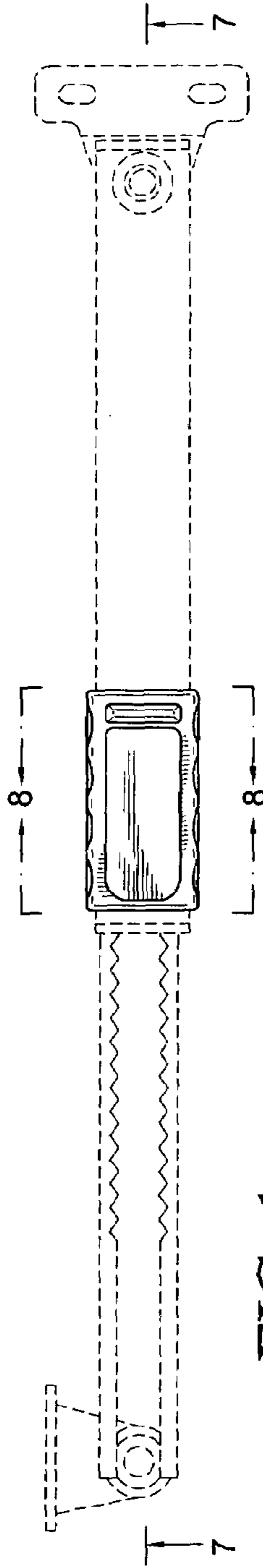

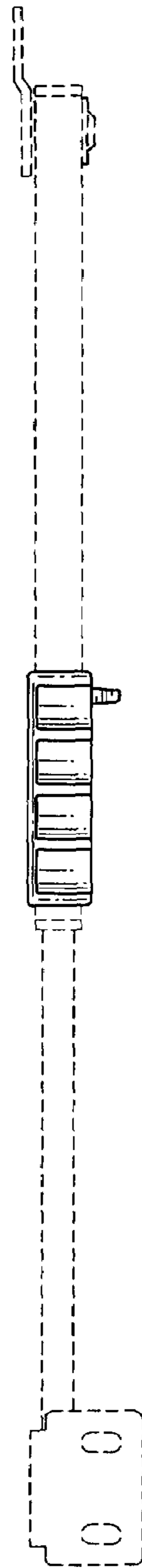

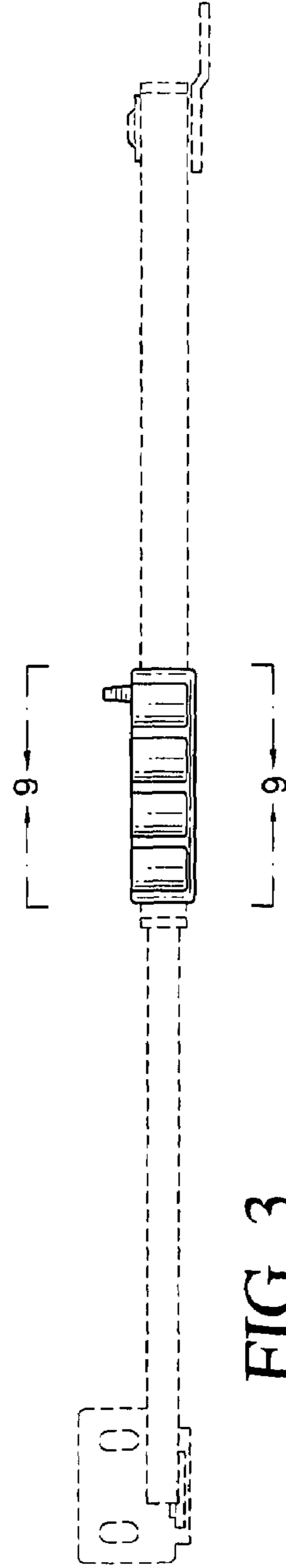

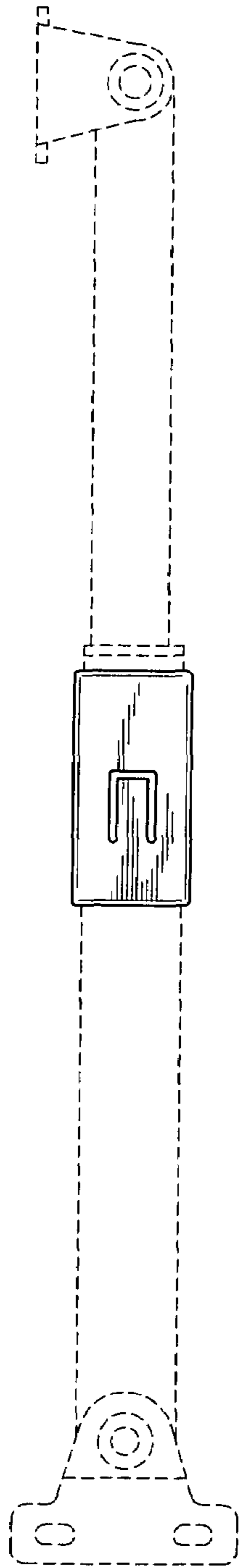

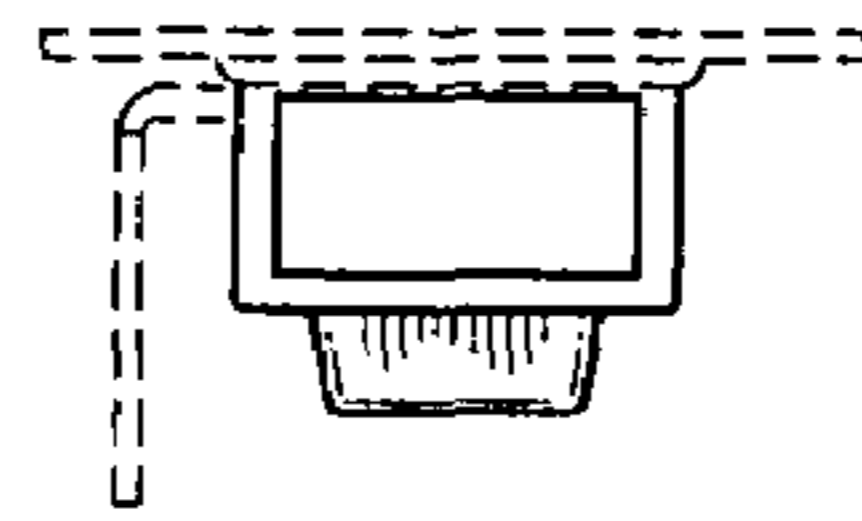

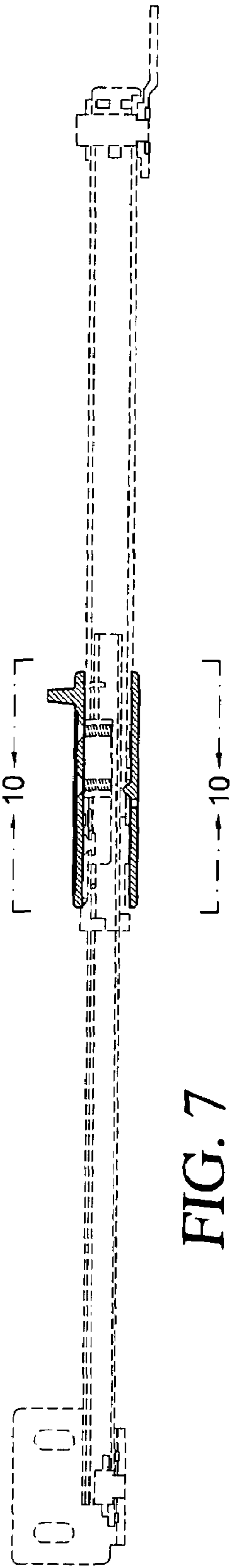

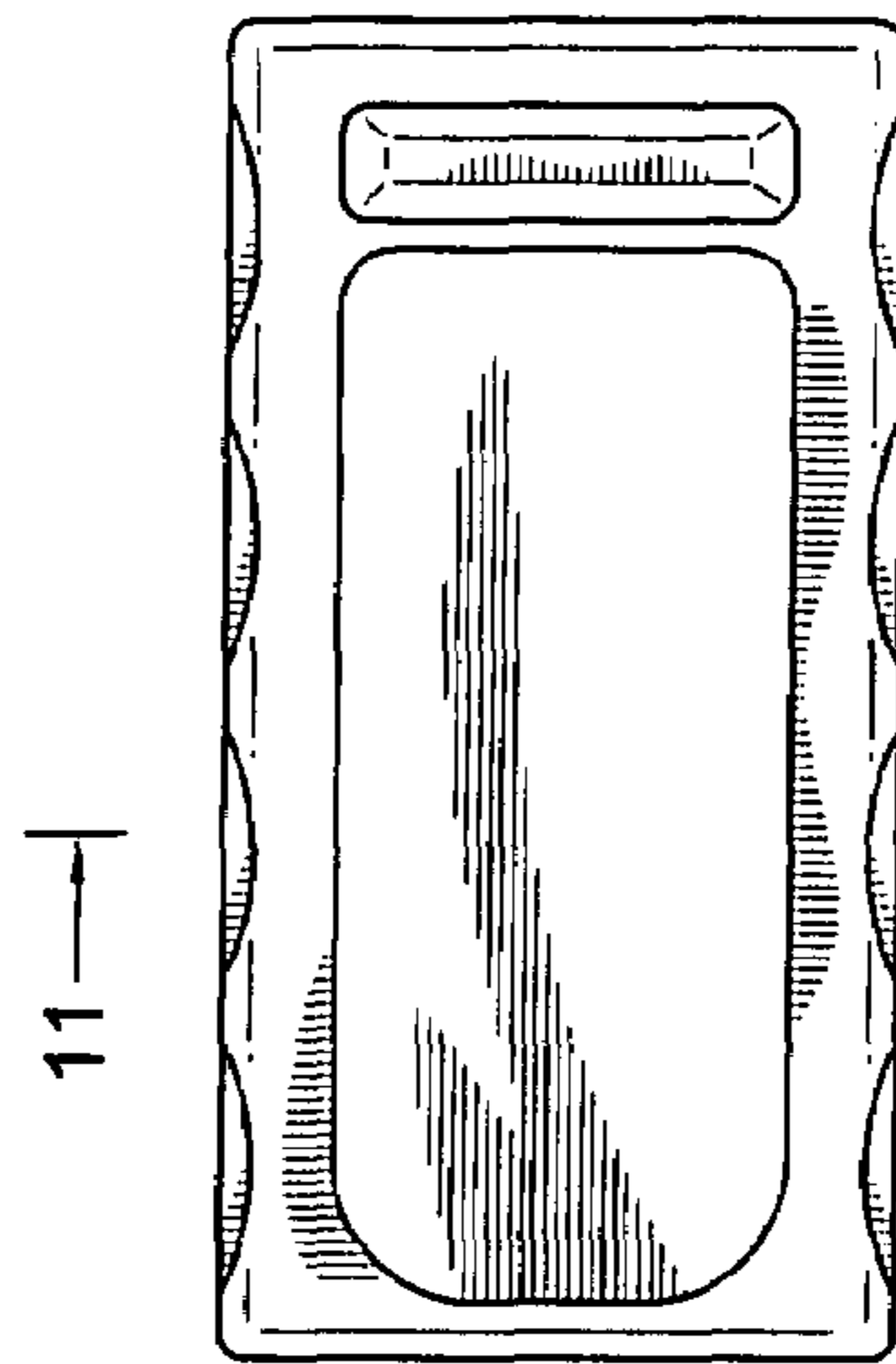

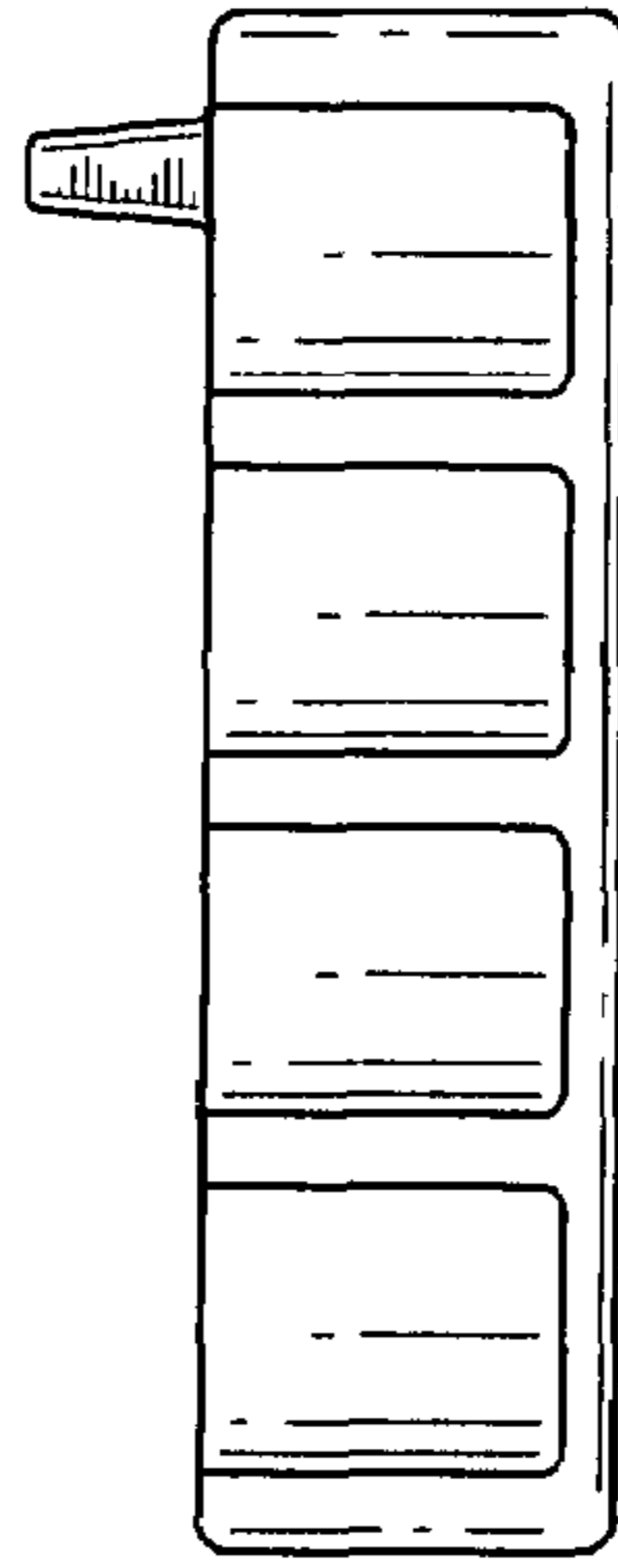

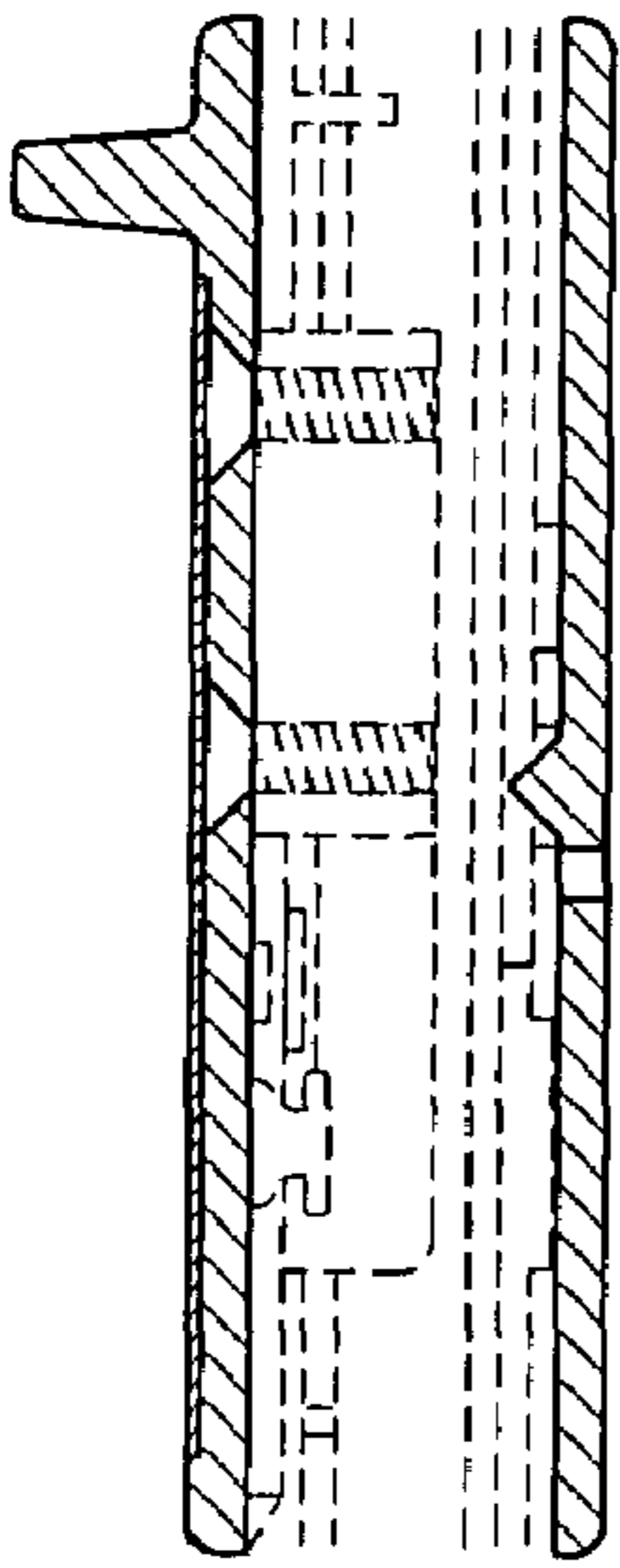

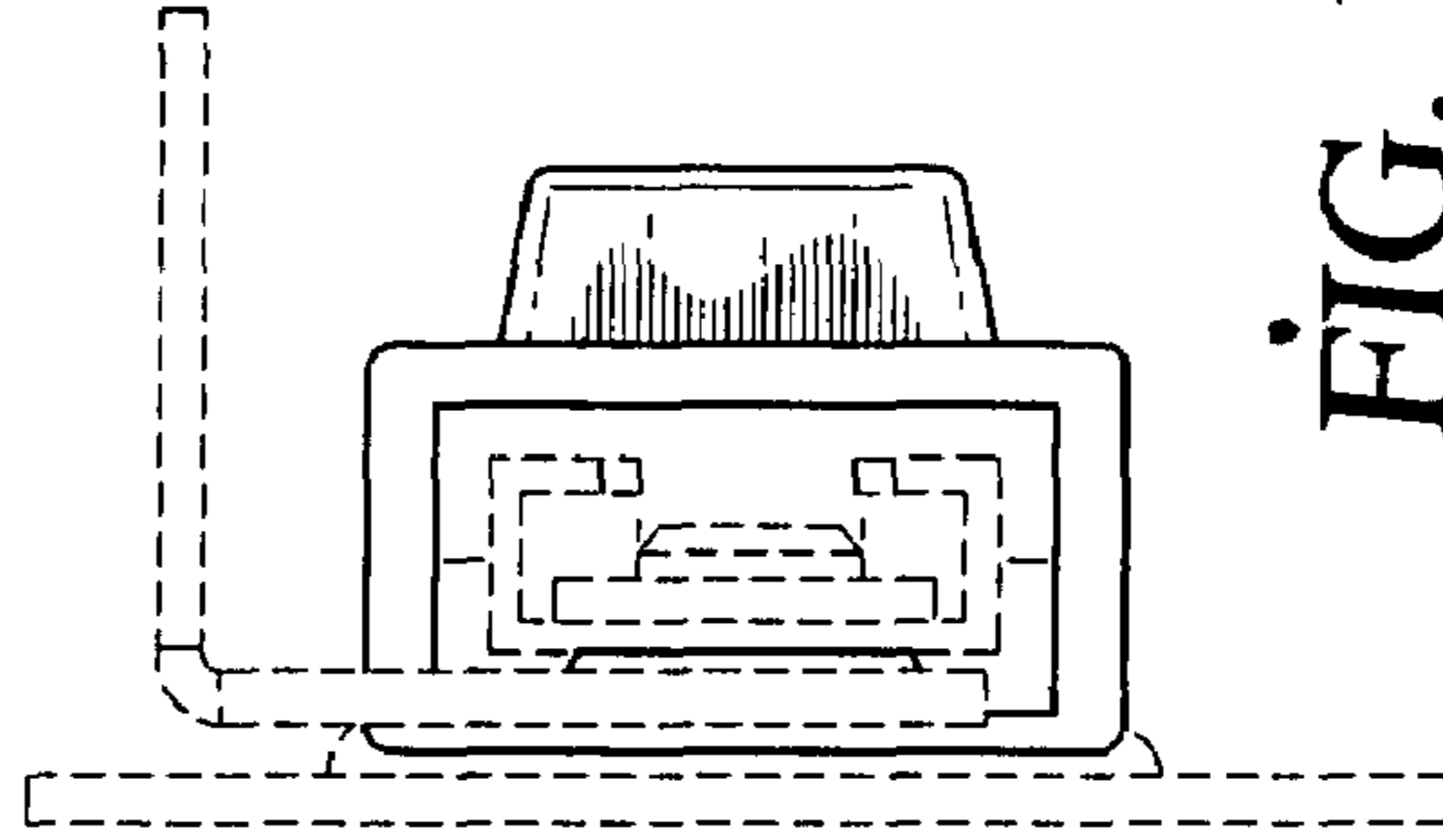

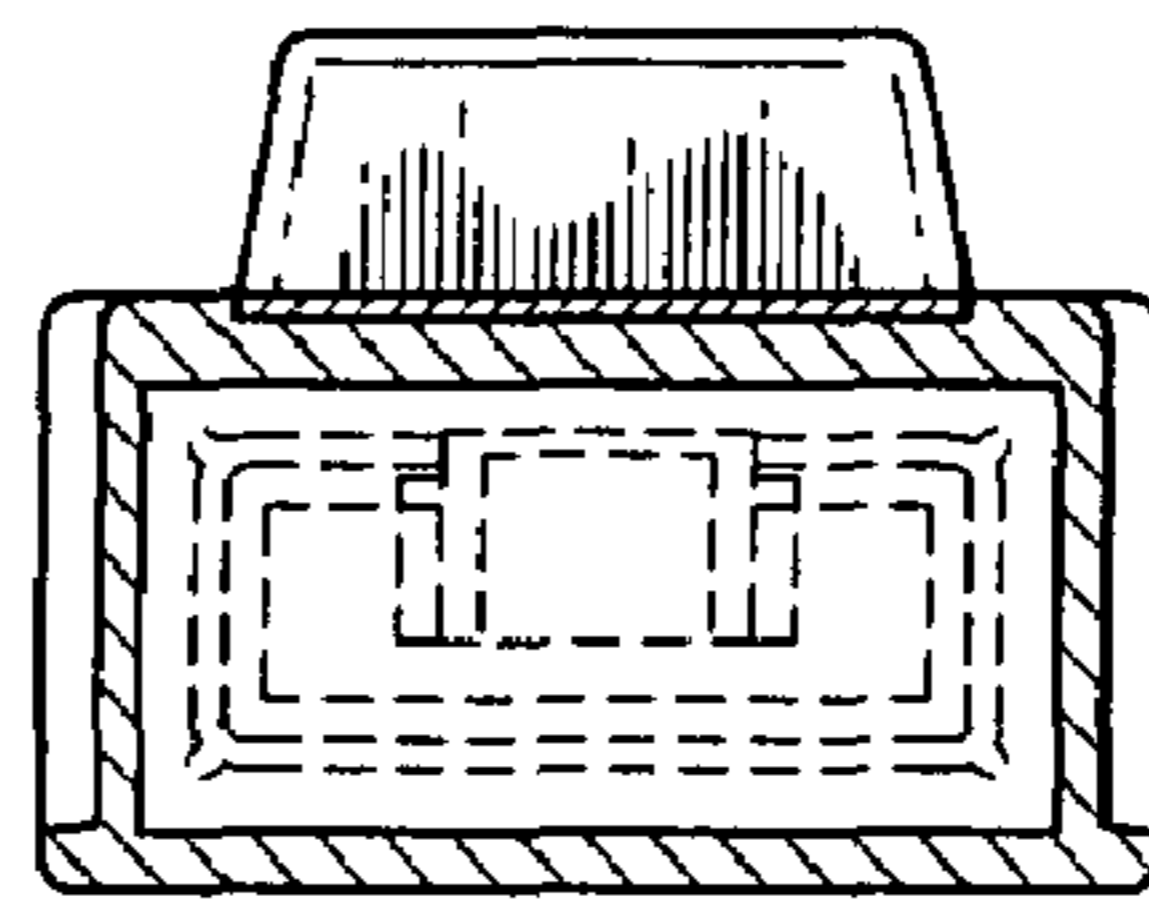

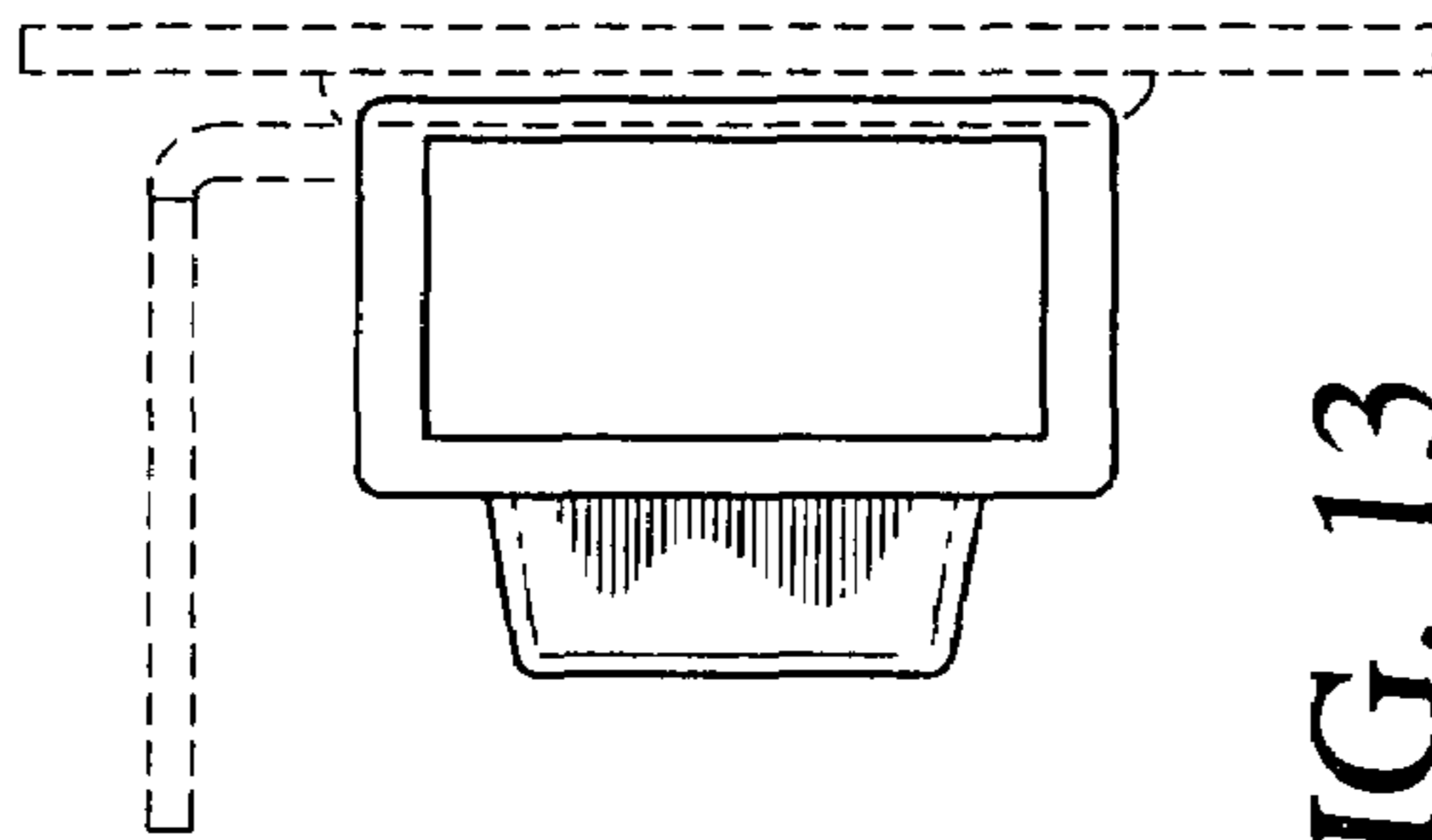

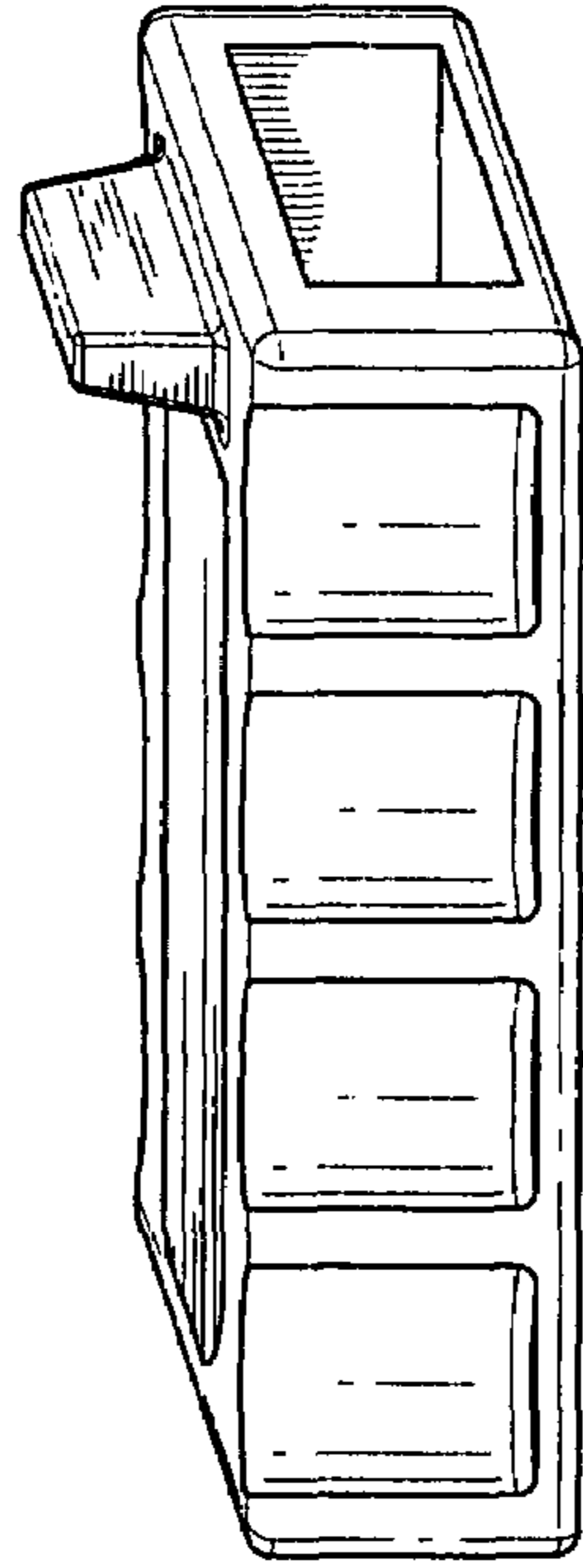

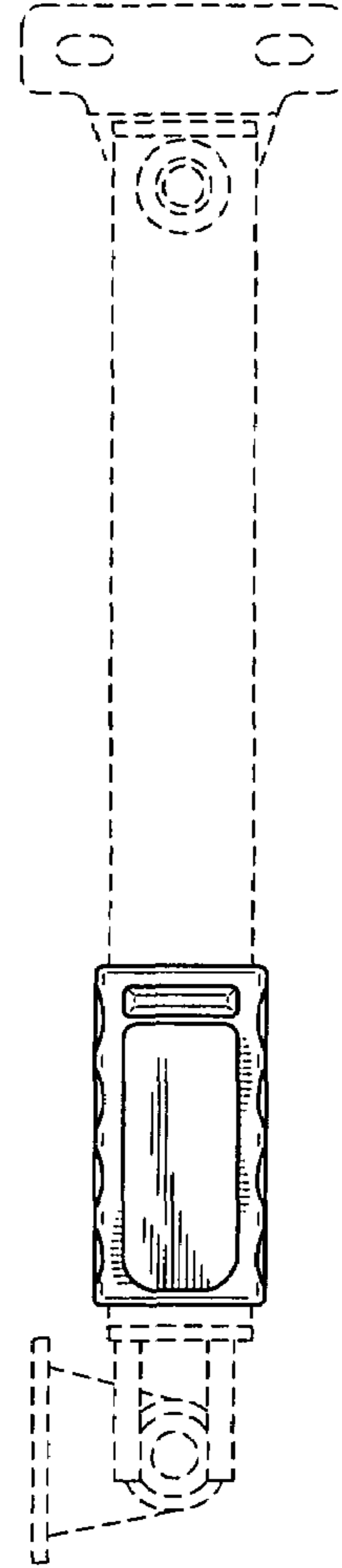
