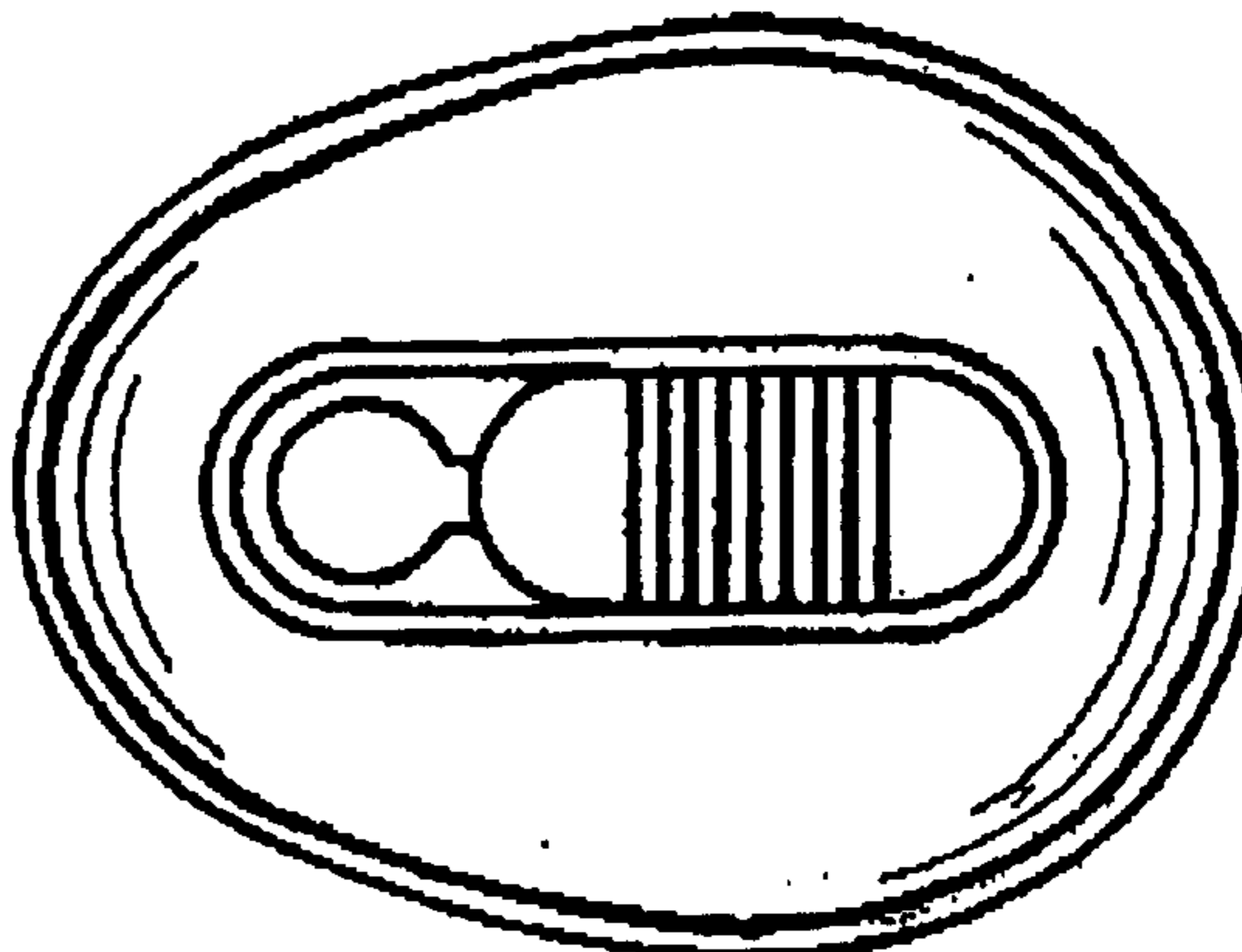
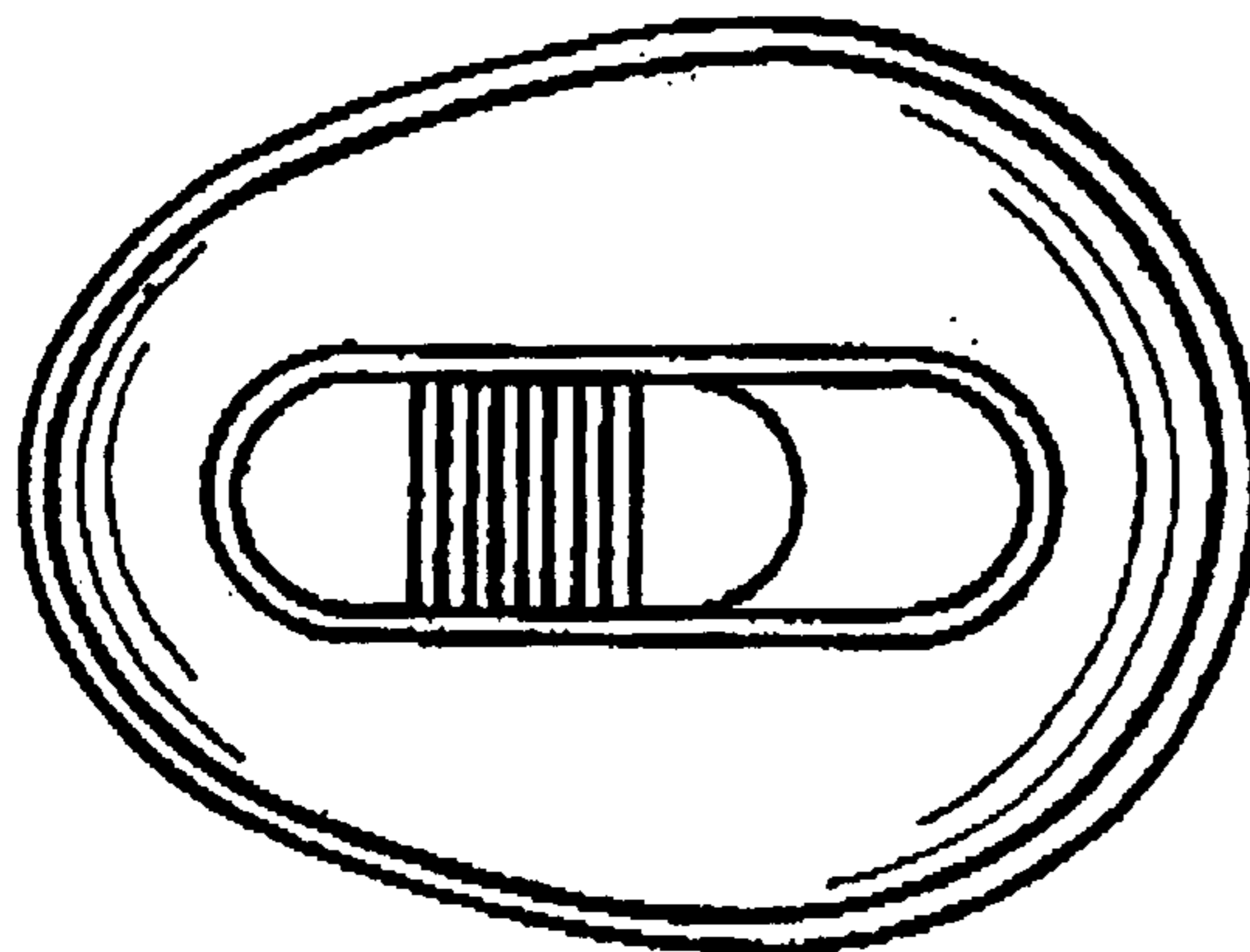
FIG. 1 is a top plan view of a dispenser showing my new design;

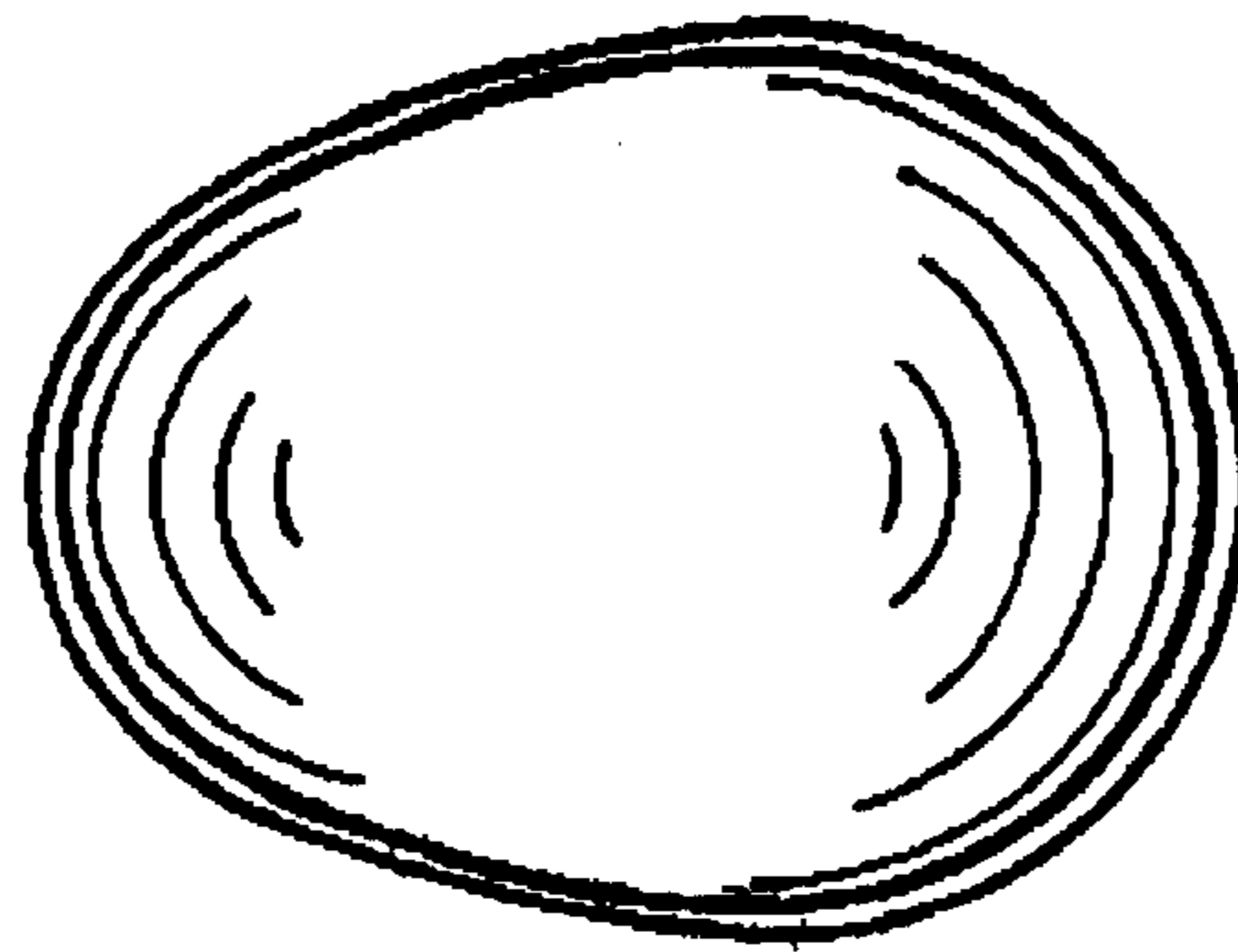

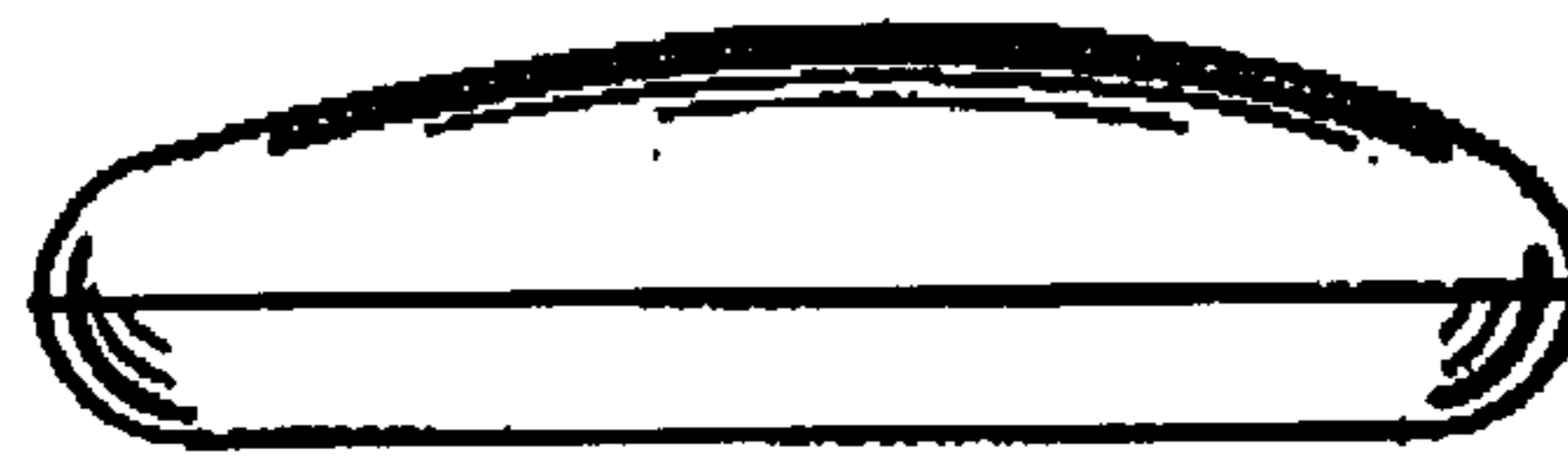

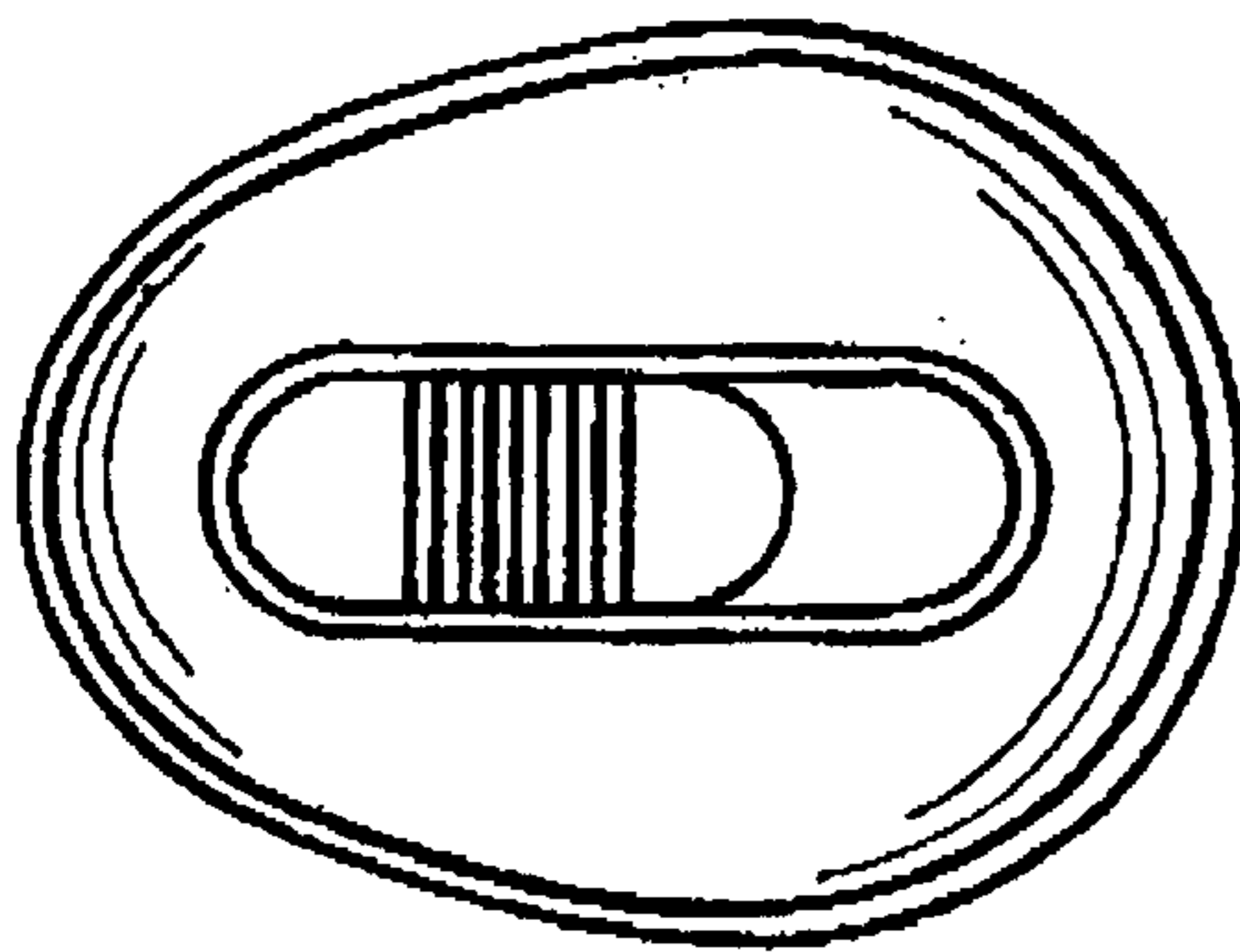

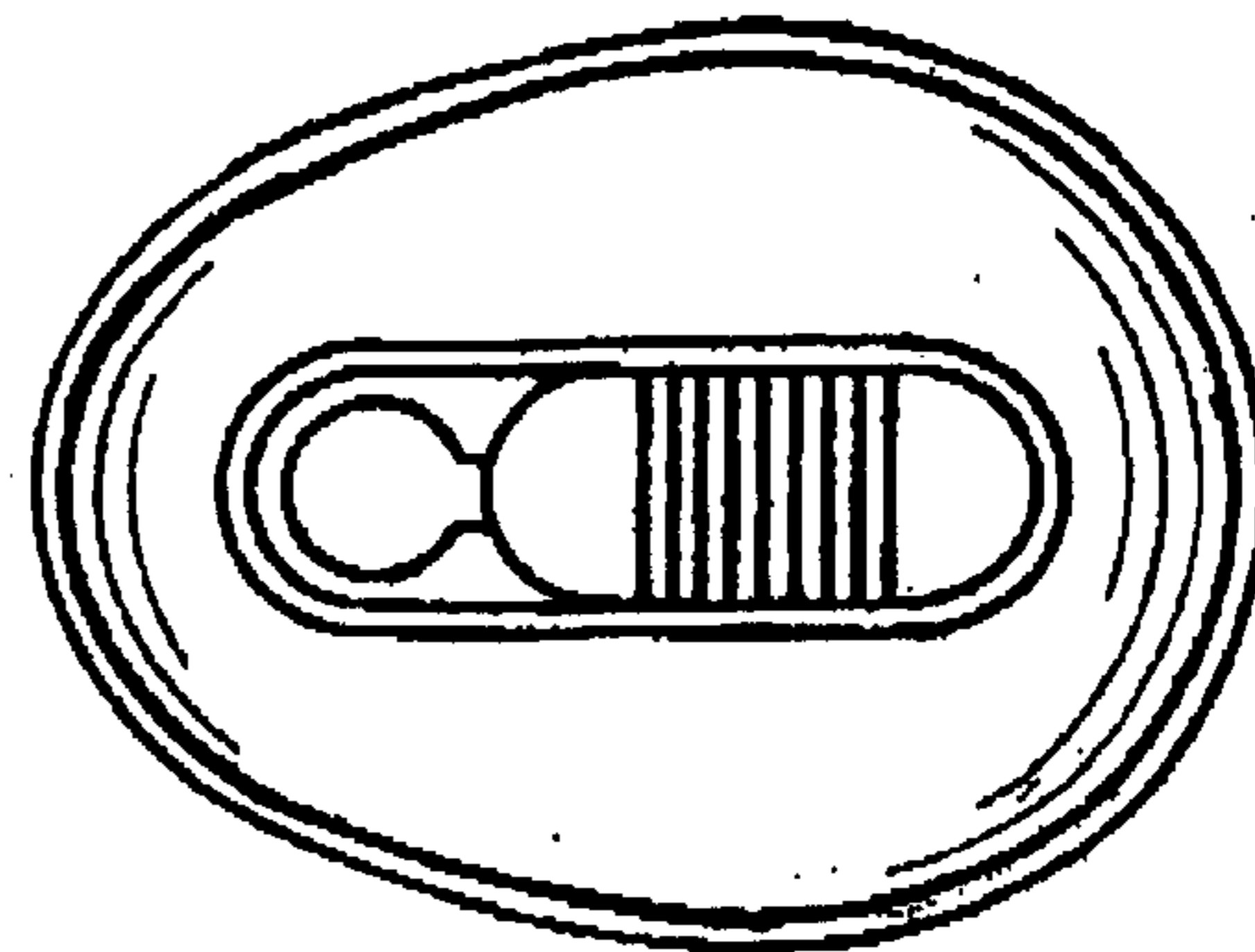

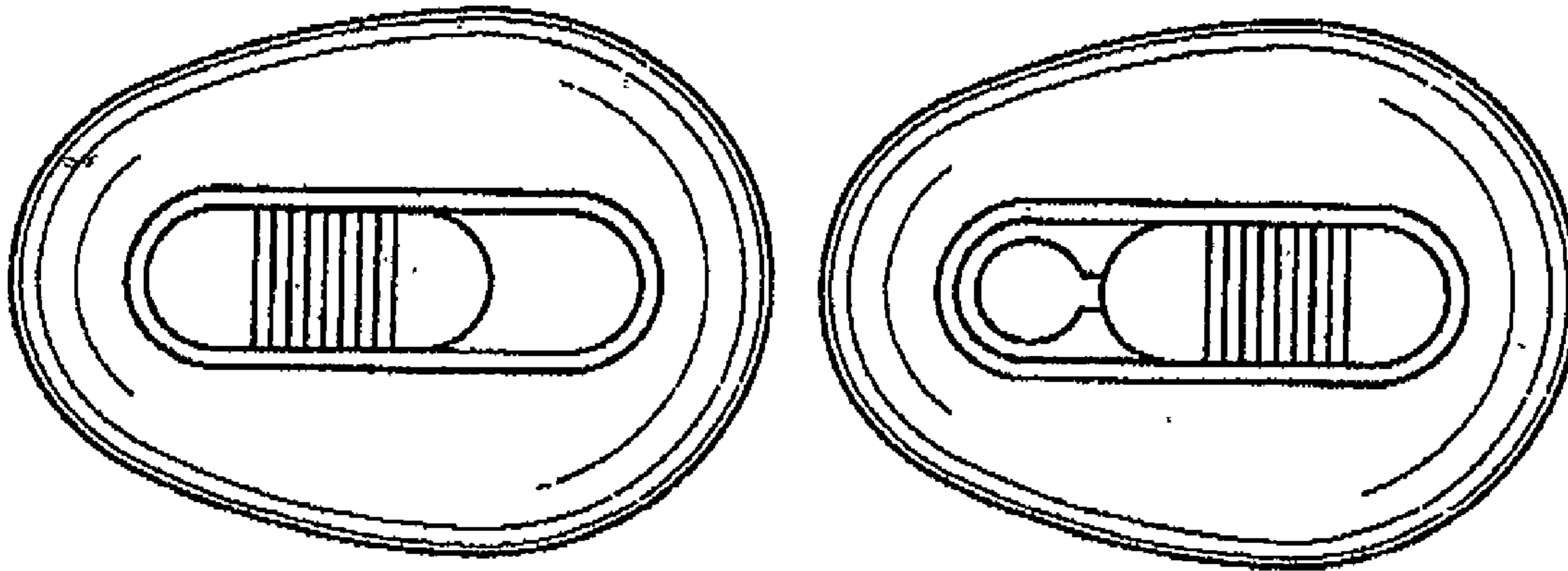
FIG. 1 is a top plan view of a dispenser showing my new design;

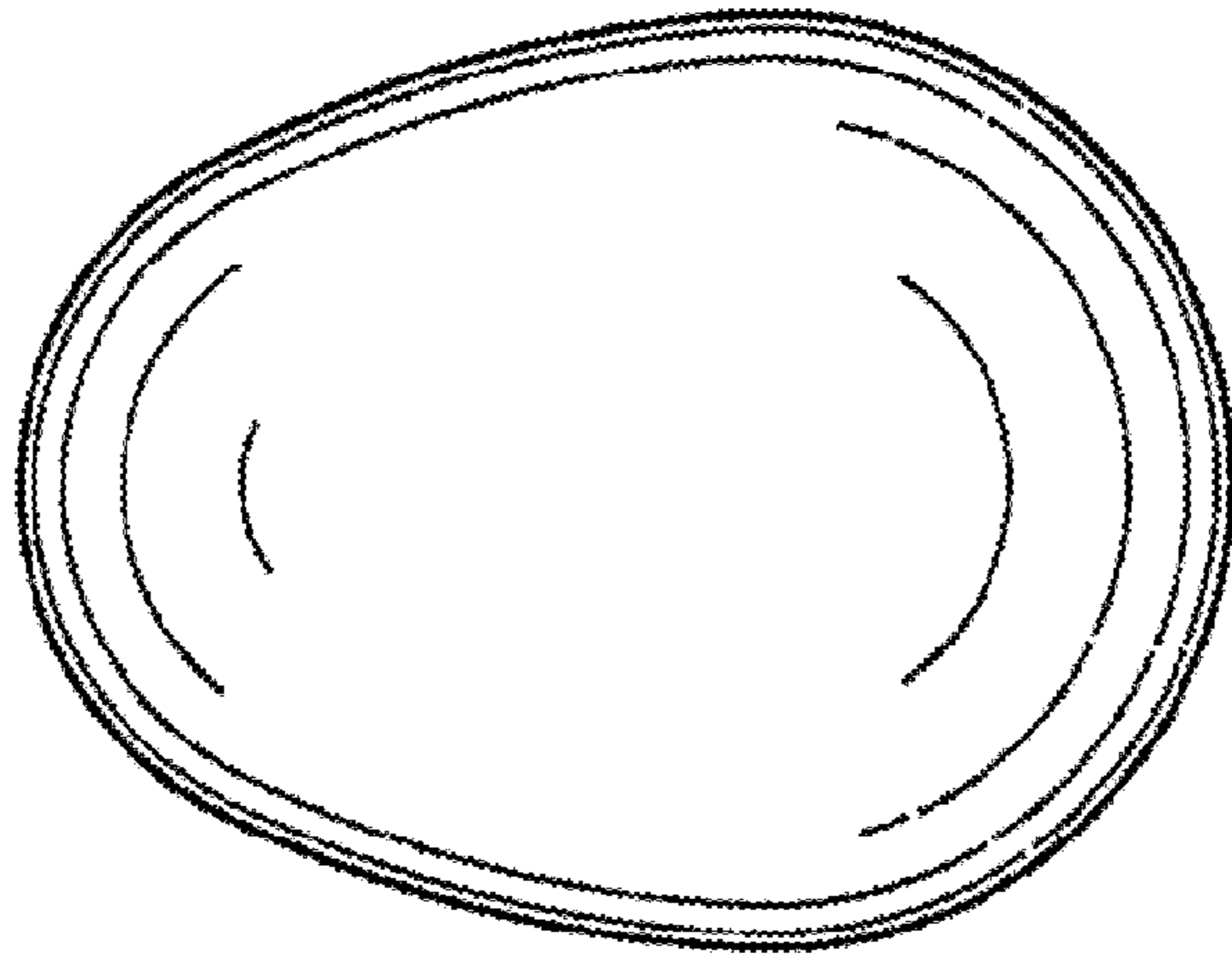

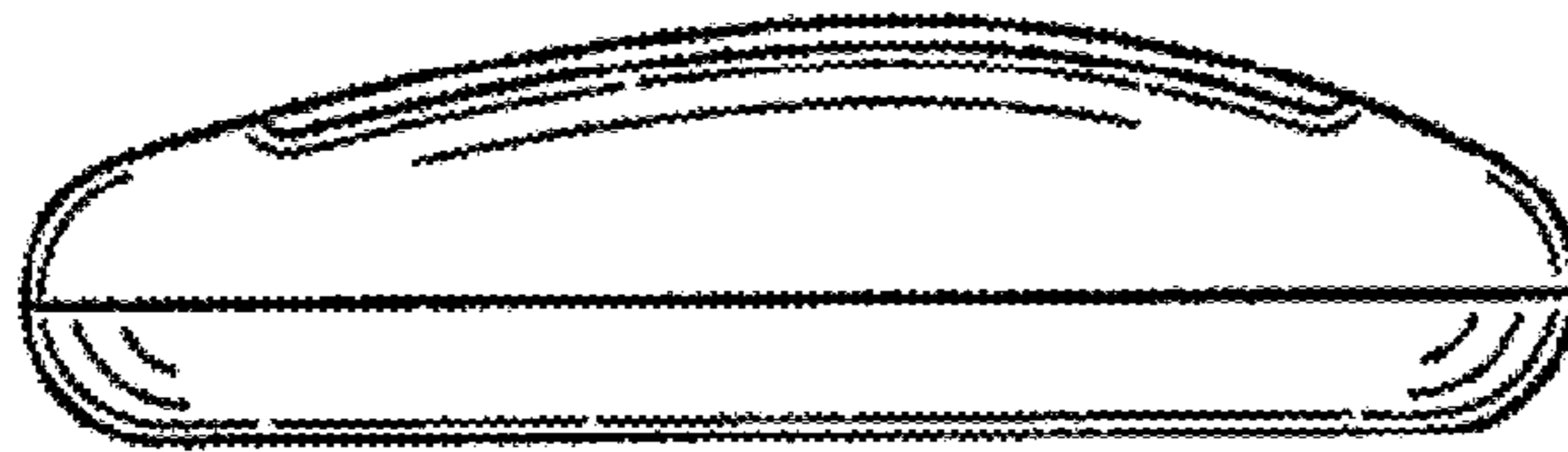

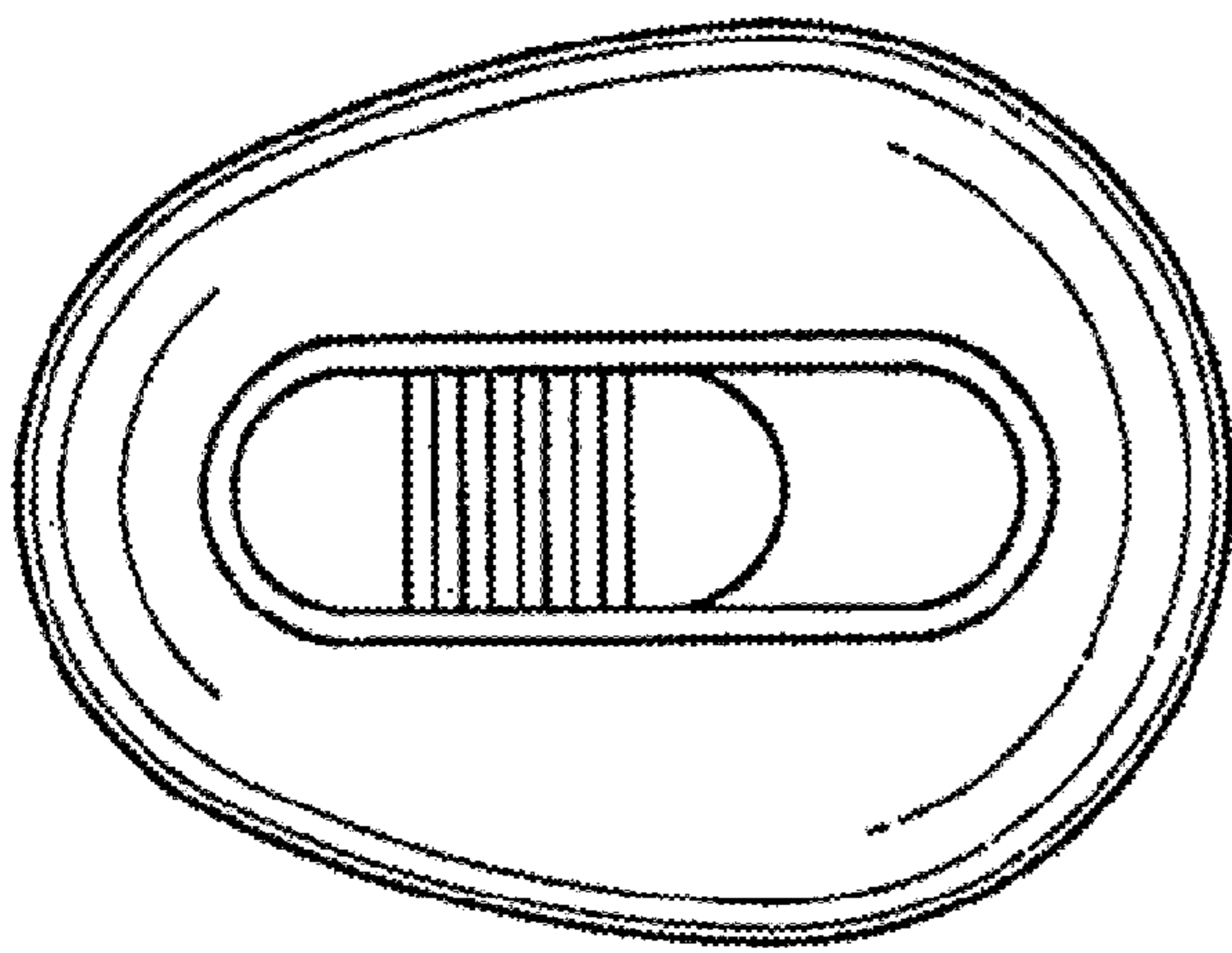

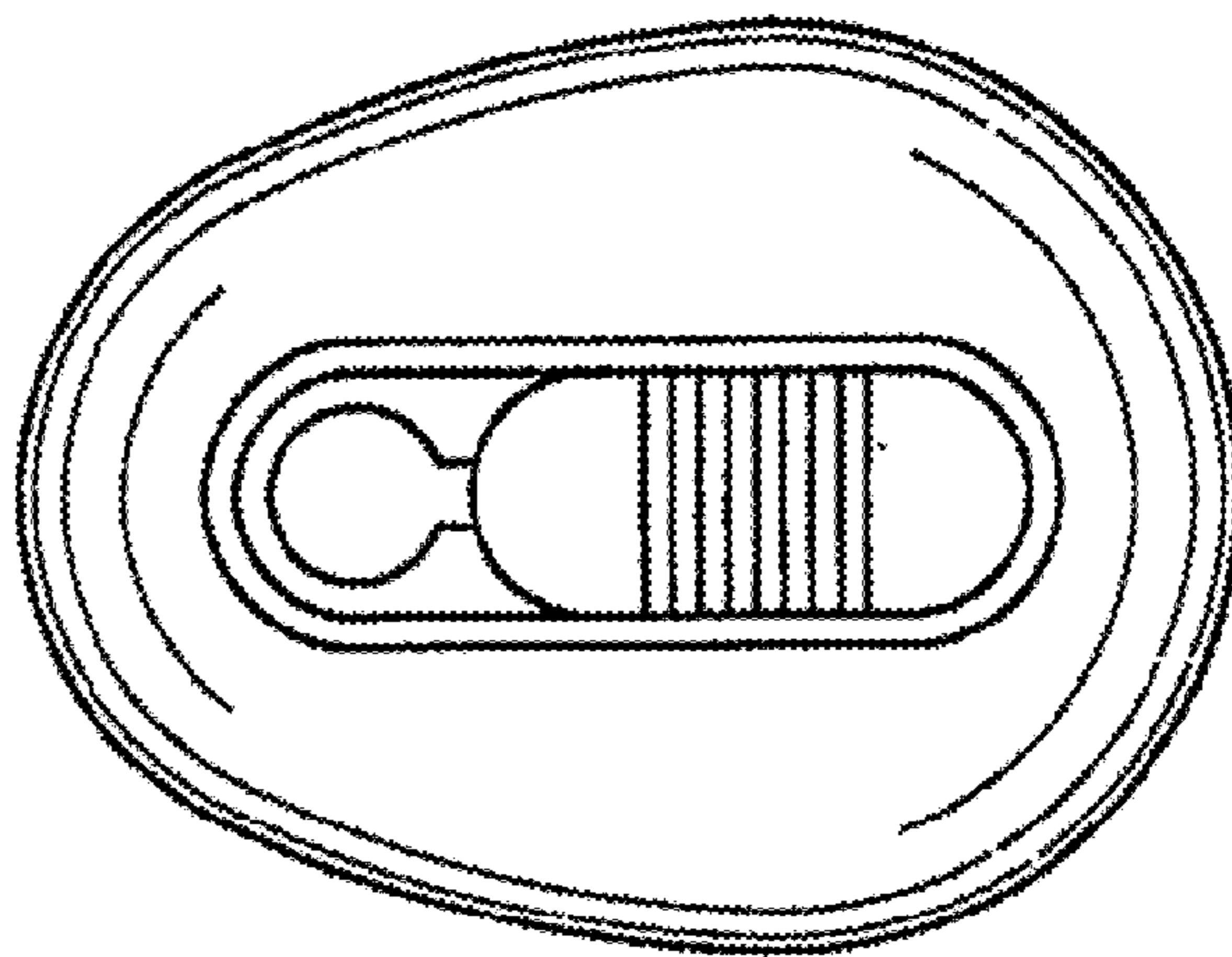
