DESCRIPTION

FIG. 1 is a right rear perspective view of an earth compactor, showing my new design wherein the broken lines are shown for illustrative purposes only and form no part of the claimed design.

FIG. 2 is a reduced perspective view thereof.

FIG. 3 is an enlarged left side elevation view thereof.

FIG. 4 is a top plan view thereof.

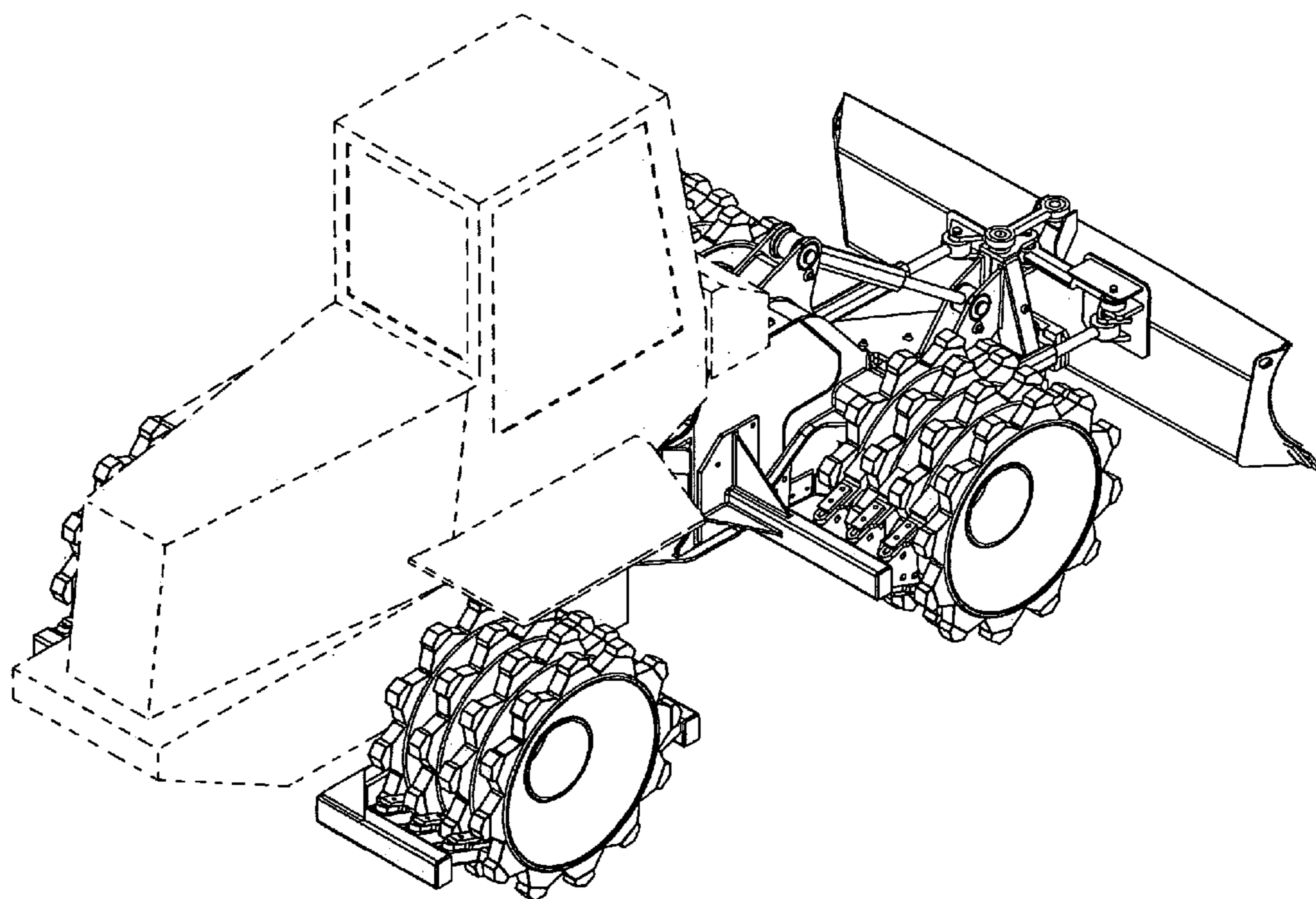
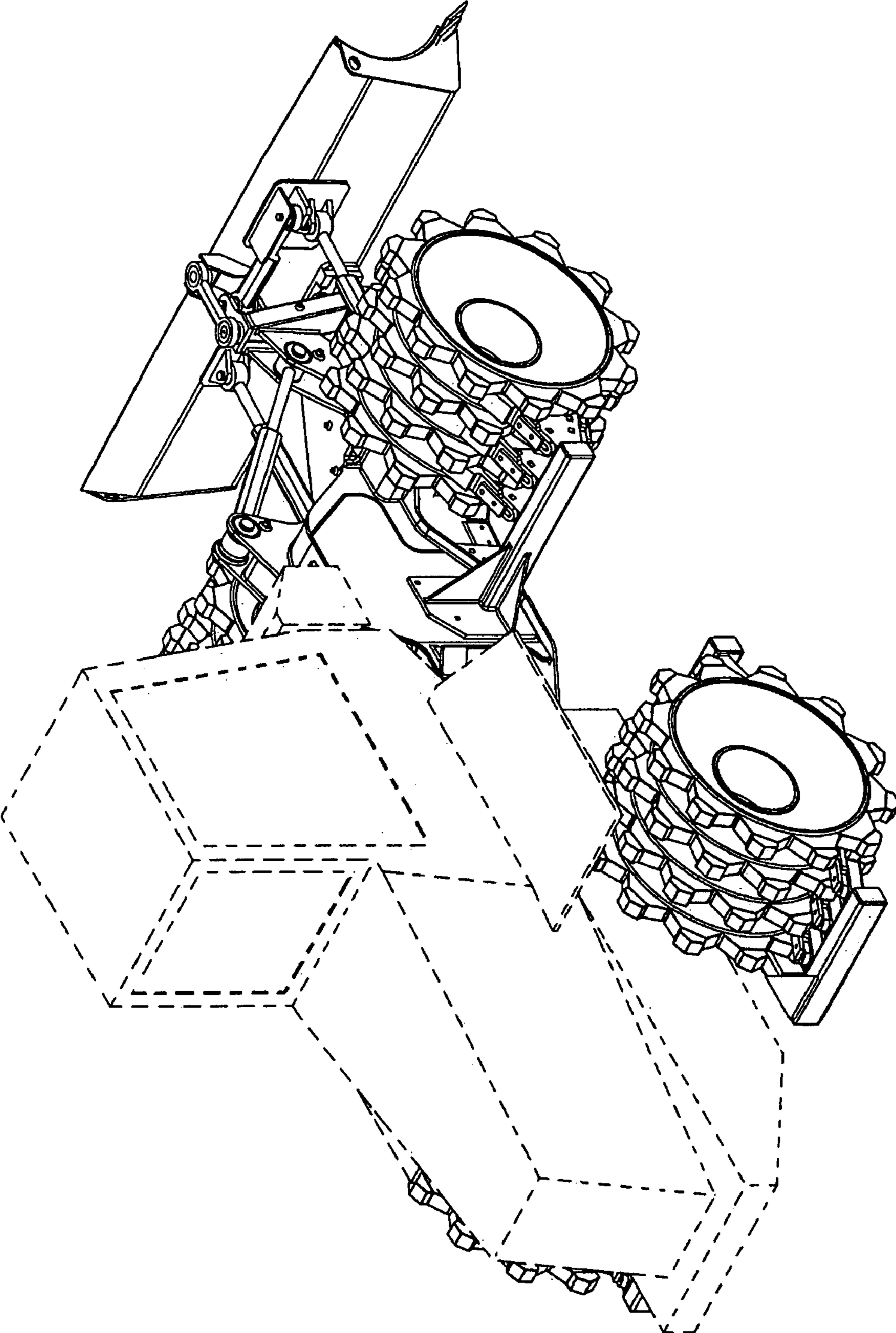

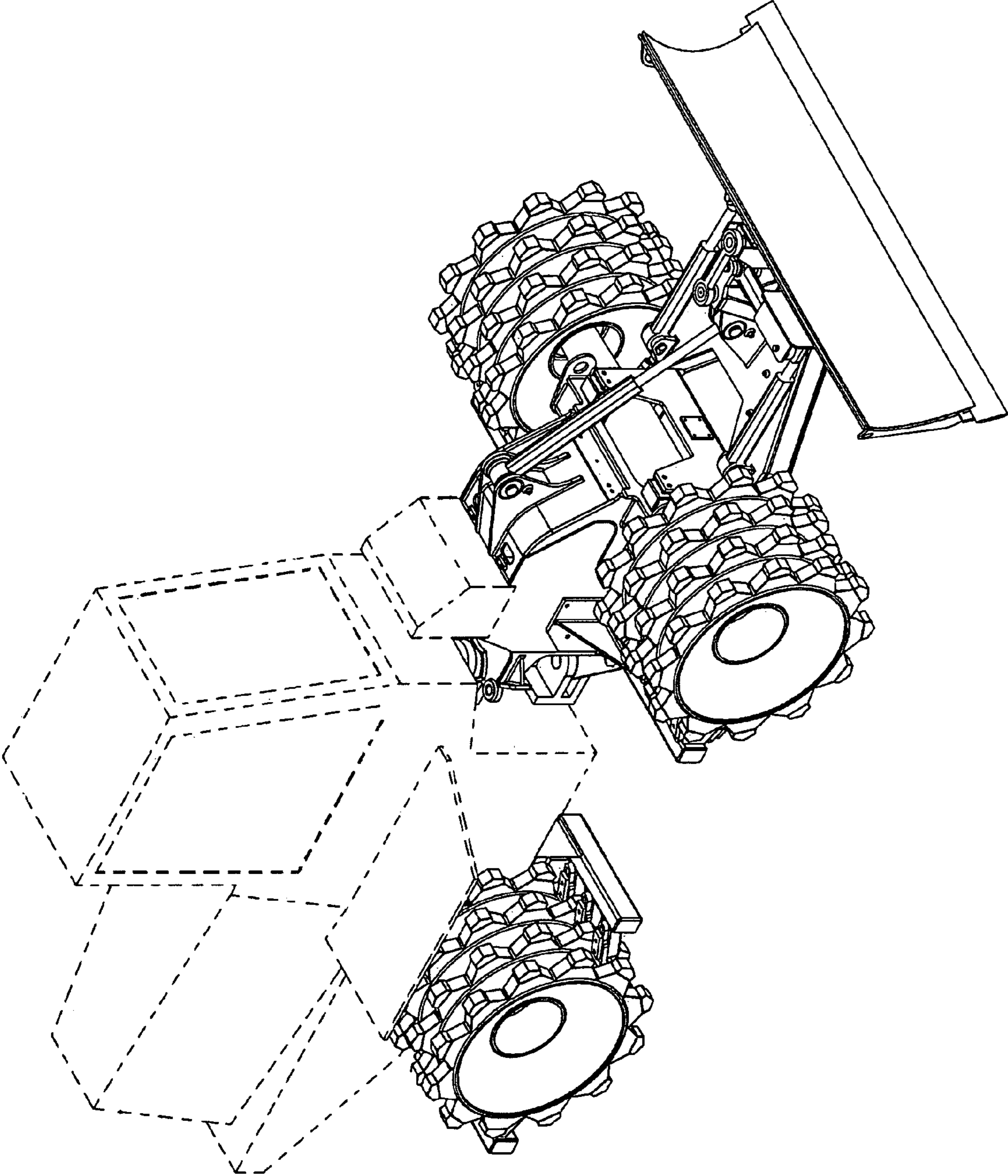

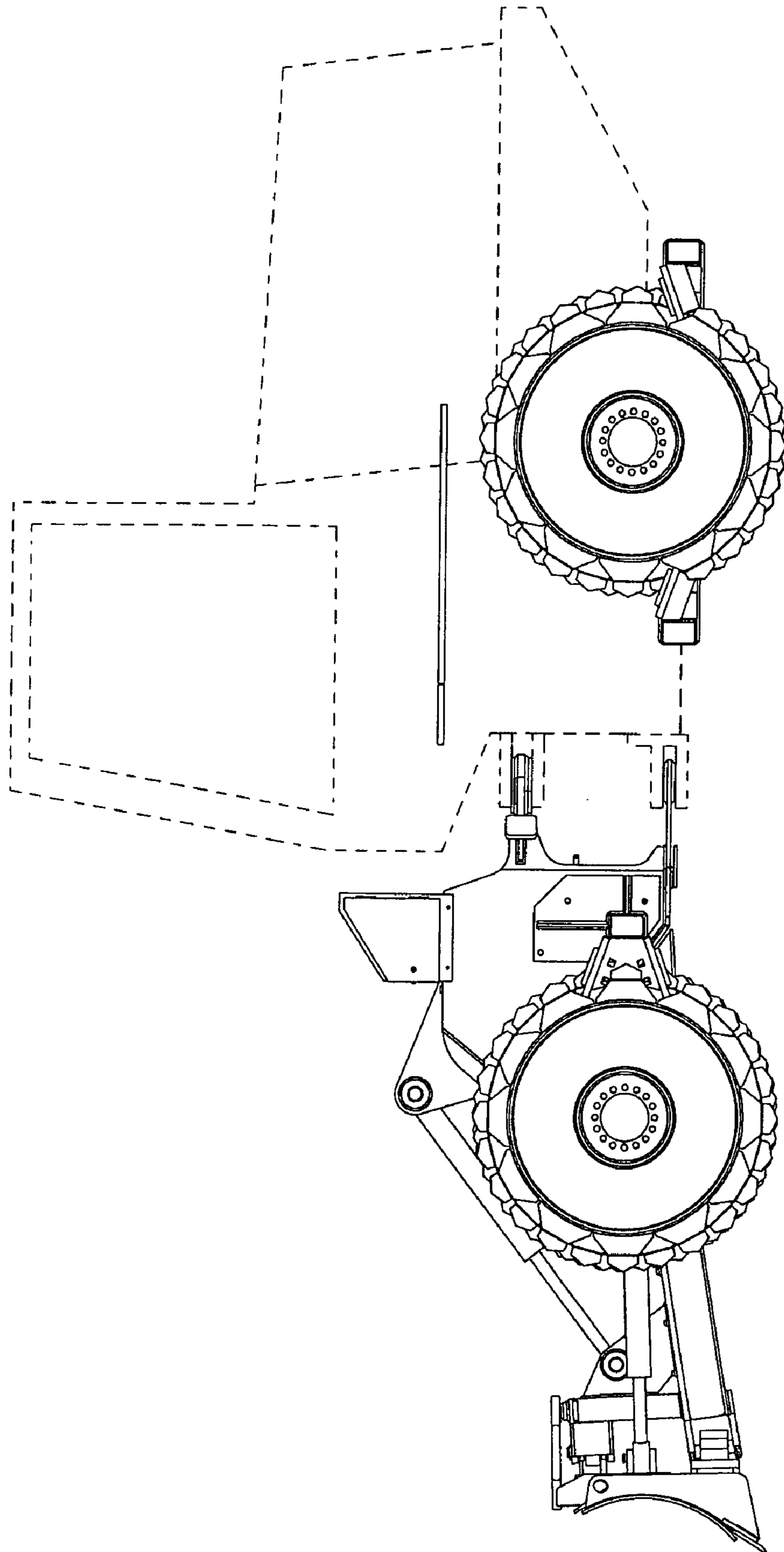

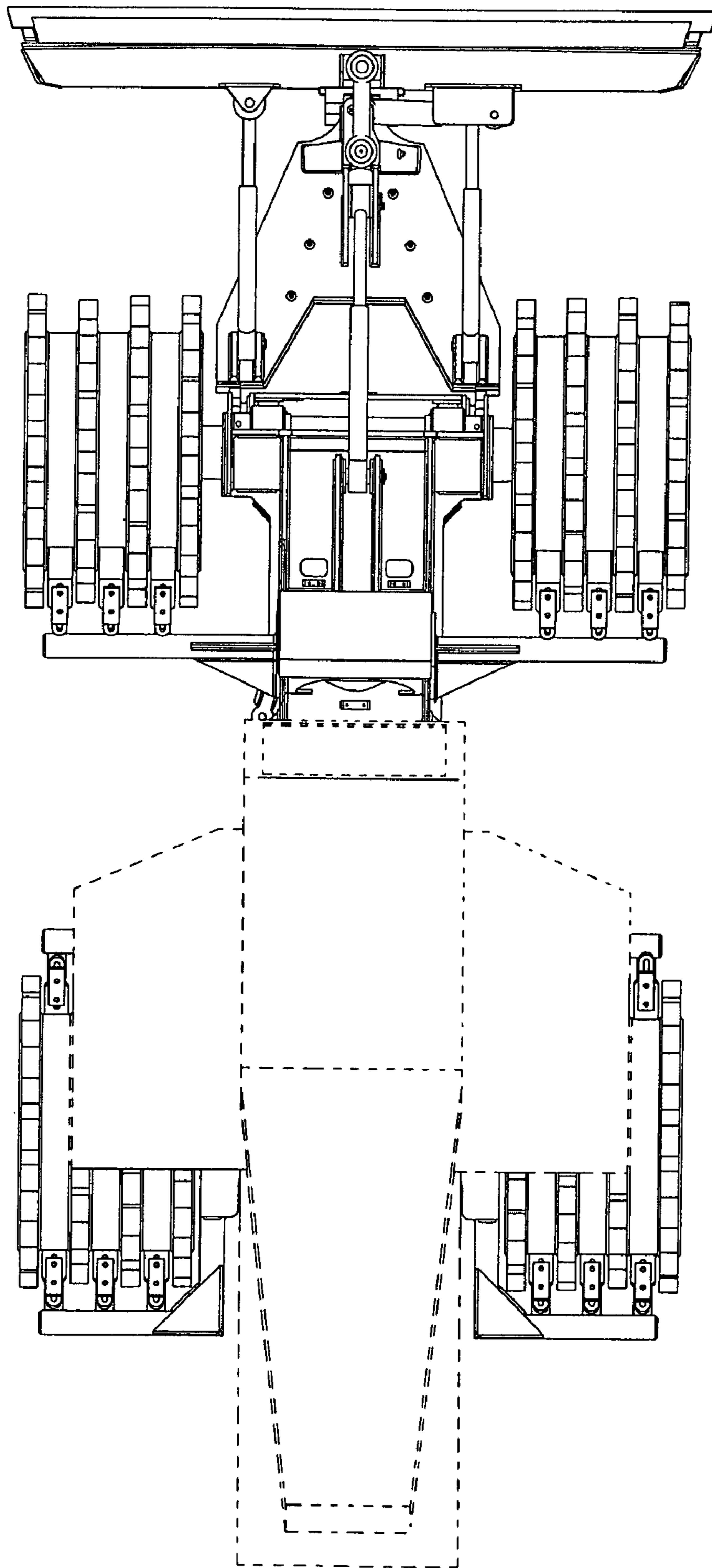
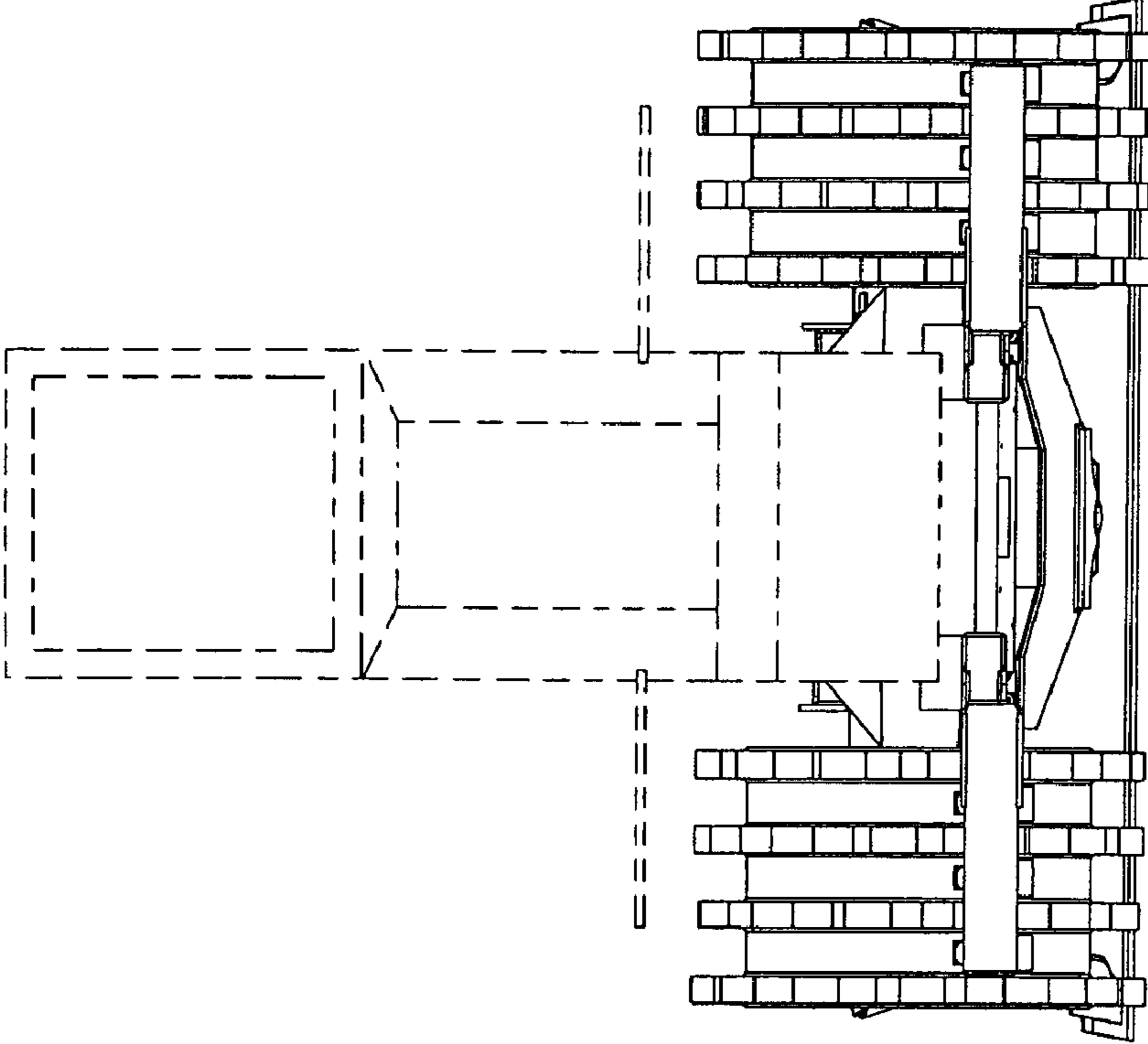

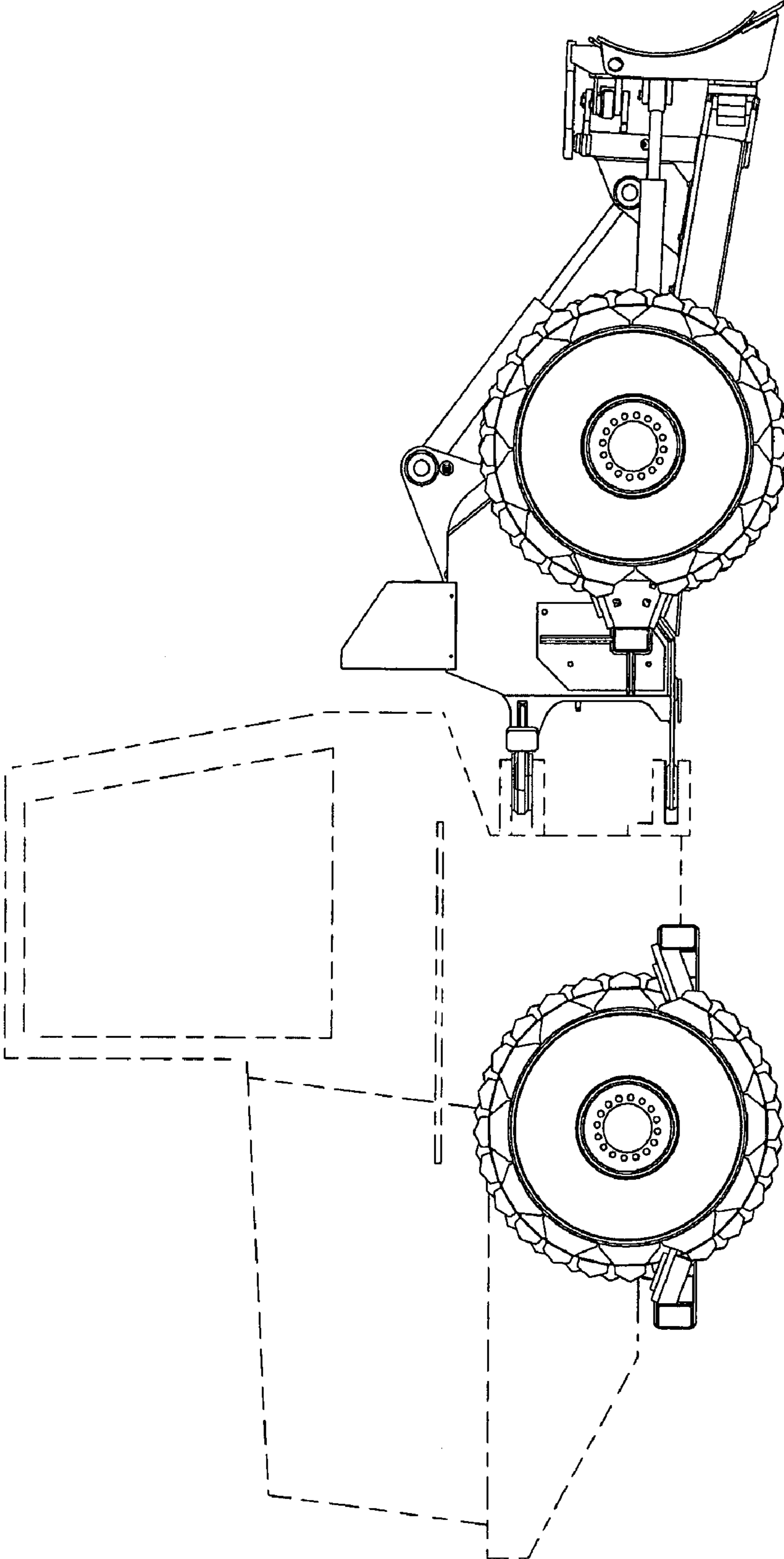
