FIG. 5 is a back view thereof.

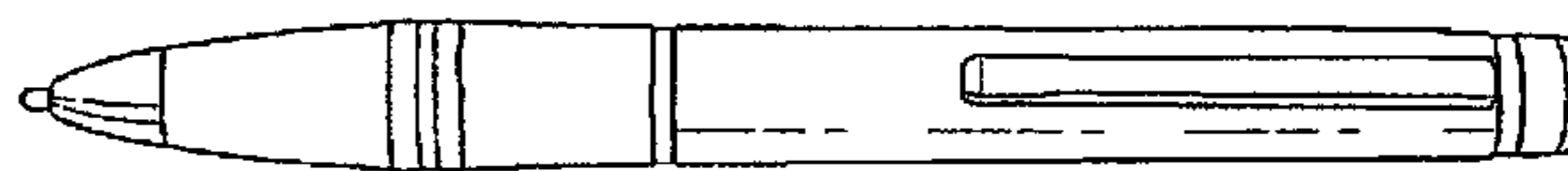
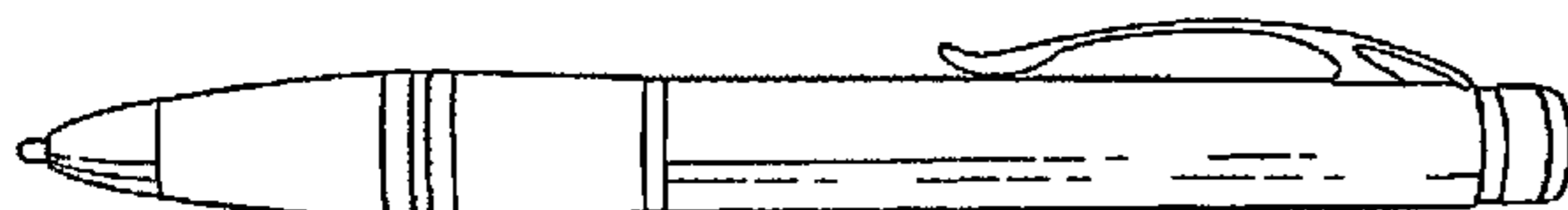
FIG. 6 is a bottom view thereof; and,

FIG. 7 is a top view thereof.

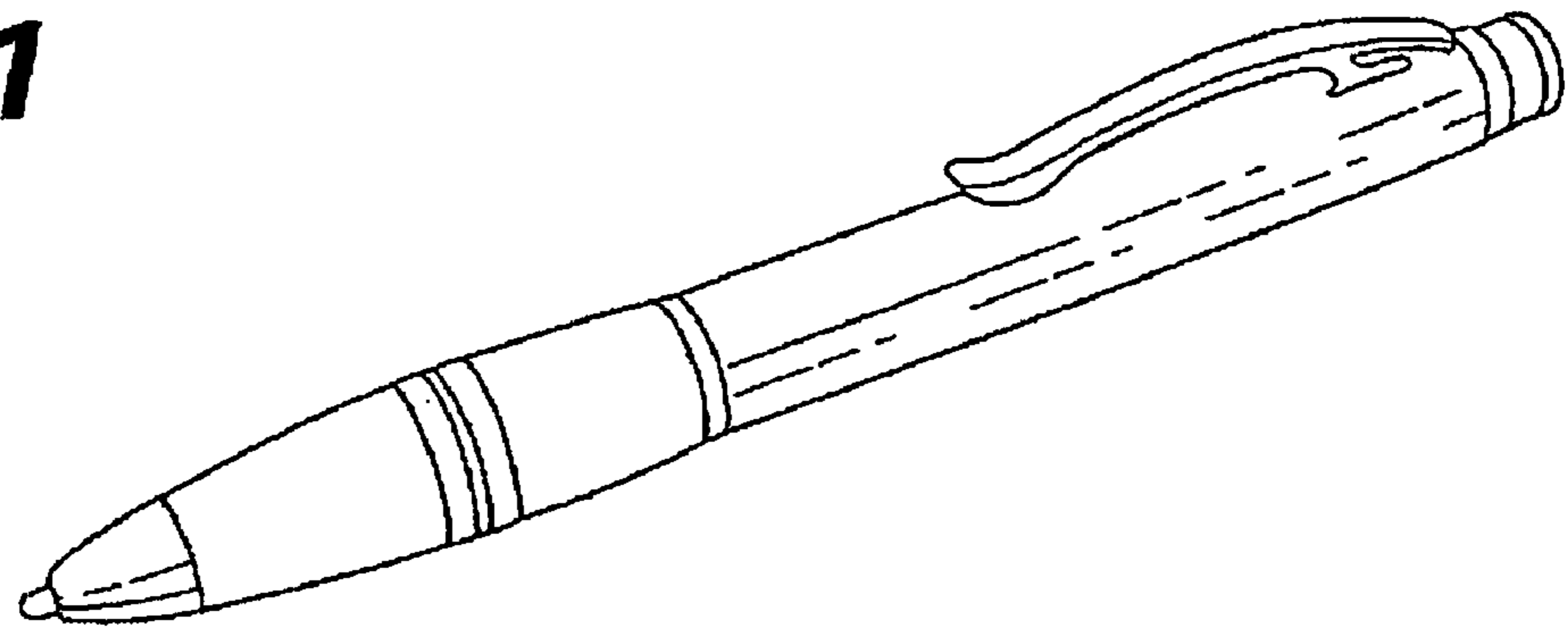

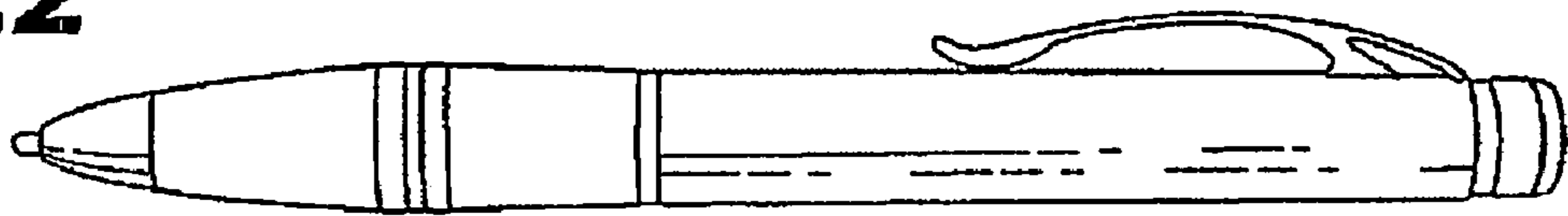

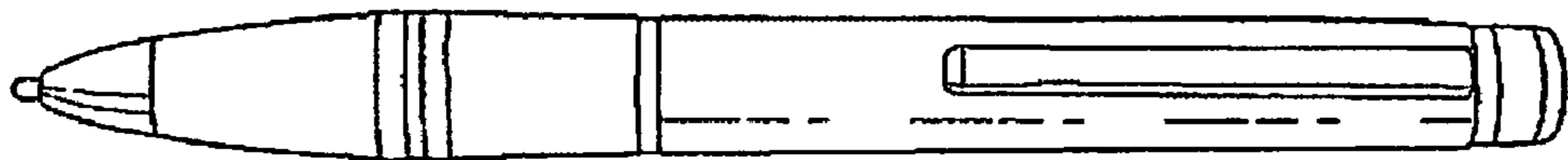

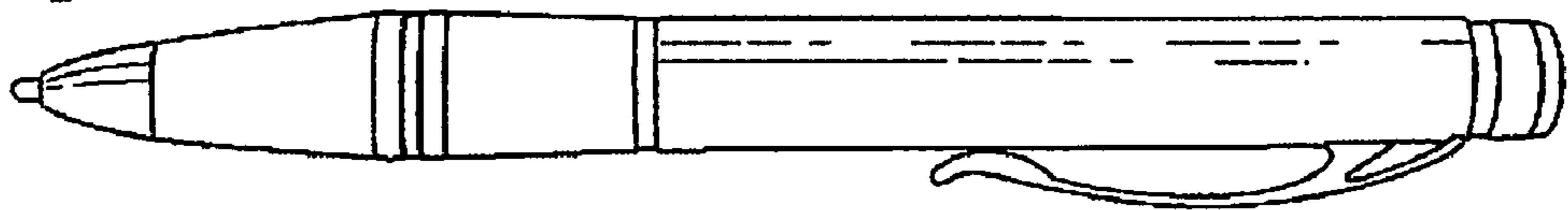

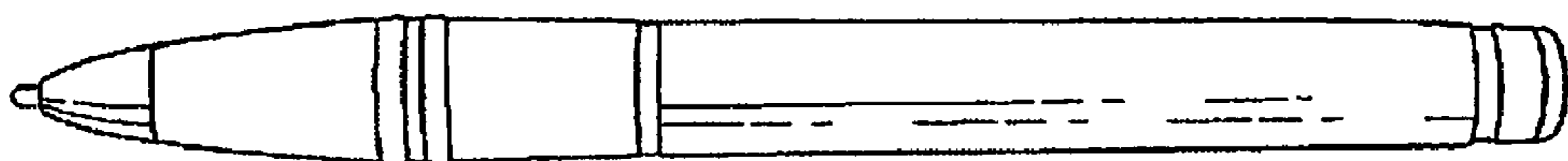

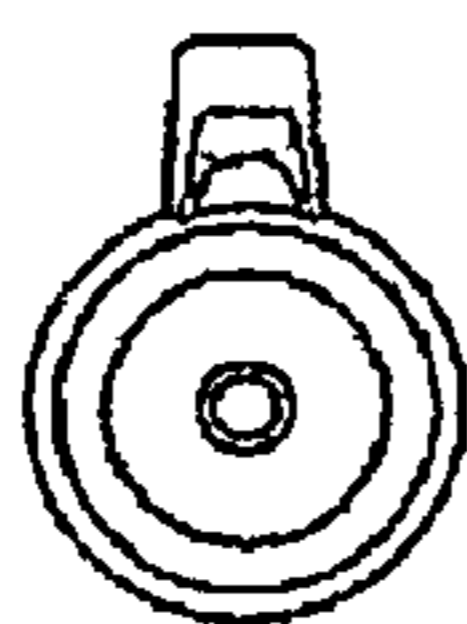
