FIG. 6 is a top plan view thereof, the unshown aspects of this modified embodiment being identical to what is shown and described in FIGS. 3 and 4.

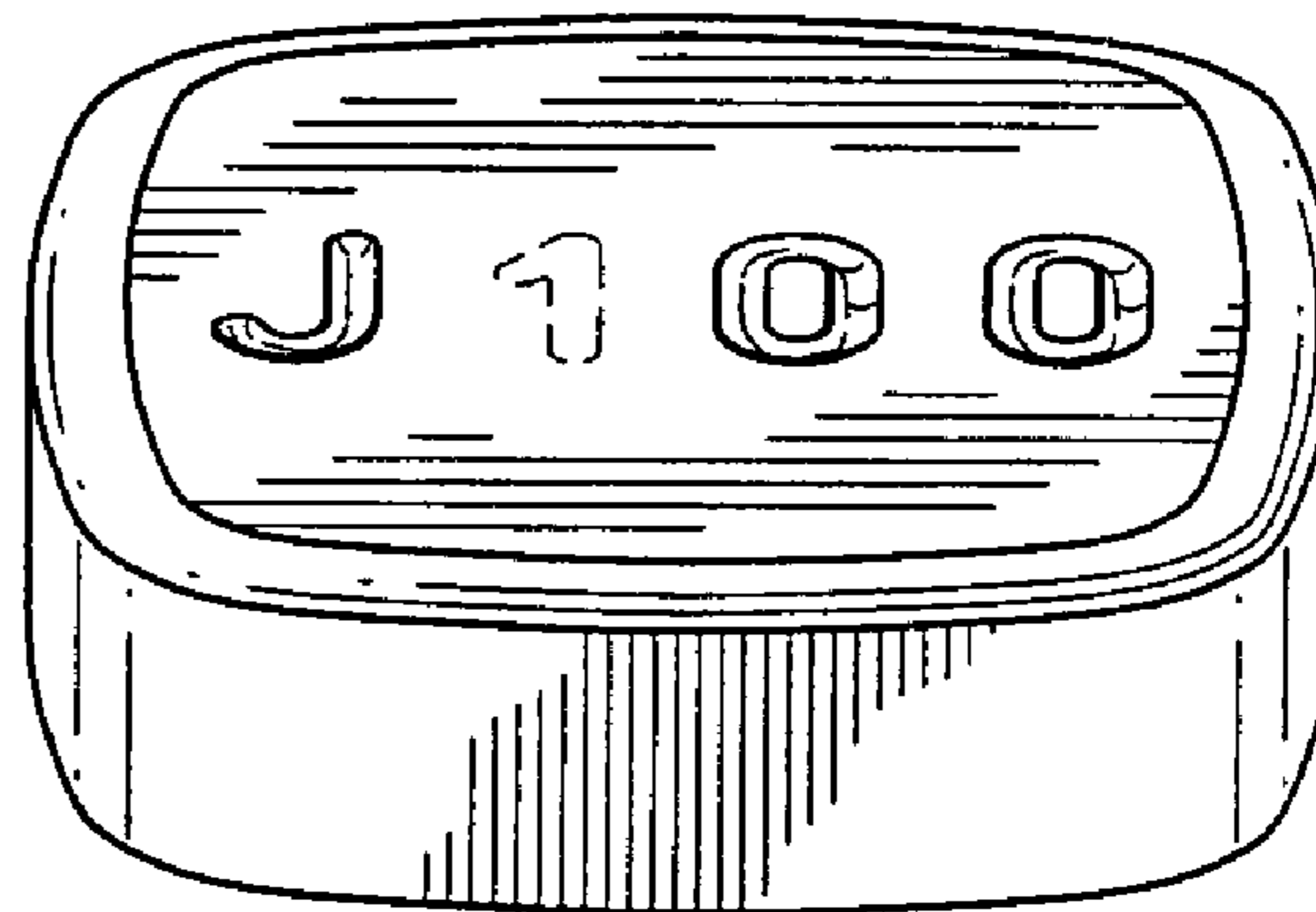
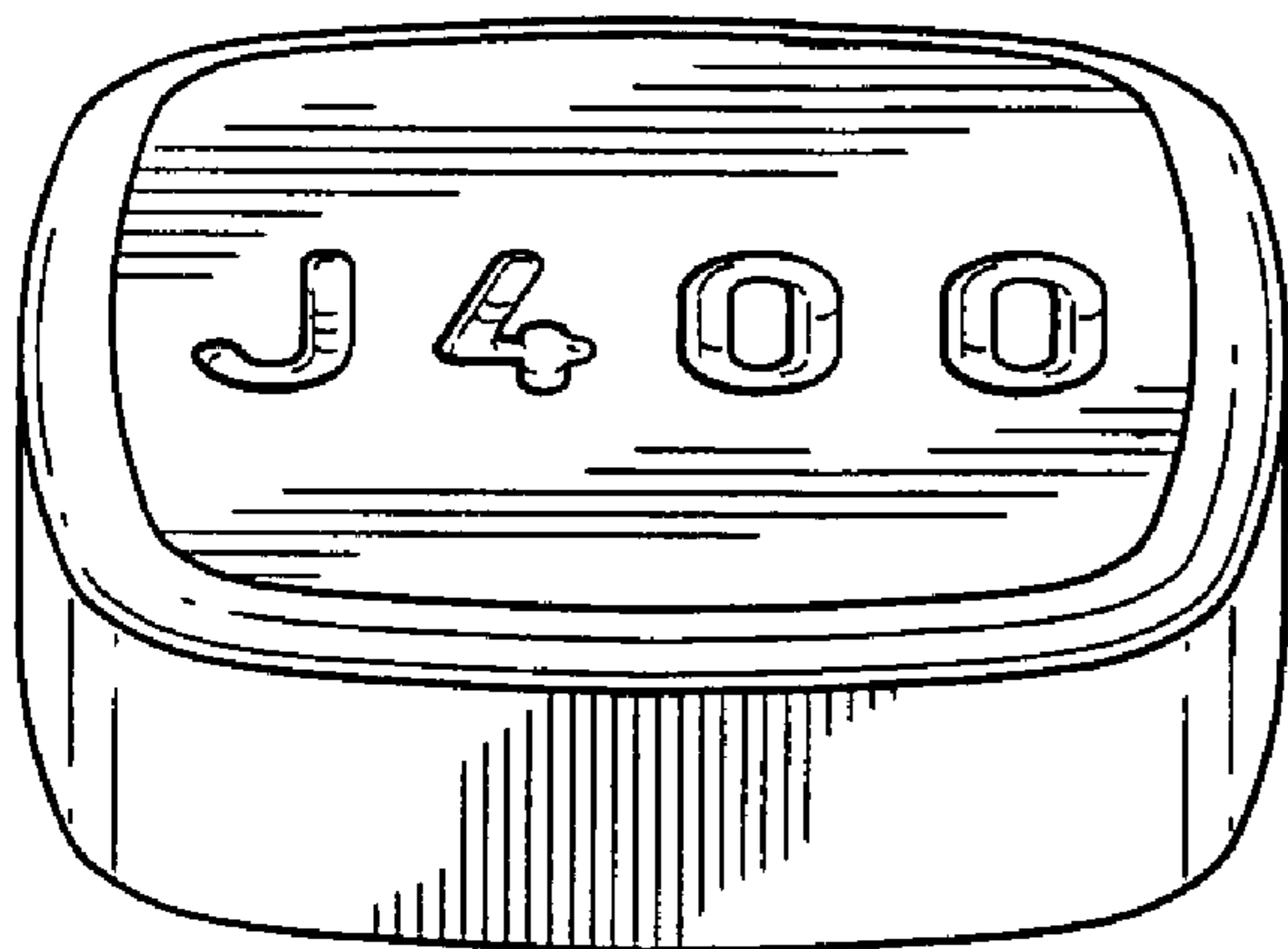

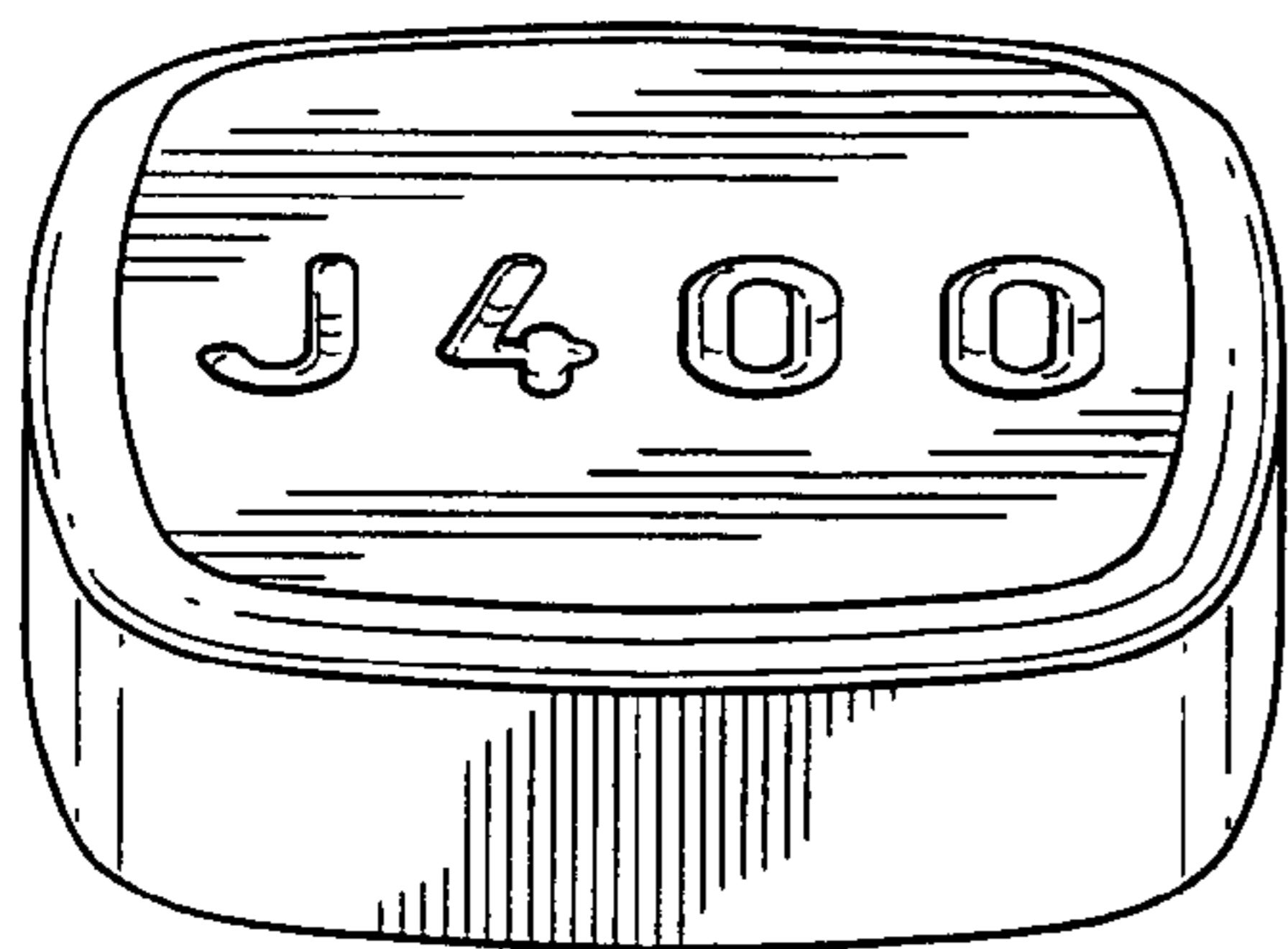

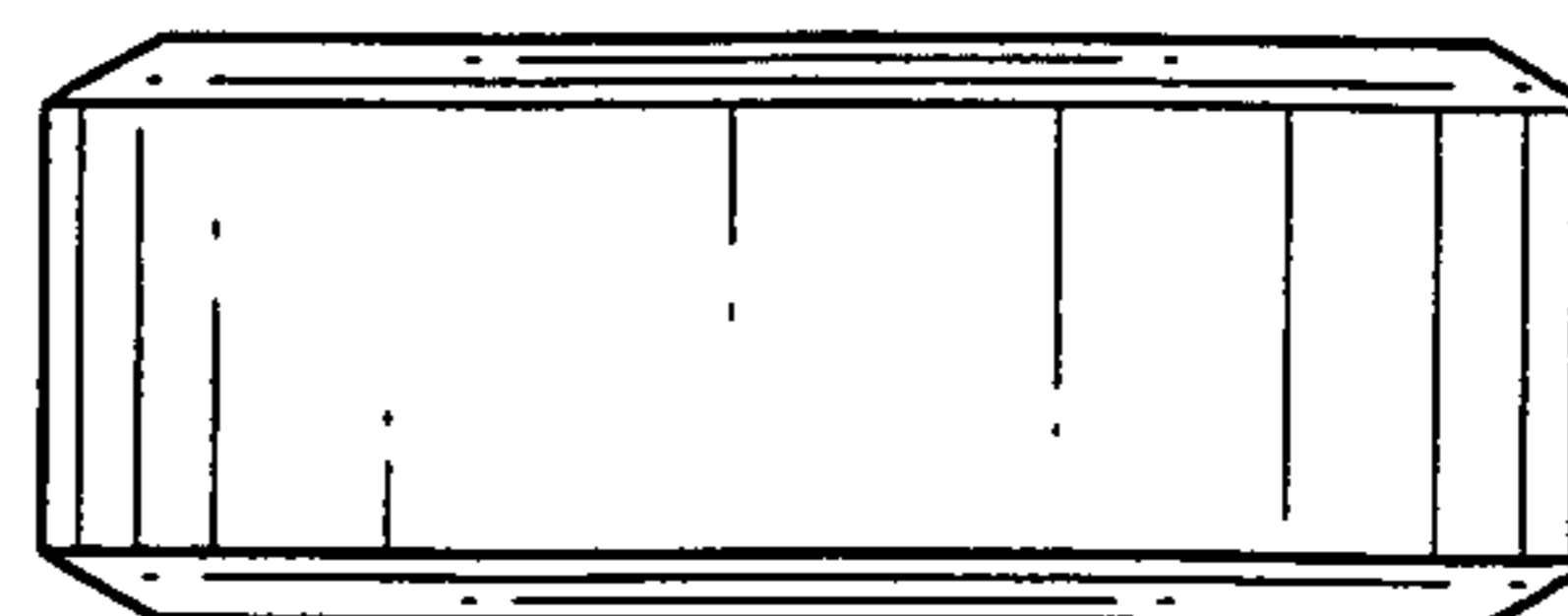

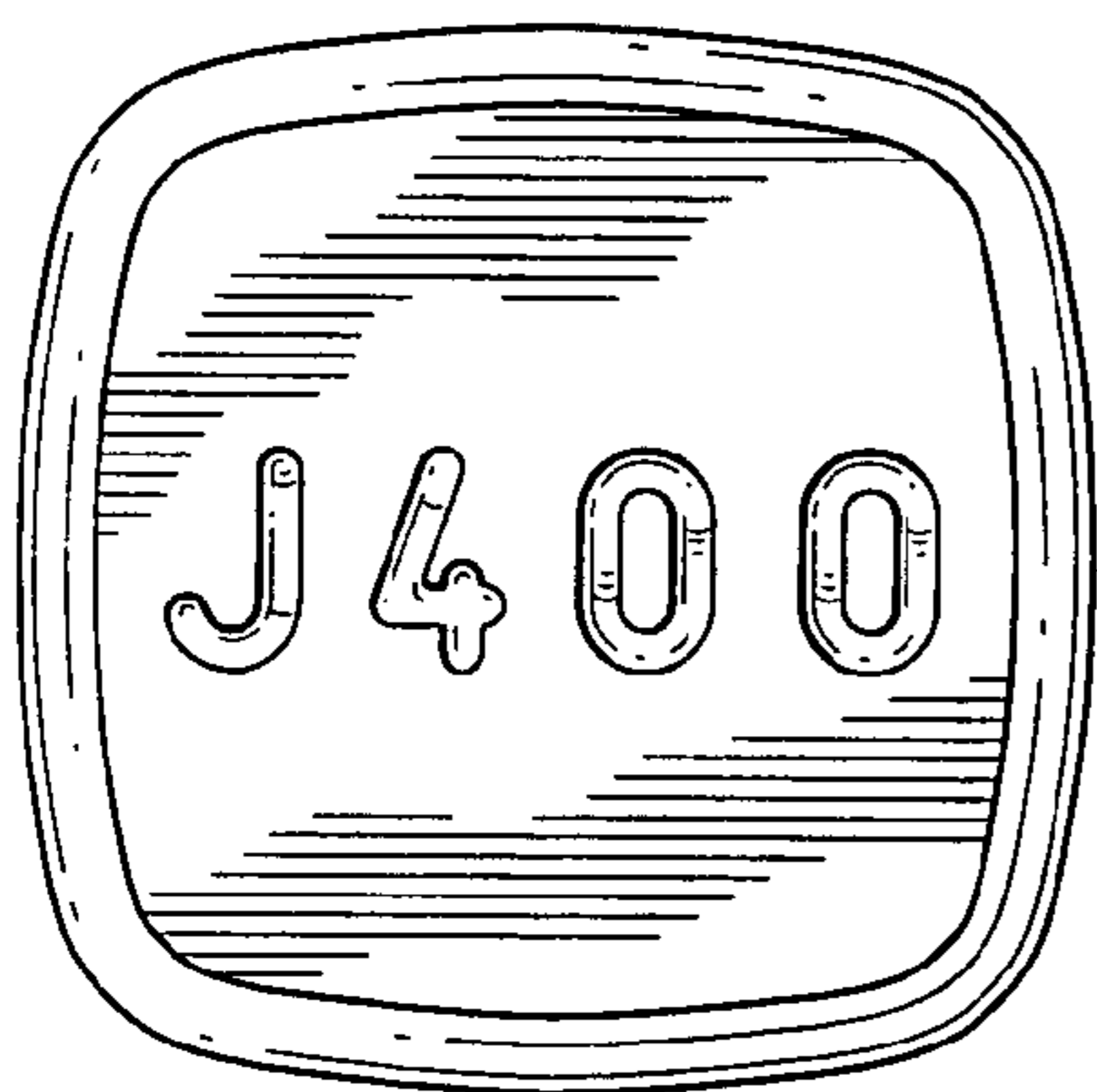

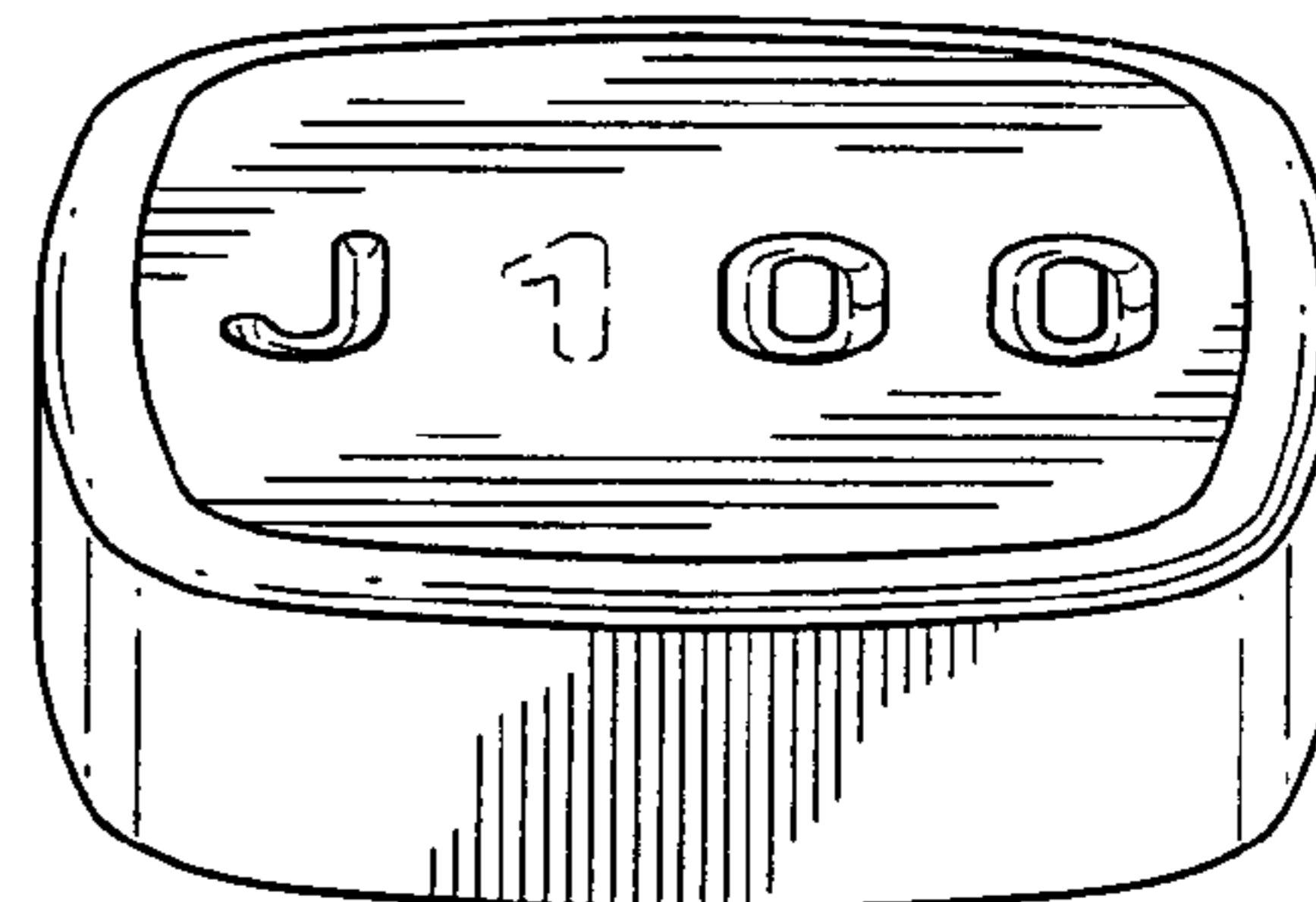

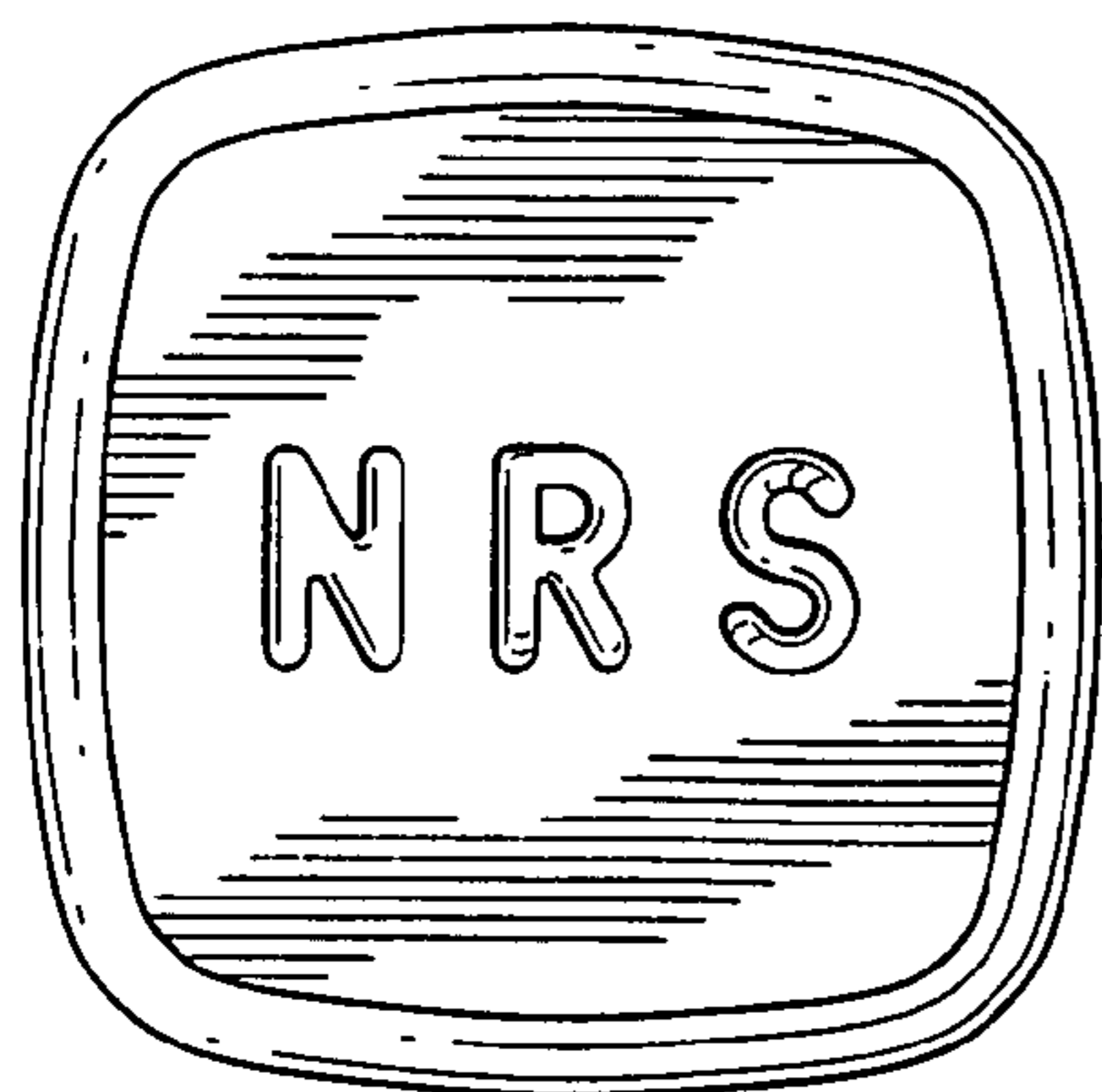

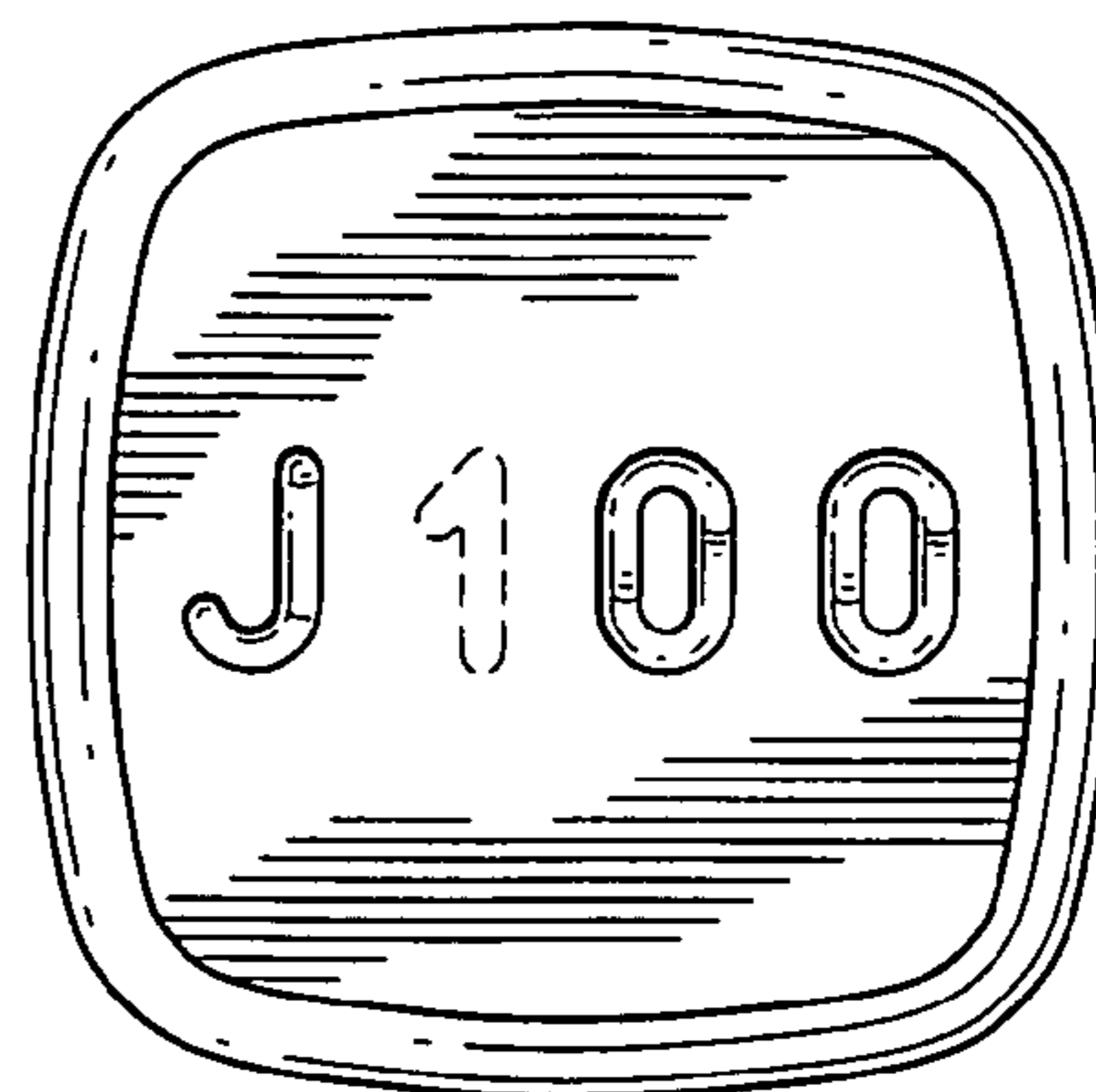
