DESCRIPTION

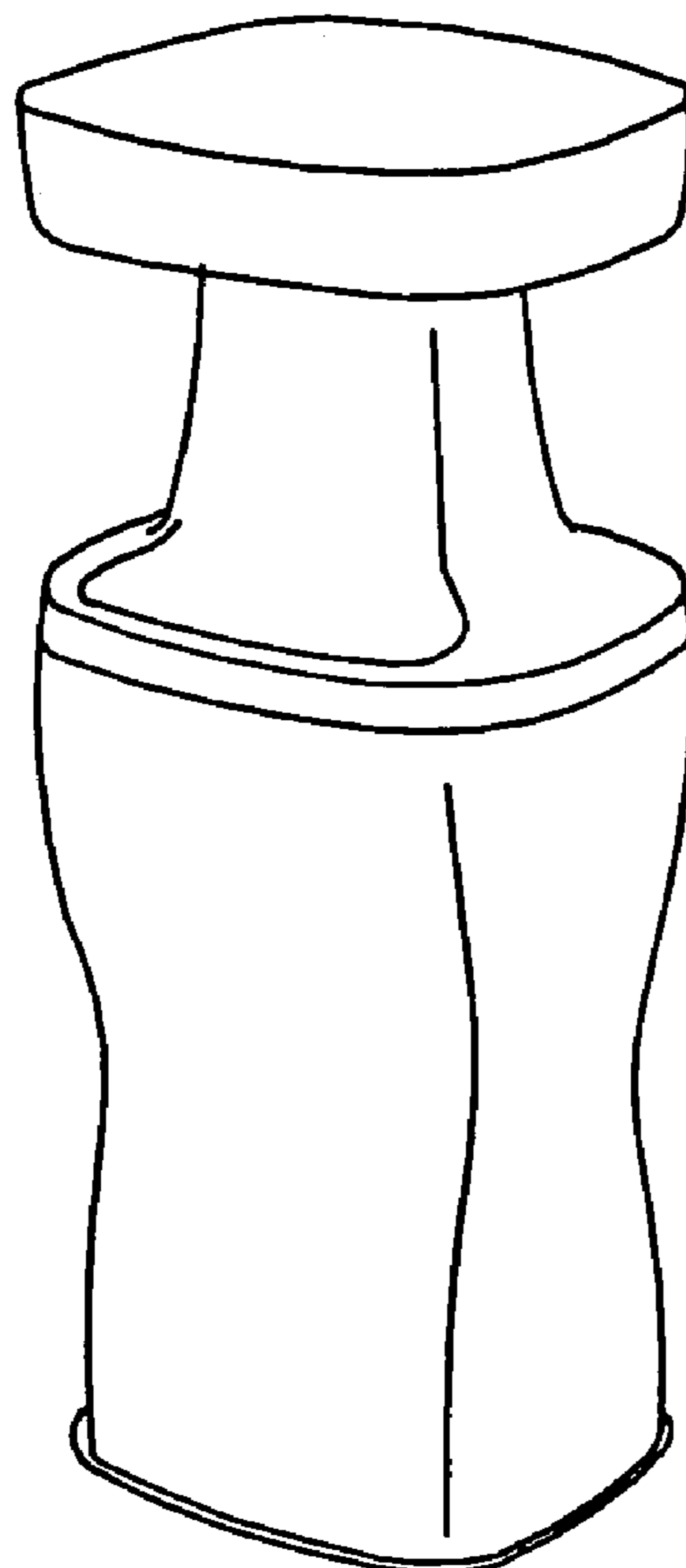
FIG. 1 is a perspective, front and left-side view showing my design. The rear view and right-side view are mirror images thereof.

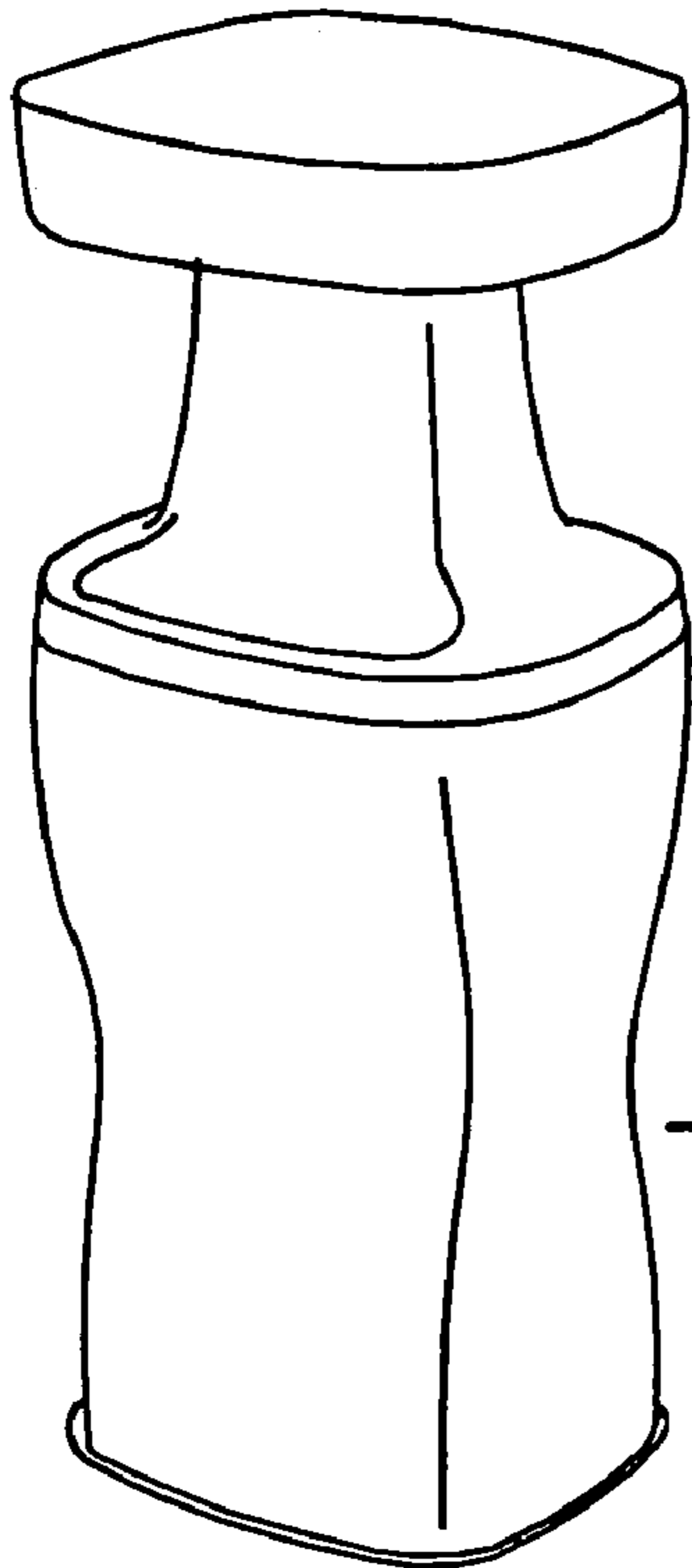

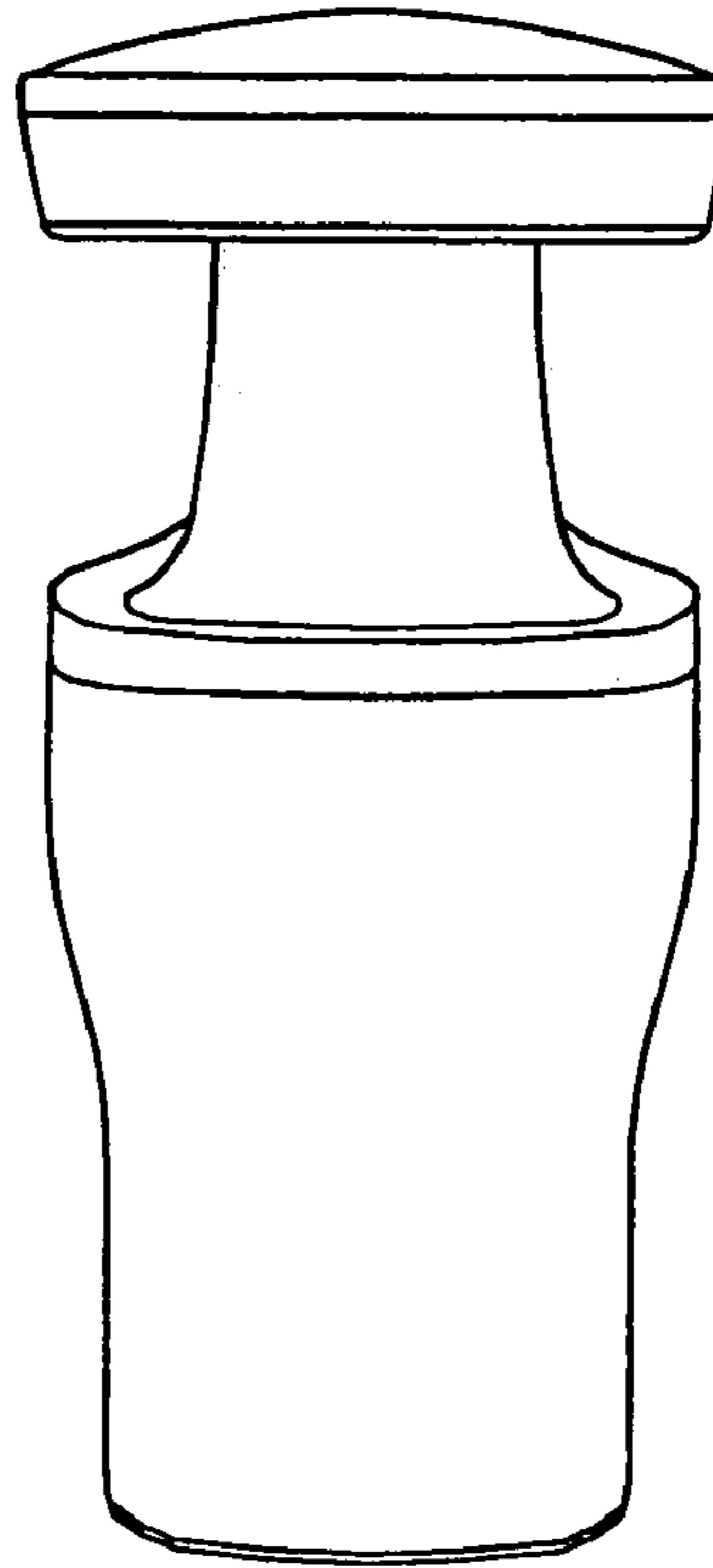

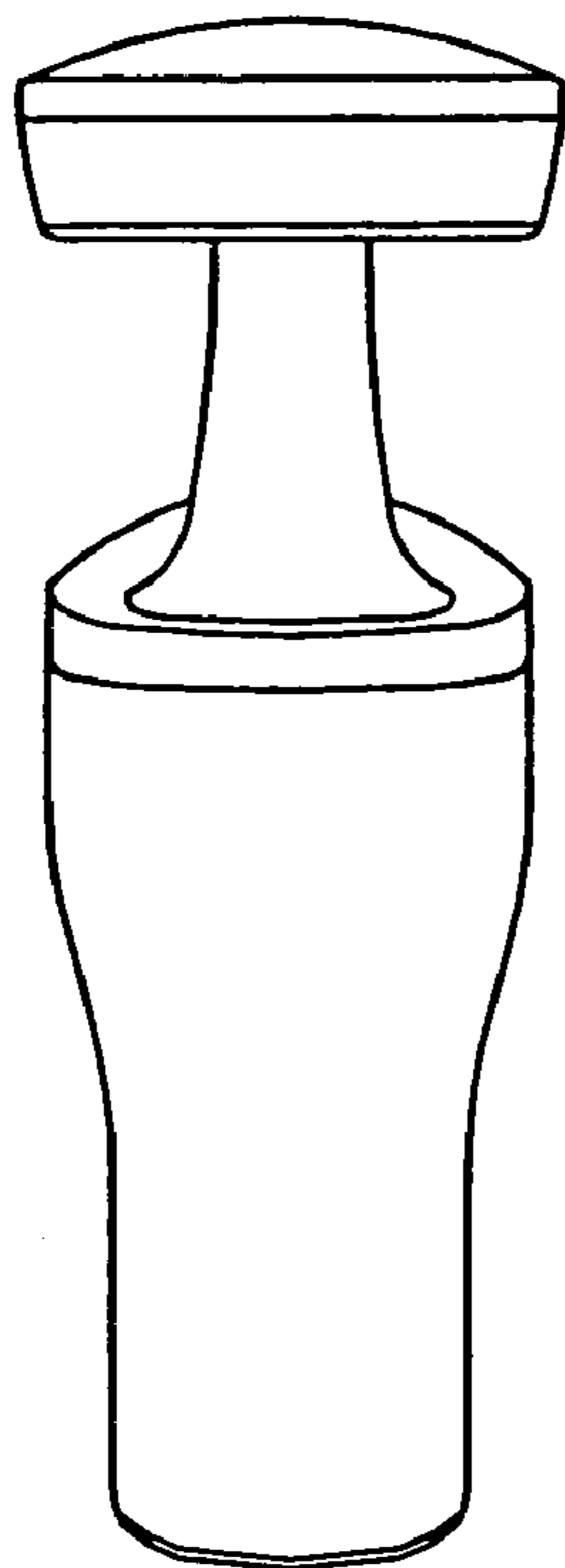

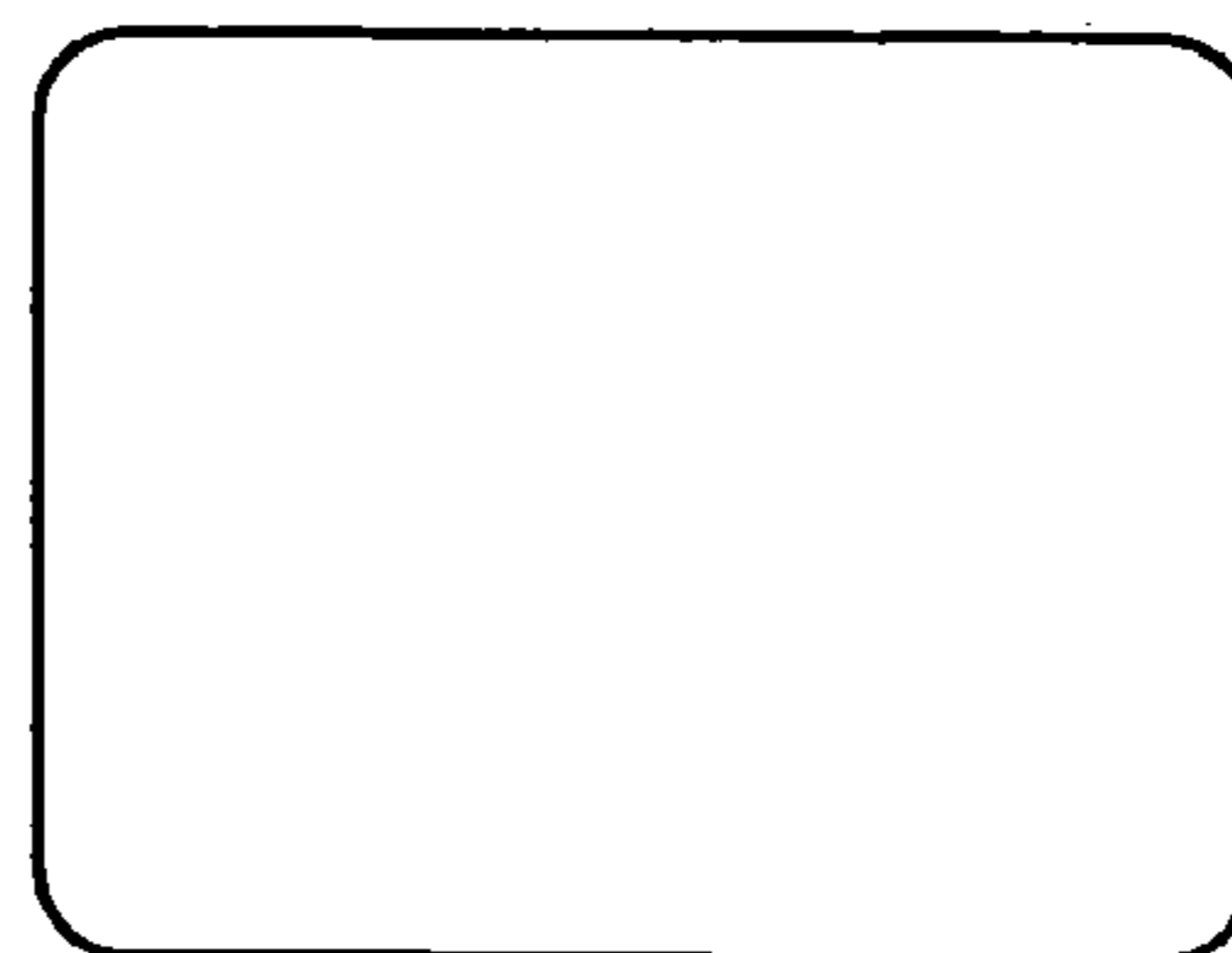
