(57) **CLAIM**

The ornamental design for a cosmetic case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cosmetic case according to my new design;

FIG. 2 is a top elevational view of the cosmetic case;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a bottom elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a left-side elevational view of the cosmetic case;

FIG. 7 is a right-side elevational view thereof;

FIG. 8 is a perspective view of the cosmetic case with the upper and lower portions thereof separated from one another;

FIG. 9 is a perspective view of the upper portion of the cosmetic case in an open condition;

FIG. 10 is an elevational view of the bottom of the upper portion of the cosmetic case;

FIG. 11 is an elevational view of the front of the upper portion thereof;

FIG. 12 is an elevational view of the rear of the upper portion thereof;

FIG. 13 is an elevational view of the left side of the upper portion thereof;

FIG. 14 is an elevational view of the right side of the upper portion thereof;

FIG. 15 is a perspective view of the lower portion of the cosmetic case in an open condition;

FIG. 16 is an elevational view of the front of the lower portion of the cosmetic case;

FIG. 17 is an elevational view of the left side of the lower portion thereof;

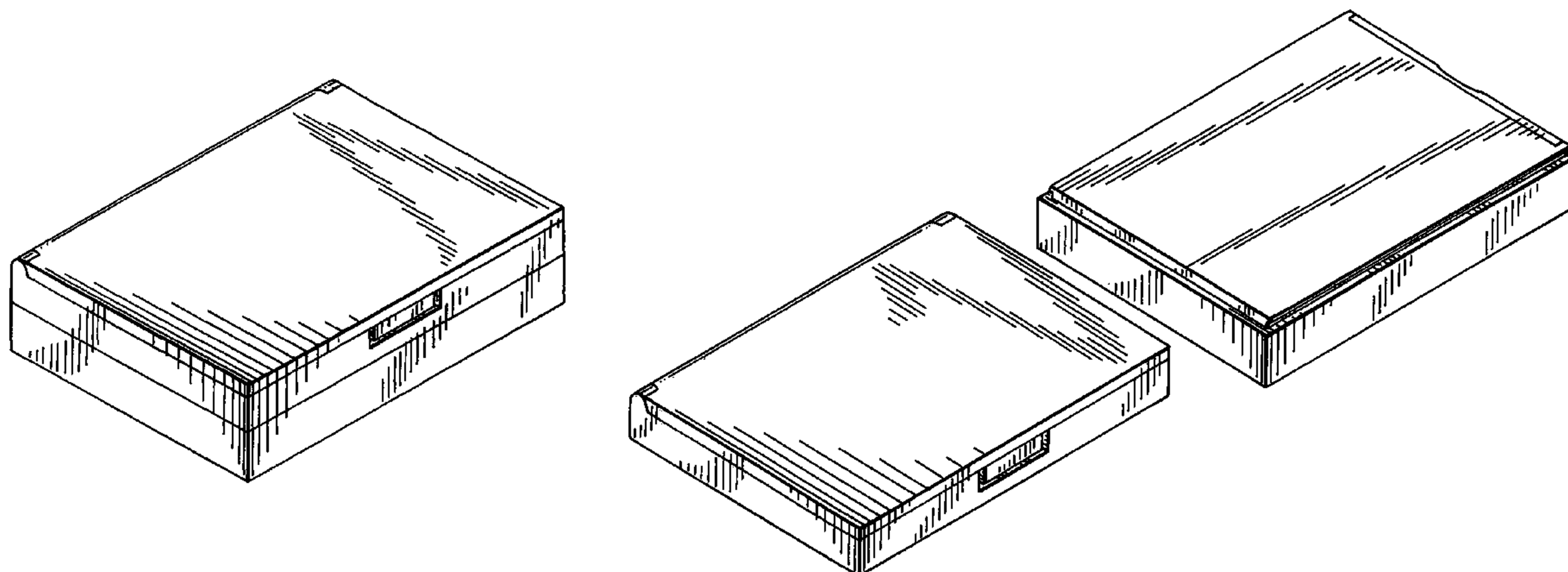
FIG. 18 is an elevational view of the right side of the lower portion thereof;

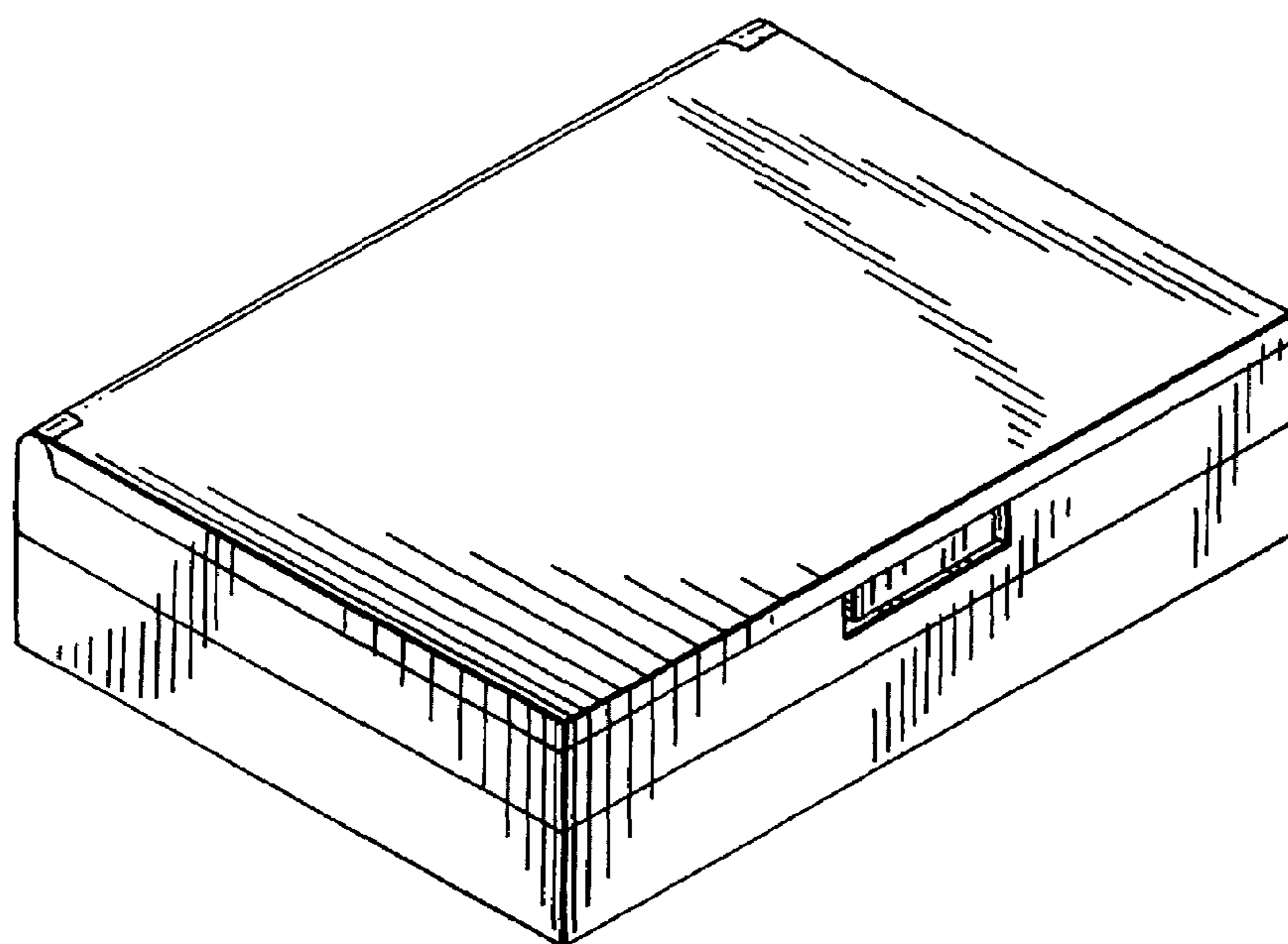

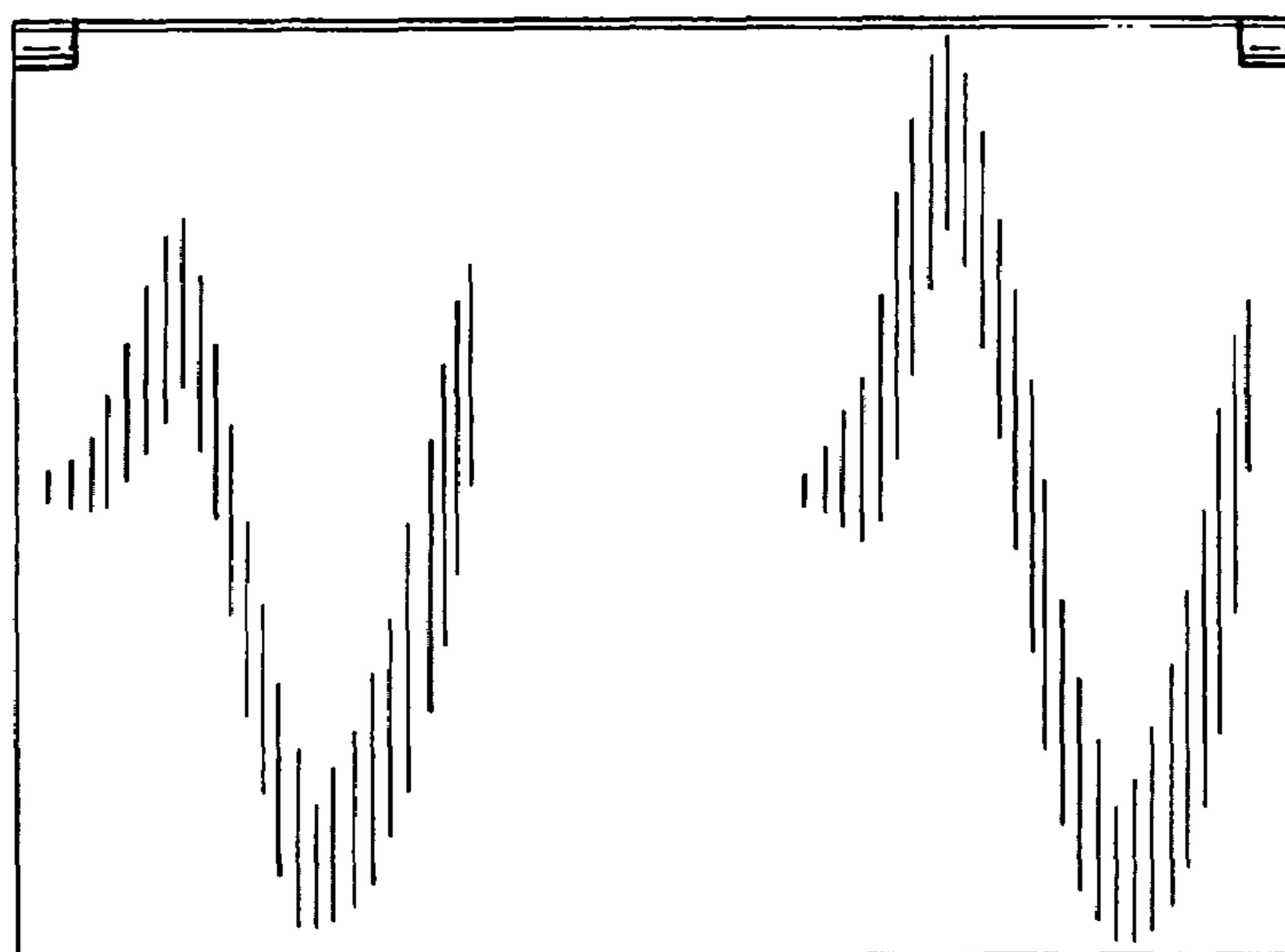

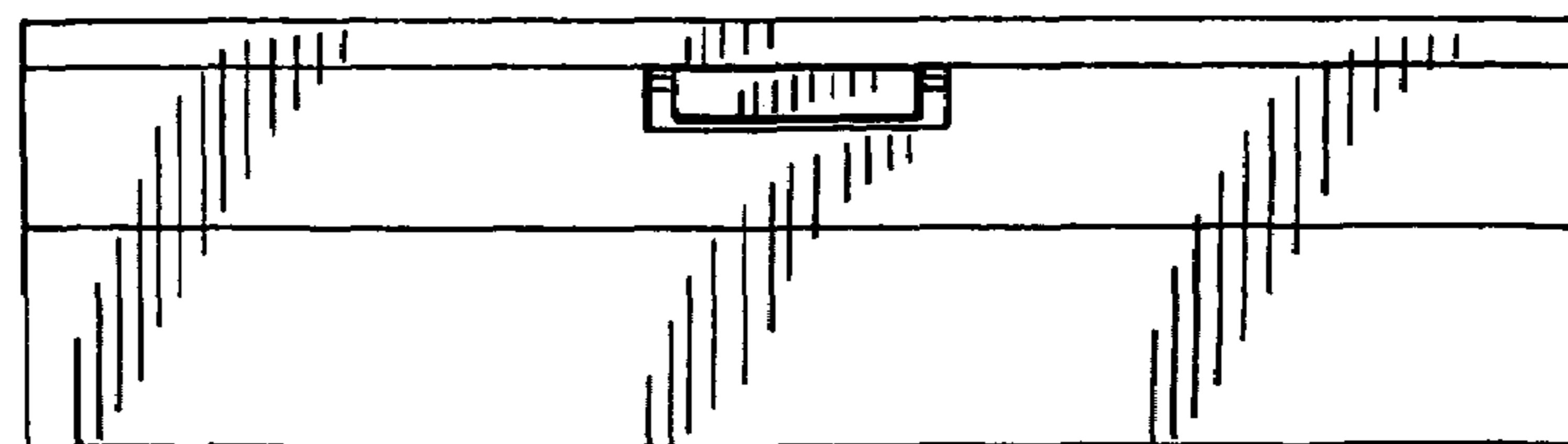

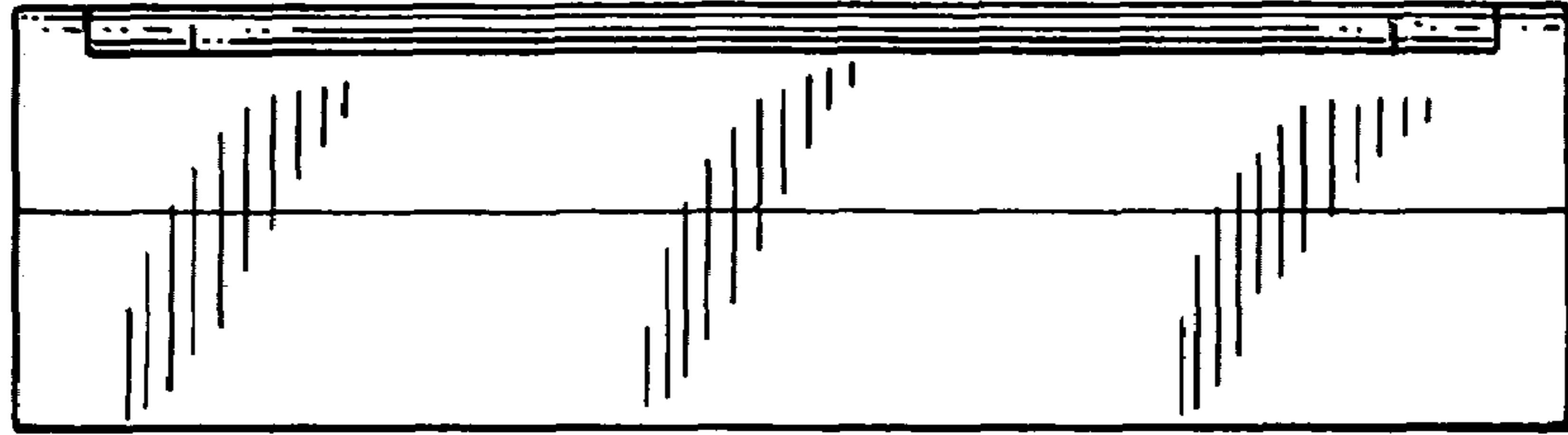

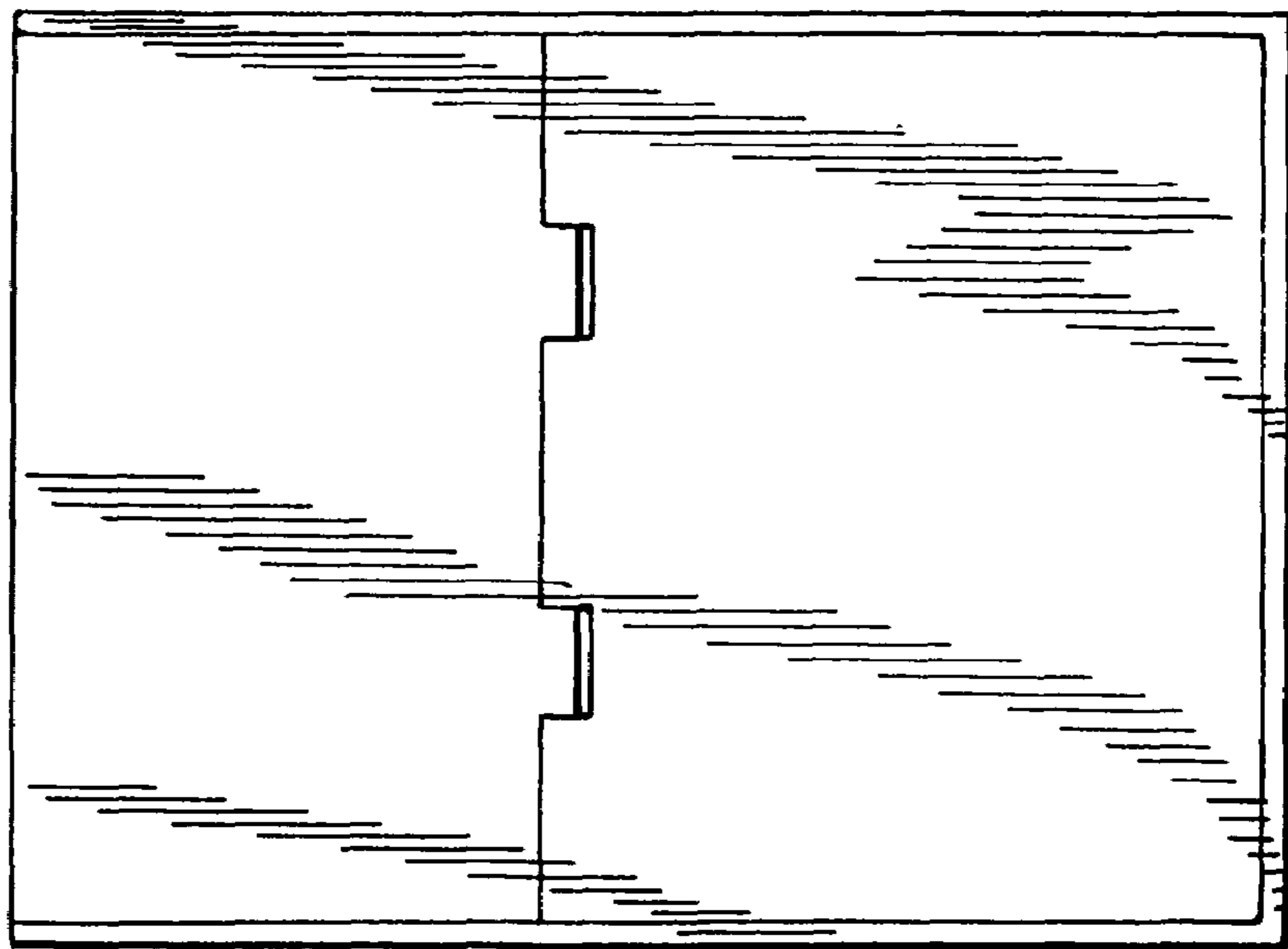

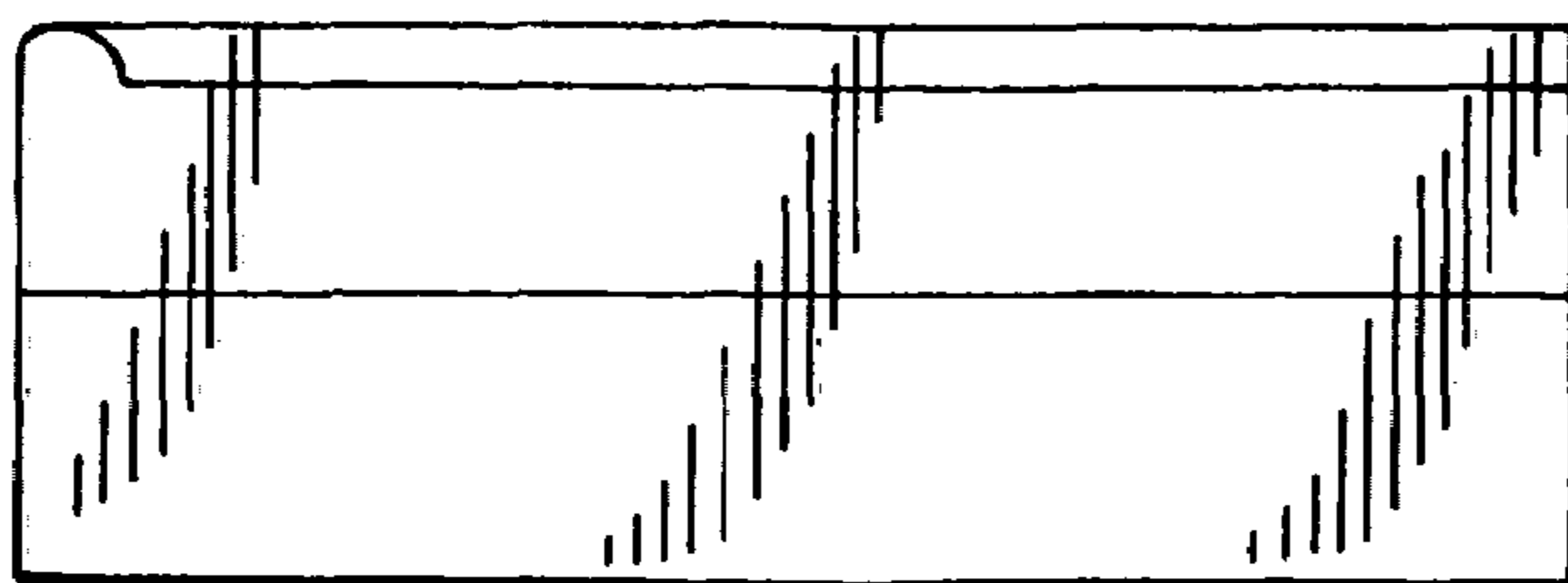

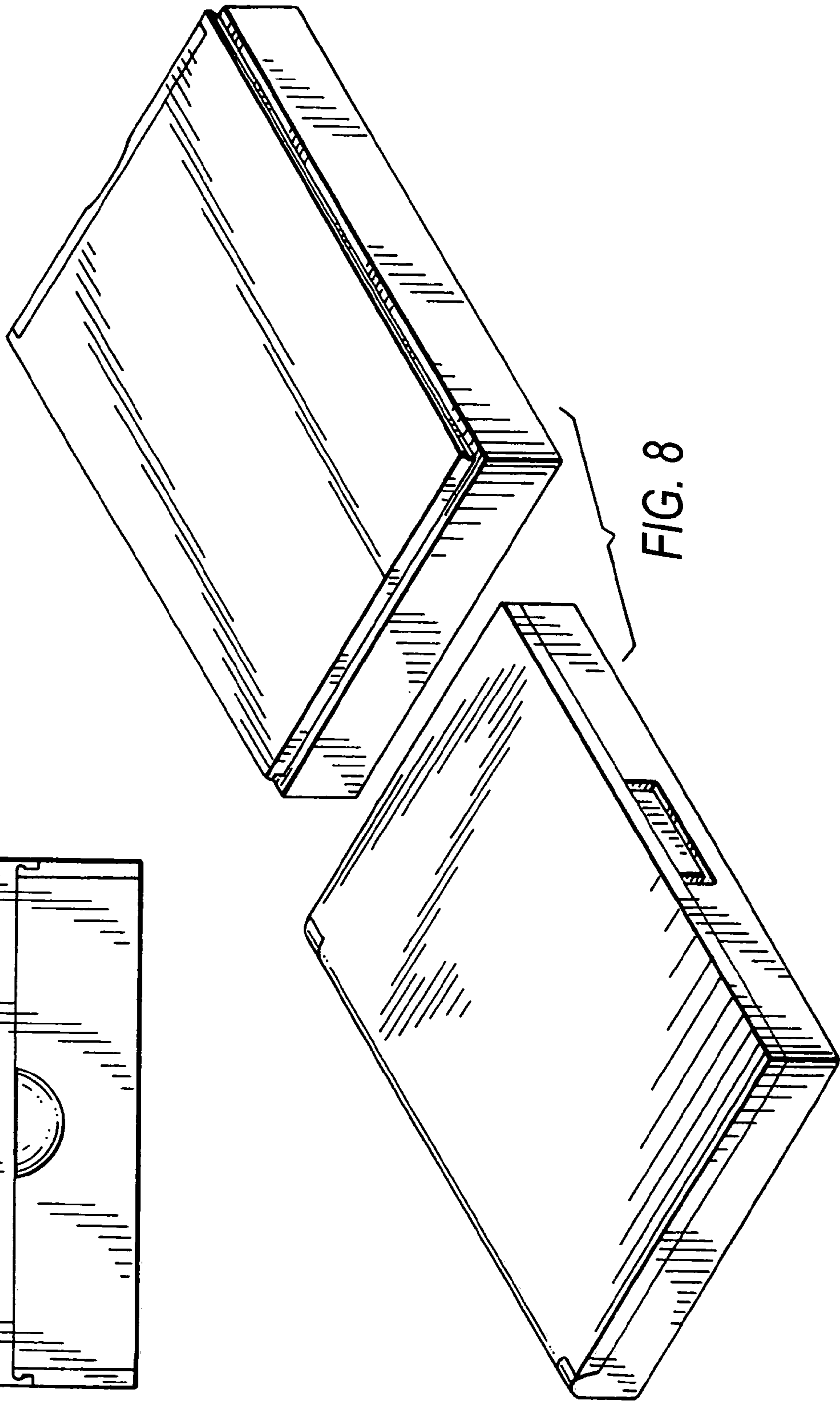
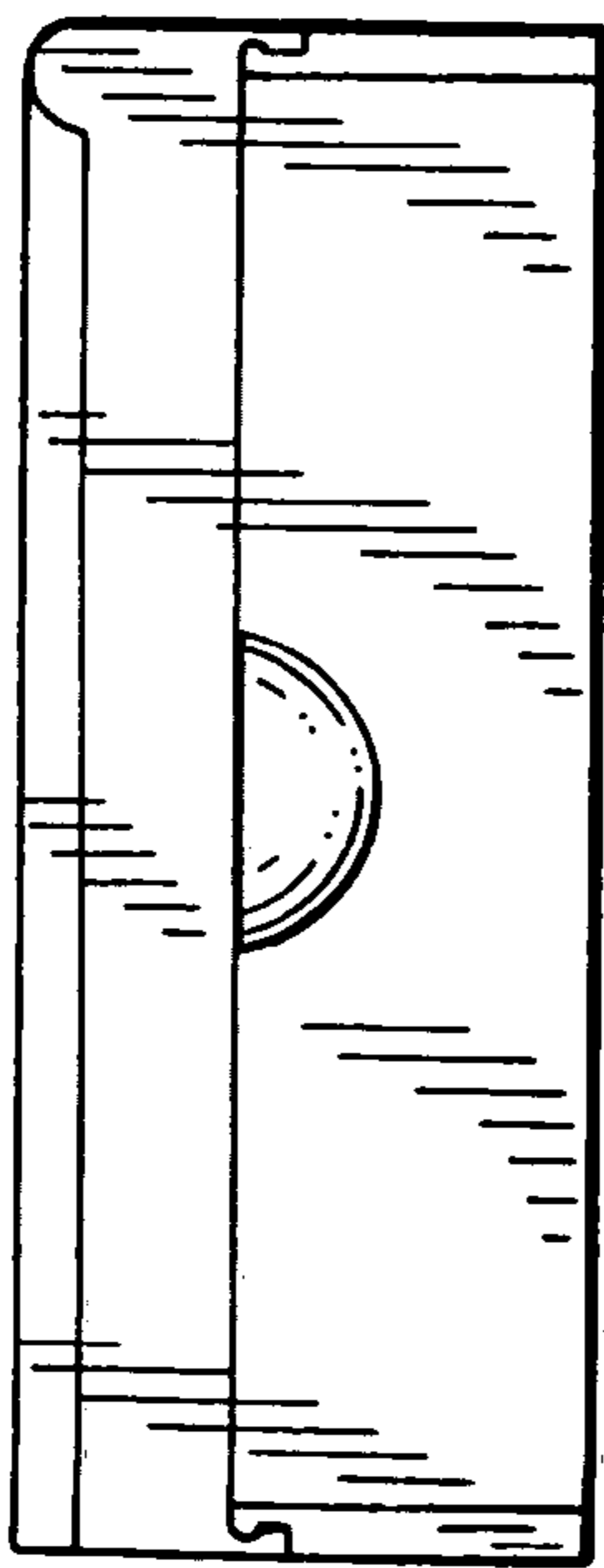

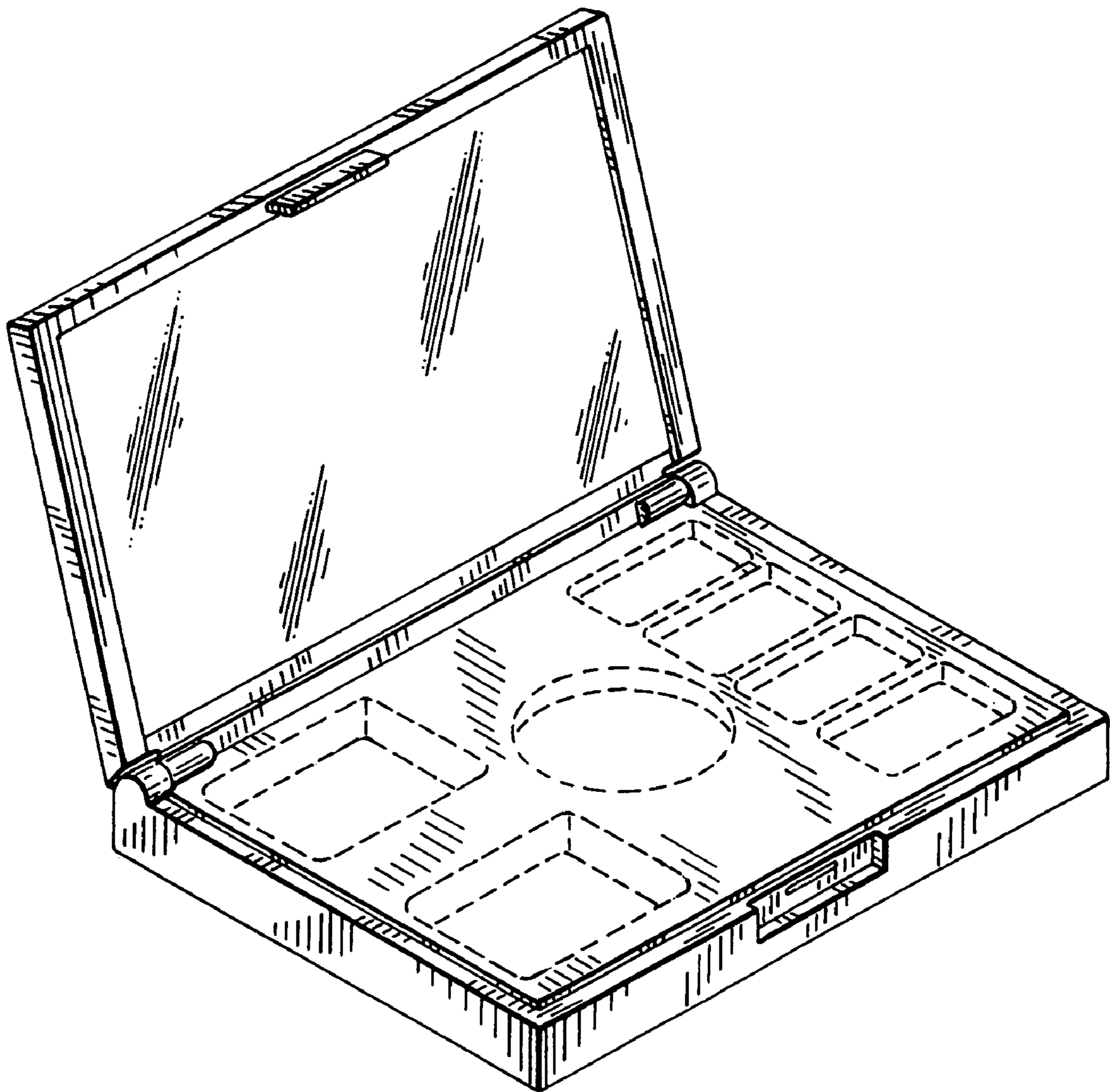

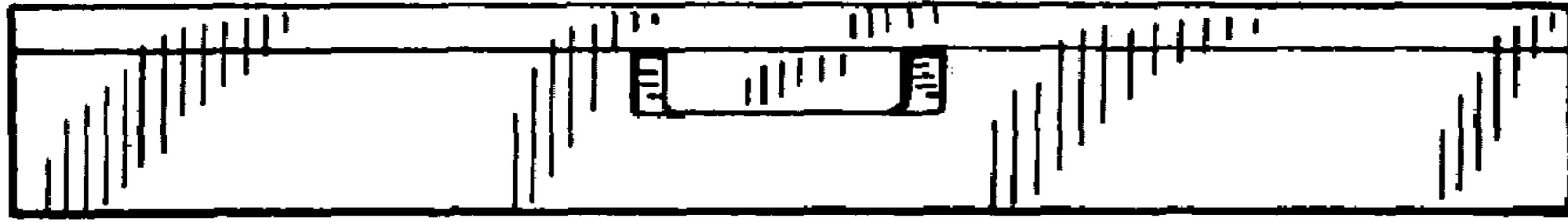
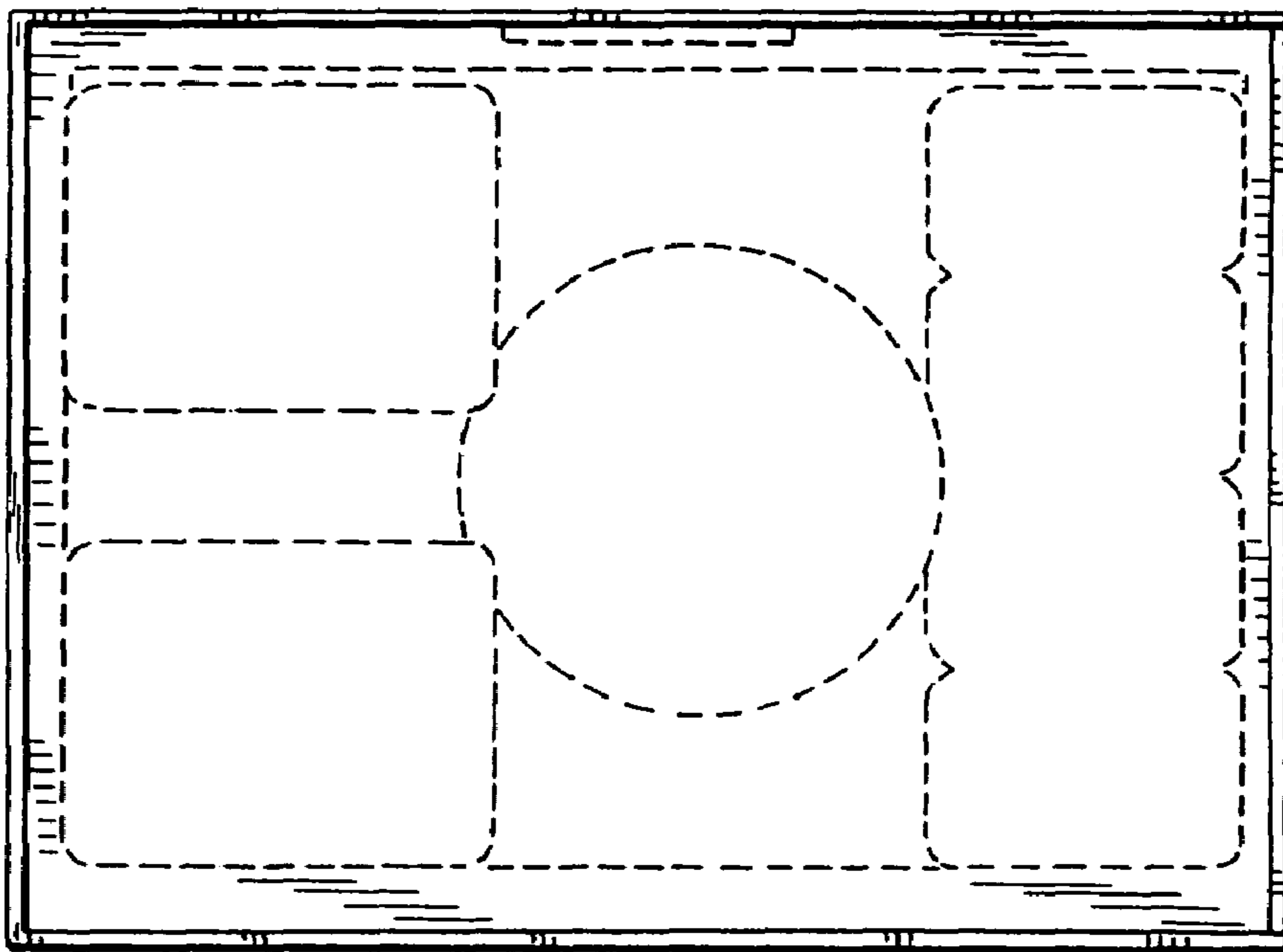

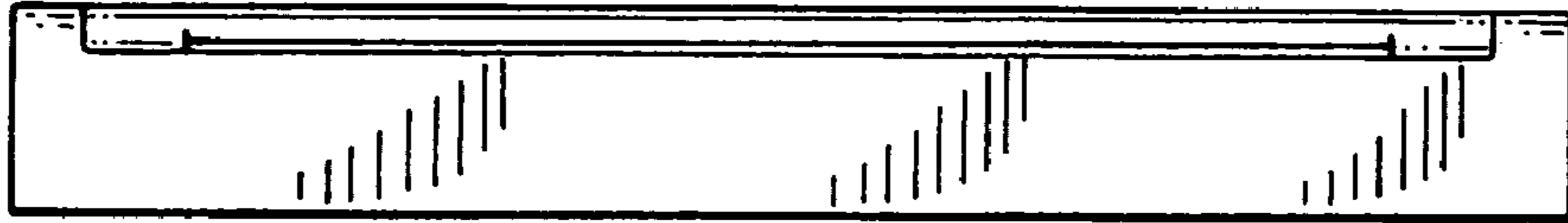

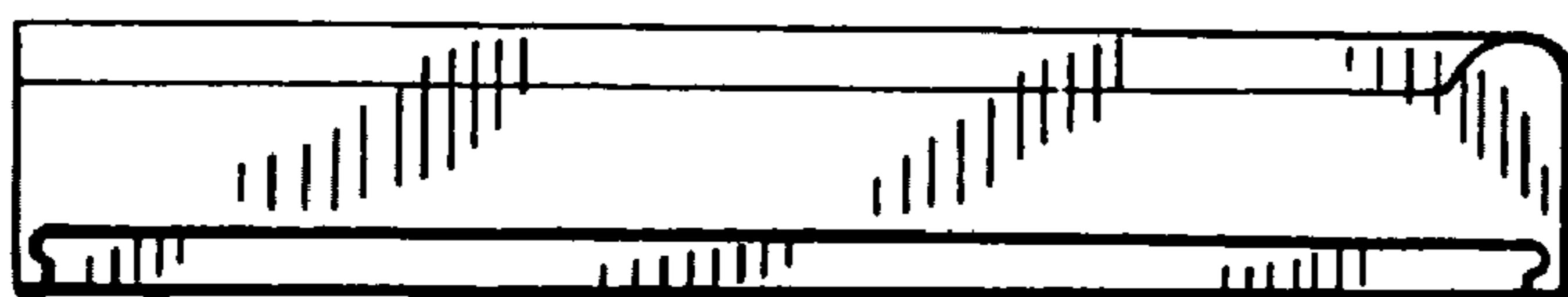
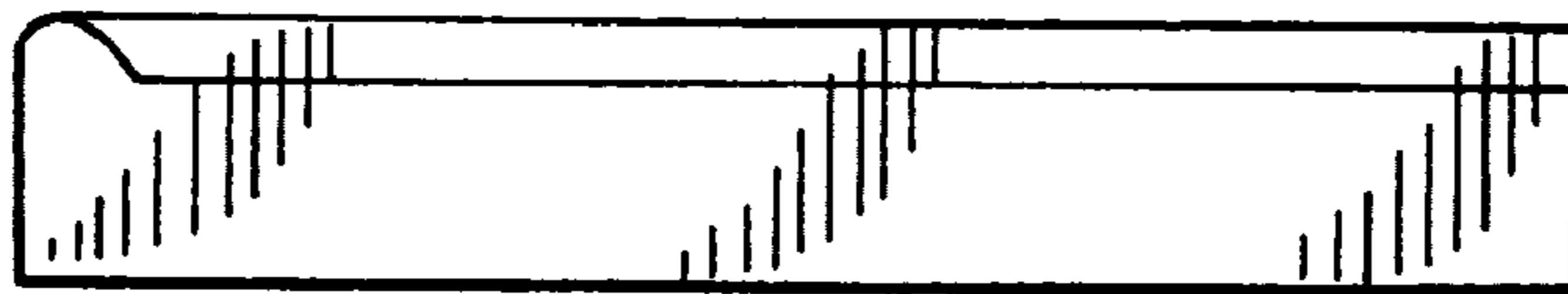

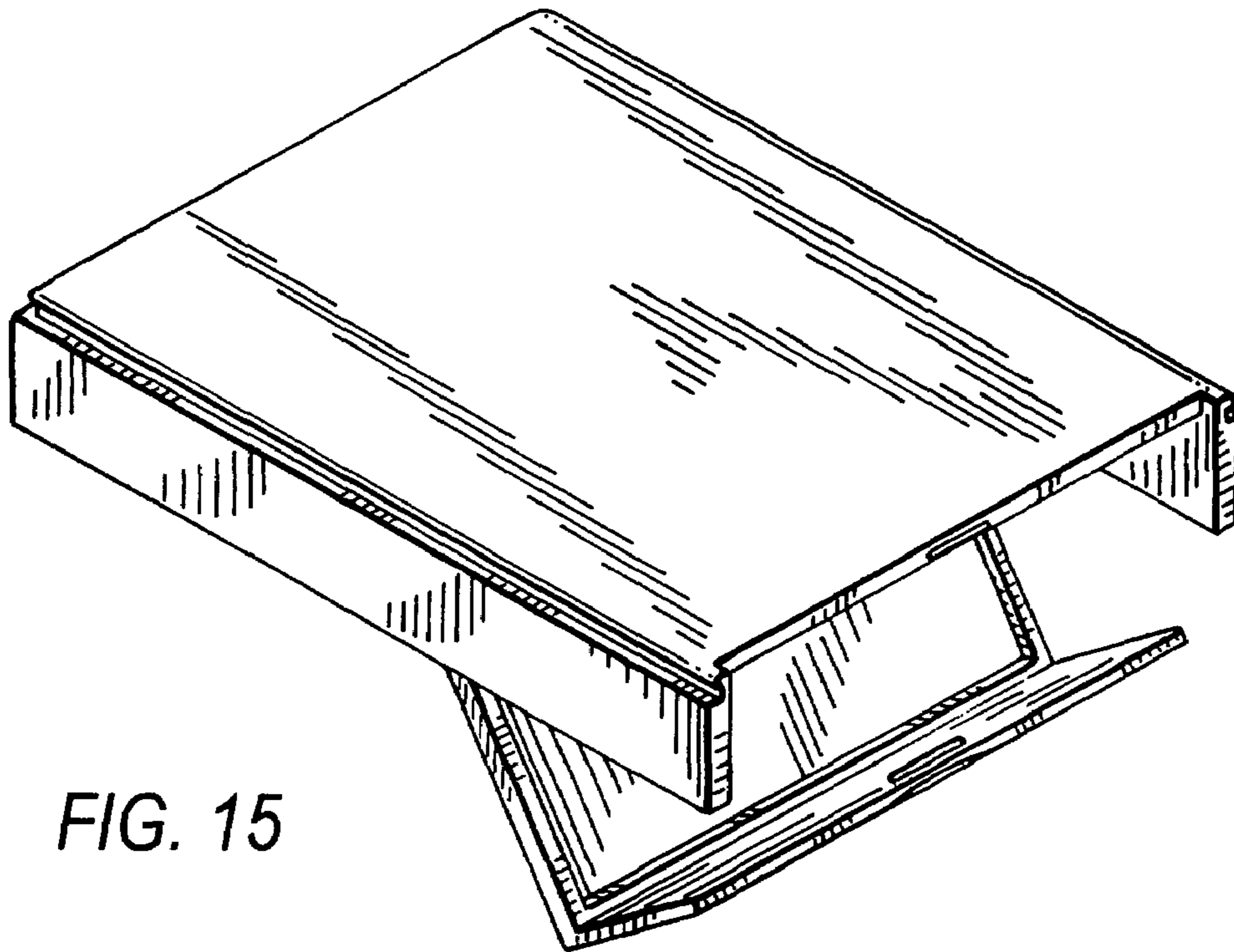

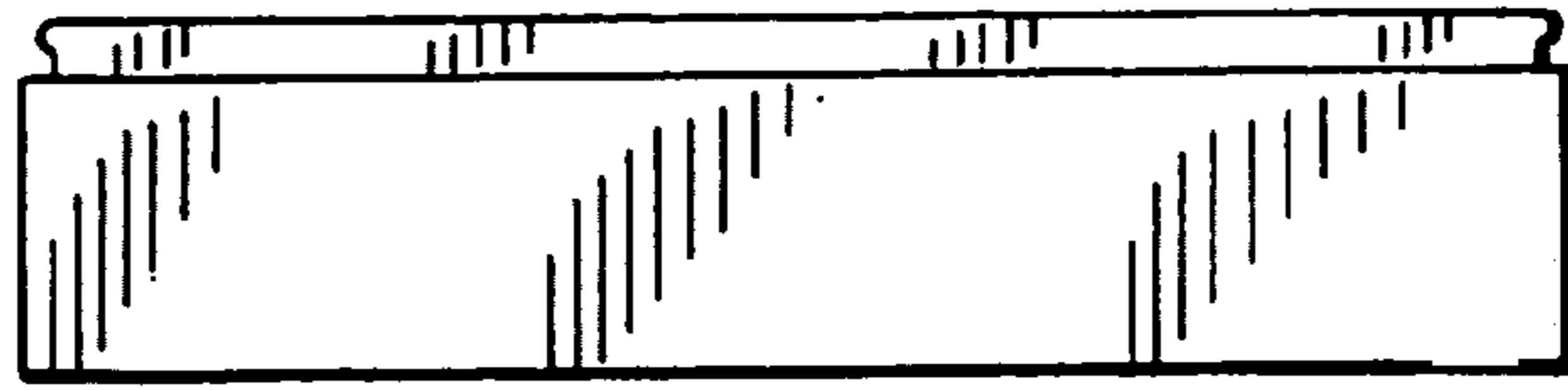

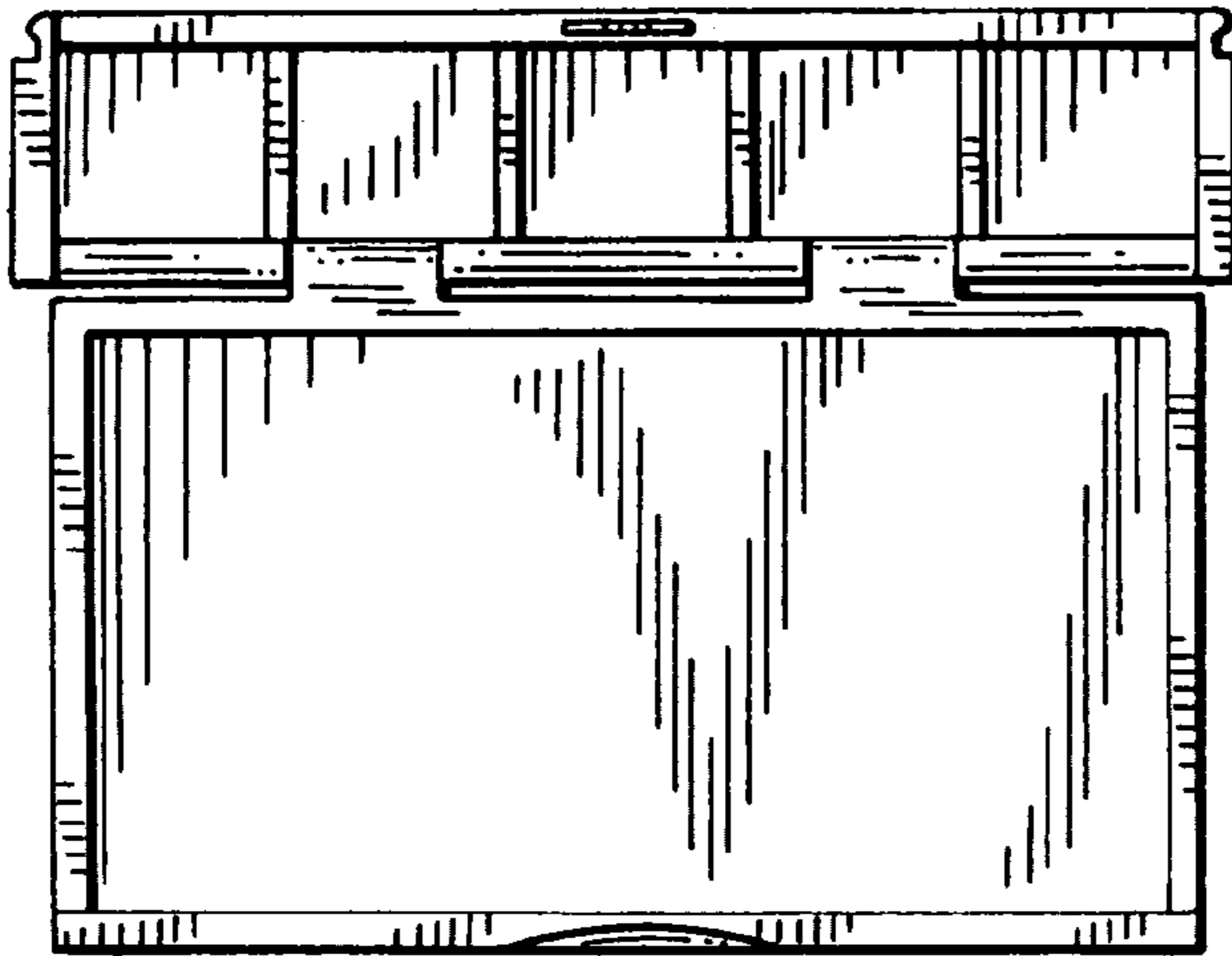
