I claim, the ornamental design for a protective cover for children, as shown and described.

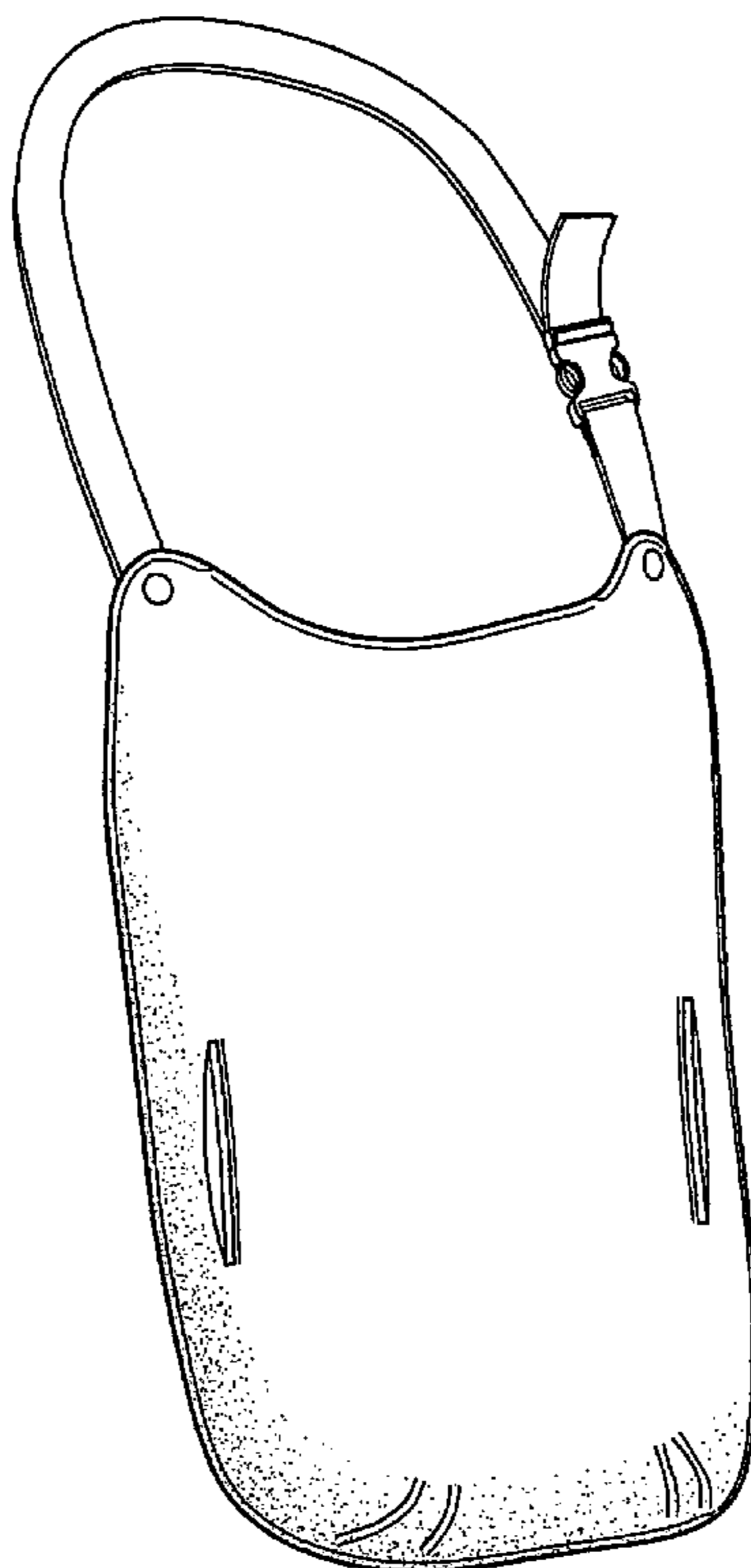
DESCRIPTION

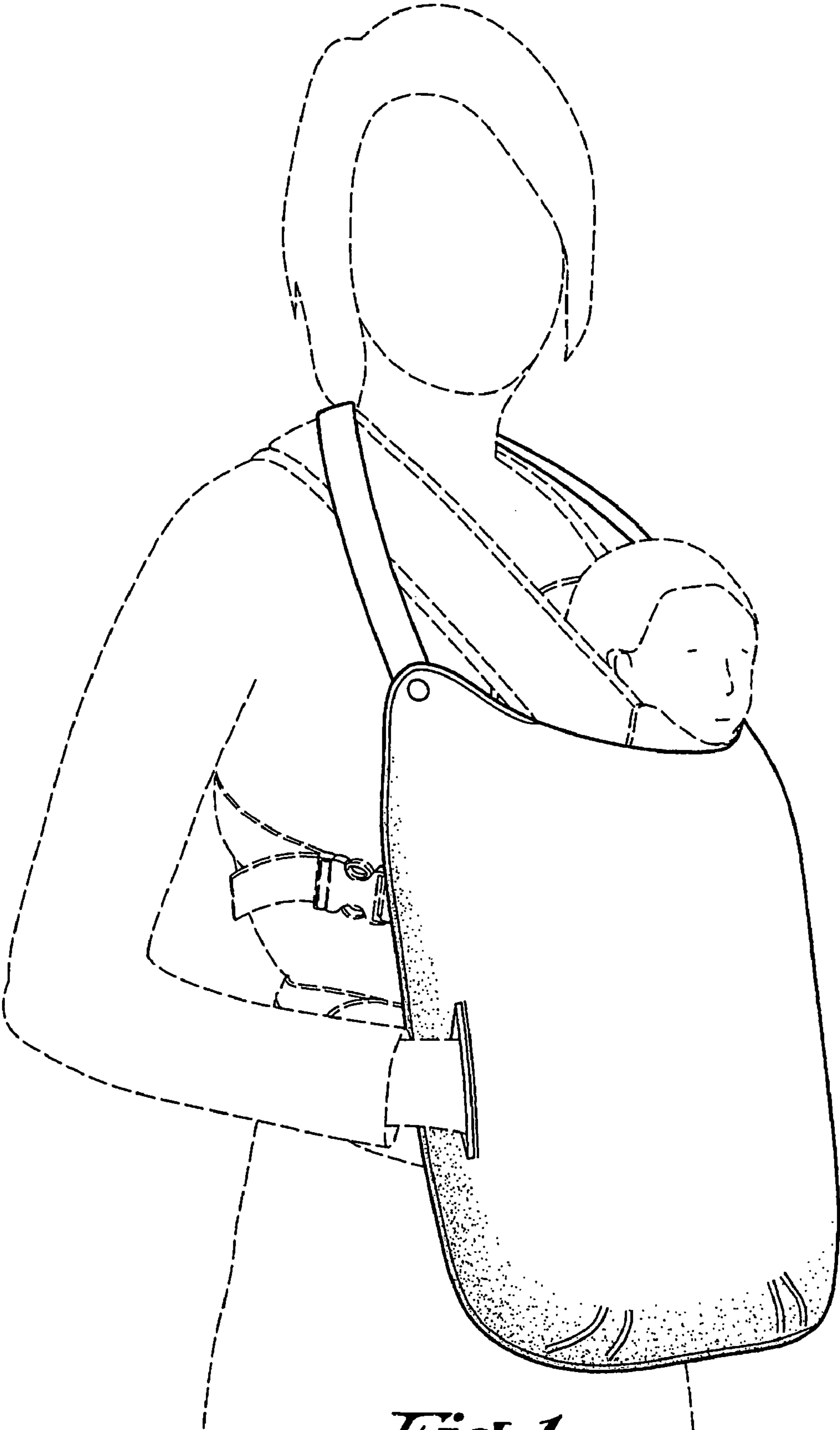

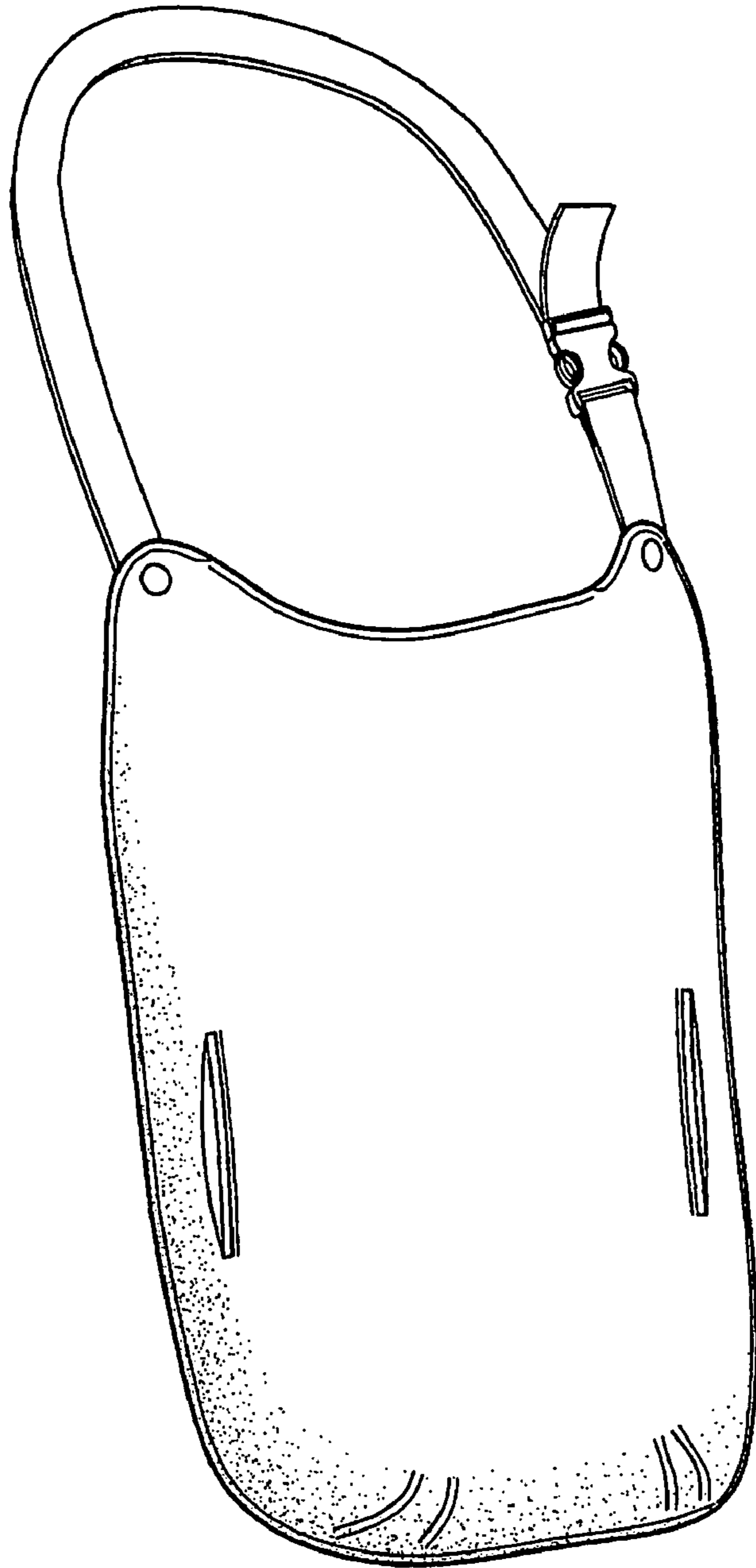
