(57) **CLAIM**

The ornamental design for a handle for a utensil, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a handle for a utensil according to the present design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a first end elevational view thereof;

FIG. 6 is a second end elevational view thereof;

FIG. 7 is an enlarged cross-sectional view taken through line 7—7 of FIG. 1;

FIG. 8 is a top plan view of an alternative embodiment handle for a utensil according to the present design;

FIG. 9 is a right side elevational view thereof;

FIG. 10 is a bottom plan view thereof;

FIG. 11 is a left side elevational view thereof;

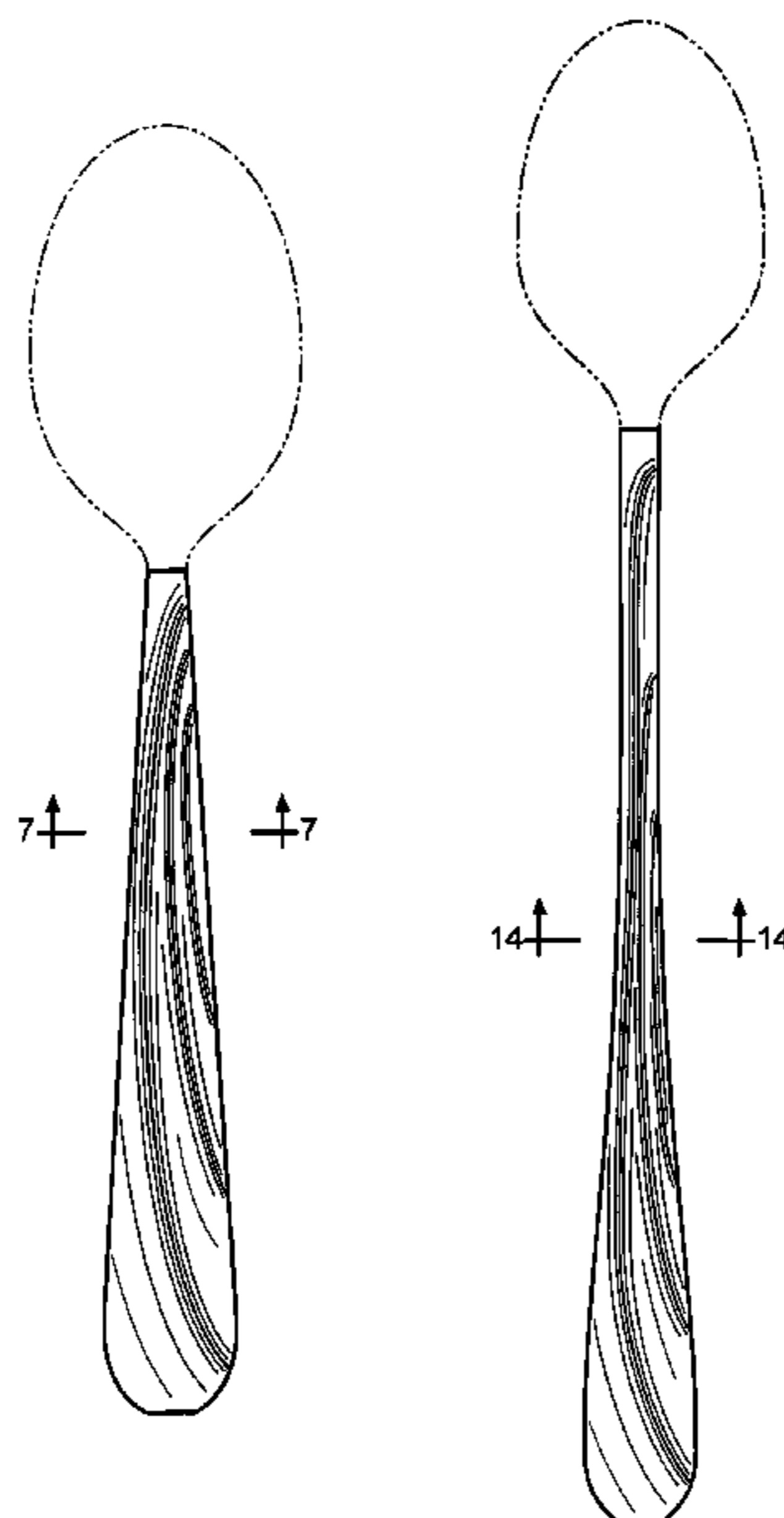
FIG. 12 is a first end elevational view thereof;

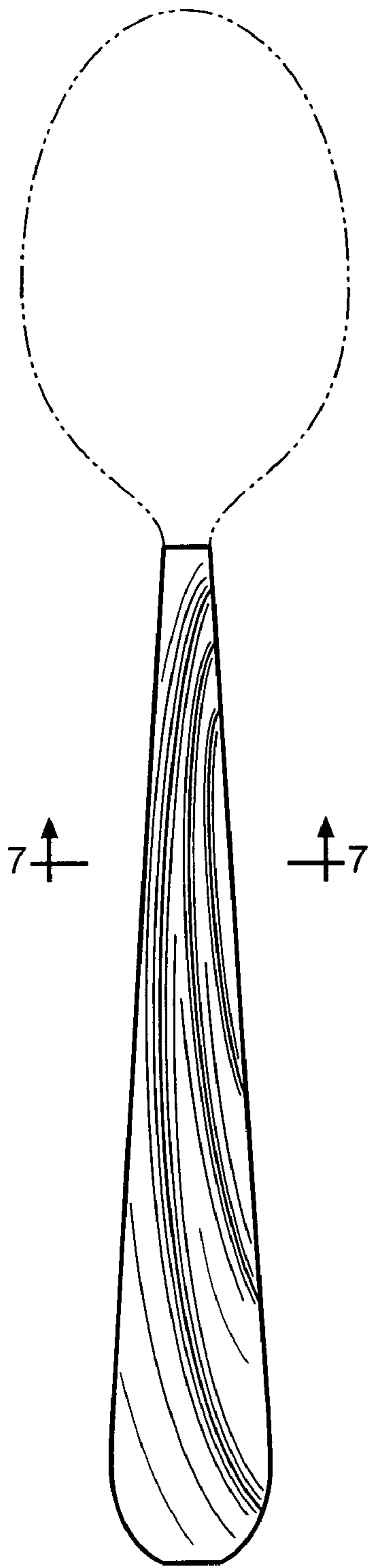
FIG. 13 is a second end elevational view thereof; and,

FIG. 14 is an enlarged cross-sectional view taken through line 14—14 of FIG. 8.

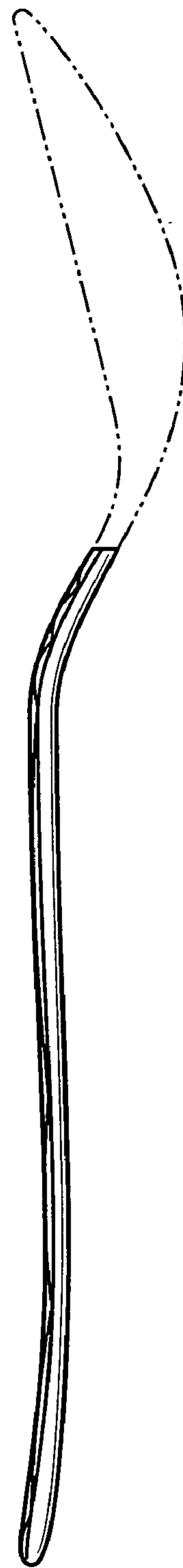
The broken lines shown FIGS. 1-4 and 8-11 are illustrative of environmental structure only and form no part of the claimed design.

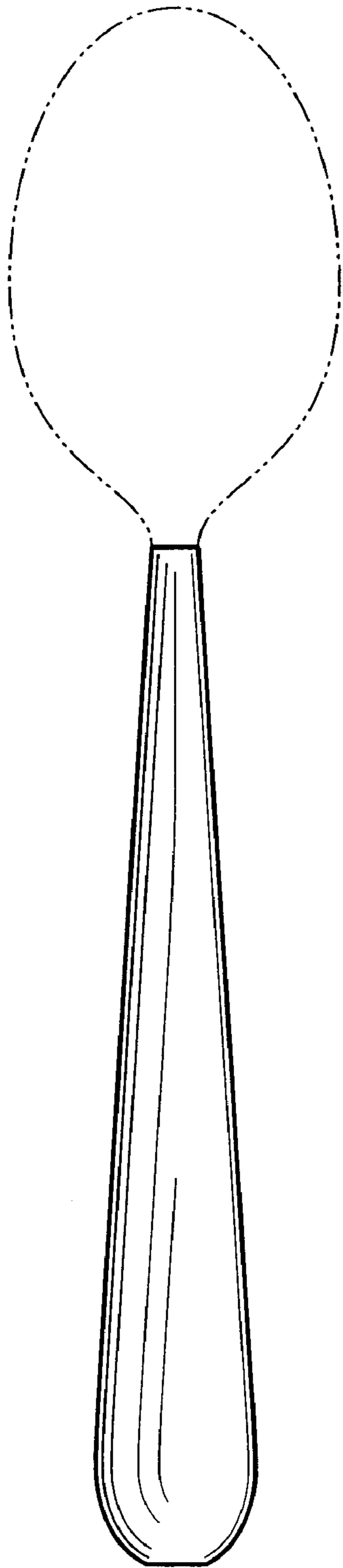




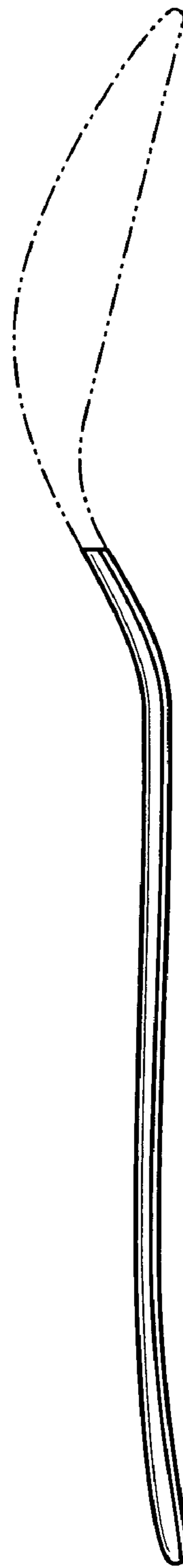

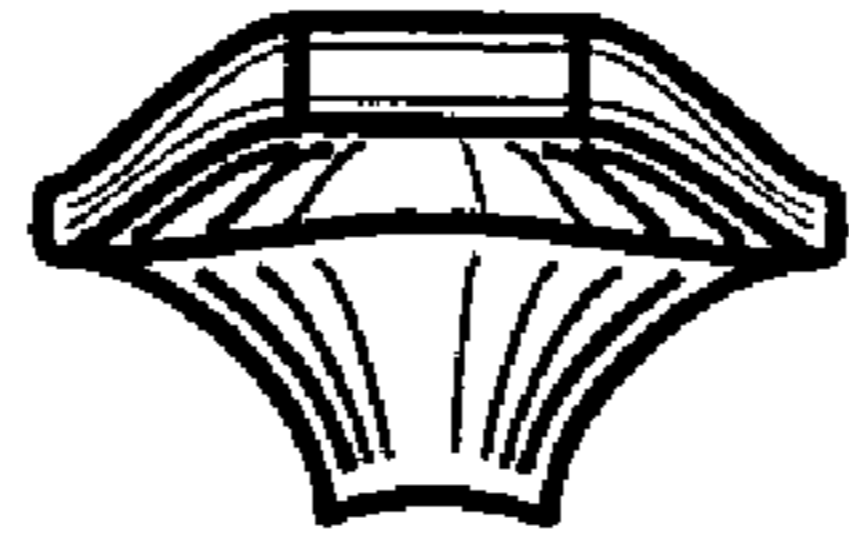

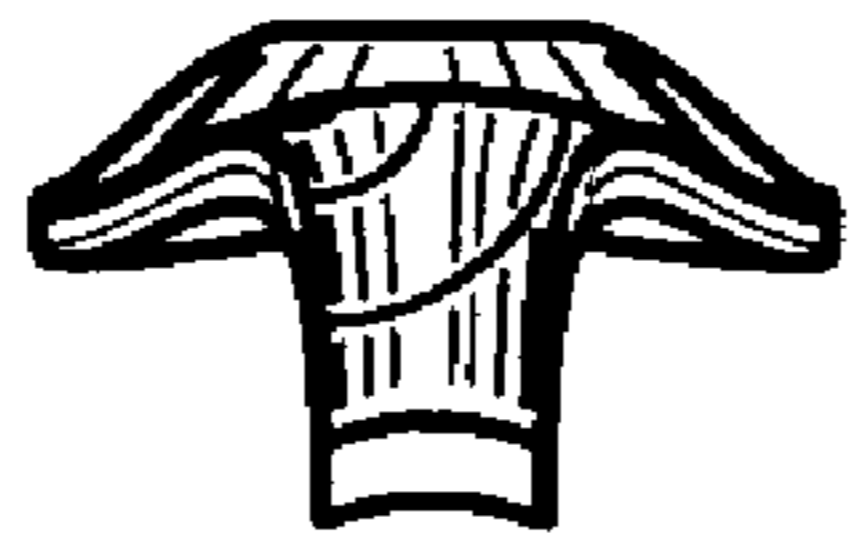

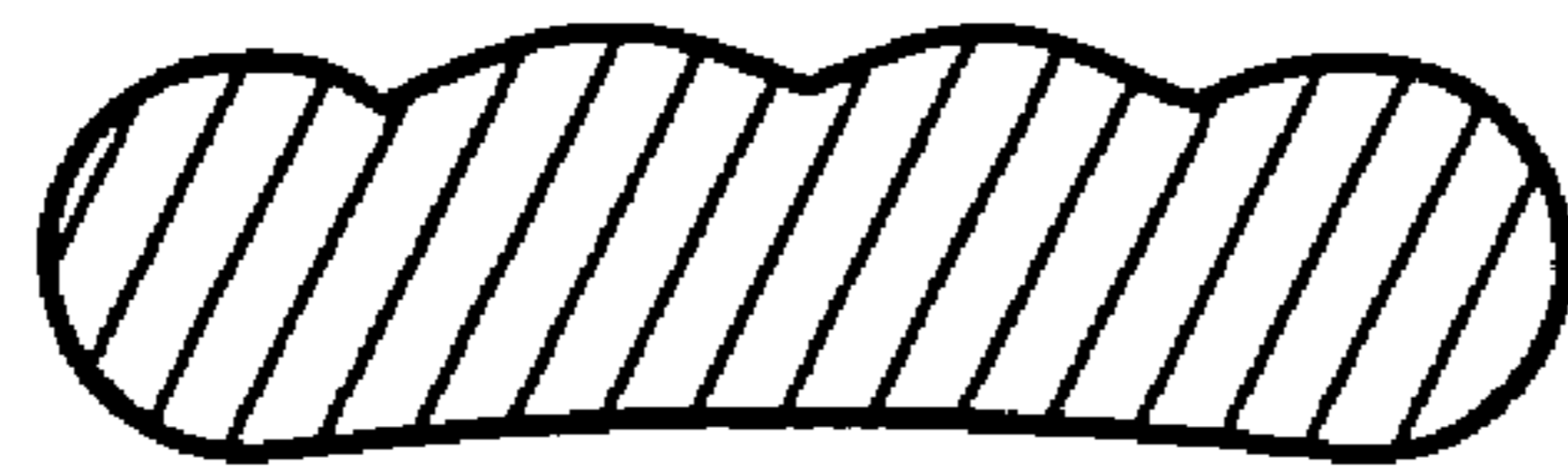

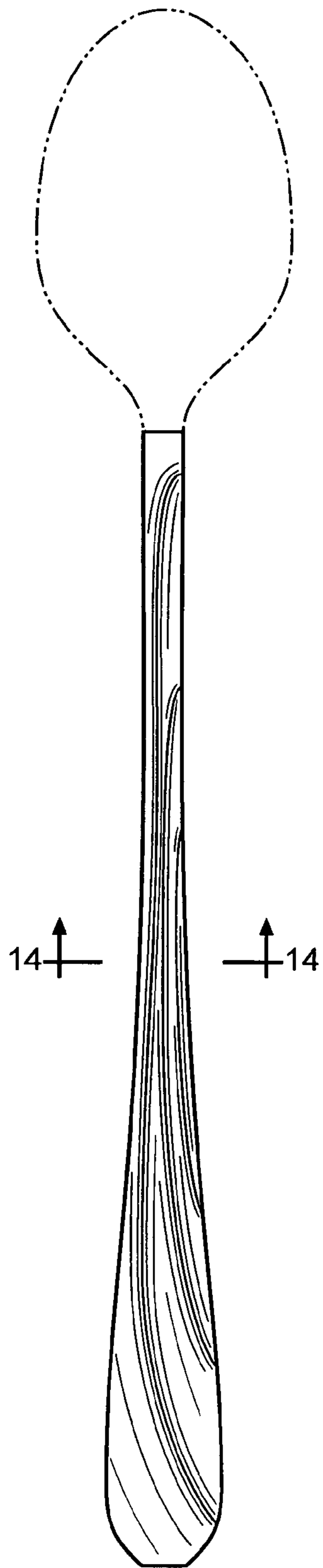

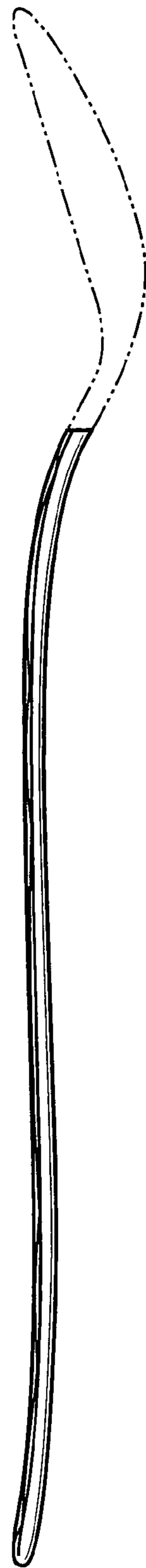

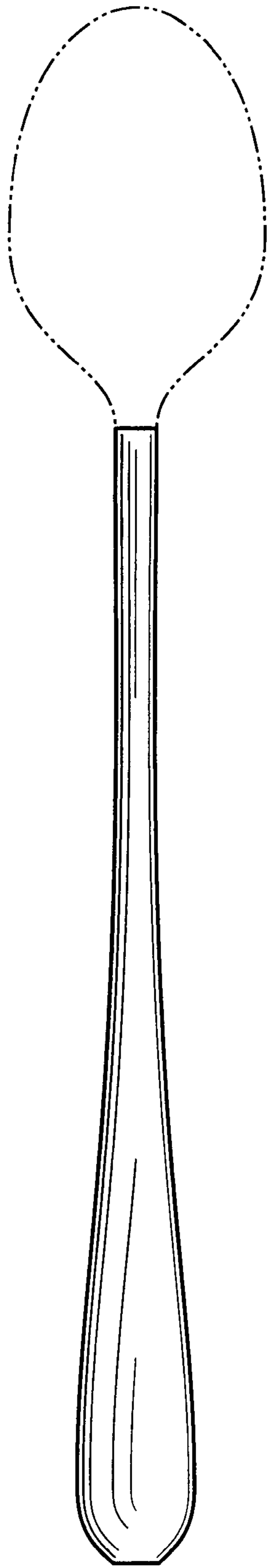

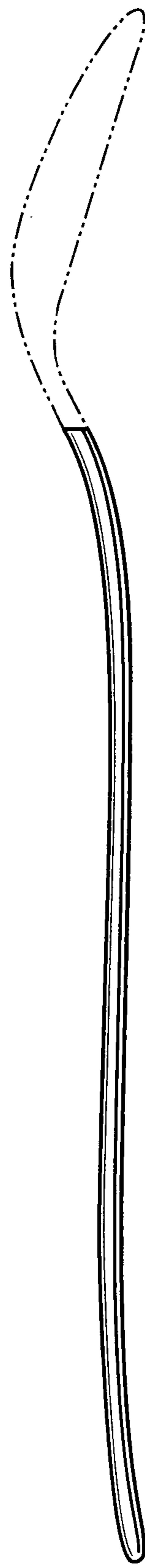

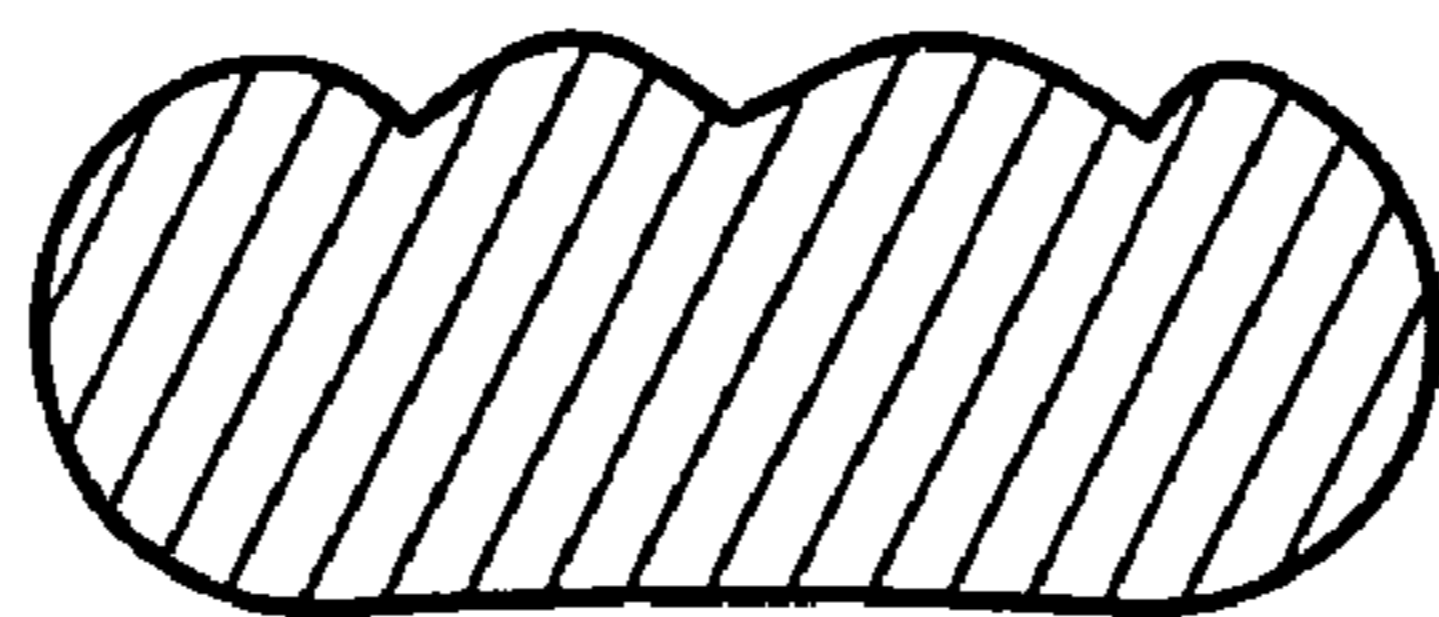
