(57) **CLAIM**

The ornamental design for a grooved wall mug, lid and holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a grooved wall mug, lid, and holder showing my new design;

FIG. 14 is a front elevational view thereof;

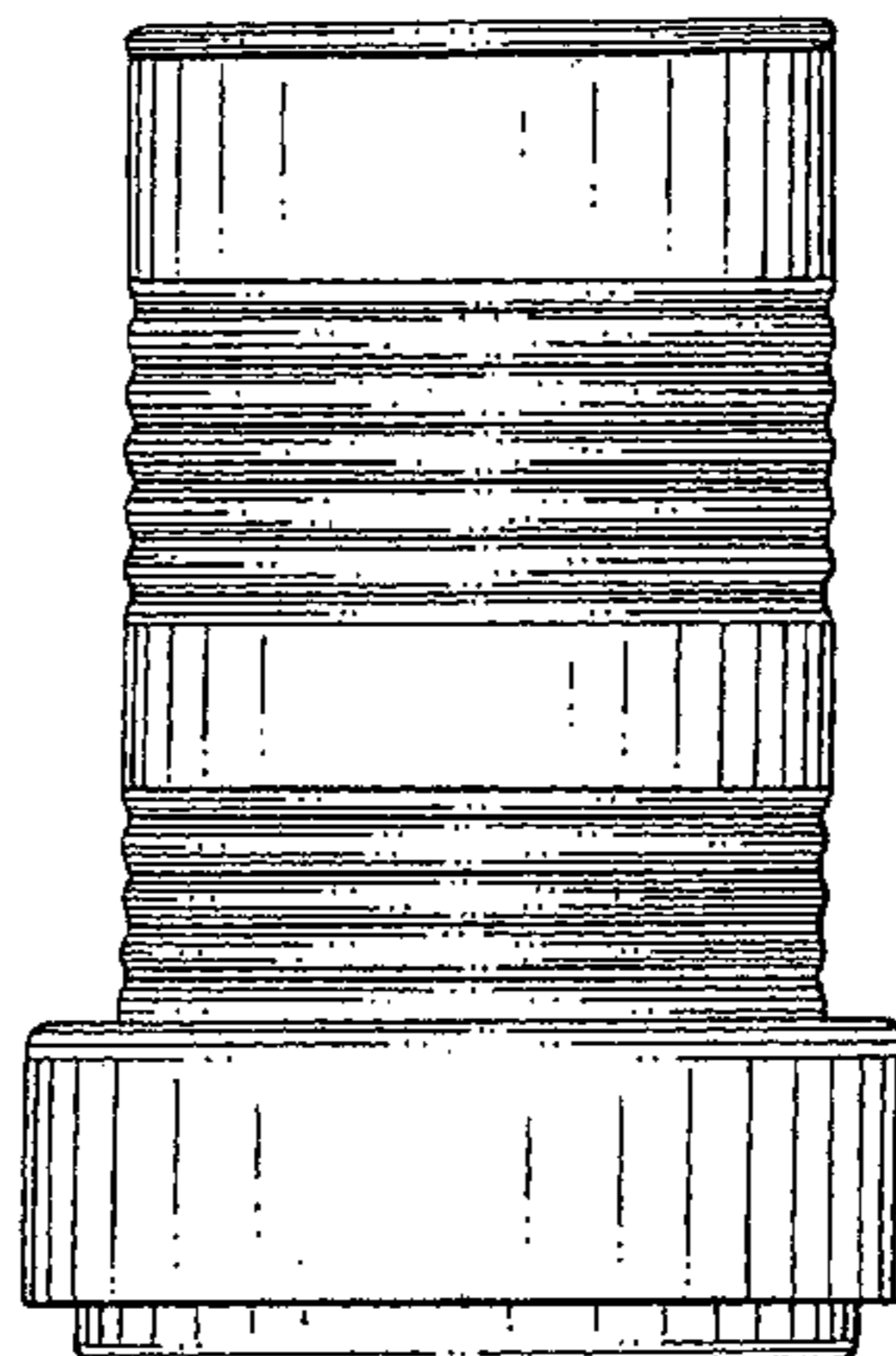
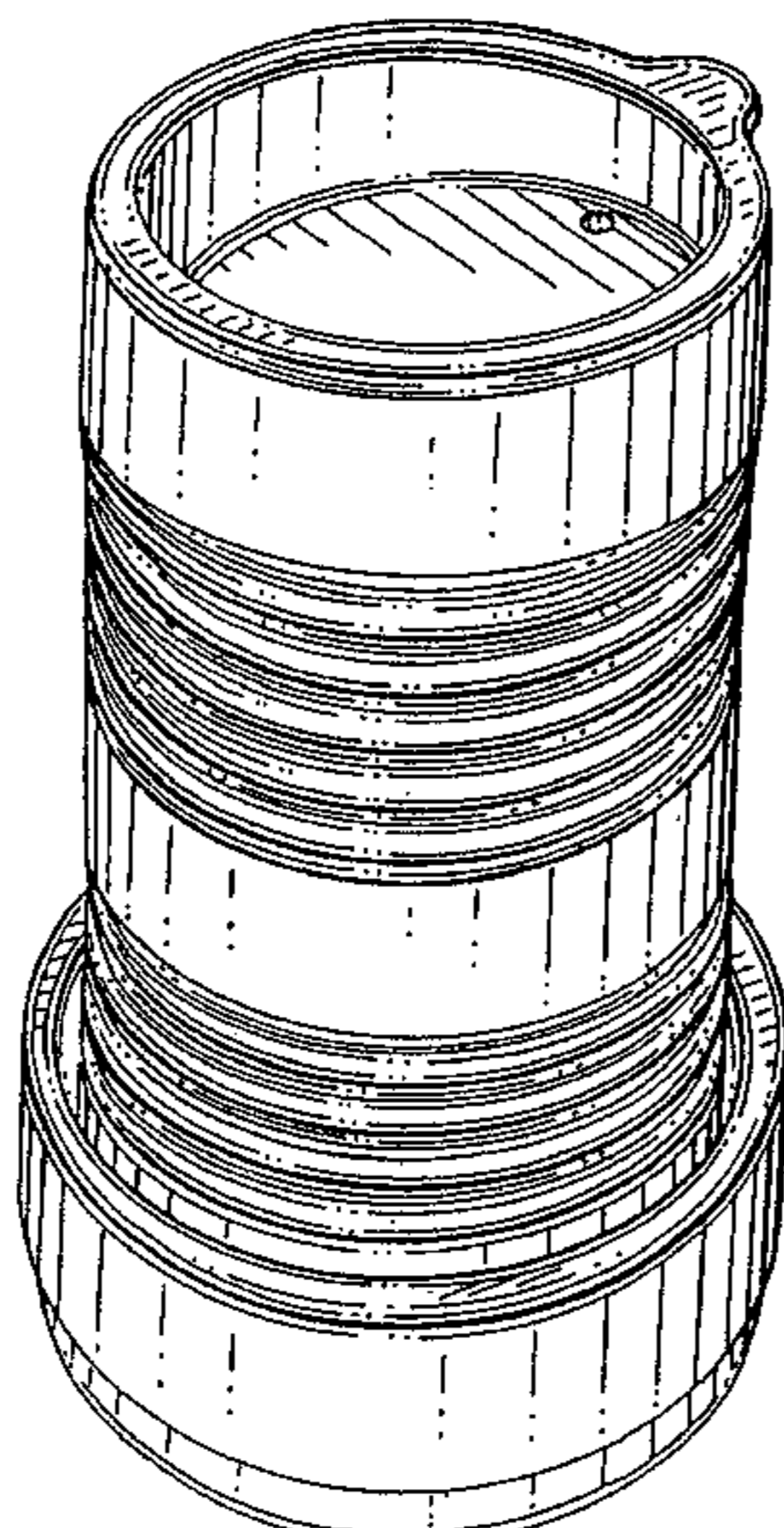
FIG. 15 is a rear elevational view thereof;

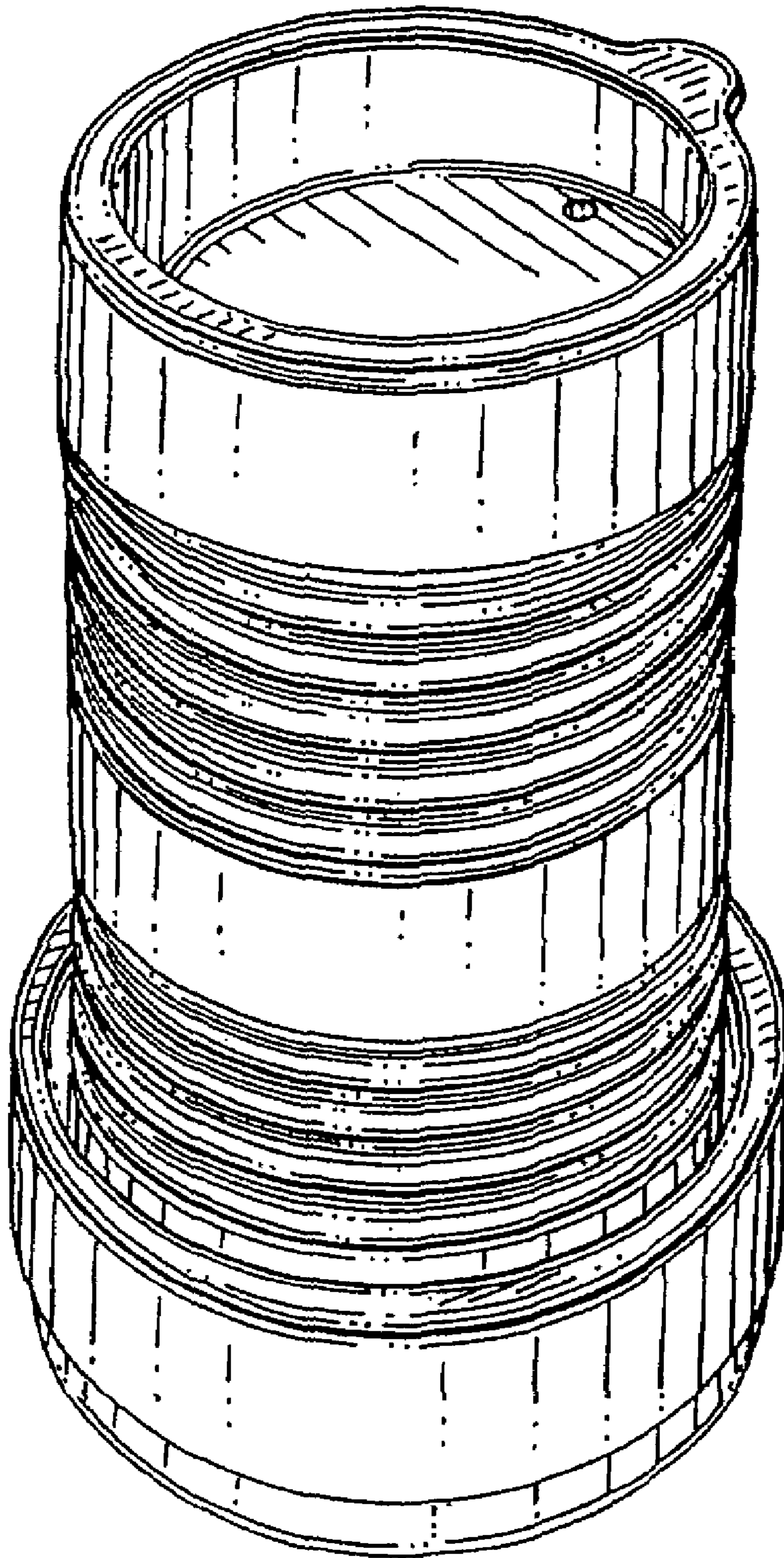

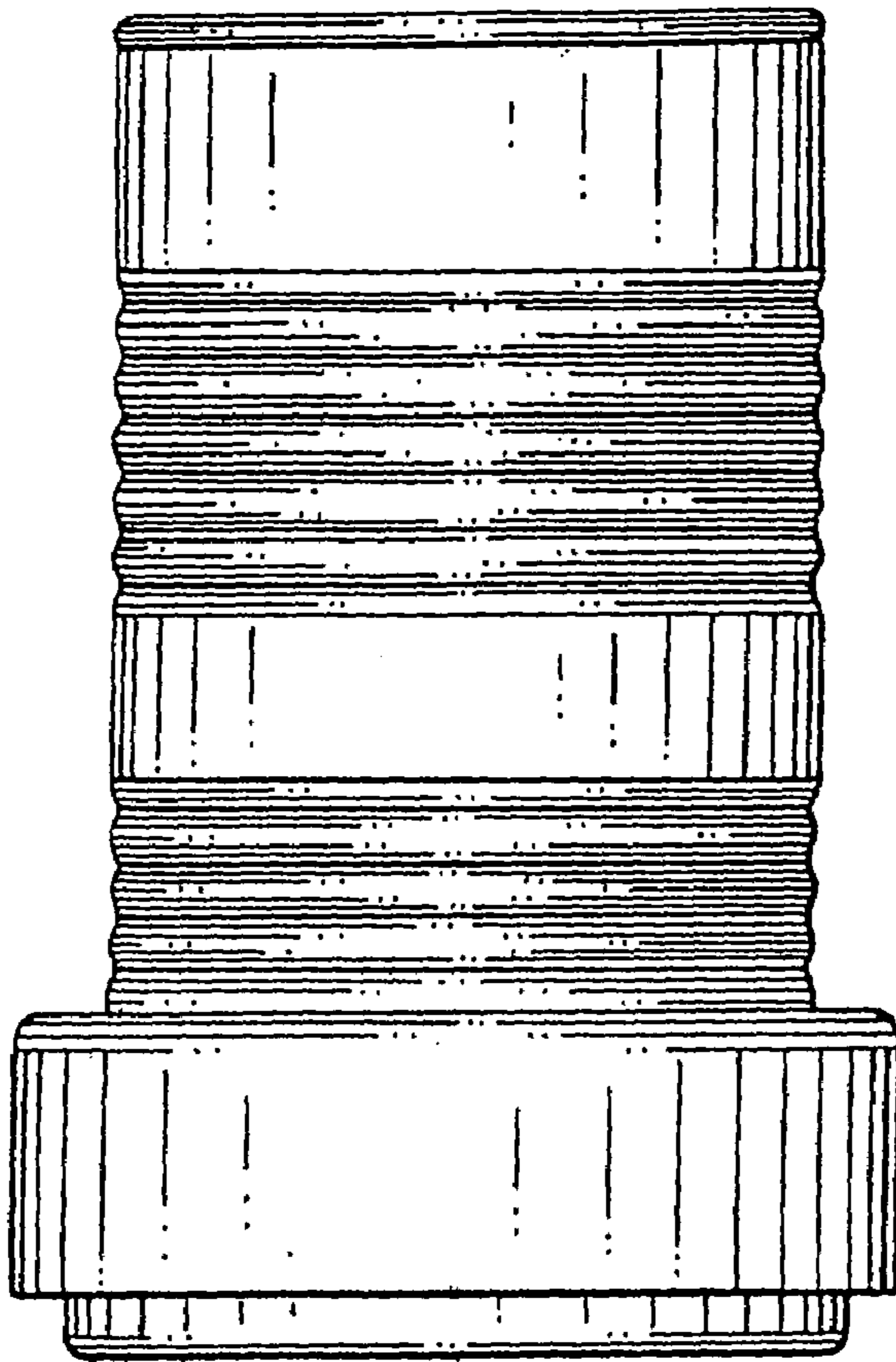

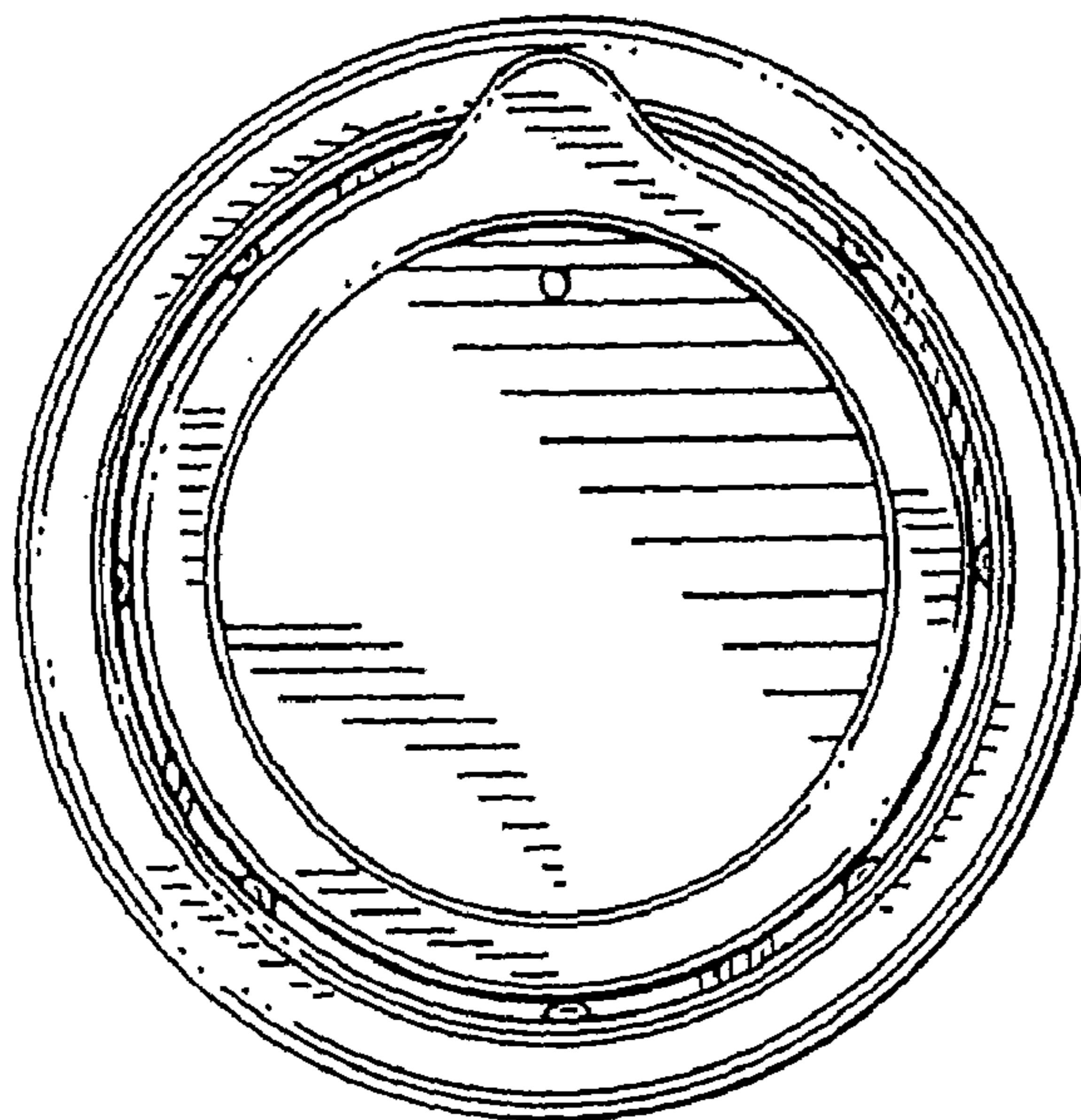
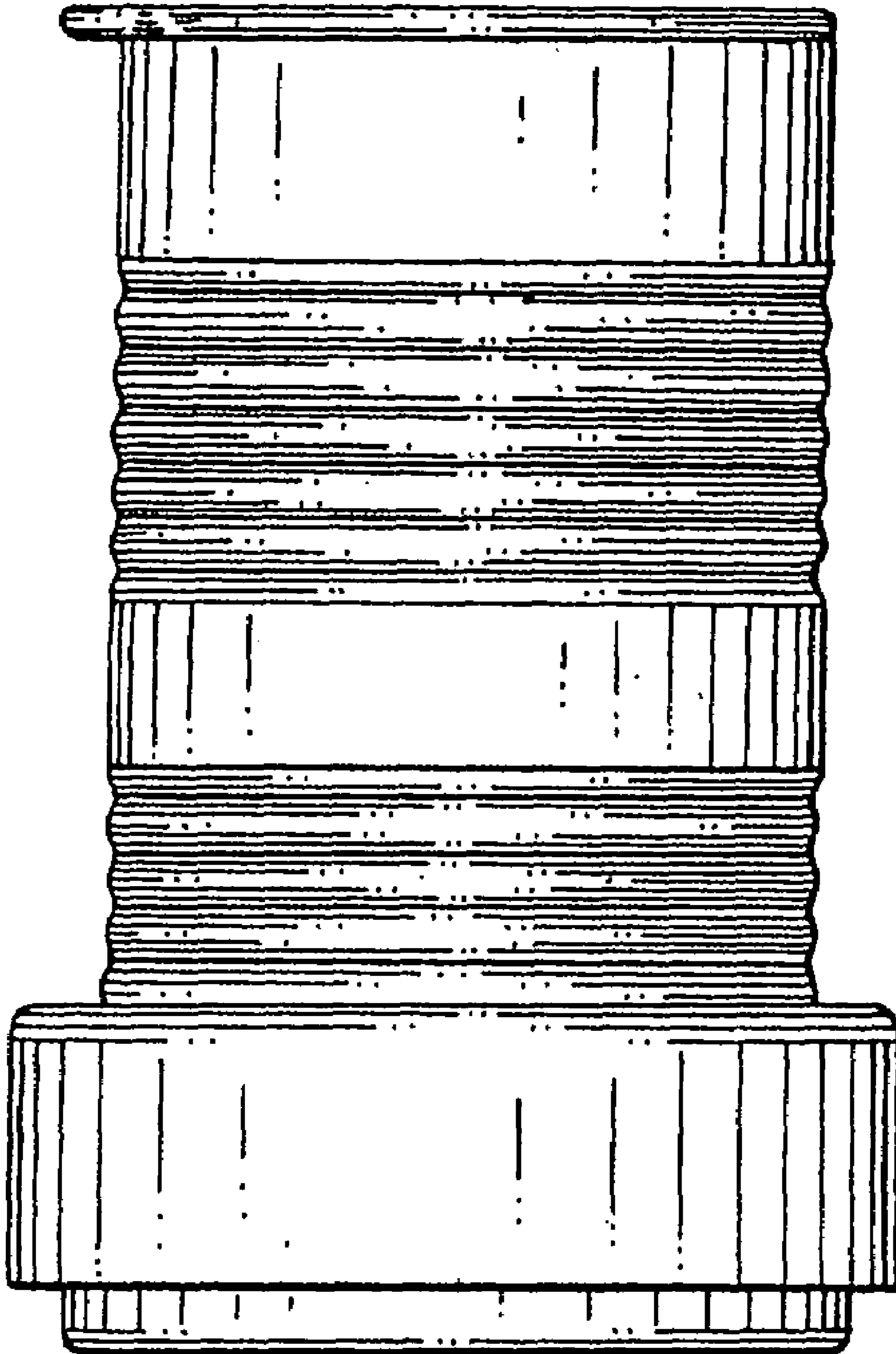

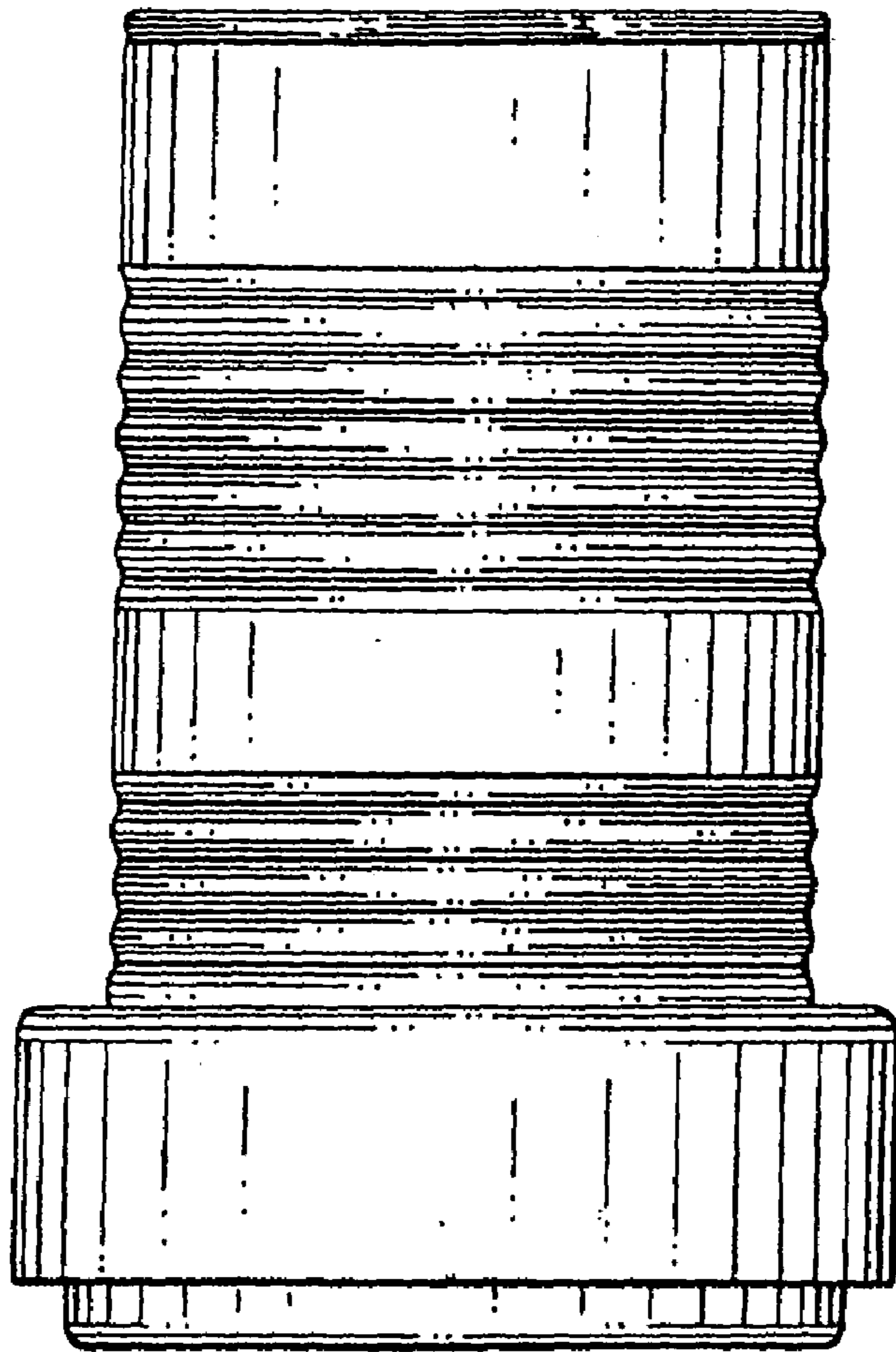

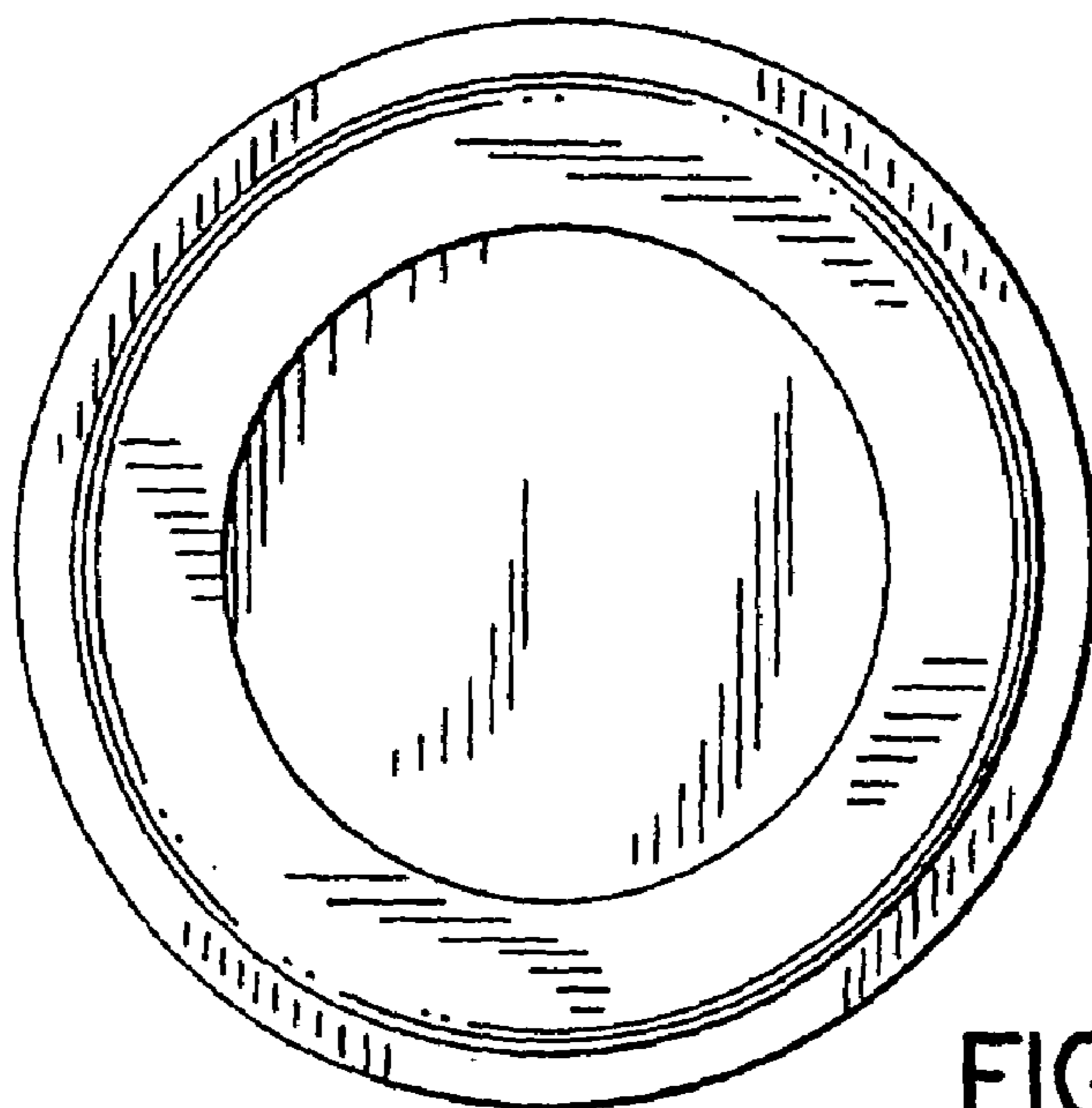
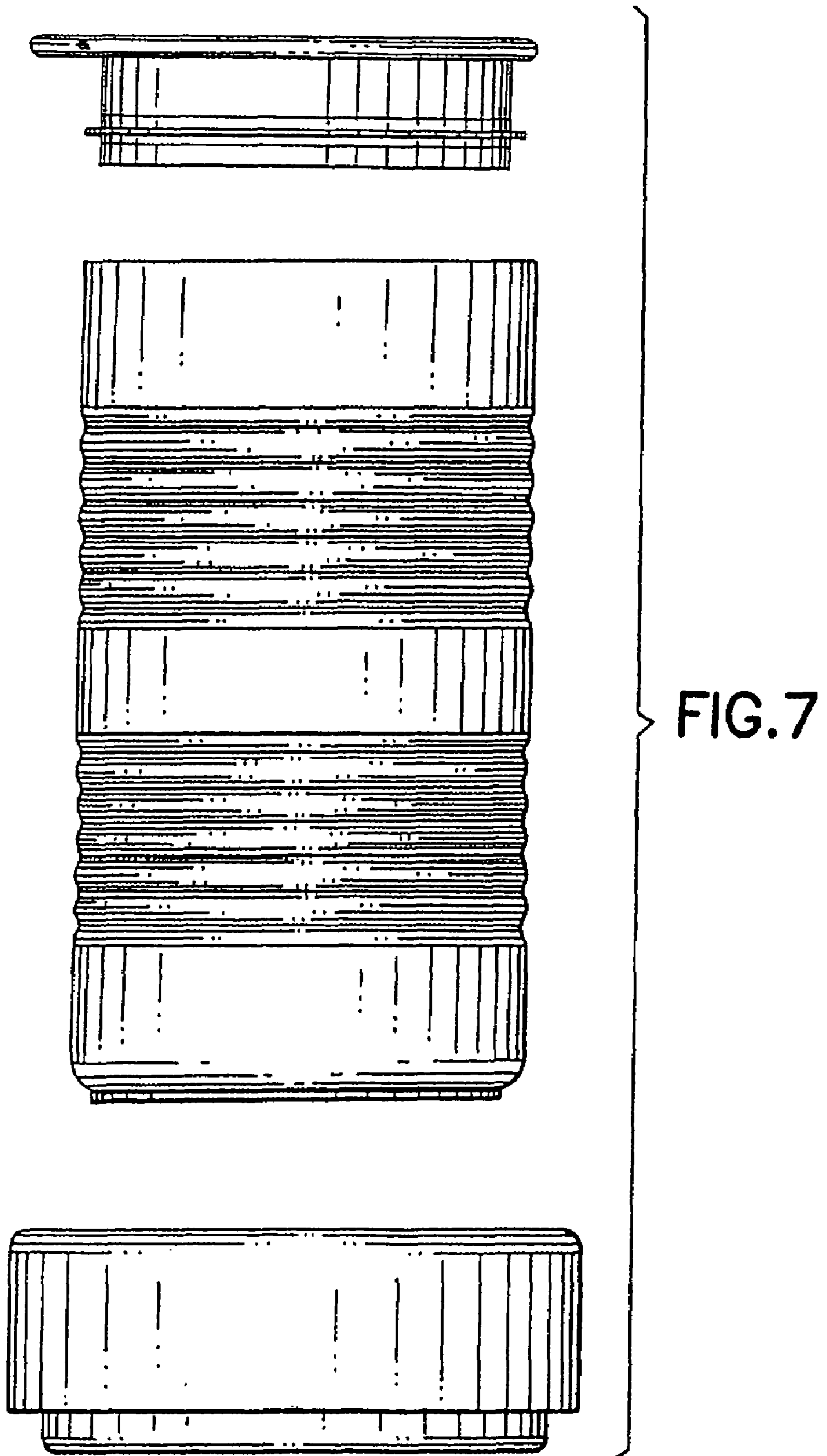

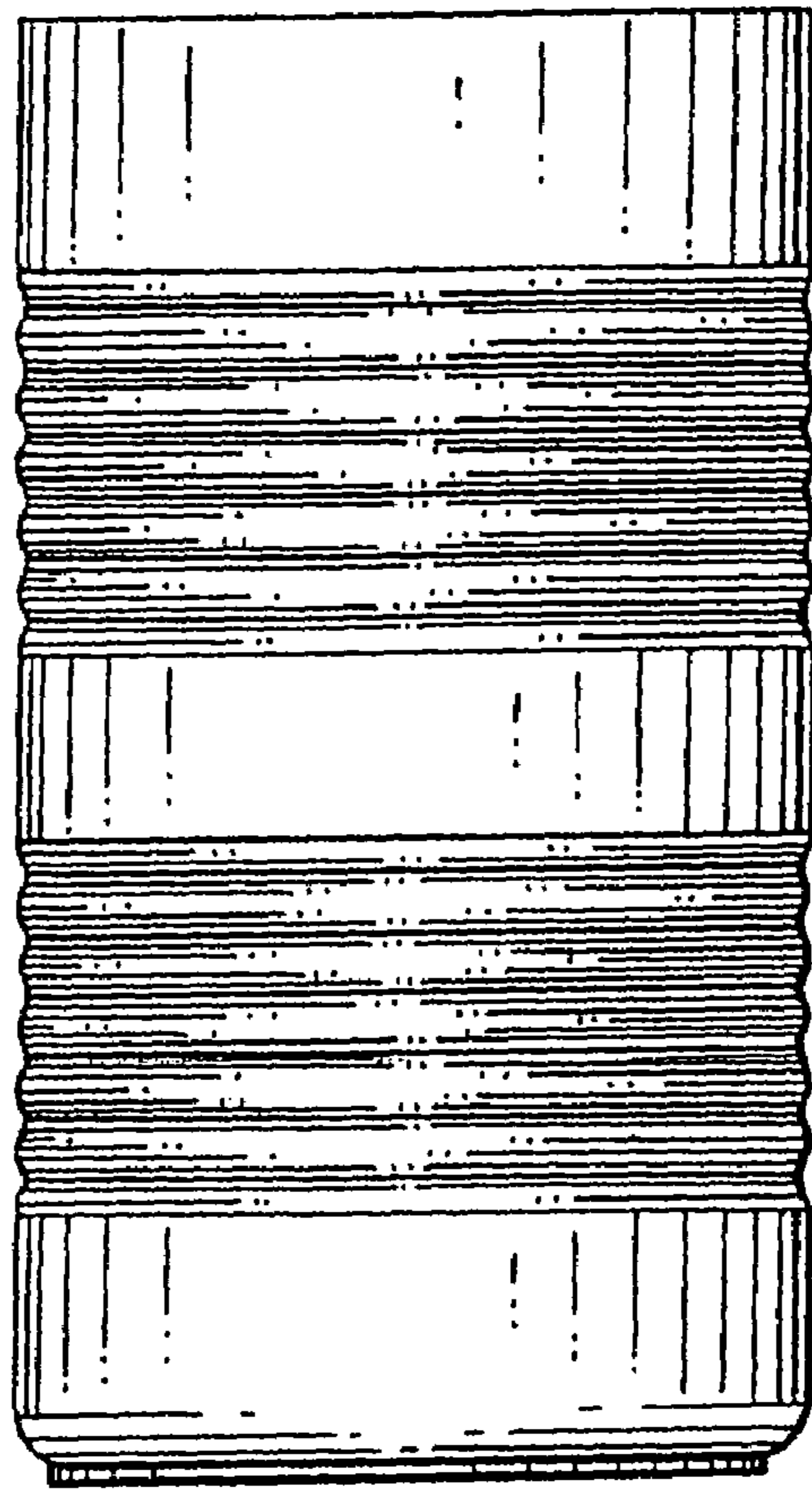

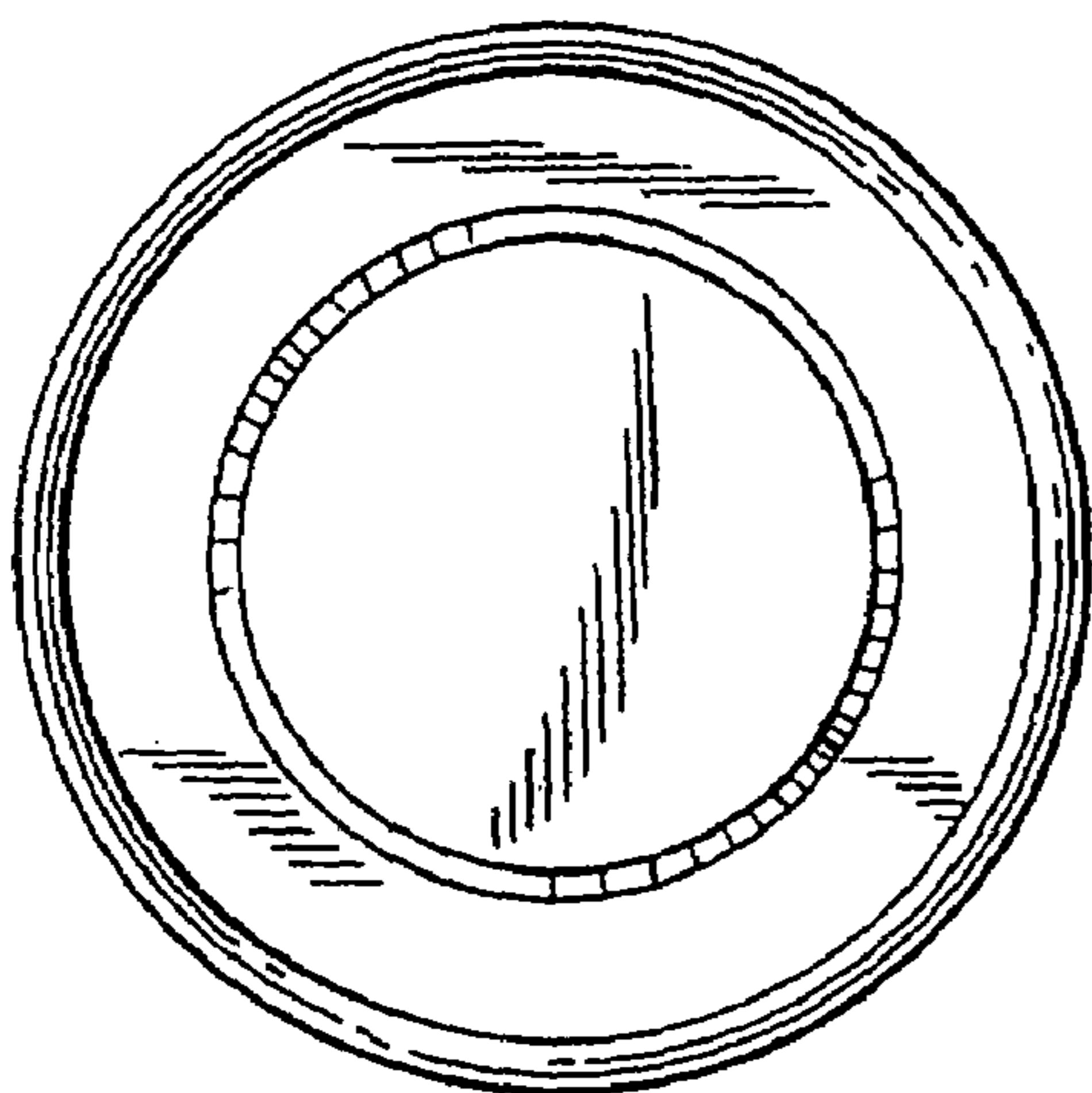
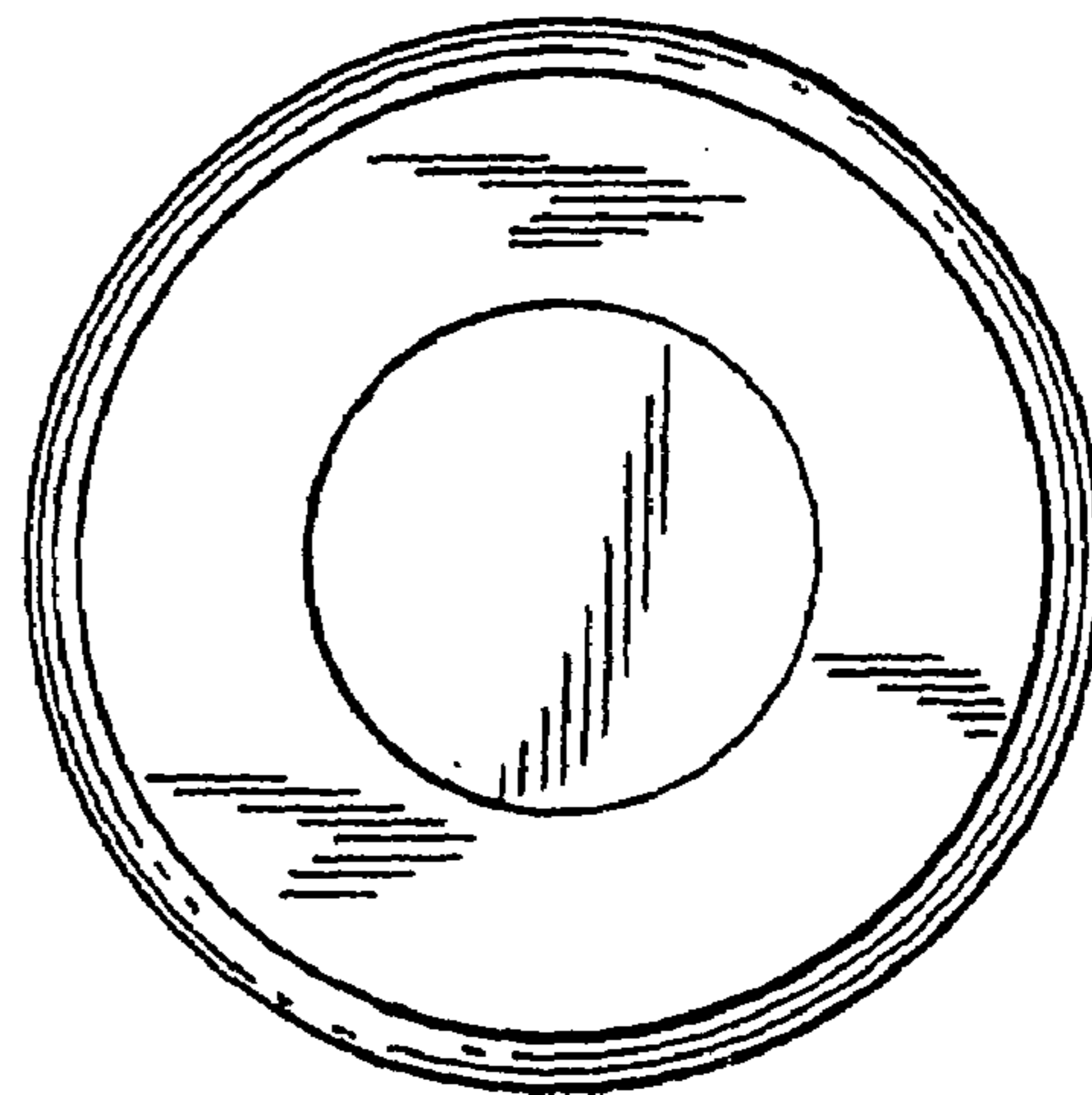

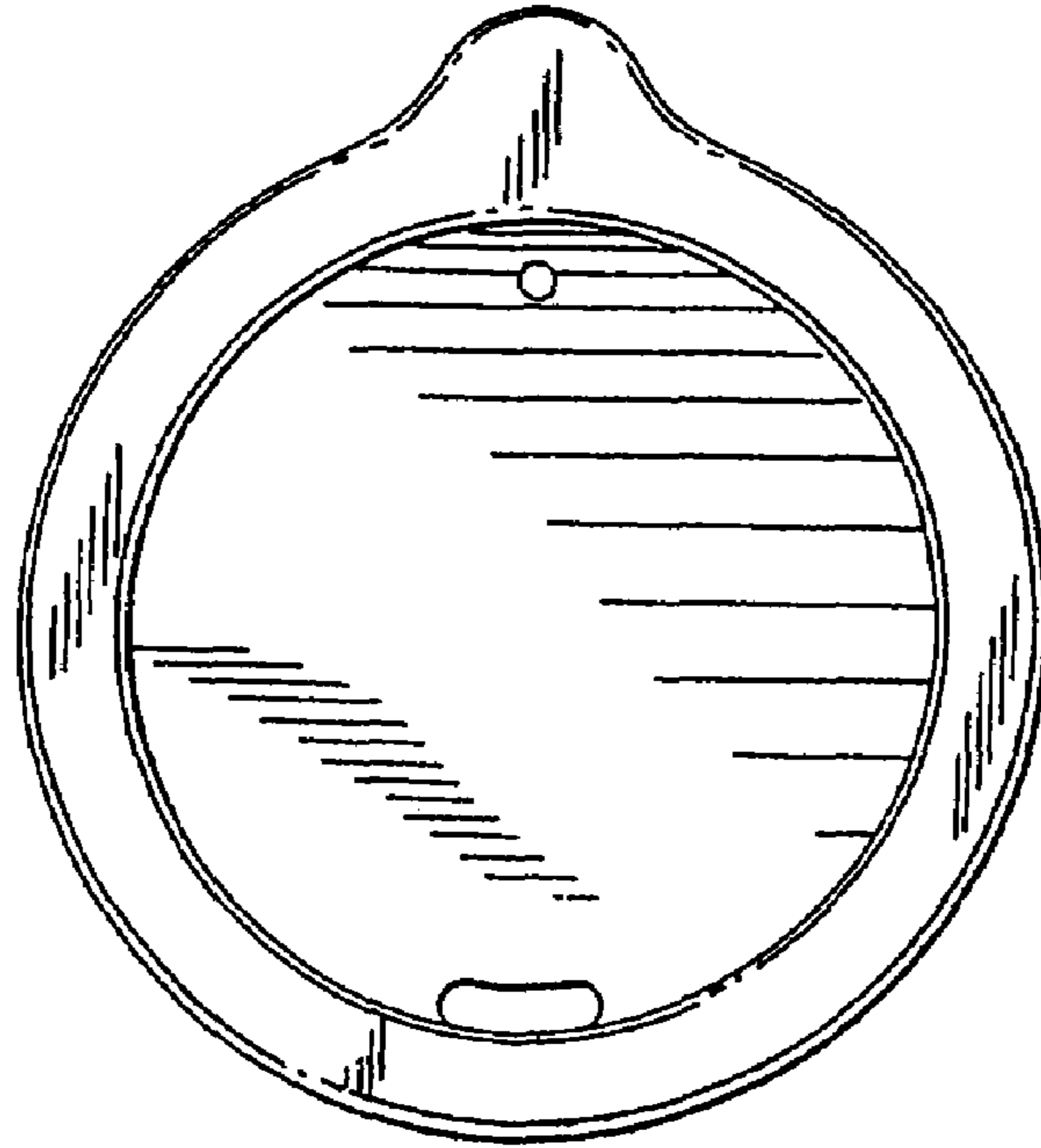

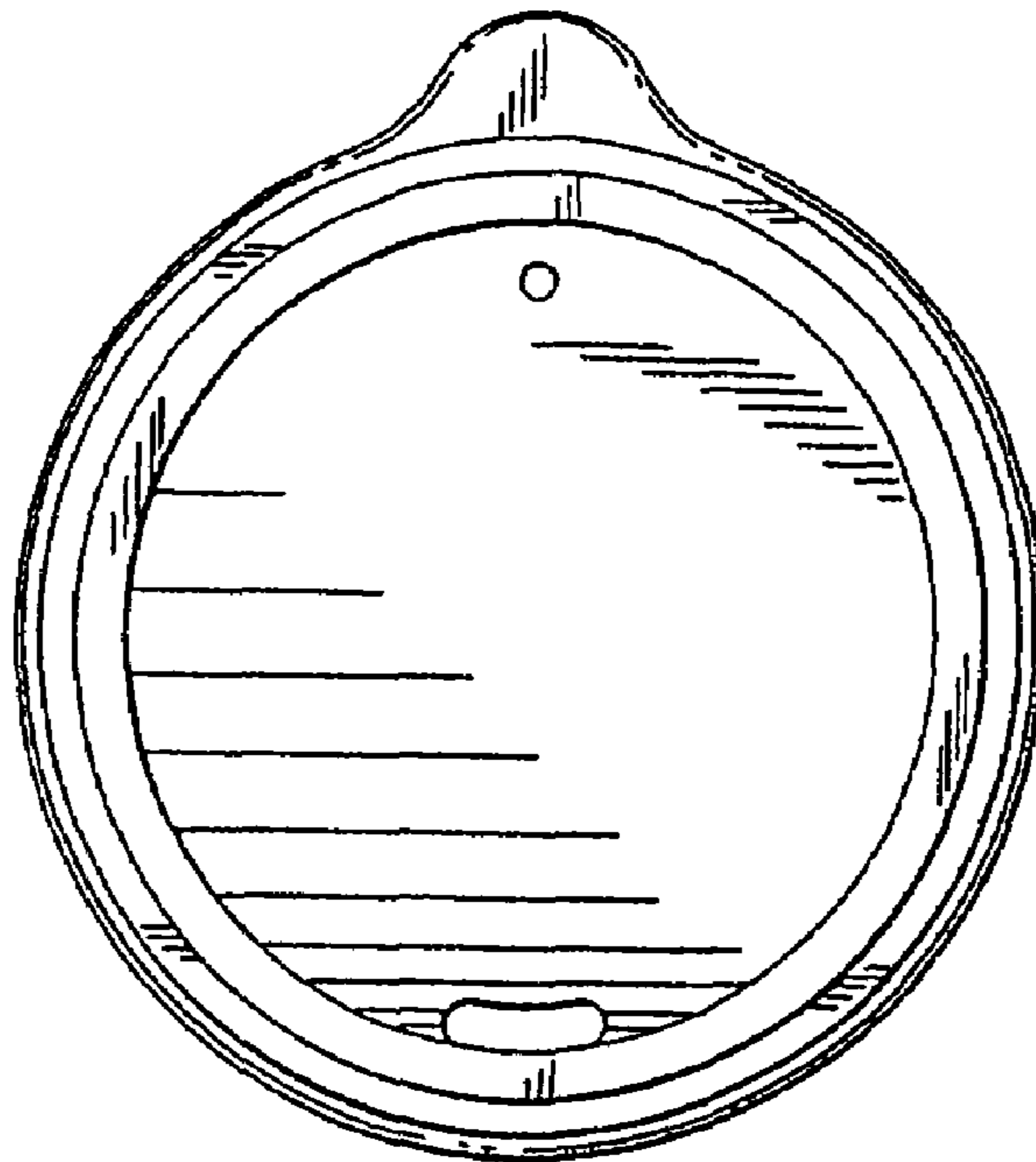

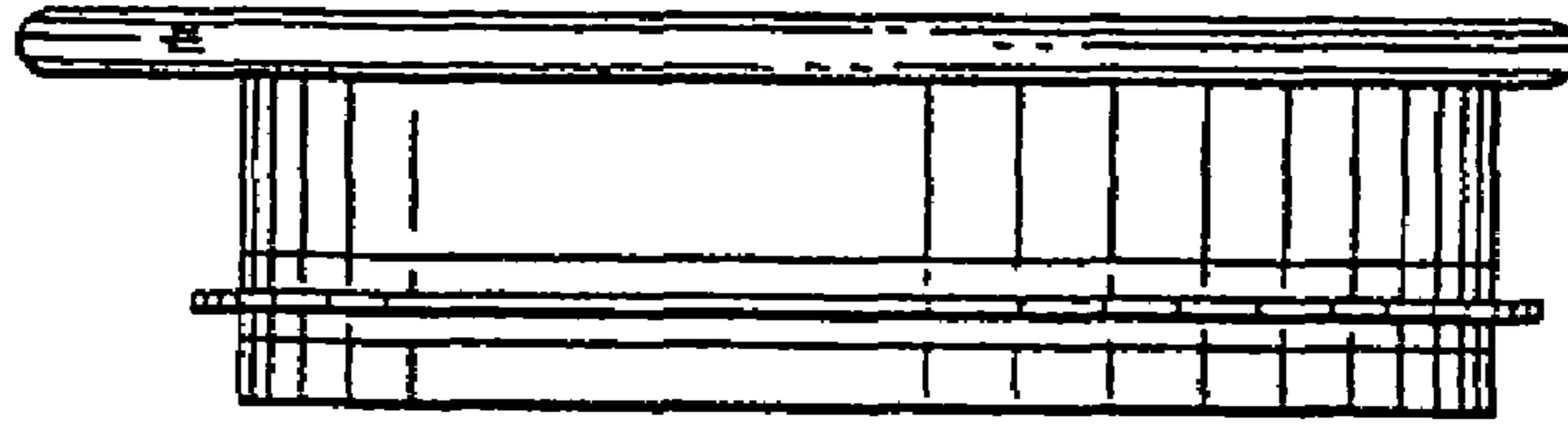

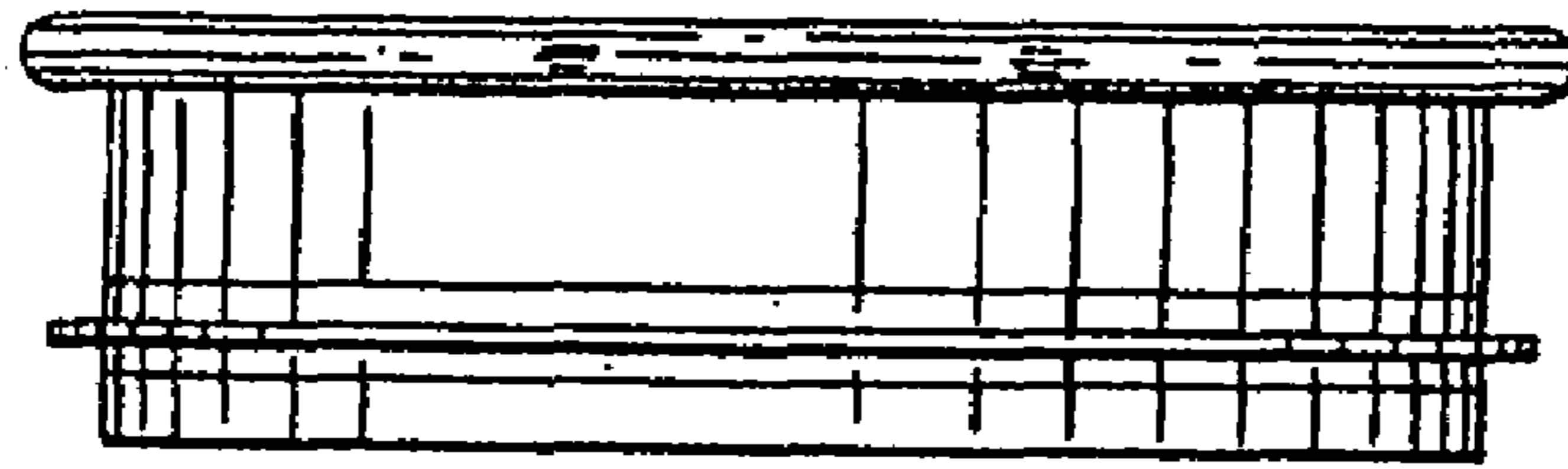

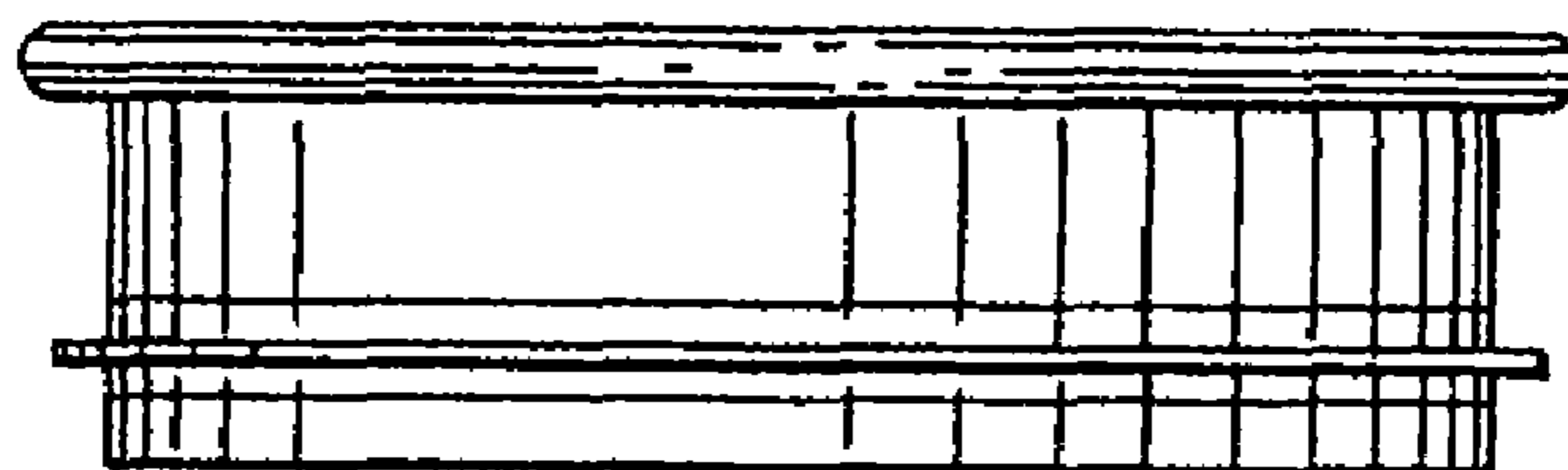

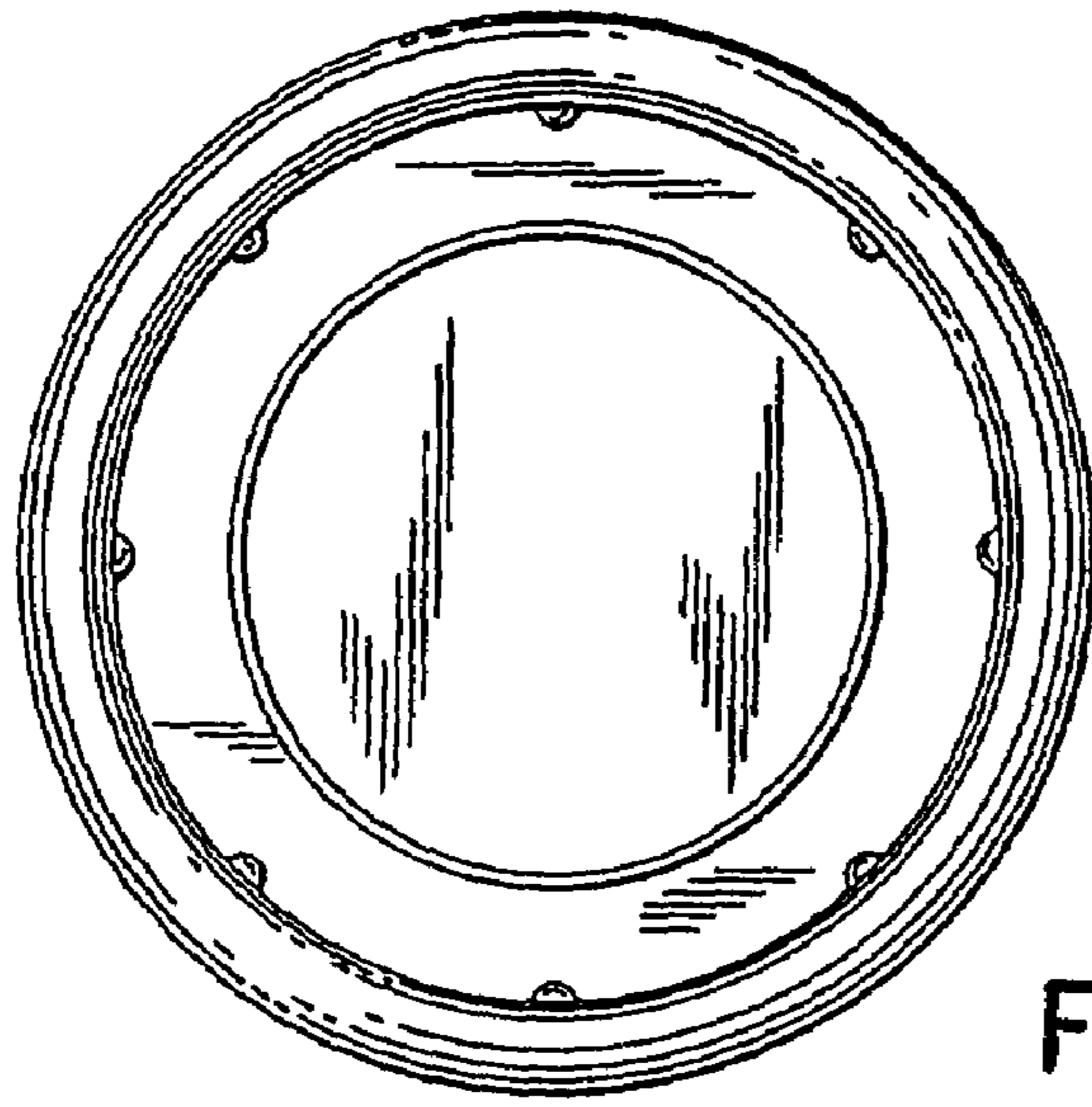

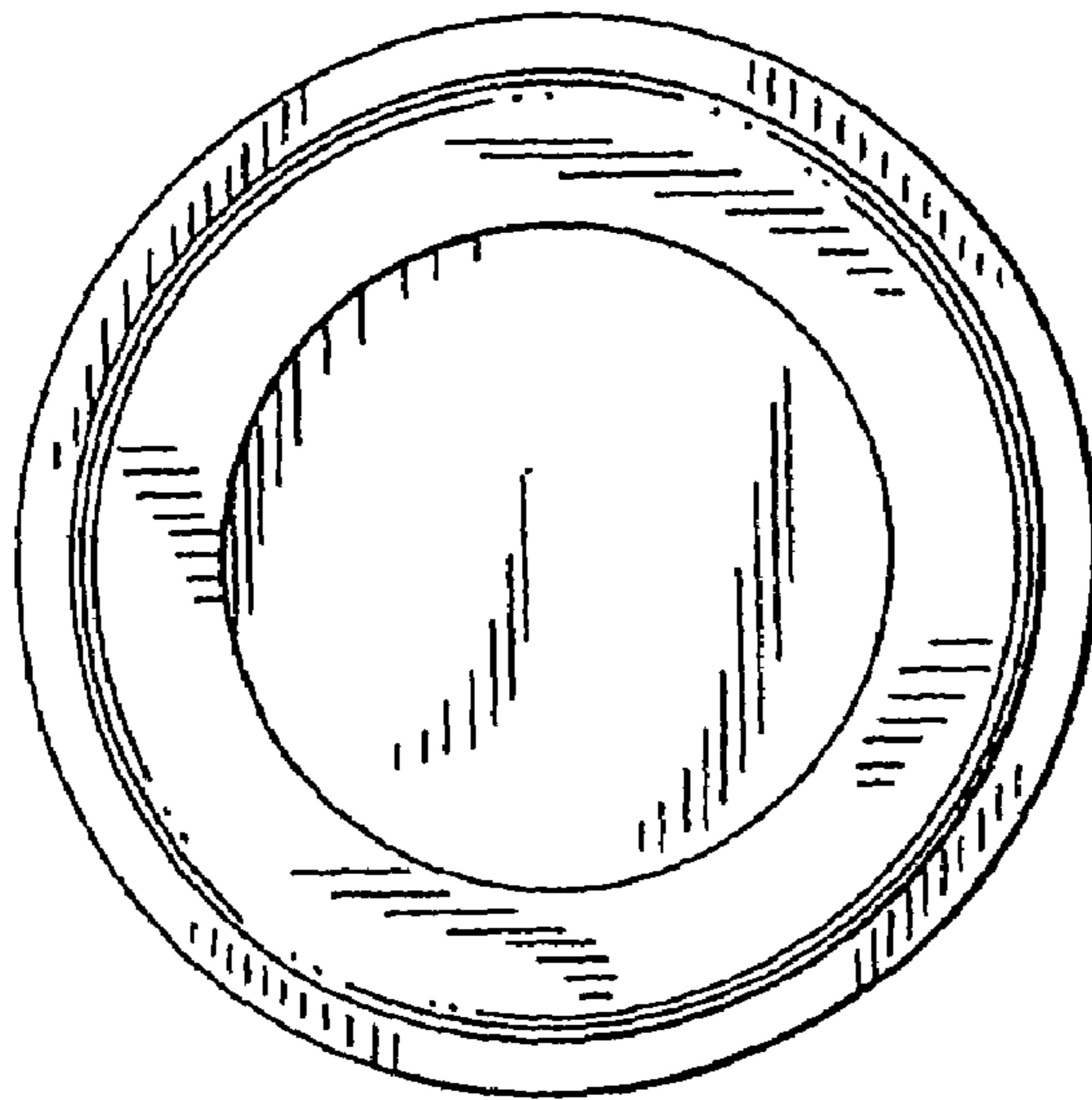

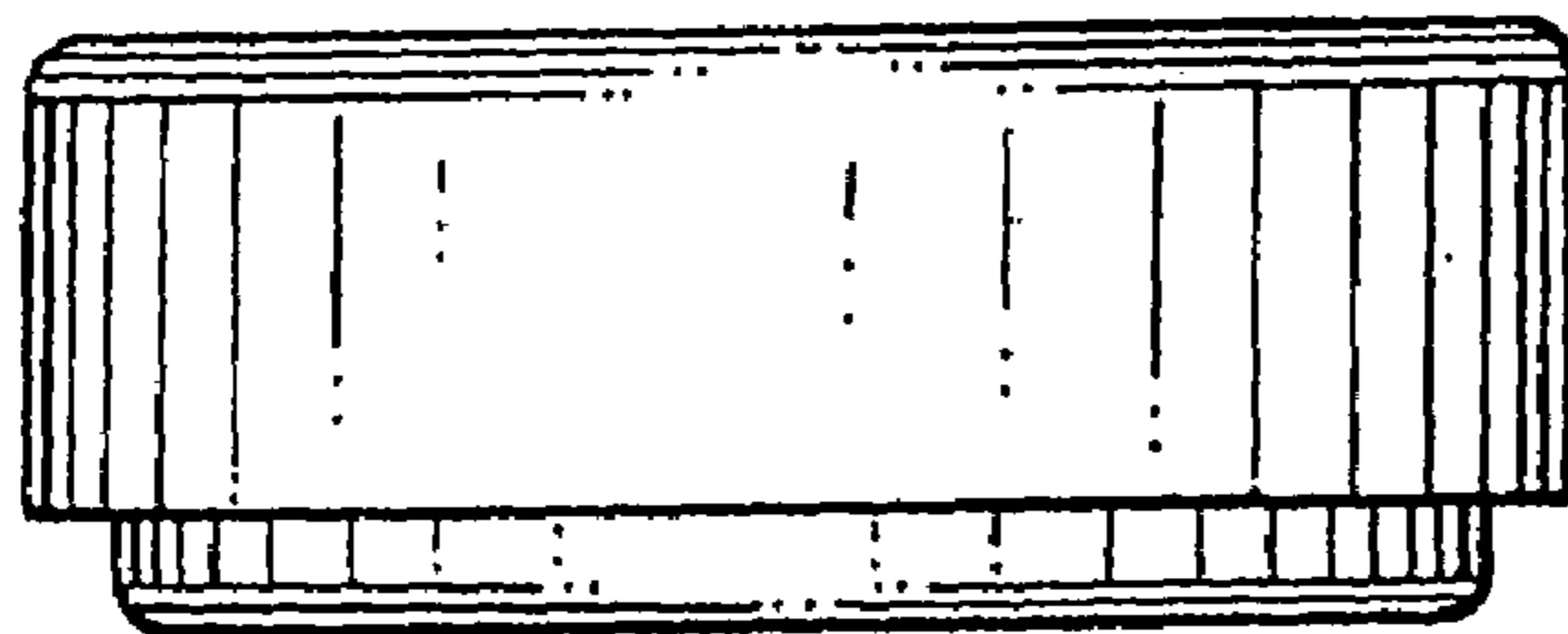
