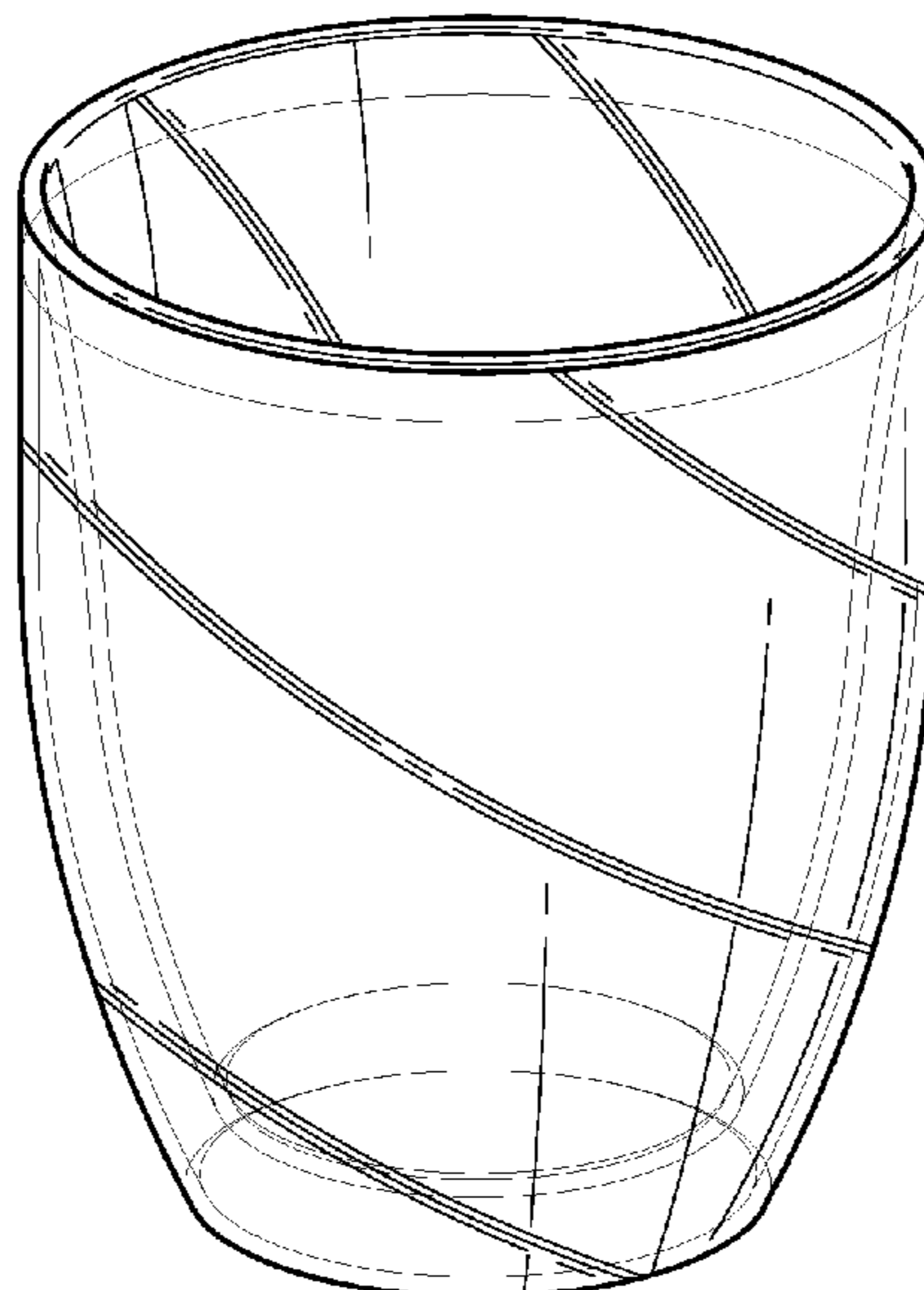
(57) **CLAIM**

The ornamental design for a double walled glass, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the double walled glass showing my design thereof;

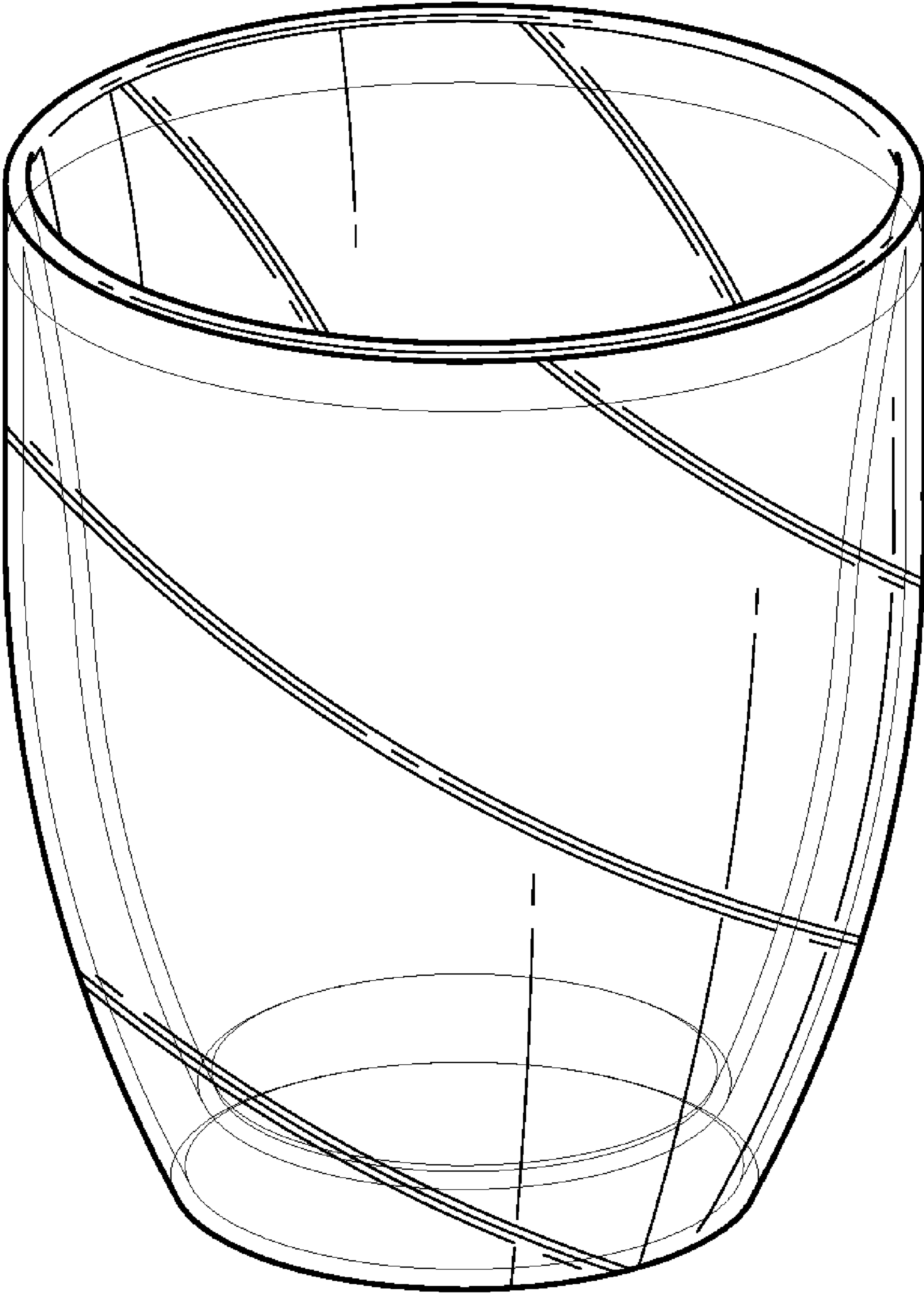

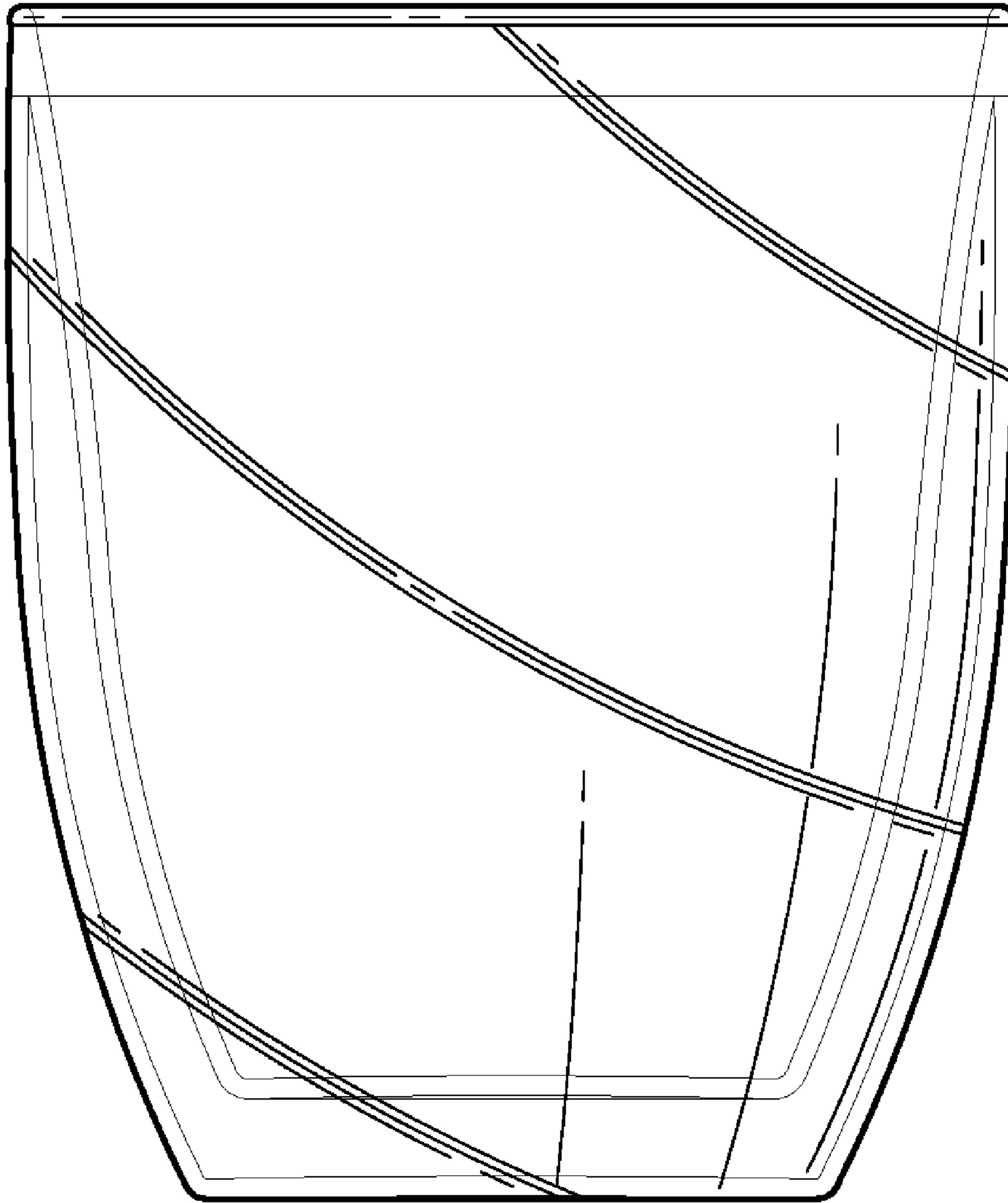
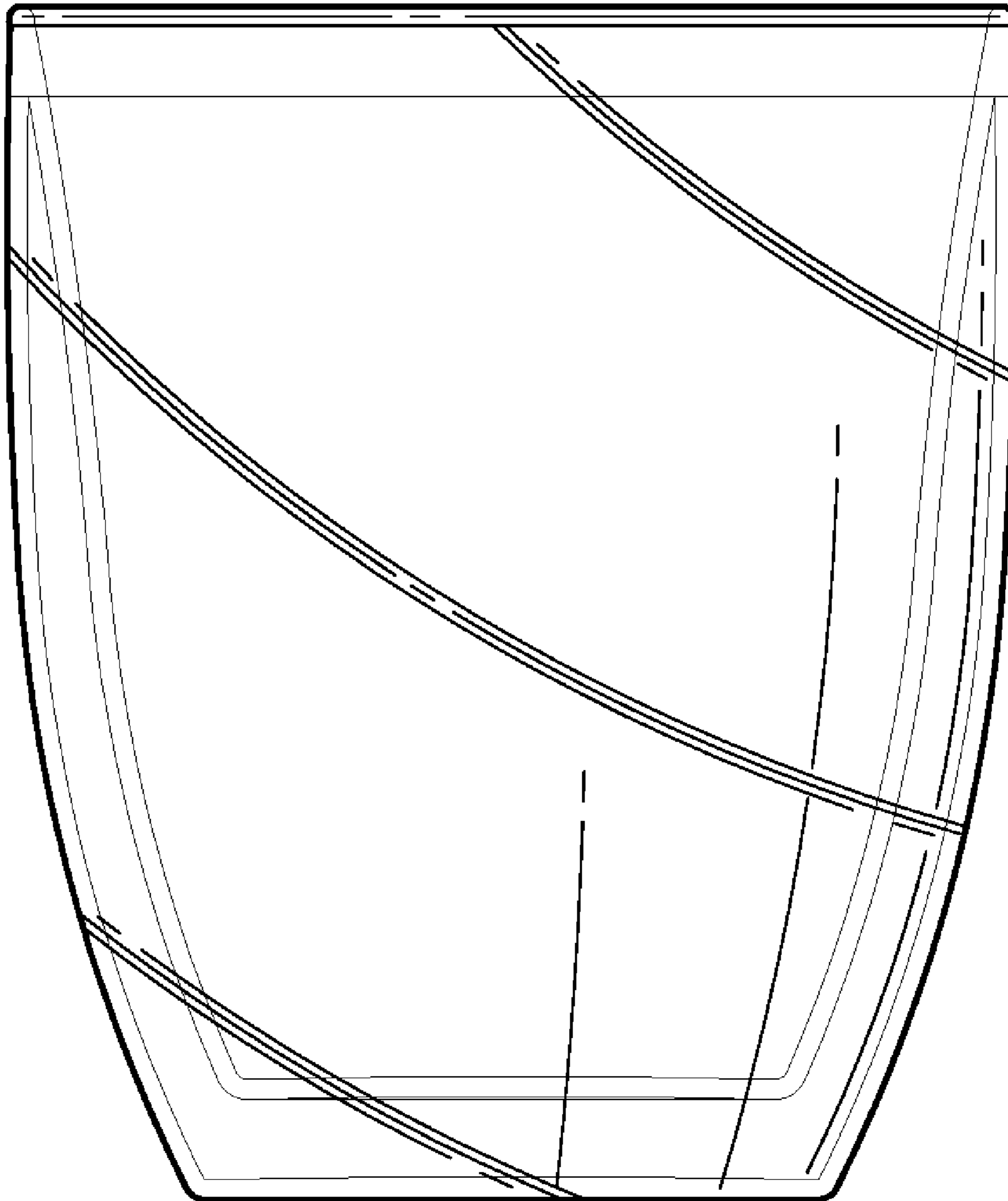

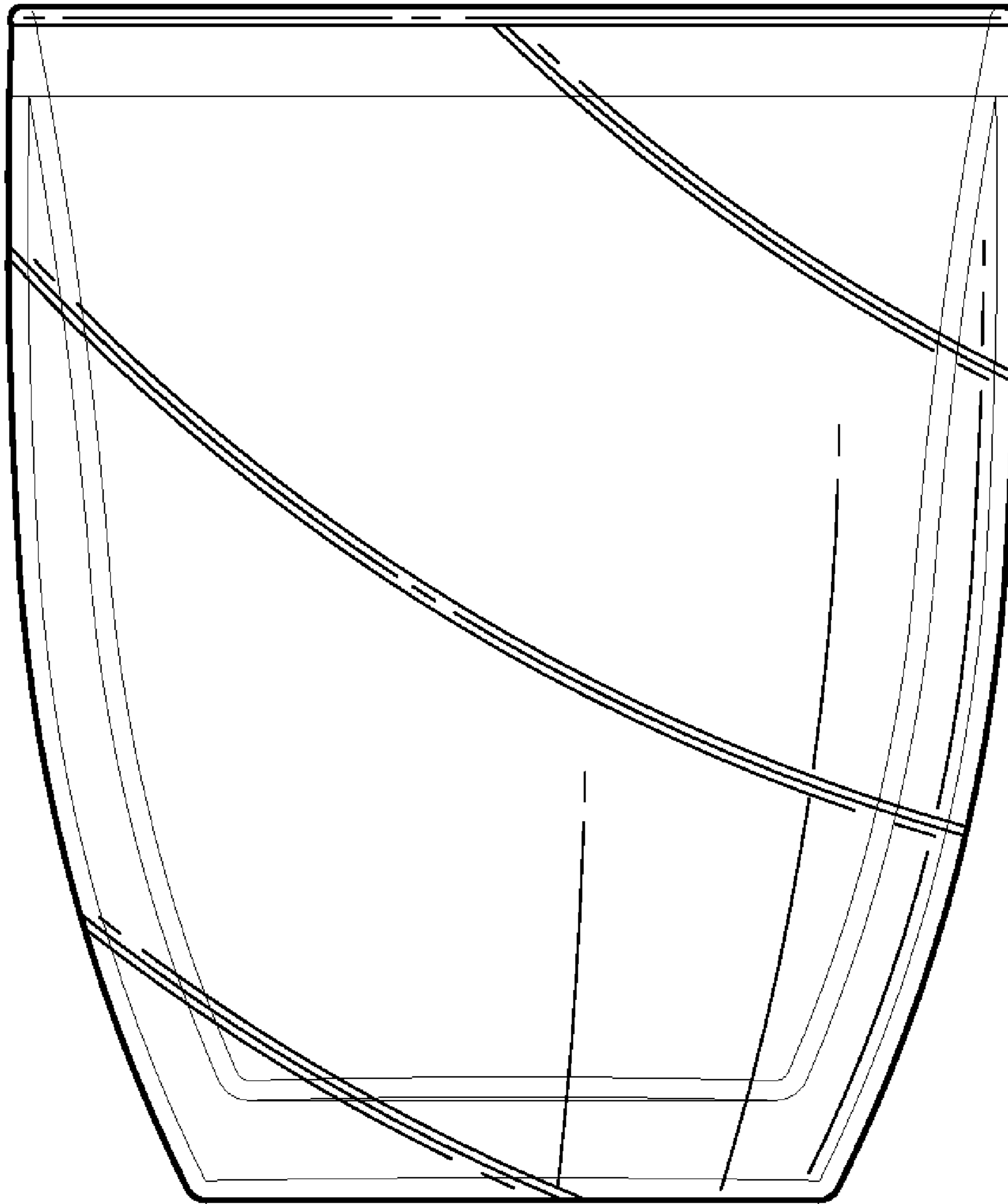

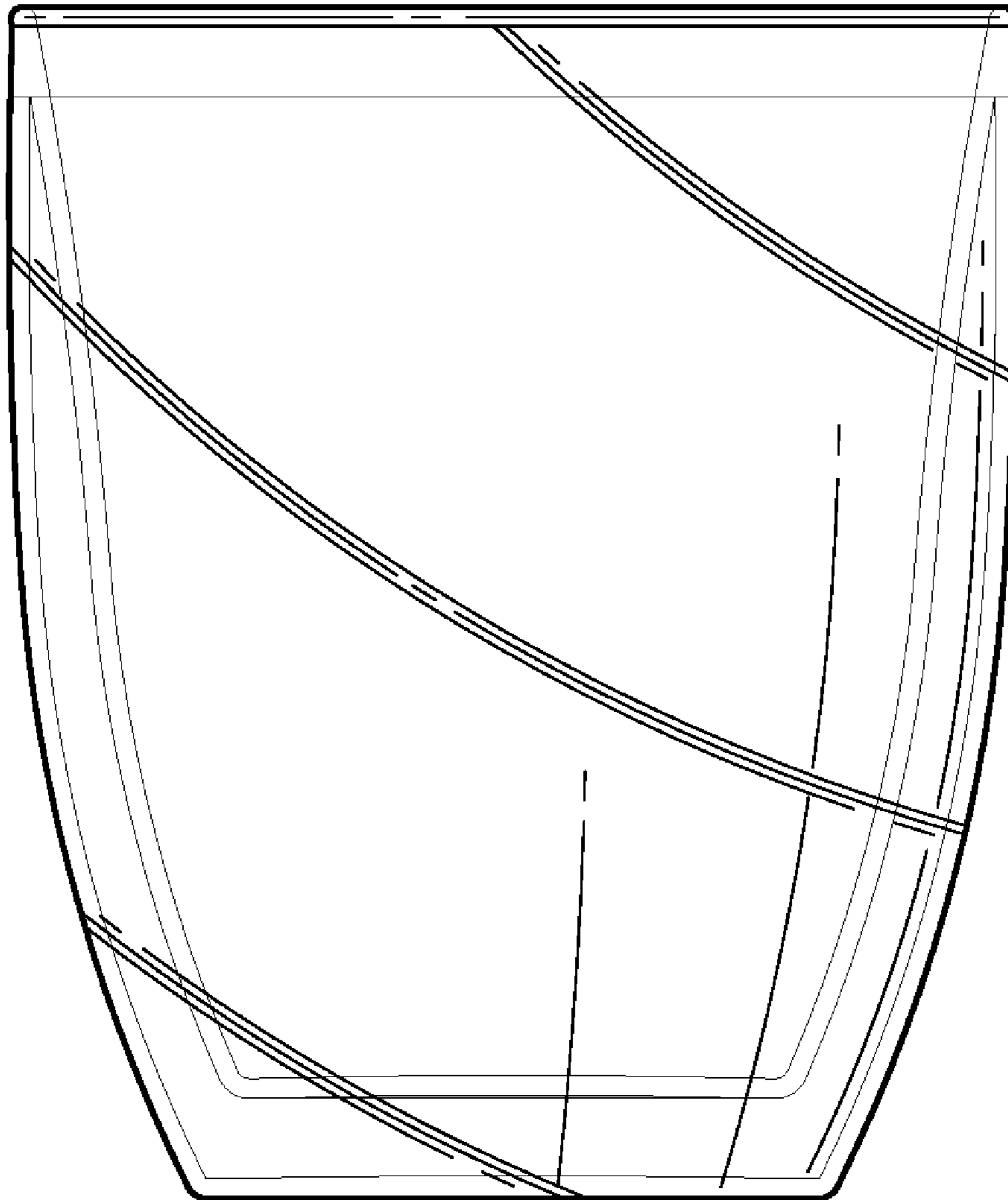

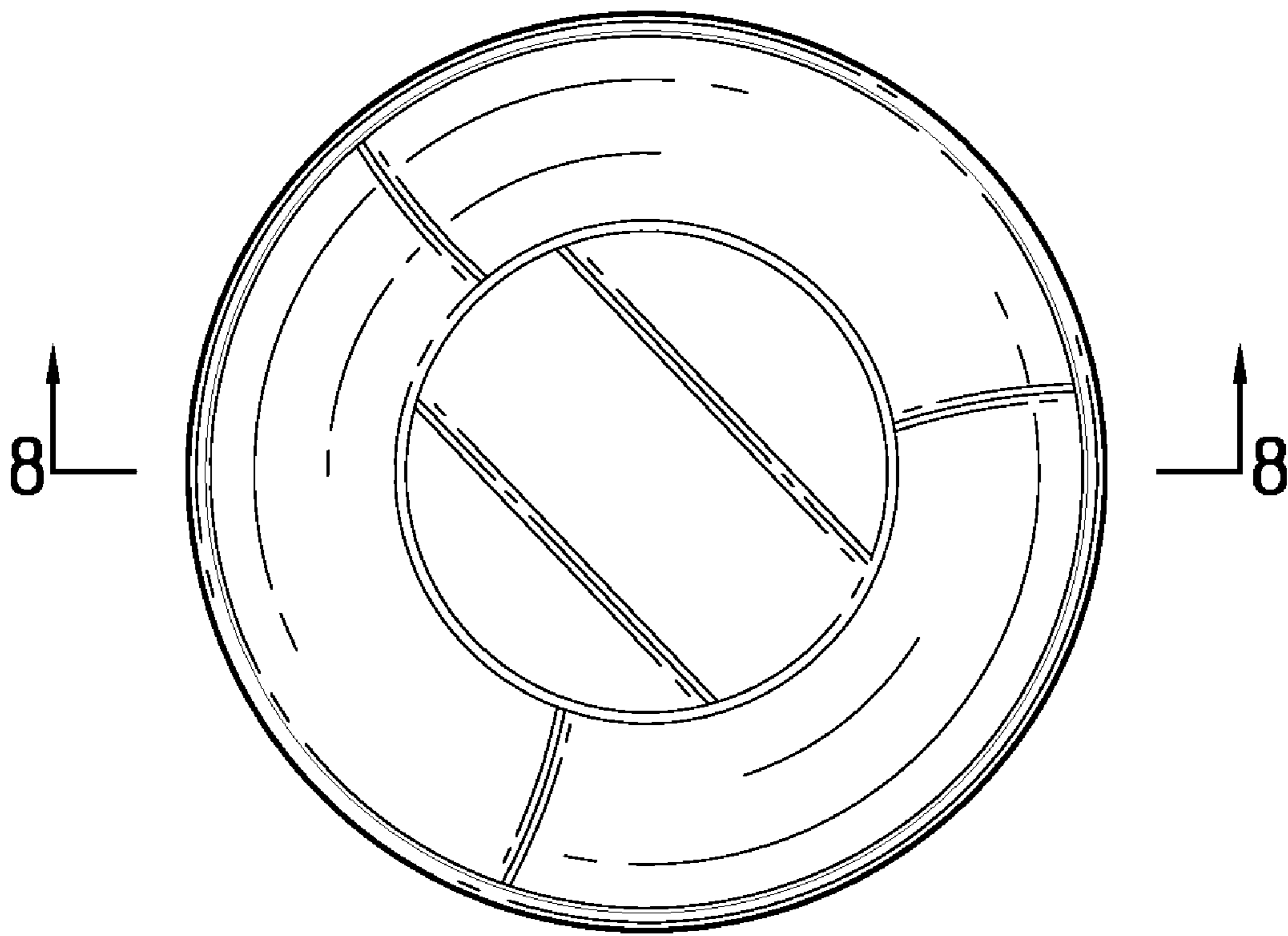

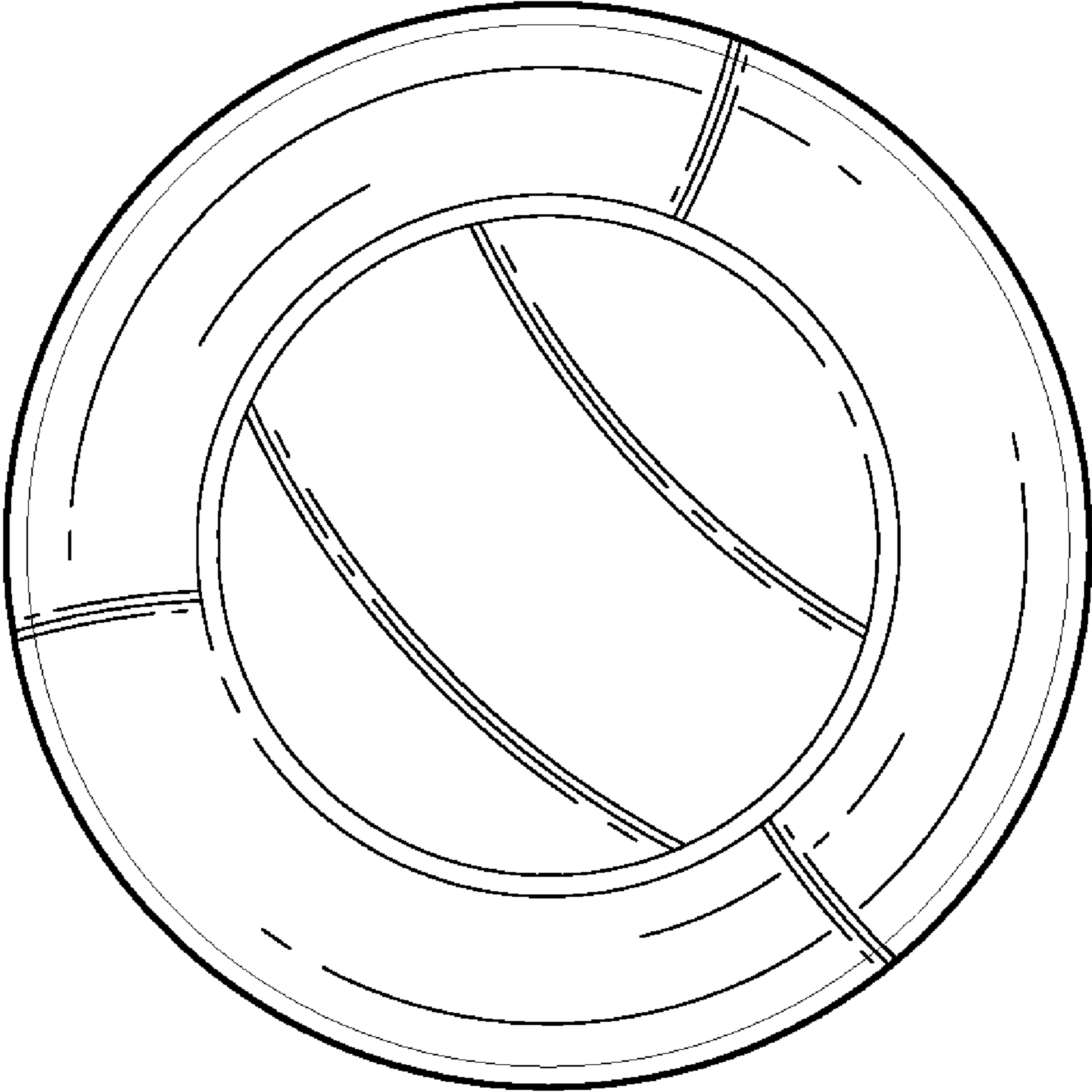

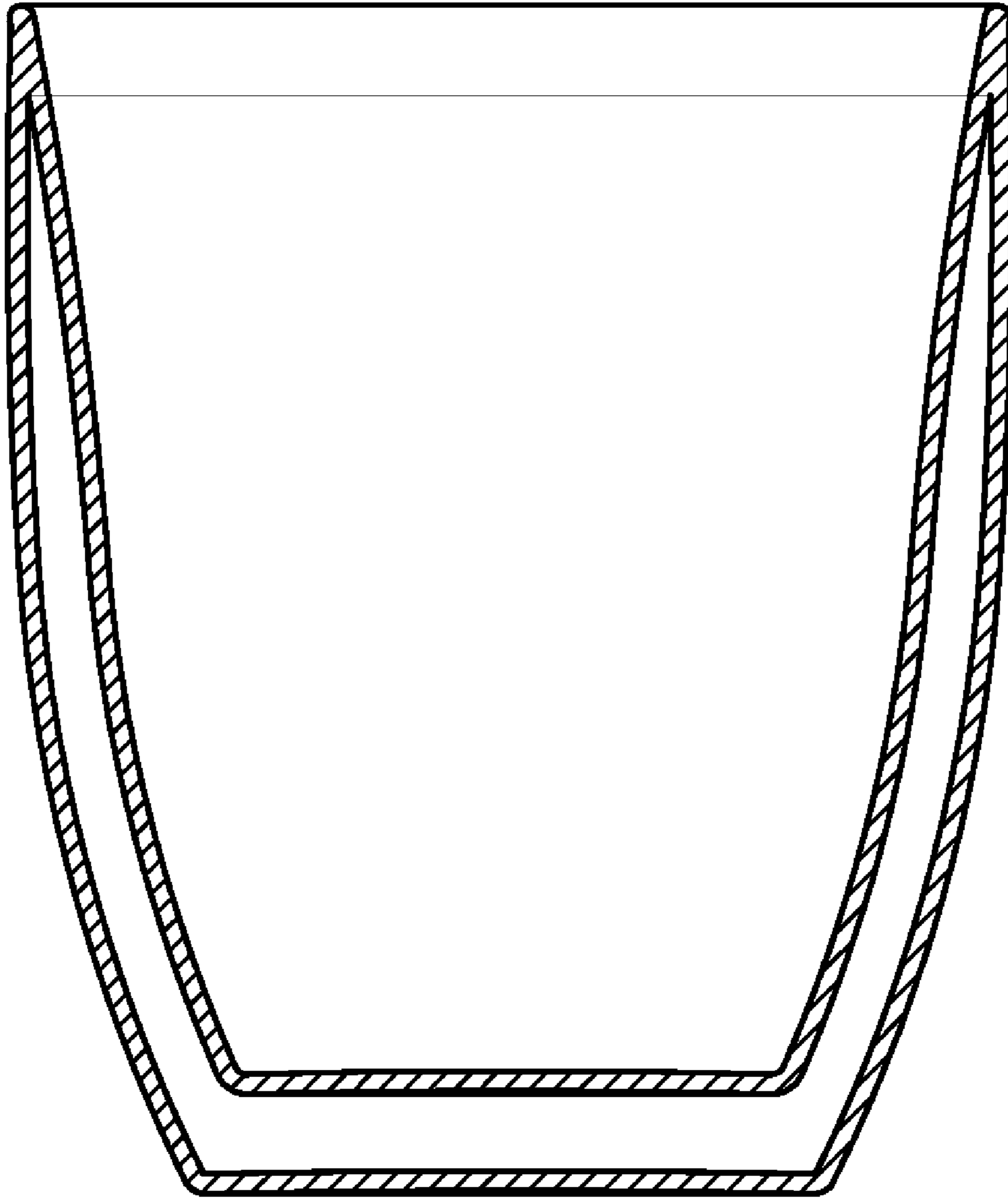

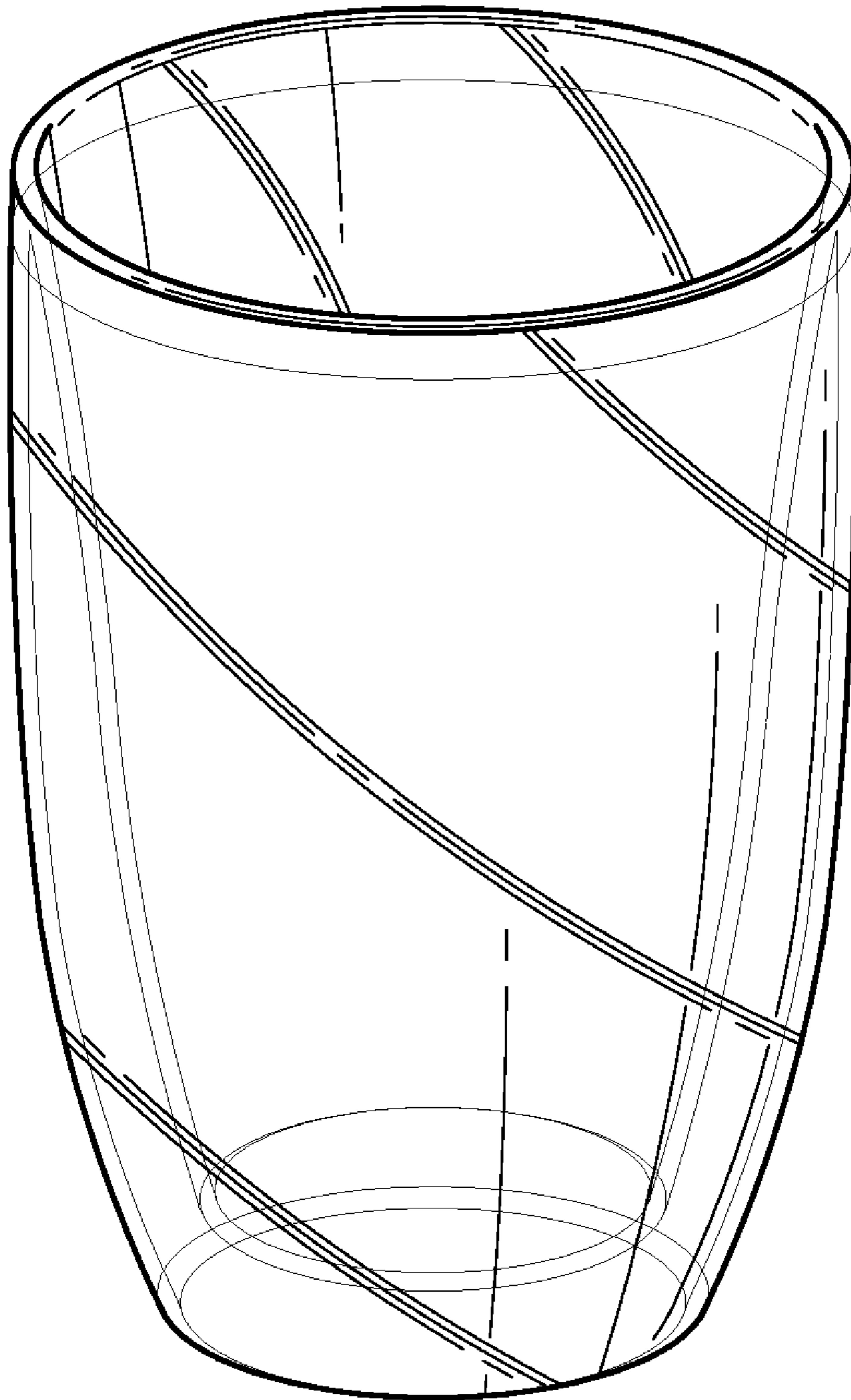

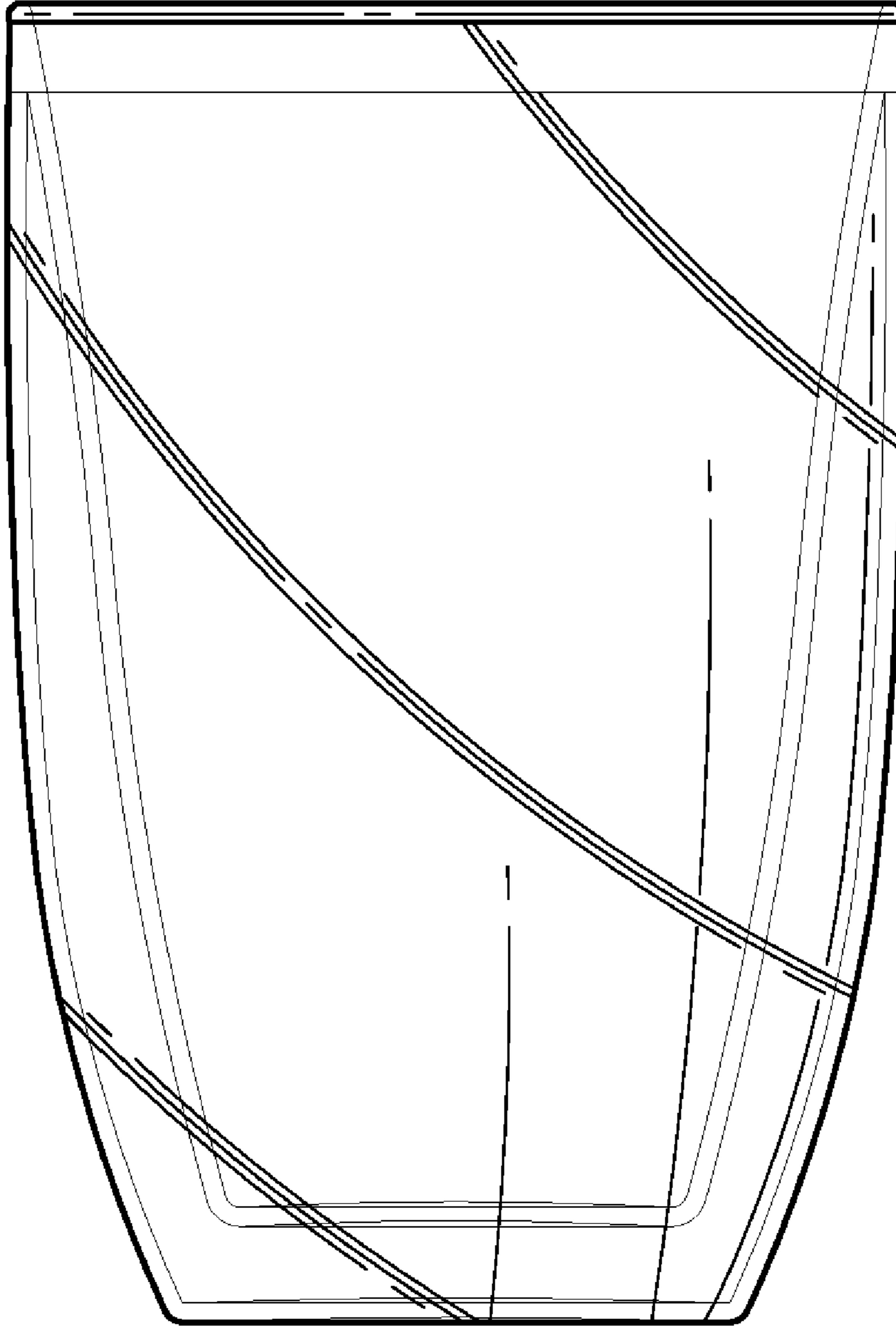
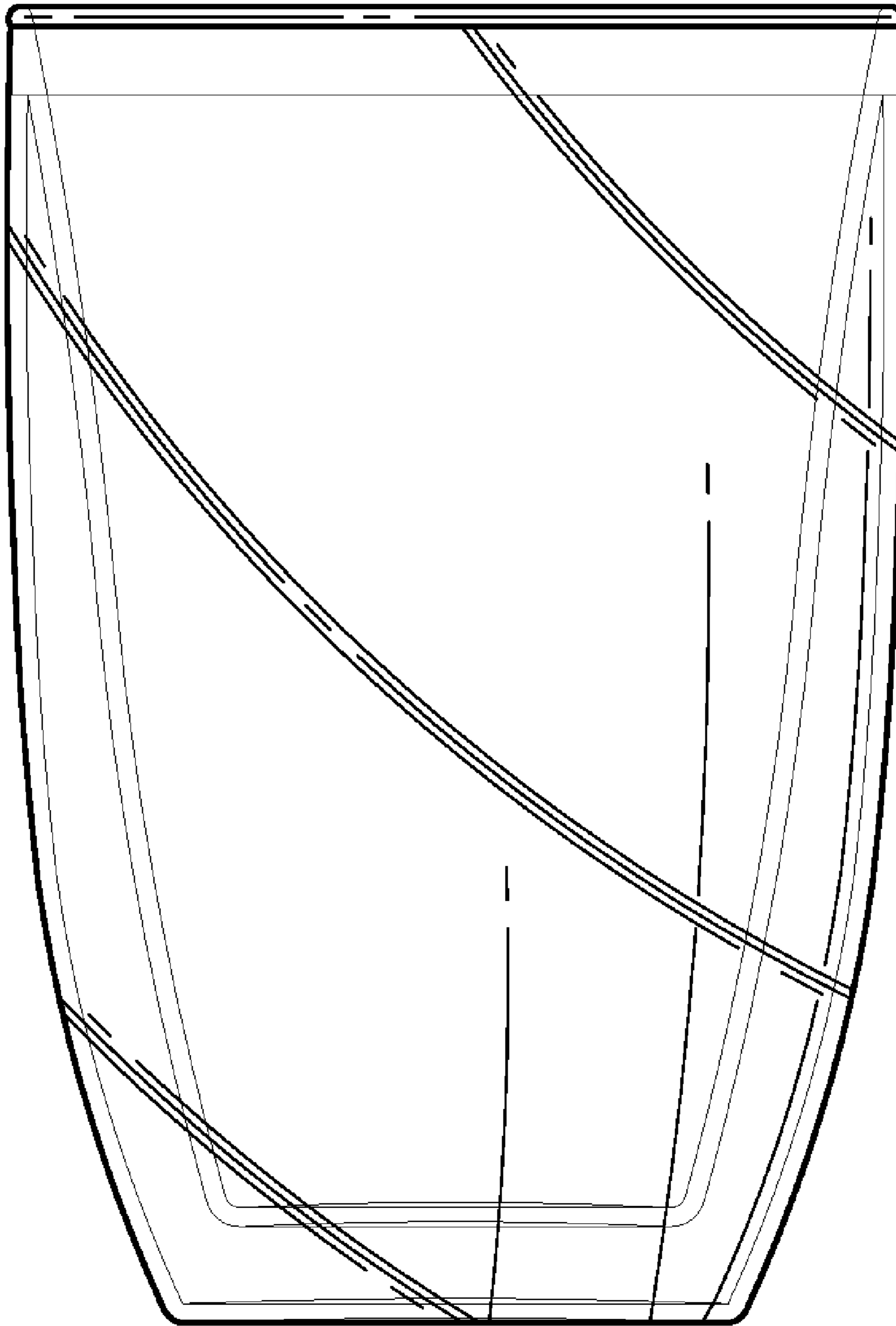
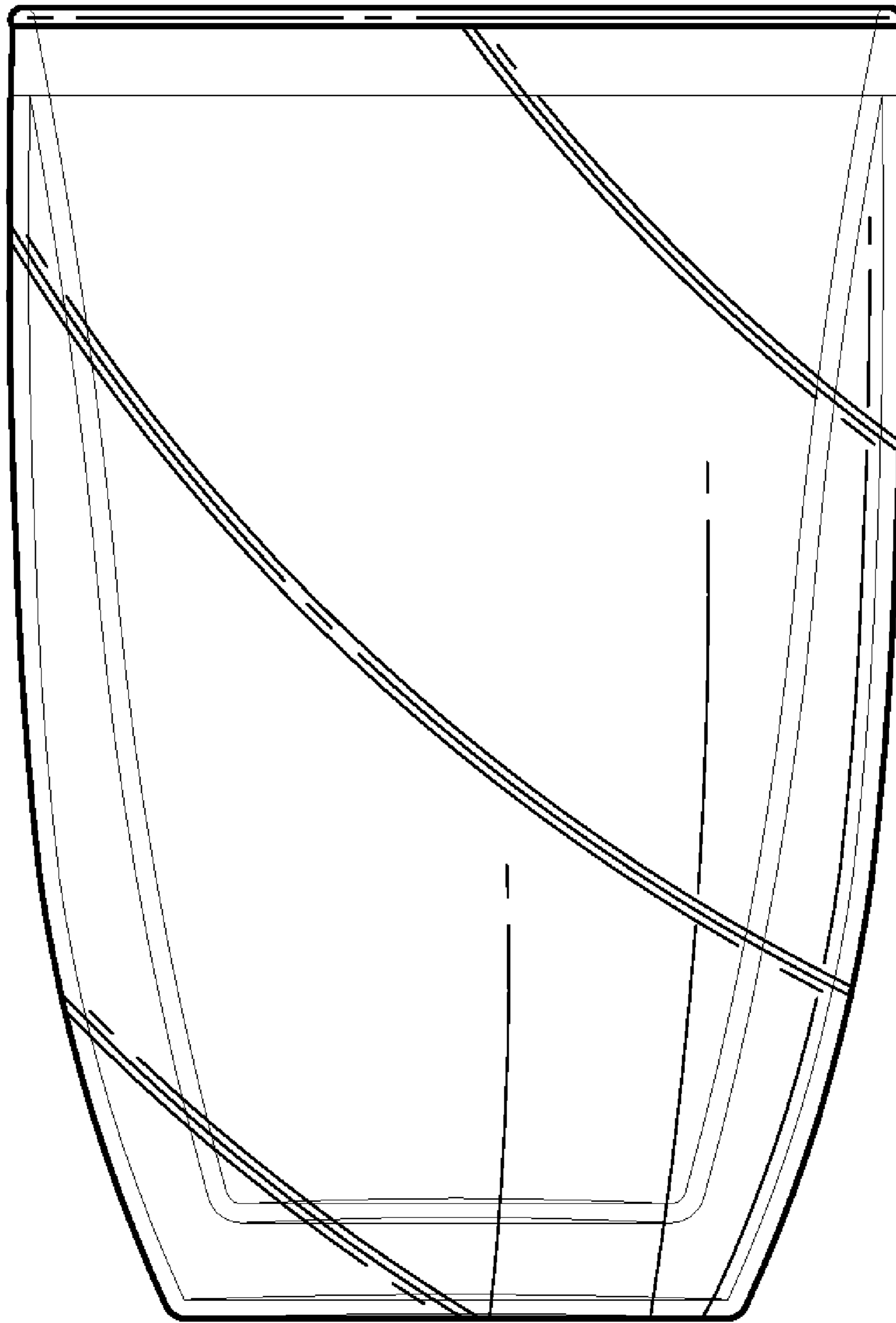


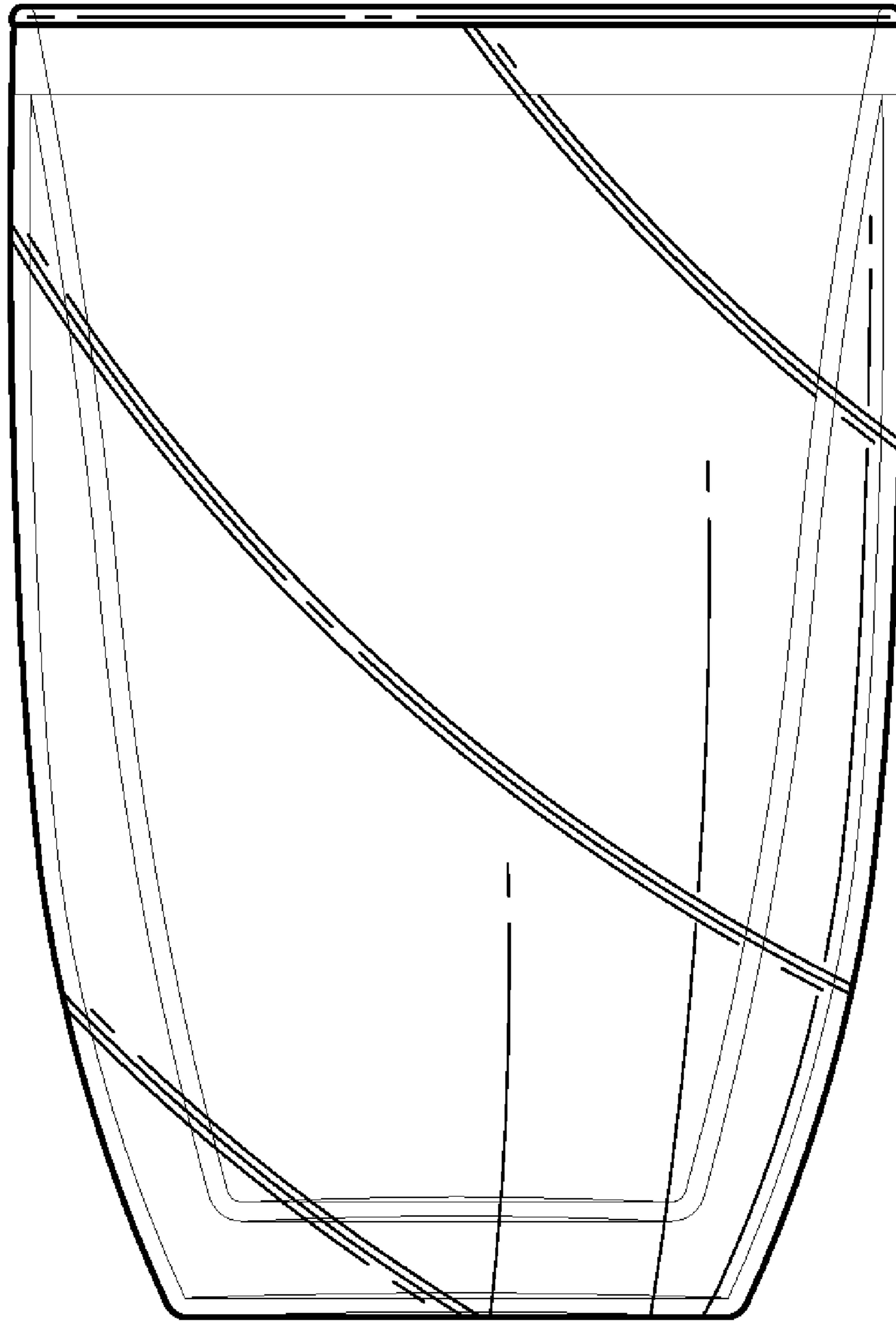

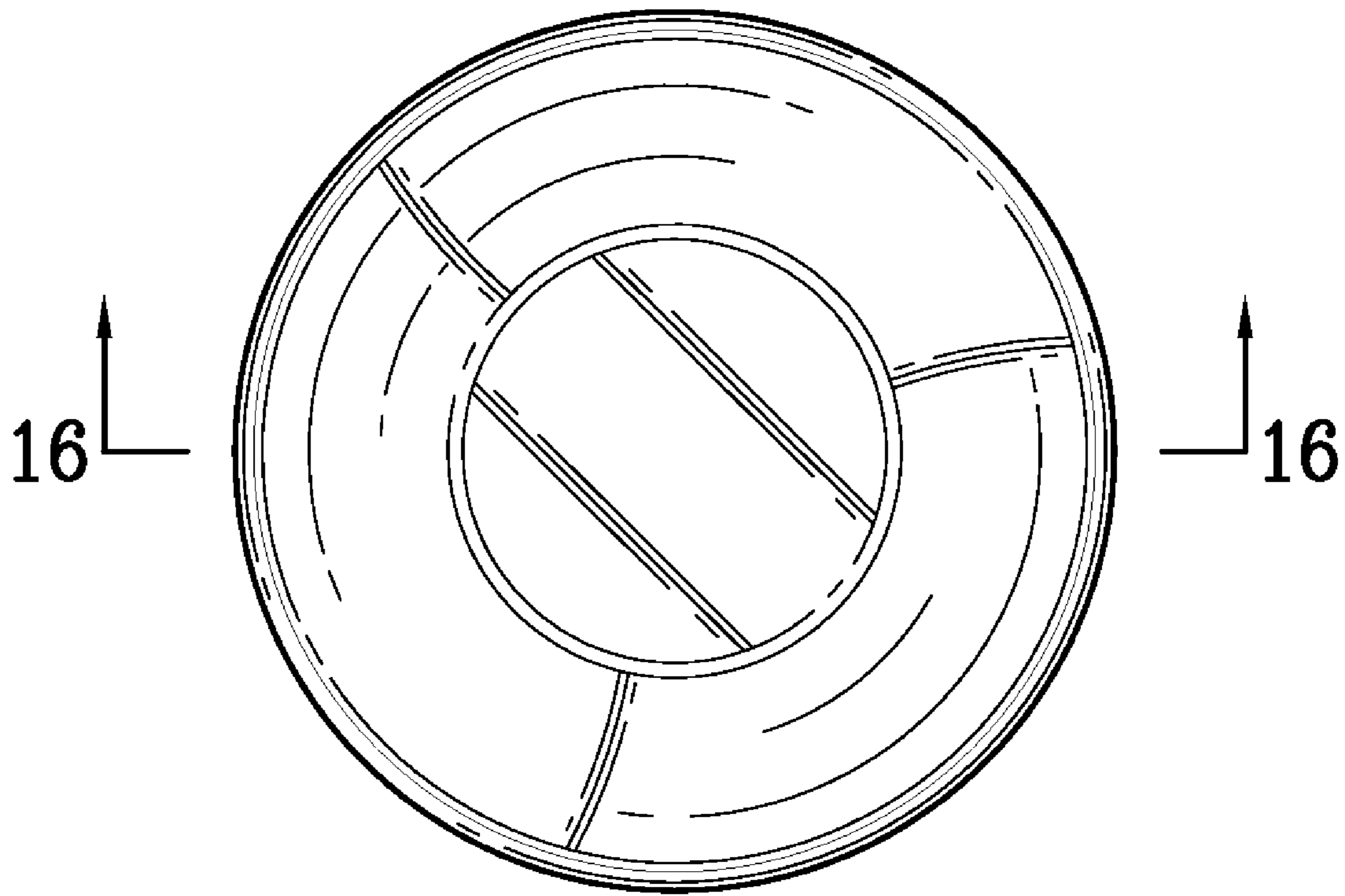
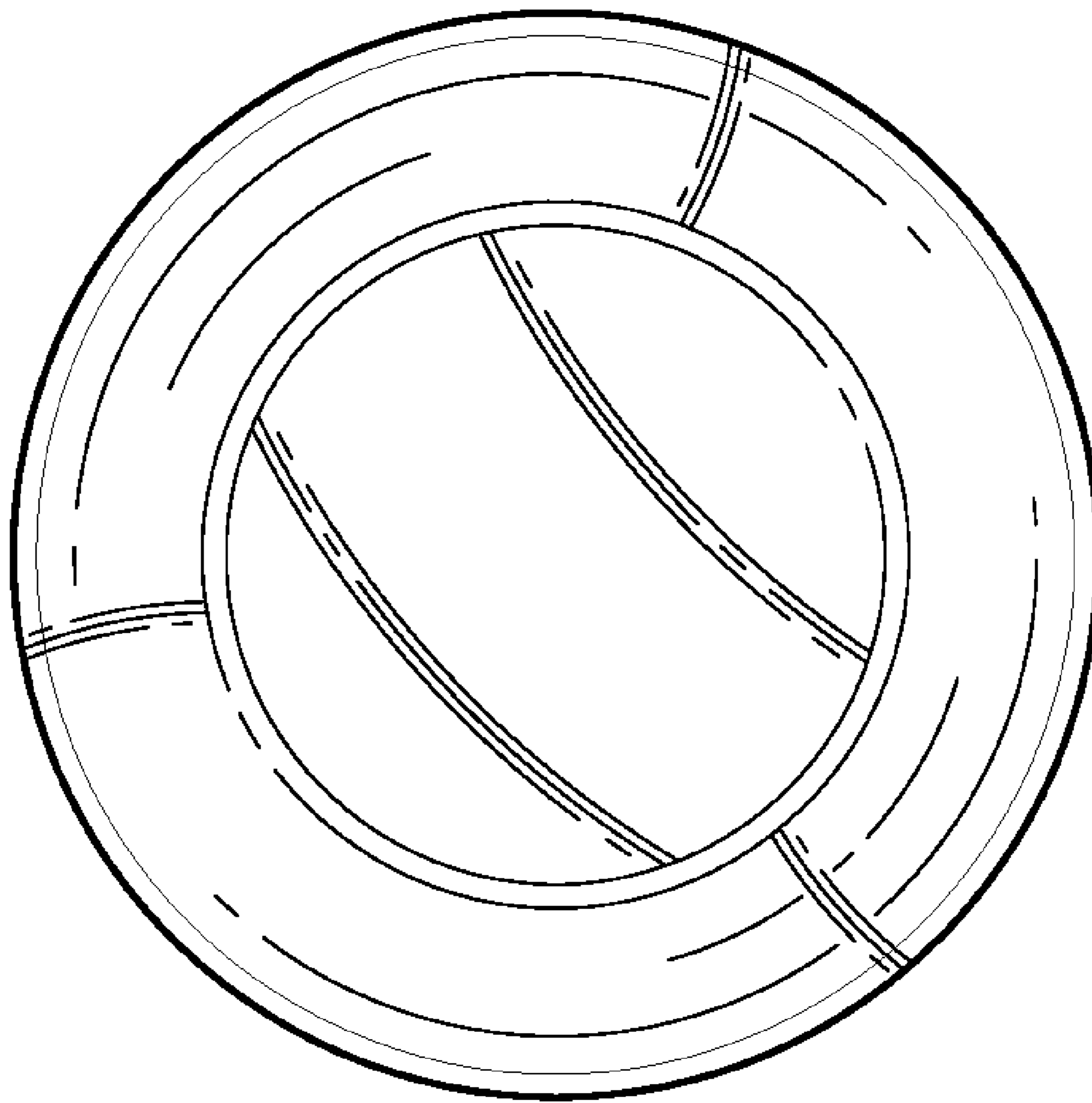
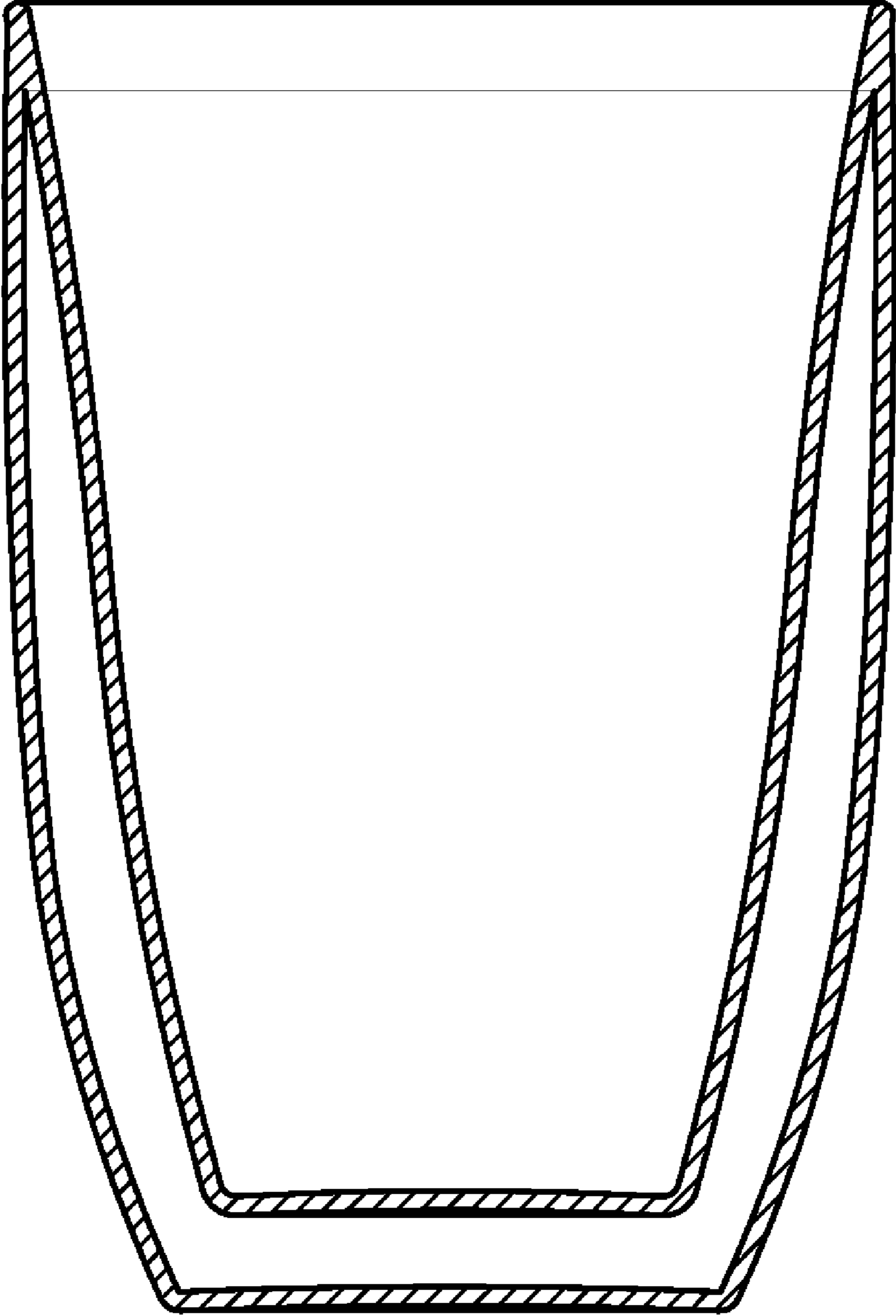
