FIG. 1 is a perspective view thereof;

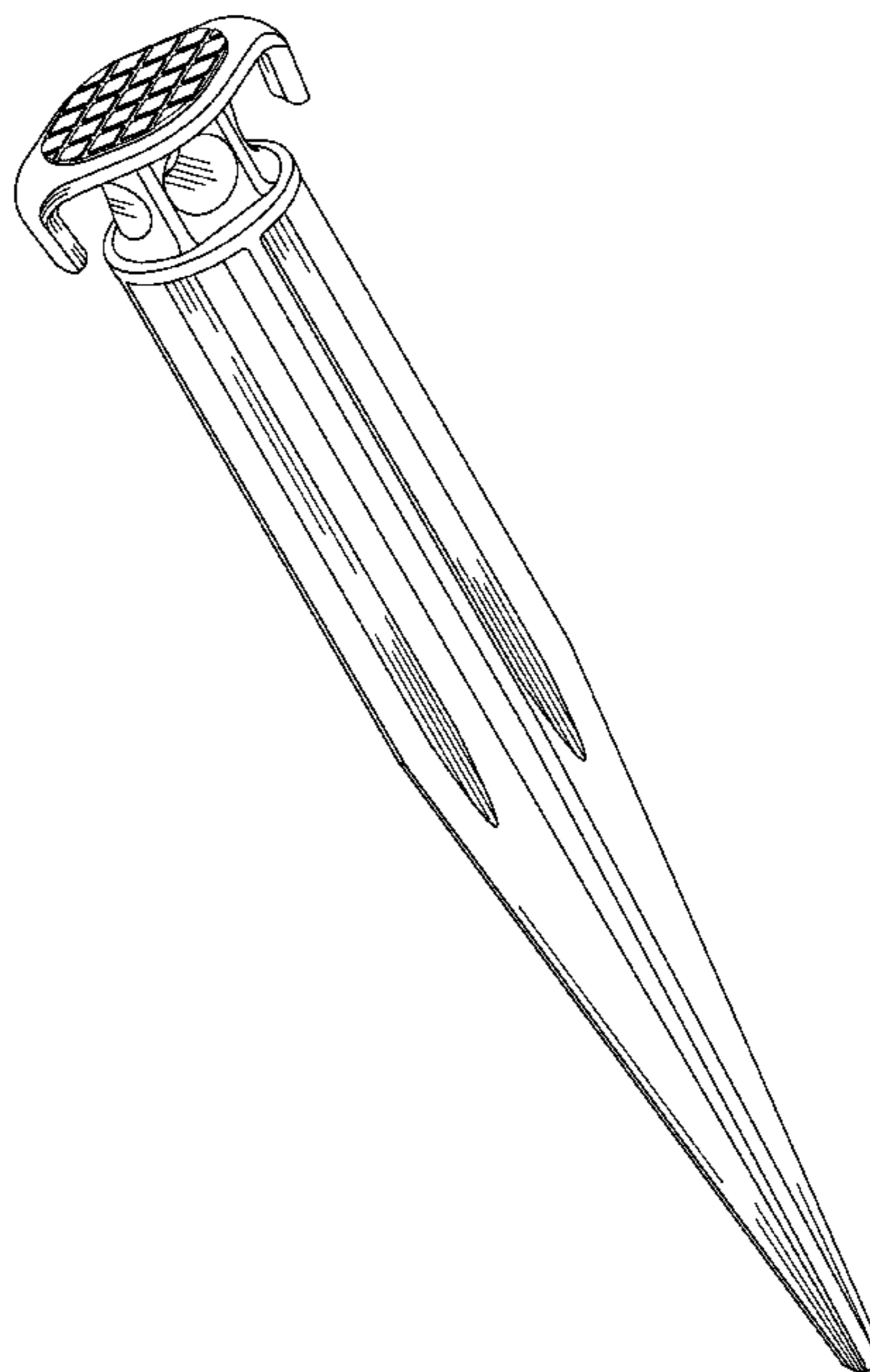
FIG. 2 is a front elevation view thereof; the front and back sides are identical;

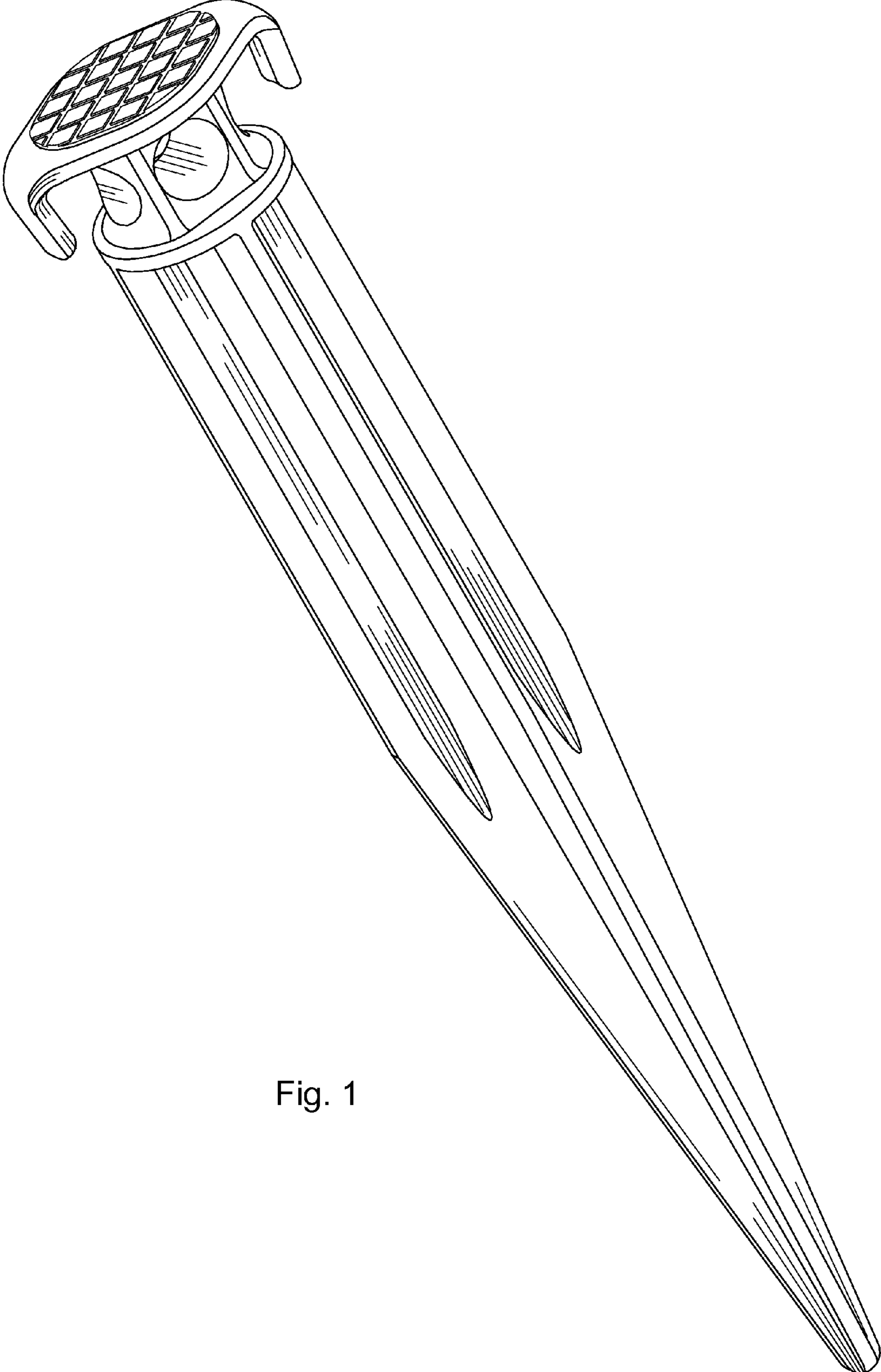

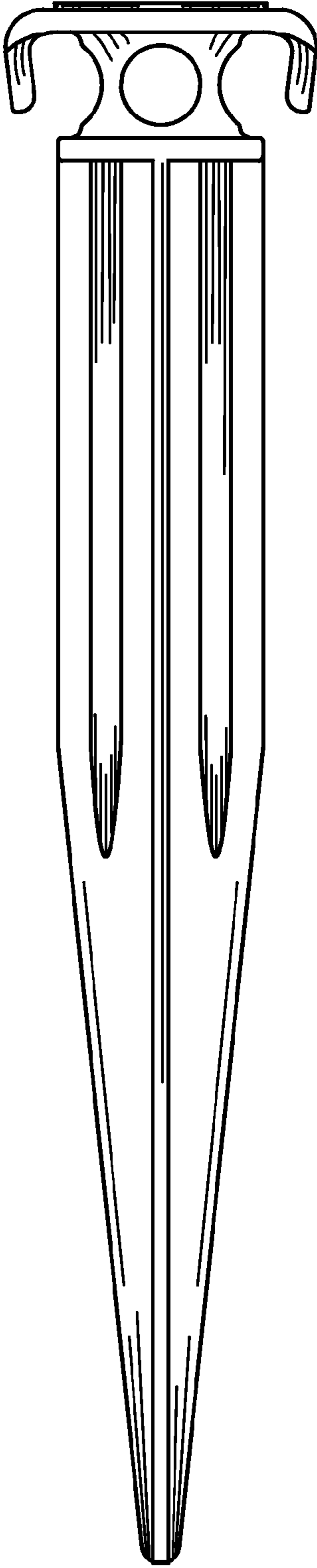

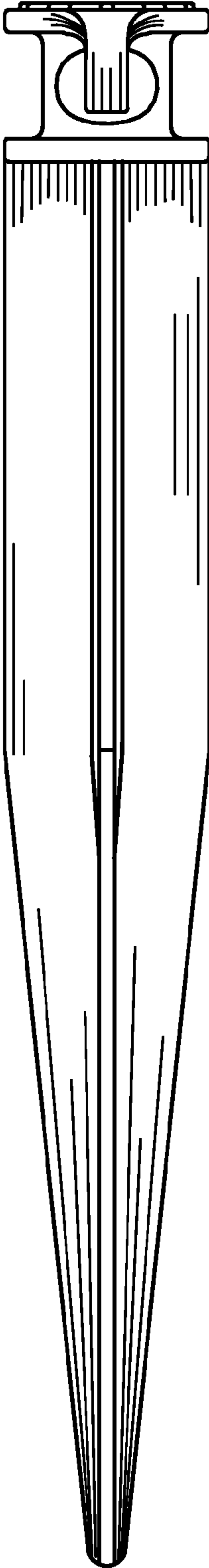

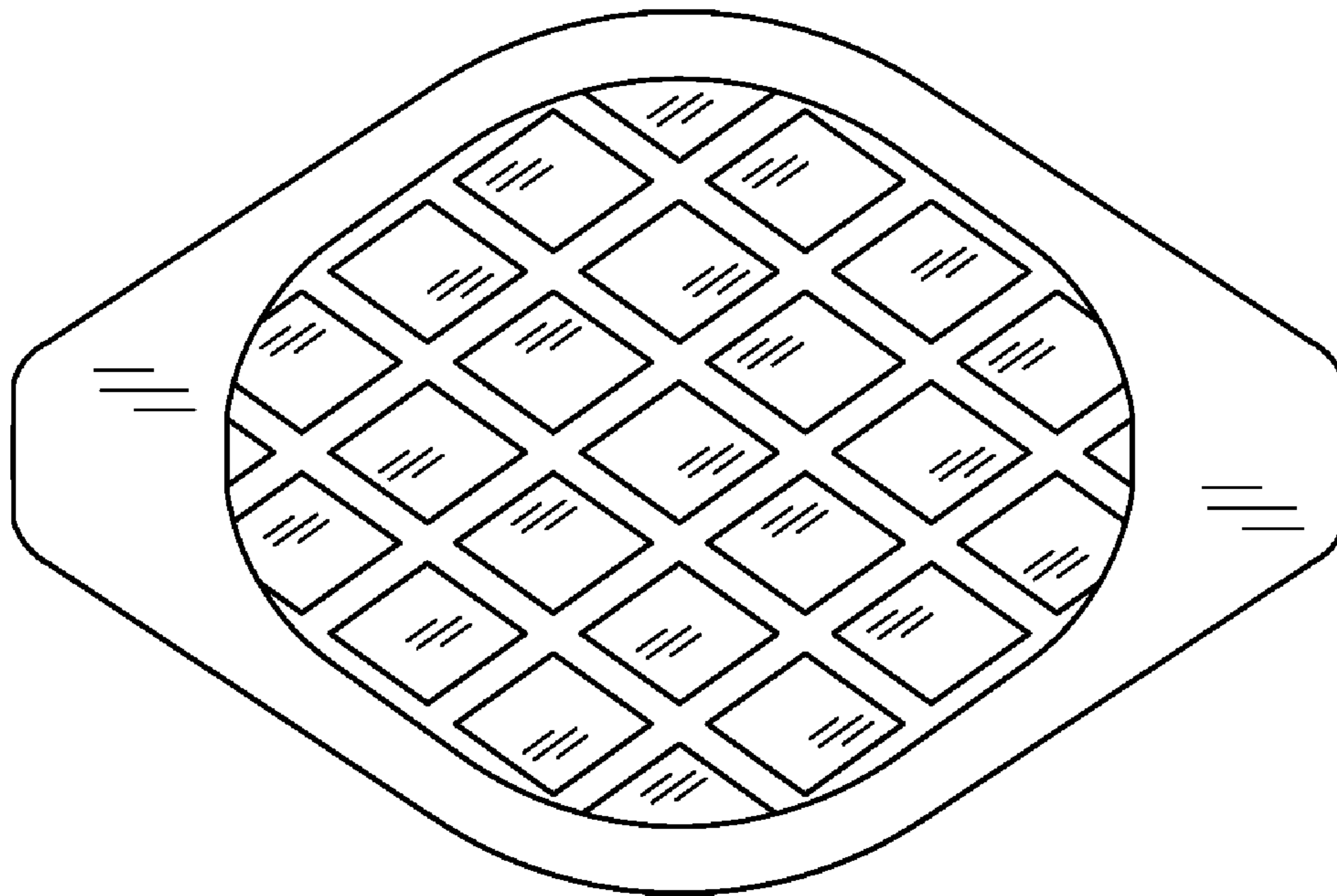
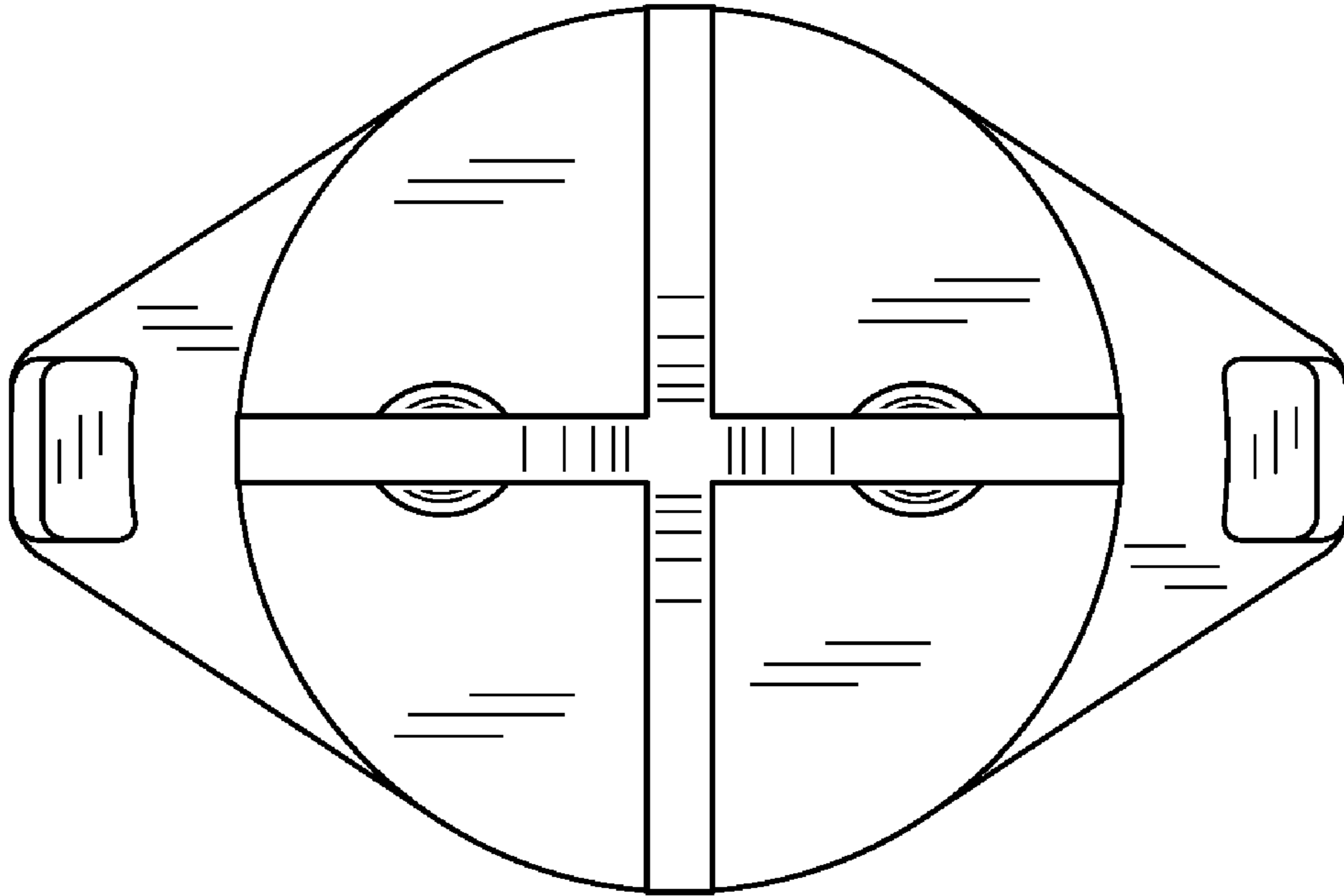
