(57) **CLAIM**

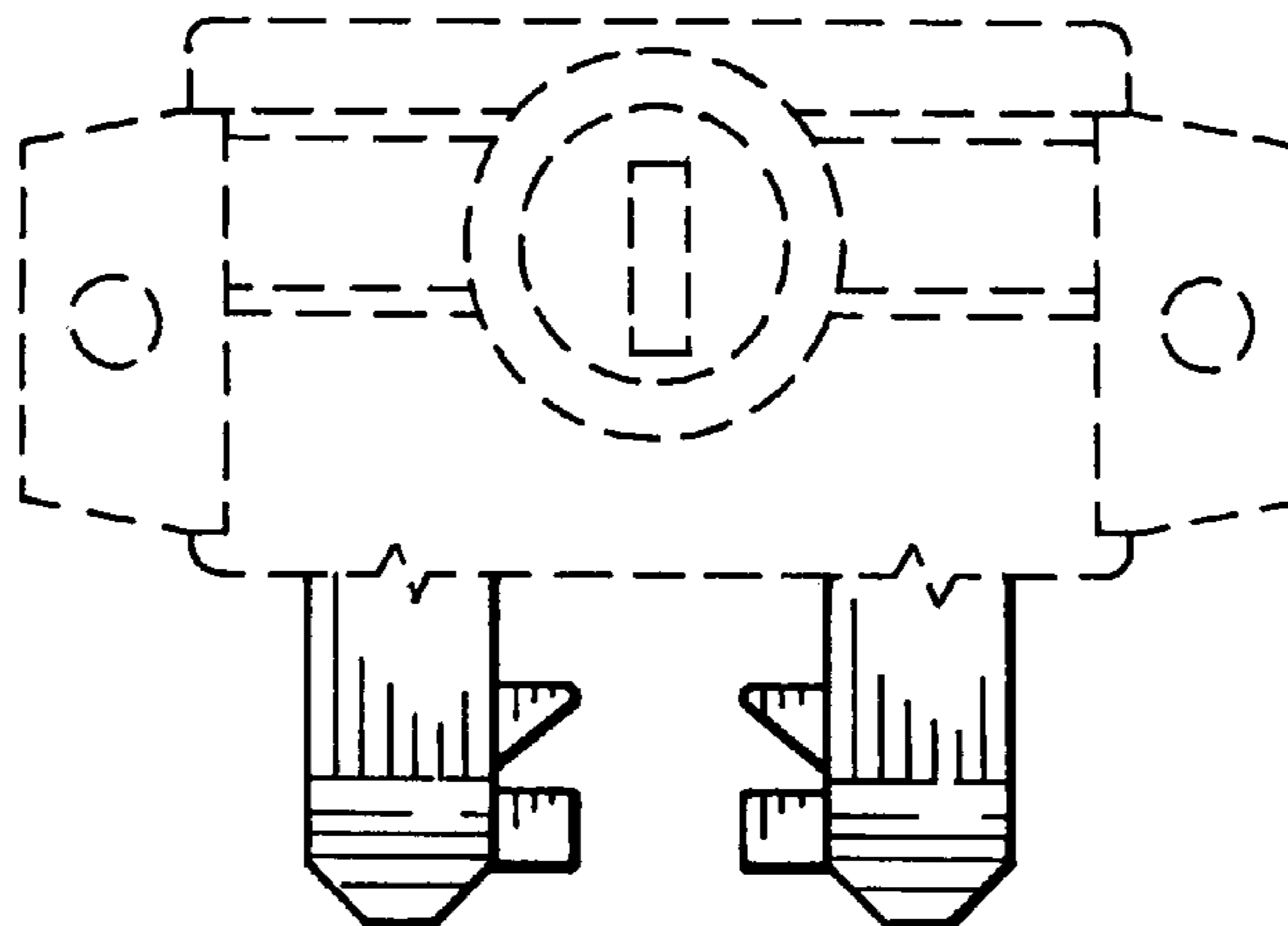
I claim the ornamental design for portions of a dual-action latch assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view showing my design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a bottom view thereof; and,  
FIG. 4 is a left side view thereof, it being understood that a right side view is identical hereto but a mirror image reversal hereof.

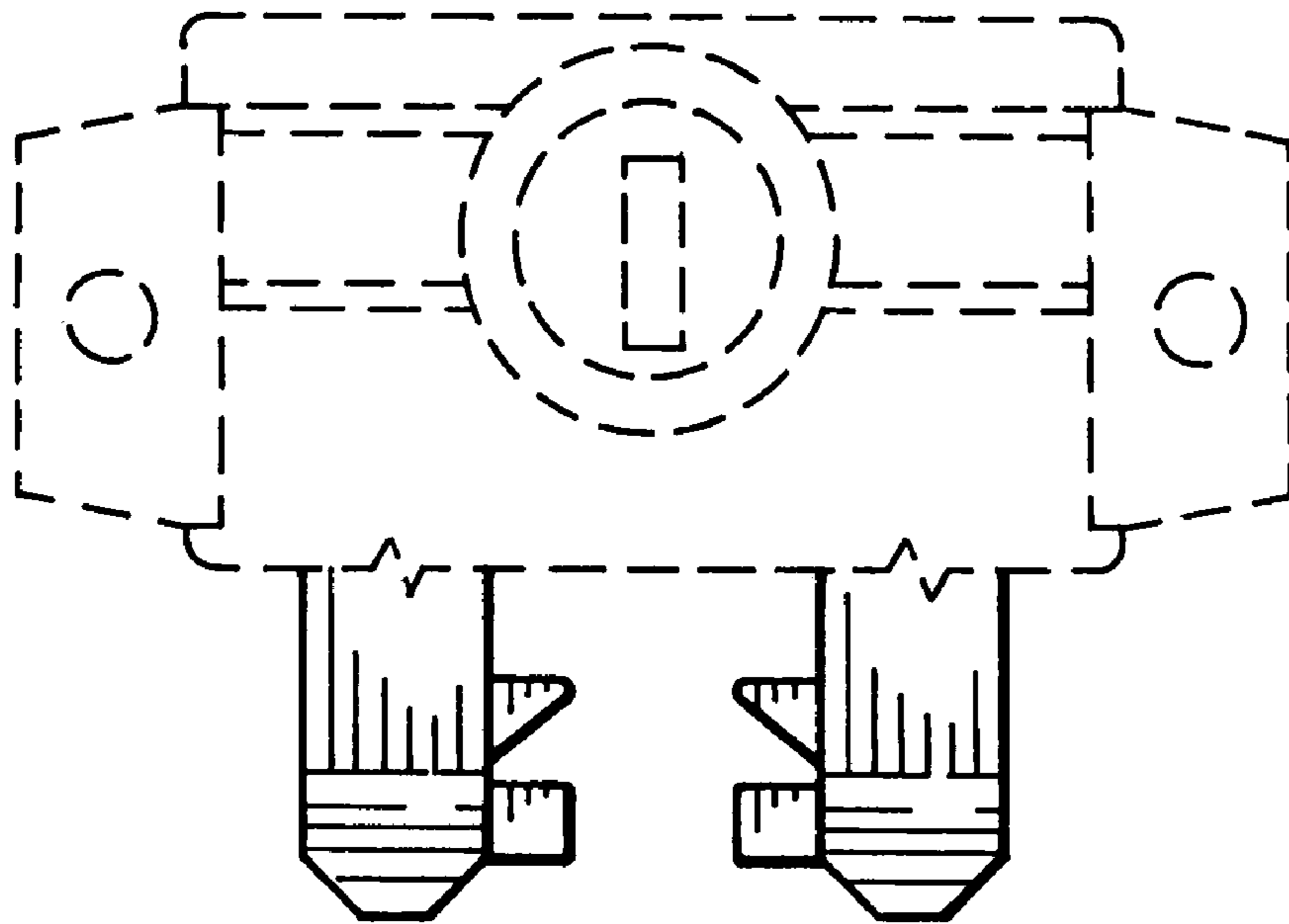

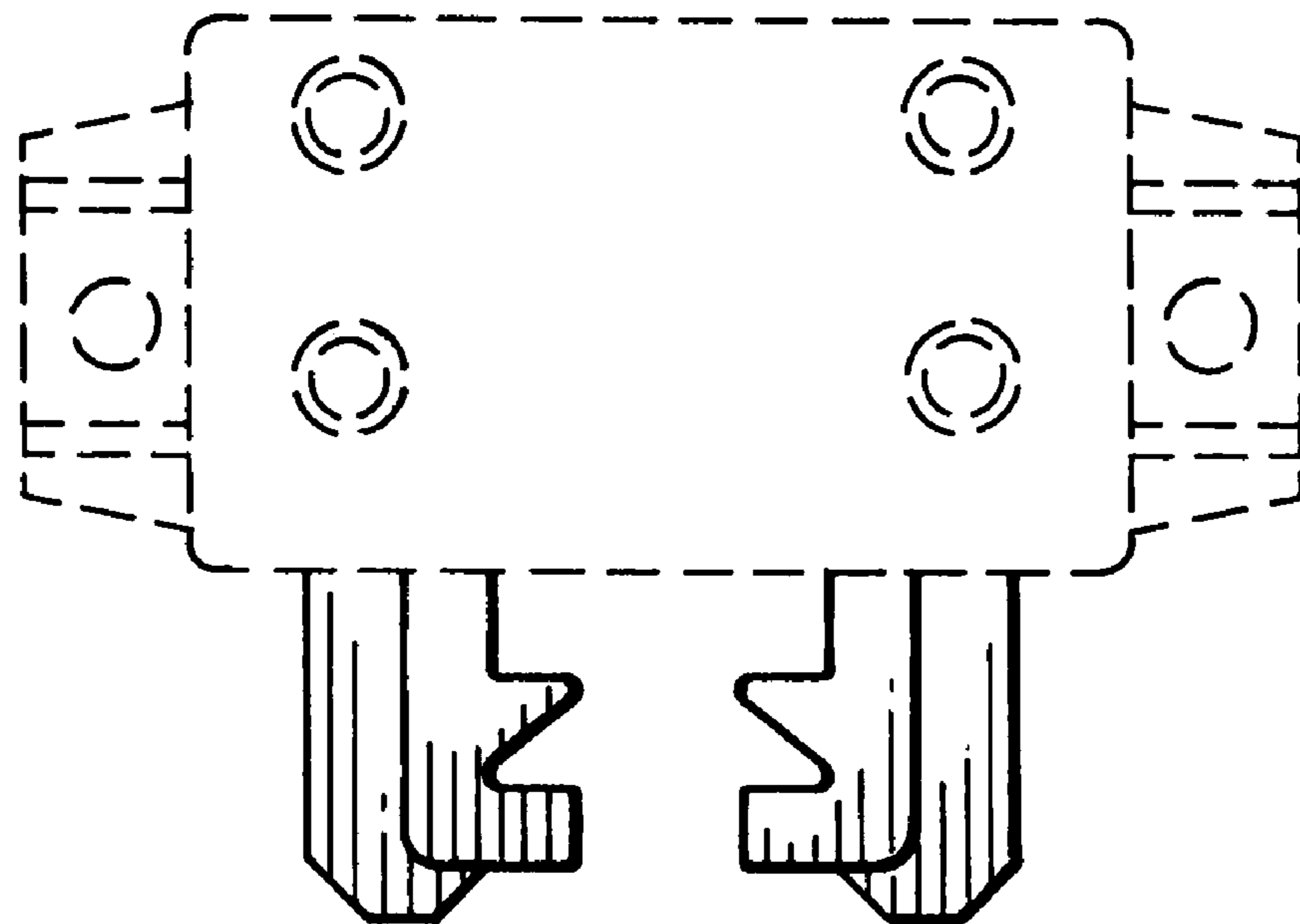

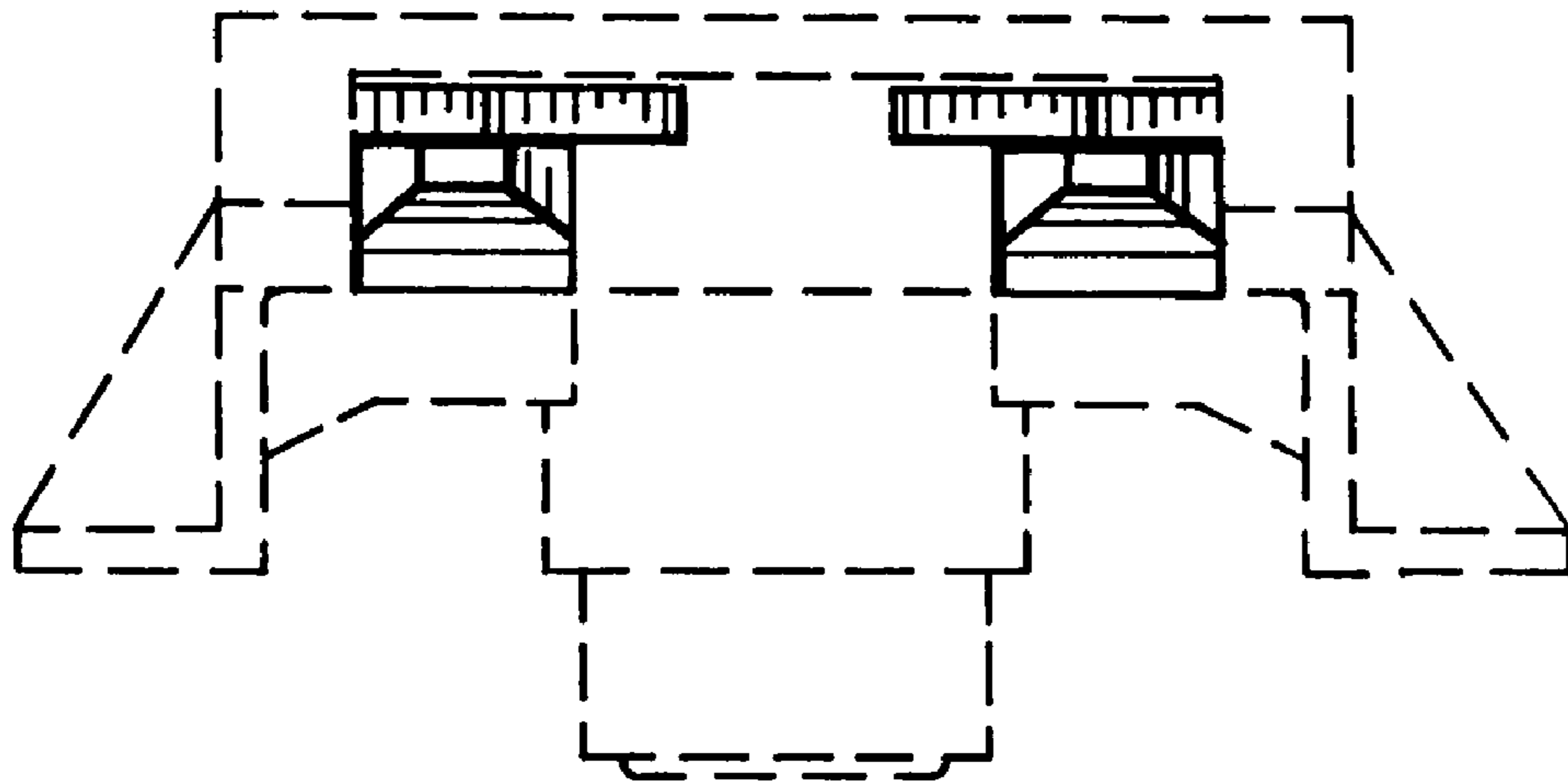

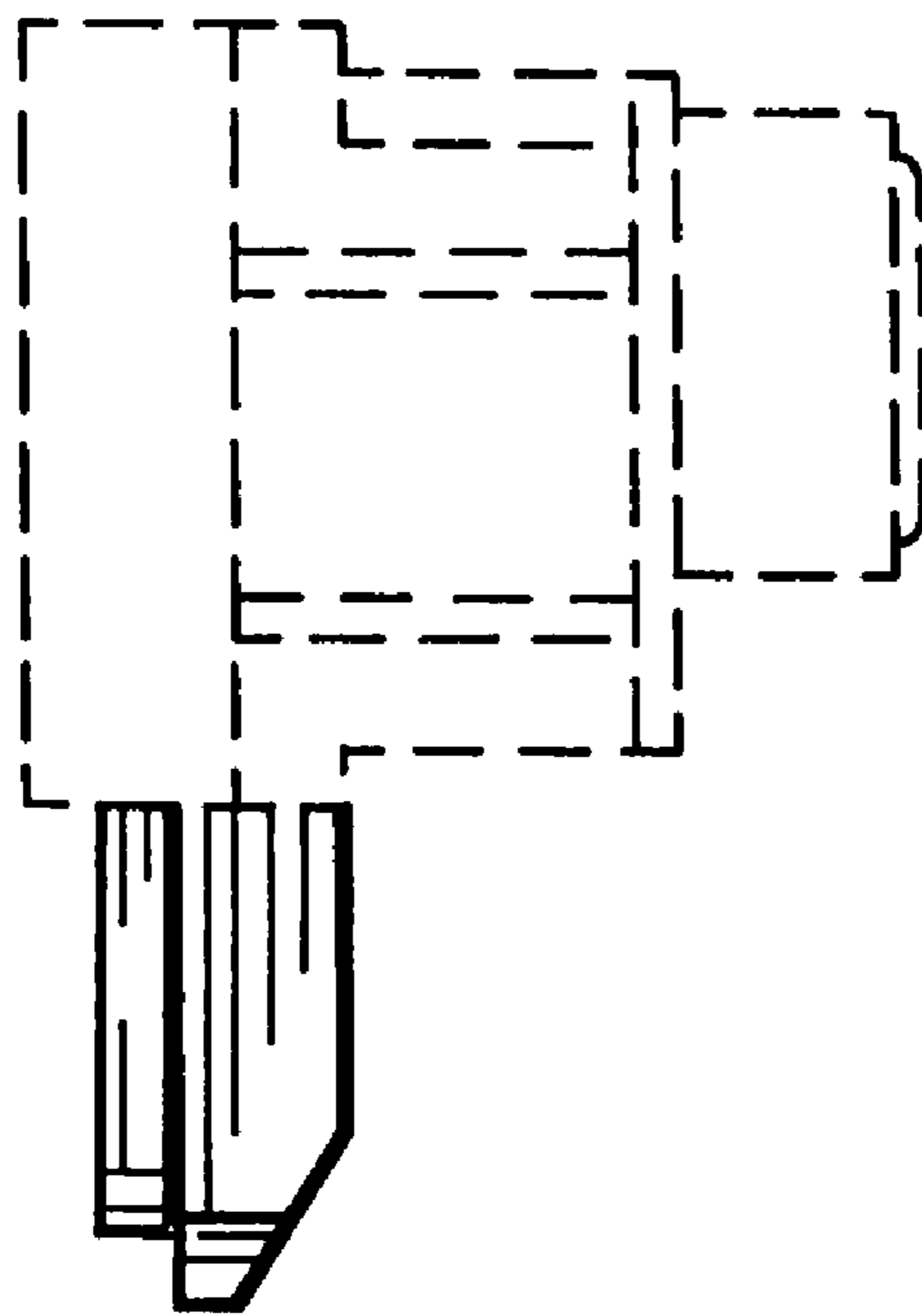
