FIG. 10 is a second side view of the second embodiment;

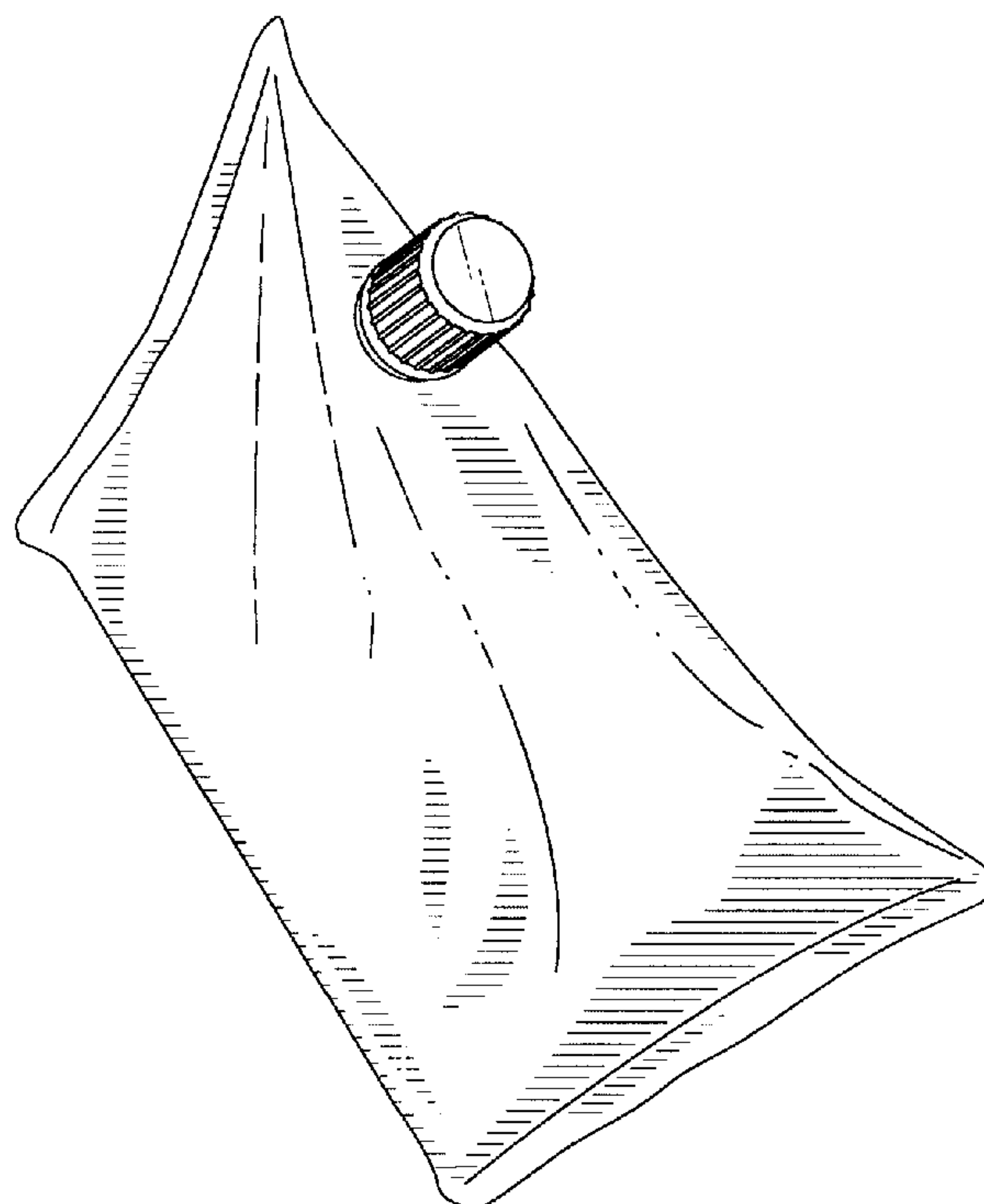
FIG. 11 is a front view of the second embodiment;

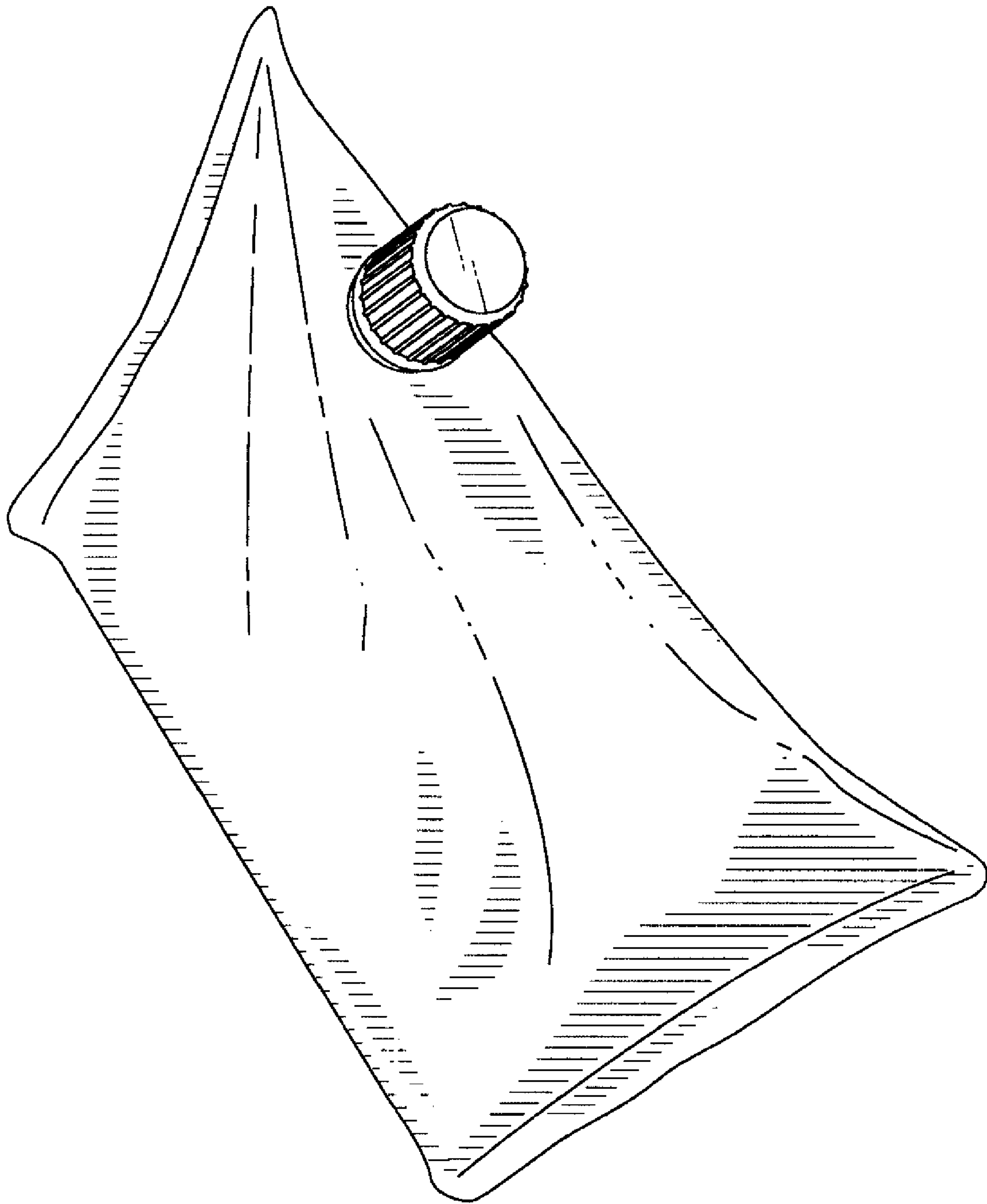

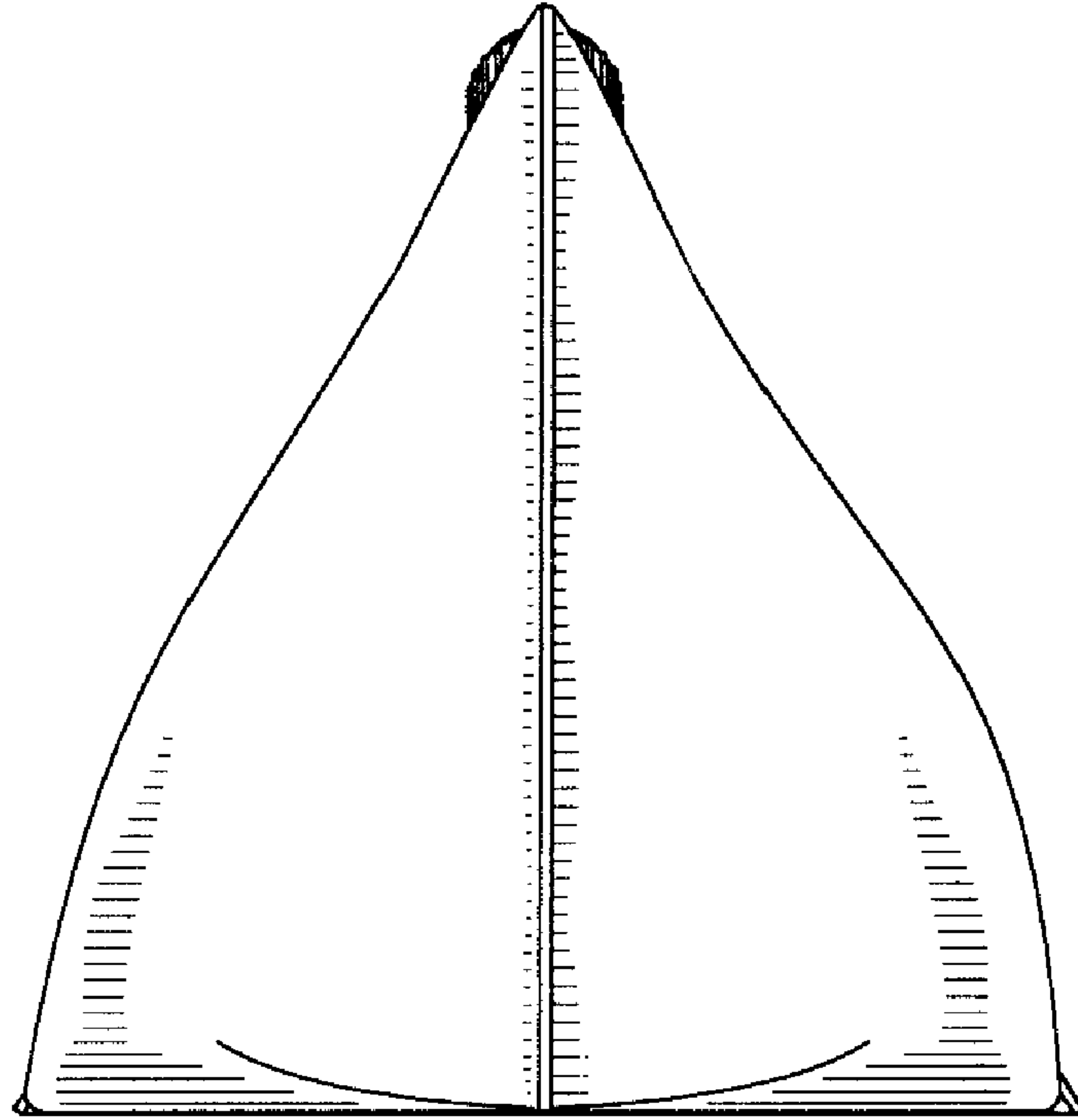

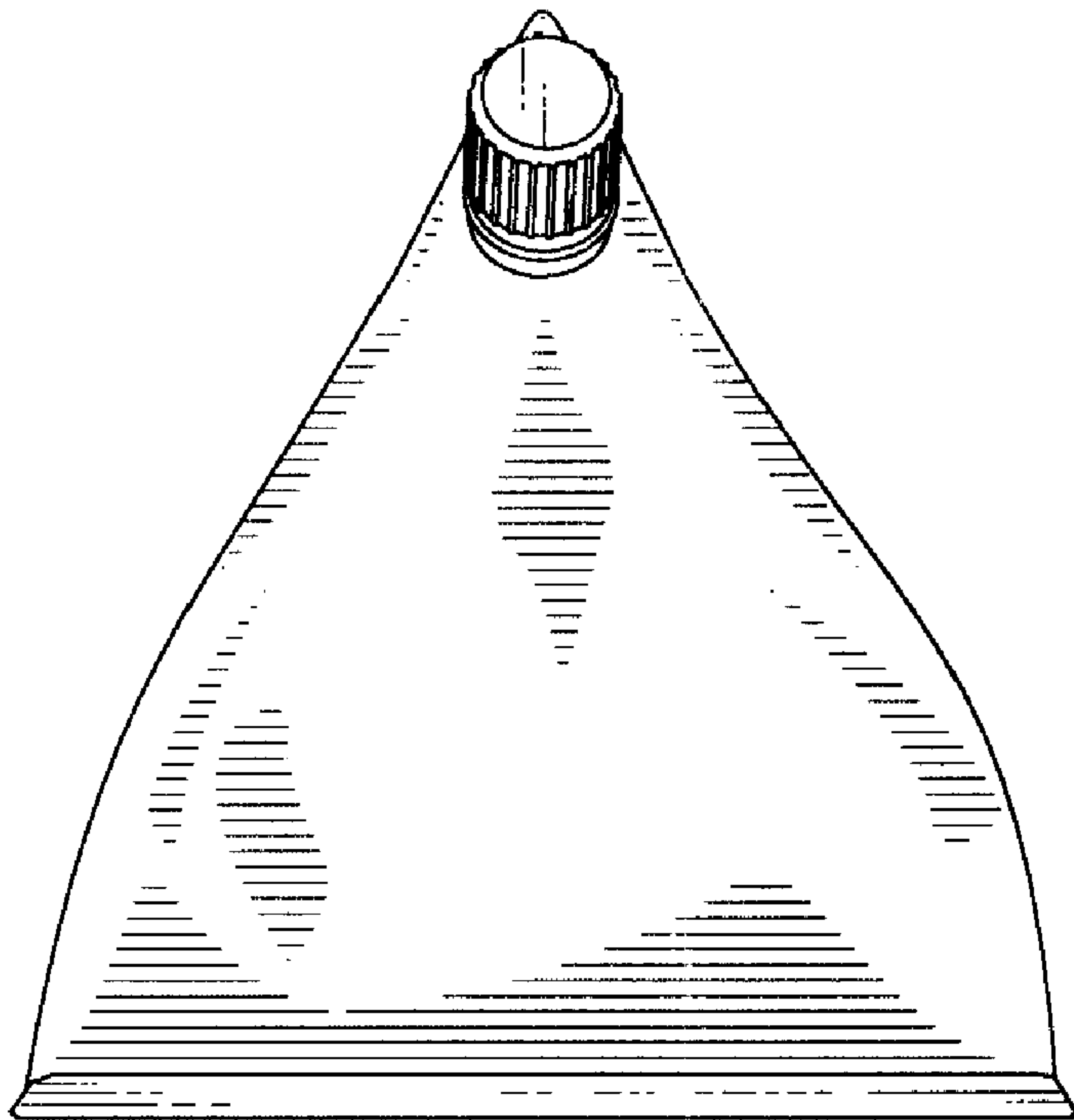

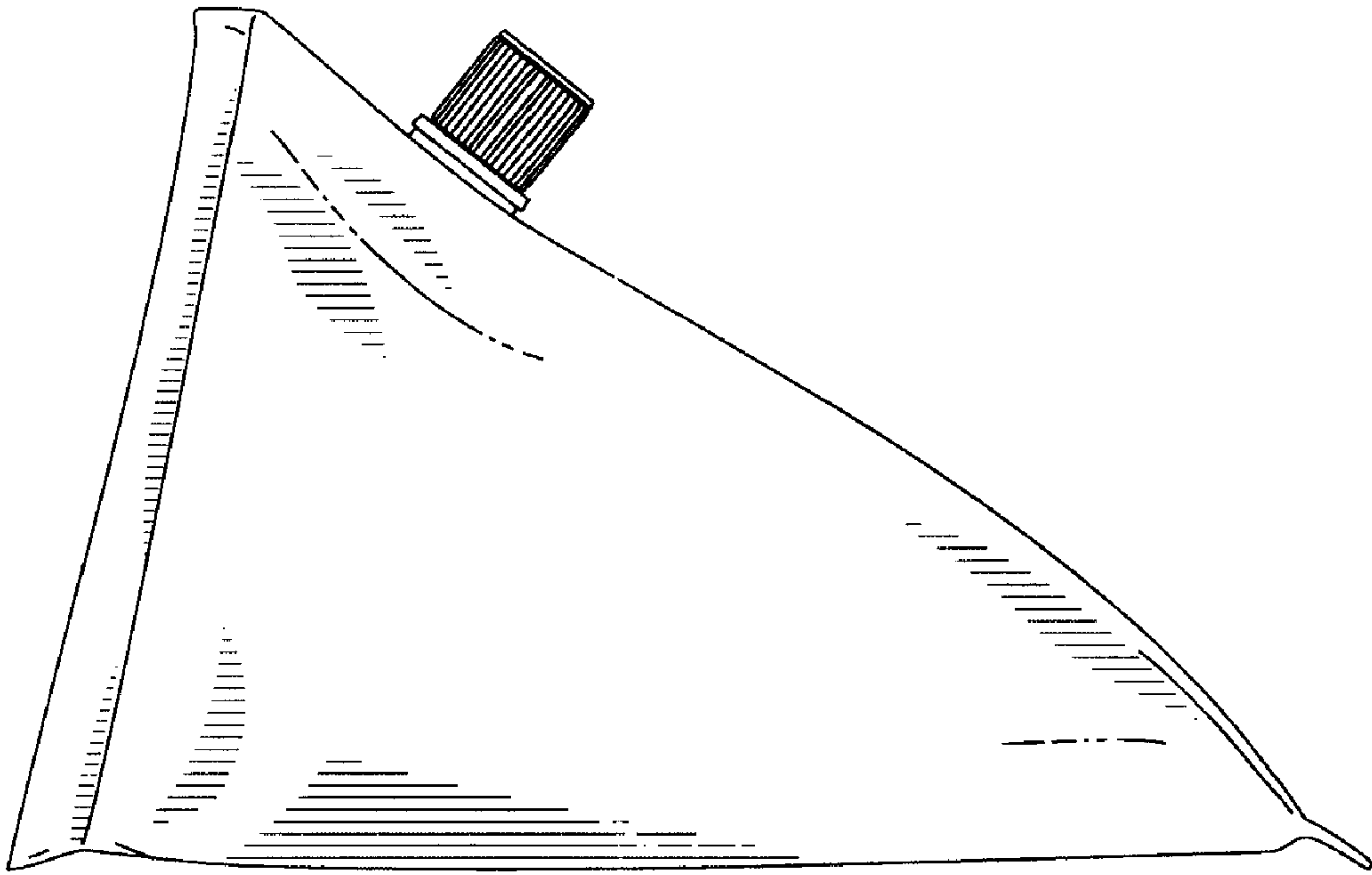

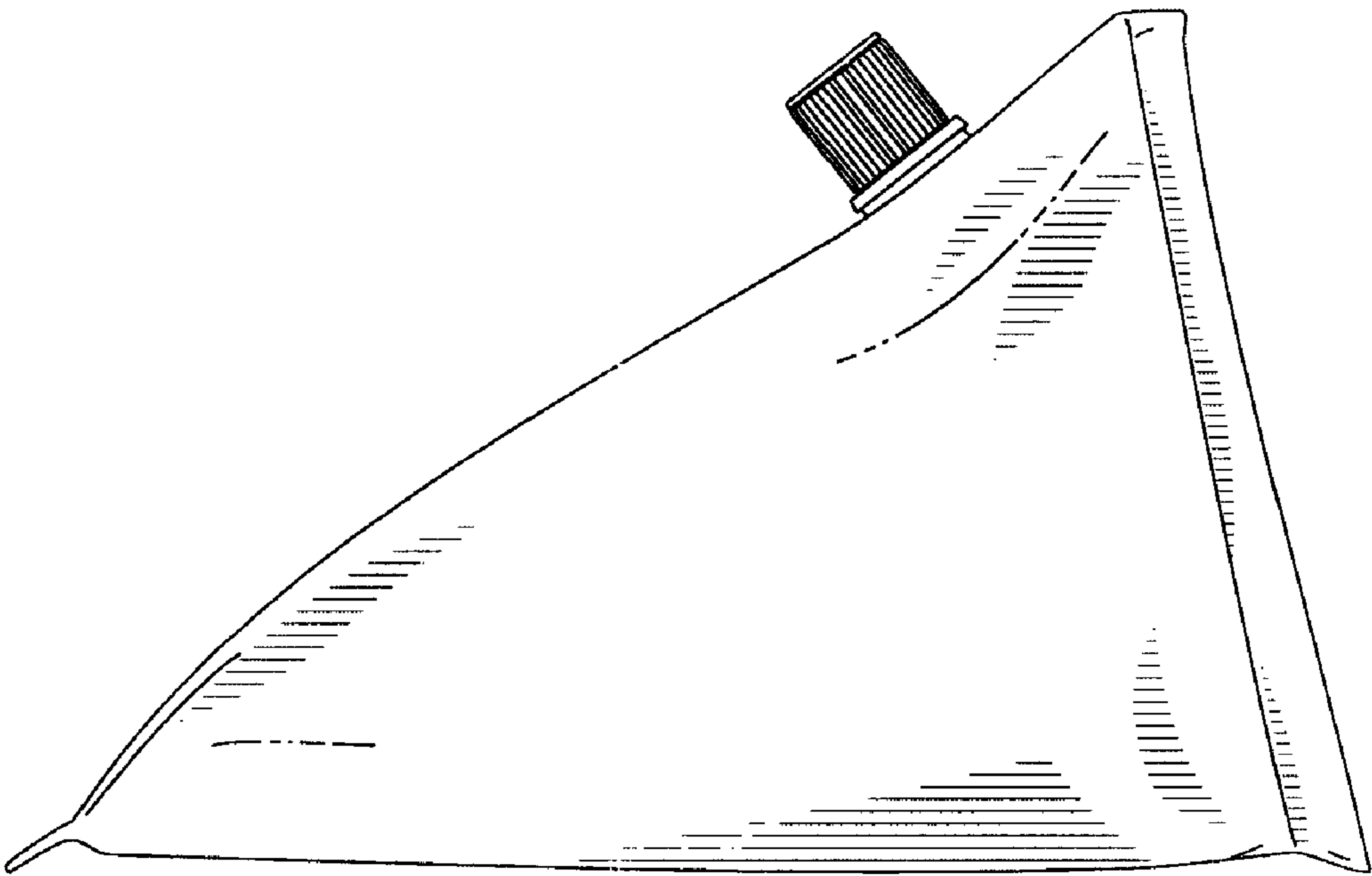

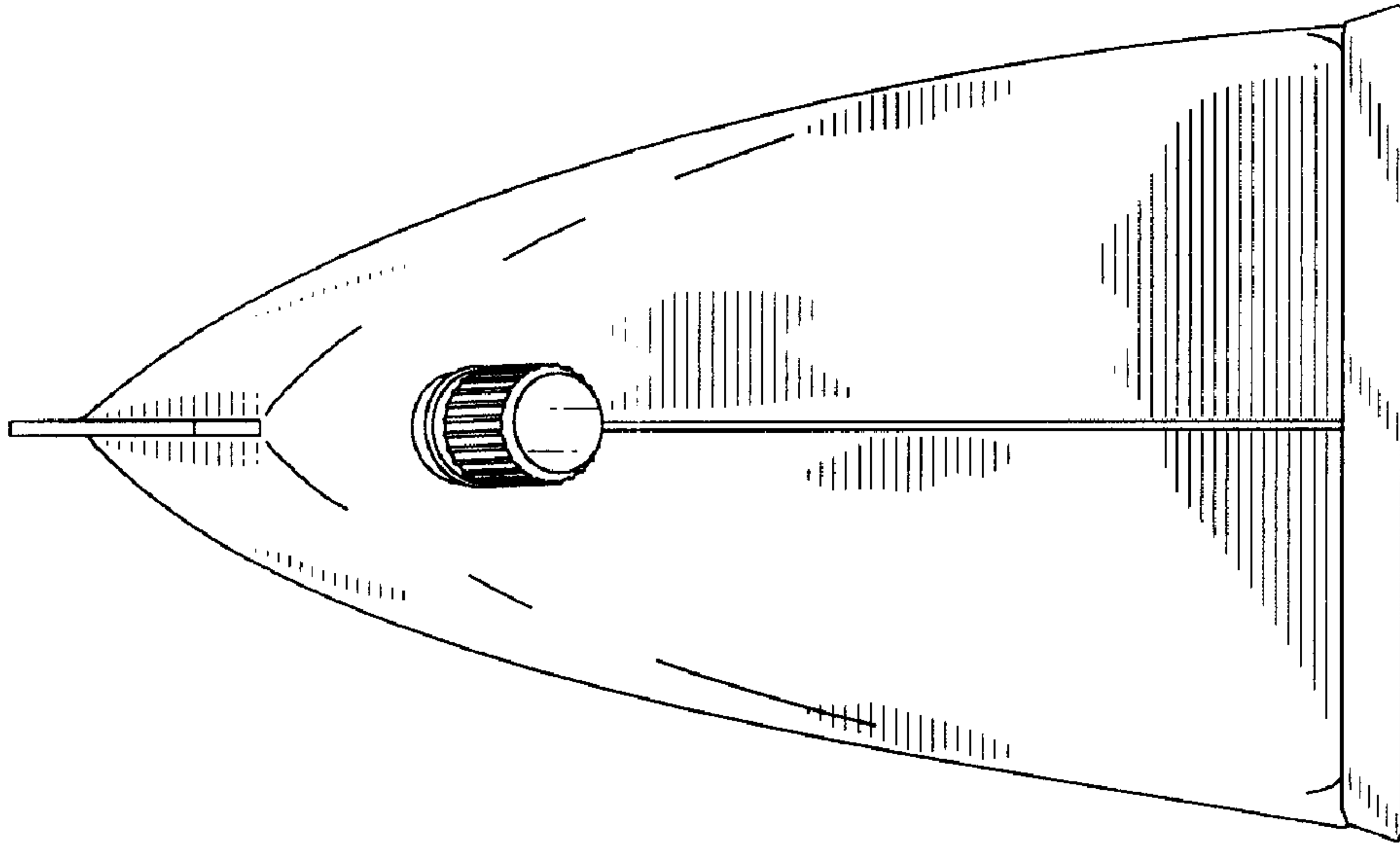

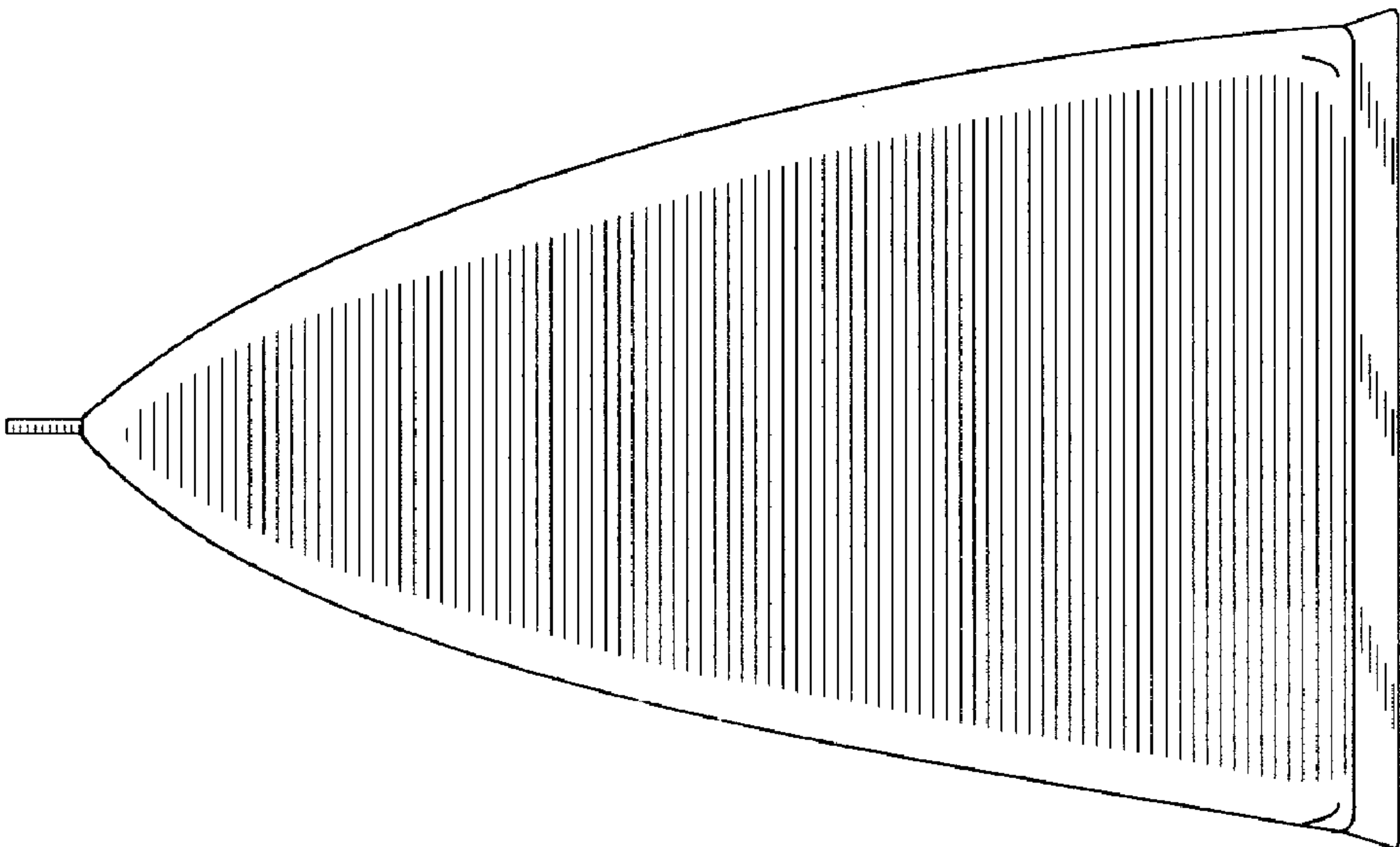

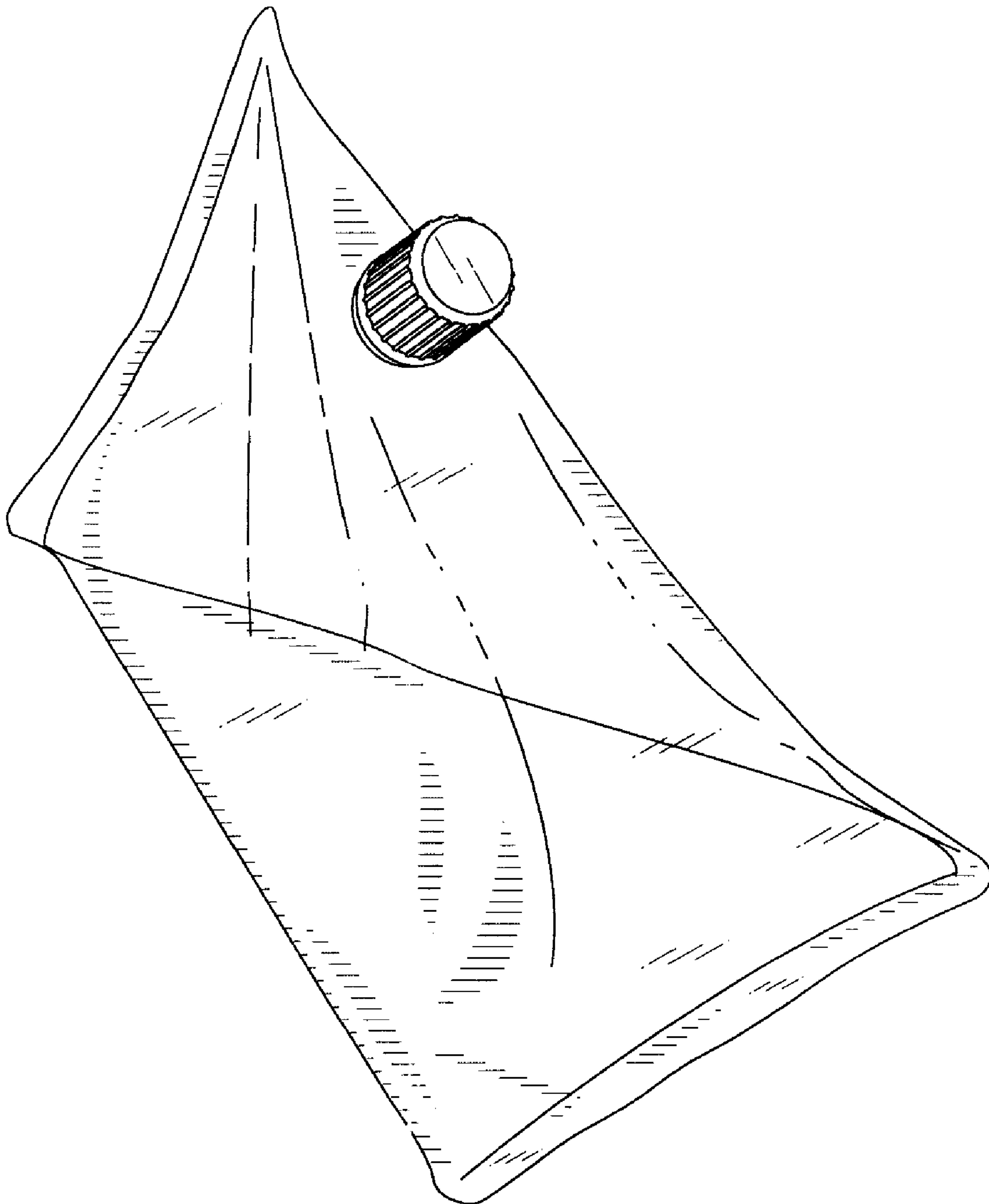

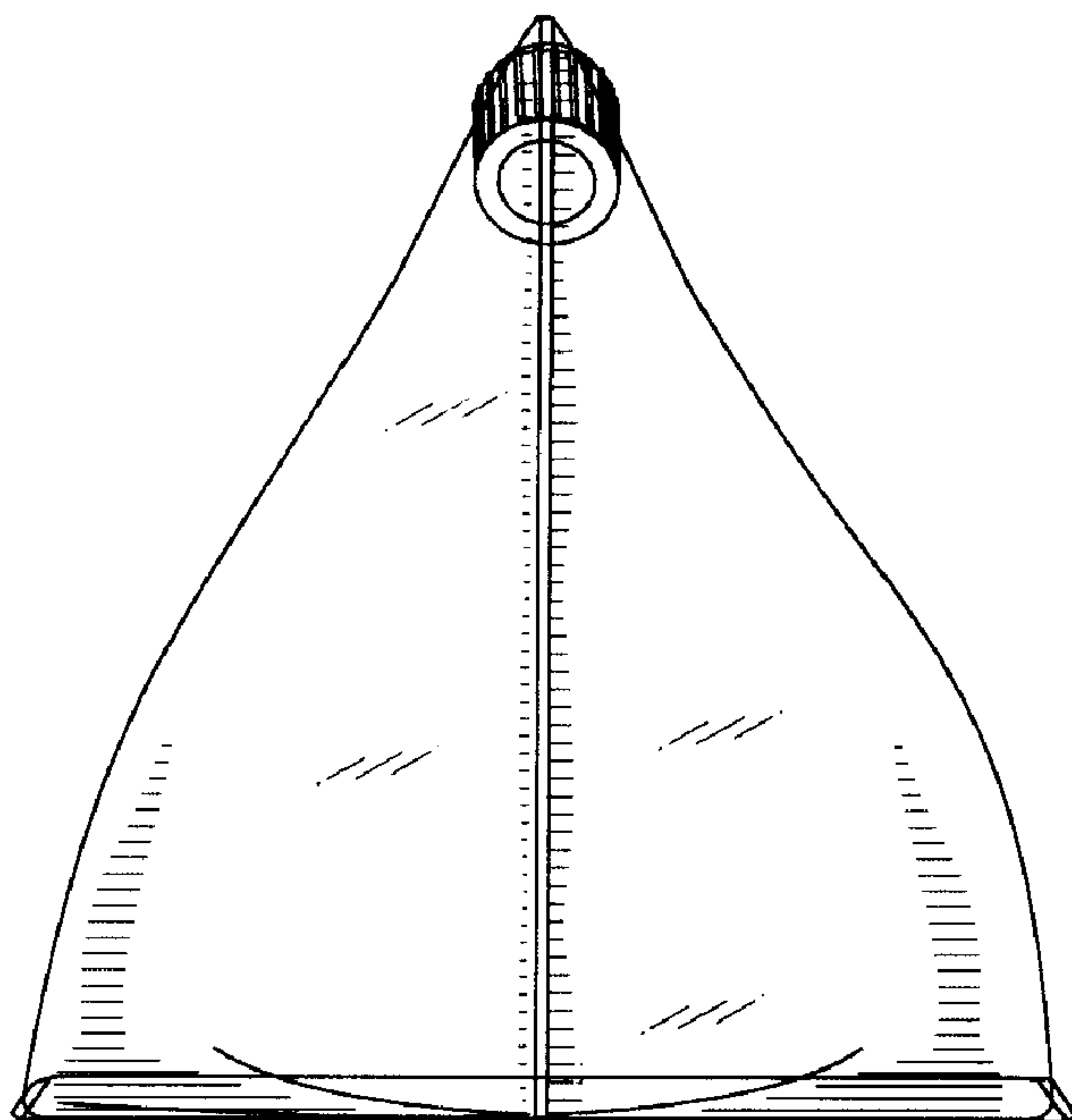

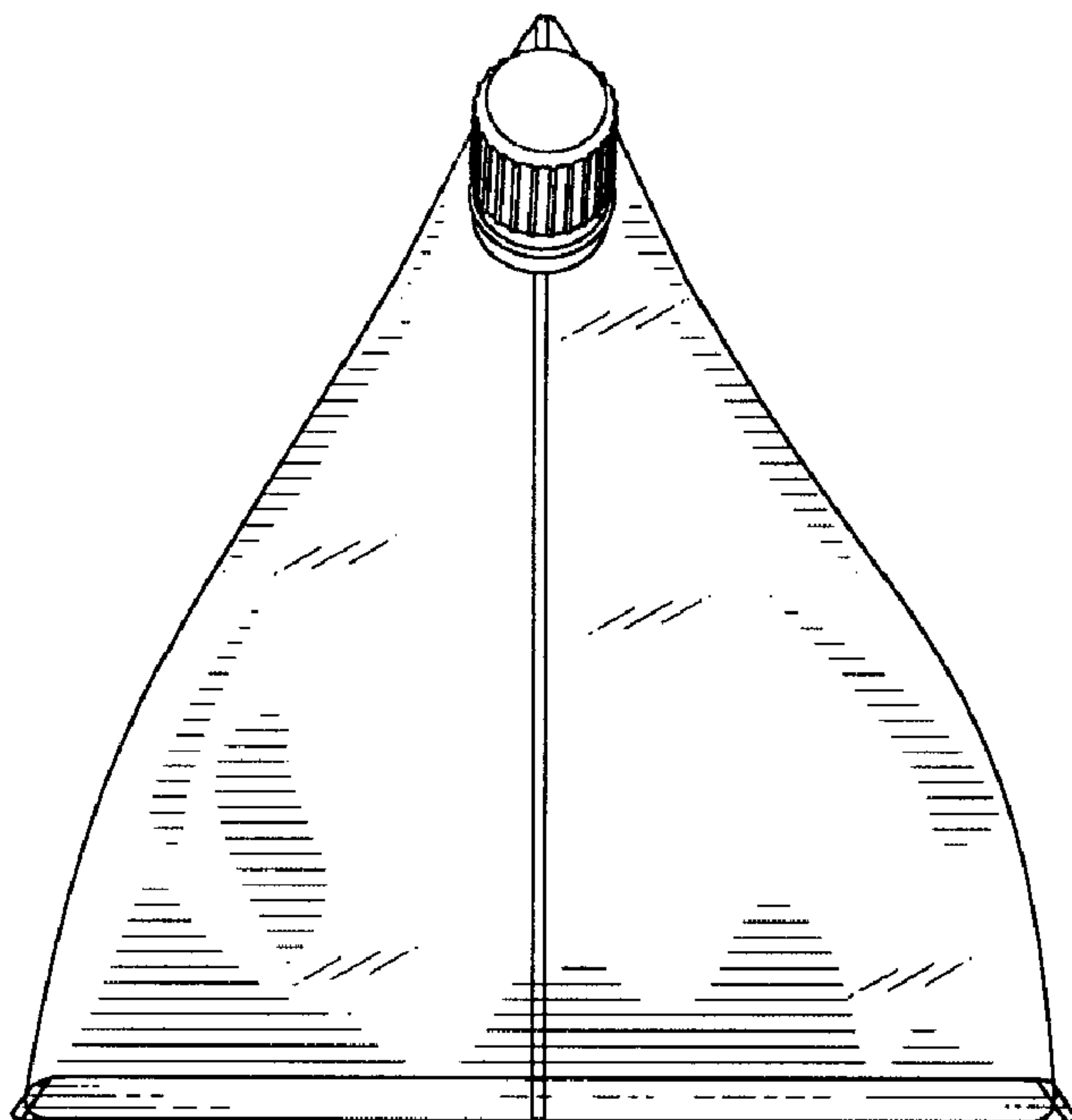

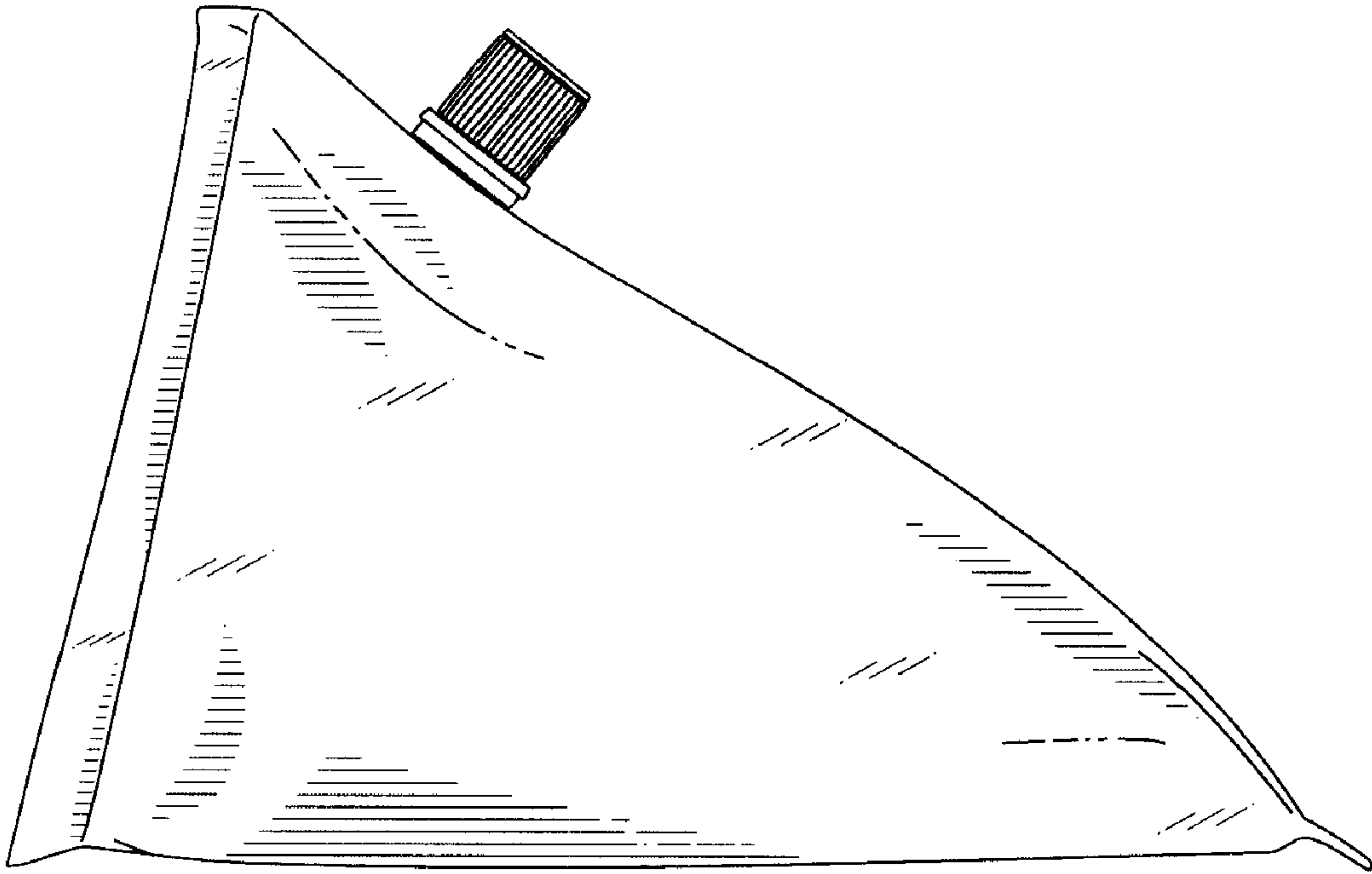

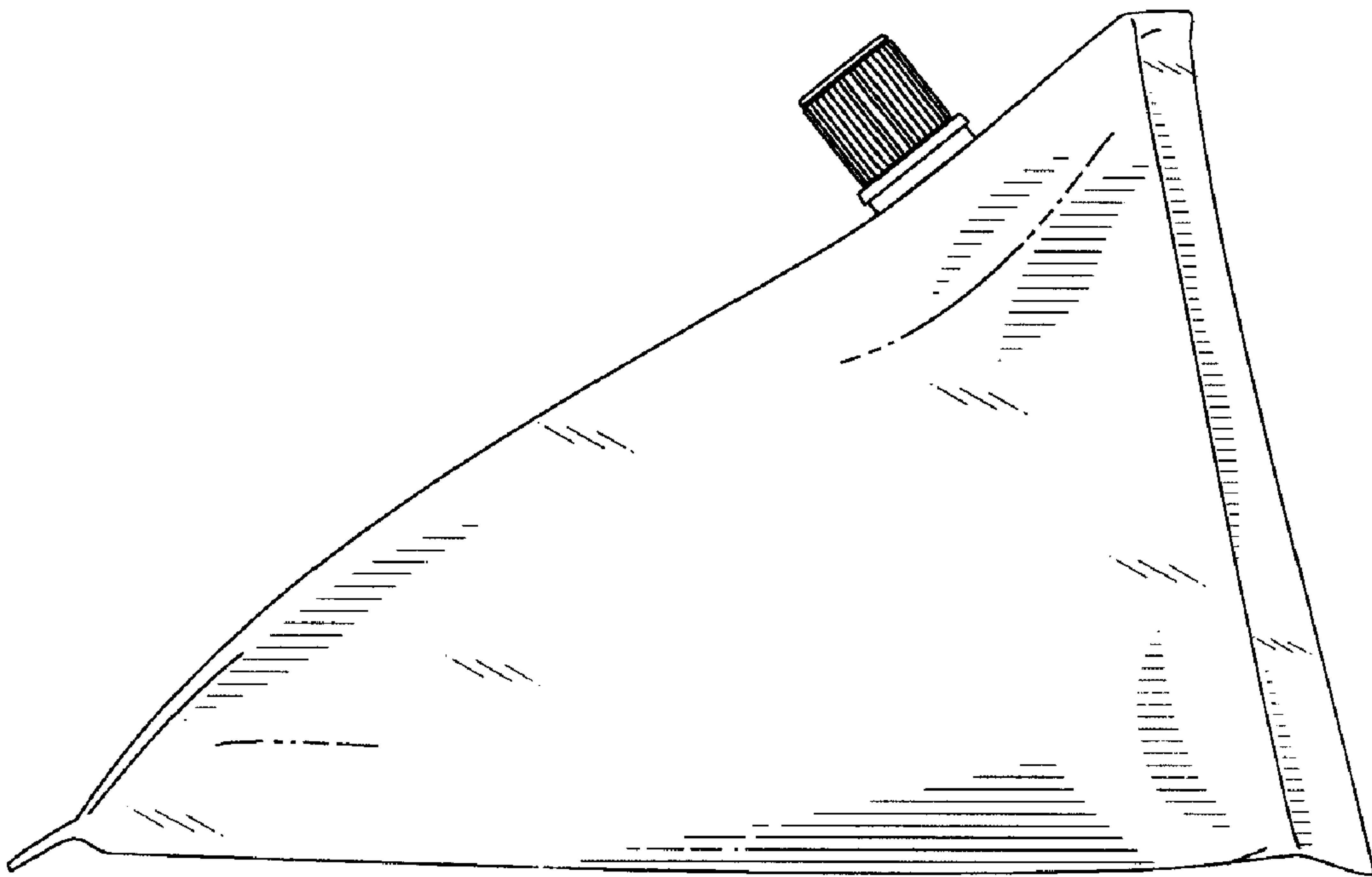

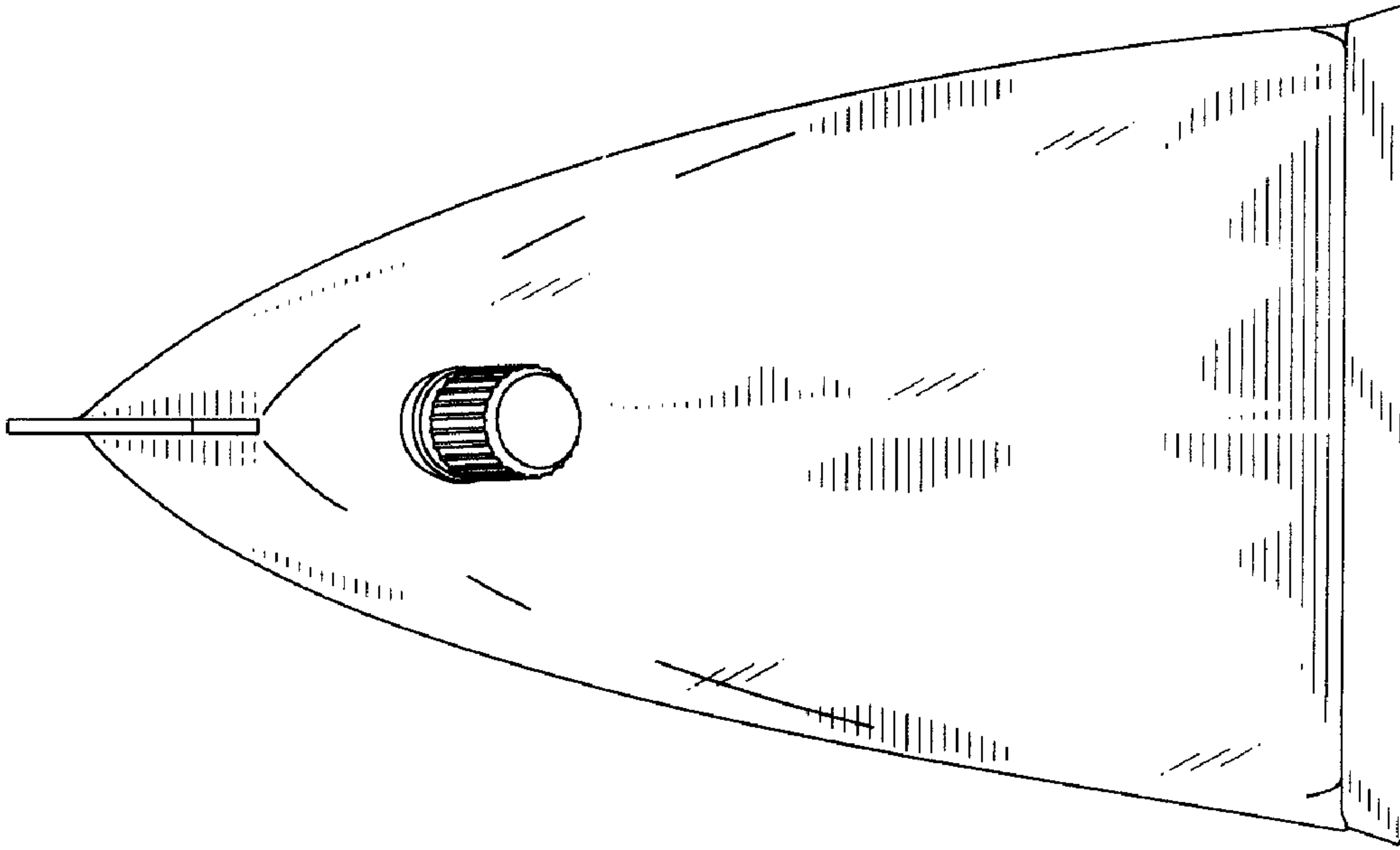

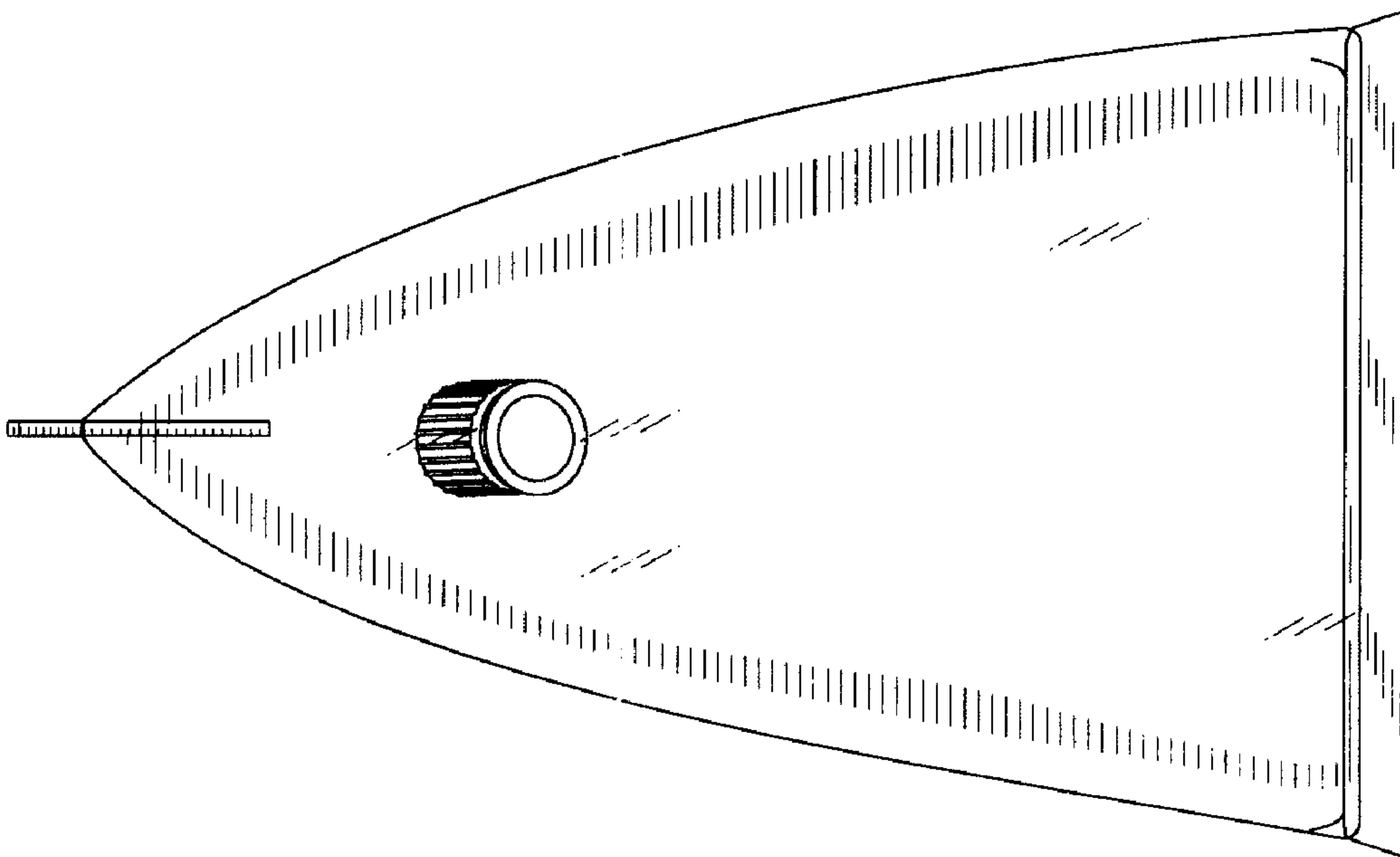
