FIG. 2 is a top plan view thereof;

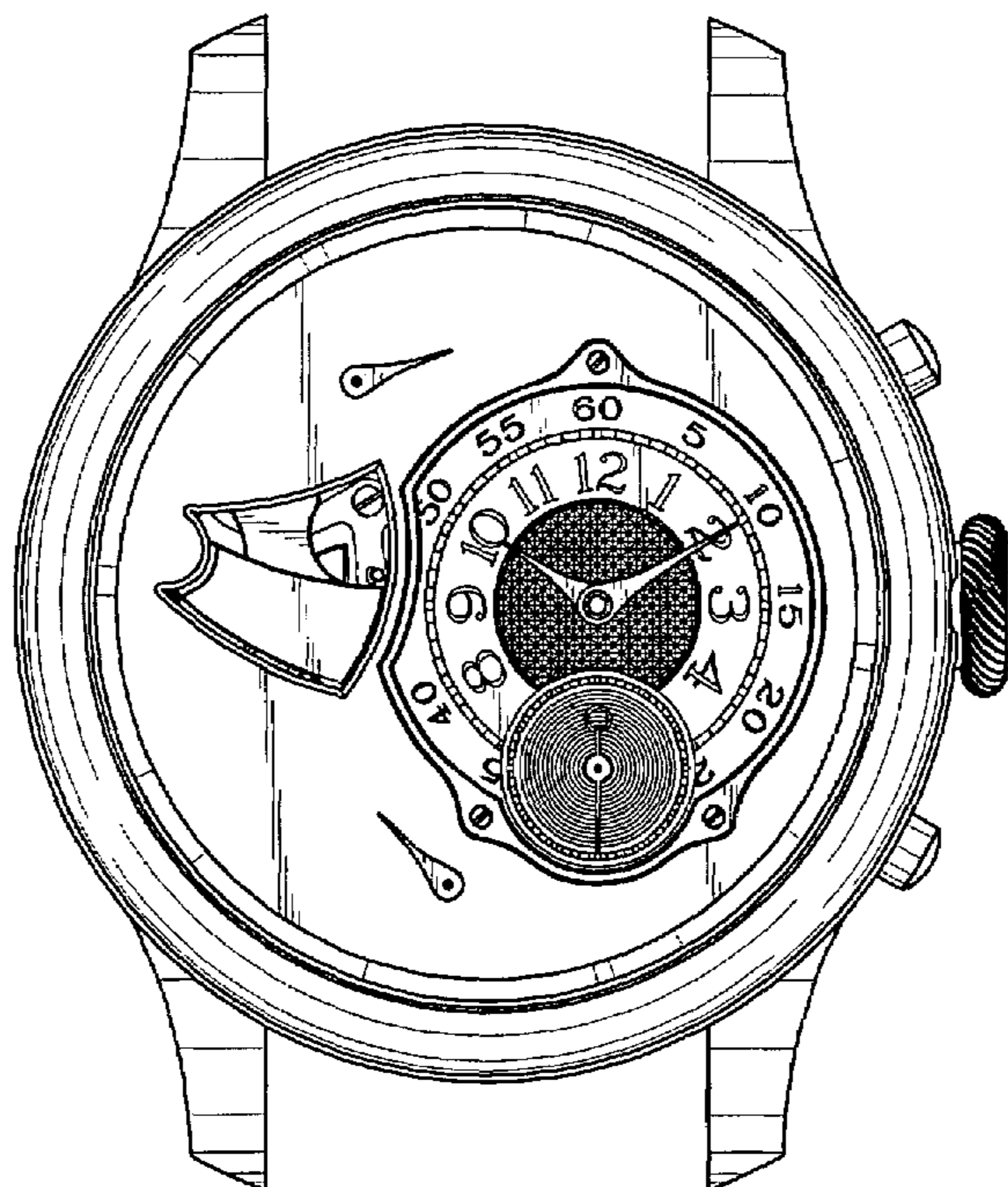
FIG. 3 is a left side elevation thereof;

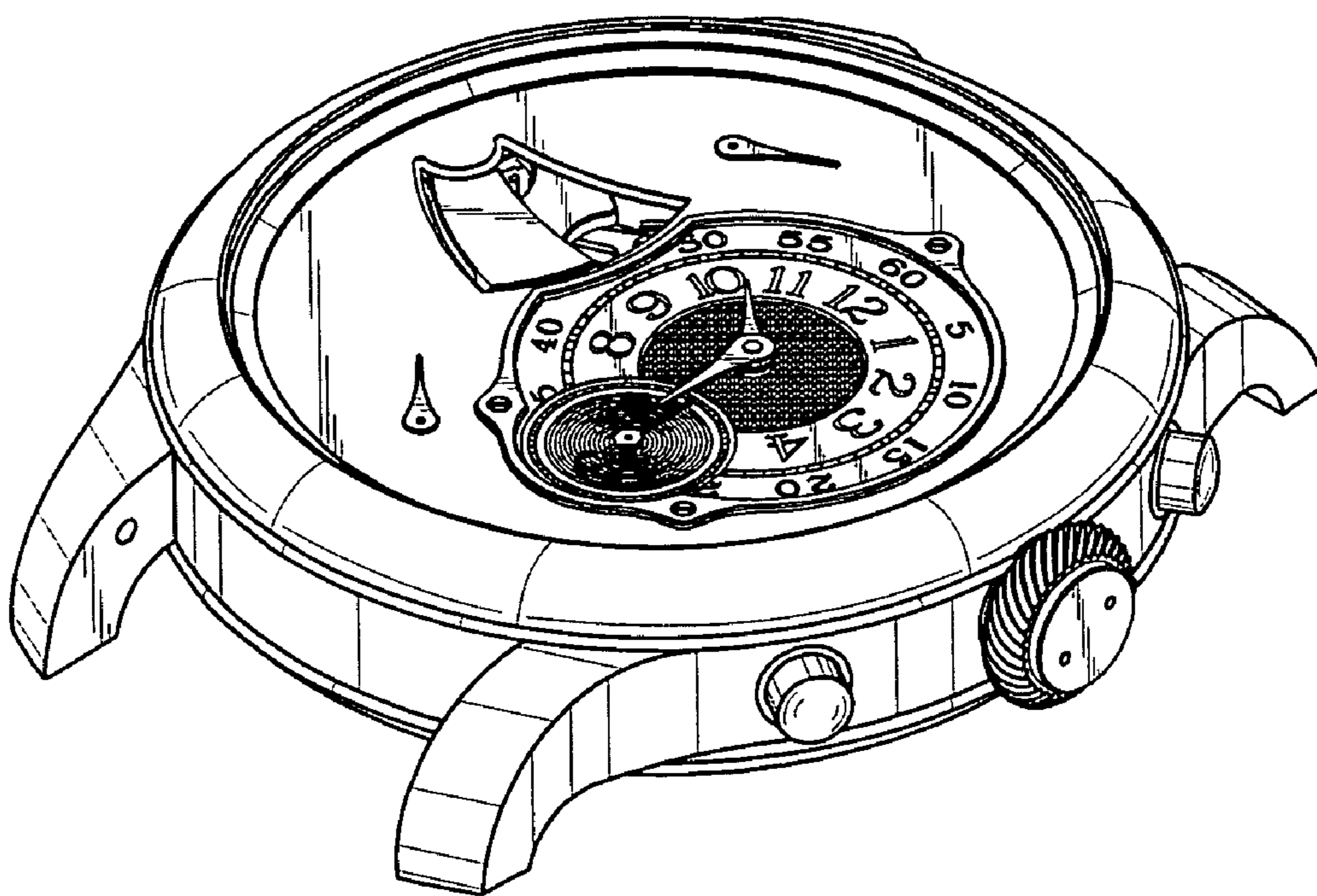
FIG. 4 is a right side elevation thereof;

FIG. 5 is an end elevation thereof; and,

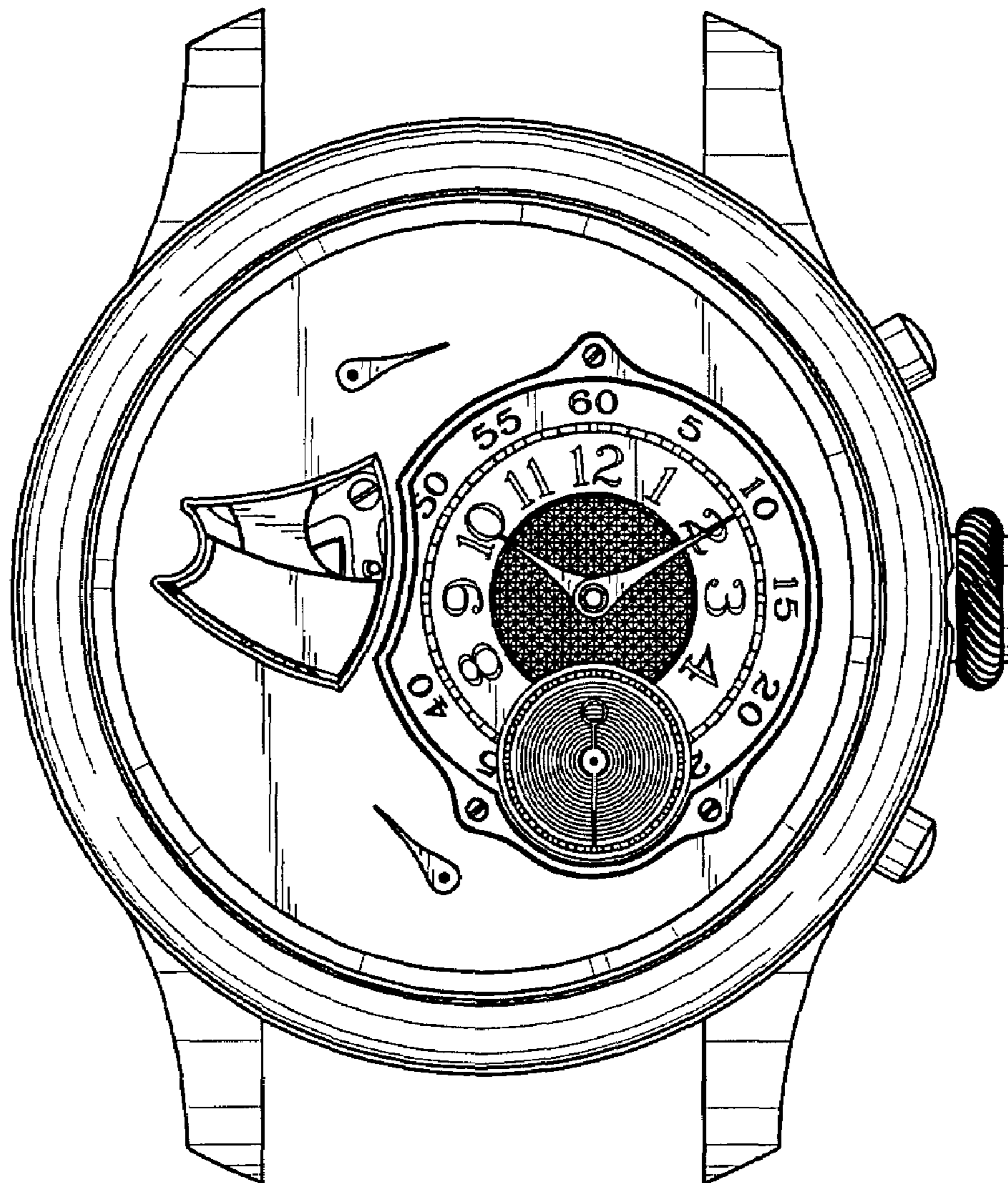
FIG. 6 is an end elevation of the opposite end thereof.

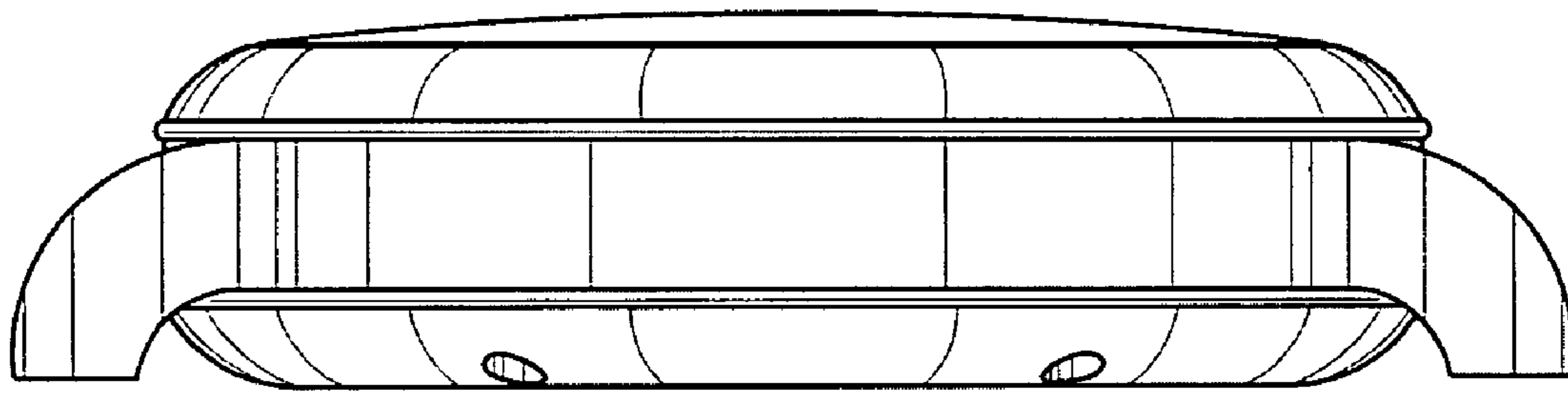




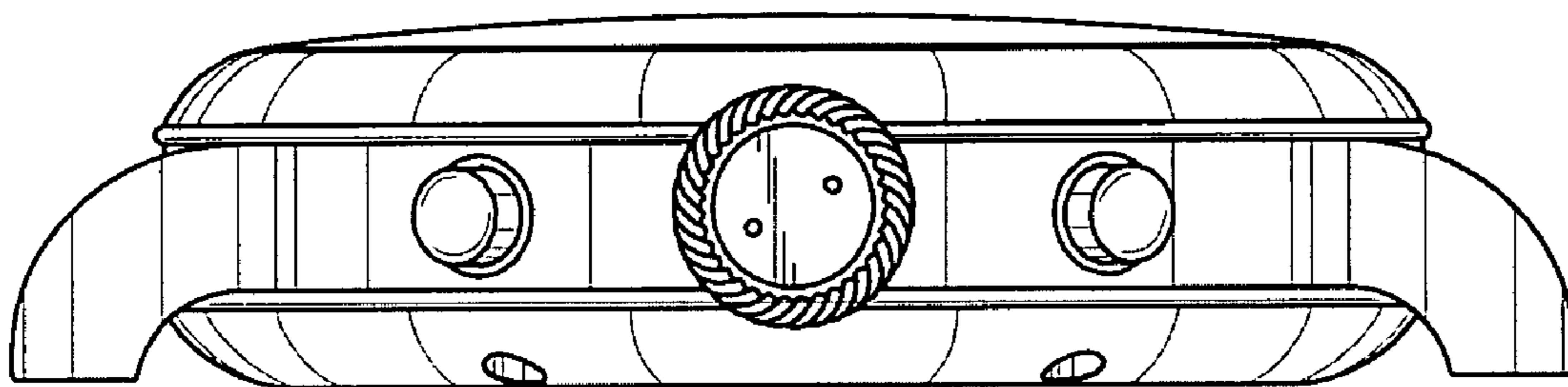

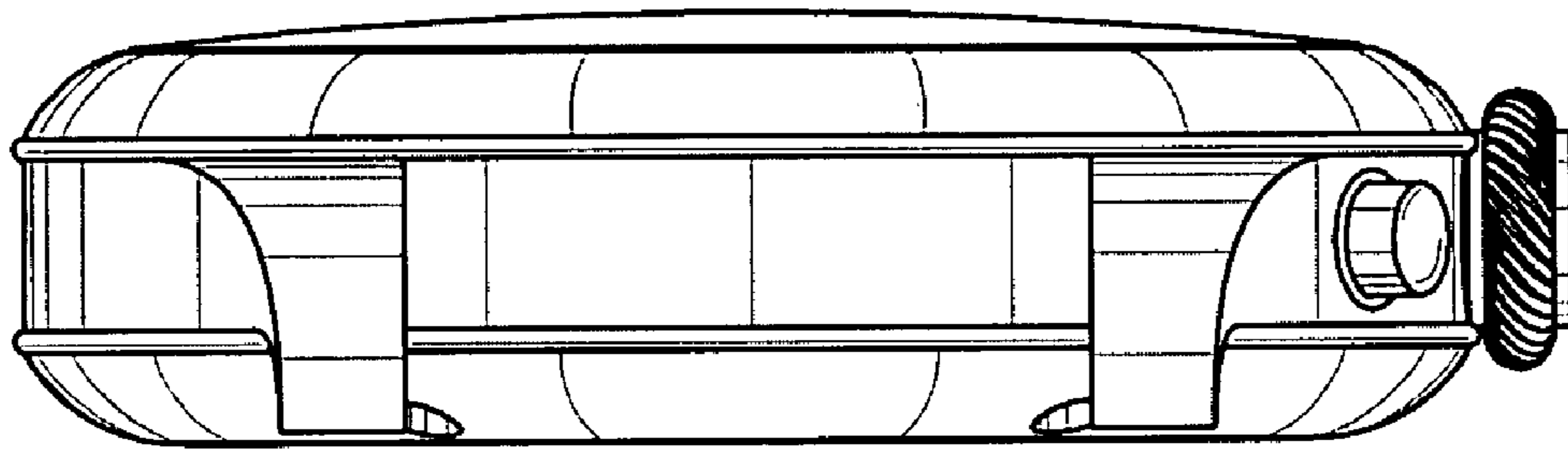

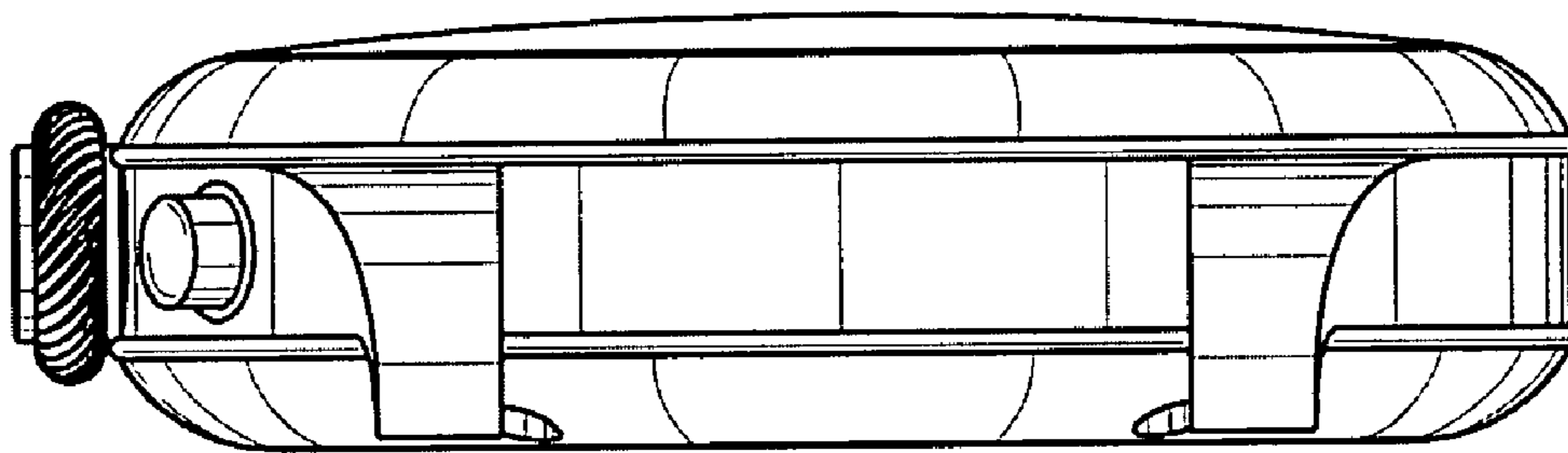
