device or similar articles, as shown and described.

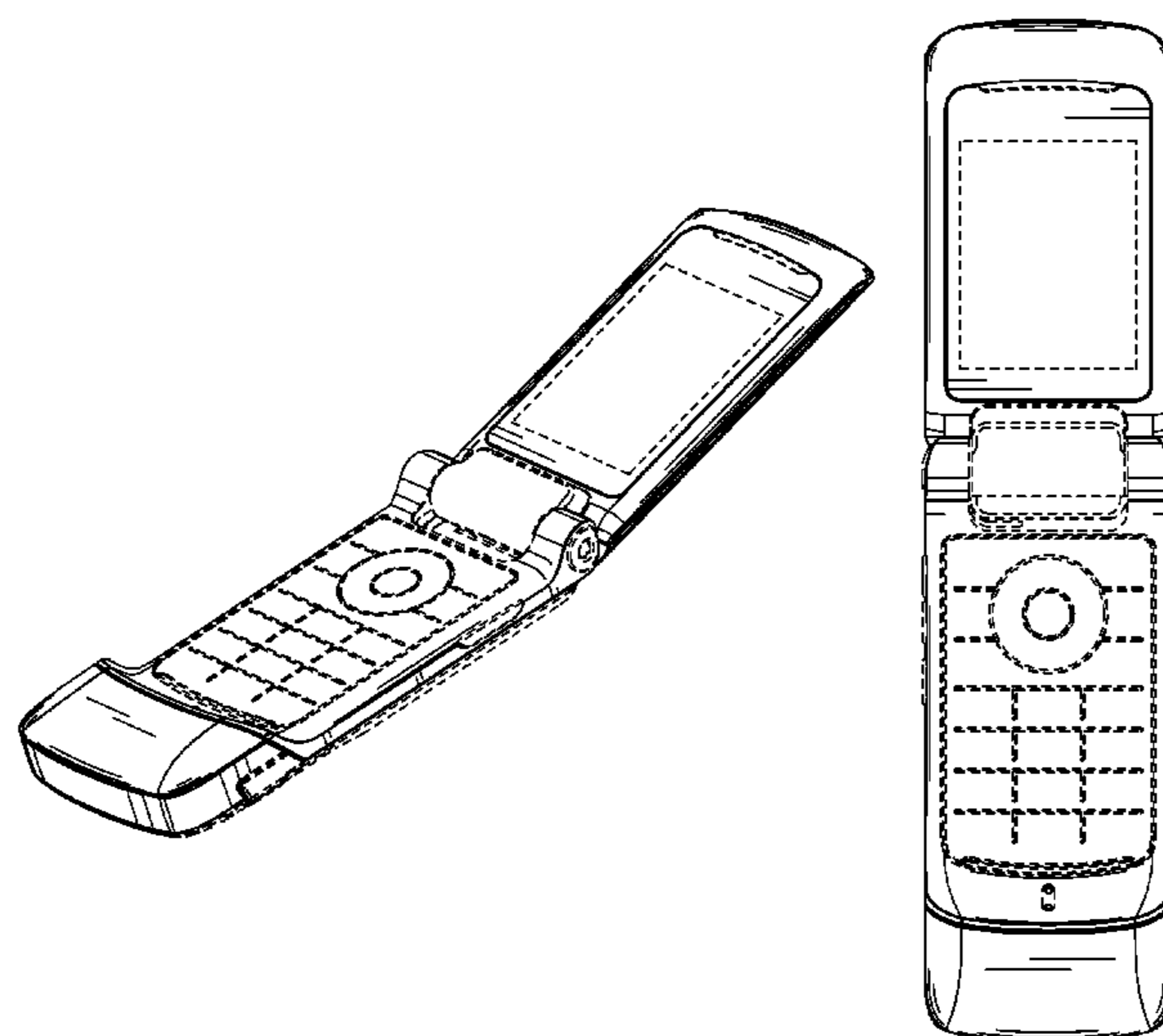
DESCRIPTION

FIG. 1 is a perspective view of a housing for a communi-
cation device showing our new design; and,

FIG. 2 is a front view thereof.

The broken lines shown in the drawing that are immediately
adjacent to the shaded areas and define unshaded regions
represent the bounds of the claimed design, while all other
broken lines are directed to environment and are for illus-
trative purposes only; the broken lines form no part of the
claimed design.

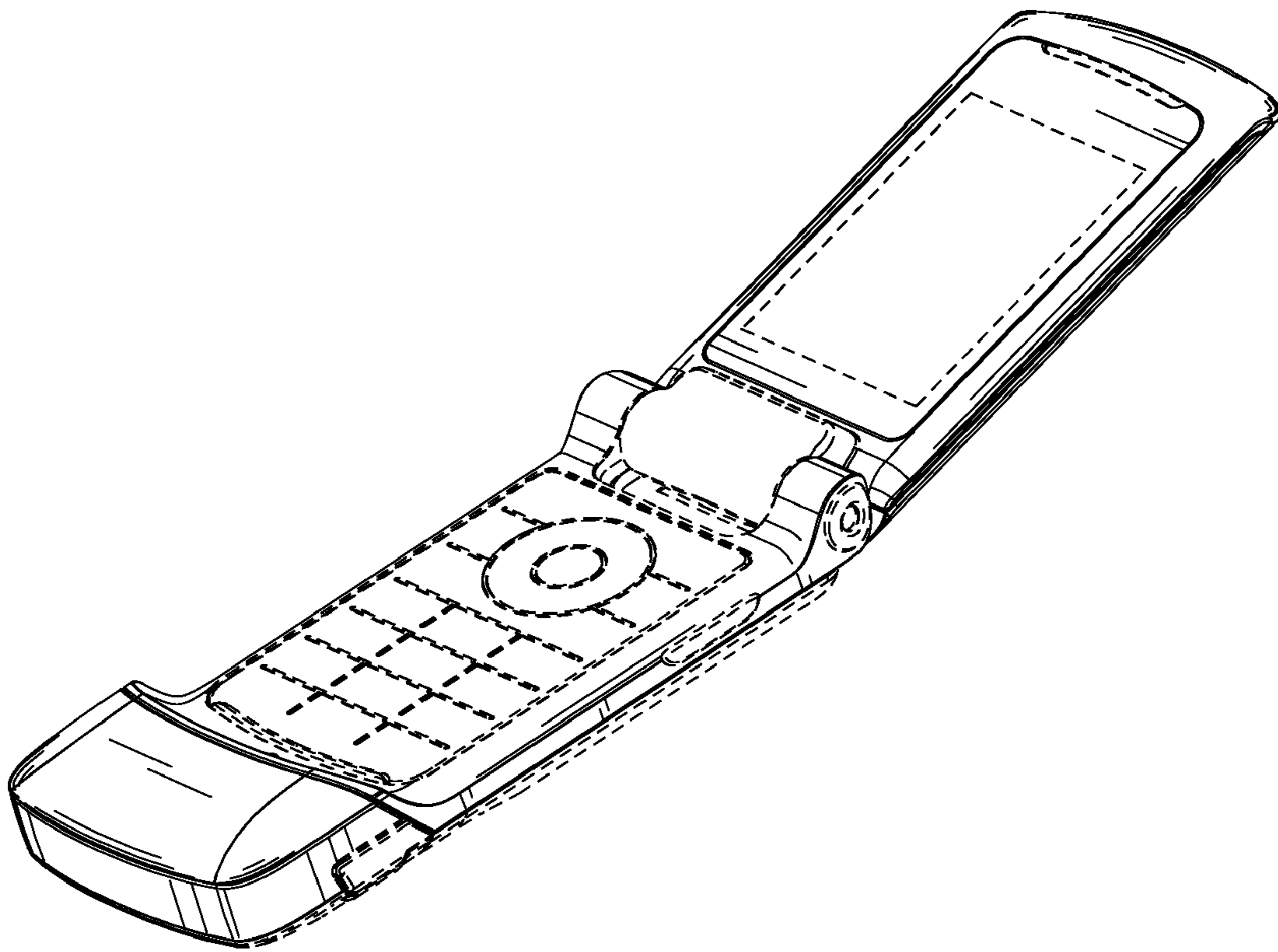

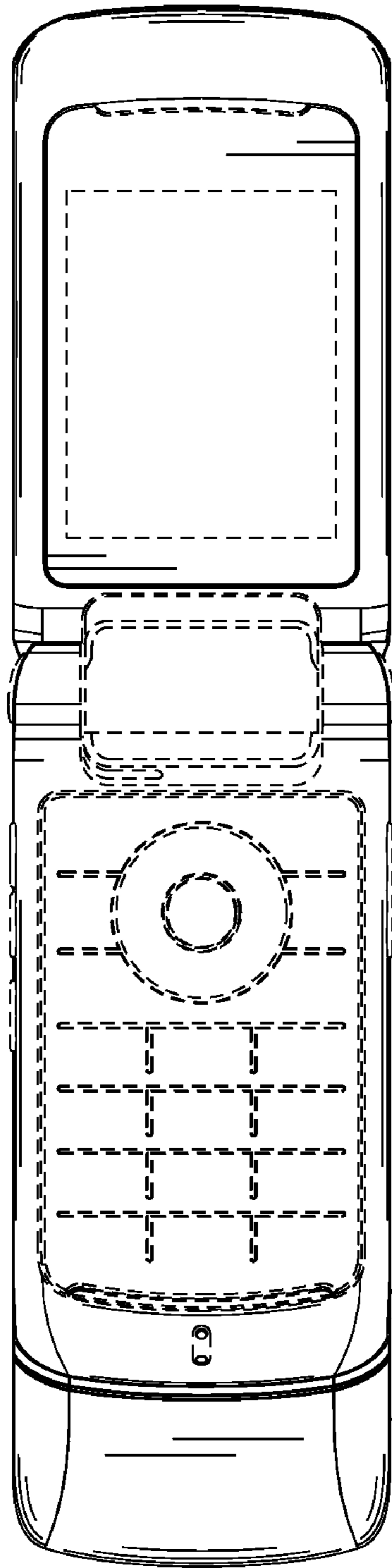
