FIG. 5 is a top view; and

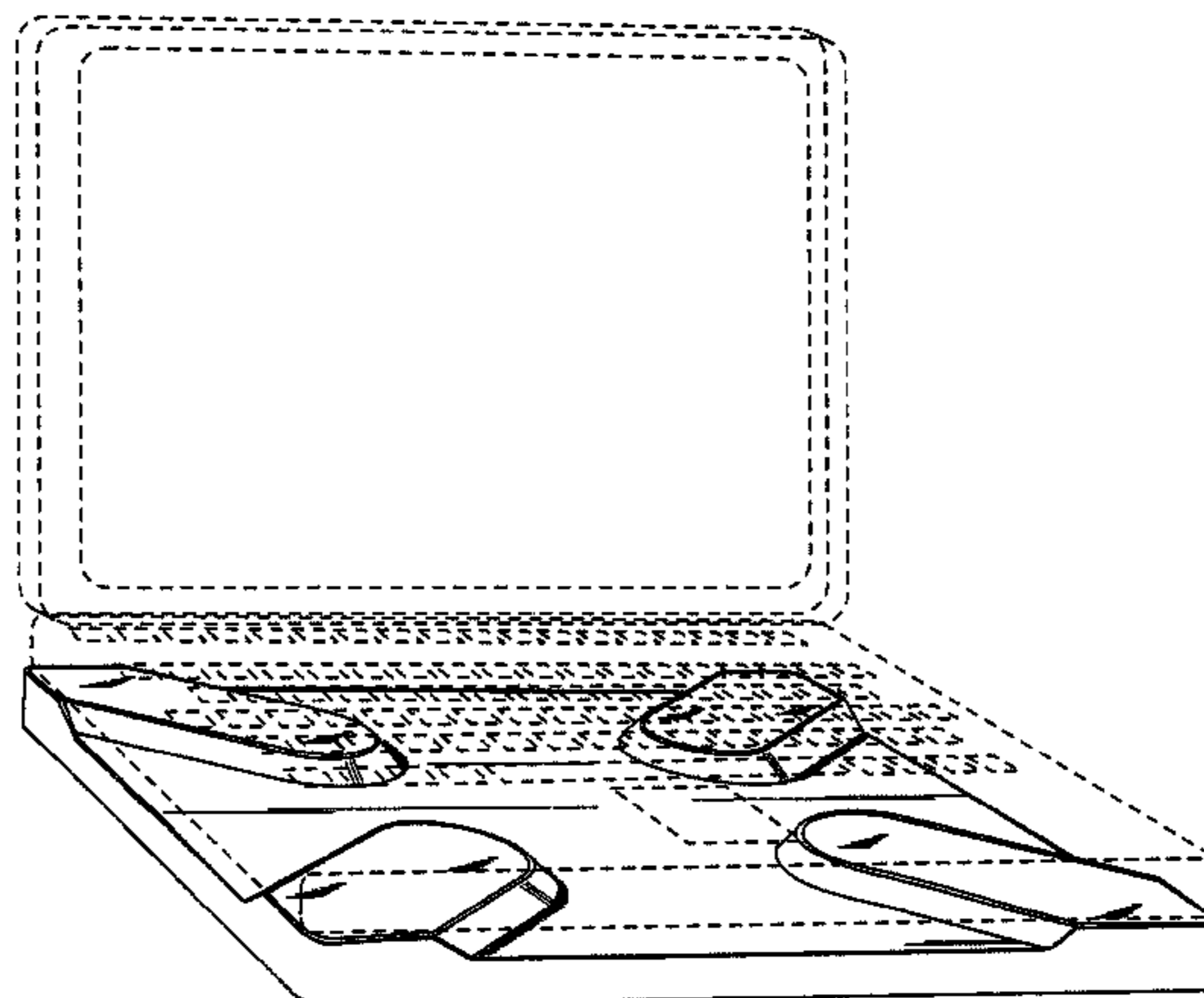
FIG. 6 is a front view thereof;

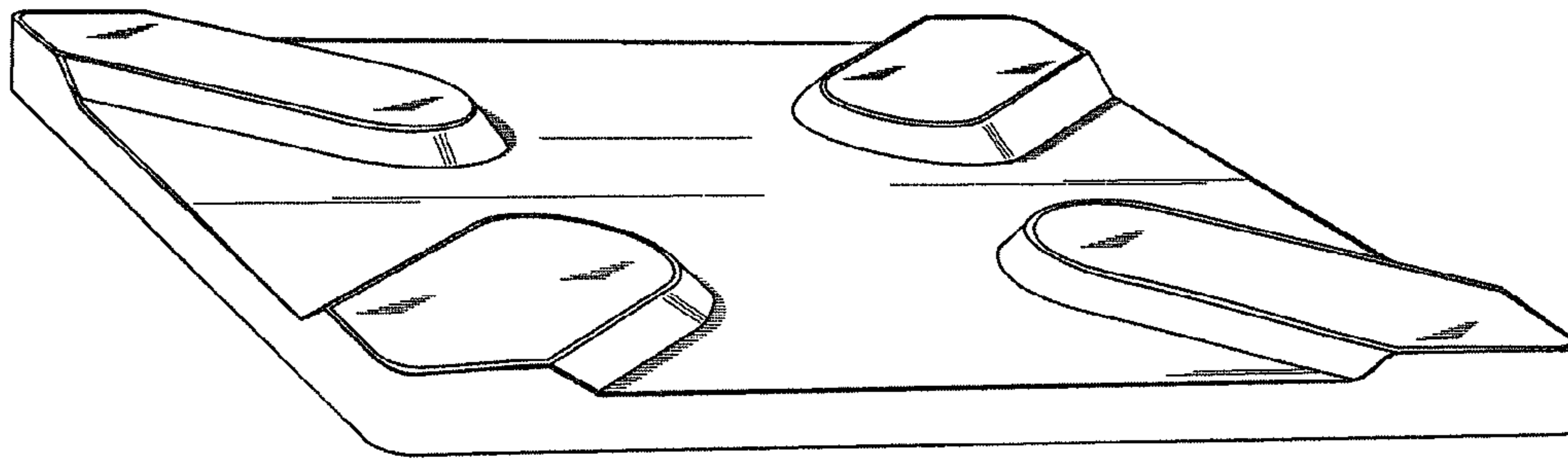

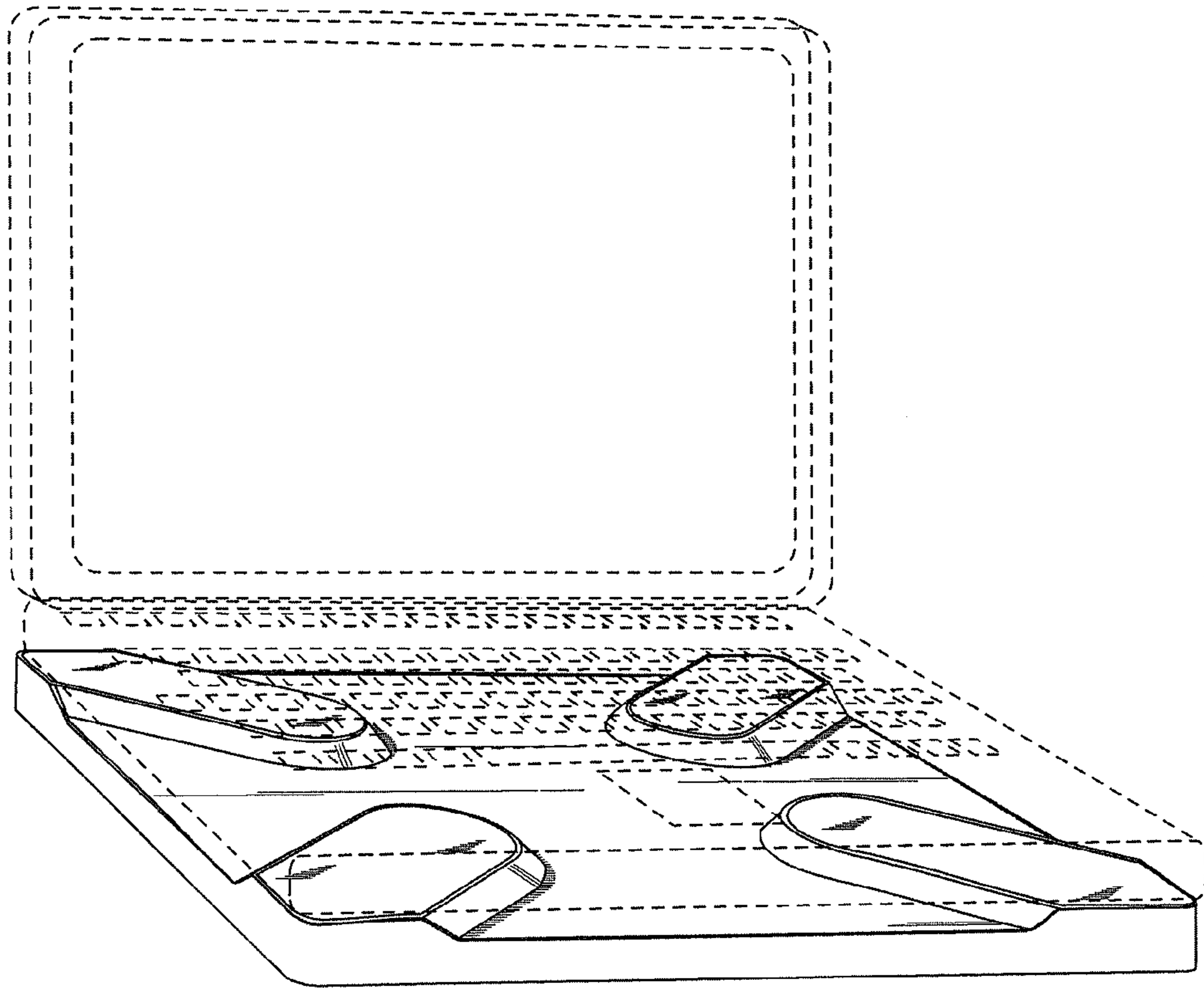

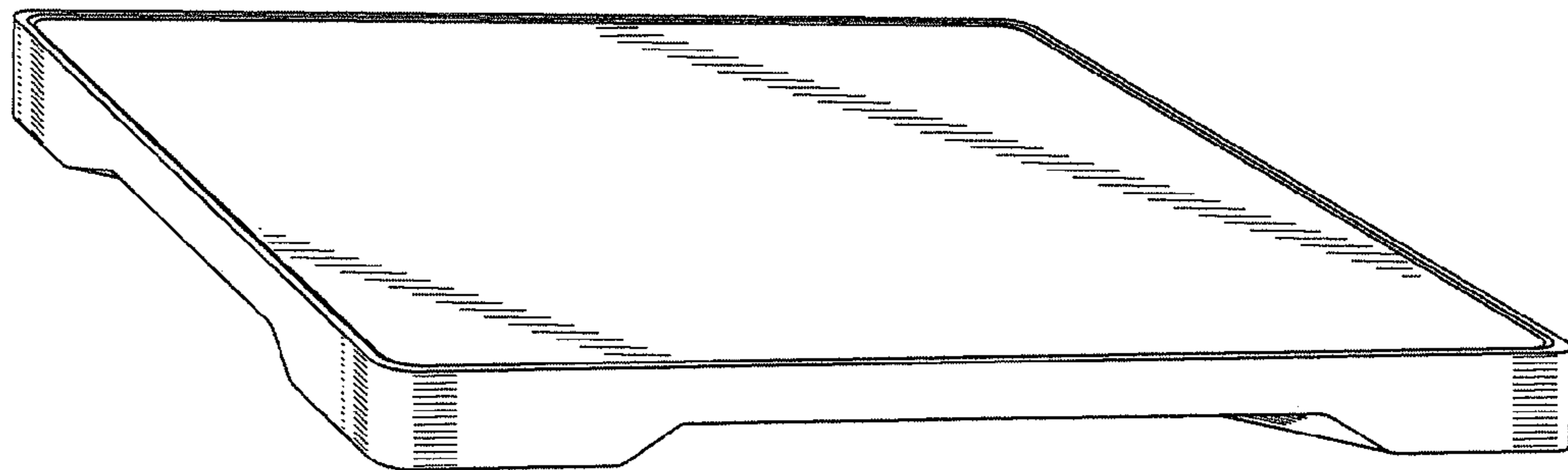

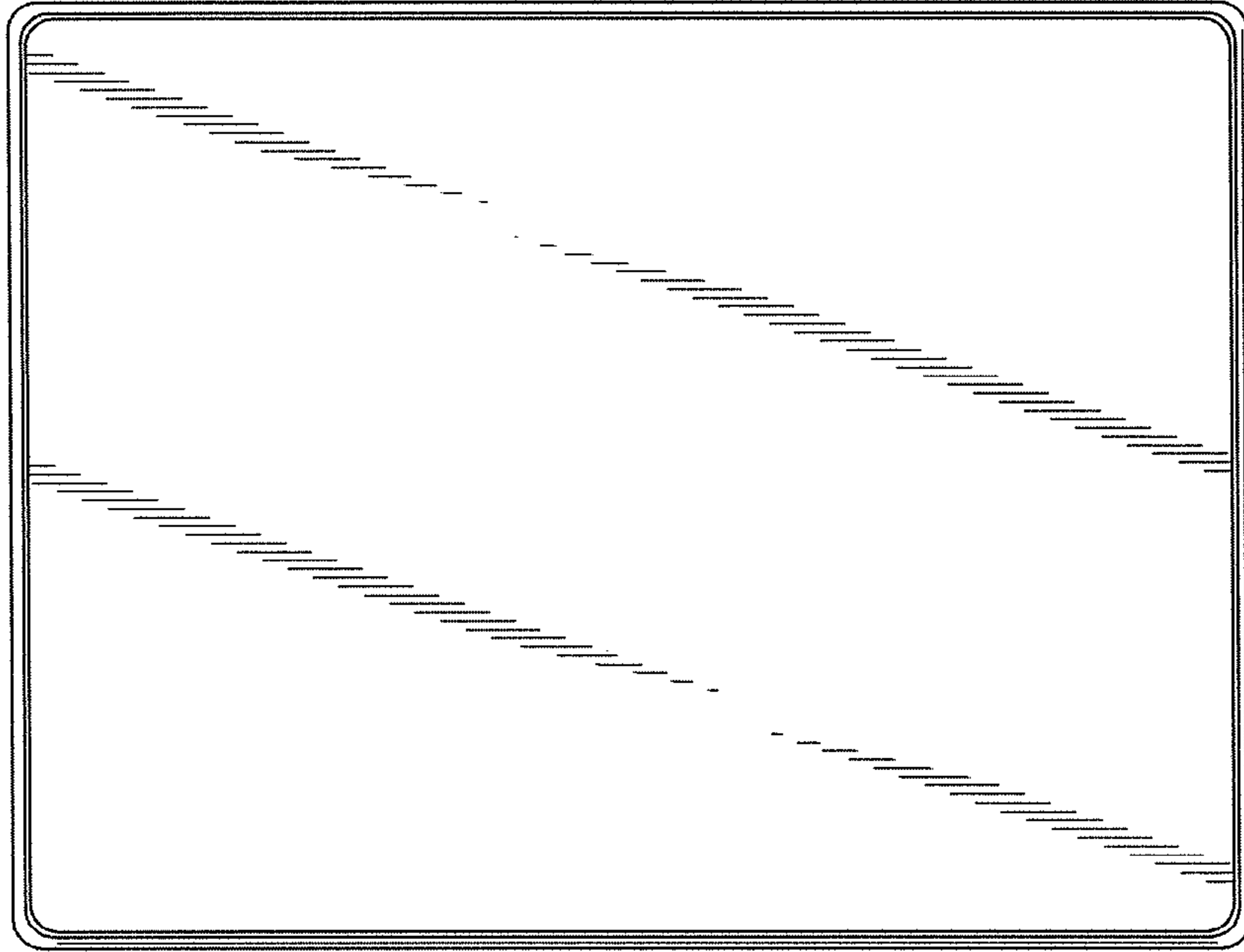

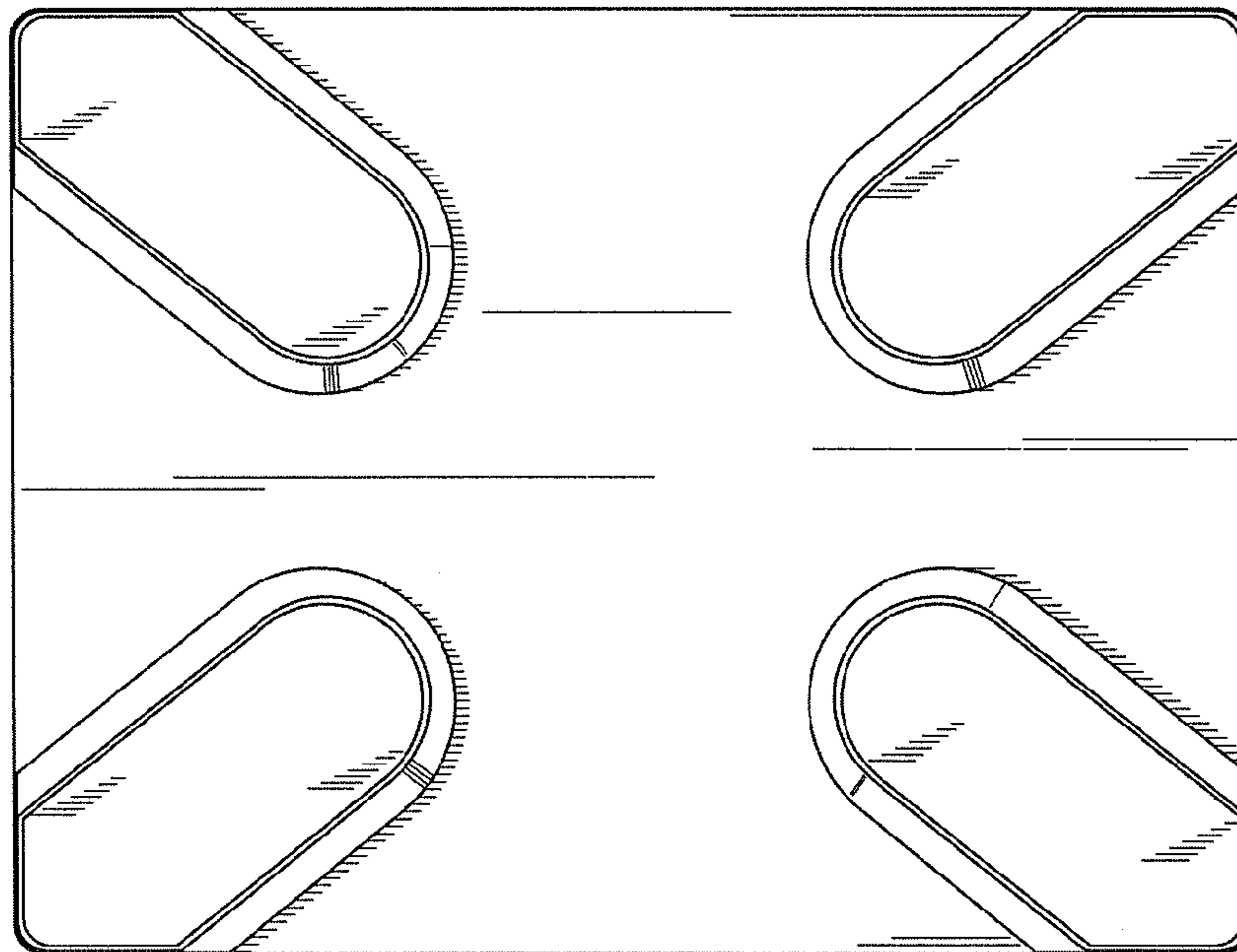

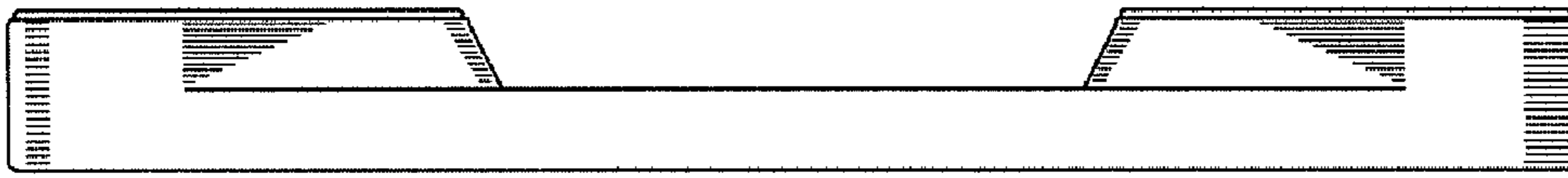

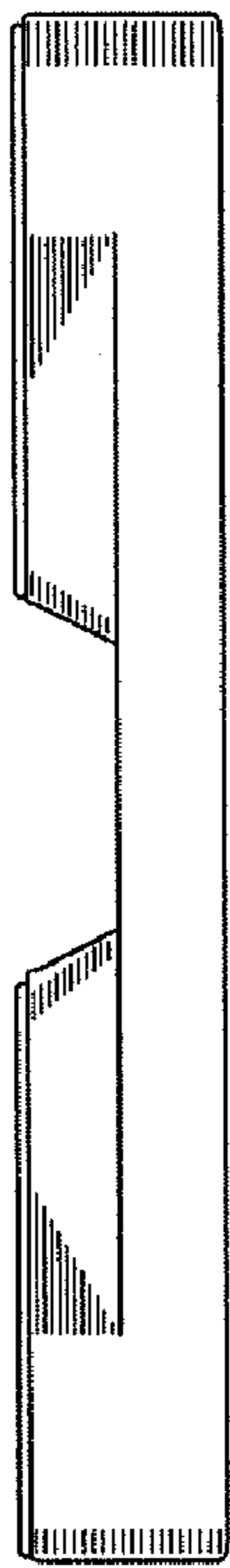
