(57) **CLAIM**

The ornamental design for a dragonfly fishing lure, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of dragonfly fishing lure
showing my new design;

FIG. 2 is a top plan view of the dragonfly fishing lure as
depicted in FIG. 1;

FIG. 3 is a bottom plan view of the dragonfly fishing lure as
depicted in FIG. 1;

FIG. 4 is a left side view of the dragonfly fishing lure as
depicted in FIG. 1, the right side view being a mirror image
thereof;

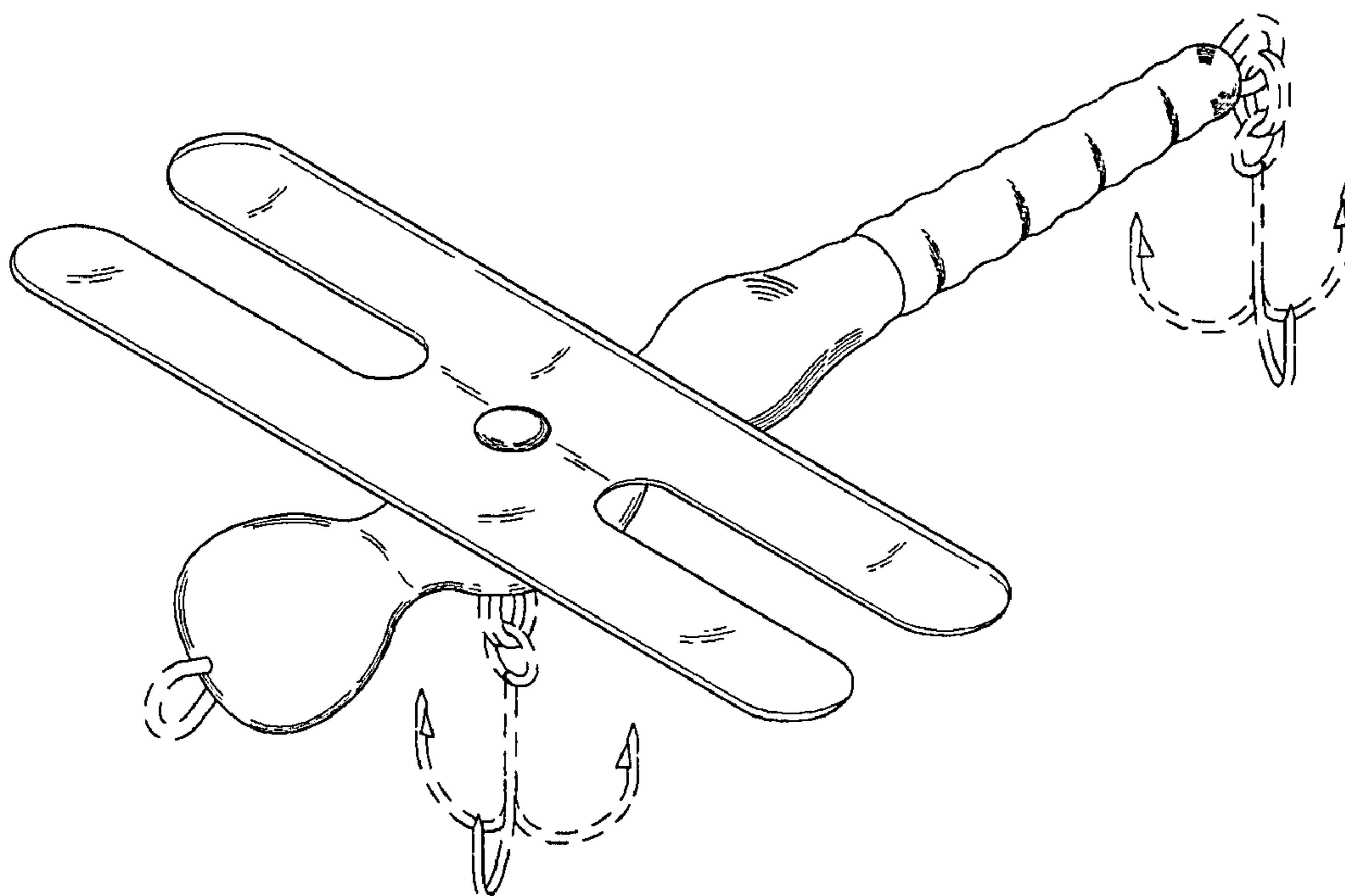
FIG. 5 is a right side view of the dragonfly fishing lure as
depicted in FIG. 1, the left side view being a mirror image
thereof;

FIG. 6 is a front side view of the dragonfly fishing lure as
depicted in FIG. 1; and,

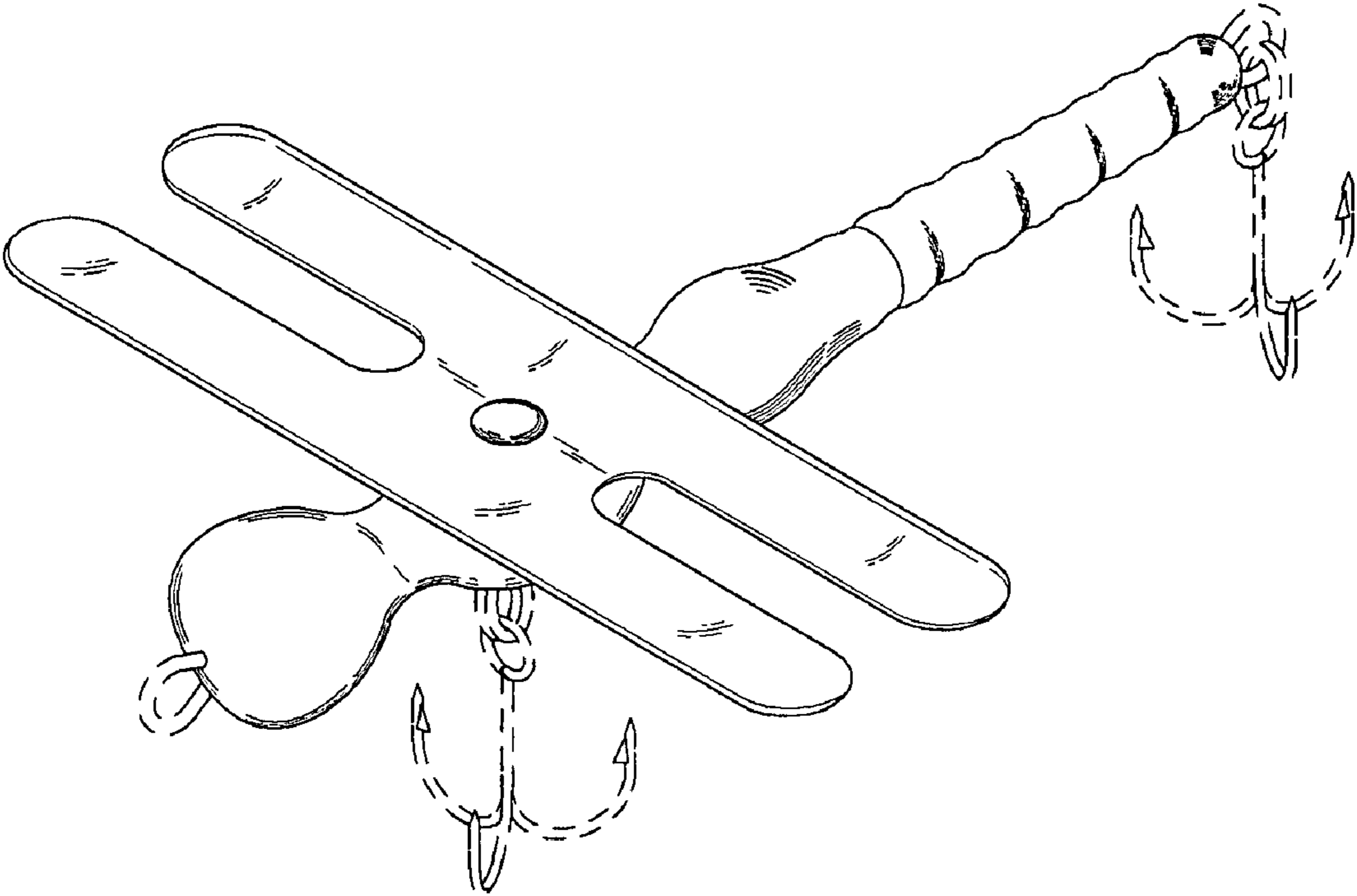

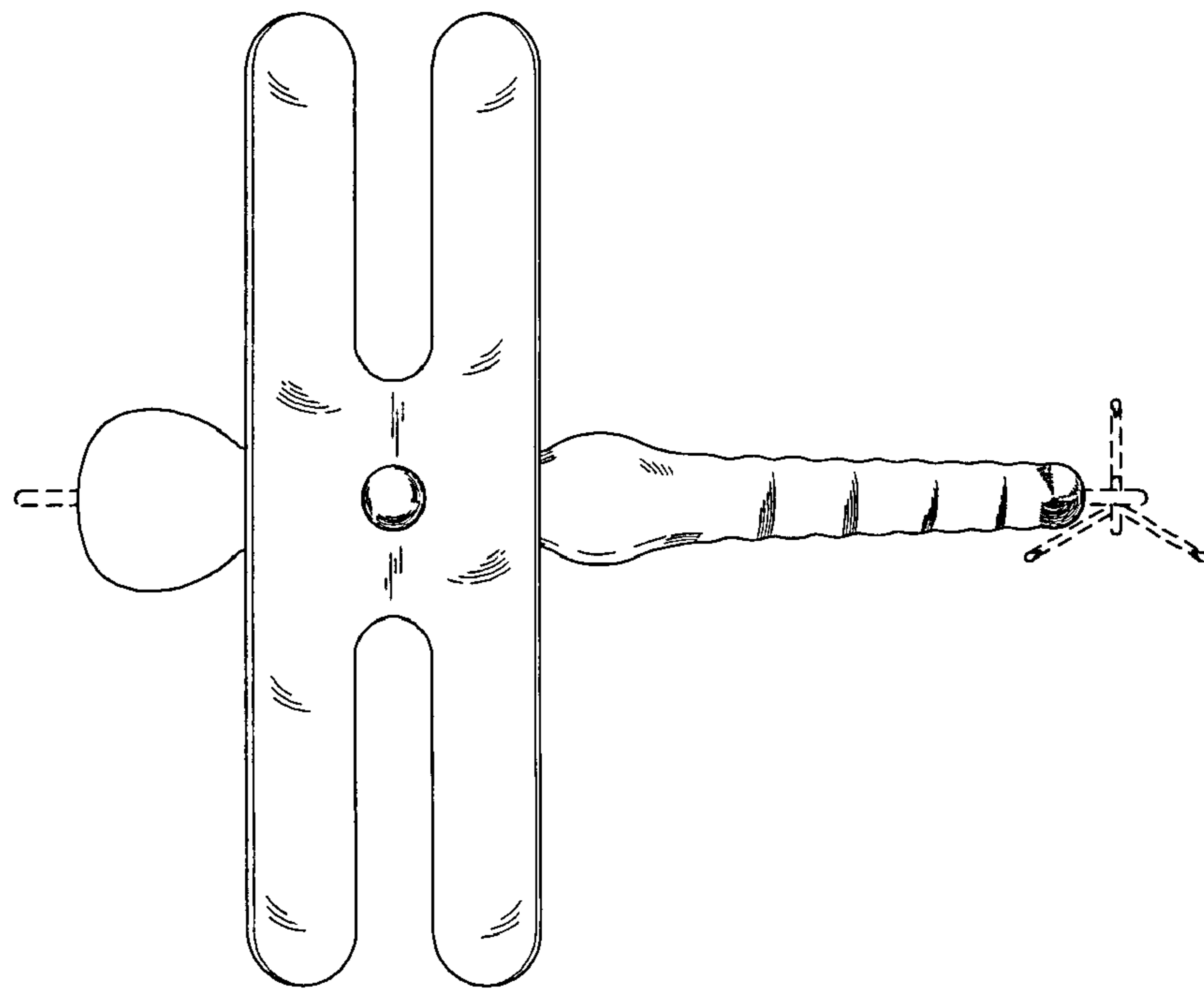

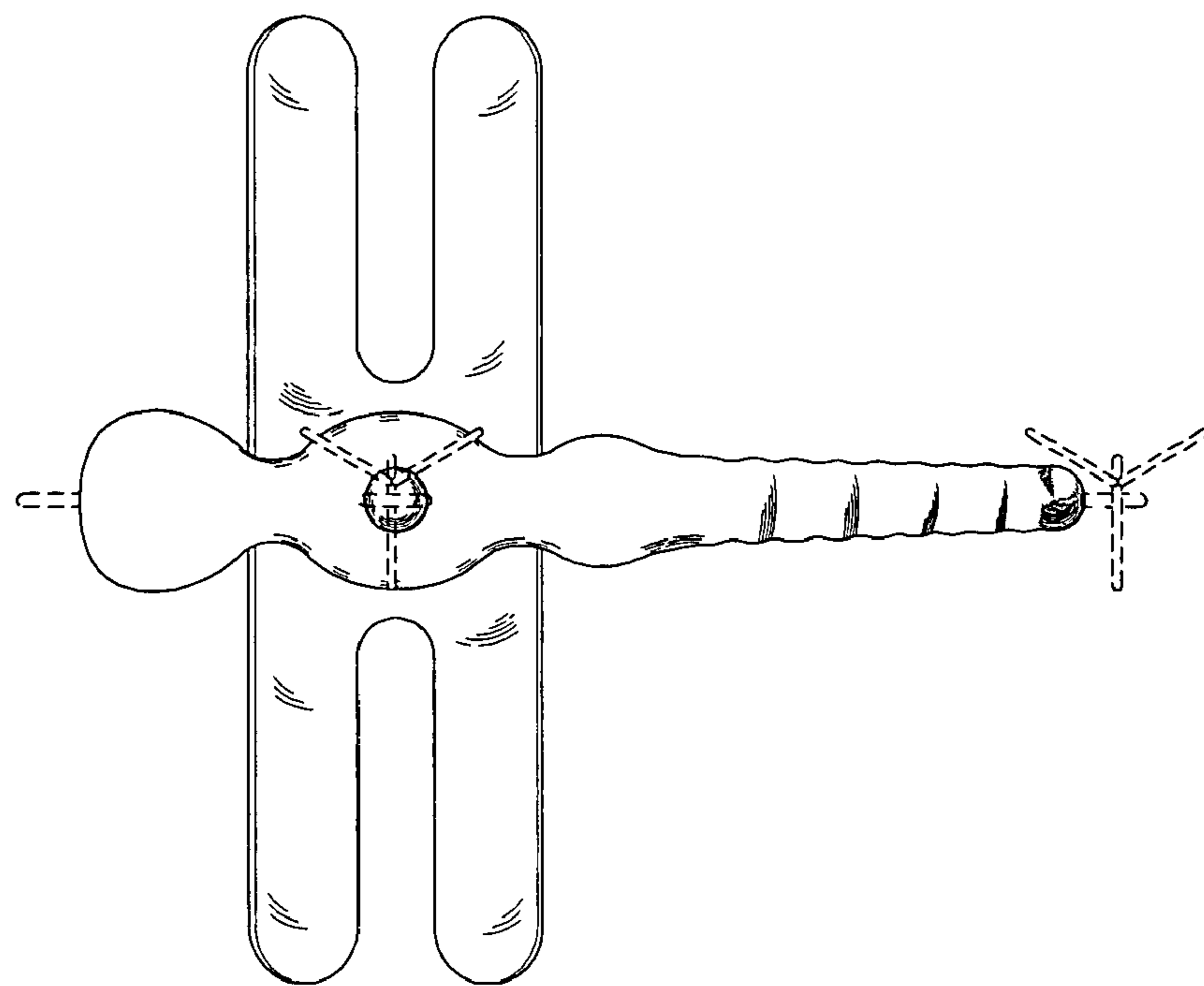

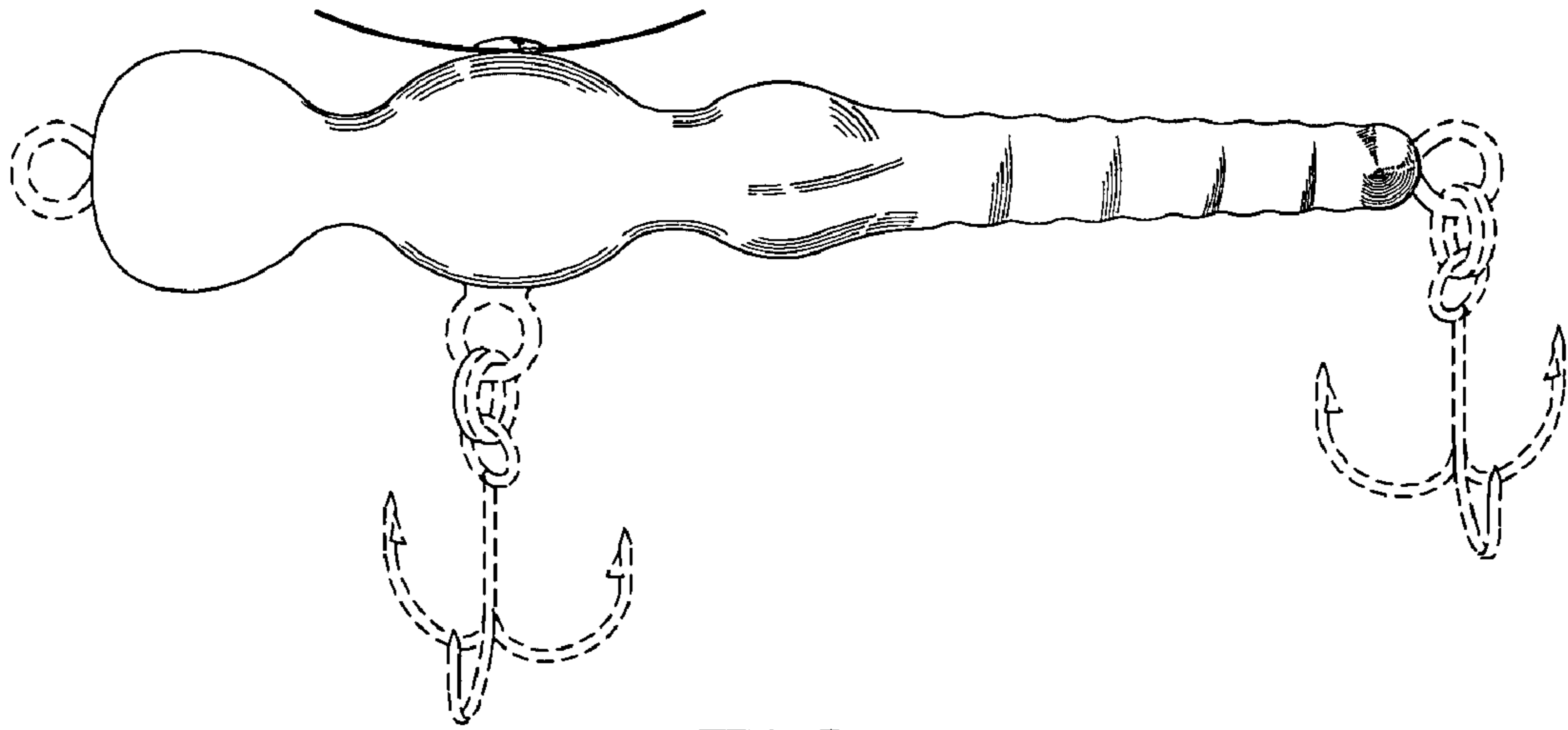

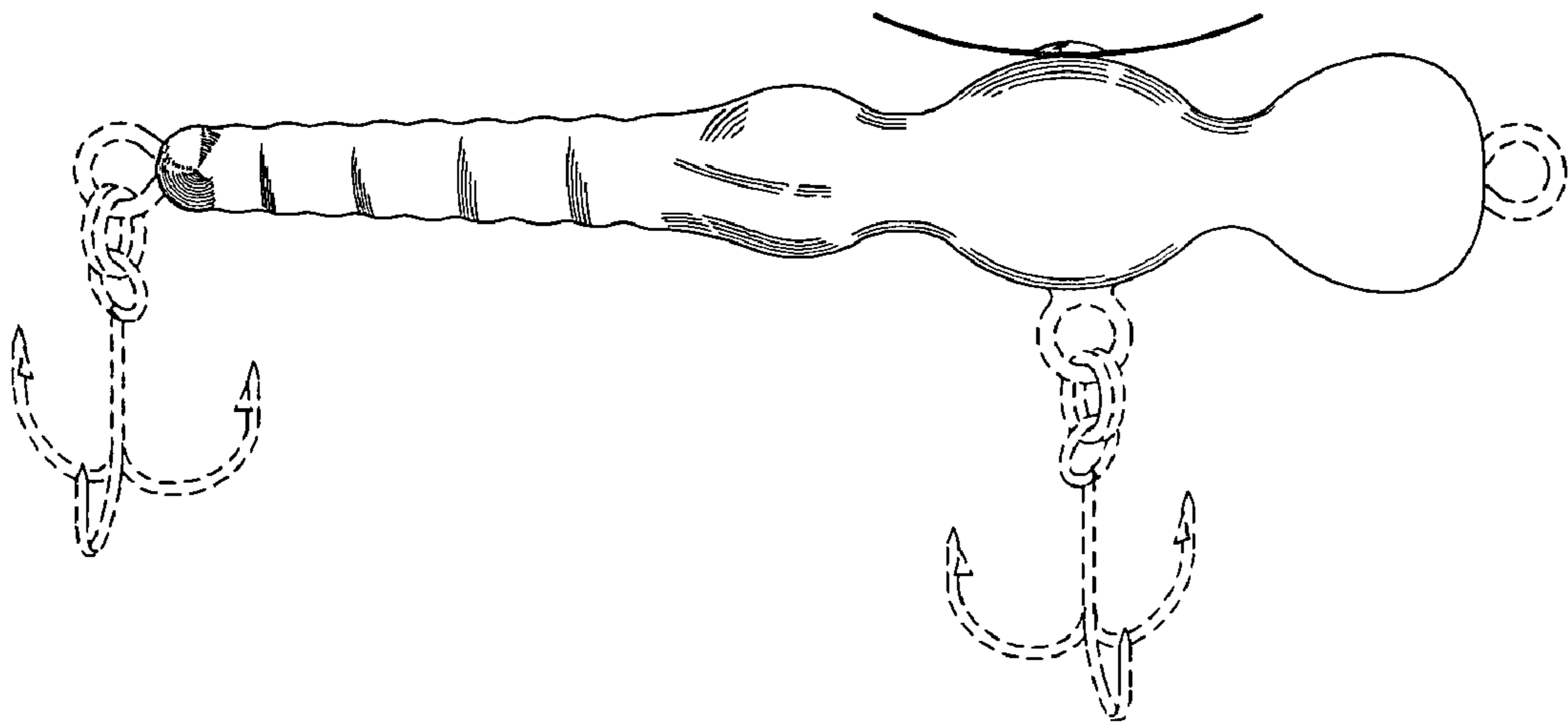

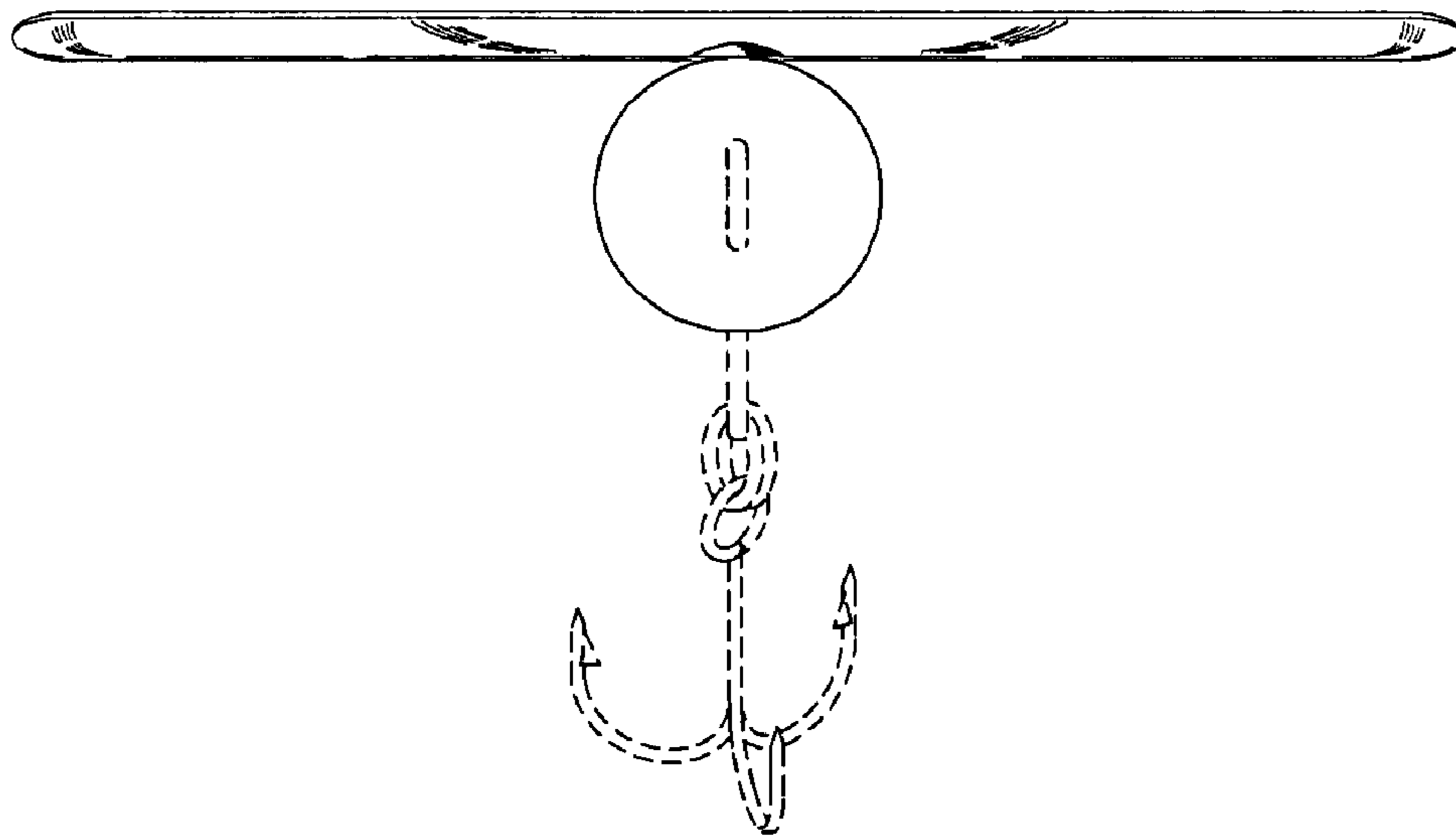

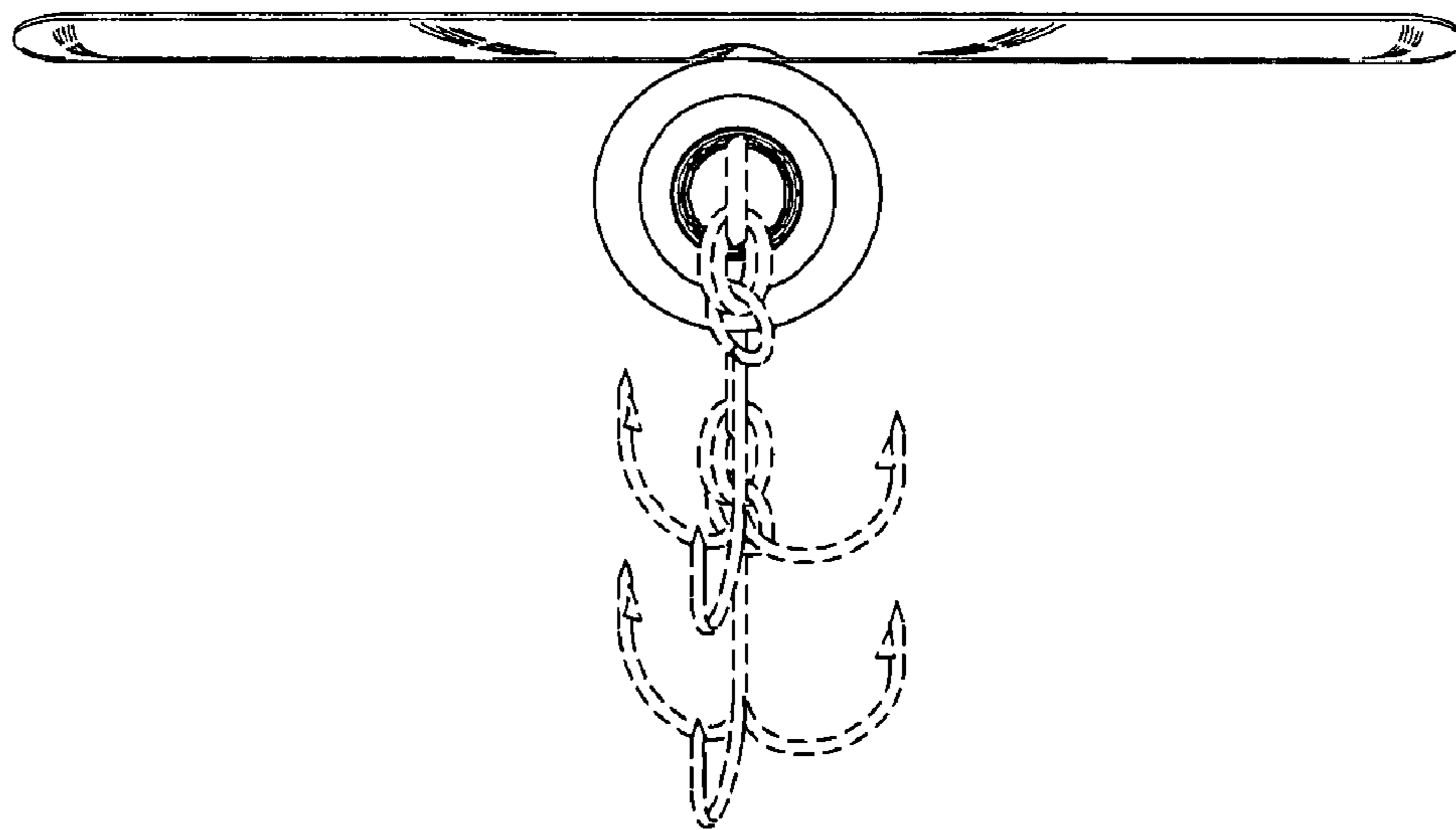
