(57) **CLAIM**

We claim the ornamental design for a vaporizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a vaporizer showing my new design.

FIG. 2 is a front elevational view of the vaporizer shown in FIG. 1.

FIG. 3 is a right side elevational view of the vaporizer shown in FIG. 1, the left side elevational view being a mirror image thereof;

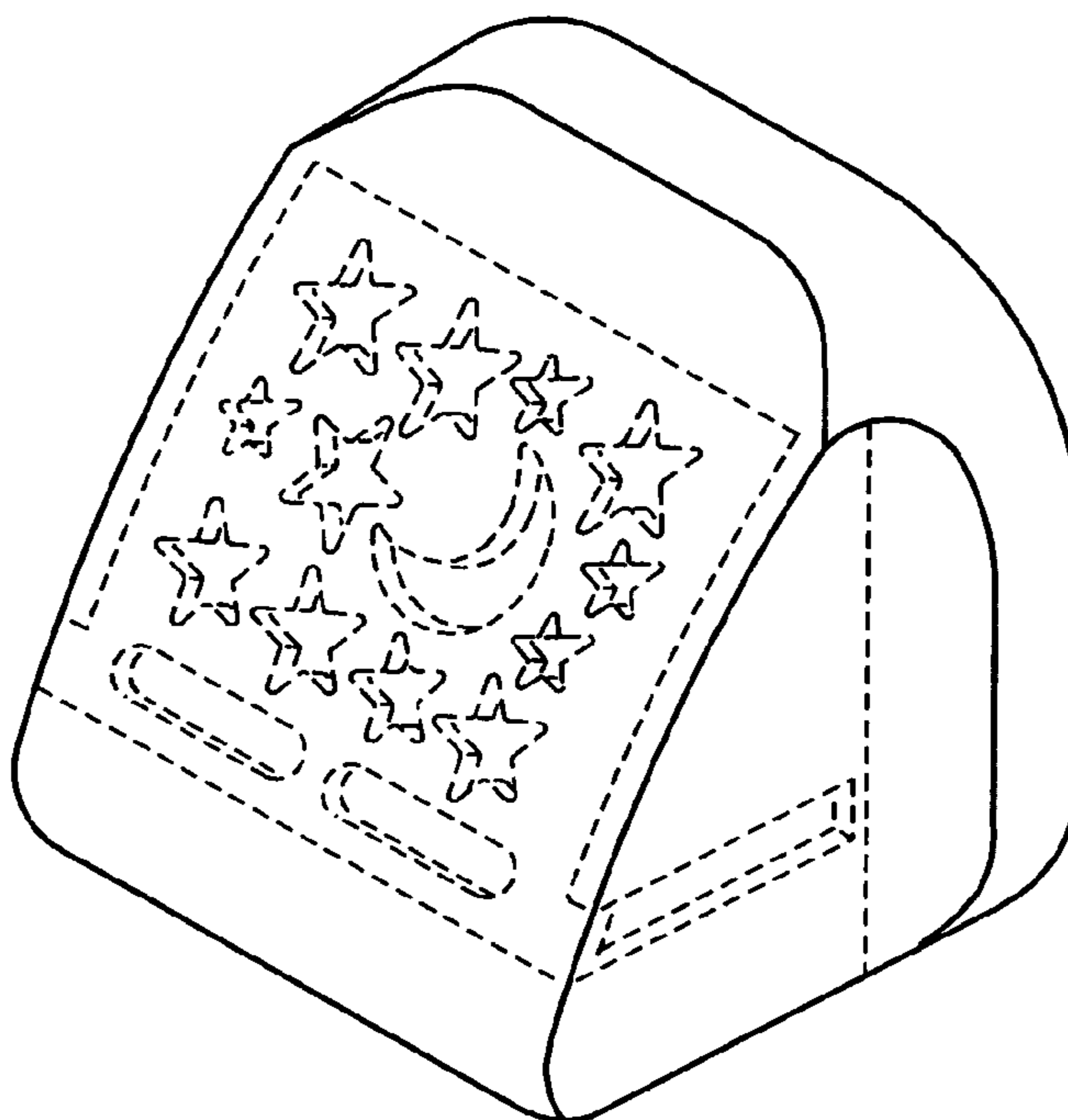
FIG. 4 is a top plan view of the vaporizer shown in FIG. 1.

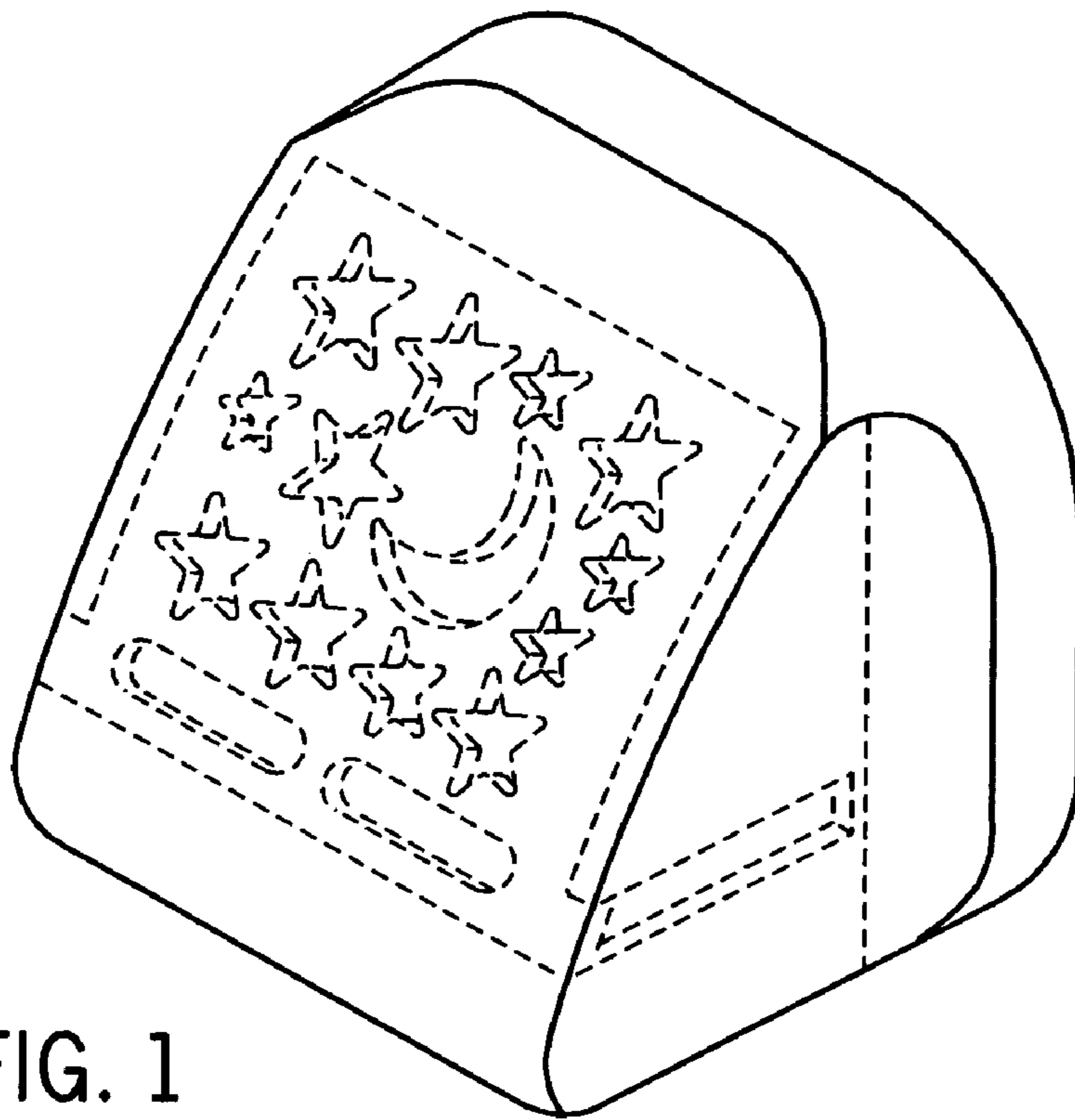

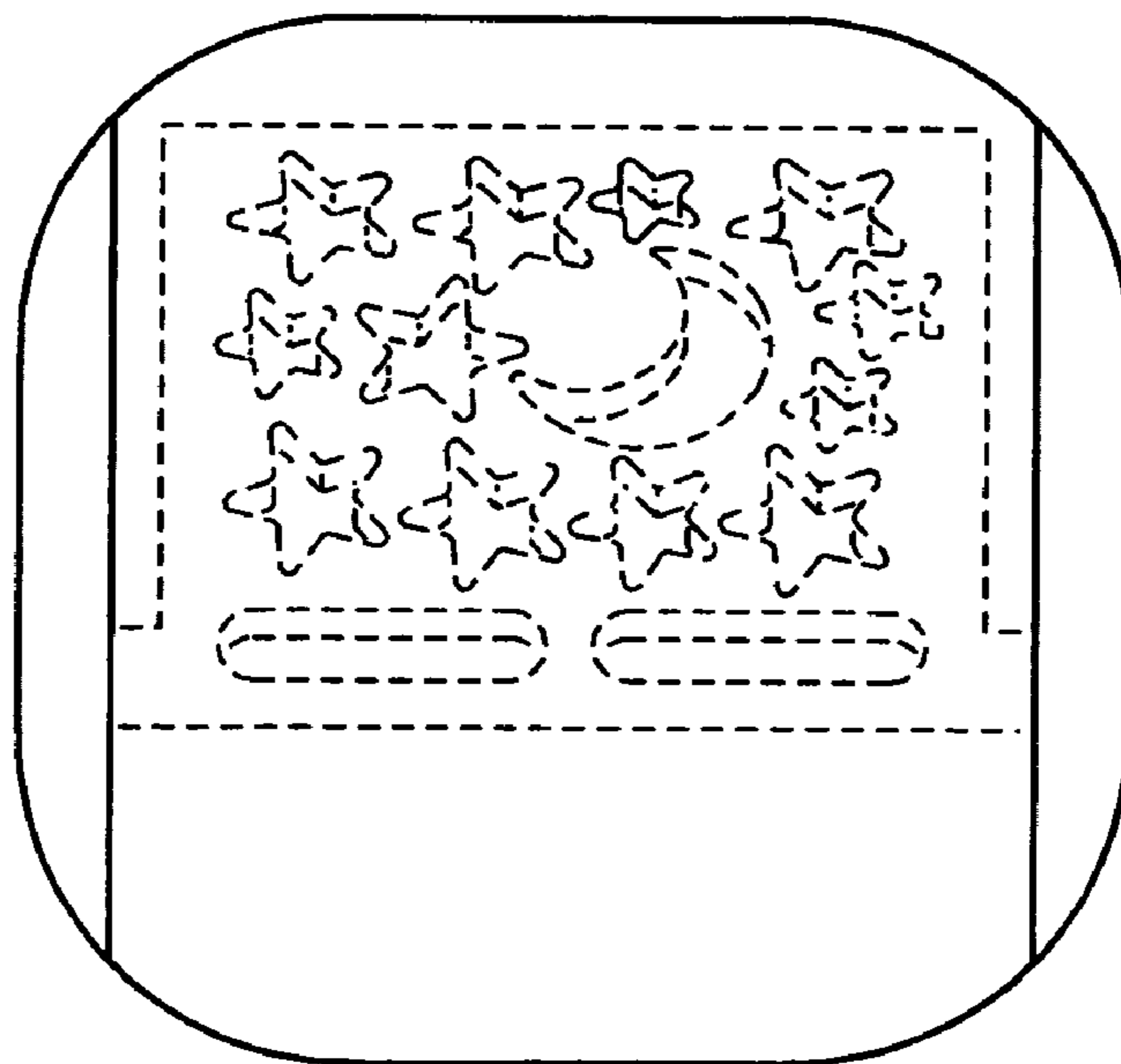

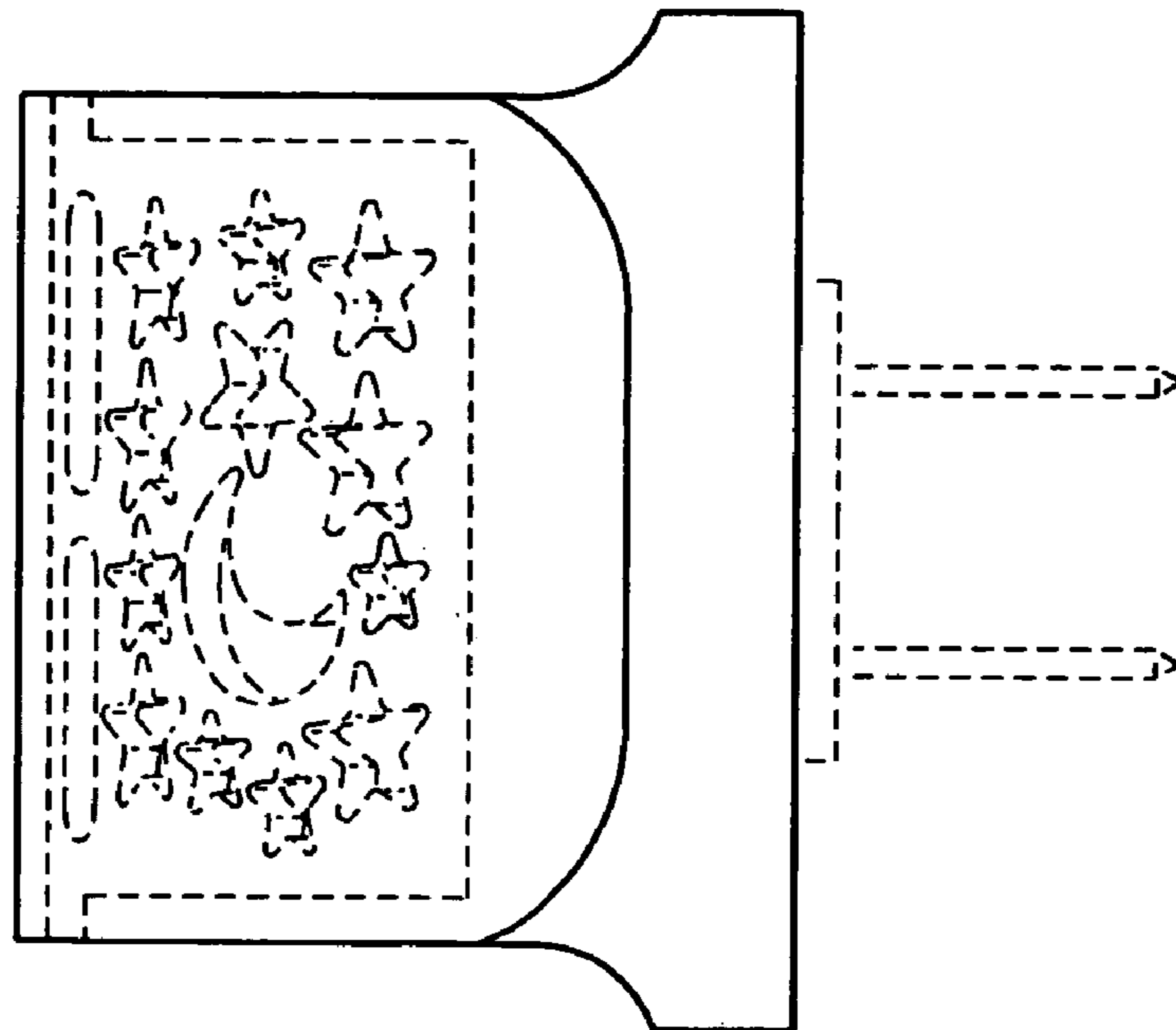
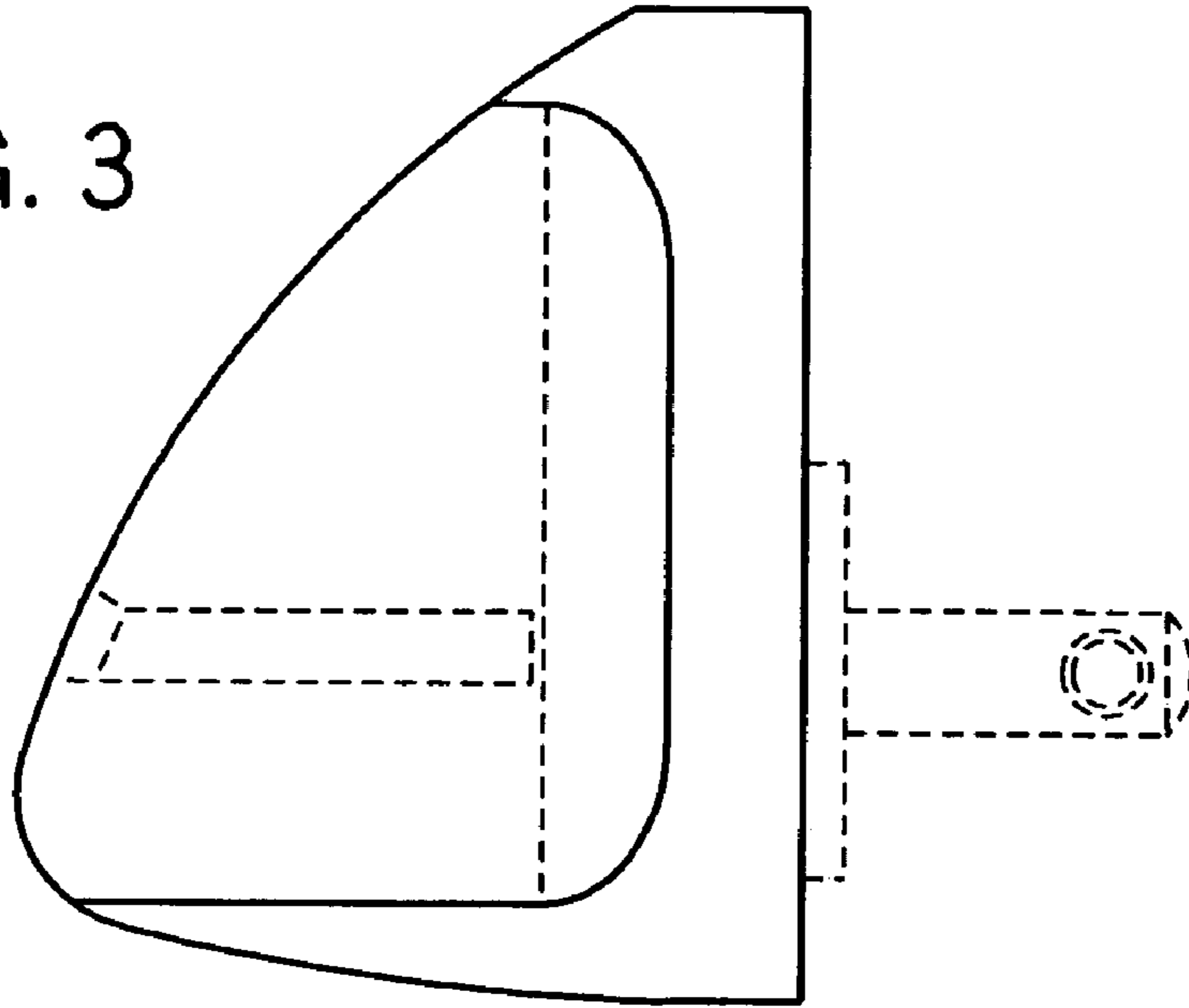

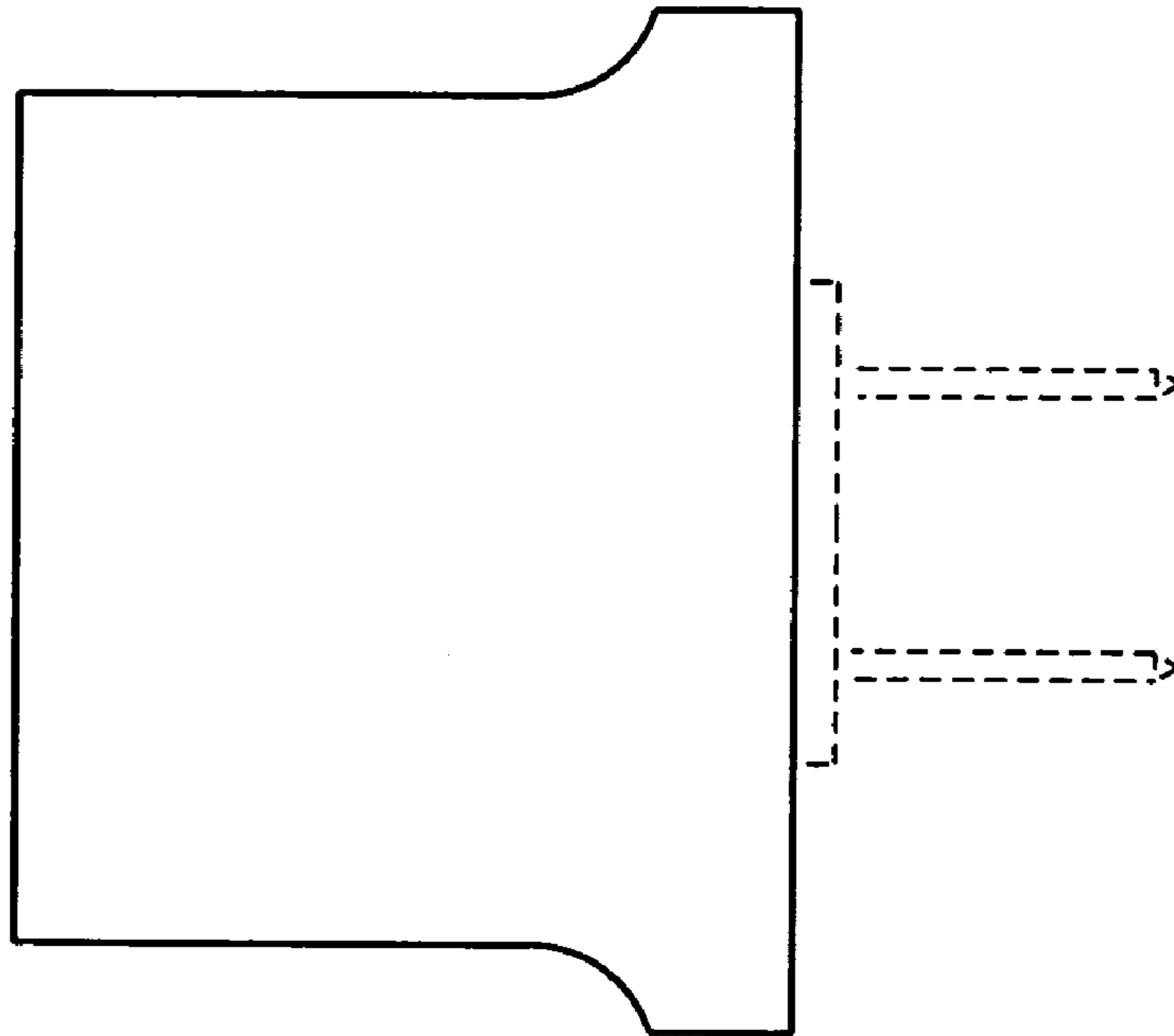

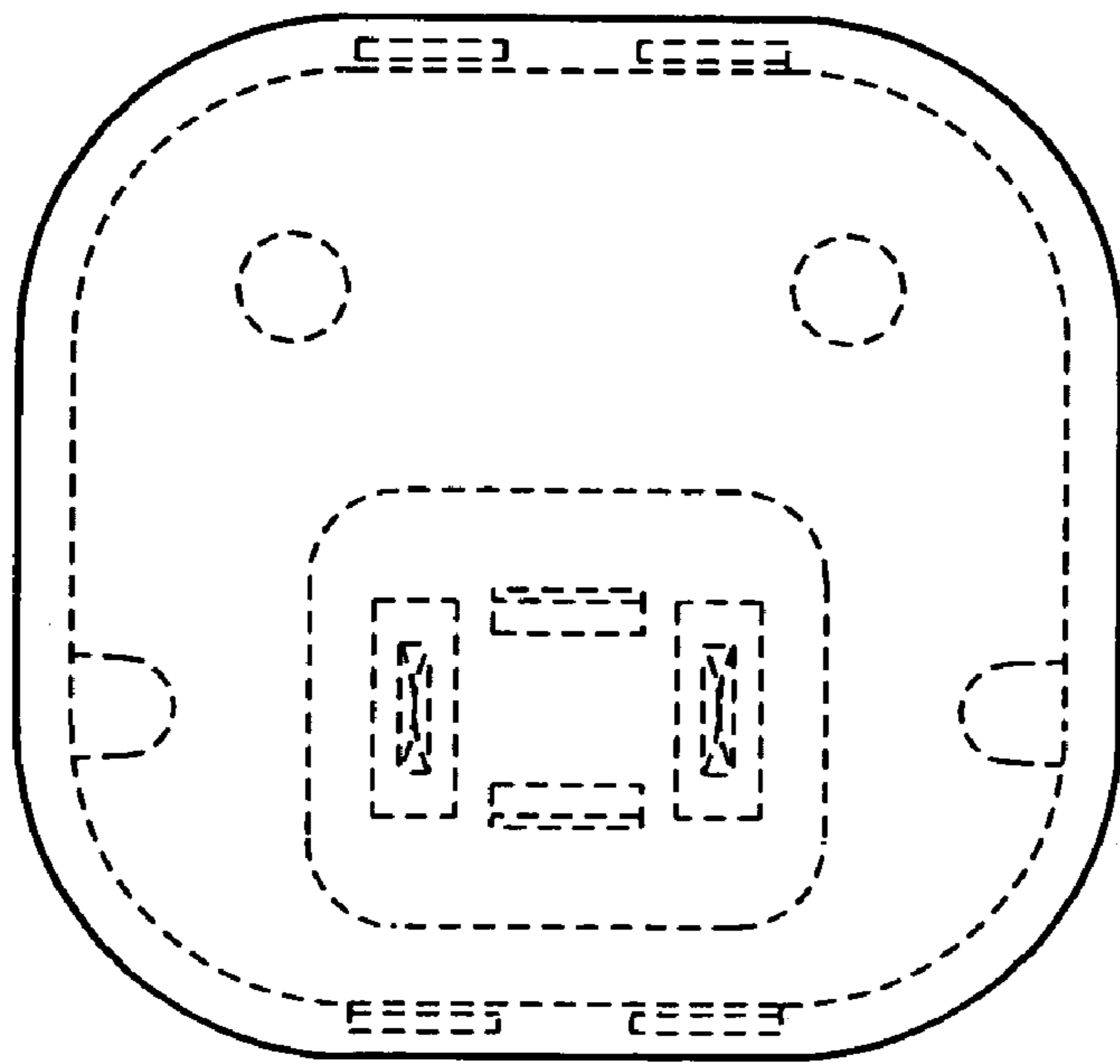
