FIG. 2 is a bottom view thereof;

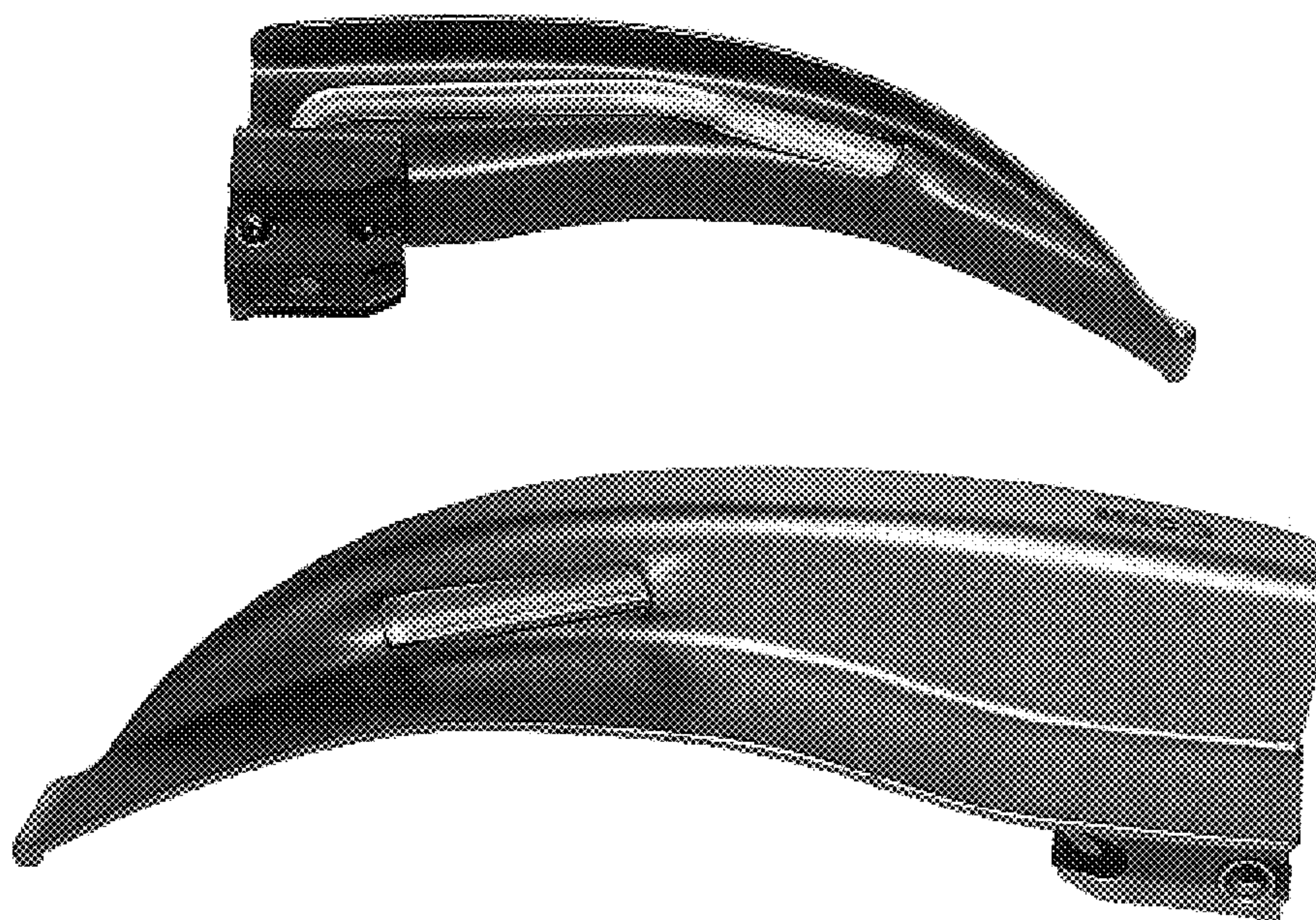
FIG. 3 is a further side perspective view thereof;

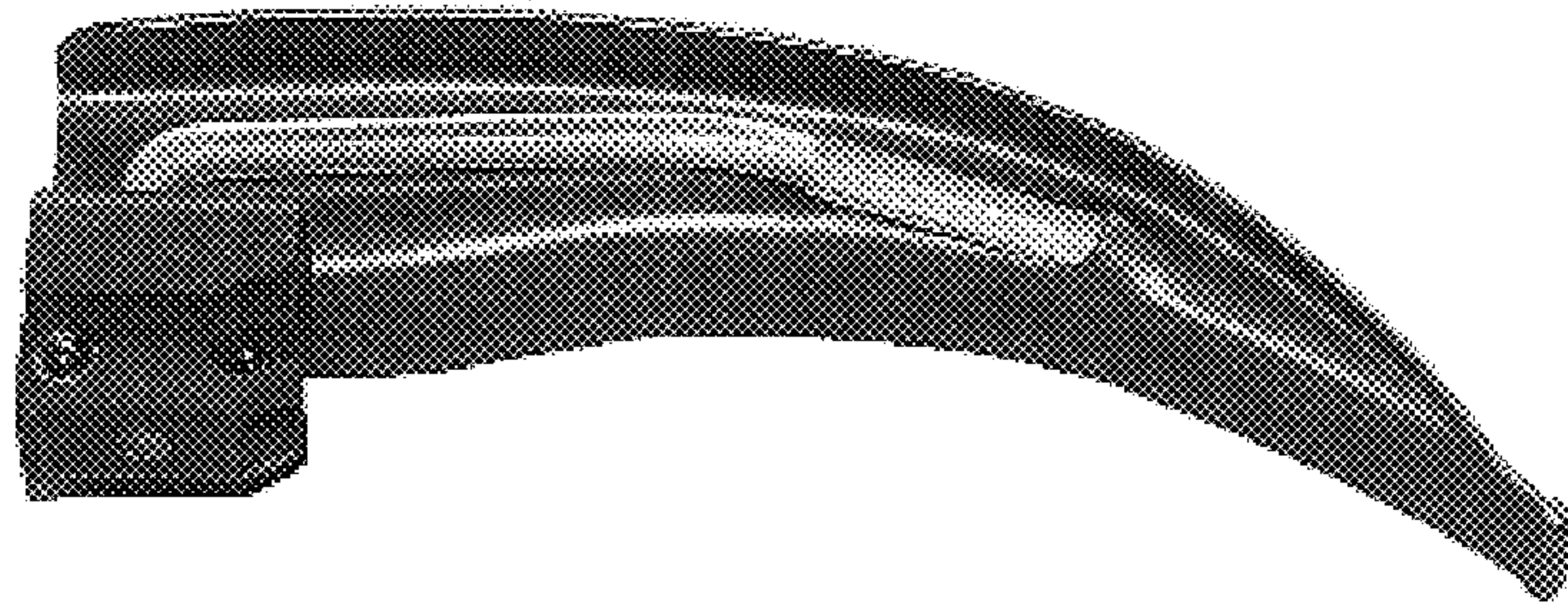

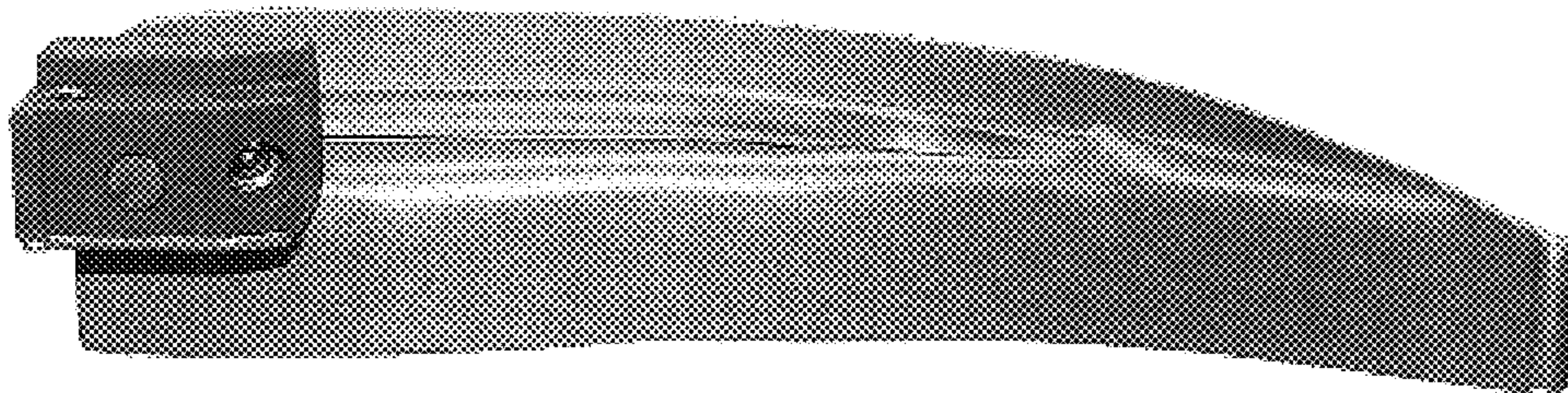

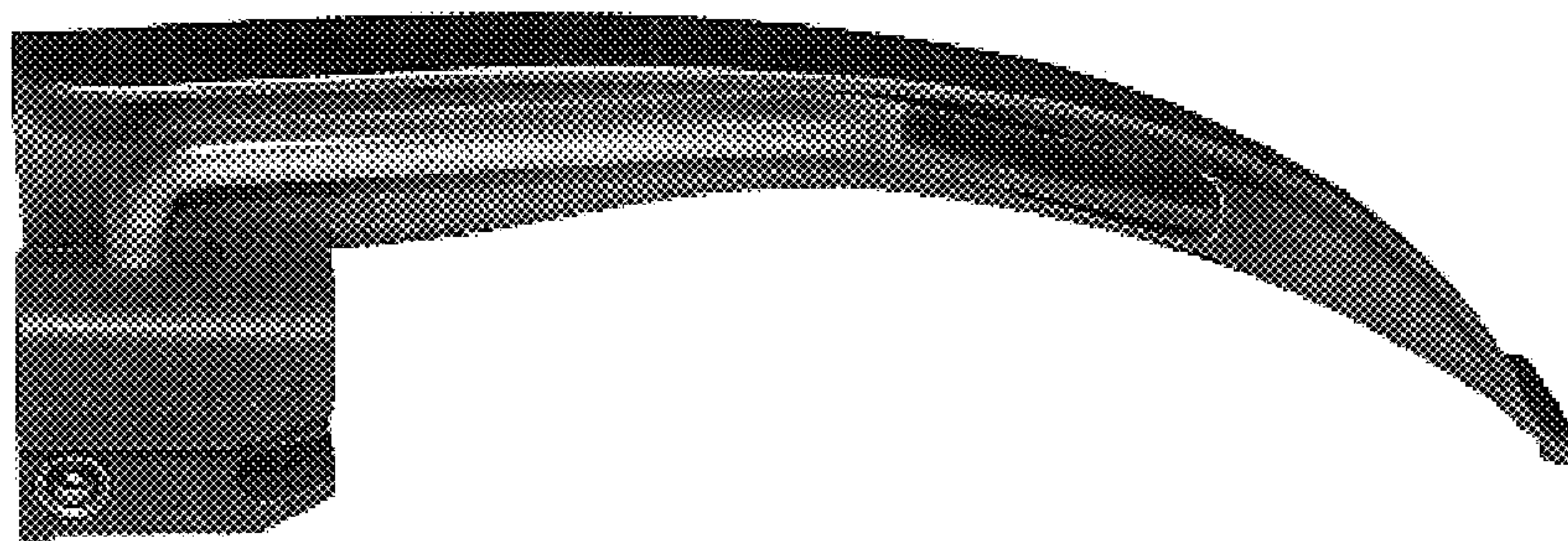

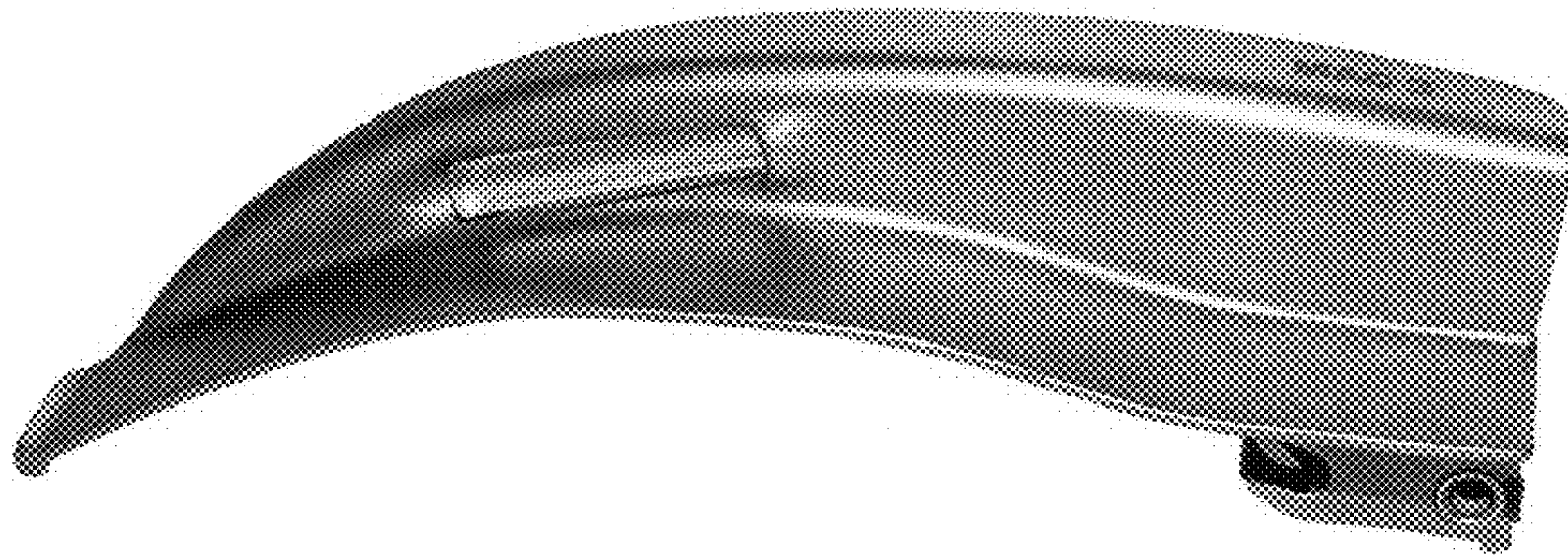

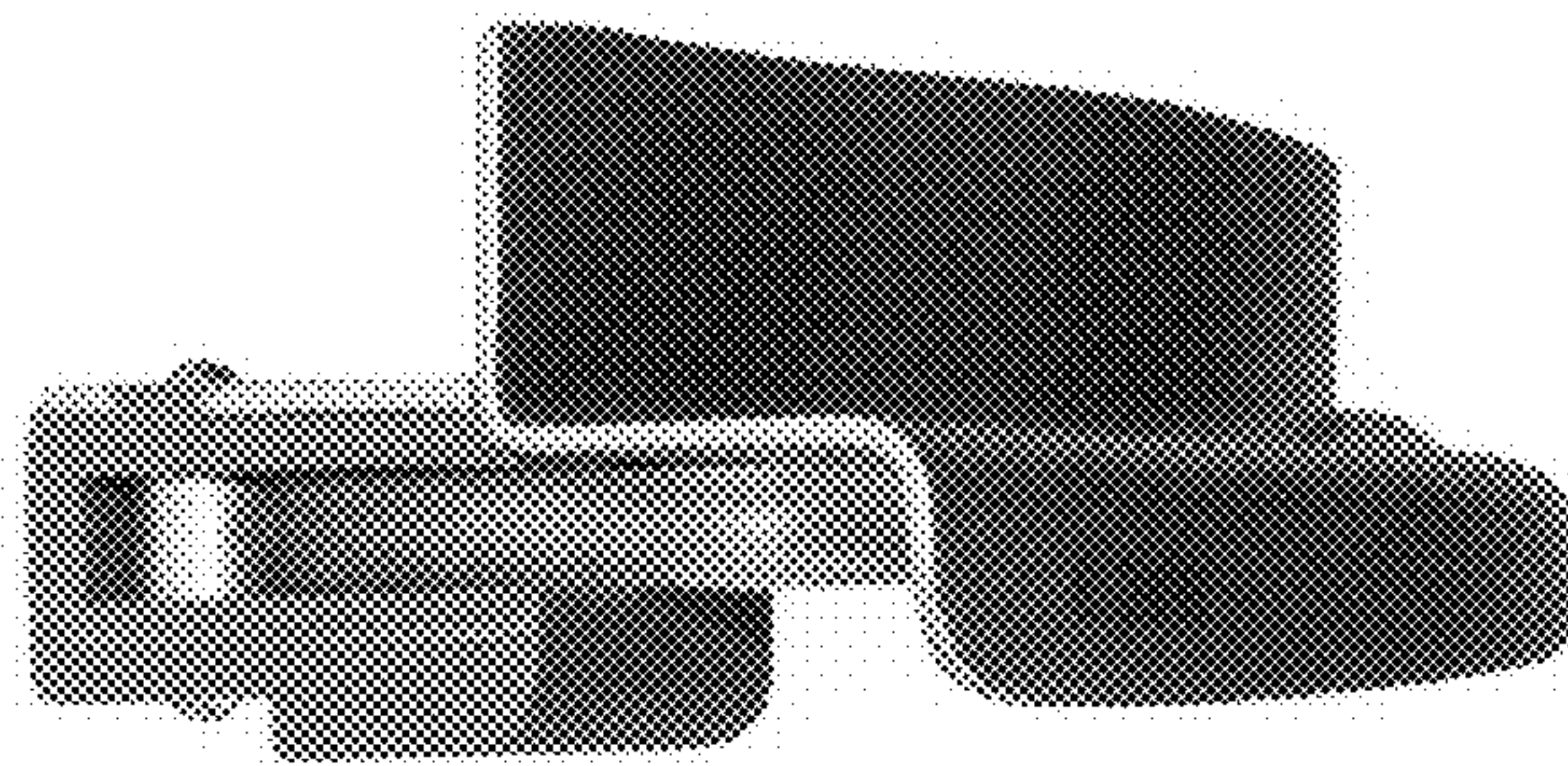

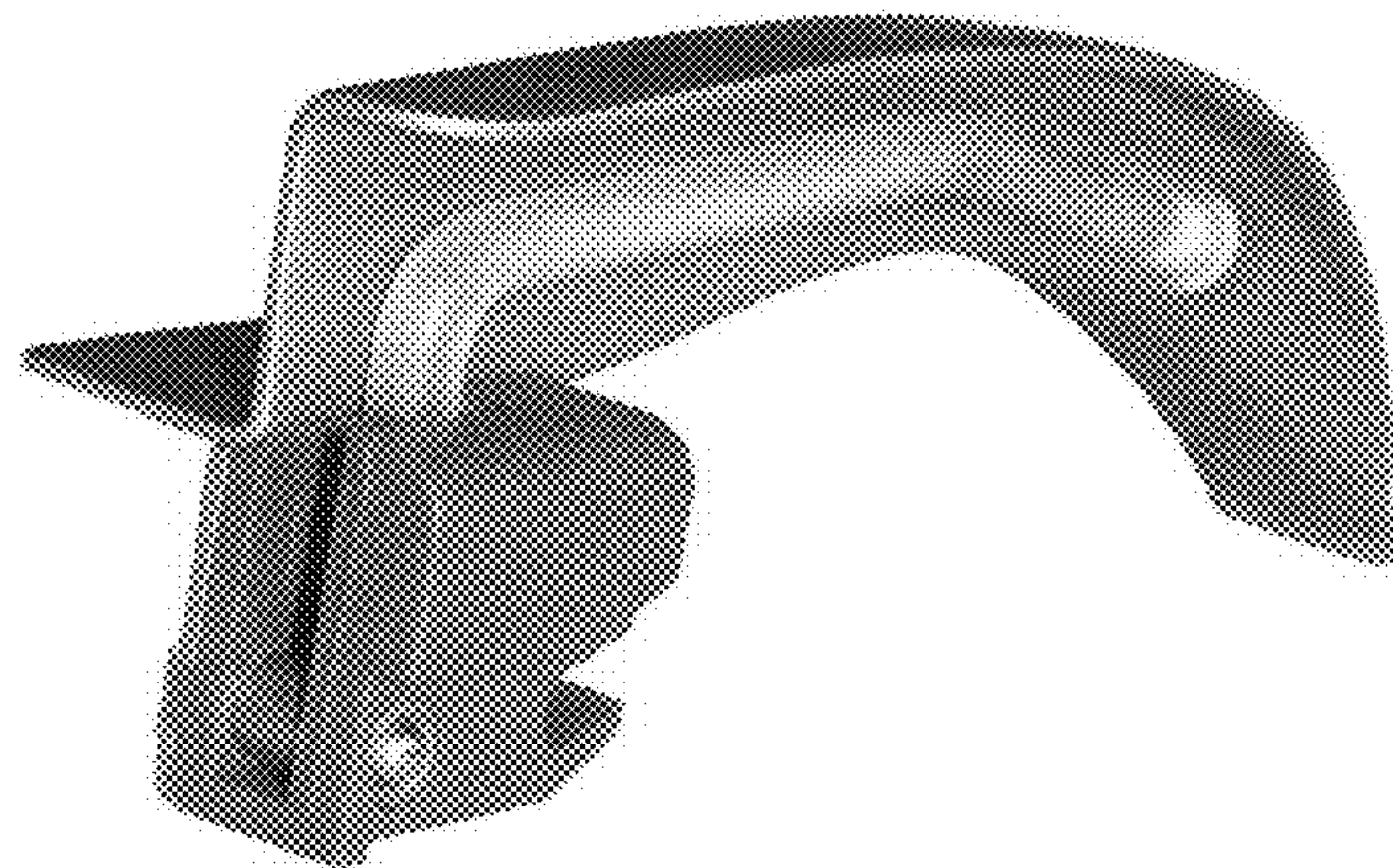
