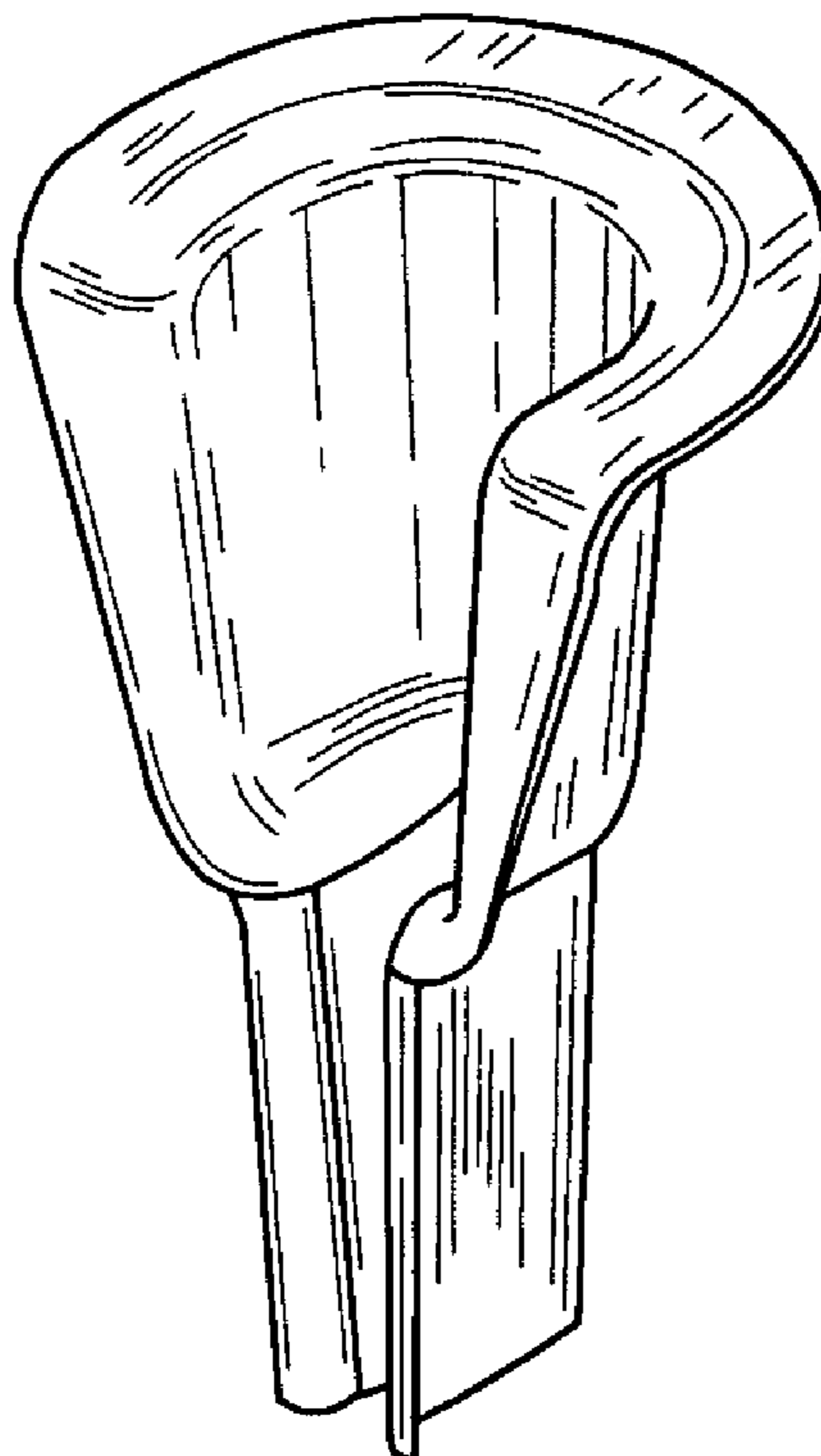
FIG. 1 is a top, right side perspective view of the ultrasound probe clip showing our new design;

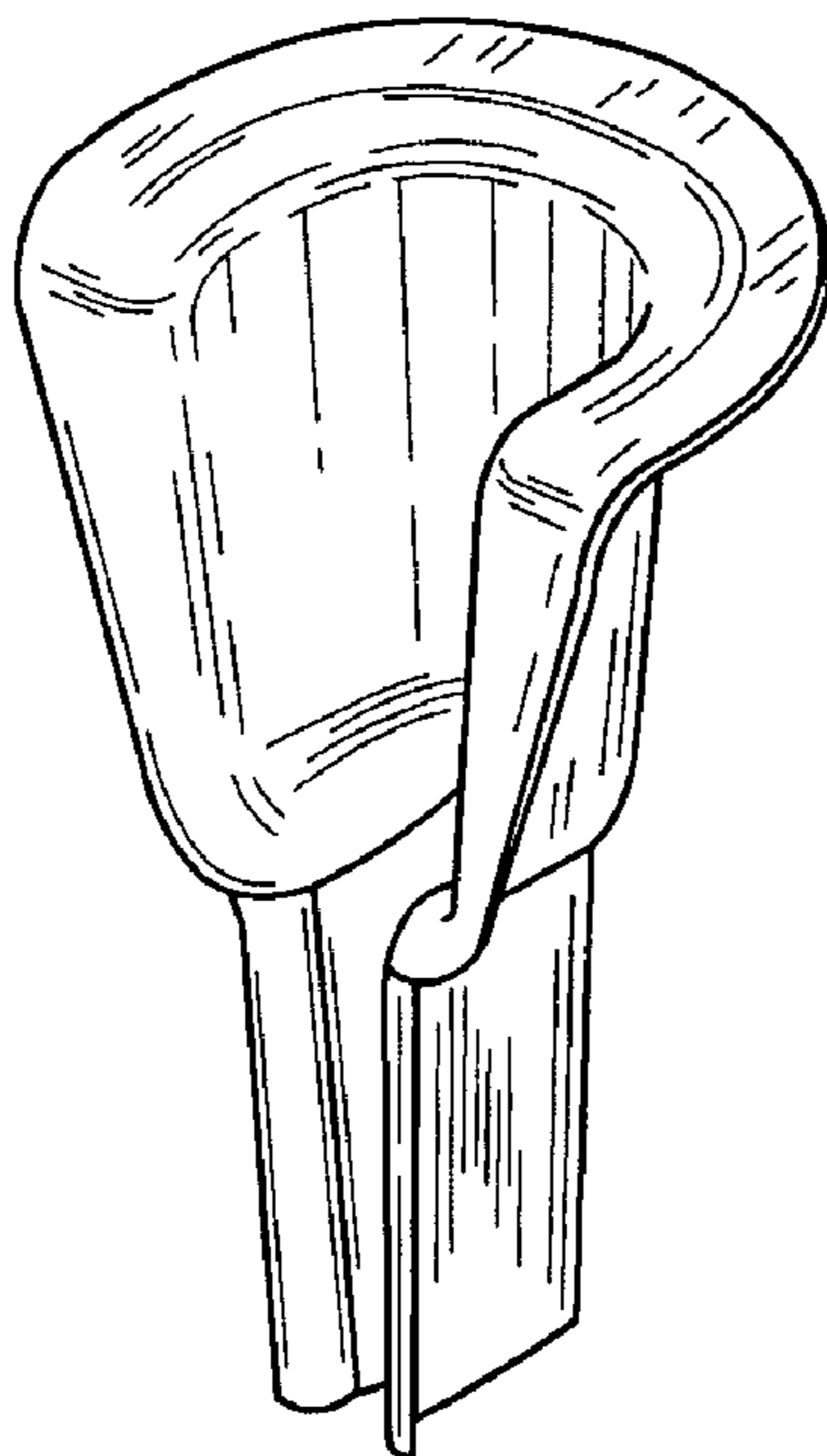
FIG. 2 is a front view thereof;

FIG. 3 is a right side view thereof, the left side view being a mirror image; and,

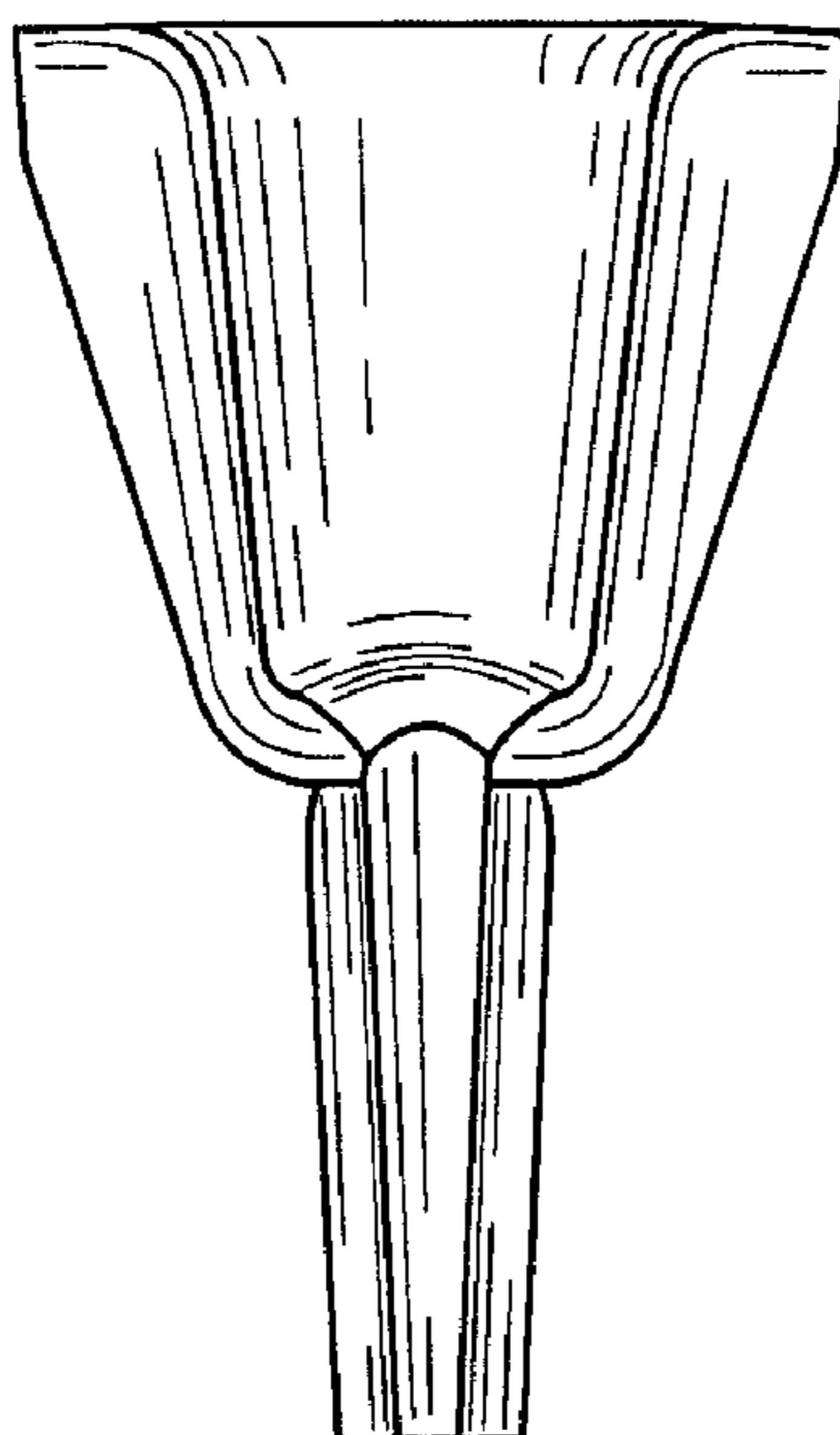
FIG. 4 is a top view thereof.

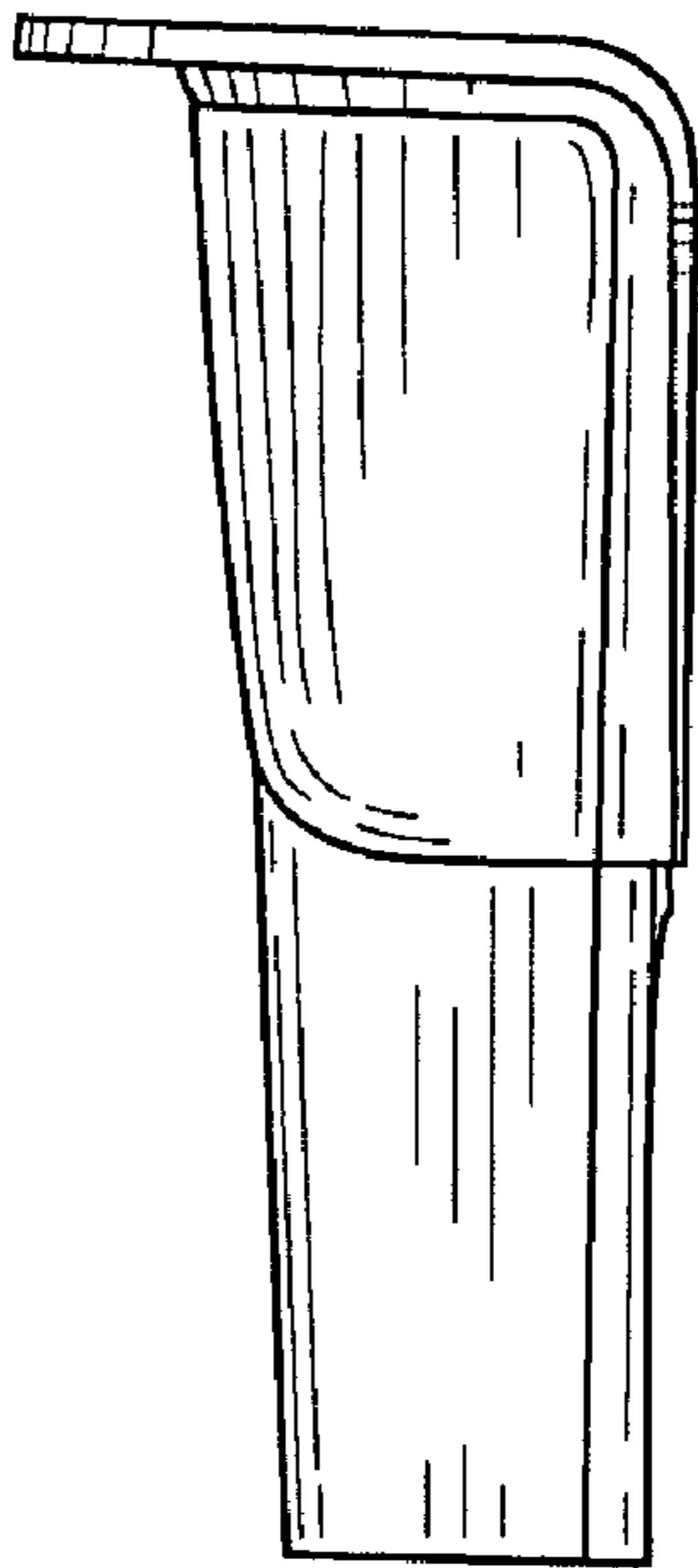




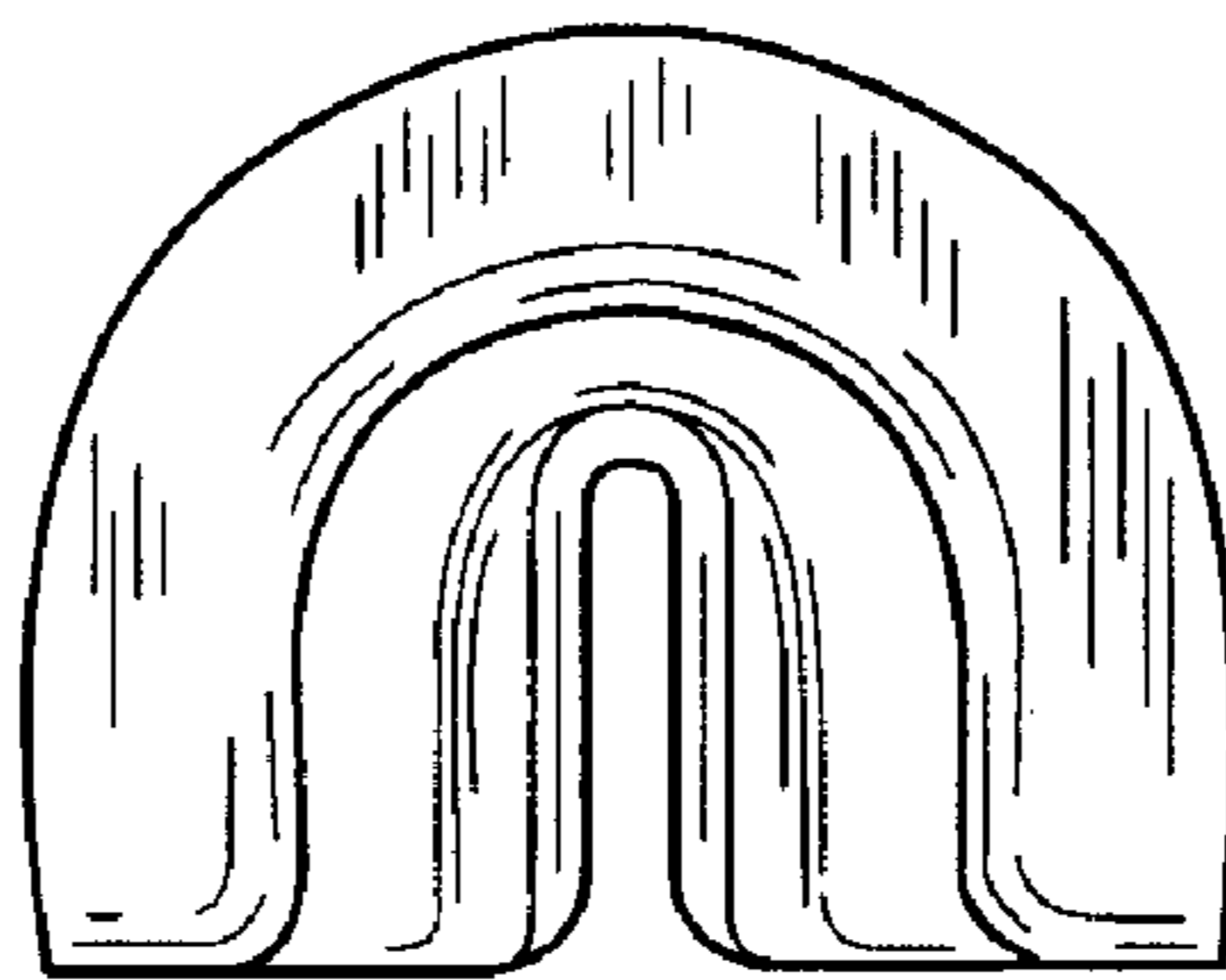
