The ornamental design for memory foam back brace, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear exterior elevational view of a memory foam back brace showing my new design;

FIG. 2 is a front interior elevational view thereof;

FIG. 3 is a left side elevational view thereof;

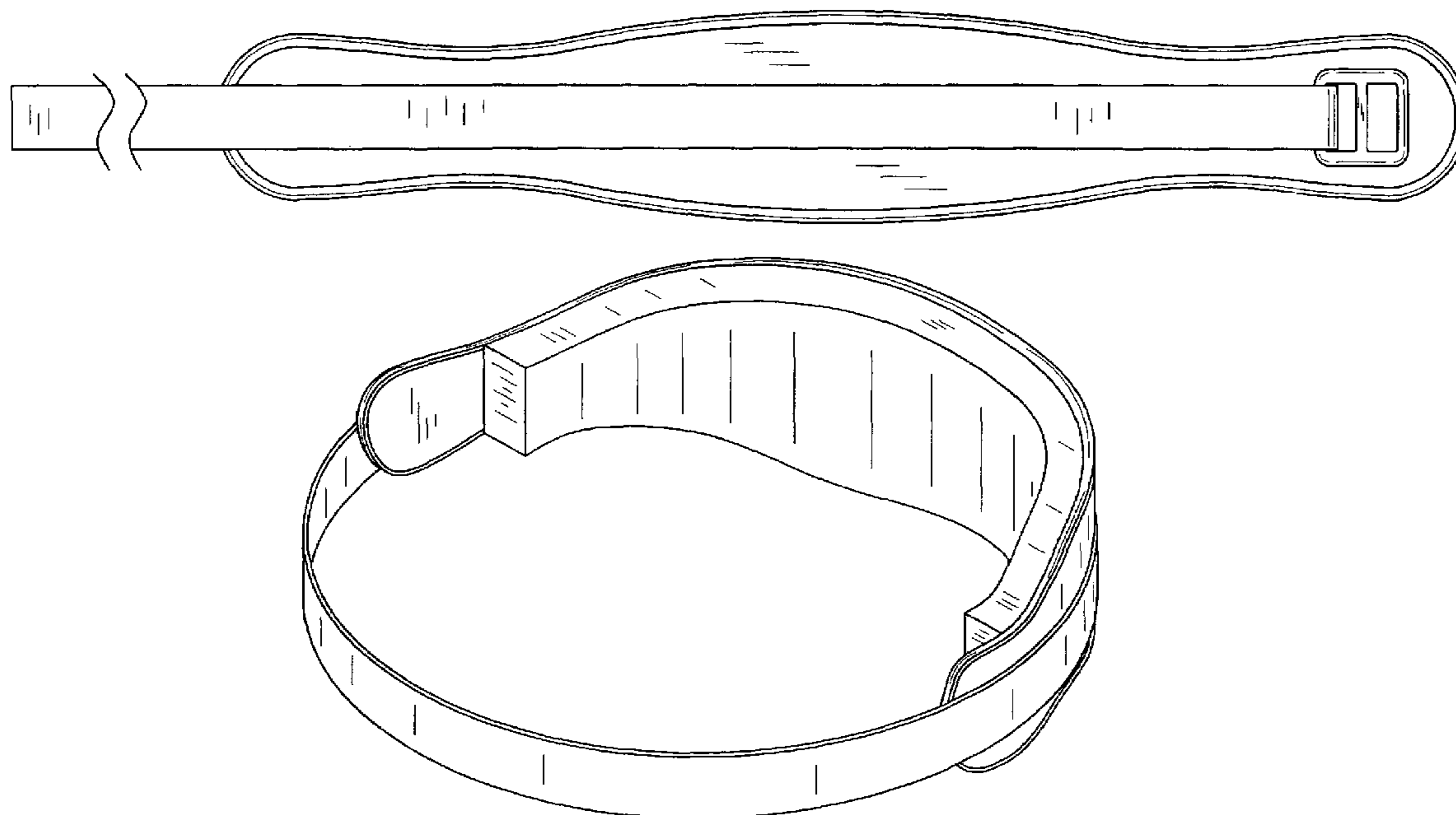
FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is an isometric view thereof.

It is understood that the strap on the memory foam back brace is shown broken away for ease of illustration and to indicate indeterminate length.

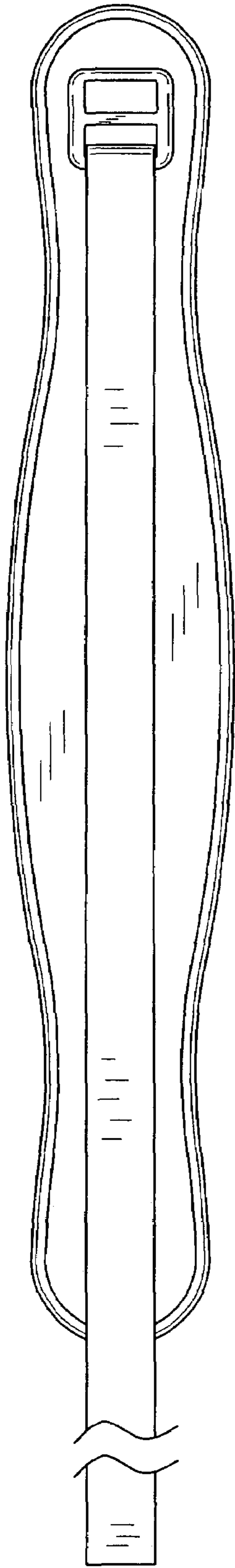

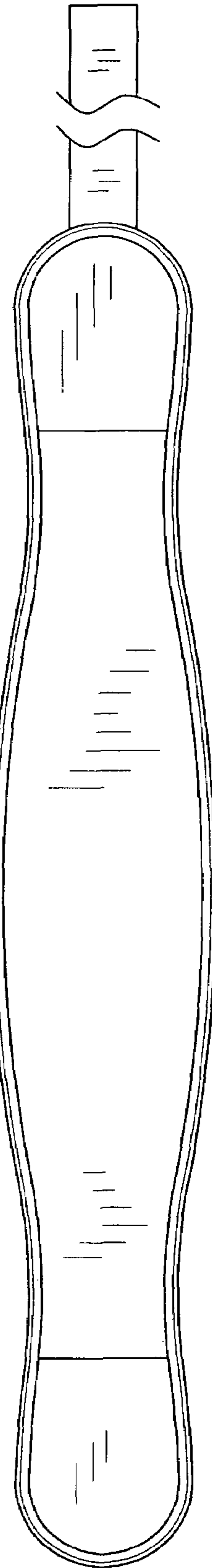

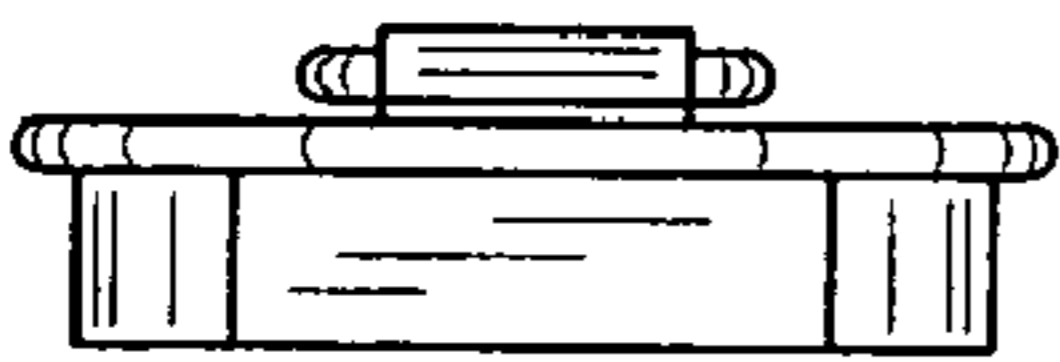

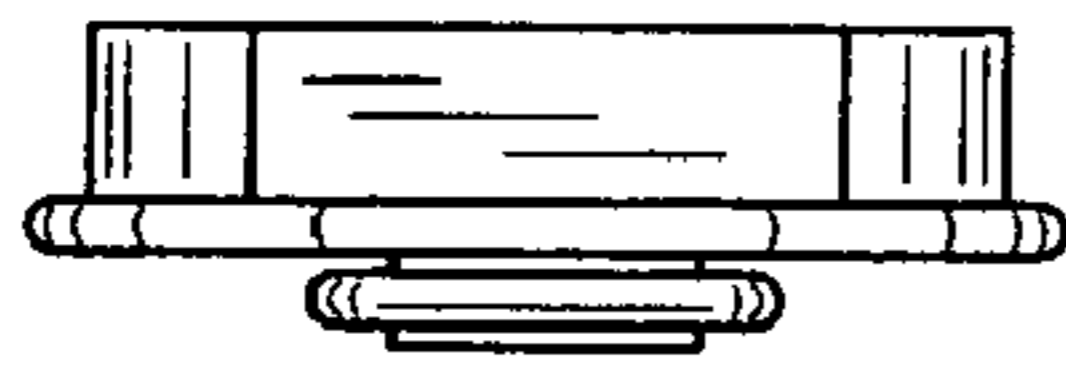

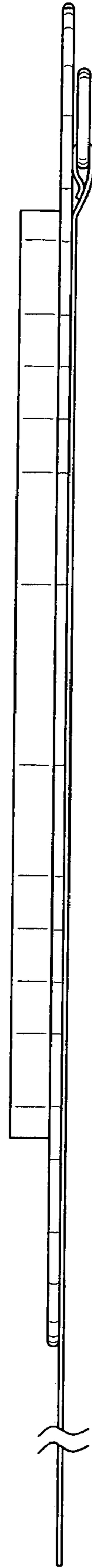

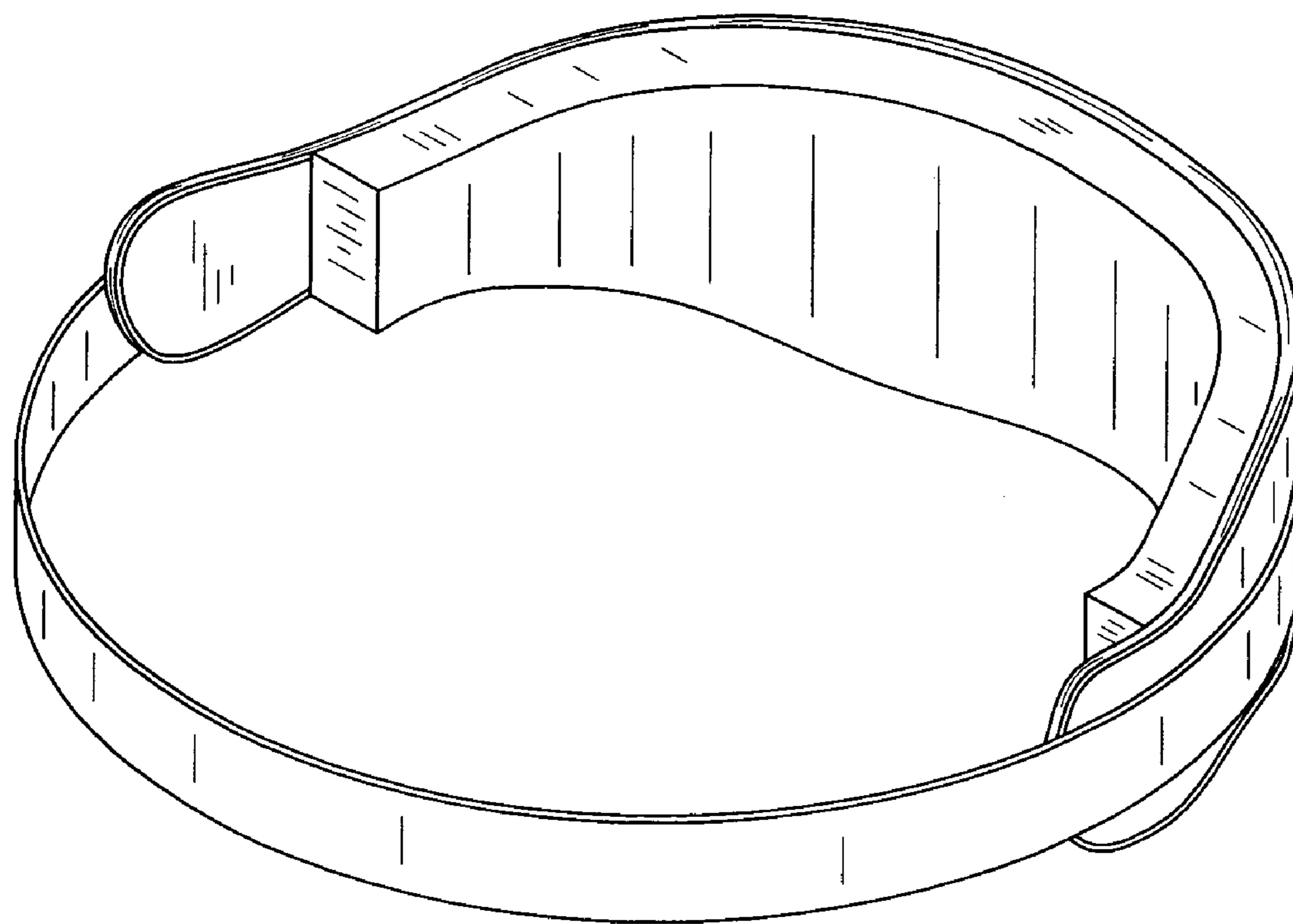
